E lectrostatic disorder-induced interactions in inhomogeneous dielectrics

A bstract. { We investigate the e ect of quenched surface charge disorder on electrostatic interactions between two charged surfaces in the presence of dielectric inhom ogeneities and added salt. We show that in the linear weak-coupling regime (i.e., by including mean-eld and G aussian- uctuations contributions), the im age-charge e ects lead to a non-zero disorder-induced interaction free energy between two surfaces of equal mean charge that can be repulsive or attractive depending on the dielectric mism atch across the bounding surfaces and the exact location of the disordered charge distribution.

E lectrostatic interactions are one of the two fundam ental com ponents of the D LVO theory of colloidal stability [1,2]. They are standardly described by the Poisson-Boltzm ann (PB) theory [1,3] embodying the mean- eld approach to classical charged systems. Mean- eld interactions between like-charged macroions are repulsive in nature and thereby tend to stabilize solutions of charged macroions. In strongly coupled systems (e.g., when multivalent counterions are present), electrostatic interactions how ever induce strong attractive forces between like-charged macroions. This attraction can not be captured by the meanthat tend to destabilize charged solutions. This attraction can not be captured by the mean-

eld approach and a new paradigm dubbed the strong-coupling limit [6,7] was introduced to describe the equilibrium properties of C oulom b uids when the mobile counterion charges become large. The crossover from the mean-eld Poisson-Boltzm ann description to the strong-coupling limit is governed by a single dimensionless electrostatic coupling parameter, which is given by the ratio of the B jerrum length (identifying C oulom bic interaction between ions them selves) and the G ouy-C hapman length (describing electrostatic interaction between ions and the charged macroion surface) [4]. Electrostatic interactions between charged macroions in the mean-eld and the strong-coupling limit thus unfold into a much richer structure than conveyed for many years by the D LVO paradigm. The collapse of a highly charged polyelectrolyte, such as D NA, in the presence of multivalent counterions is the most dramatic example of unexpected and counter-intuitive features of the strong-coupling electrostatics [7,8].

Recently we added a new twist to the theory of electrostatic interactions in charged systems [9]: not only can electrostatic interactions between like-charged macroions turn from repulsive to attractive due to strong-coupling counterion-induced correlations, but we showed

that in the case of no added salt and no image interactions, the quenched disordered distribution of surface charges on the macroions can induce an additive attractive interaction in the strong-coupling limit even if the mean charge of the macroions is zero. This elect is due to the nonlinear features of the average over quenched disorder of the distribution of charges on the macroion surfaces. Such quenched distributions of macroion charge have been invoked recently in experimental investigations of interactions between solid surfaces in the presence of charged surfactants [10,11]. The patterning of interacting surfaces by quaternary amm onium surfactants in these experiments is highly disordered, depends on the method of preparation and has basic implications also for the forces that act between other types of hydrophilic surfaces with mixed charges, most notably in biological as well as in synthetic systems. Motivated by these observations we will now try to develop the theory of electrostatic interactions in system s with quenched disordered macroion charge distributions further.

Here we will consider the e ects of added salt and of im age interactions due to dielectric inhom ogeneities on the disorder-induced interaction between two charged walls of equal mean charge density. We shall focus only on the weak-coupling regime and evaluate interaction free energies up to the rst-loop (Gaussian- uctuations) contribution around the linearized mean-eld (Debye-Huckel) solution. We will show that in general im age interactions have a pronounced e ect on the way disordered charge distributions bring about electrostatic interactions in salt solution, their most notable e ect being that they can induce non-m onotonic interactions as a function of the spacing between the interacting surfaces. These results m arkedly contrast the weak-coupling results obtained in the absence of added salt and im agecharge e ects [9], where the disorder contribution turns out to be nil.




Fig. 1 { Geometry of a system composed of two surfaces with disordered charge distribution at separation D = 2a with dimensional dimensional for the interior region (where salt ions are present), "m, and for the exterior region, "p.

A ssum e a monovalent salt solution con ned between two charged surfaces at z = a. A ssum e furtherm one that the surface charges are sm all such that the linearization approximation is valid. The corresponding grand canonical partition function in the eld of an external xed charge distribution, (r), is given in the functional integral representation as

where (r) is a uctuating potential eld and the linearized e ective H am iltonian reads [12]

Here we take the dielectric constant " = "(r) to have a value, "p, in the two sem i-in nite regions (i.e. $j_{Z}j > a$), which is in general di erent from , "m, assumed in between the charged surfaces. A coordingly, the inverse D ebye screening length is (r) = = $\frac{D}{8} \frac{b}{B} n$ in between the two surfaces (with $b_{B} = e^{2} = (4 \ "_{0} \ "k_{B} T)$ being the B jerrum length and n the salt concentration), and zero otherwise. We assume that the surface charge distribution, (r), has a quenched disordered component. The average over quenched disorder is done as

where the disorder average is de ned here via a Gaussian probability distribution as

N ote that $_0$ (r) represents the m ean charge density and g (r) gives the disorder variance around the m ean value. Since all the functional integrals in the expression for the disorder-averaged free energy are G aussian, the free energy follows straightforwardly as

Here we have de ned the inverse of the operator "" $_0$ (r² + ²) as the G reen function that satis es

with the appropriate boundary conditions of the continuity of derivatives multiplied by the dielectric constants at the surfaces with dielectric discontinuity. The disorder-averaged partition function could also be obtained through the replica form alism [9] but the direct integration approach is much more straightforward in the case of linearized electric H amiltonian, Eq. (2). In the second and third terms of Eq. 5, we recognize the usual uctuational and linearized mean-eld Debye-Huckel (DH) contributions respectively. The rst term is thus stemming from the elects of the disorder. Let us evaluate it explicitly and anlayze its consequences.

B ecause of transverse isotropy, the following Fourier decomposition for the G reen function is valid

with z and z^0 denoting the norm al coordinate to the surfaces and = (x;y), the transverse coordinates. We now evaluate two G reen functions corresponding to the cases

- (i) when the disordered charge distribution is contained within the medium " $_{\rm m}$, and
- (ii) when the disordered charge distribution is contained within the medium " $_{\rm p}$.

These G reen functions can be derived straightforwardly by using the m ethods described in Ref. [13] as

Furtherm ore, we assume that the disorder variance is surface distributed and thus

It can reside either inside the slab (e.g., at a) or outside the slab (e.g., at a + for arbitrarily sm all). The only di erence in the calculation is whether expressions (8) or (9) are used when evaluating the rst trace in Eq. 5. Subsequently, one obtains the disorder-induced part of the free energy for the two aforem entioned cases of the location of the disordered charge distribution as

for the case (i), and as

for the case (ii), where S is the total area of the two bounding surfaces. In both of the above expressions we have subtracted the part of the free energy that does not depend on the separation a since we are only interested in the interaction free energy.

It is thus immediately obvious that some asymmetry should exist in the system (either di erent dielectric constants in between and outside the surfaces, or salt in between and no salt outside, etc.) in order that the disorder contribution to the free energy becomes non-zero. A loo obviously in both cases (i) and (ii) if = 0, there is no disorder-induced interaction. If = 1, then in the case (i), the interaction is zero, but not in the case (ii).




Fig. 2 { Numerical evaluation of the disorder-induced interaction between two charged surfaces, $F_{(i)}$ (a) and $F_{(ii)}$ (a) from Eqs. 12 (left) and 13 (right) for 0 < a < 1. The values of the ratio " $_m = "_p$ are 0.2; 0.4; 0.6; 0.8; 1.0; 5.0 and 10.0 (from top to bottom). The non-monotonic character of the disorder-induced interaction is clearly discernible. Its details depend crucially on the ratio " $_m = "_p$.

The dependence of the disorder part of the free energy, that is Eqs. 12 and 13, on the dimensionless separation between the surfaces, a, is shown in Fig. 2. The most interesting feature of the disorder-induced interaction free energy is that the interaction can be non-monotonic and that it depends critically on the ratio of the two dielectric constants. For sm all and large values of a, the disorder interaction free energy assumes simple limiting form s as we show later.

Putting the above results together with the uctuational and m ean-eld contributions, where we assume that the surface charge distribution has a mean value given by

we obtain the following expressions for the interaction free energy, Eq. 5, in the case (i) and (ii) respectively, i.e.

These are the nal results of our calculation. We note here that the only approximation involved in the derivation of the above results is the linearization approximation in the C oulom b eld action, Eq. 2, that makes them valid only in the weak-coupling limit, i.e., for smallmean surface charge density and low counterion valency.

Let us assess the importance of the disorder-induced interaction by considering a few illuminating limiting cases, the general form being given numerically in Fig. 2. In the case of vanishing salt or small separations, a ! 0, one gets in the case (i), where disorder is located inside the slab of dielectric constant $"_m$,

The above limiting form is valid only if $"_m \notin "_p$. O there is higher order terms come into play. The second case (with the disorder located outside the slab and in the medium $"_p$) leads to exactly the same free energy and thus in this limit, there is no di erence in the disorder-induced interaction whether the disordered charge distribution is within medium $"_m$ or $"_p$. O by iously in this limit, the disorder-induced part of the interaction falls o inversely with the

rst power of the separation, D = 2a, to be compared with the inverse-square decay in the case of the zero-frequency van-der-W aals (uctuational) term. Its sign depends on the values of both dielectric constants. One should also note that in this limit, the disorder and the mean-eld term combine, yielding

It would thus seem that the disorder merely renorm alizes the square of the charge density. But since the disorder term can be either positive or negative, depending on the value of "m" one can not claim that the only elect of disorder in this limit is the disorder-renorm alization of the mean surface charge, since the whole expression Eq. 19 can not be written as proportional to $(_R)^2 = (_{R})^2 = (_{R})^2$, which is by denition always positive, where 0 would indicate the disorder dependent terms. The disorder in this limit therefore does not simply renorm alize the surface charge and can lead to attractive or repulsive interactions, depending on the sign of "m" p. However, an important consequence of the disorder elects in this limit is that it induces interactions even between nom inally uncharged surfaces with a mean charge density = 0. These interactions have the same dependence on the separation as the mean – eld D H term in this limit, except that they can be either repulsive or attractive depending again on the di erence "m" . Nom inally neutral surfaces thus exhibit electrostatic-like interactions

induced solely by the variance of the charge distribution, not its mean value!

In the opposite limit of large salt or large separations, a ! 1, one remains with

for the case (i). The disorder-induced component (rst term) has the same separation dependance as the standard screened zero-frequency van-der-W aals (vdW) interaction (second term), but is shorter ranged than the corresponding mean-eld DH term (third term). A loo in this lim it, the disorder-induced interaction is always repulsive, which means that the overall interaction can change sign upon increase of the separation, as is already apparent from Fig. 2. The interesting point now is that the disorder-induced term clearly renormalizes the uctuational (van-der-W aals) contribution, since it has the same separation-dependance as the zero-frequency van-der-W aals term but with the opposite sign.

For the second case (ii) and in the same lim it of a ! 1, we obtain

Again the disorder part of the interaction (rst term) has almost the same functional dependence on the intersurface separation as the zero-frequency van-der-W aals part (second term). O ne can thus make a general conclusion that in the limit a ! 0, the disorder-induced component of the interaction free energy electively behaves like the mean-eld contribution, while in the limit a ! 1, it behaves like the uctuational (vdW) contribution. In a certain sense, the disorder-induced interaction thus interpolates between mean-eld and uctuational interactions. All this is of course valid only in the weak-coupling limit and one can not apply these conclusions to the disordered strong-coupling regime [9]. The analysis of the interplay between disorder-induced elects and in age-charge elects in the strong-coupling limit will be left for a separate exercise.

The results derived above, apart from the e ects due to nite salt concentration in between the apposed charged surfaces, clearly di er from those obtained in the absence of dielectric inhom ogeneities [9], where the m ean-eld contribution was shown to be decoupled from the disorder e ects. The conclusion reached in Ref. [9] is thus limited to disordered charge distributions in m ersed in a single dielectric m edium without any inhom ogeneities in the corresponding static dielectric constant.

Note that if the mean surface charge is zero (= 0), then according to Eqs. 20 and 21, the equilibrium spacing between surfaces is given by the competing disorder-induced and uctuational interaction parts for large a. In case (i), Eq. 20 obviously implies no nite equilibrium spacing. The interaction is monotonic and its sign depends on whether the ratio $4G = ("_m "_0 k_B T)$ is bigger or smaller than one. In case (ii), Eq. 21, an optimal surface separation exists since the disorder and uctuational contributions do not have excly the same separation-dependence.

In all the limiting cases addressed above, the disorder-induced part of the interaction can be masked by either mean-eld or uctuational terms in the total interaction, which would make its elects particularly di cult to pinpoint experimentally. Its most important feature, though, is the non-monotonic character of the interaction at intermediate separations (see Fig. 2). In the case of interactions between charged interfaces, this feature may be important for the stability of planar charged macrom olecular assemblies such as lipid bilayers.
