Quantum magnetism with multicomponent dipolar molecules in an optical lattice

We consider bosonic dipolar molecules in an optical lattice prepared in a mixture of di erent rotational states. The $1=r^3$ interaction between molecules for this system is produced by exchanging a quantum of angular momentum between two molecules. We show that the M ott states of such system s have a large variety of quantum phases characterized by dipolar orderings including a state with ordering wave vector that can be changed by tilting the lattice. As the M ott insulating phase is melted, we also describe several exotic super uid phases that will occur.

In ultracold physics, system s with long-range dipolar interactions have recently attracted considerable attention both theoretically and experimentally (for a recent review of ultracold dipolar molecules see [1] and references therein). For atom s, dipolar interactions com e from theirm agneticm om ents and becom e im portant for large electronic spin [2]. Recent experiments dem onstrated the relevance of such dipolar interactions for the expansion of Cratom s from the BEC state [3]. On the other hand, for heteronuclear m olecules, dipolar interactions arise from their electric dipole m om ents. Recent experim ents have succeeded in trapping and cooling several types of heteronuclear m olecules [1, 4, 5, 6]. In a state with a wellde ned angular momentum, molecules do not have a dipole m om ent. H ow ever, w hen an external electric eld is used to polarize the molecules, dipolarm om ents can be induced. There has been considerable theoretical e ort to study the resulting dipole interactions and m any-body physics associated with such system s [8, 9, 10, 11, 12?].

In this Letter, we consider an alternative mechanism for obtaining the $1=r^3$ dipolar interactions, and the im portant concom itant directional character. Namely, we investigate a m ixture of heteronuclear dipolar m olecules in the lowest (N = 0) and the rst excited (N = 1) rotational states. For such a system, the origin of the longrange interaction is the exchange of angular m om entum quanta between molecules. We demonstrate that when loaded into an optical lattice, such mixtures can realize various kinds of non-triviale ective dipolar spin system s with anisotropic, long-range interactions. Several approaches for realizing spin systems using cold atoms have been discussed before, including bosonic mixtures in optical lattices in the M ott state [13, 14, 15, 16], interacting ferm ions in special lattices [17], and trapped ions interacting with lasers [18]. The system we consider has the practical advantages of the high energy scale for spindependent phenom ena (set by dipolar interactions) and the new physics associated with the long-ranged nature of the dipole interactions. Experimental realization of the system will give insight into several open questions in condensed m atter physics including com petition between ferro and antiferroelectric orders in crystals [19, 20] and system s with frustrated spin interactions [21].

Consider the system that contains bosonic molecules in the lowest (N = 0;N_z = 0) and rst excited (N = 1, N_z = 1;0;1) rotational states where we let s^y and $t_{1;0;1}^{y}$ create these respective states. We will often use the change of basis $t_{x}^{y} = (t_{1}^{y} + t_{1}^{y}) = \overline{2}$, $t_{y}^{y} = i(t_{1}^{y} + t_{1}^{y}) = \overline{2}$. To describe molecules in an optical

lattice we use the one-band Hubbard type e ective model

 $H = H_{kin} + H_{Hub} + H_{dip} :$ (1)

The rst term on the right hand side of (1) is the kinetic energy from nearest-neighbor hopping $H_{kin} = \int_{hiji}^{P} s_{i}^{y} s_{j} + t_{i}^{y} t_{j} + hc:$ Operators s_{i}^{y} and t_{i}^{y} create molecules on site i (here and after the sum mation over repeating indices = x, y, z is implied). The last term in (1) describes the dipolar interaction between molecules from di erent sites

where R_i are lattice vectors, e_{ij} is the -component of the unit vector along R_i R_j, and parameter equals $2d^2=3$, where d is the value of the dipole m om ent associated with the N = 0 ! N = 1 transition, and d_i is the dipole m om ent operator at site i. The -component of the operator d_i is written as

where we absorbed the energy di erence between the rotational levels $E_{N=1}$ $E_{N=0} = 2B_e$ into the time dependence of the t operators. Since the rotational constant B_e is considerably larger than any other energy scale in the system, we assume that the terms in (2) that oscillate at frequencies $4B_e$ average to zero. This forces the number of m olecules in the N = 0 and N = 1 states to be independently conserved. Then (2) reduces to

The second term on the right hand side in (1) is the Hubbard on-site interaction. For two s molecules in

the absence of an external electric eld, the long-range part of their interaction potential is dom inated by the van der W aals tail C 6=R 6 originating from second order terms in the dipole-dipole interaction operator [22]. For polar molecules with large static rotational polarizabilities one can estimate C₆ $d^4 = 6B_e$. For the RbCs molecule (d = $0.5 \text{ a.u., } B_e = 7.7 \quad 10^8 \text{ a.u.}$) we have C_6 1:5 10⁵ a.u. For molecules with smaller dipole m om ents and larger rotational constants like, for exam ple, CO (d = 0.043, B_e = 9.0 10⁶), the van der W aals interaction is comparable in magnitude to interatom ic forces. In any case the range of the potential, which scales as $R_e = (m C_6)^{1=4}$, is not much dierent from typical ranges of interatom ic potentials (for R bC s R e 400 a.u.). First order terms in the dipole-dipole operator are also absent for two molecules with N = 1. In this case, apart from a weak quadrupole-quadrupole contribution proportional to R 5 , the long-range part of the intermolecular potential is given by the van der W aals interaction with a comparable C_6 coe cient. Thus, the interactions between molecules with the same N are all short ranged and, in an ultracold system, can be modeled by contact potentials. Then, averaging them over the Gaussian on-site wave functions gives the Hubbard on-site interaction.

The interaction between s and t molecules (without loss of generality we consider = z here) is sim ilar to the resonant interaction of an electronically excited atom and a ground state atom . For even partial waves the interm olecular potential is asymptotically given by $(1 \quad 3\cos^2_z)=2R^3$, where z is the angle $W_z(R) =$ between R and the z-axis. W e consider the weakly interacting regime where the characteristic energy scale of this l_{h}^{3} , is sm aller than the B loch band interaction, E separation. Here l_0 is the oscillator length of the on-site harmonic con nement. Then, the two-body problem in a harm onic potential can be solved in the mean-eld approximation by using the pseudopotential approach (see [23] and references therein). Due to the anisotropy of W_z (R) the corresponding on-site interaction energy, V_z , can be tuned at will by changing the aspect ratio of the on-site con nem ent [23].

W e arrive at the following expression for H $_{\rm H\,ub}$:

It is easy to see that (5) holds for arbitrary lling factors as long as the on-site density proles remain Gaussian. However, for the purpose of this paper it is sulcient to consider on average one or two molecules per site. The ten coupling constants in Eq. (5 are dicult to control independently. However, in many cases not all of them are relevant. For a mixture of s and t_{z} molecules the relevant coupling constants are U, U_z , and V_z . These are tunable through trap aspect ratio and/or Feshbach resonance. W hen considering this system we will take $U = U_z$ and $V = V_z$. Another example is the M ott insulating state with one molecule per site (all kinds of molecules are allowed) when the interaction energies are much larger than J. Then, the particular values of the on-site coupling constants are not important (for mechanical stability it is su cient that they are positive) and the state of the system is found by minimizing the intersite dipolar interactions.

W e now discuss the resulting phase diagram, rst focusing our attention on the M ott insulating state with one m olecule per site. W e take the variationalwave function

where describes the fraction of the molecules excited into N = 1 states and $_i$ is a norm alized complex vector $_i$ i = 1. Here, $_i$ is the variational parameter which describes the direction the dipole moment points on site i. This allows us to construct variational states that bene-

t m axim ally from dipolar interactions. In all cases discussed below we veri ed the absence of phase separation by checking the eigenvalues of the com pressibility m atrix for s and t bosons [24]. Taking the expectation value of the dipole operator (3) with our variational wave function (6) we obtain hd_i i = sin (2)j jcos('_i 2B_et) where we have written _i = j je^{i'_i}. Upon taking the expectation value of dipole H am iltonian (4), we nd for the dipolar energy

W hen m in in izing the energy in (7) it is important to keep track of the conservation laws that may be present for certain experimental geometries and on the initial preparation of the system. We will now consider several examples of ordering in the Mott insulating state. A lthough the dipole interaction in all cases is described by (7) we will see that di erent preparation leads to very di erent types of order. Though all discussion in this work will be restricted to 2d, we emphasize that there are nontrivial results in the M ott insulating phase for the 1d and 3d cases as well. As the rst example, we consider the square lattice in the xy-plane de ned by vectors $a_1 = x$ and $a_2 = y$. Due to cross-term s such as $s^y t_x^y s t_y$ in the dipolar ham iltonian (4), we see that t_x m olecules can be converted to t_v m olecules and vice-versa. Thus, N $_{t_v}$ and N_t, are not conserved quantities, and, consequently, the only conserved quantities are N $_{\rm s}$ and N $_{\rm t}$. Now consider preparing this system in a mixture of N = 0

and N = 1; N_z = 1 states. Then after the system relaxes, taking the constraints into account, we must have

xed $hN_s i = N \cos^2()$, $hN_{t_x} i + hN_{t_y} i = N \sin^2()$, and $hN_{t_z} i = 0$. This gives the constraints on the variational wave function $_{iz} = 0$ and $j_x \hat{f} + j_y \hat{f} = 1$. We see that the dipoles are allowed to rotate freely in the xy-plane. For this case, the dipoles will choose to point head-to-tail in the direction of one of the bonds, while alternating in the other. Thus, it is straightforward to see that this gives the ordering wave vector q = (0; ; 0) with $_{ix} = e^{i(q R_i + ' \, 0)}$ and $_{iy} = _{iz} = 0$ where '_0 is an arbitrary phase corresponding to a change of phase of the tim e dependent oscillations of the dipolarm on ent.

We point out that this con guration is degenerate to the one with dipoles pointing head-to-tail in the y-direction.

As the next example in two dimensions, we take the same lattice as in the previous example, but prepare the system in a mixture of N = 0 and N = 1; N_z = 0 states. Recalling that for this geometry, both N_s and N_{t_z} are conserved quantities, we not the constraint on the variational wave function $_{ix} = _{iy} = 0$ and $_{iz} = e^{i' \cdot i}$. With this constraint, the dipole interaction energy is

$$E_{dip} = \frac{\sin^2 (2)}{4} \frac{X}{\frac{1}{3} \sin^2 (2 - 1)} \frac{1}{3} \frac{\cos(\prime_{i} \prime_{j})}{\frac{1}{3} \pi_{i} R_{j} \frac{1}{3}}$$

Here, the dipoles are conned to point in the z-direction, and therefore cannot point head-to-tail. This gives antiferrom agnetic ordering in all directions, q = (;;0), with $_{iz} = e^{i(q R_1 + '_0)}$ where '_0 is an arbitrary phase.




FIG.1: The ordering wave vector as the lattice is tilted by angle . A sdescribed in the text, for this situation a magnetic eld is used to break the degeneracy between (N = 1, N $_z$ = 1;0;1) states.

For the nal example for the M ott insulating state, we consider a lattice in the xz-plane given by $a_1 = \cos()\hat{x} + \sin()\hat{z}$ and $a_2 = \sin()\hat{x} + \cos()\hat{z}$. In addition, we consider breaking the degeneracy of the (N = 1, N_z = 1;0;1) states with an external static magnetic eld in the z-direction which will introduce the term proportional to BL_z into our ham iltonian. Preparing the system in a superposition of N = 0 and N = 1; $N_z = 1$ states, we note that because of this degeneracy breaking, there will be no mixing between other angular momentum states. That is, we can completely neglect the t_{1;0} states. This will give $i_x = i_{iy} = e^{i_{i}} = 2$ and z = 0 which will con ne our dipoles to rotate in the xy-plane as: $hd_i(t)i = d_0 \cos(i_i 2B_et) + d_0 \sin(i_i 2B_et)$: The dipolar energy of this system is therefore

$$E_{dip} = \frac{\sin^{2}()}{8} \frac{X}{\sin^{2}()} \frac{\cos('i '_{j})(1 \frac{3}{2}e_{ijx}^{2})}{\Re i R_{j}\beta} : \qquad (9)$$

We use the ansatz ' $_{i} = q R_{i} + '_{0}$ to nd the minimum of this dipolar energy for a particular lattice de ned by the angle , and the results are sum marized in Fig.1.

W e now consider melting the M ott insulator, and entering the super uid (SF) state. An interesting question to consider is what happens to the ordering wave vector as the M ott insulating state is melted? For instance, deep in the super uid phase, we will have q = 0 which is favorable for Bose-E instein condensation while we saw that antiferrom agnetic ordering is typically favored in the M ott insulating state by dipolar interactions. One possibility is that the wave vector interpolates sm oothly between these two extrem es as the hopping J increases. Another possibility is that the molecules in the s and t states phase-separate. W e will show below that both scenarios are possible depending on on-site energy parameters in our original ham iltonian. For sim plicity, we restrict our attention to the third example we discussed above for the Mott insulating state which was a two dimensional lattice in the xy plane prepared with $_z$ polarized light. For further sim plicity, we take hN $_{s}i = hN _{t_{z}}i = N = 2.$ As we saw before, we can neglect populating the t_x and t_y states, and this phase has antiferrom agnetic q = (; ; 0)order in the M ott insulating phase.

A llow ing for noninteger occupation per site motivates the variational wave function

where $a_i^y = \cos(p e^{ip_s R_i} s_i^y + \sin(p) e^{ip_t R_i} t_{iz}^y$ and norm alization requires $n j_n f = 1$ (compare with (6)). As before, this wave function maxim izes the dipole energy for a given site which is energetically favorable. We can now use a canonical transformation to write our original ham iltonian in terms of the boson operators a_i^y (dened above) and $b_i^y = \sin(p) e^{ip_s R_i} s_i^y + \cos(p) e^{ip_t R_i} t_{iz}^y$ (a new variable resulting from the transformation), and drop the terms which give zero when evaluated using the above variational wave function (10). This leads to the following single-site mean eld ham iltonian




FIG. 2: The phase diagram for V = U (left) and V = 0 (right). For both cases, the dipolar interaction strength was xed at = U=5. Show n are the antiferrom agnetic M I states with one and two bosons per site labeled M II and M I2. SF1 and SF2 correspond to super uid states with partial and com – plete phase separation (described in text). SF3 is a super uid phase with no phase separation which has an ordering wave vector that interpolates between the M ott insulating and deep super uid regim e.

where $n_a = a^y a$ and we have already performed the minimization over the center of mass momentum $p = (p_t + p_s)=2$. The ground state of this ham iltonian for xed (relative concentrations) and $q = p_e p_s$ (relative momentum) can be determined self-consistently in hai and hn_a i through iteration numerically. The general approach will then be to minimize these ground state energies over $q_{x,y} \ge [0;]$ and $\ge [0; =2]$. When the minimum occurs for e = 4, phase separation will occur.

The resulting phase diagram s are shown in Fig.2. The M ott insulating phases are antiferrom agnetically aligned and were discussed in the previous section. SF1 corresponds to partial phase separation where part of the lattice will have a larger concentration of s molecules while the other part will have a higher concentration of t molecules. Recall that phase separation will occur for when =4 since we initially prepare the system to have equal populations of m olecules in the s and t_z states. The region with more smolecules will have $(p_s)_{x,y} = 0$ and $(p_t)_{x,y} = .$ This will allow the more populated s species to bene tmaximally from BEC which prefers zero wave vector while still giving $q_{x,v} = which is preferred$ for the dipole interaction. The similar situation holds for the region of the lattice with a higher concentration of t, molecules. SF2 corresponds to the case where the s and t_z molecules completely phase separate. Since the dipole interaction is negligible for this case, we will have

In conclusion, we have shown that polarm olecules prepared in a mixture of two rotational states can exhibit long-range dipolar interactions in the absence of an external electric eld. We have described several novel M ott insulating and super uid phases that can be realized as a result of such an interaction. Such states can be detected by B ragg scattering or by tim e-of- ight expansion [25].
