One-loop approxim ation for the Hubbard model

The diagram technique for the one-band Hubbard model is form ulated for the case of moderate to strong Hubbard repulsion. The expansion in powers of the hopping constant is expressed in terms of site cum ulants of electron creation and annihilation operators. For G reen's function an equation of the Larkin type is derived and solved in a one-loop approximation for the case of two dimensions, nearest-neighbor hopping and half-lling. The obtained four-band structure of the spectrum and the shapes of the spectral function are close to those observed in M onte C arlo calculations. It is shown that the maxim a form ing the bands are of a dissimilar origin in dimensions of the B rillouin zone.

I. IN TRODUCTION

Systems with strong electron correlations which, in particular, cuprate perovskites belong to are characterized by a Coulomb repulsion that is comparable to or larger than hopping constants. One of the sim plest models for the description of such systems is the Hubbard model^{1,2,3} with the Ham iltonian

where t_{nm} is the hopping constants, the operator a_n^y creates an electron on the site n with the spin projection = 1, U is the on-site C oulomb repulsion, the electron number operator $n_n = a_n^y a_n$. In the case of strong electron correlations, $U \ge j_{nm}$ j it is reasonable to use a perturbation expansion in powers of the hopping constants for investigating H am iltonian (1). A pparently the nst such expansion was considered in Ref. 4. The further development of this approach was given in Refs. 5,6,7,8,9 where the diagram technique for H ubbard operators was developed and used for investigating the M ott transition, the magnetic phase diagram and the superconducting transition in the H ubbard m odel.

The rules of the diagram technique for H ubbard operators are rather intricate. B esides, these rules and the graphical representation of the expansion vary depending on the choice of the operator precedence. The diagram technique suggested in R efs. 10,11,12,13 is free from these defects. In this approach the power expansion for G reen's function of electron operators a_n and a_n^y is considered and the terms of the expansion are expressed as site cum ulants of these operators. B ased on this diagram technique the equations of the Larkin type¹⁴ for G reen's function were derived.^{10,12,13}

However, the application of this approach runs into problem s. In particular, at half-lling the spectral weight appears to be negative near frequencies $!_d = \frac{U}{2} \cdot ^{13}$ T his draw back is connected with divergencies in cum ulants at these frequencies. As can be seen from form ulas given below, all higher-order cum ulants have such divergencies at $!_d$ with sign-changing residues, which are expected

to compensate each other in the entire series. If, as in Ref. 13, only some subset of diagram s is taken into account the divergencies of di erent orders can be com pensated only accidentally. On the other hand, at frequencies neighboring to !d cum ulants are regular. If a selected subset of diagrams is expected to give a correct estim ate of the entire series for these frequencies the values at !d can be corrected by an interpolation using results for the regular regions. This procedure is applied in the present work where the one-loop approxim ation is used { as irreducible diagram s in Larkin's equation those appearing in the rst two orders of the perturbation expansion are adopted. One of these diagram s contains a loop form ed by a hopping line. It is shown that for the case of a square lattice, nearest-neighbor hopping and half-lling the electron spectrum consists of four bands. These band structure and the calculated shapes of the electron spectral function are close to those obtained in M onte-C arlo calculations^{15,16,17} and recently in the cluster perturbation¹⁸ and the two-particle self-consistent¹⁹ calculations. It is shown also that the maxim a form ing the bands are of a dissimilar origin in dierent regions of the Brillouin zone.

In the following section the perturbation expansion for the electron G reen's function is formulated in the form convenient for calculations and Larkin's equation is derived. In Sec. III the equations of the previous section are used for calculating the spectral function and the obtained results are discussed. Concluding remarks are presented in Sec. IV.

II. DIAGRAM TECHNIQUE

W e consider G reen's function

as the unperturbed Ham iltonian and the perturbation, respectively, and using the known²⁰ expansion for the evolution operator we get

where = 1=T is the inverse tem perature, the subscript \0" near the angular bracket indicates that the averaging and time dependencies of operators are determ ined with the Hamiltonian H $_0$. The subscript \c" indicates that term swhich split into two orm ore disconnected averages have to be dropped out.

The Hamiltonian H₀ is diagonal in the site representation. Therefore the average in the right-hand side of Eq. (4) splits into averages belonging to separate lattice sites. To be nonzero these latter averages have to contain equal num ber of creation and annihilation operators. For this average to be nonvanishing operators have to belong either to the same site or to two di erent sites,

are cumulants²¹ of the rst and second order, respectively. All operators in cum ulants (5) belong to the sam e lattice site. Due to the translational symmetry of H $_{0}$ in Eq. (3) the cum ulants do not depend on the site index which is therefore on itted in Eq. (5).

A verages which appear in higher-order term sofEq. (4)can be transform ed in the sam e m anner. The average in the k-th order term which contains k + 1 creation and annihilation operators is represented by the sum of all possible products of cum ulants with the sum of orders equal to k + 1. All possible distributions of operators between the cum ulants in these products have to be taken into account. The sign of a term in this sum is determ ined by the num ber of perm utations of ferm ion operators, which bring the sequence of operators in the initial average to that in the term . A ctually the above statements determine rules of the diagram technique. Additionally we have to take into account the presence of topologically equivalent terms { terms which dier only by permutation of operators $H_1(i)$ in Eq. (4). Since these terms are equal, in the expansion only one of them can be taken into account with the prefactor = j=k!where j is the number of topologically equivalent term s. Following Ref. 11 in diagram swe denote a cum ulant by a circle and the hopping constant t_{nn^0} by a line directed from n^0 to n. The external operators a_{n^0} (⁰) and a_n () are denoted by directed lines leaving from and entering into a cumulant. The order of a cumulant is equal to a num ber of incom ing or outgoing lines. Sum m ations and integrations over the internal indices n_i , n_i^0 , i and i are carried out. Since site indices of operators included in a cum ulant coincide, som e site sum m ations disappear. A lso som e sum m ations over i get lost, because in any cum ulant spin indices of creation and annihilation operators have to m atch. Taking into account the multiplier $(1)^k$ in Eq. (4), the sign of the diagram is equal to (1)¹ where 1 is the num ber of loops form ed by hopping lines. Figure 1 dem onstrates connected diagram s of the rst four orders of the power expansion (4) with their signs and prefactors. Here the thick line with arrow in the left-hand side of the equation is the total G reen's function. Notice that if we set $t_{nn} = 0$, contributions of the diagram s (b), (d) { (f), (i) { (n), (p), (t), and (u) vanish. However, below a renorm alized hopping parameter will be introduced which is nonzero for coinciding site indices and therefore the m entioned diagram s are retained in Fig.1.

All diagrams can be separated into two categories { those which can be divided into two parts by cutting som e hopping line and those which cannot be divided in

this way.^{8,14} These latter diagram s are referred to as irreducible diagram s. In Fig. 1 the diagram s (c), (e), (f), (h), (j), (k), (n), (p), and (r) { (v) belong to the rst category, while the others are from the second category. The form er diagram s can be constructed from the irreducible diagram s by connecting them with hopping lines. Notice that a prefactor of some composite diagram is the product of prefactors of its irreducible parts [cf., eg., the irreducible diagram s (a), (d) and the composed diagram s (j), (k) in Fig. 1]. If we denote the sum of all irreducible diagram s as K (n⁰; n), the equation for G reen's function can be written as

This equation has the form of the Larkin equation. 14

The partial sum mation can be carried out in the hopping lines of cum ulants by inserting the irreducible diagram s into these lines. In doing so the hopping constant t_{nn^0} in the respective form ulas is substituted by

For the diagram (b) in Fig.1 inserting irreducible diagram s into the hopping line leads to the diagram s (g), (m), and (q).

D ue to the translation and time invariance of the problem the quantities in Eqs. (6) and (7) depend only on differences of site indices and times. The use of the Fourier transform ation

In the approxim ation used below the total collection of irreducible diagram s K $(k; i!_1)$ is substituted by the sum of the two sim plest diagram s (a) and (b) appearing in the rst two orders of the perturbation theory. Due to the form of the latter diagram this approximation is referred to as the one-loop approximation. In the diagram (b) the hopping line is renormalized in accordance with Eq. (9). Thus,

are the Fourier transforms of cumulants (5), N is the number of sites and we set $t_k = 0$. Notice that in this approximation K does not depend on momentum.

Now we need to calculate the cumulants in Eq. (10). To do this it is convenient to introduce the Hubbard operators $X_n^{ij} = jin ihjn jwhere jin i are eigenvectors of site H am iltonians form ing H_0, Eq. (3). For each site there are four such states: the empty state jDniwith the energy E_0 = 0, the two degenerate singly occupied states j niwith the energy E_1 = and the doubly occupied state jDniwith the energy E_2 = U = 2. The Hubbard operators are connected by the relations$

with the creation and annihilation operators. The com – mutation relations for the Hubbard operators are easily derived from their de nition. Using Eq. (11) the rst cumulant in Eq. (5) can be computed straightforwardly:

where $Z_0 = e^{E_0} + 2e^{E} + e^{E_2}$ is the partition function, $E_{ij} = E_i - E_j$. As indicated in Refs. 8,10,13, if K (k; i!_1) is approximated by this cumulant the result corresponds to the Hubbard-I approximation.²

To calculate K $_2$ it is convenient to use W ick's theorem for H ubbard operators: 5,6,7,8

where the averaging and time dependencies of operators are determ ined by the H am iltonian H₀, is the index combining the state and site indices of the Hubbard operator. If X is a ferm ion operator (X⁰, X² and their conjugates), P_k is the number of permutation with other ferm ion operators which is necessary to transfer the operator X from its position in the left-hand side of Eq. (13) to the position in the right-hand side. In this case

In Eq.(13), $[X_{\rm k};X_{\rm k}]$ denotes an anticom m utator when both operators are of ferm ion type and a commutator in other cases.

The substitution of Eq. (11) in hT a (0)a ()a ()a (1) a (1) in K 2, Eq. (5), leads to six nonvanishing averages of H ubbard operators (such averages are nonzero if the num bers of the operators X 0 and X 0 coincide in them, and the same is true for the pair X 2 and X 2). Applying W ick's theorem (13) to these averages the num – ber of operators in them is sequentially decreased until only tim e-independent operators are retained. For H $_{0}$ in Eq. (3) these are X 00 , X ${}^{\circ}$, and X 22 . Their averages are easily calculated. As a result, after some algebra we nd

The rst term in the equation for ${}_{1}K_{2}$ is the even function of i! ${}_{l_{1}}$. It goes not contribute to the sum over ${}_{l_{1}}$ in Eq. (10), since ${}_{k}t_{k}^{2}G$ (k; i! ${}_{l_{1}}$) is supposed to be an odd function of i! ${}_{l_{1}}$. Thus, nally Eq. (10) acquires the form

A nalogous equations were obtained in Refs. 8,10,13 (in Ref. 8 the last term in the right-hand side of the equation is three times smaller, because diagrams with spin propagators were not taken into account there).

Let us turn to real frequencies by substituting $i!_1 w$ ith z = ! + i where is a small positive constant which a ords an articial broadening. Results given in the next section were calculated with G (k;z) in the right-hand side of Eq. (18) taken from the Hubbard-I approximation. A sm entioned, this G reen's function is obtained if K (k!) in Eq. (8) is approximated by the rst cumulant (12). For half-ling we nd

Below the two-dimensional square lattice is considered. It is supposed that only the hopping constants between




FIG. 2: The imaginary part of K (!) calculated using Eqs. (18) and (19) for a 100 100 lattice, $t = \frac{1}{8}U$ and = 0.01U (the dashed line). The solid line shows the corrected = K (!) (see text).

nearest neighbor sites t are nonzero which gives $t_k = 2t[\cos(k_x) + \cos(k_y)]$ where the intersite distance is taken as the unit of length.

III. SPECTRAL FUNCTION

Figure 2 dem onstrates = K (!) calculated with the use of Eqs. (18) and (19). The change to real frequencies carried out in the previous section converts the M atsubara function (2) into the retarded G reen's function.²⁰ It is an analytic function in the upper half-plane which requires that = K (!) be negative. As seen from Fig. 2, this condition is violated at $! = \frac{U}{2}$. This di culty of the considered approximation was indicated in Ref. 13. The problem is connected with divergencies at $!_d = and$ U introduced by functions g_0 (!) and g_2 (!) in the above form ulas. As can be seen from the procedure of calculating the cum ulants in the previous section, these functions and divergencies with sign-changing residues will appear in all orders of the perturbation expansion (4). It can be expected that in the entire series the divergencies com pensate each other, however, in the considered subset of term s such com pensation does not occur. Nevertheless, as seen from Fig.2, at frequencies neighboring to $!_d$ cumulants are regular and, if the used subset of diagram s is expected to give a correct estim ate of the entire series for these frequencies, the value of = K (!) at the singular frequencies can be reconstructed using an interpolation and its values in the regular region. An example of such interpolation is given in Fig. 2.

The function K (z) has to be analytic in the upper halfplane also and therefore its real part can be calculated from its in aginary part using the K ram ers-K ronig relations. We use this way with the interpolated = K (!) to avoid the in uence of the divergencies on < K (!). How -




FIG.3: The spectral function A (k!) calculated for m om enta along the route shown in the inset. An 8 8 lattice, t = $\frac{1}{4}U$ and = 0.2U.

ever, the use of the interpolation overrates som ew hat values of $\frac{1}{2}$ K (!) jwhich leads to the overestim ation of the tails in the real part. To correct this defect the interpolated K (!) is scaled so that its real part for frequencies $\frac{1}{2}$ j $\frac{U}{2}$ coincide with the values obtained from Eq. (18). It is worth noting that such obtained spectral function

satis es the norm alization condition $\binom{K_1}{1}$ d!A (k!) = 1 with an accuracy better than 0.01.

The spectral function obtained in this way with the use of Eqs. (18), (19), and (20) for momenta in the Brillouin zone of an 8 8 lattice is shown in Fig.3. In these calculations the sm all lattice and a comparatively large articial broadening were used to reproduce the conditions of M onte-C arb calculations carried out in Ref. 22. C om paring Fig.3 with Fig.5 in that work we nd close similarity of these two groups of spectra { not only the general shapes of spectra are close but also the position of m axim a in them. Some discrepancies can be also noticed. In particular, in the spectrum for $k = (\frac{1}{2}; \frac{1}{4})$ in Fig.3 the intensity of m axim um at a positive frequency is larger than in the respective spectrum in Ref. 22 (in

this latter spectrum this maximum looks like a barely perceptible peculiarity).




FIG. 4: The upper panel: the spectral function A (k!) calculated for m on enta along the sym m etry lines of the square B rillouin zone. The lower panel: the dispersion of m axim a in the upper panel show n as a gray-scale plot with darker areas corresponding to larger intensity of m axim a. A 100 100 lattice, t = $\frac{1}{9}$ U and = 0:1U.

The spectral function for a larger U is shown in Fig. 4 where the momenta along the symmetry lines of the square Brillouin zone were chosen. Let us com pare these results with the spectra in Fig. 1 in Ref. 17 which were obtained in M onte-C arlo calculations with the sam e ratio U=tj in an 8 8 lattice. We found that the results shown in Fig. 4 change only slightly with decreasing the lattice size to this value. The com parison has to be carried out with low-tem perature spectra of Ref. 17, since Eq. (17) used in our calculations was derived for the case Т U. Notice that in this lim it at half-lling the spectral function in the used approximation does not depend on tem perature. Again we nd that our calculated spectra are close to those obtained in the M onte-C arlo calculations, though there are some di erences in relative intensity of maxima. In our spectra som e maxima resolved in the M onte-C arb calculations bok like shoulders ofm ain m axim a and a decrease of the arti cial broadeninα does not convert the shoulders to maxima. On the other hand, the maxim a at ! 2jtj in the spectra form om enta near (0;0) and at ! 2 jjin the spectra for momenta near (;) which are well resolved in our results are barely perceptible in Fig. 1 of Ref. 17. The possible reason for these di erences can be established from the comparison of Figs. 3 and 4. The respective maxima in the former gure for the smaller U are less intensive. Apparently, like the Hubbard-I approximation, the used approach som ew hat overestim ates the electron correlations. Nevertheless, Fig. 4 reproduces correctly the most essential features of the spectra obtained by the M onte-C arlo m ethod.

One of these features recently reproduced also in the cluster perturbation¹⁸ and the two-particle selfconsistent¹⁹ calculations is the four-band structure of the spectrum . In Fig. 4 these bands are located near frequen-3jtjand ! = 6jtj. The high-frequency bands cies! = are observed near the (0;0) and (;) points, while the low-frequency bands have a larger existence dom ain in our calculations. Sim ilar four bands can be identi es in Fig. 3. A more detailed treatment of the low-frequency bands shows that either of them in turn contain two com ponents. Maxima in A (k!) arise by two reasons { due to the sm allness of the denom inator in Eq. (20) when a frequency satisfying the equation 1 $t_{k} < K$ (!) = 0 falls into a region of a small damping j = K (!) j and due to the strong frequency dependence of = K (!) in the numerator of Eq. (20). The high-frequency bands and the low-frequency bands in the central part and at the periphery of the Brillouin zone arise due to the rst reason. As seen from Fig. 2, the regions of sm all dam ping are bcated on either side of the two maxim a in = K (!) which gives rise to the well-separated four bands. However, for m om entawhich are close to the boundary of the magnetic Brillouin zone the equation 1 $t_{k} < K$ (!) = 0 has no solutions due to a small or vanishing t_k . In this case the twomaxima of A (k!) originate from the twomaxima in

j=K (!) j. They are located in the same frequency ranges as the low-frequency maxim a originated from the resonance denom inator in Eq. (20). Therefore they can be combined in a common dispersion band, although widths of the maxim a of di erent origin can signi cantly vary for a sm aller arti cial broadening.

As can be seen from Eqs. (8), (18), and (19), the used approximation does not describe the M ott transition { for ! 0 the density of states (!) = N^{1⁻¹} A (k!) at ! = 0 vanishes for any nite U. This aw can be remedied by going to the next approximation. The use of approximation (19) in Eq. (18) means that only diagrams (a) in Fig.1 are inserted in the hopping line of the diagram (b). If these latter diagrams are also inserted in the line, Eq. (18) is transformed to the following selfconsistent equation for the irreducible part:

For the initial electron dispersion t_k described by the sem ielliptical density of states

where B is the halfwidth of the band, Eq. (21) can be solved analytically and the condition for the disappearance of the gap at ! = 0 in (!) can be found. It happens when U $U_c = 3B$ and the gap opens when $U > U_c$. A nalogous results for som ew hat di erent equations and initial dispersions were obtained in R efs. 7,8,13.

IV. CONCLUSION

The considered diagram technique is very promising for a generalization to many-band Hubbard models for which energy parameters of the one-site parts of the Ham iltonians exceed or at least are comparable to the intersite param eters. The expansion in powers of these latter param eters can be expressed in terms of cum ulants in the sam e m anner as discussed above. Now there are distinct cum ulants which belong to di erent site states characterized by dissimilar parameters of the repulsion and the level energy. These cum ulants are described by form ulas sim ilar to Eqs. (12) and (16). For example, for the $Em ery m odel^{23}$ which describes oxygen 2p and copper $3d_{x^2}$ v² orbitals of Cu-O planes in high-T_c superconductors there are two types of cum ulants corresponding to these states. Diagram s of the lowest orders, e.g., for G reen's function on copper sites resemble those shown in Fig.1 where \oxygen" cum ulants are included in hopping lines. Equations of the type of Eq. (8) and partial sum m ations sim ilar to Eq. (9) can be derived also in this case.

In summary, the diagram technique for the one-band Hubbard model was form ulated for the case of moderate to strong Hubbard repulsion. The expansion in powers of the hopping constant is expressed in terms of site cumulants of electron creation and annihilation operators. For G reen's function the equation of the Larkin type was derived and solved for the case of two dim ensions, nearest-neighbor hopping and half-lling. The obtained spectrum contains four bands. It was shown that maxima of the spectral function forming the bands are of dissim ilar origin in di erent regions of the Brillouin zone { in its central part and at the periphery the maxin a stem from the resonance denom inator in the form ula for the spectral function, while near the boundary of the magnetic Brillouin zone they originate from the strong frequency dependence of the irreducible part in the numerator of this formula. The obtained band structure and the shapes of the spectral function are close to those found in the M onte C arb calculations.
