Sm all param eter for lattice m odels with strong interaction

D iagram series expansion for lattice models with a localized nonlinearity can be renorm alized so that diagram vertexes become inreducible vertex parts of certain in purity model. Thus renorm alized series converges well in the very opposite cases of tight and weak binding and pretends to describe in a regular way strong-correlated systems with localized interaction. Benchmark results for the classical O (N) models on a cubic lattice are presented.

One of the key problems of the modern condensedmatter theoretical physics is the quest for a regular description of the strong correlations [1]. Roughly speaking, correlations are strong if the nonlinearity and coupling are comparable, and therefore perturbative approaches make no sense.

Consider a lattice model with local coupling between cells with a nonlinearity localized inside each cell. In the two limit cases of the weak and tight binding a series expansion can be performed in powers of the respective small parameters [2]. One of a few regular ways to handle the situation of crossover is to employ the concept of bcalized correlations. It basically m eans that interaction of each cellw ith the rest of the system can approxim ately be described as an interaction with certain non-correlated e ective bath 3]. The parameters of this bath are to be found self-consistently. If there is, say, one particle per cell, it means that realmulti-site problem is approxin ated by much simpler single-site one ("impurity problem "). An example of such an approach is the mean-eld description of the classical statistical ensembles of interacting particles. In this scheme, interaction of a particle with its uctuating surrounding is replaced with interaction of a particle with a constant average eld. There is a self-consistent equation for this eld. An accuracy can be dram atically increased for change the mean-eld by Gaussian-bath approximation. In this case, the surrounding is approxim ated by certain G aussian ensemble. It is important that alm ost the same argum entation can be presented for very wide class of systems. Particularly, so-called dynam icalm ean-eld theory (DMFT) for strongly interacting ferm ions is essentially a Gaussianbath approximation [4].

Physically, G aussian-bath approximation consists in the assumption that the irreducible part of high momenta is localized inside a single site. The strong point of this assumption is that it is valid for several very diement limits for systems with localized nonlinearity. The approximation reproduces leading-order results of the weak- and tight-binding series expansion simultaneously. Indeed, if the nonlinearity is small, the perturbation theory explicitly says that correlations are localized in the st-order of weak-binding approximation. On the other hand, if coupling goes to zero, sites become alm ost isolated and correlations are obviously localized, no matter how strong the nonlinearity is. Once the two opposite lim its are described well, their crossover can be expected to be also somehow depicted. There is some more justications for the scheme, particularly it becomes exact for a system of an in nite dimensionality.

Since an analysis of proper in purity problem gives a good understanding of the properties of stronglycorrelated systems, it is desirable to construct a perturbation theory starting from the solution of an impurity problem as a zeroth approximation. A theory of this kind is presented in this paper for lattice models with a localized nonlinearity. We exactly renormalize diagram expansion so that diagram vertexes become irreducible vertex parts of certain impurity problem. An important peculiarity of the proposed approach is that a good convergence is achieved both in tight-binding and weakbinding situations. As an example, we present the results obtained for quantum Ising model in a transverse edd.

We consider statistics of the real vector eld on a discrete lattice with a localized nonlinearity () and the dispersion law . In general, lattice potential can depend on a number of the lattice site. Through the article we number sites by x whereas components of the on-site eld $_{\rm x}$ are numbered by j, statistical average is denoted by triangle brackets:

Consider an auxiliary ensemble with energy

We introduced here vector quantity ⁰ and a Herm itian tensor A having non-zero terms only at the same x-indices: $A_{xx^0} = 0$ for $x \in x^0$ (through the text we call such quantities 'x-diagonal'). The values of A and ⁰ are not speci ed for a while. Since A is x-diagonal, site oscillators of the auxiliary ensemble are uncoupled (one can see that E^{aux} () splits to a sum of independent single-site energies). Thus, properties of the auxiliary system at each site can be obtained as a solution of a single-site in purity problem. D enote an average over the auxiliary ensemble by overline and introduce normalized two-point correlator and higher-order irreducible vertex parts at the sites of auxiliary system :

To simplify the notation, we om it site index x and write numbers as subscripts for the on-site coordinates here.

It should be noted that mean-eld and Gaussian-bath approxim ations can be understood as approxim ations of the system (1) by (2) with a self-consistent requirement 0 = and certain choice of A_{xx} . Indeed, to obtain the mean-eld scheme, one should, rst, replace all in E () with its average for all cells except just a single one, and, second, use an average over this particular cell as a guess for < >. It is easy to check that the mean-eld corresponds to the simple choice $A_{xx} = x_x$. Gaussian-bath approximation also reduces the system to a single-site problem. The di erence is that the remaining degrees of freedom are not frozen in its average positions, but approximated with harm onic oscillators, forming Gaussian bath. These Gaussian degrees of freedom can be integrated out, giving again single-site energy like in (2) with certain A. An approximation for the single-site system by a harm onic oscillator can be found from the requirem ent that the approximation mimics \overline{x} and g_{xx} . Thus obtained parameters of harmonic oscillators are to be used as in the next iteration of the self-consistent loop as parameters of the oscillators forming the bath. These iterations converge to the point where x-diagonal part of the tensor g + (A)¹ vanish. This is in fact a condition for A of the Gaussian-bath approximation.

The aim of this paper is to express averages (1) via , g and $^{(n)}$ by certain regular series. The quantities A and $_0$ will determ ined by certain self-consistent conditions.

First, we would like to introduce the "dual" variables f. Let us consider the basis where g(A) g is diagonal and label the states in this basis by p. De ne the integration \mathbb{P} f] df_{p1} ::: df_{pn} ::: in such a way that the path of integration in each integral depends on a sign of diagonal element (g(A)g)_{pp}: f_p goes from 1 to 1 for (g(A)g)_{pp} f 0 and from i1 to i1 overwise. With thus de ned \mathbb{P} f], the following identity holds:

In fact, the path of integration over f_p is chosen to deliver the convergence of integrals here. A fier this identity is applied, partition function takes the form



A set of exact relations between the averages over initial and dual ensemble can be established by the integration by parts in (5) with respect to f. Particularly,

The idea of an introduction of new variables is that

energy (5) does not contain direct coupling between dif-

ferent sites for the initial variable , since $(g^{1}f) =$ $_x$ ($_x$ (g¹ f)_x). Therefore $_x$ can be integrated out at each site, yielding an an expression for the energy in dual variables E (f):

This expression is form ally very similar to an initial system (1). Physical di erence com es, rst, from the possibility to choose A and ⁰ in certain optimalway, and, second, from the the non-trivial way of integration over f so that f has an imaginary part. In particular, $< f_{xj}^2 >$ can be negative or equal zero.

Properties of the dual potential V (f) are determ ined by the cum ulant expansion (2) for an auxiliary system . The last term in (7) is chosen in such a way that the second derivative of V vanishes; other derivatives are ⁰)g¹ and $V^{(n)} = (n)$ for n $V^{(1)} = ($ 3. To describe e ects due to non linearity, we introduce tensor n

so that ⁰ describes a non-local contribution to the selfenergy of the initial system (1). It follows from the second line of (6) that dual two-point correlator can be expressed as follow s: via

All expressions presented above are exact. Now, we construct a perturbation theory resulting from the series expansion in powers of V. Terms of these series can be expressed by the diagram swith ⁽ⁿ⁾ standing at vertexes connected with lines carrying dualtwo-point correlator < f f > .W e consider the series for ⁰. It can be found from the expansion of the left- and right-hand side of (9) in powers of V and ⁰, respectively. Som e of those diagram s are presented in Figure 1. Each diagram is accompanied by an additional factor ¹ and a num erical coe cient. It can be found from the above-m entioned expansion of (9).

Form ally, single-lag vertexes can occur in the diagram s due to the presence of V $^{(1)}$ in the dual energy (7). W e require such 0 that < f > = 0 to get rid of them . Then the rst line of 6) requires

Since ⁽ⁿ⁾ of any order can in principle appear in the series, a form al sm all param eter should be introduced to group the terms properly. Consider a special case of a scalar eld with small nonlinearity: U() = ⁴, ! + 0. Estimate how appears in high derivatives ofV (f): ${}^{(2n)}$ / n and ${}^{(2n \ 1)}$ / n $_{0}$. We propose to group diagram s with respect to their form al sm allness in powers of . This is clearly a good choice for a weak-binding lim it. Consider the opposite case of tightbinding ! 0 and suppose that our choice of A delivers also (A)! 0 (note that mean-eld and Gaussianbath schemes satisfy this condition). It is obvious from (7) that bare two-point correlator appears to be a sm all quantity in this case. Since the number of lines in a diagram is roughly proportional to its -order, again appears to be a good sm all param eter. W e conclude that series expansion converges well both in tight-binding and weak-binding lim its and therefore expect that the theory is suitable for a crossover situation.

Form ally, series expansion can be constructed for any A, but an appropriate choice should result to better convergence. It is useful to require

One can form ally obtain Gaussian-bath approximation as a result of G aussian approximation for < f f > in(9), combined with requirem ents (10,11). Gaussian approximation means⁰ order of the theory. Higher terms of an expansion in powers of improve the result and, in particular, bring non-local correlations on the scene.

To dem onstrate capabilities of the m ethod and to give more technical details, we present here the results obtained in an 2 -approximation for classical (N) models at 3D cubic lattice with the nearest-neighbor coupling. Potential energy is

where x is an N-component vector of the constrained length $j_x j_x^2 = (x_x) = N$. In the previous notation, dispersion law is $_{k} = (\cos k_{x} + \cos k_{y} + \cos k_{z})$, whereas the constrain makes the system nonlinear. Sum is over all pairs of the nearest neighbors. Cases of N = 1;2;3correspond to Ising, xy, and Heisenberg models, respectively. In three dimensions, system (12) shows a secondorder phase transition at nite tem perature for N. The m odel is extensively studied. One can note M onte C arlo simulations [5, 6], high-temperature expansion [7] (in

our term inology, this is in fact tight-binding approach), renorm alisation-group m ethods [8] etc. Here we do not pretend to obtain som ething new for the m odel itself. It is used to check if the m ethod works for a realistic system.

For simplicity, let us consider an unordered state < > = 0, so that only even-lag vertexes appear in diagrams, ${}^{(2n+1)=0}$. It can be easily obtained that $g_{12} = {}^{1}_{12}$ (irrespective on N) and ${}^{(4)}_{1234} = {}^{N}_{12 34} + {}^{13 24} + {}^{14 23}$) with ${}^{N}_{N=1} = 2=3$; ${}^{N}_{N=2} = 1=2$; ${}^{N}_{N=3} = 2=5$. Here is a K ronecker delta. Tensor structure of g, ${}^{(4)}_{1}$, as well as A, corresponds to the O (N) symmetry of the problem.

The self-consistent equation for a follows from (8) and (11):

Technically, this equation can be solved iteratively, sim ilarly to DMFT-loop technique [4]. Start from certain guess for A and ⁰. For a general case, one should calculate g(A) and ⁽ⁿ⁾ (A) at this point, but for a particular model (12) it is not necessary as g and do not depend on A, because of the constrain $jj_x jf = N \cdot Cal$ culate < f f > from 9, given g; A, and ⁰. For thus obtained < f f > and (n), calculate new guess for 0 for a given order in (see below expressions for 0 up to 2). Finally calculate the right-hand side of (13), given g;A, and new ⁰. Denote the obtained value by g and take the quantity $A + (g^1 g^1)$ as new guess for A, where . 1 is a num erical factor. Repeat the loop for new A and ⁰. For properly chosen initial guess and value of iterations converge to a xed point satisfying equation (12).

G aussian-bath approximation corresponds to an assumption $^{0} = 0$. Corrections are given by the diagram s presented in Figure 1. Lines in these diagrams are thick, i.e. they correspond to the renormalized correlator < f f > . First-order correction would be given by a simple loop shown as diagram (a) in Figure 1. This diagram corresponds to form ula $\frac{1}{2}$ (4) < f_x f > . It is how ever absent, because < f_x f > equals zero in G aussian-bath approximation, as it can be obtained from (6) and (13). So the correction starts actually from 2

Strictly speaking, once high-order corrections are taken into account, $\langle f_x \\ \pm \rangle$ does not vanish anym ore. But it rem ains sm all. It can be shown that sim ple bops does not appear in diagram s up to ³ order. Consequently, second-order correction to ⁰ can be described by just a single diagram (b) drawn in Figure 1, so that $0 \\ xx^0 = \frac{1}{6}$ $2 < f_x$ $\pm 0 > 3$. A fler the sum over internal indices is taken, it gives $0 \\ xx^0 = 1$ 2 $(1 + N = 2)f_{x,x^0}^3$, where f_{x,x^0} is a diagonal element of the dual correlator.




FIG.2: E ective soft-m ode dispersion for 0 (N) m odel at N = 1;2;3. D ashed line: G aussian-bath approximation. Solid lines: results for the ²-scheme, from bottom to top: N = 1 (Ising), N = 2 (xy), and N = 3 (Heisenberg). In a narrow region near critical point the iteration procedure did not converge, and the lines are not drawn. Symbols are num erical data for N = 1;2;3: respectively solid circles, open circles and crosses. D otted line is a t corresponding to a purely critical' behavior of < > in Ising m odel.

Figure 2 shows data for the e ective soft-m ode dispersion $_0$ (< $_{k=0}$ $_{k=0}$ >)¹. Dots are num erical data. Data for the lines are obtained by form ula

 $_0 = g^1 + _{k=0} + ^0$ A. Iteration procedure converges well everywhere except very narrow regions near critical point. Since we were not interested in a description of the critical point itself, we did not put special attention to the source of this divergence.

G aussian-bath approximation predicts the same dependence for any N, as one can observe from (13) with $^{0} = 0$. This is a serious qualitative drawback, although the quantitative accuracy is not so bad. So, the dependence of $_{0}$ on N in the model is related with a non-local part of correlations, and should be described by higher terms of -corrections. Indeed, ²-correction describes the dependence $_{0}$ (N) well. There is also a dramatic increase of the accuracy in the ² curves.

For the broken-sym m etry state, the theory can be constructed in a very similar manner. Iteration loop now includes also a modi cation of 0 to full lithe condition (10) at a xed point. Diagram (c) from Figure 1 appears due to the presence of $^{(3)}$. We do not show num erical results here, because they are very similar to what we obtain for the unordered state.

The entire plot range of F igure 2 lies within a critical region. For example, all points for Ising model obey critical scaling law $\langle {}_{k=0}^{2} \rangle / ({}_{c})^{1:24}$ with a good accuracy, as the dashed line shows. Thus the theory performs well deep inside the critical region. However, the very vicinity of the critical point is not correctly described, because we work with perturbation theory of a nite order. It would be worth to construct a renorm alization approach. An attempt to construct a primitive approach of this kind starting from mean-eld theory was perform ed several years ago [10].

There is a comment about an applicability of other approximation schemes. The system is strongly nonlinear, so weak-binding approximation is clearly not valid here. On the other hand, tight-binding description of a low order fails near the phase transition point because of the critical increase of the correlation length. For example, second order of the tight-binding series gives $_{0} = ^{1} (1+4)^{1}$. This is very inaccurate; corresponding curve simply lies out of the plot range of Figure 2. M ore sophisticated schemes, for example, cumulant expansion, also require much higher order to achieve an accuracy comparable with the presented 2 results. It is also important to recall that Gaussian-bath approximation becomes exact in the limit N $\ ! \ 1$, and 1=N expansion can be constructed at this point [11]. But 1=N approach is essentially based on a very particular O(N) symmetry of system (12). Contrary, our method is developed for a general case and does not require any special sym m etry.

In conclusion, we presented an exact renormalization of the diagram -series expansion in terms of the selfconsistent impurity model. Renormalized vertexes are irreducible vertex parts of the impurity model. There

is an explicit small parameter in the theory for weakbinding and tight-binding limit. A worked example of an ²-approximation for simple 3D models demonstrates that the method perform swell for a strong-correlated situation. The example models were chosen because of the physical simplicity; the method itself looks rather general. It would be particularly important to extend it to the systems of identical quantum particles. Another challenge is a construction of renorm alization-group theory based on the method.
