Sem i-ferm ionic representation for spin system s under equilibrium and non-equilibrium conditions

We present a general derivation of sem i-ferm ionic representation for spin operators in term s of a bilinear combination of ferm ions in real and imaginary time form alisms. The constraint on ferm ionic occupation numbers is full led by means of imaginary Lagrange multipliers resulting in special shape of quasiparticle distribution functions. We show how Schwinger-Keldysh technique for spin operators is constructed with the help of semi-ferm ions. We demonstrate how the idea of semi-ferm ionic representation might be extended to the groups possessing dynamic symmetries (e.g. singlet/triplet transitions in quantum dots). We illustrate the application of semi-ferm ionic representations for various problems of strongly correlated and mesoscopic physics.

Introduction

It is known that spin operators satisfy neither Ferm i nor Bose commutation relations. For example, the Pauli matrices for S = 1=2 operator commute on dierent sites and anticom mute on the same site. The commutation relations for spins are determined by SU (2) algebra, leading to the absence of a Wick theorem for the generators. To avoid this di culty and construct a diagram matic technique and path integral representation for spin systems various approaches have been used. The rst class of approaches is based on representation of spins as bilinear combination of Fermi or Bose operators $^{1-7}$, whereas the representations belonging to the second class deal with more complex objects like, e.g. the Hubbard 8 and supersymmetric 9 operators, the nonlinear sigm a model 10 etc. However, in all cases the fundamental problem which is at the heart of the diculty is the local constraint problem. To illustrate it, let's consider e.g., rst class of representations. Introducing the auxiliary Ferm i or Bose elds makes the dimensionality of the Hilbert space, where these operators act, greater than the dim ensionality of the Hilbert space for the spin operators. As a result, the spurious unphysical states should be excluded from the consideration which leads in turn to some restrictions (constraints) on bilinear combinations of Ferm i/B ose operators, resulting in substantial complication of corresponding rules of the diagram m atic technique. The representations from the

second class su er from the same kind of problem, transformed either into a high nonlinearity of resulting model (non-linear sigm a model) or hierarchical structure of perturbation series in the absence of W ick theorem (Hubbard operators). The exclusion of double occupied and empty states for a S = 1=2 impurity interacting with conduction electron bath (single impurity K ondo model), is controlled by ctitious chem ical potential (Lagrange multiplier) of Abrikosov pseudoferm ions 5. At the end of calculations this \chem ical potential" should be put! \freeze out" all unphysical states. In other words, there exists an additional U (1) gauge eld which freezes the charge uctuations associated with this representation. The method works for dilute systems where all the spins can be considered independently. Unfortunately, attempts to generalize this technique to the lattice of spins results in the replacement of the local constraint (the number of particles on each site is xed) by the so-called global constraint where the number of particles is xed only on an average for the whole crystal. There is no reason to believe that such an approximation is a good starting point for the description of the strongly correlated system s. A nother possibility to treat the local constraint rigorously is based on M a jorana ferm ion representation. In this case ferm ions are \real" and corresponding gauge sym m etry is Z_2 . The di culty with this representation is mostly related to the physical regularization of the uctuations associated with the discrete sym m etry group.

An alternative approach for spin H am iltonians, free from local constraint problem, has been proposed in the pioneering paper of Popov and Fedotov 11 . Based on the exact ferm ionic representation for S=1=2 and S=1 operators, where the constraint is controlled by purely in aginary Lagrange multipliers, these authors demonstrated the power and simplication of the corresponding M atsubara diagram technique. The semi-ferm ionic representation (we discuss the meaning of this denition in the course of our paper) used by Popov and Fedotov is neither ferm ionic, nor bosonic, but rejects the fundamental Pauli nature of spins. The goal of this paper is to give a brief introduction to a semi-ferm ionic (SF) approach. A reader can indicate a brief introduction to a semi-ferm ionic representation and its application to various problems in the original papers 11 . However, we reproduce the key steps of important derivations contained in 19 , in order to make the reader's job easier.

The manuscript is organized as follows: in Section I, the general concept of sem i-ferm ions is introduced. We begin with the construction of the SF form alism for the fully antisym metric representation of SU (N) group and the fully sym metric SF representation of SU (2) group using the imaginary-time (Matsubara) representation. We show a bridge between dierent representations using the simplest example of S = 1 in SU (2) and discuss the SF approach for SO (4) group. Finally, we show how to work with semi-ferm ions in real-time form alism and construct the Schwinger-Keldysh technique for SF. In this section, we will mostly follow original papers by the author 12 , 19 . The reader acquainted with semi-ferm ionic technique can easily skip this section. In Section II, we illustrate the applications of SF form al-

1. Sem i-ferm ionic representation

To begin with, we brie y reproduce the arguments contained in the original paper of Popov and Fedotov. Let's assume $rst\ S=1=2.W$ edenote as H the Hamiltonian of spin system. The standard Paulimatrices can be represented as bilinear combination of Fermioperators as follows:

on each site i of the lattice. The partition function of the spin problem $\ Z$ is given by

where $\hat{H_F}$ is the operator obtained from \hat{H} by the replacement (1) and

(N is the number of sites in the system and = 1=T is inverse temperature). To prove equation (2) we note that the trace over the nonphysical states of the i-th site vanishes

Thus, the identity (2) holds. The constraint of xed number of ferm ions $\hat{N_j} = 1$, is achieved by means of the purely imaginary Lagrange multipliers = i = (2) playing the role of imaginary chemical potentials of ferm ions. As a result, the G reen's function

is expressed in terms of M atsubara frequencies $!_F = 2$ T (n + 1=4) corresponding neither Ferm i nor Bose statistics.

For S = 1 we adopt the representation of \hat{H} in term s of the 3-component Ferm i eld:

The partition function Z is given by

It is easy to note that the states with occupation numbers 0 and 3 cancel each other, whereas states with occupation 1 and 2 are equivalent due to the particle-hole symmetry and thus can be taken into account on an equal footing by proper normalization of the partition function. As a result, the Green's function in the imaginary time representation is expressed in terms of $!_F = 2$ T (n + 1=3) frequencies.

In this section, we show how sem i-ferm ionic (Popov-Fedotov) representation can be derived using the mapping of partition function of the spin problem onto the corresponding partition function of the ferm ionic problem. The cases of arbitrary N (even) for SU (N) groups and arbitrary S for SU (2) group are discussed.

1.1. SU (N) group

We begin with the derivation of SF representation for SU (N) group. The SU (N) algebra is determined by the generators obeying the following commutation relations:

where ; = 1;:::;N .W e adopt the denition of the Cartan algebra 25 of the SU (N) group fH g=S similar to the one used in 26 , noting that the diagonal generators S are not traceless. To ensure a vanishing trace, the diagonal generators should only appear in combinations

which e ectively reduce the number of independent diagonal generators to N $\,$ and the total number of SU (N) generators to N 2 $\,$ 1.




Fig.1. Rectangular Young tableau to denote a SU (N) representation (a), single column tableau corresponding to $n_{\text{c}}=1$ (b) and single row tableau standing for spin S = n_{c} =2 representation of SU (2) group (c).

In this paper we discuss the representations of SU (N) group determ ined by rectangular Young Tableau (YT) (see 26 and 19 for details) and mostly concentrate on two important cases of the fully asymmetric (one column) YT and the fully symmetric (one row) YT (see Fig.1).

The generator \hat{S} may be written as biquadratic form in terms of the Fermi-operators

restrict the H ilbert space to the states with m $$^{\circ}_{\circ}$ particles and ensure the characteristic sym m etry in the color index a. Here m ${}^{\circ}_{\circ}$ corresponds to the number of rows in rectangular Young Tableau whereas n_c stands for the number of columns. The antisymmetric behavior with respect to ${}^{\circ}_{\circ}$ is a direct consequence of the fermionic representation.

Let us consider the partition function for the H am iltonian, expressed in terms of $SU\ (N\)$ generators

where Tr^0 denotes the trace taken with constraints (11). As it is shown in 19 , the partition function of SU (N) model is related to partition function of corresponding ferm ion model through the following equation:

here P ($_{\rm j}$) is a distribution function of im aginary Lagrangem ultipliers. We calculate P ($_{\rm j}$) explicitly using constraints (11).

We use the path integral representation of the partition function

and the ferm ionic representation of SU (N) generators (10) is applied.

Let us rst consider the case $n_c=1.W$ e denote the corresponding distribution by $P_{N,m}$ ((j)), where m is the number of particles in the SU (N) orbital, or in other words, 1 m < N labels the dierent fundamental representations of SU (N).




Fig. 2. Graphical representation of exclusion principle for SU (N) sem i-ferm ionic representation with even N, $n_c = 1$ (we use = i T=2 for SU (2) and $_1 =$ i T=4; $_2 =$ 3i T=4 for SU (4)).

To satisfy this requirement, the m inimal set of chemical potentials and the corresponding form of $P_{N,m}$ ((j)) are to be derived (see Fig.2).

To derive the distribution function, we use the following identity for the constraint (16) expressed in terms of G rassmann variables

Since the H am iltonian is sym m etric under the exchange of particles and holes when the sign of the Lagrange multiplier is also changed simultaneously, we can simplify (18) to

its, we nevertheless keep the ratio $m = N = 1 = 2 \times d$. Then, the following \lim iting distribution function can be obtained:

We note the obvious sim ilarity of the lim iting DF (22) with the G ibbs canonical distribution provided that the W ick rotation from the lim aginary axis of the Lagrange multipliers to the real axis of energies E is performed and thus (j)N = 2 has a meaning of energy.

Up to now, the representation we discussed was purely ferm ionic and expressed in term sofusualG rassmann variables when the path integral form alism is applied. The only dierence from slave ferm ionic approach is that in aginary Lagrange multipliers are introduced to full lithe constraint. Nevertheless, by making the replacement




Fig. 3. The minimal set of M atsubara frequencies for a) SU (N) representation with even N / SU (2) representation for half-integer value of the spin.b) SU (2) representation for integer values of the spin and l=1.

of sem i-ferm ions with M atsubara frequencies di erent from both Ferm i and Bose representations (see Fig.3).

The exclusion principle for this case is illustrated on Fig 2, where the S=1=2 representation for the rst two groups SU (2) and SU (4) are shown. The rst point to observe is that the spin H am iltonian does not distinguish the n particle and the n hole (or N n particle) subspace. Eq. (19) shows that the two phase factors $\exp(n)$ and $\exp(N n)$ accompanying these subspaces in Eq. (20) add up to a purely imaginary value within the same Lagrange multiplier, and the empty

have multiple Lagrange multipliers, the distribution function P () linearly combines these imaginary prefactors to select out the desired physical subspace with particle number $n\,=\,m$.

In Fig.2, we note that on each picture, the empty and fully occupied states are cancelled in their own unit circle. For SU (2) there is a unique chem ical potential = i $\,$ T=2 which results in the survival of single occupied states. For SU (4) there are two chem ical potentials (see also Fig.3). The cancellation of single and triple occupied states is achieved with the help of proper weights for these states in the distribution function whereas the states with the occupation number 2 are doubled according to the expression (21). In general, for SU (N) group with $n_{\rm c}=1$ there exists N=2 circles providing the realization of the exclusion principle.

1.2. SU (2) group

W e consider now the generalization of the SU (2) algebra for the case of spin S . Here, the most convenient ferm ionic representation is constructed with the help of a 2S + 1 component Ferm i eld a_k (j) provided that the generators of SU (2) satisfy the following equations:

This result corresponds to the original Popov-Fedotov description restricted to the S=1=2 and S=1 cases.




Fig. 4. G raphical representation of exclusion principle for SU (2) sem i-ferm ionic representation for S=1 and S=2. For any arbitrary integer value of spin there exists S circle diagram S corresponding to the S di erent chem ical potentials and providing the realization of the exclusion principle.

For the case l=m=N=2! 1 and S=(N-1)=2! 1 the expression for the lim iting DF $P_{1,j,l}(\ (j))$ coincides with (23). We note that in S! 1 (or N! 1) lim it, the continuum \chem ical potentials" play the role of additional U (1) uctuating eld whereas for nite S and N they are characterized by xed and discrete values.

When S assumes integer values, the minimal fundamental set of M atsubara frequencies is given by the table in Fig.3.




Fig. 5. The Keldysh contour going from 1 ! 1 ! 1 in real time. The boundary conditions on the imaginary time segment determ ine the generalized distribution functions for quasiparticles.

The exclusion principle for SU (2) in the large spin limit can be also understood with the help of Fig 2 and Fig 4.0 ne can see that the empty and the fully occupied states are cancelled in each given circle similarly to even-N SU (N) algebra. The particle-hole (PH) symmetry of the representation results in an equivalence of single occupied and 2S occupied states whereas all the other states are cancelled due to proper weights in the distribution function (29). In accordance with PH symmetry being preserved for each value of the chemical potential all circle diagrams (see Fig 3, Fig 5) are invariant with respect to simultaneous change \$ and \$n_{\rm particle}\$\$ \$n_{\rm holes}\$.

1.3. Sem i-ferm ionic representation of SO (N) group

In this chapter we show the way of generalization of sem i-ferm ionic representation to the dynam ical algebras o (4) and o (5) (see Appendix A). Like in the case of pure spin operators, these representations should preserve all kinem atical constraints.

The rst step to derive sem i-ferm ionic representation for SO (4) group is based on the local isom orphism of SO (4) and SU (2).

We start with n = 4 - eld representation of SU (2) group (10)

Therefore, we conclude that the antisymmetric (singlet) combination a_{12} a_{21} does not enter the expression for spin S=1 operators. Thus, three (out of four) component Ferm i-eld is su cient for the description of S=1 SU (2) representation in agreement with (27). Dening new elds as follows

The constraint (43) transforms to a standard SU (2) S=1 constraint (48) in both cases $n_s=0$ and $n_s=1$ since there is no singlet/triplet m ixing allowed by SU (2) algebra.

To dem onstrate the transform ation of the local constraint let's $\;$ rst consider the case $n_s=$ 0. The constraint reads as follows

We do not present here ten 5 5 m attrices characterizing SO (5) representation to save a space. The reader can easily construct them using representations (47). There exists also a bosonic representation based on Schwinger bosons which might be derived by the method similar to used above for SO (4) group. The representations of higher SO (n) groups can be constructed in a similar fashion.

K inem atic constraints in posed on auxiliary ferm ions and bosons is in strict compliance with the C asim ir and orthogonality constraints in spin space. A coordingly, the number of ferm ionic and bosonic elds reproduces the dimensionality of spin space reduced by these constraints. We have seen that the 6-D space of generators of SO (4) group is reduced to D=4. Then the minimal (unconstraint) ferm ionic representation for this group should contain two U (1) ferm ions. This means that the representation (46) is not minimal. Apparently, the best way to not such representation is to use Jordan-Wigner-like transformation 10 . The exact form of Jordan-Wigner transformation for SO (4) group was recently reported in 27 . The same kind of arquments applied to SO (5) group tells us that the spinor eld should contain seven

com ponents. This means that the 3-color U (1) ferm ionic representation should be completed by one more real (Majorana) ferm ion, and this fact points to one more hidden $\rm Z_2$ sym metry 10 .

1.4. Real-time form alism

We discuss nally the real-time form alism based on the sem i-ferm ionic representation of SU (N) generators. This approach is necessary for treating the systems out of equilibrium, especially form any component systems describing Ferm i (Bose) quasiparticles interacting with spins. The real time form alism 28 , 29 provides an alternative approach for the analytical continuation method for equilibrium problems allowing direct calculations of correlators whose analytical properties as function of many complex arguments can be quite cum bersome.

To derive the real-time form alism for SU (N) generators we use the path integral representation along the closed time Keldysh contour (see Fig.5). Following

In general the EDF for half-integer and integer spins can be expressed in terms of Ferm i and Bose EDF respectively. We note that since auxiliary Ferm i elds introduced for the representation of SU (N) generators do not represent the true quasiparticles of the problem, helping only to treat properly the constraint condition, the distribution functions for these objects in general do not have to be real functions. Nevertheless, one can prove that the imaginary part of the EDF does not a ect the physical correlators and can be eliminated by introducing an in nitesimally small realpart for the chemical potential. In spin problems, a uniform/staggered magnetic eld usually plays the role of such real chemical potential for semi-ferm ions.

2. Application of sem i-ferm ionic representation for strongly correlated systems

In this Section we illustrate some of the applications of SF representation for various problems of strongly correlated physics.

2.1. Heisenberg model: FM , AFM and RVB

The e ective nonpolynom ialaction $^{31;32}$ for Heisenberg model with ferrom agnetic (FM) coupling has been investigated in 11 . The model with antiferrom agnetic (AFM) interaction has been considered by means of semi-ferm ionic representation in 17 and 18 (magnon spectra) and in 12 for resonance valence bond (RVB) excitations. 2.2. Dicke model

In this Section we describe the application of sem i-ferm ionic approach to two-level systems interacting with single-mode radiation eld (Dicke model). The in uence of dissipative environment on two-level system has been extensively studied in spin-boson model 35 (see also a review 36 for coherent e ects in mesoscopic few level system, Dicke super and sub-radiance e ects). Addressing the reader to above mentioned reviews for discussion of physical implementation of the Dicke model, we discuss in this section only technical aspects related to derivation of its equilibrium (thermodynamical) properties. We closely follow original derivation contained in Popov-Fedotov paper 11.

2.3. Spin-dependent sem i-ferm ionic representation for Hubbard and t-J m odels

In this Section we discuss the spin-dependent Popov-Fedotov representation and application of sem i-ferm ions to Hubbard and t-J m odels.

The interaction U < 0 is attractive and the hopping amplitude is assumed small ju j. The physical situation underlining this lim it of model is characterized by the existence of exactly one single occupied site and empty or double occupied sites otherwise. The physical restriction also imposes a subtle constraint on the corresponding Hilbert space, which requires that all contributions from states with m ore than one unpaired electron are ruled out. Thus, the situation is opposite the Popov-Fedotov lim it where only single occupied states represent physical states of the model, while empty and double occupied states were unphysical and eliminated by the single occupancy condition.

In order to rem ove single occupied states in large negative-U Hubbard model (LNU) from therm odynamic averages, it was proposed 14;37 to introduce an imaginary magnetic eld to the Hamiltonian

A nother example without particle-hole symmetry (dynamical symmetries) will be considered in the Section devoted to application of sem i-ferm ions in mesoscopic physics.

2.4. K ondo lattices: com petition between m agnetic and K ondo correlations

The problem of competition between Ruderm an-Kittel-Kasuya-Yosida (RKKY) magnetic exchange and Kondo correlations is one of the most interesting problem of the heavy ferm ion physics. The recent experiments unambiguously show, that such a competition is responsible for many unusual properties of the integer valent heavy ferm ion compounds e.g. quantum critical behavior, unusual antiferrom agnetism and superconductivity (see references in 20). We address the reader to the review 38 for details of complex physics of Kondo e ect in heavy ferm ion compounds.




Fig. 6. K ondo screening of the local moment in single—impurity K ondo problem. Dashed line denotes sem i-ferm ions, solid line stands for conduction electrons.

W e start with a perfect K ondo lattice. The spin correlations in K L are characterized $J^2 = T_F$; and K" $_{F}$ exp (" $_{F}$ =J) (the inter-site by two energy scales, i.e., I indirect exchange of the RKKY type and the Kondo binding energy, respectively). At high enough tem perature, the localized spins are weakly coupled with the electron Ferm i sea having the Ferm i energy ${}^{\mathrm{u}}_{\mathrm{F}}$, so that the magnetic response of a rare-earth sublattice of K L is of param agnetic Curie-W eiss type. W ith decreasing tem perature either a crossover to a strong-coupling K ondo singlet regim e occurs at $_{K}$ or the phase transition to an AFM state occurs at T = T_{N} is a coordination number in KL. If T_N K the interference between two trends results in the decrease of both characteristic temperatures or in suppressing one of them . The mechanism of suppression is based on the screening e ect due to K ondo interaction. As we will show, the K ondo correlations screen the local order param eter, but leave nonlocal correlations intact. The mechanism of K ondo screening for single-im purity K ondo problem is illustrated on Fig. 6 As a result, the magnetization of local impurity in the presence of K ondo e ect is determined in terms of GF's of sem i-ferm ions G(!) by the following expression 39 :

To take into account the screening e ect in the lattice model we apply the sem iferm ionic representation of spin operators. In accordance with the general path-integral approach to K L's, we rst integrate over fast (electron) degrees of freedom . The K ondo exchange interaction is decoupled by auxiliary eld $^{\rm 40}$ with statistics

com plem entary to that of sem i-ferm ions which prevents this eld from Bose condensation except at T=0. As a result, we are left with an elective bosonic action describing low-energy properties of KL model at high $T>T_K$ temperatures.

K ondo screening of the Neel order

To analyze the in uence of K ondo screening on form ation of AFM order, we adopt the decoupling scheme for the H eisenberg model discussed in Section II.A. Taking into account the classic part of N eel eld, we calculate the K ondo-contribution to the elective action which depends on magnetic order parameter N:

It is seen that unlike the case of local magnetic order, the K ondo scattering favors transition into the spin-liquid state, because the scattering means the involvement of the itinerant electron degrees of freedom into the spinon dynamics.

2.5. Sem i-ferm ionic representation for spin glass models

In this Section we sketch the technicalities related to the application of Popov-Fedotov m ethod to disordered spin system s. W e address the reader to a review 41 on theoretical concepts and experim ental facts on spin glasses.

W e consider Ising/H eisenberg spin glass model

The replica-global term $({}^{\rm P}_{i}\,{\rm S}^{\rm a}_{})^2$ is decoupled by a replica independent Hubbard-Stratonovich eld, while the replica local product $(S_r^a)^2$ requires a replica-dependent decoupling eld 44 . Although it is well known that both SK and isotropic vector model of in nite range spin glass are unstable with respect to Parisi's broken symm etry permutation symmetry 45 , we shall consider rst the replica symmetrical solutions existing only near the phase transition point.

The last step is to integrate over all Popov-Fedotov ferm ions taking the lim it n! 0 and calculate free energy per site

We emphasize, that in the framework of quantum theory treatment we do not have a freedom to choose q freely. In general, the equations for q and q are the set of coupled equations.

2.6. K ondo lattices with quenched disorder

In this Section we consider the Kondo Lattice model (92) with random RKKY interaction. The random ness is associated with e.g. the presence of non-magnetic im purities in magnetic compound resulting in appearance of random phase in the RKKY indirect exchange. In this case the spin glass phase should be considered. As it has been shown in 16 and 20 , the in wence of static disorder on K ondo e ect in m odels with Ising exchange on fully connected lattices (SK model) can be taken into account by the mapping K L model with quenched disorder onto the single impurity K ondo model in random (depending on replicas) magnetic eld. It allows for the self-consistent determ ination of the E dw ards-A nderson $q_{E,A}$ order parameter given by the following set of self-consistent equations

Here $q = q_{EA}$ and q are nondiagonal and diagonal elements of Parisi matrix respectively. Therefore, the Kondo-scattering results in the depression of the freezing tem perature due to the screening e ects in the same way as the magnetic mom ents and the one-site susceptibility are screened in the single-impurity Kondo

problem when Ising and K ondo interactions are of the same order of magnitude. Let's now brie y discuss the uctuation e ects in K ondo lattices. The natural way




Fig. 7. Feynm an diagram s for nonlocal excitations associated with the overlap of K ondo clouds. W avy line denotes K ondo "sem i-B osonic" eld, solid line stands for ferm ions, dashed line denotes sem i-ferm ions.

to construct the uctuation theory is to consider the non-local dynam ical K ondo correlations described by the eld (q;!) (see Fig.7). In fact, the non-locality of the \sem i-B osonic" eld is associated with an overlap of K ondo clouds 20 and responsible for a crossover from the localized magnetism to the itinerant-like uctuational spin-liquid magnetism. The temperature dependence of static magnetic susceptibility becomes nonuniversal in spite of the fact that we are in a region of critical AFM uctuations which is consistent with recent experimental observations (see 20 for details).

3. Application of sem i-ferm ions in mesoscopic and nano-physics

3.1. K ondo e ect in quantum dots




Fig. 8. (a) Double quantum dot in a side-bound con quration (b) co-tunneling processes in biased DQD responsible for the resonance K ondo tunneling.

The single electron tunneling through the quantum dot ⁴⁶ has been studied in great details during the recent decade. Am ong many interesting phenomena behind the unusual transport properties of mesoscopic systems, the K ondo e ect in quantum dots, recently observed experimentally, continues to attract an attention both of experimental and theoretical communities. The modern nanoscience technologies allow one to produce the highly controllable systems based on quantum dot devices and possessing many of properties of strongly correlated electron systems. The quantum dot in a semiconductor planar heterostructure is a conned few-electron system (see Fig.8) contacted by sheets of two-dimensional gas (leads). Junctions between dot and leads produce the exchange interaction between the spins of the dot and spins of itinerant 2D electron gas. Measuring the do I V characteristics, one can investigate the K ondo e ect in quantum dots under various conditions.

Various realizations of K ondo e ect in quantum dots were proposed both theoretically and experimentally in recent publications (see e.g. $^{47;48}$ for review). In order to illustrate the application of sem i-ferm ionic approach we discuss brie y electric eld induced K ondo tunneling in double quantum dot (DQD). As was noticed in

49, quantum dots with even N possess the dynamical symmetry SO (4) of spin rotator in the K ondo tunneling regime, provided the low-energy part of its spectrum is form ed by a singlet-triplet (ST) pair, and all other excitations are separated from the ST manifold by a gap noticeably exceeding the tunneling rate . A DQD with even N in a side-bound con guration where two wells are coupled by the tunneling v and only one of them (say, 1) is coupled to metallic leads (L;R) is a simplest system satisfying this condition $^{49;50}$. Such system was realized experimentally in Ref. 51. As it was shown in 23 the Shrie er-Wol (SW) transform ation, when applied

where the c-operators describe the electrons in the leads and f-operators stand for the electrons in the dot. The matrices \hat{S}^d and \hat{R}^d (d=x,y,z) are 4 4 matrices de ned by relations (A 13) (see Appendix A) and $J^{S} = J^{SS}$, $J^{T} = J^{TT}$ and J^{ST} are singlet, triplet and singlet-triplet coupling SW constants, respectively.






Fig. 9. Right panel: leading (b,d) and next to leading (c,e) parquet diagram s determ ining renormalization of J^S (a). Solid lines denote electrons in the leads. D ashed lines stand for sem i-ferm ions representing double electron states in the dot. Left panel: irreducible diagram s contributing to RG equations. Hatched boxes and circles stand for triplet-triplet and singlet-triplet vertices respectively.

Applying the sem i-ferm ionic representation of SO (4) group introduced in Section I, we started with perturbation theory results analyzing them ost divergent Feynm an diagram s (Fig.9) for spin-rotator m odel 23.

Following the "poorman's scaling" approach we derive the system of coupled renormalization group equations (see Fig.9) for elective couplings responsible for the nite bias eV transport through DQD.

As a result, the dierential conductance G (eV; T)= G_0 the universal function of two param eters $T=T_K\;$ and $eV=T_K\;$, G $_0$ = $\;e^2=\;$ \sim :

where T_K is a non-equilibrium K ondo tem perature 23 . Thus, the tunneling through singlet DQDs with the singlet/triplet splitting = E_T E_S

in di erential conductance at eV instead of the usual zero bias K ondo anom aly which arises in the opposite lim it, < T_K . Therefore, in this case the K ondo e ect in DQD is induced by a strong external bias.

The scaling equations can also be derived in Schwinger-Keldysh form alism (see 12 and also 19) by applying the "poorman's scaling" approach directly to the dot conductance. Thus, applying the sem i-ferm ionic representation to the local (zero-dimensional) problem with dynamical symmetry 48 we developed regular perturbation theory approach and obtained the scaling equations.

3.2. From double quantum dot to spin chains and ladders

In this Section we show the application of sem i-ferm ionic representation to 1D systems (spin chains and ladders). The sem i-ferm ions give a powerful tool for ferm ionization of the spin system which can be bosonized as a next step in 1D. The bosonization procedure performed by means of Hubbard-Stratonovich transformation $^{52;53;54}$ is known in the literature on Tomonaga-Luttinger model as "functional bosonization" (see also $^{55;56}$). It is known to be asymptotically exact in the long-wave limit. The sem i-fermionic representation allows us to apply the functional bosonization methods to 1D spin systems 57 .






Fig. 10. Spin Ladder (a) and Spin Rotator Chain (b)

Let us consider, as an exam ple Spin Ladder (SL) and Spin Rotator Chain (SRC) m odels, Fig.10 58 . Generic Ham iltonian for spin systems under consideration is the Heisenberg-type spin 1/2 ladder Ham iltonian

Here index = 1;2 enum erates the legs of the ladder, and the sites hil; i2i belong to the same rung (Fig. 10a).

A chain of dim ers of localized spins illustrated by Fig. 10b is described by the $\sin p \ln e d$ version of this H am iltonian

The geometry of alternate rungs is chosen in a system (Fig. 10b) to avoid exchange interaction between spins siz and siz.

The transverse coupling may emerge either from direct exchange (in case of localized spins) or from indirect Anderson-type exchange induced by tunneling (similarly to the case of quantum dots). In the latter case the sign of J_t is antiferrom agnetic, in the form er case it m ay be ferrom agnetic as well. The same is valid for J_1 .

As it is shown in $^{27;58;59}$, SO (4) is an intrinsic property of S= 1/2 spin ladders and decorated spin chains.

To describe the elementary excitations in SRC we use the sem i-ferm ionic representation for SO (4) group (see Section I). Then the single-site H am iltonian m ay be represented in a form

where h is uniform magneticeld applied in z direction and E_{ST} is a singlet/triplet splitting.

Let us consider the X X Z-SRC model 27. The Ham iltonian of this model is written in terms of the generators of SO (4) group (see Appendix B) as follows

The S-S part of this Ham iltonian describe the S = 1 chain, with the Haldane gap in the excitation spectrum (see, e.g., 60;59). The question is, how do the S-R interaction modi es the gap. We consider the case of FM dimers, when the triplet is the ground state. In this case one has one m ore gap m ode, where the gap equals Jt. This mode is coupled to Haldane branch only via S-R exchange terms in (119).

The spin liquid ferm ionization approach adopted here is a convenient tool for description of Haldane spectrum. Unlike the S = 1=2 model, where the spin-liquid state is easily described by globally U (1) invariant m odes $T_{ij}T_{ji} =$ case of S = 1, one deals with variables which e ectively break this symmetry. One can rewrite the e ective Hamiltonian of SRC model with = 0 in a form

on neutral ferm ions, whereas the terms in the second line are "anomalous" (they do not conserve spin ferm ion number). For example the propagator $hS_i^{\dagger}S_j^{}$ i contains anomalous components $f_{i1}^{\gamma}f_{j1}^{\gamma}f_{j0}f_{i0}$! $F_{ij;11}F_{ji;00}$ along with normal ones $f_{i1}^{\gamma}f_{j0}f_{i0}$: Here F_{ij} , $\circ = f_j$ f_i \circ . The rst term in (120) describes the kinetic energy spinon excitations, and two last anomalous term breaking U (1) symmetry are responsible for the Haldane gap.




Fig. 11. Lowest order contributions to anom alous propagator.

To reveal the contribution of dynam ical sym m etry on the Haldane gap, one have to note that these terms enter both in counter ow in the set term and in gauge sym m etry breaking terms in the second line. In spin 1 ladder the counter ow term

 $f_{10}^{\prime\prime}\,f_{j0}$ predeterm ines the width of spinon band described by the <code>rst line</code> of Eq. (120). A pparently, the one m ore channel (tripet/singlet transitions in B 0S) enhances this e ect, because in this case the local constraint in poses m ore restrictions of phase uctuations.

The gap itself is due to anom alous correlations described by the second line of Eq. (120). Here the appearance of second channel of spinless excitations results in form ation of even and odd operators B $_{\rm j}^{\rm OS}$ and C $_{\rm j}^{\rm OS}$. The Haldane gap closes when the fbi and fb i states are degenerate (the odd operator C $_{\rm j}^{\rm OS}$ nulli es the anom alous terms responsible for its form ation). This means that appearance of OS channel favors closing of the Haldane gap.

In a strong coupling case of J_t J_1 both above trends m ay be considered at least in the lowest order of a perturbation theory. In case of spin ladders $^{61;62}$ the 1-st and 2-nd-order in $g=J_1=J_t$ anom alous diagram s are represented in Fig.11.

4. Epilogue and perspectives

In this paper, we demonstrated several examples of the applications of semiferm ionic representation to various problems of condensed matter physics. The list of these applications is not exhaustive. We did not discuss, e.g., the interesting development of SF approach for 2D Ising model in transverse magnetic eld, functional bosonization approach based on semi-fermionic representation applied to S=1=2 chains, application of SF formalism to mesoscopic physics 24 etc. Nevertheless, we would like to point out some problems of strongly correlated physics where the application of SF representation might be a promising alternative to existing eld—theoretical methods.

Sum m arizing, we constructed a general concept of sem i-ferm ionic representation for SU (N) and SO (N) groups. Them ain advantage of this representation in application to the strongly correlated systems in comparison with another methods is that the local constraint is taken into account exactly and the usual Feynm and iagram matic codex is applicable. The method proposed allows us to treat spins on the same footing as Ferm i and B ose systems. The sem i-ferm ionic approach can be helpful for the description of the quantum systems in the vicinity of a quantum phase transition point and for the nonequilibrium spin systems.

It is known, that three generators of SU (2) group together with the Casim ir operator L^2 de ne a sphere S_2 where each state is parameterized by two angles. The coherent states of SU (2) group may be constructed 65 by making a standard stereographical projection of the sphere from its south pole to the complex plane z. The space of generators of SO (4) group is 6-dimensional, while 2 constraints determine 4-dimensional surface, where each state is characterized by four angles. The stereographical projection of this surface on a 4-D complex hyperplane allows to construct coherent states for SO (4) group.

The commutation relations (A.5) can be transformed into another form by making the linear transformation to the basis

The operators L_1 ; M_1 as well as J_1 ; K_1 form the elements of the Lie algebra o(4). The operators $(J_1; J_2; J_3)$ and $(K_1; K_2; K_3)$ are separately closed under commutations, each describing a subalgebra of o(4), namely o(3) = u(2). The Lie algebra o(4) is the direct sum of two o(3) algebras. This splitting of the o(4) algebra into two

o(3) subalgebras is directly associated with the local isom orphism between the Lie group SO (4) with the direct product group SU (2). SU (2). The triads $(J_1; J_2; J_3)$ and (K₁; K₂; K₃) each form proper ideals ⁶⁴ in o(4), and the Lie algebra o(4) is sem i-sim ple.

The symmetry group of spin rotator is de ned in close analogy with the above construction, but all rotations are performed in a spin space. The triplet/singlet pair is form ed in a simplest case by two electrons represented by their spins s = 1=2. Let us denote them as s_1 and s_2 . The components of these vectors obey the commutation relations

By construction S is the operator of the total spin of pair, which can take values S = 0 for singlet and S = 1 for triplet states. The second operator R is responsible for transition between singlet and triplet states. Thus we come to the dynamical group SO (4) for spin rotator.

Sim ilar procedure is used for the SO (5) group. The corresponding o (5) algebra = D (A.1) satisfying com mutation relations (A.2). These 10 generators m ay be identi ed as 3 vectors and a scalar in a following fashion

where the operators S;R;P and the scalar operator A obey the following commutation relations

The operators R and P are orthogonal to S, while the Casim ir operator is $K = S^2 + R^2 + P^2 + A^2 = 4$. These operators act in 10-D spin space, and the kinem atical restrictions reduce this dim ension to 7. Sim ilarly to SO (4) group, the vector operators describe spin S=1 and transitions between spin triplet and two singlet components of the multiplet, whereas the scalar A stands for transitions between two singlet states.

The group SO (5) is non-compact, and the parametrization (A.14) is not unique. As an alternative, one may refer to another representation of Dused, the theory of high-T $_{\text{c}}$ superconductivity 66 :

with 10 generators identied as a scalar Q and three vectors S_{i}^{2} and -y standing for the total charge, spin and triplet S = 1 superconductor order param eter. B oth representations (A.14) and (A.16) are connected by the unitary transformation.

Appendix B. Dynam ical Sym metries in Spin Rotator Chain Model

Now we see that both e ective Ham iltonians belong to the same fam ily. In all three case one may transform initial ladder or "sem i-ladder" Ham iltonians into really one-dimensional spin-chain Ham iltonians, which, however, takes into account the hidden symmetry of a dimer. The eective Ham iltonians (B.6), (B.7)) contain operators R describing the dynamical symmetry of dimers. It is clear that this dynamical symmetry make the spectrum of this Ham iltonians more rich than that of a standard Heisenberg chain. Like in many other cases, rotation transformation eliminates the antisymmetric combination of two generators.

The transform ation (B.3) reveals the hidden symmetry of well known spin 1/2 ladder (B.6). It maps the ladder ham iltonian onto a pair of coupled chain Ham iltonians: one is conventional spin 1 Haldane chain, another is unconventional pseudospin

1 Haldane chain. Spin and pseudospin are coupled dynamically by the commutation relations and kinematically by the local Casimir constraint

One may also compare the Hamiltonian (B.6), (B.7) with elective Hamiltonian of spin-1 chain, which arises after decomposition of spin-one operators into pair of spin 1/2 operators, $S_i = s_i + r_i$. This decomposition operation transforms initial Hamiltonian into a form similar to HSRC but for spin-one-half operators s_i ; r_i . The dierence between two cases is that these elective spins commute unlike operators S_i ; R_i . In other words, the dierence is that the local symmetry of spin-one chain is SO (3) whereas the local symmetry of SRC is SO (4). The spin rotator chain (B.7) is in some sense intermediate between spin chains and spin ladders. In this cases the spin-pseudospin symmetry is obviously broken by the cross terms $2S_iR_j$, and our aim is to not the specil calculates of this novelmodel systems.

In all cases the sim pli ed versions of H eisenberg H am iltonians m ay be considered. The sim pli ed SL m odels are w ellknown 61 . The sim pli ed an isotropic versions of the H am iltonian (B.7) have the following form s:

SRC in strong magnetic eld: SO (4) group is reduced to SU (2) group in strong magnetic eld, when the Zeem an splitting exactly compensates the exchange gap in a single dimer, $h_0 = fE_T$ E_S j. Then at low T, the states ji0i and ji 1i are quenched, and only two components, R survive in the wholem anifold . As a result, the H am iltonian (B.7) is mapped onto a X Y -m odel for spin one half:

This means that starting from a singlet ground state for J_t E_T $E_S > 0$, one may induce development of spin liquid-like excitations by applying strong magnetic eld. In a near vicinity of this point of degeneracy, H $_{\rm int}$ acquire the feature of XY model in transverse magnetic eld.
