# Statistical m echanics and V lasov equation allow for a simpli ed H am iltonian description of Single-Pass Free E lectron Laser saturated dynam ics

A reduced H am iltonian formulation to reproduce the saturated regime of a Single Pass Free E lectron Laser, around perfect tuning, is here discussed. A sym ptotically, N  $_{\rm m}$  particles are found to organize in a dense cluster, that evolves as an individual massive unit. The remaining particles ll the surrounding uniform sea, spanning a nite portion of phase space, approximately delimited by the average m omenta  $!_+$  and !. These quantities enter the model as external parameters, which can be self-consistently determined within the proposed theoretical framework. To this aim, we make use of a statistical mechanics treatment of the V lasov equation, that governs the initial am pli cation process. Simulations of the reduced dynamics are shown to successfully capture the oscillating regime observed within the original N-body picture.

#### I. GENERAL BACKGROUND

Free-Electron Lasers (FELs) are coherent and tunable radiation sources, which dier from conventional lasers in using a relativistic electron beam as their lasing medium, hence the term free-electron.

The physical mechanism responsible for the light emission and amplication is the interaction between the relativistic electron beam, a magnetostatic periodic eld generated in the undulator and an optical wave copropagating with the electrons. Due to the e ect of the magnetic eld, the electrons are forced to follow sinusoidal trajectories, thus em itting synchrotron radiation. This spontaneous em ission is then am pli ed along the undulator until the laser e ect is reached. Am ong di erent schem es, single-pass high-gain FELs are currently attracting grow ing interest, as they are prom ising sources of powerful and coherent light in the UV and X ranges. Besides the Self Am pli ed Spontaneous Em ission (SASE) setting [1], seeding schemes may be adopted where a small laser signal is injected at the entrance of the undulator and guides the subsequent ampli cation process [2]. In the following we shall refer to the latter case. Basic features of the system dynamics are successfully captured by a simple one-dimensional Hamiltonian m odel [15] introduced by Bonifacio and collaborators in [3]. Rem arkably, this sim pli ed form ulation applies to other physical systems, provided a form al translation of the variables involved is performed. As an example, focus on kinetic plasm a turbulence, e.g. the electron beam -plasm a instability. W hen a weak electron beam is injected into a therm al plasm a, electrostatic m odes at the plasm a frequency (Langm uir m odes) are destabilized. The interaction of the Langmuir waves and the electrons constituting the beam can be studied in the fram ework of a self-consistent Ham iltonian picture [4], form ally equivalent to the one in  $\beta$ ]. In a recent paper [5] we established a bridge between these two areas of investigation (FEL and plasma), and exploited the connection to derive a reduced Ham iltonian m odel to characterize the saturated dynam ics of the laser. A coording to this scenario, N m particles are trapped in the resonance, i.e. experience a bouncing motion in one of the (periodically repeated) potential wells, and form a clum p that evolves as a single m acro-particle localized in space. The rem aining particles populate the surrounding halo, being alm ost uniform ly distributed in phase space between two sharp boundaries, whose average mom entum is labeled  $!_{+}$  and !. The issue of providing a self-consistent estim at for the external parameters N<sub>m</sub>,  $!_{+}$  and ! is addressed and solved in this paper.

This long-standing problem was rst pointed out by Tennyson et al. in the pioneering work [6] and recently revisited in [4]. A rst attempt to calculate N<sub>m</sub> is made in [9] where a sem i-analytical argument is proposed. In this respect, the strategy here proposed applies to a large class of phenomena whose dynamics can be modeled within a H am iltonian fram ework [4, 7] displaying the emergence of collective behaviour [8].

The paper is organized as follows. In Section II we introduce the one-dimensional model of a FEL amplier [3] and review the derivation of the reduced H am iltonian [5, 6]. Section III recalls the statistical mechanics approach to estimate the saturated laser regime. In Sections IV to VI the analytic characterization of  $N_m$ ,  $!_+$  and ! is given in

details and the results are then tested num erically in section VII. Finally, in Section VIII we sum up and draw our conclusions.

# II. FROM THE SELF-CONSISTENT N-BODY HAM ILTONIAN TO THE REDUCED FORMULATION

Under the hypothesis of one-dimensional motion and monochromatic radiation, the steady state dynamics of a Single-Pass Free Electron Laser is described by the following set of equations:

where  $z = 2k_w z_r^2 = h i_0^2$  is the rescaled longitudinal coordinate, which plays the role of time. Here,  $= [a_w !_p = (4ck_w)]^{2=3} = r$  is the so-called Pierce parameter,  $h i_0$  the mean energy of the electrons at the undulator's entrance,  $k_w = 2 = w$  the wave number of the undulator,  $!_p = (4 e^2 n = m)^{1=2}$  the plasma frequency, c the speed of light, n the total electron number density, e and m respectively the charge and m ass of one electron. Further,  $a_w = eB_w = (k_w m c^2)$ , where  $B_w$  is the rms peak undulator eld. Here  $r = w (1 + a_w^2) = 2^{1=2}$  is the resonant energy, w and being respectively the period of the undulator and the wavelength of the radiation eld. Introducing the wavenumber k of the FEL radiation, the two canonically conjugated variables are (p), de ned as  $= (k + k_w)z - 2 k_w z_r^2 = h i_0^2$  and  $p = (h i_0) = (h i_0)$ . corresponds to the phase of the electrons with respect to the ponderom otive wave. The com plex am plitude  $A = A_x + iA_y$  represents the scaled eld, transversal to z. Finally, the detuning parameter is given by  $= (h \frac{2}{b} - \frac{2}{r}) = (2 - \frac{2}{r})$ , and measures the average relative deviation from the resonance condition.

The above system of equations (N being the number of electrons) can be derived from the Ham iltonian

where the intensity I and the phase ' of the wave are given by  $A = \begin{bmatrix} p & \\ I=N & exp(i) \end{bmatrix}$ . Here the canonically conjugated variables are  $(p_j; j)$  for 1 = j N and (I; I). Besides the \energy" H, the total momentum  $P = \begin{bmatrix} j & \\ j & p_j \end{bmatrix}$  is also conserved. By exploiting these conserved quantities, one can recast the FEL equations of motion in the following form for the set of 2N conjugate variables  $(q_j; p_j)$  [10]:

where the dot denotes derivation with respect to z, and  $q_j = j$  ' mod(2) is the phase of the j<sup>th</sup> electron in a proper reference frame. The xed points of system (5)-(6) are determined by imposing  $q_j = p_j = 0$  and solving:

An elliptical xed point is found for  $q_i = q = 3 = 2$ . The conjugate m om entum solves  $(p + )^p = N p + 1 = 0$  and therefore depends on P = N. We shall return on this issue in the following Sections.

For a monokinetic initial beam with velocity resonant with the wave, equations (1), (2) and (3) predict an exponential instability and a late oscillating saturation for the am plitude of the radiation eld. Num erical simulations fully comm this scenario as displayed in g. 1. In the single particle (q;p) space, a dense core of particles is trapped by the wave and behaves like a large \m acro-particle", that evolves coherently in the resonance. The distances between these particles do not grow exponentially fast (as is the case for chaotic motion) but grow at most linearly with time (for particles trapped in the resonance with di erent adiabatic invariants, i.e. essentially di erent action in the single particle pendulum -like description). This linear-in-time departure of the particles appears in the di erential rotation in g. 2, while the remaining particles are alm ost uniform ly distributed between two oscillating boundaries. Having observed the form ation of such structures in the phase-space allowed to derive a simplie of Ham iltonian model to characterize the asymptotic evolution of the laser [5, 6]. This reduced form ulation consists in only four degrees of freedom, namely the wave, the macro-particle and the two boundaries delimiting the portion of space occupied by the so-called chaotic sea, i.e. the uniform halo surrounding the inner core.




FIG.1: Evolution of the radiation intensity as follows from equations (1), (2) and (3).  $N = 10^4$  electrons are simulated, for an initial mono-energetic prole. Here = 0 and I (0) ' 0. Particles are initially uniform by distributed in space.

In [5] we hypothesized the m acro-particle to be form ed by  $N_m$  individual massive units, and introduced the variables (;) to label its position in the phase space.

The  $N_c = N$   $N_m$  particles of the surrounding halo are treated as a continuum with constant phase space distribution,  $f_{sea}$  (;p;z) =  $f_c$ , between two boundaries, namely  $p_+$  (;z) and p (;z) such that:

where  $p^0$  represents their mean velocity. These assumptions allow to map the original system, after linearizing with respect to p, into [5]:

Normalizing the density in the chaotic sea to unity yields  $f_c = 1 = (2 \ !)$ , where ! = ! + ! represents the (average) width of the chaotic sea. The above system can be cast in a Ham iltonian form by introducing new actions I and their conjugate angles ':

The reduced 4-degrees-of-freedom Ham iltonian reads, up to a constant irrelevant to the evolution equations:




FIG.2: Phase space portraits for di erent position along the undulator [z = a) 80, b) 81, c) 83, d) 84]. The di erential rotation of the m acro-particle is clearly displayed. For the parameters choice refer to the caption of Fig. 1.




FIG. 3: (q,p) phase space portrait in the deep saturated regime for a monokinetic initial beam  $(I(0) ' 0, p_j(0) = 0 \text{ and } q$ uniform by distributed in [0;2]). The two solid lines result from a numerical t performed according to the following strategy. First, the particles located close to the outer boundaries are selected and then the expression p(q) = !  $j_V jsin(q + B)$  is numerically adjusted to interpolate their distribution. Here,  $j_V j_B$  and ! are free parameters. The numerics are compatible with the simplifying assumption  $B_+ = B ' 0$ .

The rst four terms represent the kinetic energy of the m acro-particle, the oscillation of the wave and the harm onic contributions associated to the oscillation of the chaotic sea boundaries. The remaining terms refer to the interaction energy. Total momentum is  $P = +I + N_c!$ . The Ham iltonian (19) allows for a simplified description of the late nonlinear regime of the instability, provided the three parameters  $!_+$ , ! and  $N_m$  are given.

To achieve a complete and satisfying theoretical description we need to provide an argument to self-consistently estimate these coecients. To this end, we shall use the analytical characterization of the asymptotic behavior of the laser intensity and beam bunching (a measure of the electrons spatial modulation) obtained in [11] with a statistical mechanics approach. In the next section these results are shortly reviewed.

## III. STATISTICAL THEORY OF SINGLE PASS FEL SATURATED REGIME

As observed in the previous Section, the process of wave ampli cation occurs in two steps: an initial exponential growth followed by a relaxation towards a quasi-stationary state characterized by large oscillations. This regime is governed by the V lasov equation, rigorously obtained by performing the continuum limit (N ! 1 at xed volume and energy per particle) [4, 11, 12] on the discrete system (1-3). Form ally, the following V lasov-wave system is found:

A subsequent slow relaxation towards the Boltzm ann equilibrium is observed. This is a typical nite-N e ect and occurs on time-scales much longer than the transit trough the undulator [3, 4, 13]. For our calculations we are interested in the rst saturated state. To estimate analytically the average intensity and bunching parameter in this regime we exploit the statistical treatment of the V lasov equation, presented in [11]. In the following, we provide a short outline of the strategy. Since the G ibbs ensembles are equivalent for this model, note that the same expressions are recovered through a canonical calculation [4, 11, 14].

The basic idea is to coarse-grain the microscopic one-particle distribution function f (;p;z). An entropy is then associated to the coarse-grained distribution f, which essentially counts a number of microscopic con gurations. Neglecting the contribution of the eld, since it represents only one degree of freedom within the (N + 1) of the H am iltonian (4), one assumes

where the constant  $f_0$  is related to the initial distribution [17].

The equilibrium is computed by maxim izing this entropy, while imposing the dynamical constraints. This corresponds to solving the constrained variational problem

where , and are the Lagrange multipliers for the genergy, momentum and normalization constraints and, in addition, we have assumed the non-restrictive condition  $\cos(i) = 0$  [11]. Using then the three equations for the constraints, the statistical equilibrium calculation is reduced to noting the values of the multipliers as functions of energy and momentum . These equations lead directly to the estimates of the equilibrium values for the intensity I and bunching parameter b = j exp (i i)  $j \in \mathbb{N}$ .

In the following, we focus on the case of an initially monokinetic beam injected at the wave velocity, while the initial wave intensity is negligible, so that = 0 and = 0. Moreover we let  $f_0 ! 1$ , which amounts to ! 1 in eq. (29). Results are displayed in g. 4 showing remarkably good agreement between theory and simulations, below the critical threshold  $_{\rm c}'$  1.9 that marks the transition between high and low gain regimes. This transition is purely dynamical and cannot be reproduced by the statistical calculation.

Analytically, it turns out that




FIG. 4: C om parison between theory (solid and long-dashed lines) and simulations (symbols) for a monoenergetic beam with = 0, = 0, when varying the detuning. The dotted vertical line, = c' 1:9, represents the transition from the high-gain to low gain regime [3].

# IV . TOWARDS THE ANALYTICAL CHARACTERIZATION OF $\ensuremath{\mathsf{N}}_{\ensuremath{\mathsf{m}}}$

A spreviously discussed, one can predict the value of the bunching param eterb, using the above statisticalm echanics description. C learly, the bunching param eterb depends on the spatial distribution of the particles. From its de nition it im m ediately follows:

To proceed we can isolate the contribution relative to the macroparticle from that associated to the chaotic sea. We thus obtain:

Focus on the rst two terms of expression (33). We assume the macroparticle to be ideally localized at the elliptic xed point solving (7)-(8), i.e. set  $q_j = q = 3 = 2$ , for each individual massive unit belonging to the inner agglom eration. Hence,  $_{i2\,m\,acro} \cos q_i = N_m \cos q = 0$ . As concerns the second contribution, recalling the expressions for the boundaries p (q) and  $p_+$  (q) (see caption of g. 3), one can form ally write:

con m ing the relevance of the m acroparticle picture to the bunching param eter, a physical quantity of param ount in portance for the FEL dynam ics. Formula (37) yields bunching param eter values larger than (39), i.e. in plies that the sea also contributes to increasing the bunching param eter. The di erence increases as the sea getsm ore populated and the width  $!_+$  ! is reduced (note that our approximations require  $j_{+}$  j +  $j_{-}$  j <  $!_+$  !, see g.3).

# V. ESTIMATING THE AVERAGE MOMENTUM OF THE BOUNDARIES !

In this section we estimate the unknown quantities ! by characterizing their functional dependence on  $N_m$ . For this purpose we introduce (see schematic layout of g.3):




FIG.5: Solid line: ! vs z. Dashed line: ! vs z. Param eters are set as discussed in the caption of g. 1.

The problem of estimating ! is obviously equivalent to providing a self-consistent calculation for ! and !. The latter are both monitored as function of time in g.5 and shown to be practically constant.

In the following, we shall focus on the case of a system which evolved from an initially monokinetic beam and an initially in nitesimal wave. It is then convenient to choose the Galilean reference frame moving at the beam initial velocity. This translates into the conditions = 0 and = 0. The detuning is arbitrary so far. It is of prime interest to consider the special case where the beam is injected at the resonant velocity, so that = 0. We shall make this additional assumption in section V II, but the estimates in this section and in the next one do not require it unless explicitly stated.

Consider the conservation of momentum for the original N-body system (4) and focus on the asymptotic dynamics, which allows one to isolate the contributions respectively associated to the macroparticle and the chaotic sea. A veraging over the number of particles yields:

where  $p_{sea}$  stands for the average momentum of the chaotic sea and the subscript  ${}^{00}$  labels the initial condition. To simplify the calculations, we introduced the rescaled intensity J = I = N. As already observed in [5, 6], the macroparticle rotates in phase space. This rotation is directly coupled to the oscillations displayed by the laser intensity. A veraging over a bounce period  $z_{rot}$ , one form ally gets:

where h i stands for the time average. Focus now on  $h_{pea}$  i. Since particles are uniform by lling the chaotic sea, one can use the approximation outlined before eq. (9) (see also caption of g.3):

As already outlined in the preceding discussion, we assume that the macroparticle oscillates around the xed point and therefore each individual element constituting the macroparticle veries the condition  $hq_j i = q$ . In addition, from equation (7):

To proceed in the analysis, we approximate the right hand side in equation (44) as:

consistently with the argum ent after (33). The above relation is derived by perform ing a linearization (see Appendix), validated num erically and supported a posteriori by the correctness of the results. The contribution of the chaotic sea reads:

M erging equations (44), (45) and (46) and recalling (37) and (31), one obtains

Thus the macroparticle moves on the average at the same velocity as the center of the chaotic sea. Inserting equations (43) and (47) into (42) and solving for !, we nd,

To get an expression for !, we consider the energy conservation for the original N-body model (4). By averaging over one complete rotation of the macroparticle, we write:

We then bring into evidence the contributions associated to the massive agglomerate and to the particles of the surrounding halo, for both the kinetic and the interaction term s:

Hereafter we make use of  $hp_{m \ acro}^2 i' hp_{m \ acro} i^2$ , which in turn amounts to assume small oscillations around the mean  $hp_{m \ acro} i$ , consistently with (44) which neglects such oscillations. The kinetic energy associated to the uniform sea can be estimated as follows:

In this estim atewe assumed the particles to be distributed uniform by in a rectangular box, disregarding the sinusoidal shape of the boundaries. The modulation of the outer frontiers results in higher order corrections which can be neglected.

The interaction term follows directly from (44) and (47). Inserting (51) in (50), one nds:

The preceding calculations lead to three equations that allow to estimate  $N_m$ , ! and ! (and thus ! + and ! ), provided an expression for V is given.

Note that V enter as variables in the H am iltonian and thus evolve self-consistently. However, one can assess their average value using an adiabatic argument [4]. The boundaries of the sea are rather sharply drawn by the motion of particles, which move following the time-dependent H am iltonian H<sub>1:5</sub> =  $p^2=2+2^{\circ} J \sin($  '), with 1.5 degrees of freedom. In a rst approximation, the time dependence of J and ' results in a detuning of the wave, as

where we used (31) and the estimates of sec. IV. The resulting velocity agrees with the canonical estimate of reference [4] in the low-temperature regime, as it must since ensembles are equivalent for this model.

Let us neglect the pulsations of J and further variations of '. Then the H am iltonian H<sub>1:5</sub> is brought to the integrable form of the classical pendulum, by a G alileo transform ation to the fram e moving at velocity v = hJi. In this fram e, the motion of particles preserves their action, which is directly related to their e ective energy

where  $p^0 = p + hJi$ ,  $q^0 = + hJit$  '<sup>0</sup>; here '<sup>0</sup> = ' + hJit is the wave phase in the new fram e. Solving for p, we get:

where we used the assumption that  $hJi^{1=2}=E$  is small, i.e. that the particle motion near the sea boundary (which has period 2 = 2E) is fast with respect to the characteristic frequency  $2hJi^{1=4}$  of particle oscillations inside the wave potential well. From (55) we nally obtain

Note that the boundaries found here are also approximately level lines of the distribution f given by eq. (29), as they should be.

# VII. VALIDATING THE THEORY THROUGH DIRECT SIMULATION

In conclusion, we obtained a system of equations that can be solved to compute the values of  $V_+$  and  $V_-$  and provide self-consistent estimates of the three quantities  $N_m$ ,  $!_+$  and  $!_-$ , through a direct calculation of  $!_-$  and  $!_-$ , for an initially monokinetic beam and in nitesimal wave (H = N = 0, P = N = 0). The nal equations read in the case = 0:




FIG. 6: Rescaled laser intensity I/N vs time. The solid line refers to the reduced dynamics. The free parameters are xed according to the self-consistent derivation here discussed. The dashed line refers to a direct integration of the original N-body system (4).

where hJi = Af and b are calculated from (31). The system is explicit after a few algebraic calculations, which show that

It is worth recalling that the derivation of this system assumes that the dynamical variables like V and J do not vary too much, so that these nalestimates yield coe cients ! which do not depend on time.

In table I the solutions of system (57) are compared with the values measured in direct numerical experiments. The theoretical values are then used to simulate the reduced dynamics (19). Comparisons with numerical results based on the original N-body (4) model are reported in g. 6 and display a remarkably good agreement. The normalized standard deviations of the intensity in the two cases dier by less than ve percent. As an additional check, we report in g. 7 the Fourier transform of the signals displayed in g. 6. A discrepancy smaller than 1 % is observed for the peak values. These results provide an a posteriori validation of the reduced model which can be e ectively employed to characterize the saturated evolution of the FEL eld.

To estimate N<sub>m</sub> we select the i<sup>th</sup> particle and calculate the spatial distances from the adjacent neighbors. If such quantities remain below a cut-o threshold during the subsequent evolution, the particles are said to belong to the inner cluster.




FIG. 7: Fourier transform of the signals reported in g. 6. The thick solid line refers to the reduced model, while the dashed one refers to the original N-body system.

## VIII. CONCLUSION

In this paper we consider a reduced H am iltonian formulation to reproduce the saturated regime of a single-pass Free E lectron Laser around perfect tuning. The model consists of only four degrees of freedom. The particles trapped in the resonance give birth to a coherent structure localized in space which is form ally treated as an individual macroparticle. The remaining particles constitute the so-called chaotic sea and are uniform ly distributed in phase space between two sharp boundaries that evolve according to the V lasov equation.

Thism in in alistic approach was rst derived by Tennyson et al. working in the context of plasm a physics and recently adapted to the FEL in [5]. The original form ulation assumes three external parameters, namely the mass of the dense core,  $N_m$ , and the averagem on enta ! associated to the outer boundaries, which have been so far phenom enologically adjusted to reproduce the results of N-body simulations. The lack of a self-consistent characterization has signicantly weakened the potential impact of the reduced H am iltonian approach so far.

This long standing problem [4, 6] is here addressed and solved. To this end we make use of the analytical estimates of the average intensity and bunching parameter at the saturation based on a statistical mechanics treatment of the V lasov equation and of adiabatic theory [4, 11]. Our theoretical predictions for the parameters are compared to direct num erical measurements, showing an excellent agreement. Simulations of the reduced dynamics, complemented with the strategy here discussed, reproduce remarkably well the oscillatory regime displayed by the original N-body model.

In conclusion, we have provided a solid self-consistent form ulation for the reduced H am iltonian, which we hereby propose as an alternative theoretical tool to investigate the saturated regime of a FEL.

#### Appendix

Consider the following expression:

and suppose w e w ant to evaluate hW i. The asymptotic intensity oscillates around a given plateau hJ i, hence w e w rite the dom inant Fourier term (see g. 7):

with  $_{\rm J}$  = J=hJi, noting J the amplitude of the oscillations. M oreover the m acroparticle displays regular oscillations, centered around q = 3 = 2. This in turn allows us to write:

for the i<sup>th</sup> particle composing the dense core. Here  $_{q}$  m easures the average distance from q. Assuming both  $_{J}$  and  $_{q}$  to be small, one can approximate (59) as follows:

where use has been m ade of the fact the  $\cos q = 0$ . A veraging (62) over one period  $z_{rot} = 2 = !$  one gets:
