Tunneling anomaly of superconducting lm s in strong magnetic elds.

We consider the tunneling Density of States (DoS) of superconducting Im s driven to the param – agnetic phase by the Zeem an splitting. We show that there is m in im um in the DoS whose position depends on the orientation of the applied eld. This dependence, not predicted by previous theoretical calculations, is in agreement with a recent experiment.

It is well known that superconductivity can be destroyed by applying a magnetic eld because of the breaking of the time reversal symmetry (see e.g. Ref. 1). The magnetic eld acts on both the orbital motion and the spin of the electrons; while in the bulk the orbital e ect is responsible for the suppression of superconductivity, in low-dimensionality systems (d 2) the Zeem an splitting of the states with opposite spin and which are degenerate in zero eld can be the dominant mechanism for this suppression.^{2,3} In the norm all phase, the theory of interaction corrections to the Density of States (DoS)

reviewed in Ref. 4 predicts the appearance of singular contributions to the DoS located at the Zeem an energy $E_Z = g_{L-B} H (g_L$ is the Lande g-factor, _B the Bohr m agneton and H the m agnetic eld). However experiments performed almost a decade ago⁵ and subsequent theoretical calculations³ showed that there are more singular corrections located at a lower energy E_+ :

and is the BCS gap. In a sm allgrain, the origin of these corrections can be understood as follows:³ when a spindown electron tunnels into a state singly occupied by a spin-up electron, they form a pair; the interaction m ixes this pair with the empty states at energies > $E_z = 2$; the m ixing is resonant at the energy E_+ and this resonance m anifests itself as an anom alous contribution to the D oS. The position of the anom aly was predicted to be \universal", i.e. independent of both the dim ensionality and the direction of the magnetic eld. Recent experiments on superconducting Al lm s⁶ are in disagreement with the latter result: the position of the m easured m inim um in the D oS m oves to higher energies as the component of the m agnetic eld perpendicular to the lm is increased.

In this paper we reconsider the calculation of the superconducting uctuations corrections to the D oS in the norm all phase for disordered lines and wires in strong magnetic elds. To understand why the reconsideration is necessary, let us brie y review the qualitative argument given in Ref. 3 to explain the position and width of the anomaly in lines and wires: as discussed above, the position of the singularity was found to be located at E_+ for tunneling into a grain; then a self-consistent argument was given to not the characteristic energy scale

W_d (width of the singularity in d dimensions) in one-and two-dimensional systems. The latter argument is based on the assumption that the system can be e ectively divided into zero-dimensional patches whose size L_{W_d} is then found self-consistently { this assumption however breaks down if dephasing happens on a scale shorter than the patches' size. In the presence of a perpendicularm agnetic edd, this scale is given for Im s by the magnetic length $l_{H} = (\sim c=eH)^{1=2}$, and the break-down happens at

This suggests that, for strong enough magnetic elds, additional contributions to the DoS which are particular to one- and two-dimensional systems might become relevant,⁸ below we show that this is indeed the case and for lms in a tilted eld, we present the detailed derivation of the dependence of the position of the singularity on the perpendicular component of the magnetic eld. From now on, we use units with $\sim = 1$.

To describe the superconducting system s, we consider the pairing H am iltonian H = H₀ + H_{int}, where the noninteracting part H₀ is given by the sum of the kinetic energy, the Zeem an energy and the disorder potential, and H_{int} is, in second-quantized notation (g > 0 is the coupling constant):

The D oS is related to the imaginary part of the one particle G reen's function and the latter can be calculated with e.g. the diagram matic technique.⁷ As this procedure is standard, we skip intermediate steps and we simply quote the nal answer⁴ for the one-loop uctuation correction to the D oS for spin down electrons at zero temperature in d-dimensions:

with D the diusion constant, and is the uctuation propagator:

As noticed in Ref. 3, due to its analytical properties this propagator can be separated into a \pole" part and a \cut" part:

and ^c is implicitly de ned by Eqs. (8)-(9). We can accordingly write d as a sum of two terms: d() =

 ${}_{\rm d}^{\rm p}$ () + ${}_{\rm d}^{\rm c}$ (). The contribution ${}_{\rm d}^{\rm c}$ () can be found in Ref. 4 and for example in d = 2 it is proportional to ln [ln ($E_{\rm Z}$)]; we give it here no further consideration, since this contribution is less divergent than the ones we calculate below . We note that the separation (8) is possible provided that E $_{\rm Z}$ > ; if this condition is satisfied, our results are applicable even for elds smaller than the parallel critical eld H $_{\rm ck}$ as long as the sample is in the norm al state.

A coording to the above argum ent, we want to evaluate the right hand side of Eq. (5) with the substitution

and the result of this calculation gives the lowest order perturbative correction to the DoS.On the other hand in Ref. 3 a resumm ation of perturbation theory was perform ed in the long wavelength approximation Dq^2 ., but this approximation is not always applicable. Indeed let us consider a 2D system, in which case the approxim ation m eans that, in energy units, the exchanged m omentum is limited by =g, where g = 4 ₀D is the adim ensional conductance; for good conductors =g and this energy scale is much smaller than the gap . Since the Cooper pair energy [i.e. the position of the pole in Eq. (9)] is & and the exchanged energy is much smaller than , we can e ectively neglect the \Ferm isea" under the pair: from a form alpoint of view, we can extend the upper $\lim it of integration in Eq. (5)$ to in nity. In other words, in this approximation we can neglect the exclusion principle, which forbids the electrons from $\going under the sea"$, i.e. interacting with electrons at energies below the Ferm i energy.¹⁰ However when a magnetic eld with a component perpendicular to the lm is present, Landau quantization renders the m om entum variable discrete:




FIG.1: W idth and position of the minimum for small (left) and large (right) perpendicular eld as explained in the text.

is the Cooperon cyclotron frequency and is the tilting angle. The momentum transfer (in energy units) is therefore of order $_{\rm H}$ and when this becomes su ciently large we are not allowed to neglect the exclusion principle anym ore: the correct lim its of integration must be considered.¹¹ For strong elds, the e ect of the \pm sea" is to move the position of the minimum to higher energies:¹² for H W $_2$ the anom aly, centered at E_+ has a width W_2 much sm aller than E_+ [cf. Eqs. (1) and (18)] and the Ferm i sea is not probed by the excitations contributing to the anomaly, see Fig. 1a. On the contrary, for H W $_2$ a sizable fraction of these excitations would be located below the Ferm i energy, as shown by the dashed line in Fig. 1b. However the exclusion principle suppresses the contributions from under the \Fermi sea", the pro le of the anom aly becom es asym m etric and as a consequence the minimum appears to shift to higher energies, as in the solid line of Fig. 1b. This qualitative argum ent predicts that as we increase $_{\rm H}$, the shift also increases, in agreem ent with the quantitative result derived below. It also places the transition between the weak and strong eld regimes at $_{\rm H}$ W_2 , which is the sam e condition as in Eq. (3). In sum m ary, the long wavelength approximation is justilled in the weak eld regime and the non-perturbative approach of R ef. 3 is necessary in this case; in the strong eld limit, on the contrary, a perturbative calculation is su cient, as we explicitly show below.

A first the substitution (10), the integration over ! in Eq. (5) can be performed exactly and we write the result as:

where we separated di erent contributions based on their degree of divergence in the parallel eld case: ${}^{m}_{d}$ gives them ost divergent term (a -function in d = 2) which was considered in Ref. 3, along with subleading term s; other subleading term s are collected in the the (less) divergent part ${}^{1}_{d}$; nally ${}^{f}_{d}$ contains only nite contributions and hence we do not need its explicit form. The relevant

contributions are:

Note that Eq. (14a) reduces to the perturbative result of Ref. 3 upon replacing the square bracket with 2 i. In what follows we retain only the most divergent terms, as nite and weakly divergent contributions have already been discarded in perform ing the replacement (10).

W e now restrict our attention to the case d = 2 with a non-zero perpendicular component of the magnetic eld, so that we must use the substitution (11) and replace in Eqs. (14) the integrations over momentum with sum mations:

characterizes the width of the tunneling anomaly in the parallel eld and the function f(a;b) is de ned as:




FIG.2: Tunneling anomaly in tilted eld. The continuous lines are the correction $\frac{p}{2}$ of Eq.(17) for = 35,23 and 16 (top to bottom) with g = 5, $E_z = 2.5$ and $g_L = 2$. The vertical dotted line is at $= E_+$. The dashed line is the approximate contribution of Ref. 3 for = 35, which can also be obtained by letting b! 1 in Eq.(19).

in which the correction is indeed smaller than the bare $D \circ S \cdot A \circ an example$, we plot both Eq. (17) and the corresponding approximate form ula of Ref. 3 in Fig. 2. We note that, in agreement with our previous discussion: the

m inim um is shifted to a higher energy; the contribution at sm all energies (near the Ferm i sea) is suppressed; the overall shape is asym m etric about the m inim um, in qualitative agreem ent with the experim ents.^{5,6} In addition, the anom aly is sm aller than the prediction of the approxim ate form ula { this could be relevant in a quantitative com parison with experim ents.

For the purpose of calculating the eld-dependent position of the m inimum, we can di erentiate Eq. (17) and then expand the result to rst order in = (E_+)= $_{\rm H}$ by assuming $\frac{1}{2}$. Performing this calculation we nd:

W hile the above inequality is exact (and the equality is valid for $= _{\rm H} = 0$), the one in Eq. (22) should be understood as follows: for E; $\& _{\rm H} = 3$ the approximate equality holds, while at lower values of these parameters is the upper limit that applies. Setting Eq. (21) to 0 and using for an estimate the limiting values of and , we

nd for the position E of the minimum:

which generalizes the result of R ef. 3 and reduces to it for $_{\rm H} = 0.1^3$ The sm allness of the constant justi es a posteriori the expansion. In the experiment of R ef. 6, Eq. (24) has been successfully tested; below we comment on the applicability of this equation for experimentally relevant values of the parameters and we give more reliable estimates for the dependence of E on $_{\rm H}$.

A coording to the de nitions (1), (2) and (15), the inequalities $E < E_+ E_Z$ hold; in the experiments⁶ all these quantities are . This means that W₂ =4q for good conductors. On the other hand

so that for \large" tilting angles we have $_{\rm H}$ $E_{\rm Z}$; thus we nd that the condition (20) is experimentally satised. However the same reasoning shows that the conditions for the applicability of the upper limit estimate in Eq. (22) are easily violated. A more detailed study of the correction (17) shows that for the position E of them inimum we can distinguish two regimes for di erent ranges of the parameter $_{\rm H}$ =E $_{\rm Z}$, namely:

The coe cient $_1$ depends weakly on the eld through E_z ; for elds larger than about twice the parallel critical eld this dependence can be neglected¹⁴ and we nd:

independent of the eld. The result (26a) is obtained by expanding [Eq. (22)] as a function of the quantities $E = _{H}$, $= _{H}$, while Eq. (26b) is found by taking the limit g! 1 in the derivative of Eq. (17): in this case the

nite value of [de ned before Eq. (21)] is calculated num erically and then we evaluate the coe cients of the rst order corrections in E = H; = H { these are responsible for the suppression of the E_+ term . W e stress that in the tilted eld the linear dependence of the position of the minimum on the eld is a robust prediction. We also notice that in the allowed region of the parameters, the coe cient $_1$ in front of $_H$ varies between 0:016 and 0:112, i.e. it agrees with of Eq. (24) within a factor of 3; since it is also true that $_1 = < 3$, the estimate Eq. (24) is a correct order-of-m agnitude one. Indeed that equation has been successfully applied in a study of a g = 5:6 sam ple for which¹⁵ $_{\rm H} = E_{\rm Z}$. 8 in Ref. 6.¹⁶ Experiments in higher conductance samples, where $_{\rm H} = E_{\rm Z}$ 7, would enable to test Eq. (26b) directly: its simpler dependence on the physical parameters as compared to Eq. (26a) would make possible a more quantitative com parison between theory and experiments.

Up to now, we have not considered the phase relaxation e ect of the (parallel component of the) magnetic eld, since it can be usually neglected in the tilted eld.³ This e ect is accounted for by shifting the frequency in the de nition (6) of the Cooperon: $! + i = _{\rm H}$, with⁴

Here $_{H_{k}}$ is as in Eq. (12) but with \cos instead of \sin and the transverse Thouless energy is: $E_{T} = D = a^{2}$, where a is the lm's width. In the parallel eld, momentum integration in Eqs. (14) is straightforward; we do not give here the explicit answers (due to space lim – itations), but the qualitative results are the same as for the tilted eld upon replacing $_{H}$! $1 = _{H}$. A lso, we note that Eqs. (14) can be used to evaluate the correction to the D oS of superconducting wires; for both wires and the parallel eld case, the one-loop approximation is valid when W $_{d H}$ 1.¹⁷

In conclusion, we calculated the one-loop interaction correction to the Density of States for superconducting Im s in tilted eld and in the param agnetic phase. We found a minimum in the Density of States which shifts linearly with the applied eld to higher energies, see e.g. Eq. (24); this dependence has been demonstrated experimentally.⁶
