Spin wave instabilities and eld induced transitions in heavy ferm ions

We study phase transitions in heavy ferm ion systems due to spin-wave instabilities. One motivation is to determ ine the changes in the spin-wave parameters of a magnetically ordered heavy ferm ion system as it approaches a quantum critical point (QCP) by applying pressure. The other more actual is to provide an alternative approach, based on spin-wave instabilities, for the magnetic eld induced transitions recently observed in antiferrom agnetic heavy ferm ion materials.

IN TRODUCTION

Pressure and magnetic eld have been used as externalparam eters to drive heavy ferm ion m aterials through di erent quantum critical points []. The theory of the heavy ferm ion quantum criticality has been developed starting on the param agnetic side of their phase diagram [2]. In the ordered magnetic phase, usually with antiferrom agnetic (AF) long range order, most studies have concentrated in determ ining the shape of the critical line as a function of pressure (P) and magneticeld (H), in particular when $T_N \,!\, 0$ [1]. This gives information on the important shift exponent which is determined by the critical exponents associated with the QCP. However, in the broken sym m etry phase, the m agnetic excitations are spin-waves and a relevant question concerns what happens to these modes as the quantum critical point (QCP) is approached from the ordered side [3]. More speci cally, we ask what happens to the spin-wave param eters, its gap and sti ness as, for example, T_N (P) goes to zero, ie., P approaches P_{C} the critical pressure? The most direct way to answer this question would be to perform neutron scattering experiments, but these are non trivial. There are other less direct strategies to follow these modes as the system approaches a QCP.One of these is the electrical resistivity. Since magnons scatter the conduction electrons of the correlated m etal, the tem perature dependent resistivity has a component which is due to electron-m agnon scattering. The tem perature dependence of this component yields direct information on the spin-wave gap and sti ness 3].




FIG. 1: (Color online) Phase diagram of an anisotropic antiferrom agnet in an external magnetic eld in the easy axis direction [5]. The three phases, antiferrom agnet, spin-op and param agnetic and the tricritical point (T) are shown. The full lines are lines of second order phase transitions. The dashed line is a line of rst order transitions and the dotted line is a crossover line dividing the param agnetic region in two regin es, as explained in the text.

Recently, there have been many experimental studies on eld induced transitions in magnetic heavy ferm ion systems [4]. The analysis of these experiments takes into account correlated electrons with masses strongly renormalized by the presence of a QCP at the critical eld $H_{\rm C\,2}$ (see Fig.1). However, eld induced magnetic transitions are associated with soft spin-wave modes. Consequently, close to $H_{\rm C\,2}$ these modes give an important contribution to the thermodynamic properties and electrical resistivity, by scattering the quasi-particles. These contributions

should be included in an analysis of this phase transition, besides that of other quasi-particles.

The magnetic eld and temperature dependent phase diagram of an anisotropic antiferrom agnet, with the external eld H applied in the easy axis direction [], is shown schematically in Fig.1. General features of this phase diagram are the presence of a tricritical point and lines of rst and second order transitions. Heavy fermions are in general strongly anisotropic and a relevant situation for these materials is the metamagnetic case where there is no intermediate spin- op phase at all and the system goes directly from the antiferrom agnetic phase to the paramagnetic phase through a line of second order phase transitions, H $_{\rm C\,2}$ (T).

RESISTIVITY OF THE AN ISOTROPIC ANTIFERROM AGNET IN ZERO M AGNETIC FIELD

W e start considering the case relevant for the study of heavy ferm ions system s, driven by pressure to a QCP. The spectrum of hydrodynam ic spin-wave excitations in the antiferrom agnetic phase, for H << H $_{\rm C\,1}$ (T << T $_{\rm N}$) (see Fig.1), is given by,

where the gap is proportional to the anisotropy (either exchange or single ion). In the isotropic case and in the absence of a magnetic eld, the hydrodynamic magnons have a linear dispersion relation, ! (k) = $\frac{1}{2}$ D k, diesently from those in a ferrom agnet, for which, ! (k) = D k^2 .

We consider rstam etallicantiferrom agnet in a simple cubic lattice with no applied external eld. Following Yam ada and Takada [6] we write the electrical resistivity due to electron-magnon scattering as,

where C is a constant. The quantity I_{AF} (0;T) is given by the following integral [6],

where ! (k) = $\frac{p}{2 + D k^2}$ is the dispersion relation of the antiferrom agnetic m agnons. In the lim it $^1 = k_B T <<$, we deal with this integral changing variables and integrating by parts to obtain,

where $y_0 = = k_B T$. The function $F(x) = e^{y_0 (1 \cos h x)}$ is such that, F(0) = 1 and $F(x_f) = e^1$. The last condition in plies $y_0 (1 \cos h x_f) = 1$, or $\cosh x_f = 1 + y_0^1$. This function cuts of the integral at x_f and we can rewrite the equation above as,

which yields,

Since $\cosh x_f = 1 + y_0^1 = 1 + k_B T = , \sinh 2x_f = 2 + 1 + y_0^1 = 1 + y_0^1 = 1$. Using that $y_0^1 = k_B T = <<1$, we obtain,

the rst term in this expansion yields the result of Ref.[6]. Furtherm ore, it is easy to check that in the gapless case the tem perature dependence of the resistivity due to linearly dispersive magnons is, (T)/T² [6]. Eq. 3 allows to obtain from the measured (T), the absolute value of the spin-wave gap. If (T) is measured for dierent pressures it yields the trend of the stiness D and gap

as a function of this parameter, for example, when approaching a QCP. In a recent analysis of a magnetic heavy firm ion driven to a QCP by pressure, we obtained that / (P_C P), vanishing with pressure at the same critical pressure P_C that T_N (P) vanishes while the sti ness D remains unrenormalized [3]. It would be interesting to conmuthese results by direct neutron scattering experiments [7,8].

ZERO TEM PERATURE FIELD INDUCED TRANSITION

We now turn our attention to the next topic of this Report which deals with the phase transition induced in AF heavy ferm ions by an external magnetic eld. In this case it is useful to start in the paramagnetic phase, with $H > H_{C2}$ (T = 0) (see Fig. 1). The results below apply in general even if the external eld is applied perpendicularly to the easy axis. The spin-wave spectra for $H > H_{C2}$ is ferrom agnetic like, with a dispersion relation given by [5, 9],

where the m inus sign takes into account explicitly the antiferrom agnetic nature of the exchange interactions (J). In a simple cubic lattice, the m inimum of the spin-wave spectrum occurs for $q=Q=\left(=a;=a;=a\right)$. For simplicity we have considered only the isotropic part of the exchange coupling [5, 6, 9]. Since ! (Q) = H 2SZJ, the condition ! (Q) 0 de nest he critical eld $H_{\!\!\!\!\!/} 2(T=0)=2SZJ=$, below which the spin-wave energy becomes negative signalling the entrance of the system in the AF or spin- op phase. Above, Z is the number of nearest neighbors. Finally, writing q=Q+k and expanding for smallk, the spin-wave dispersion relation can be obtained as,

where the spin-wave sti ness at T=0, $D=SJ\hat{a}$ (a is the lattice parameter). The temperature dependence of $H_{C2}(T)$ is determined by that of the spin-wave sti ness D(T) [5, 9]. This generally results in a critical line varying with temperature as, $H_{C2}(T) = H_{C2}(T=0)$ bT $^{3=2}$.

We can obtain the magnon contribution to the electrical resistivity in the presence of the external magnetic eldas, (T) / I (H;T), where in three dimensions (3d)

with $y_0 = -k_B T$. The gap = (H H $_{C\,2}$) is the control param eter for the zero tem perature eld induced phase transition.




FIG. 2: (Color online) Field dependence of the electron-magnon resistivity for a xed temperature in region II of the phase diagram of Fig.1. The inset shows the eld dependence of the modulus of the derivative d =dH , which diverges as a power law when H approaches H $_{\text{C}\,2}$.

We can distinguish two regions, separated by the crossover line T $\,=\,$ ($=k_B$)(H $\,$ H $_{C\,2}$), in the phase diagram of Fig.1. This line is fully determined by the value of the magnetic moment $\,$ and by H $_{C\,2}$. In region II, for T >> T $\,$ and in particular for H = H $_{C\,2}$, the dom inant contribution to the resistivity is due to gapless magnons and given by, / (k_B T = H $_{C\,2}$) $^{3=2}$. In this region, for a $\,$ xed temperature T >> T , the resistivity as a function of magnetic $\,$ eld obtained from Eq6 is shown in Fig.2 . The resistivity has a cusp at H $_{C\,2}$. In fact d =dH / (H $\,$ H $_{C\,2}$) $^{1=2}$ and diverges to $\,$ 1 as H $\,$! H $_{C\,2}$ [6].

In region I, for k_B T << (H $\,$ H $_{C\,2}$) the resistivity is calculated as in the previous section and is given by,

The therm odynam ic properties of the system close to H $_{C\,2}$ can be easily obtained in the soft mode scenario. They are essentially those of a system of non-interacting bosons. The temperature and eld dependent contribution of the spin-wave excitations to the speciencheat G_V can be shown to have a form similar to that of the electrical resistivity. We get, C_V / I_F (H; T), with I_F (H; T)

given in Eq.6. Consequently, in region II, which includes the line H = H $_{\text{C}\,2}$, the speci cheat has a simple power law dependence, C $_{\text{V}}$ / (k_{B} T = H $_{\text{C}\,2})^{3=2}$. In region I, the eld and temperature dependence of C_{V} is the same as that of the resistivity given in Eq. 7. The magnetization at the critical eld H $_{\text{C}\,2}$ decreases with a T $^{3=2}$ power law. In region I for H > H $_{\text{C}\,2}$ it decreases exponentially due to the gap, = (H H $_{\text{C}\,2}$).

TW O DIM ENSIONAL CASE

M any heavy ferm ions systems due to their anisotropy in the crystalline structure have a regime close to their QCP where the critical uctuations have a two-dimensional character [1]. For this reason it is interesting to generalize the results obtained above for the case of two dimensions (2d). In 2d the relevant integral for the resistivity can be evaluated and we get,

where $h = (H H_{C2})=H_{C2}$ and $t = k_B T = H_{C2}$. In the lim it (h=t)! 0, this reduces to




FIG .3: Sem i-logarithm ic plot of the resistivity $\;$ and speci c heat C $_V$ divided by T in 2d. Inset shows $\;$ and C $_V$ versus T .

This resistivity varies nearly linear in temperature (Fig.3) but for H ! H_{C2} (h ! 0) it is not de ned for nite tem peratures. This is related to the fact that for an isotropic system there is no long range order in two dimensions at any nite temperature due to the creation of an in nite num ber of magnons. The systems we are considering are in fact three dimensional, although they may exhibit in som e region of their phase diagram a 2d behavior. However, this is just a regime which will cross over to 3d su ciently close to the transition. Consequently this divergence of 2d (0;t) should not interfere with the actual observation of a nearly linear tem perature dependence of the resistivity of real systems in some range of region Π . In 2d the spin-wave contribution to the speci cheat, as before, has a similar eld and temperature dependence of the resistivity due to electron-magnon scattering. We nd in this case ((h=t)! 0) that in region II (Fig3),

The decrease of the magnetization with temperature in a xed eld in this region also has a eld and temperature dependence similar to Eq. 9.

Finally, in region I the speciencheat, magnetization and resistivity have an exponential term, as in Eq. 7. Only the temperature dependence of the pre-factor is dependent on dimensionality. This makes it discult to distinguish a 2d from a 3d regime in this region, either in thermodynamic or transport measurements.

CONCLUSIONS

We have obtained the electrical and therm odynamic properties of a m etallic antiferrom agnetic system due to spin-wavem odes close to a zero temperature eldinduced transition. The existence of these excitations close to this phase transition is a general phenom enon, depending only on the appearance of a sym m etry-broken state below H_{C2}. The resistivity is determined by the scattering of quasi-particles by ferrom agnetic-like m agnons which becom e gapless at the transition. The contribution of the spin-wave modes to the thermodynamic and transport properties is distinct in dierent regions of the phase diagram. In region I, this is exponentially suppressed by the gap = $(H H_{C2})$, but in region II these m odes are effectively gapless and give rise to im portant contributions. Notice that these contributions should be considered in addition to those of other quasi-particles. For example, in region I, it has been observed [4] a signicant T² term in the resistivity probably due to electron-electron interaction. This temperature dependence of the resistivity is dierent from that arising from spin-wave scattering which in turn is exponentially suppressed by the gap. In region II however, the spin-wave term is large and its power law tem perature dependence is sim ilar to that associated with non-Ferm i liquid behavior close to a QCP [10]. This will make it dicult to separate this contribution from that of other quasi-particles. The interaction of the latter with the spin-wave modes may even give rise to substantial mass renormalization. The same remarks apply for the therm odynam ic properties in both regions.

The temperature dependence of the thermodynamic properties at the critical eld $H_{C\,2}(T=0)$ is similar to that predicted by the scaling theory of a QCP with a dynamic exponent z=2 [10]. In the present case, this value of z rejects the ferrom agnetic-like dispersion

of the magnons and not the antiferrom agnetic nature of the transition. In the extreme metamagnetic case of an Ising antiferrom agnet in an external longitudinal eld, a renormalization group approach yields a phase diagram where the T = 0 transition at H $_{\text{C}\,2}$ is not associated with a xed point. The point (H = H $_{\text{C}\,2}$; T = 0) is just an ordinary point that lows to (H = 0; T = T_{N}) as any point in the line of second order transitions H = H $_{\text{C}\,2}$ (T), since the magnetic eld turns out to be an irrelevant parameter [11]. Notice that the spin-wave approach presented above is independent whether the T = 0 transition at H $_{\text{C}\,2}$ is associated or not with a xed point.
