Spin Hot Spots in vertically-coupled Few-electron Quantum Dots

The e ects of spin-orbit (SO) coupling arising from the con nement potential in single and two vertically-coupled quantum dots have been investigated. Our work indicates that a dot containing a single electron shows the lifting of the degeneracy of dipole-allowed transitions at B = 0 due to the SO coupling which disappears for a dot containing two electrons. For coupled dots with one electron in each dot, the optical spectra is not a ected by the coupling and is the same as the dot containing one electrons. However, for the case of two coupled dots where one partner dot has two interacting electrons while the other dot has only one electron, a remarkable e ect is observed where the oscillator strength of two out of four dipole-allowed transition lines disappears as the distance between the dots is decreased.

Interest in spin properties of sem iconductor nanostructures has increased signi cantly in recent years due to the exciting possibility to manipulate it in solid state devices [1, 2]. The role of SO coupling in nanostructured systems is in portant in this context because this coupling would provide a means to in uence the spin states via the orbital degrees of freedom [3]. Quantum dots (QDs) are particularly prom ising systems for these studies as the electron spin states are very stable in these zero-dimensional system s and are measurable [4].

In quantum dots, spin hot spots are composed of two or more states that are degenerate in the absence of the SO coupling but the degeneracy is lifted due to the SO coupling [5]. The importance of these hot spots lies in the fact that this lifting of degeneracy allows mixing of the spin-up and spin-down states and opens up the possibility for spin ip transitions in the presence of the SO coupling. Recent studies have indicated that for laterally coupled quantum dots, there is no contribution of the Bychkov-Rashba SO potential [6] to the spin hot spots at zero magnetic eld [5]. We have explored the spin hot spots in vertically coupled quantum dots where they are readily identi able and re ects interesting physical properties in the presence of SO coupling through the low -lying energy levels as well as in the dipole-allowed optical absorption spectra. To be speci c, we have studied the e ect of Bychkov-Rashba SO coupling in the optical transition spectra and the energy levels of two parabolic dots placed vertically and interacting only through the Coulom b interaction. Interestingly, the zero-eld spin hot spots in our vertically-coupled QDsmanifests in the dipole transition energies. For coupled QDs with one dot containing two electrons while the other with a single electron, the SO e ect strongly depends on the interdot separation. It should be pointed out that a vast literature exists on the electronic properties of vertically-coupled quantum dots [7], but without any spin-orbit interaction included. The interest on the role of SO coupling in coupled quantum dots has reached its peak recently due to its in portance

in quantum information processing [8].

W e begin with the low-lying energy levels and the transition energies of a single electron in a vertically-coupled parabolic quantum dot [9, 10] in the presence of a SO coupling. From the D irac equation we know that whenever a spin-half particle with charge q m oves under the four-potential (\tilde{A} ;) the lowest-order relativistic correction leads to the SO potential V_{SO} of the form

In quantum dots the electric eld can arise, for example from the inversion asymmetry of the potential restricting the motion of the electrons (charge e < 0 and effective mass m) to a two-dimensional plane [11]. Then the electric eld would be perpendicular to the plane of the motion. Furthermore, since we may well assume the eld to be nearly hom ogenous within the range of the electron wave functions it can be replaced to a good approximation with its average value. It is also custom ary to collect all the parameters including the average of the electric eld into a single coupling constant leading to the familiar Bychkov-Rashba potential [6]

for the SO coupling due to the inversion asymmetry.

A nother source for the electric eld in the quantum dot is of course the potential V_c that con nest the electrons into the dot in the two-dimensional plane. The eld \vec{E}' now lies in the plane of motion and, if the con nement is rotationally symmetric it will be parallel to the radius vector $\vec{r} = (x; y)$. It is easy to see that the SO coupling can now be written as [12]

where p and A stand for the angular components of the m om entum and the vector potential, and where again we have combined m ost of the parameters to a constant . A s compared to the V_{SOI} we see two essential di erences in V_{SOC}. Firstly, the coupling depends on the position, in particular in the case of the parabolic con nem ent V_c = $\frac{1}{2}$ m $\binom{9}{2}r^2$ it will be proportional to $\binom{9}{2}r$. Secondly, it is diagonal in spin space. From our point of view this latter property m akes it very attractive because it allows us to nd analytic solutions for the single-particle problem. It should be noted, how ever that in order to see the e ects arising from the con nem ent-induced SO coupling V_{SOC}, the con nem ent itself m ust be rather large. Typically, ~!_0 m ust be of the order of 10{20 m eV [12].

The Ham iltonian describing our coupled-dot system is given by

where d is interdot separation (in units of magnetic length ${}^{\circ}_{\rm B}$), H $^{\circ}_{\rm i}$ is the H am iltonian governing a single electron con ned in a parabolic quantum dot [9, 10] and is given by

where $_z$ is the Pauli z-matrix and is the Bychkov-Rashba spin-orbit coupling parameter [6]. It is to be noted that the rst term of H $_{so}^{\circ}$ is independent of the external magnetic eld B.At B = 0 it lifts the spin degeneracy because of the magnetic eld orginating from the orbital motion of the electron in the presence of electric eld com ing from the con nem ent potential [12].

The energy eigenfunctions are then given by

where $r = (\sim = m)^{\frac{1}{2}}$ and $L_n^{j'j}$ is the generalized Laguerre polynom ial.

The corresponding electron energy levels are




FIG.1: The (a) dipole transition energies and (b) a few lowlying energy levels of the single-electron energy spectrum of a single quantum dot in the presence of the SO coupling. The states are labelled as (';) where ' and denote the orbital and spin quantum numbers respectively. The spin up and spin down projections are denoted by 1 and 1 respectively. At B = 0, the degeneracy (w ithout the SO coupling) is lifted. The states w ith antiparallel ' and spin are lower in energy.





FIG.2: The (a) dipole-transition energy spectrum and (b) the few low-lying energy levels of a two-electron dot in the presence of the SO coupling. In (b) the low est line represents the eigenvalues of the state $L = '_1 + '_2 = 0; S = s_1 + s_2 = 0$. The eigenvalues for the L = 1; S = 1; 0; 1 states are drawn as dashed lines.

and $!_{c}$ is the cyclotron frequency. C learly, the SO coupling in uences [Eqs. (3) and (2)] which results in an increase of the energy of the up spin and an decrease in energy of the down spin. Another e ect due to the SO






FIG.3: The (a) transition energy spectrum and (b) the few low -lying energy levels of two vertically-coupled dots separated by $d = 0.5 \frac{h}{B}$ in the presence of the SO coupling. Each dot contains a single electron. In (b), the three lowest lines correspond to the eigenvalues for the states $L = \frac{h}{D_1} + \frac{h}{D_2} = 0$; $S = \frac{h}{S_D - 1} + \frac{h}{S_D - 2} = 0$; 1. The eigenvalues for the L = 1 states are drawn as dashed lines.

coupling is from the last term of Eq. (2) which is independent of an external magnetic eld. As mentioned earler, at B = 0 it lifts the spin degeneracy of the states with the same orbital momentum. The energy of the states with anti-parallel spin and ' is lowered while the states with the parallel ' and spin show an increase in energy at B = 0.

The dipole-allowed transition energies of a single parabolic dot in the presence of the SO coupling are presented in Fig. 1(a) while the energy eigenvalues are presented in Fig. 1(b). In all our calculations, the m aterial param eters are for the InAs dots as listed in Ref. [12]. Transitions take place from the j' = 0; "i state to j' = 1; "i and j' = 1;" i states. These two transitions are not degenerate at B = 0 because of the SO coupling: j 1 "ihas low erenergy than that of jl "i [Fig.1(b)]. It is interesting to note that this splitting between the L = +11 branches at B = 0 disappears if the dot conand L = tains two electrons [Fig. 2 (a)]. In the energy spectrum of a two-electron dot [Fig. 2(b)], the lowest line represents a two-electron state where the electrons occupy 10 "i and 1) #i states. In order to understand the degeneracy of the L = +1 and L = -1 branches at B = 0, let us look at the states involved in the transition to (say) the L = +1branch. In this case, any of the two electrons occupying 1) "i and 1) #i states can be excited: the electron is excited either from 10 "ito 11 "ior from 10 #ito the 11 #i state. Due to the SO interaction, the excitation energies are not degenerate at B = 0. Since there are now two electrons, the Coulomb interaction between them mixes the jl "i and jl #i states. The eigenstate is a com bination of jl "i and jl #i states due to the C oulom b interaction. Similarly, the L = 1 transition can occur in two ways:

electron can either jump from j "i to the j 1 "i state or from j #i to the j 1 #i state. A gain, these two possibilities for L = 1 are not degenerate at B = 0 but due to the C oulom b interaction the eigenstate is a com bination of these two alternatives. How ever, the state j 1 "i is degenerate at B = 0 w ith jl #i and so are the states j 1 #i and jl "i [F ig.2 (b)]. Therefore, we do not observe a splitting at B = 0 between the L = +1 and L = 1 branches in the optical spectra of a dot containing two interacting electrons.

The results for two quantum dots each containing one electron and are vertically coupled (via only the C oulom b interaction) are displayed in Fig. 3. For a large separation of the dots (e.g., $d = 9:5'_{B}$), the transition energies, quite expectedly, resemble those of a single dot with one electron Fig. 1(a)]. As the dots are brought closer, the inter-dot interaction becom es stronger but that m odi es only the energy spectrum, leaving the optical spectra unchanged [Fig. 3(a)]. Figure 3(b) shows the low-lying energy levels for two dots at a separation of $d = 0.5 I_B$. An electron in the ground state j) "i in any of the two dots can make a transition to jl "i state. There are now two states corresponding to $L = {}^{\prime}_{D1} + {}^{\prime}_{D2} = 1$, $S = S_{D 1} + S_{D 2} = 1$ where $'_{D 1}$, $S_{D 1}$ and $'_{D 2}$, $S_{D 2}$ represent the quantum numbers for the rst and second dot respectively. W hen the inter-dot interaction is very weak, the two states $('_{D1} = 1, '_{D2} = 0)$ and $('_{D1} = 0, '_{D2} = 1)$ are degenerate. However, as the separation between the dots is decreased, the Coulomb interaction lifts the degeneracy between the two eigenstates (which are linear combination of above two states). For L = 1, we sim ilarly have two levels. However, the oscillator strength of the lower state is nearly zero and the transition takes place only to the higher state. Therefore, there are only two lines (for L = 1) in the optical spectra for all distances between the two dots F ig. 3(a)].

The most interesting situation is found to occur when one dot has a single electron while the other dot contains two electrons. Figure 4 shows the transition energies of the two dots for two di erent values of the interdot separation: (a) d = 0.5'_B, and (b) d = 9.5'_B. For a large separation of the dots (d = $9.5'_{B}$), there are four lines as a function of the magnetic eld [Fig. 4(b)], whereas there are only two lines for a much smaller separation $(d = 0.5 '_{B})$ [Fig. 4(a)]. This is because when the dots are far apart the uncoupled two-electron dot does not show the SO splitting between the L = 1 and L = 1 branches at B = 0 and as a result, there are two m iddle lines that are degenerate at B = 0. The one-electron dot, on the other hand shows a splitting and results in the lowest line corresponding to the L = 1 branch while the upperm ost line corresponds to the L = 1 branch. Hence we have two L = 1 branches and two L =1 branches for the two dots. As the distance between the dots decreases, the excited L = 1 state of the two dots are coupled by the Coulomb interaction. The transition probability for the low er state decreases while it increases for the higher state. At $d = 0.5'_{B}$ the transition to the lower state is zero and hence we have only one line corresponding to the L = 1 branch and similarly one line for the L = 1branch [Fig. 4(a)]. The novel result we observe here is that, unlike in the case of two coupled dots with one electron in each dot, in the present system, for a large separation, the L = 1 branch coming from the two-electron dot is not degenerate with the L = 1 branch coming from the one-electron dot. Therefore, one could observe the dis-

appearence of one of the two L = 1 branches (same for the two L = 1 branches) as the distance between the two dots is decreased. It should be pointed out that the L = 1 branch of the dot containing two electrons is not degenerate with the L = 1 branch of the dot containing a single electron because the two-electron dot does not show the SO splitting between the L = 1 branches while the one-electron dot does show the splitting.

In summary, we have investigated a single parabolic QD and two vertically coupled QDs, containing one or two (interacting) electrons, in the presence of the SO coupling. For single dots, the SO interaction that we considered to be arising from the con nem ent potential, lifts the degeneracy of the dipole-transition energies at B = 0 for a dot containing one electron. The splitting disappears for a dot containing two electrons. The lifting of the degeneracy at B = 0 is also observed for two coupled QDs, each containing a single electron. In case of two coupled dots where one partner dot has two interacting electrons while the other has only one electron, the dipole transition energies show a remarkable dependence on the interdot separation. For a large separation, the spectra consist of four lines corresponding to a com bination of one and two electron spectra. However, as the separation between the dots is decreased, the oscillator strength for the lower eigenstates of L = +1 and L =decreases and the optical spectra contains only two lines instead of four.
