Theory of coexistence of superconductivity and ferroelectricity

A new investigation of the coexistence and competition of ferroelectricity and superconductivity is reported. In particular we show that the starting H am iltonian of a previous study by B imm an and W eger (2001) can be exactly diagonalized. The result di ers signi cantly from mean-eld theory. A H am iltonian with a di erent realization of the coupling between ferroelectricity and superconductivity is proposed. We report the results for mean-eld theory applied to this H am iltonian. We not that the order parameters are strongly a ected by this coupling.

In the present paper we report two related results from a reexam ination of previous work on nearly ferroelectric superconductors. In that paper a coupling term was introduced into the original Hamiltonian (Eq. 27 of Ref. 1). An investigation of that coupling term shows that it only gives a squeezing of the phonons and no coupling to the electronic pairs, and therefore the Hamiltonian can be diagonalized exactly. However, the double mean-eld approximation does result in an e ective coupling between the two subsystems. (Eq. 34 of Ref. 1). Therefore the results of the analysis of that equation remain valid. Our second result follows from introducing a dierent biquadratic coupling term in the Hamiltonian of Eq. 27 of Ref. 1, which satis es gauge and inversion symmetries. This term does couple the two subsystems. We will treat this new Hamiltonian in mean-eld approximation.

We start with the model of coexistence of superconductivity and ferroelectricity proposed by Birm an and Weger¹. For convenience we include its main features here. Birm an and Weger start with two separate Hamiltonians for the superconducting and ferroelectric sectors. The superconducting sector is a mean—eld reduced BCS pseudo-spin model (we corrected a misprint in Ref. 1)

where \mathbf{w}_k is the single-electron energy and \mathbf{w}_k is the pairing interaction energy. The pseudo-spin operators \mathbf{w}_k obey SU (2) commutation relations and are defined as

and $\hat{a}_{k"}$ and $\hat{a}_{k"}^{y}$ are the electron annihilation and creation operators for wave vector $\hat{\kappa}$; spin ("); etc.

The Hamiltonian of the ferroelectric sector of the model is $\sin p \ln a$ a Hamiltonian of a displaced harmonic oscillator

where $\hat{B}_0^{\gamma}; \hat{B}_0$ have boson commutation relations.

C om bining those two sectors together and introducing a gauge invariant coupling between them , B imm an and W eger obtain the following H am iltonian (Eq. 27 of Ref. 1)

Here we notice that the structure of the pseudo-spin operators in terms of the pair operators in plies

and therefore $^{12}_{11}$, $^{12}_{2}$ and $^{12}_{3}$ are invariant to any rotation of the form exp 11 .

We use this property to diagonalize the Ham iltonian analytically by applying the following unitary transformation

Inserting them back into the transformed Hamiltonian gives

and this is the decoupled H am iltonian of a squeezed and shifted harm onic oscillator and a spin of one-half in a magnetic eld. The energy spectrum is given by

W e can now use the exact eigenstates of the H am iltonian to compute the order param eters of the system:

W hile the order param eter of the ferroelectric sector is a ected by the SC-FE coupling strength, the order param eter of the superconducting sector is not. This occurs since in the coupling term $_2 \not|_2^2$ $B_0^Y + B_0^{^2}$; $\not|_2^2$ is a c-num ber and not an operator.

Using a double mean-eld approximation for the Hamiltonian (Eq. 34 of Ref. 1) and variational coherent state wave function, Birm an and Weger¹ obtained the following relations for the order parameters

Here both order parameters are a ected by the SC-FE coupling strength ($_2$):

To sum up this part, we have obtained an exact analytical solution of the ferroelectricity and superconductivity coexistence model, used in Ref. 1. We showed here that contrary to the mean—eld results, an exact solution of the model demonstrates that the ferroelectric order parameter is a ected by the coupling, but the superconducting order parameter is not. If one were to initially model the SC-FE system by Eq. 34 of Ref. 1, the results reported in Ref. 1 would remain valid.

Returning to the original question of the proper coupling term in a quantum mechanical Ham iltonian, we need to respect gauge and inversion symmetry. Since the superconducting gap parameter is a complex quantity the added term should correspond to the bilinear j \hat{j} : We now take this as $\uparrow_+ \uparrow$: The coupling term for the ferroelectric polarization, which respects inversion symmetry will correspond to P^2 and can be taken as $\hat{B}_0^{\hat{Y}} + \hat{B}_0^{\hat{Y}} = \hat{B}_0^{\hat{Y}} + \hat{B}_0^{\hat{Y}} = \hat{B}_0^{\hat$

The interaction term in this H am iltonian di ers from the corresponding term (Eq. 27) in R ef. 1. This H am iltonian is not exactly solvable, therefore we make a mean—eld approximation in the form

Inserting Eq. 5 into Eq. 4 results in a solvable bilinear Hamiltonian




FIG. 1: The absolute values of the superconducting order param eter and the ferroelectric order param eter as a function of the coupling constant $_2$: The left side of the ordinate corresponds to small negative values of $_2$: Here = " = $_1$ = ! $_0$ = 1:

This mean-eld Ham iltonian, Eq.6, diers from Eq.34 in Ref.1 and can be diagonalized using rotation, squeezing and displacement transformations;

This set of equations can be reduced to a polynomial equation, which we solved numerically. Using these numerical results we investigate the behavior of the order parameters

Fig. 1 shows the dependence of the two order parameters on the coupling coecient between the ferroelectric and superconducting subsystems. There is a smooth evolution of each of the order parameters with the coupling coecient $_2$: Both order parameters are non-vanishing at $_2$ = 0. We note that $_2$ is bounded by two critical values, beyond which there are no real solutions for the set of self-consistent equations (7). At the positive critical value the superconducting gap parameter $_{\rm SC}$ reaches its maximum, and the polarization order parameter $_{\rm FE}$ reaches its minimum. For negative values of $_2$ the superconducting order parameter vanishes very rapidly, while the ferroelectric order parameter sharply diverges, when $_2$ approaches its negative critical value.

In conclusion we note that our new model for SC-FE coexistence/com petition does agree with the spirit of the M atthias conjecture that each of these cooperative elects tends to exclude or suppress the other.
