Single tensionless transition in the Laplacian roughening model

We report large scale M onte Carlo simulations of the equilibrium discrete Laplacian roughening (dLr) m odel, originally introduced as the simplest one accomm odating the hexatic phase in two-dimensionalmelting. The dLrm odel is also relevant to surface roughening in M olecular Beam Epitaxy (MBE).We nd a single phase transition, possibly of the K osterlitz-T houless type, between a at low-temperature phase and a rough, tensionless, high-temperature phase. Thus, earlier conclusions on the order of the phase transition and on the existence of an hexatic phase are seen as due to nite size e ects, the phase diagram of the dLrm odel being similar to that of a continuum analog previously form ulated in the context of surface grow th by MBE.

Two-dimensional (2D) melting has played a driving rôle in Statistical Physics for more than two decades. E orts made at clarifying its nature [1] have aided to understand systems in which topological defects are relevant, from the equilibrium uctuations of metallic surfaces [2] to super uidity and superconductivity in thin Im s, and phase transitions in liquid crystals [3]. One of the most intriguing related notions is the hexatic phase, between a solid at low temperature (T) and an isotropic uid at high T, transitions between phases being of the K osterlitz-T houless (KT) type. Such is the K osterlitz-T houless H alperin-N elson-Y oung (KTHNY) mechanism for 2D melting [3]. A lthough controversial for som e time, the hexatic phase has indeed been found in atom istic m odel system s [4] and in experiments [5].

A successful approach to system swith defect-m ediated phase transitions as the above has been the use of duality to form ulate equivalent height models. E.g., the discrete G aussian (dG) model [Eq. (1) below for bending rigidity parameter = 0] is dual of the 2D C oulom b gas, and the roughening transition in the former corresponds [6] to the well-known KT phase transition of the latter, driven by the unbinding of vortex-antivortex pairs. W ith a sim ilar philosophy, the discrete Laplacian roughening (dLr) model was introduced by N elson [7] to describe 2D m elting. Its H am iltonian is

where r denotes position on a 2D lattice of lateral size L, r_d is discrete gradient, and h 2 Z. The original dLr m odel [7] is obtained by setting to zero the surface tension parameter . Note, the dLrm odel is a discrete version of the linear approximation to Helfrich's energy functional for 2D m embranes [8], and provides a simplied description of uctuating tensionless surfaces, such as biological m embranes [8] or, e.g., such as those grown under conditions typical in Molecular Beam Epitaxy (MBE) [9].

For the dLrm odel, the KTHNY mechanism would im ply [1] an interm ediate hexatic phase in which the surface disorders in heights, but not in slopes (quasi-long range orientational order). For low T, the surface would be in a at phase, dual of the isotropic uid in melting, while for high T the surface would disorder in heights and slopes, providing the dual of the solid phase. In term sof the surface structure factor S (q) = $h\hat{h}(q)\hat{h}(q)i[10]$, the rough high T phase in plies power law behavior as S (q) q^4 , changing to S (q) q^2 in the hexatic phase [11], and to existence of a nite correlation length in the at low T phase. Equivalently, for the stationary height-di erence C (r) and slope-di erence C_d (r) correlations [12], these behaviors amount to: (i) rough phase C (r) $r^2 \log r$, C_d (r) $\log r$; (ii) hexatic phase C (r) $\log r$, C_d (r) 1; (iii) at phase C (r) 1_{r} C (r) 1. Results supporting this picture were obtained on sm all (L 32) square and triangular lattices [13]. How ever, con icting evidence for \mathbf{L} 64 was presented that the model had a single rst. order transition, see [14] and references therein. The discrepancy has remained unsolved, in spite of recent analytical studies [15], elucidation of the phase diagram being important to the diverse contexts mentioned above.

Here, we provide new Monte Carlo (MC) simulations of the dLrm odel on the square and triangular lattices. Our results for sizes up to 512 512, much larger than those previously studied [13, 14], allow us to see previous works as inconclusive due to nite size e ects. The model has a single continuous transition, possibly of the KT type, between the at and the rough phases, there being no sign of an hexatic phase to within our num erical resolution in T. Notably, this provides an instance of a roughening transition in which the rough phase corresponds to a free tensionless surface, rather than a free surface with tension, as in the dG model. Moreover, the phase diagram of the dLr model is seen to resemble closely that of a continuum model proposed [9, 15] for MBE growth, suggesting that both m odels are in the sam e universality class, much like the relationship between the dG and the




FIG.1: Surface m orphologies for three sample temperatures around T_c on the L = 128 square lattice for N eumann (zero derivative) boundary conditions. Inset: Lateral cut of the surface for T = 1:7. All units are arbitrary.

continuum sine-Gordon models [16].

For our M C simulations we follow the same procedure as in [13], uctuations being treated by the histogram m ethod [17], further validated through additional sim ulations on di erent points of the extrapolated intervals. Therm alization has been checked by monitoring the behavior of non-local observables like the speci c heat and the structure factor at the sm allest wave-vector on our nite lattices, S(q = 2 = L), as functions of MC time. Note that the dLrm odel has a richer ground state structure than the dG model, Ham iltonian (1) with = 0 being minimized not only by con gurations with uniform heights, but also by con gurations with uniform slopes (and by more complex morphologies, see below), see e.g. the surface m orphology m ade up of patches with various constant slopes shown in Fig. 4 for high T. In simulations, this requires large enough system sizes and appropriate boundary conditions so that the fullm in in a structure can be signi catively probed. In particular, for sm all sizes and periodic boundary conditions the system is e ectively constrained to uctuating around a single energy minimum (the morphology with zero slope), inducing apparent hystheretic behavior associated with a rst order transition [14]. In our simulations, we have employed both periodic and free (Neumann) boundary conditions, and we have m ade sure that results provided are (qualitatively) independent of these.

As done for the dG m odel in [?], we study the phase transition through the behavior of the structure factor S (q) for di erent temperatures. In order to test the KTNHY mechanism, we have studied the behavior of S (q) as a function of T and L, by thing the smallwave-vector part of S (q) to S (q) q^r . As seen in Fig. 3 for the square lattice (for the sake of clarity, we om it plots for the triangular lattice, in which completely analogous




FIG.2: E ective exponent r in the small wave-vector behavior S (k) k^r (for k $2\sin(q=2) < k$ (L) 3 = L), as a function of T, for L = 32 (3), 64 (2), and 128 (o). Inset: surface structure factor S (k) on the L = 128 square lattice vs k, for T = 1:62 (bottom) up to T = 1:69 (top). D ashed reference lines have slopes 2 (bottom) and 4 (top). All other lines are guides to the eye. All units are arbitrary.

results are obtained), there is no evidence of a nite temperature interval within which r' 2, that would be the signature of the hexatic phase. Rather, we nd a gradual change from the at phase behavior (r' 0) to the rough phase one (r' 4). This change becomes more abrupt when the system size is increased, so that only the at and the rough phases remain well-de ned in the therm odynamic limit. These results may thus explain the apparent observation of an hexatic phase in [13] for sm all L values, where no system atic nite size e ects were assessed. By de ning the critical temperature T_c as the value at which curves for di erent system sizes cross [17], we estim ate $T_c = 1:65$ (1) for the square lattice and $T_c = 1:90$ (2) for the triangular lattice.

Further evidence on the existence of a single phase transition is provided by the behavior the speci c heat $c(T;L) = hH_{dLr}^2 i hH_{dLr}i^2 = (T^2L^2)$ as a function of tem perature. Fig. 1 shows c(T) on the square and triangular lattices for the largest system sizes in our simulations. W ithin our statistics, a single peak at T = Tcan be detected, rather than two as would be expected within the KTHNY scenario. The height and position of the peak are functions of lattice size L. Fig. 2 (inset) provides the results of nite size analysis on the speci c heat curves, in which the maximum value $c_{max}(L)$ obtained for each lattice size is plotted as a function of L. Remarkably, although for lattice sizes L . 70 the specicheat grows approximately as c_{max} . L compatible with claim s on the apparent weakly rst order character of the transition for L 64 [14] , for larger L values the increase of c_{max} (L) slows down. For our largest sim ulated systems, the best t is logarithm ic c_{max} logι. Actually, for the 2D XY model the specic heat at the transition temperature is known [18] to rst grow logarithm ically with system size and then saturate for large




FIG.3: c(T) vs T on the square (m ain panel) and triangular (inset) lattices for L = 16 (), 32 (4), 64 (o), 128 (3), 256 (2), and 512 (5). Bars are statistical errors and thin lines are guides to the eye. For the larger L values in each case, thick solid lines show the c(T) curve extrapolated by the histogram m ethod [17]. All units are arbitrary.

enough values of L, suggesting our result m ight re ect nite size e ects. Indeed, saturation is expected provided that the correlation length at T is smaller than L and thus a horizontal plateau would occur at low k for S (k), namely r = 0 as de ned in Fig. 2. The steady decrease of rat T for increasing L indicates that such a condition has not being reached. Persistence of logarithm ic behavior in the L! 1 lim it would rather suggest that the phase transition is in e.g. the 2D Ising class [19]. In order to explore this possibility, in Fig. 2 we study the dependence of the speci c heat jum p position T (L) with lateral size L. In a continuous transition, T (L) scales $L^{1=}$ (1 + g $L^{!}$), where g is a nuas [19] T (L) T merical constant and ! is an exponent that accounts for corrections to scaling, and is in the range 7=4 2 for ! the 2D Ising class [20]. The best multiparameter t to such scaling form yields = 1:54(47), and = 0:94(16)on the square and the triangular lattices, together with ! = 1:6(3), and 2.2(2.0) respectively, to be compared with = 1 for the 2D Ising class [21]. Although these results might seem compatible with 2D Ising universality for the present transition, we believe our num erical evidence favors more strongly a di erent interpretation. Thus, in marked contrast with 2D Ising and as shown by Fig. 3, the transition in the dLrm odel is from a phase with nite correlation length to a continuous line of xed points [in the Renorm alization G roup (RG) sense], characterized by an in nite value of the correlation length, as occurs in a KT transition [16]. In order to corroborate the latter interpretation, we can try a phenom enological KT-type form for T (L), namely [19]

$$T (L) = T + \frac{a}{(\log L + b)^2};$$

for constant a and b. As seen in Fig. 2, this t is in very




FIG.4: Transition temperature T as obtained from Fig.1, as a function of L for the square (2) and triangular (4) lattices. For each case, the dashed line is a power-law tT (L) T L $^{\rm 1=}$, and the solid line is a t to Eq. (2). L = 512 is not employed for the t due to low statistics. Inset: $c_{\rm m \ ax}$ (L) vs L on the square (2) and triangular (4) lattices. Lines are logarithm ic ts to the data, shown for reference. All bars represent statistical errors and all units are arbitrary.

good agreem ent with the num erical data for large sizes. We must caution the reader on the well-known feature of the KT transition, that the peak of the specie cheat does not occur at the critical tem perature but, rather, at a tem perature preceding T_c [18, 19]. A lthough the size of this o set can be model-dependent, Fig. 2 indeed provides estimates, T = 1.63 (1) on the square lattice, and T = 1.85 (1) on the triangular lattice, that are below the corresponding T_c values, and are still inside the low T behavior for the spatial correlation functions, see Fig. 3. Thus, the inexistence of an interm ediate phase and the fact that the spatial correlations and the specie cheat change behavior at di erent values of T can be hardly reconciled with a single transition of the Ising class.

Our results seem to replace the KTHNY scenario for the dLr model by a single, tensionless, KT-type phase transition. The absence of the hexatic phase may seem surprising when contrasted with the offen accepted argum ent that, for increasing T, the surface should st disorder in heights and, then, in slopes. However, this is a su cient condition for surface roughening, but it is not necessary. For instance, in the dG m odel slopes are not disordered at any tem perature. It is also conceivable, as is our belief, that heights and slopes disorder at the sam e tem perature in the dLrm odel. This remarkable result is also against the expectation that discreteness in surface heights renorm alizes the surface tension , as it indeed does in the dG model [16]. For the dLr model, generation of a non-zero would imply that the asymptotic properties of the high T phase coincide with those of the dG model [11]. In order to explore this possibility, various analytical approaches [15] have been applied to the following continuum analog of the dLrm odel, introduced

in the context of grow th by M BE [9]:

is a delta-correlated G aussian white noise, and where a?, V, are param eters. A lthough a dynam ical RG study for (3) does predict the generation of a non-zero surface tension, num erical simulations of this Langevin equation [9] give results in complete qualitative agreement with those of the dLrm odel presented here. The discrepancy between the RG arguments and the numerical results for both the discrete and continuum models might be due to inaccuracies in the treatment of model symmetries in the RG studies. Namely, the dLr model can be written as a model for the surface slopes m r_dh, ie., $H_{dLr} = \frac{1}{2} r_{r} [r_{d} m (r)^{2}]$, with the implicit restriction thatr_d m 0. Thus, the dLrm odelhas larger sym m etries than the dG m odel, the H am iltonian being invariant under arbitrary global shifts in the heights, as in the latter, but also in the slopes. Thus the ground state degeneracy here is much larger, m in in a occurring for all height con gurations for which $r_d = 0$. However, standard perturbative RG analyses [15, 22] are oblivious to such an added com plexity in the ground state structure of the model. Perhaps in a related fashion, the zero-vorticity constraint for the slope eld m ay be playing a dynam ical rôle in the unbinding of surface defects for $T = T_c$ in the

2D melting transition described by the dLrm odel.

Sum m arizing, we have found that the dLrm odel features a single continuous phase transition. A lthough sizes of our simulations are conned to a regime in which the specic heat still grows logarithm ically with L, rather than saturating as in proper KT scaling, the combined inform ation from the spatial correlations and the specic heat are consistent with a KT transition. This behavior is remarkably similar to that of the continuum m odel (3), including the tensionless nature of the high T phase. P rogress in the analytical description of these phenom ena might in prove our understanding of non-perturbative effects in defect-m ediated transitions, and of dynam ical e ects of geom etrical constraints (such as the curl-free condition above) in equilibrium system s.
