A bstract. We present an exact mapping between two simple spin models: the Fredrickson-Andersen (FA) model and a model of annihilating random walks with spontaneous creation from the vacuum  $A + A \ddagger 0$ . We discuss the geometric structure of the mapping and its consequences for symmetries of the models. Hence we are able to show that the upper critical dimension of the FA model is two, and that critical exponents are known exactly in all dimensions. These conclusions also generalise to a mapping between  $A + A \ddagger 0$  and the reaction-di usion system in which the reactions are branching and coagulation,  $A + A \ddagger A$ . We discuss the relation of our analysis to earlier work, and explain why the models considered do not fall into the directed percolation universality class.

The one spin facilitated Fredrickson-Andersen (FA) model [1,2] has been of interest recently as a simple model that exhibits dynam ical heterogeneity [3, 4, 5, 6, 7]. This model has a dynam ical critical point at zero temperature that is not characterised by the divergence of any static lengthscale. As such, it represents a possible model of structural glasses, in which dynam ical lengthscales seem to be large, but no large static lengthscales have been found [3].

An important advance was made by W hitelam et al. [4]. They showed that the master equation of the FA model can be cast in a eld-theoretic formalism that resembles a simple reaction-di usion system with branching and coagulation processes. The dynamical critical point occurs when the density of the di using defects vanishes. The properties of the system near the xed point can then be studied by the powerful m ethods of the renormalisation group. The analysis of R ef. [4] indicated that uctuation e ects are important below four dimensions and that the model is controlled by the directed percolation (DP) xed point [8] between two and four dimensions.

In this article we follow Ref. [4] in writing the FA model in a eld theoretic language. The overall picture of a zero tem perature dynam ical xed point that controls the low tem perature scaling remains robust. However, we show that a somewhat hidden symmetry of the FA model means that the xed point governing the scaling is G aussian above two dimensions, and identical to that of annihilation-di usion below two dimensions. Hence the DP xed point is not relevant to the FA model.

We determ ine the critical properties of the FA m odel by m eans of an exact m apping to a m odel of di using defects that appear in pairs from the vacuum, and annihilate in pairs: we refer to this as the AA (appear and annihilate) m odel. The m apping holds in all dimensions and at all temperatures. In one dimension the AA m odel is a (classical) Ising chain with particular single spin dynam ics; above one dimension it is more familiar as the reaction-di usion system A + A \$ 0. The critical properties of the AA m odel were derived by C andy and T auber [9]; by using our m apping we can then apply this derivation to the FA m odel. The m apping also allows us to identify an (exact) duality sym m etry of the FA m odel, which it inherits from the parity sym m etry of the AA m odel. T hese sym m etries are m ost sim ply expressed in terms of the m aster operators for the stochastic processes, which can also be interpreted as H am iltonians for quantum spin m odels [10, 11, 12].

W e will show that the mapping from FA to AA models is a speci c case of a more general relationship between the reaction-di usion processes in which the reactions are A + A \$ 0 on the one hand and A + A \$ A on the other. (Note the presence of both forward and reverse processes in these reactions.) Our conclusion will be that these two systems are controlled by the same xed point, and that their critical exponents are therefore identical.

The form of the paper is as follows. We dene the FA and AA models in Section 1. Both are models of hard core particles, but have generalisations in which particles can share the same lattice site; we also dene these models (which we refer to as bosonic'). The mapping between the FA and AA models is determined by their symmetries: it has quite a rich geom etrical stucture, which we discuss in Section 2. In Section 2.2 it is shown that the sam emapping also connects them ore general reaction-di usion processes  $A + A \$  A and  $A + A \$  0. An analogous mapping also exists between the corresponding bosonic models (Section 3). In Section 4 we study the critical properties of the various models. We also verify the scaling in three dimensions, where the dimensions between our predictions and those of R ef. [4] are clearest, by numerical simulation. Finally, we sum marise our results in Section 5.

# 1. The m odels

## 1.1. Model de nitions

In this section we introduce several models that we will consider in the remainder of the paper. We de ne them in terms of microscopic dynamical rules, before outlining the methods by which we represent their master equations and correlation functions.

We begin with the one-spin facilitated Frederickson-Andersen model [1]. This is referred to simply as 'the' FA model in what follows; more general FA models with facilitation by several spins, which exhibit more cooperative behaviour [2], will not be covered here. We de ne the model in terms of N binary variables,  $n_i \ 2 \ f0;1g$ , on a hypercubic lattice in d dimensions. The Ham iltonian for the system is trivial:

We refer to a site with n = 1 either as an up-spin or as a 'defect'; sites with n = 0 are thought of as down spins or 'empty'. The spins can ip with M etropolis rates if and only if at least one of their neighbours is in the up state. That is, for nearest neighbours i and j, we have

Since we have detailed balance with respect to the H am iltonian E, the (dimensionless) rate c parametrises the temperature according to c = e, with = 1=T as usual. It also sets the equilibrium density

We have introduced the notation h  $_{F\dot{A},eq}$  for an equilibrium dynam ical average.

To avoid confusion, we note that there are other versions of the FA model in the literature. In the original model [1] as described here the rate for ipping a spin i is proportional to the number of its up-spin neighbours. An alternative de nition chooses the rate for ipping spin i to be independent of the number of neighbours in the up state, as long as there is at least one such neighbour [13]. We do not believe that this choice makes any di erence to the critical behaviour of the system, but our exact mappings apply only to the original model as de ned above.

We can also de ne a variant of the FA model in which the occupations  $n_i$  are not restricted to binary values, but may be any non-negative integers. We refer to this as the bosonic FA model, since the natural eld theory for describing it has bosonic elds. This model has transition rates

Here and throughout, parameters for the bosonic models are distinguished by tildes from those for the hard core ones. The bosonic model (4) obeys detailed balance with respect to the stationary state P (fn<sub>i</sub>g) =  $\int_{i}^{0} e^{e} e^{n_{i}} = n_{i}!$ , so the stationary state density is

The bosonic stationary state is again a G ibbs distribution with Ham iltonian E and temperature de ned by c = e. However, in contrast to the hard core case it includes an a priori phase space weight factor  $i_1 1=n_1!$ , as appropriate for boson statistics.

W e will establish a mapping between the FA model and another model of di using defects. In this model, defects appear in pairs out of the empty state, and annihilate in pairs into it; they also di use freely across the lattice. W e refer to this model as the AA model, since the defects appear and annihilate. Both the AA and FA models can be interpreted as reaction-di usion processes. The AA model has explicit di usion, combined with reversible annihilation  $A + A \$  0. (W e follow the standard nom enclature of reaction-di usion models here, with A referring to our single species of particles, i.e. defects.) The model is de ned for binary variables: for nearest neighbours i and j,

where we choose

This model also obeys detailed balance with respect to the trivial H am iltonian, E, at a tem perature parametrised by  $c^0$ . Note that, once a trivial overall scale for the rates has been removed, there are in principle two dimensionless rates, and the requirement of detailed balance with respect to E only xes one of these, namely the ratio of the rates for appearance and annihilation. For now, we do not let the di usion rate vary independently and instead tie to  $c^0$ . The mapping between the FA and AA models will then connect models with the same value of the single parameter c. The two-parameter generalisation of the AA model with an arbitrary di usion constant also has a mapping to a generalised FA model, as we discuss in Section 2.2. For notational convenience we study the above Standard'AA and FA models rst in what follows. M appings between reaction-di usion and kinetically constrained systems

Finally, there is also a bosonic variant of the AA model with rates

where we take  $e^0 = e=4$  and  $\sim = 2$ . The stationary state densities in the AA models are

Note that in the lim it of small c, the relation (7) between  $c^0$  and c becomes  $c^0 = c=4$ , and thus identical to the one for the bosonic models. More generally, the hard core and bosonic models should become e ectively equivalent at low densities where multiple occupany of sites is very unlikely. We will exploit this correspondence frequently.

# 1.2. Operator forms for the master operators

It is convenient to write stochastic averages for systems such as those de ned above in an operator form alism [14]. This is a standard technique, so we largely restrict this section to de nitions of the quantities that we will use later.

W hen considering the bosonic versions of the FA and AA models we use a bosonic algebra with creation and annihilation operators on each site:  $[a_i;a_j] = [a_i^y;a_j^y] = 0;$  $[a_i;a_j^y] = _{ij}$ . The state fn<sub>i</sub>g is then associated with the vector  $\begin{bmatrix} a_i^y \\ a_i^z \end{bmatrix}^{n_i}$  bi, where juis the vacuum state which has all sites empty; the set of all 2<sup>N</sup> state probabilities P (fn<sub>i</sub>g;t) is mapped to the vector j (t) i =  $\begin{bmatrix} p \\ fn_{ig}g \end{bmatrix}$  (fn<sub>i</sub>g;t) is mapped to the vector j (t) i =  $\begin{bmatrix} n_{ig}g \\ fn_{ig}g \end{bmatrix}$  (fn<sub>i</sub>g;t) is not be retrieved via P (fn<sub>i</sub>g;t) = h0j  $\begin{bmatrix} a_i^{n_i} = n_i \end{bmatrix}$  (t) i, and since they must sum to unity one has hej (t) i = 1 where

is a 'projection state' that implements the sum over all possible system con gurations. The master equation can then be written in operator form as  $\mathfrak{G}_t \mathfrak{j}$  (t)  $\mathfrak{i} = L \mathfrak{j}$  (t)  $\mathfrak{i}$ , where L is known as the Liouvillian or simply the master operator. The o-diagonal elements h0j  $_i(a_i^{n_i^0}=n_i^0!)L_i(a_i^{y})^{n_i}$  j0i of L give the rates for transitions from state fnig to fnig, while the diagonal elements follow from the requirement hej = 0. Since the master equation is linear, it can be solved form ally as  $\mathfrak{j}$  (t)  $\mathfrak{i} = e^{Lt} \mathfrak{j}$  (0)  $\mathfrak{i}$ . If we specify the initial state as fnig we can read o from this the probability of making a transition to state fnig in some time intervalt:

Expectation values over the stochastic dynam ics can also be expressed in a simple form; for example, the average of som e function  $f(fn_ig)$  at time t becomes

where  $\hat{n}_i = a_i^y a_i$  is particle number operator for site i. Sim ilar expressions can be written for correlations functions involving two or more times, as illustrated below.

The hard core models with their binary occupation variables  $n_i$  have similar relations but here the states are generated by operators  $s_i^+$  and  $s_i^ (s_i^{\ddagger})^{y}$  in a spin- $\frac{1}{2}$  algebra, with  $(s_i^{\ddagger})^2 = (s_i^{-})^2 = 0$  and  $s_i^{\ddagger} s_i^{-} + s_i^{-} s_i^{\ddagger} = 1$ . In principle one should write in this expression a direct product  $N_{j\in i}I_j$  with identity operators at all other sites, but for ease of presentation we drop this here and below, along with site subscripts i where these are clear from the context. Our ordering of the basis states, while the reverse of the usual convention for spins, facilitates com parisons with other work on reaction-di usion system s [12]. It also emphasises the analogy to the bosonic case, where the only natural ordering of the basis states is in order of increasing occupancy.

It remains to give the form s of the master operator L for our models. Their matrix elements are easily derived from the relevant transition rates as explained above. One nds:

where the sum s run over all nearest neighbour pairs. The operators  $L_{FA}$  and  $L_{AA}$  for the hard core models have been written in a suggestive form that emphasizes the connection with their bosonic counterparts  $\tilde{L}_{FA}$  and  $\tilde{L}_{AA}$ .

Before leaving this section, we note that the stationary states of our models have simple closed form s in the quantum form alism, viz.

The AA model has an identical relation with  $L_{FA}$  replaced by  $L_{AA}$  and c replaced by  $c^{0}$ , and for the bosonic models one merely has to substitute for the master operator, projection and stationary state vectors their bosonic equivalents.

# 2. Sym m etries and m appings for hard core particles

#### 2.1. Detailed balance, parity and duality symmetries

Having set up the operator form alism for dynamics, we now investigate some properties of the Master operators for these models. We rest consider the elects of detailed balance, which tells us that the operator Le  $\stackrel{\text{E}}{=}$  is Herm itian (or more specifically symmetric, since all matrix elements are real). Here  $\hat{\text{E}} = \stackrel{\text{P}}{=}_{i} \hat{n}_{i}$  is the (Herm itian) operator for the energy. Multiplying by  $e^{\hat{E}=2}$  from the left and right shows that also

is Herm itian. This is more useful than Le  $\stackrel{e^{\hat{r}}}{=} \sin \alpha e$  it is related to the Liouvillian L by a similarity transformation and so has the same eigenvalues. For the FA model we can write explicitly e  $\stackrel{e^{\hat{r}}=2}{=} \stackrel{Q}{=} h_i(c)$ , where  $h_i($ ) is the single site operator

The above similarity transformation to a Hermitian form of the Liouvillians is convenient since it makes manifest the symmetries and conserved quantites of the systems. The mapping between FA and AA models relies on the fact that the Hermitian operators  $H_{FA}$  and  $H_{AA}$  are related by the exact unitary (or, more speci cally, orthogonal) transformation




Figure 1. The geometrical structure of the mapping U and the symmetries of the FA and AA models, in terms of the Herm itian operators  ${\rm H}_{\rm AA}$  and  ${\rm H}_{\rm FA}$  . Points on the spin sphere represent states  $e^{i} = 2\cos(-2)$   $J'i + e^{i} = 2\sin(-2)$   $J'i + e^{i}$  and are the usualpolar and azim uthalangles. The black dots mark the position on the spin sphere of the zero eigenstates of the operators; these are  $i_{i}$  (# $i_{i}$  $c^{0}$  **j**'i<sub>i</sub>) for the AA model,  $i_{i}$  ( $\#i_{i} + {}^{p}c_{j}i_{i}$ ) and  $i_{i}\#i_{i}$  for the FA model. Since these states factorise over and sites i, the gure can be read not just schem atically as representing the entire N -spin system, but also literally as showing the spin spheres for a single site. The rotation U is about the y-axis of the spin sphere (which points into the paper): it maps H<sub>AA</sub> onto  $H_{FA}$ . The rotation  $\frac{1}{i}(2s_i^z)$  of radians about the z-axis m aps  $H_{AA}$  onto itself. Applying the mapping U gives the duality transformation W  $^{0} = U^{-1} (\overset{\Sigma}{}_{i} 2s^{z}_{i}) U$ , which is a rotation of radians about the dashed axis and m aps  $H_{FA}$  onto itself. In term s of the transform ations in the main text, W  $^{0}$  is simply the image W  $\,$  after mapping  $\rm L_{FA}$ onto  $H_{FA}$ : we show  $W^{-0}$  here since its geom etrical structure is simpler.

with  $s_i^y = (s_i^+ \quad s_i)=2$  (as usual. Equation (28) is the key relation from which most other results for the hard core models are derived; it is easy to verify by direct calculation. The operator U has a simple geometrical interpretation: it is just a rotation about the y-axis of the spin sphere, as illustrated in Figure 1 below.

From (28) we have directly a similarity transform between the corresponding master operators for the FA and AA models:

Various relations between correlation functions in the two models can now be established. In addition to (30) one uses the analogous property for application of  $v_i$  to the steady state vector on the right:

However, a direct generalisation to stationary state correlations involving more than one time di erence, or out-of-equilibrium quantities depending on more than one time, is not possible. This is because the transformation (33) of the number operator produces a non-diagonal operator which does not directly correspond to a physical observable. Only where the transformed operator is applied either to the projection state on the left, as in (34), or the steady state on the right, as in (35), can such a link be made; otherwise more complicated relations result [15].

The most useful aspect of the mapping (29) is that it will enable us to reveal symmetries of the FA model which are 'inherited' from symmetries of the AA model. Speci cally, it is clear from the dynamical rules of the AA model that the parity of the total number of particles in the system is conserved. M athem atically, we have that

where  $s_i^z = \hat{n}_i \quad \frac{1}{2} = \frac{1}{2} \quad \stackrel{1 \ 0}{_{0 \ 1}}$ . Geometrically, the operator  $\hat{Q}_i 2s_i^z \sin p \ln p$  produces a rotation of radians about the z-axis of the spin sphere.

Since the FA and AA m odels are related by a similarity transform ation, there must be a symmetry of the FA m odel that is equivalent to the AA parity symmetry. Applying the transformation (29) to equation (38), we arrive at

Note that W  $^1$  = W , as expected for a symmetry deriving from the parity symmetry in the AA model. To understand more closely the e ect of  ${\tt W}$  note  $\mathop{\rm rst}\nolimits$  that, in the AA case, the rotation  $\sum_{i} 2s_{i}^{z}$  maps the steady state vector  $jc^{0}i / \sum_{i} (j)i_{i} + c^{0}jli_{i}$  to djli<sub>i</sub>) where the probabilities of all states fn<sub>i</sub>g containing an odd the vector <sub>i</sub> (j)i<sub>i</sub> number of particles acquire a negative sign. The sum and di erence of these two states gives the physical steady states for initial conditions containing an even and odd num ber of particles, respectively. In the FA case, W also m aps two steady states onto each other:  $(\hat{D}i_i + cjli_i) / \hat{D}i = \hat{D}i_i$ . The sym metry thus links the conventional' steady state, which is reached for any nonzero initial number of particles, to the vacuum, i.e. the empty state; the latter is trivially a steady state since the kinetic constraints of the FA model forbid any transitions into or out of it. So while the original symmetry in the AA model connects steady states that are basically equivalent, with associated dom ains of attraction' of equal size, the inherited symmetry of the FA model relates two very di erent steady states, with one having a dom ain of attraction containing all con gurations except for the empty one.

The above relations between the FA and AA models, and their corresponding symmetries, can also be understood in terms of the associated Hermitian operators. They then have simple geometric interpretations, as shown in Figure 1.

In the following we will continue to refer to 'the' steady state of the FA model as the one with nonzero particle density. The symmetry (39) then allows us to relate the dynamics in this steady state to that in near empty con gurations. This implies relations between the associated correlation functions. Proceeding as in (32), one has for example

Here we have used that application of W to the steady state vector jci on the right gives a multiple of the vacuum state. The same is easily checked for the operation of W  $^1$  on the projection state bejon the left; the associated proportionality factors cancel because of overall norm alisation. The transform ation of the num ber operators is

Up to the overall num erical factor  $c=(1+c)^2$ , the right hand side is of same form as (14): it is the probability of a transition between particular initial and nal states, containing a single particle on sites j and i respectively. This relation generalises straightforwardly to correlation functions involving m ore than two spatial points: we have that

where the right hand side is again of the form (14) and gives the transition probability between an initial state with m particles and a nal state with 1 particles. W hile this relation m ay not be familiar, it is closely related to the duality symmetry of the DP xed point [8]. The latter is more usually expressed in terms of the dynamical action: see Section 4.

In sum m ary, we see that the transform ation V m aps the parity sym m etry of the AA m odel onto an (exact) duality sym m etry of the FA m odel. The m apping thus exposes a hidden sym m etry which would not easily be recognised by looking at the FA m odel alone.

#### 2.2. M odels with additional di usive processes

The discussion so far has considered the FA and AA models, both de ned in terms of a single parameter c. We now generalise our arguments to models with extra di usive processes. This will show that our mapping applies more broadly between reaction-di usion models with, respectively, reversible coagulation (i.e. coagulation and branching) and reversible annihilation (i.e. annihilation and appearance) processes. The generalised models will also allow us to elucidate the connection between our mapping and related earlier studies.

Consider supplementing the FA model by an additional process

In particle language this is di usion of a particle A to a vacant site, while the original processes (2) are A ! A + A (branching) and A + A ! A (coagulation). This generalised FA m odel can therefore also be viewed as the reaction-di usion m odel A + A \$ A.

where  $s_i^x = (s^+ + s)=2$  and, as before,  $s_i^y = (s_i^+ s_i)=2$  and  $s_i^z = \hat{n}_i$   $1=2 = (s_i^+ s_i s_i^+)=2$ . We recognise in (44) the Heisenberg model: see Ref. [10] for a sum mary of the links between the properties of stochastic systems and their corresponding quantum spin Ham iltonians.

For our purposes it is in portant to recognise that  $L_{di}$  has nonzero m atrix elements only between states containing equal numbers of particles; it is therefore invariant under transform ation with  $h_i(x)$  { so that the associated H erm it is operator is identical to  $L_{di}$  { and under the parity transform ation  $i_2 2s_i^2$ . Due to its H eisenberg form,  $L_{di}$ is also left invariant by any global spin rotation, and in particular by U. Combining these properties, invariance under V and W then also follow. Hence the structure of the preceding subsection is all preserved for the generalised m odels: the generalised FA m odel with di usion rate D, branching rate c and coagulation rate 1 m aps via V onto a generalised AA m odel with rates

where and  $c^0$  depend only on c, as de ned in (7). We note that all generalised FA m odels have conjugate AA m odels, but that AA m odels in which the rate for the di usive process is less than  $c^0$  cannot be m apped to FA m odels with positive rates.

At this point, we make contact with two earlier studies. K rebs et al. [11] studied the above generalised models at zero tem perature but with nonzero D. Consistent with this, their mapping between the models is the limit of our mapping V for  $c_{r}c^{0}$ ! 0.

Henkel et al. [12] implicitly had the full mapping V, but considered it only in the context of one-dimensional systems that are solvable by free fermions. The AA model then reduces to the G lauber-Ising chain (their model IV) and the relevant generalised FA model has D = 1 (their model II). Henkel et al. did not comment that the mapping applies to all dimensions and to arbitrary values of the di usion constant.


We illustrate the relation between our work and Refs. [11] and [12] in Figure 2. We parametrise the FA (A + A \$ A) models by the ratio of branching and coagulation rates c and the ratio of di usion and coagulation rates D. In the AA case, appropriate dimensionless parameters are the ratio of appearance and annihilation rates  $c^{2}$  and the ratio of di usion and annihilation rates D<sup>0</sup> =  $c^{0}$  + D = . All generalised FA models map onto generalised AA models with  $c^{0} < 1$  and D<sup>0</sup>  $c^{0}$ . The standard FA model is D = 0, giving D<sup>0</sup> =  $c^{0}$ , while the pure coagulation/annihilation models of Ref. [11] correspond to  $c = c^{0} = 0$ . The free ferm ion condition of Ref. [12], nally, is the line D = 1 which maps onto the G lauber-Ising line D<sup>0</sup> =  $(1 + c^{2})=2$ . (The G lauber-Ising chain has di usion rate 1=2 and annihilation rate  $(1 + c^{2})^{1}$ , giving the stated ratio.)

To see the explicit link between our mapping and that of Ref. [12], one notes that their free-ferm ion quantum H am iltonian is directly in the form of the Liouvillian  $L_{AA}$  for the AA model if its parameters are chosen as  $D_1 = D_2 = 1$ ,  $h_1 = h_2 = (1 \quad c^p) = (1 + c^p)$ ,  $_1 = 2 = (1 + c^p)$  and  $_2 = _1c^p$ . Henkel et al. [12] then show that the FA Liouvillian can be obtained by the sim ilarity transform ation  $L_{FA} = B L_{AA} B^{-1}$ , with  $B = _i b_i$  and

Inserting these values one has  $b_i / v_i^{-1}$  (with proportionality factor  $[(1 + c)e^{4}]^{1-4}$ ) as expected by comparison with our Equation (29). We note that Henkel et al. associate particles with down spins rather than up spins as here. However, because they also use the opposite (i.e., conventional) ordering of the two local basis vectors j''i and j#i, the matrix representations of all operators are the same.

To sum marise, we showed in this section that the FA and AA models have quite a rich geometric structure underlying their symmetries and the relations between them. These relations further extend to a general mapping between reaction-di usion models with coagulation and branching ( $A + A \$  A) and annihilation and appearance ( $A + A \$  0). We expect the critical behaviour (at small particle densities, i.e. low temperature) of these models to be determined by their symmetry properties. However, the hard core constraint that allows only one particle per site makes an explicit renormalisation group analysis of such critical properties awkward. We therefore show next that the bosonic models, where this constraint is removed, have analogous symmetries and mappings between coagulation and annihilation models.



F igure 2. Sketch of the mapping between the two-parameter families of generalised FA (A + A \$ A) and AA (A + A \$ 0) models. Generalised FA models (with nonnegative c) map onto generalised AA models with 0  $c^0 < 1$  and  $c^0 D^0$ . The standard FA models with D = 0 map to models on the standard AA line  $c^0 = D^0$ . The lines c = 0 and  $c^0 = 0$  correspond to di usion-limited pair annihilation (D LPA) and di usion-limited pair coagulation (D LPC) respectively [11]. In one dimension the models are solvable by free fermions on the lines marked `'. These lines are given by D = 1 and D<sup>0</sup> = (1 + c^{D})=2, and the mapping transforms them into each other [12]. ### 3. Bosonic models

The bosonic models introduced in Section 1 have similar properties to those discussed for hard core (spin) models in the previous section. The Liouvillians again have H erm it ian analogues de ned by  $H = e^{\hat{E}=2}Le^{-\hat{E}=2}$ . The energy operator is now  $\hat{E} = \int_{i}^{P} a_{i}^{y}a_{i}$ , so if we de ne the bosonic version of  $h_{i}(x)$  as

and  $H_{AA}$  is obtained similarly from (21). This is analogous to the hard core case, but easier to see for the bosonic models since the transformation by  $h_i(x)$  simply rescales particle creation and annihilation operators, according to the rest of the relations

One expects that at low particle densities  $n_{eq} = c = (1 + c)$  c the constraint of at most single occupancy in the hard core FA model will be irrelevant, so that it becomes equivalent to the corresponding bosonic model with c = c; the same argument applies to the hard core and bosonic AA models. This physical reasoning [4] can be further supported by a large-S expansion of the hard core models (Appendix A).

W e now discuss the mappings between the bosonic models and their symmetries. The main conclusion is that the structure of the hard core models is preserved in their bosonic counterparts. The basic mapping between the two bosonic Hermitian operators is

This is easy to verify, bearing in m ind that  $e^0 = e^{-4}$  and  $\sim = p^2$ : from (51), the transformation by U shifts all  $a_i$  and  $a_i^y$  in  $H_{AA}$  by  $e^{-2} = e^{-2}$ . If one uses a basis of bosonic coherent states then the mapping is a translation in the complex plane that parametrises these states. This is the analogue of the rotation of the spin sphere generated by  $u_i$ , consistent with the intuition (Appendix A) that the bosonic models e ectively `atten' the spin sphere onto the complex plane of coherent states.

Combining  $\alpha_i$  and  $\tilde{h}_i$  we have a relation between the Liouvillians,

Here the  $i_r$  must label sites that are all distinct from each other, as do the  $j_r$ , though the two sets may contain sites in common with each other. The prefactor on the right agrees with the low density limit of the one in (37), supporting our intuition about the equivalence of hard core and bosonic models in this regime.

The duality symmetry of the bosonic FA model results in

This again relates steady state correlations to transition probabilities between specic initial and nal states; the prefactor approaches the one in (42) for c = c ! 0.

Following our discussion in Section 22, one expects that the structure of the bosonic mapping will be preserved if an extra di usive process is added to both models. This is easily veried. It is also immediate to show that the mapping is unchanged if we add on-site branching and coagulation processes, as long as we retain detailed balance for the whole model. These processes then map to on-site appearance and annihilation in the generalised AA model. (Recall that our standard bosonic FA and AA models have processes that always act on pairs of sites.)

The similarities between Eqs (47-61) and (25-39) show clearly that the bosonic models have the same structure as those with hard core exclusion. In the next section we consider the critical properties of these bosonic models; from our arguments the critical properties of the hard core models should be identical, and we check this by comparing our predictions to num erical simulation.

# 4. Critical properties

W e have shown that the FA and AA models are linked by an exact mapping. Now, both models have scaling behaviour at small defect densities that is characterised by the xed point of a renormalisation group (RG) ow. In Section 4.1 we use the mapping of the previous section together with known results to show that the FA model has upper critical dimension  $d_c = 2$ ; this conclusion also applies to the generalised FA model, i.e. the reaction-di usion modelA + A \$ A. The critical scaling is then characterised by the well-known mean-eld (Gaussian) exponents in d > 2; we also derive exact exponents

below  $d_c$  that coincide with known results in one dimension. Our results di er from earlier studies in two and three dimensions: in Section 4.2 we therefore use simulations to con rm the predicted mean-eld scaling in d = 3. In Section 4.3 we derive some analytical results for the scaling limit of correlation functions in d > 2. Finally we discuss in Section 4.4 the scaling of the persistence function since data for this were used in Ref. [4] to support the argument that non-mean-eld uctuation corrections are signi cant in three dimensions.

# 4.1. Renorm alisation group analysis

The critical properties of the bosonic AA model were established by Cardy and Tauber [9]: in their notation the model corresponds to k = 2, > 0, m = 0. We write the generating functional for dynam ical correlations in the stationary state as a path integral on the lattice

(we continue to ignore boundary terms when integrating by parts over spatial degrees of freedom). Physically, we recognise the statem in (65) as a distive propagator

for the excitations and the second term as local appearance and annihilation processes. The term s contained in  $L_{AA;1}$  will be irrelevant in the RG sense since their only e ect is to enforce the fact that appearance and annihilation of excitations take place on pairs of adjacent sites and not on single sites. (In term s of the RG calculation these terms modify the spatial structure of terms in the action that are already present, but they are not responsible for new terms, or for any singular behaviour.) We therefore neglect  $L_{AA;1}$  and arrive at the action considered in Ref. [9] for the case (k = 2, > 0, m = 0) described above.

W enow follow Ref. [9] in renorm alising this dynam icalaction. The parity symmetry of the bosonic AA model is

and must not be obscured by making any shift of the elds [9]. The symmetry is clearly preserved under the RG ow so only terms in the action with this symmetry need be considered. Power counting then shows that the upper critical dimension will be two. Above d = 2, therefore, the critical exponents have their mean-eld values

Here we have de ned by the scaling of the steady-state density  $\lim_{t \le 1} \ln_i(t)i^0$ , and by the correlation length scaling <sup>0</sup>. (The notation a bm eans that a is proportional to b in the scaling limit, i.e. close to the critical point at <sup>0</sup> = 0.) Note that in Ref. [9] these exponents were de ned in terms of the control parameter <sup>(2)</sup> and thus di er by factors of two from ours. Our convention is more appropriate for comparison with the FA model, where the steady-state particle density is the natural control parameter. We also note that the free propagator and hence the bare di usion constant D<sub>0</sub> (the constant multiplying the term <sup>y</sup>r<sup>2</sup> in the action) depend explicitly on <sup>0</sup>. In the usual RG analysis D<sub>0</sub> is set to unity, so we de ne the exponent z via the scaling of typical relaxation timescales measured in units of D<sub>0</sub><sup>1</sup>,

This is consistent with the exact scaling in one dimension and also with the naive scaling estimate  $c^{2-d}$  for the FA model [2]. In Ref. [9], and were given only to rst order in a bop expansion: in our notation the results were

for d < 2. Here y = 2d + 0 (2  $d^2$  is the scaling dimension of the coupling <sup>(2)</sup>. (The relation = d comes from the scaling relation = z = where is the exponent for the decay of the density after a quench to criticality, which equals d=2 [9].) However, we can determ ine y exactly since detailed balance xes the steady-state density to the value  $e^0 / - 0$ , so that = 1. Thus we have the exact result = 1=d, or

and the exponents (71) are exact. Equation (73) can be con m ed by sum ming the geom etric series of loop corrections that contribute to the scaling dimension y .

Proceeding to the bosonic FA m odel, the (unshifted) dynam ical action is [4]

where / c is the steady state density and  $_0$  is the bare coupling (with dimension  $[tim e]^1$  [length]<sup>d</sup>);  $l_0$  is the m icroscopic lengthscale as before. The property of detailed balance manifests itself as an invariance of the action,

This of course has an analogue in our earlier operator notation, where we recognised detailed balance as the fact that  $\Gamma_{FA_p} \exp(\hat{E})$  is Hermitian. Since  $\exp(\hat{E}) = e^{-i\frac{a_1^Ya_1}{2}}$ , this implies  $\exp(\Gamma_{FA}t) = e^{-i\frac{a_1^Ya_1}{2}}\exp(\Gamma_{FA}t)e^{-i\frac{a_1^Ya_1}{2}}$  which is the promised analogue of (75) [recall (50) and note that  $f^{Y}(a;a^{Y}) = f(a^{Y};a)$ ].

The duality symmetry as it is normally stated for systems with a DP  $\times$  xed point (but not necessarily with detailed balance) is [8]

Like detailed balance this involves time reversal; in term softhe Liouvillian it relates  $\Gamma_{FA}$  to its conjugate  $\Gamma_{FA}^{Y}$ . To arrive at the duality mapping for the FA model, we combine the preceding two symmetries of the action to obtain

In terms of operators, this symmetry now relates  $\Gamma_{FA}$  directly to itself, without any conjugation. A comparison with (59) reveals that it corresponds directly to our earlier transformation W from (57).

Both detailed balance and duality symmetries are preserved under renorm alisation if all terms in the action are retained. It is then crucial to follow Ref. [9] in choosing a basis for the RG equations that rejects this fact. The solution is to make the transformation de ned by  $\nabla$  in the previous section and to write as in (55)

This is identical in form to  $S_{AA}$  as given in Equation (64), and so the FA model renormalises exactly as the AA model, consistent with their correlation functions

obeying the simple relation (60). The signi cance of the basis used is that the resulting RG equations respect both the detailed balance and duality symmetries of the FA model. If one makes any transform other than (78), using for example the standard shift  $\overline{\phantom{x}} = \frac{y}{1}$  as in Ref. [4], then these symmetries are obscured and one is led to the conclusion that the FA model is controlled by the DP xed point between two and four dimensions.

# 4.2. Simulations showing Gaussian scaling in d = 3

We now con m our above exact predictions of mean-eld (G aussian) critical exponents in  $d > d_c = 2$  by equilibrium simulations of the FA model in d = 3. We explain how the duality relation (41) together with an appropriately adapted continuous time M onte C arbo (M C) algorithm allow us to probe citical properties well beyond the regime accessed in previous work. A comparison of our data with analytical scaling forms is also given.

A convenient observable for extracting the relaxation time scaling is the norm alised two-point susceptibility  $_{2}(t) = h E(t) E(0)i=h E(0)^{2}i$  where E = E hE i denotes the uctuation of the energy away from its equilbrium value. Since we only consider the stationary state dynamics of the FA model in this section, we drop the subscript FA, eq' on the averages. Substituting the simple form (1) of the energy function and using translational invariance,  $_{2}(t)$  can be recast in the form

with j an arbitrary reference site and  $n_{eq} = hn_i i$ , Equation (3). The second equality in (80) follows from the duality relation (41). It shows that the stationary state average de ning \_2 (t) has a dual counterpart in the dynam ics near the empty state. This is a trem endously useful fact: instead of having to simulate an equilibrium system containing hundreds or even thousands of defects we simply initialise with a single defect at site j. A coording to (80), \_2 (t) is then given by the probability that this state evolves under FA dynam ics into one containing again a single defect (at an arbitrary site i), that is any con guration with E = 1.

To measure with similar e ciency a dynamically growing lengthscale in the FA model one can consider the mean squared displacement associated with two-point correlations,

Here x (i) denotes the position vector of site i, and j is again an arbitrary reference site; we set the lattice constant to unity so that x (i) 2 Z<sup>d</sup>. Note that due to normalisation this lengthscale can exceed the equilibrium dynamical correlation length, which would conventionally be extracted from the maximum of  $_2$  (t) $r^2$  (t). As in (80) we apply the duality (41) to map the stationary state average in (81) onto h0 js<sub>i</sub> e<sup>L</sup> FA<sup>t</sup>s<sup>+</sup><sub>i</sub> JDi,

and perform simulations of the dual problem rather than the time-consuming direct equilibrium simulations.

The duality mapping increases the e ciency of an MC algorithm to such an extent that the limiting constraint in practical simulations is system size rather than computational speed. Although we initialise with just a single defect, its trajectory under FA dynamics explores the simulation box and must not be biased by nite size e ects. For conventional, lattice based algorithm s the required system size  $N = L^{d}$ can then quickly exhaust the available memory of standard computers (say 1Gb). To overcom e this problem we used a coordinate based variant of MC. Instead of storing the occupation numbers ni of N lattice sites i we keep track of the actual coordinates xa of each defect a in the Virtual' simulation box f1;2;:::;Lq<sup>d</sup>. The memory e ciency of this approach against a lattice based code is 0 (M = N) if there are M defects. Hence it is useful for simulations of problem s with low defect concentration, for instance, direct equilibrium simulations at low neg or the dual dynamics near the empty state. In analogy to lattice based codes [16, 17] one can set up a Yeverse lookup scheme 'where continuous time MC steps have 0 (1) computational complexity. This is accomplished by storing the list of defect coordinates  $fx_a g_{a=1}^M$  in a hash table. So the problem of whether any site x (i) in the virtual simulation box is occupied by a defect can be decided in 0 (1) time, just as for a lattice based code. This coordinate based continuous-time MC approach is m em ory e cient while yielding com putational speeds com parable to a lattice based code. This allows us to exploit fully the simplications a orded by (80) and (81).


Simulation results for branching rates  $c = 10^3$ ;  $10^4$ ;  $10^5$  and  $10^6$  are shown in F igures 3 and 4 below. We have used a form ally in nite virtual simulation box so that via (80) and (81) we are probing the equilibrium dynamics of the FA model in the therm odynam ic lim it. In other words, our results are guaranteed to be free of nite size e ects and can be compared directly to the scaling predictions (69) and (70). For this comparison we recall that at sm all defect densities the bosonic and hard core FA models have similar behaviour, so that /c c is proportional to c. Since we know that = 1 exactly, it is su cient to show that z = 2 and z = 1 to demonstrate G aussian

scaling. We rst verify the dynamical critical exponent z = 2 which implies for the growing length scale r (t),

For all values of c considered the data in F igure 3 show a linear dependence of  $r^2$  (t) on ct, over up to eight decades in ct; in fact our data are fully consistent with  $r^2$  (t) = 2dD<sub>0</sub>t where d = 3 and D<sub>0</sub> = c=2. This value of D<sub>0</sub> con m s the expected scaling D<sub>0</sub> c; we return below to a derivation of the prefactor in D<sub>0</sub> = c=2. It should be emphasised that the kind of spatio-tem poral scaling used here determ ines the dynam ical exponent directly from its de nition; measuring the ratio between exponents for the correlation length and relaxation time is a valid procedure only if the di usion constant is slow ly varying at criticality.




Figure 4. Simulation data obtained from the dual representation (80) of the twopoint susceptibility  $_2$  (t) and with the same parameters as in Figure 3. The inset shows  $_2$  (t) versus t. At each c data are collected up to times  $t = 0.5 = c^2$ , that is up to  $t = 0.5 \quad 10^{12}$  for the lowest c. The main plot demonstrates data collapse with the G aussian scaling of the relaxation time  $c^2$ . The full line represents our analytical prediction for the c! 0 scaling of  $_2$  (t), Equation (84); there are no t parameters. Error bars are largest for the data at  $c = 10^{-6}$ ; even there we estim ate a relative error below 1%.

Consider next the simulation data for  $_2$  (t) shown in the inset of Figure 4. Scaling

arguments predict that  $_2$  (t) should be a universal function of t= , with the relaxation time. From (70) we expect for Gaussian exponents

Collapse of data for  $_{2}$  (t) under this prescription is shown in Figure 4. W hile there are still noticeable pre-asymptotic contributions at  $c = 10^{3}$  the data for  $c = 10^{4}$  and in particular  $c = 10^{5}$ ;  $10^{6}$  seem to have converged to the nal scaling form of  $_{2}$  (t) to within our numerical accuracy. To con m the critical scaling in more detail we next give a theoretical analysis that predicts the precise shape of  $_{2}$  (t) in the critical limit c ! 0.

# 4.3. Scaling analysis for two-point functions in d > 2

We now show that the c! 0 lim it of the equilibrium two-point susceptibility for FA models in d > 2 dimensions is

where  $_{d} = d \mathbb{P}_{d}(2;0;:::;0) + 2 (d 1) \mathbb{P}_{d}(1;1;0;:::;0)]$ , and  $\mathbb{P}_{d}(x)$  is the probability that a pair of random walkers with initial separation x will never meet: this function is considered in Appendix B. Equation (84) is consistent in particular with the scaling expectation that  $_{2}(t)$  should be a function of t= with  $\hat{c}$ . In d=3 and substituting the survival probabilities (B.6) and (B.7) one has  $_{3}$  5:80961. The exact c ! 0 scaling form (84) for this dimensionality is shown in Figure 4 and is in perfect agreement with our simulation data. The remainder of this subsection is devoted to the derivation of (84); we return to more general discussion in Section 4.4.

A system atic analysis of the dynam ics in the critical lim it c ! 0 requires a careful distinction between the tim escales involved. We will need unscaled time t as well as the scaled time variables x = ct and  $y = c^2t$  whose 0 (1) increments correspond to time intervals t of 0 ( $c^1$ ) and 0 ( $c^2$ ), respectively. For time intervals t = 0 (1) the lim it c ! 0 is clear: the rate c for branching processes  $1_j0_k$  !  $1_j1_k$ , where k is a nearest neighbour (NN) of j, then vanishes. Only the coagulation processes  $1_j1_k$  !  $1_j0_k$  or  $1_j1_k$  !  $0_j1_k$  can then take place, each occuring with rate unity, and the lifetime of excited states like  $1_j1_k$  that contain two (or more) NN defects is 0 (1).

The dynamics over intervals with x = 0 (1), i.e. t = x = c = 0 (c), is rather di erent. Processes involving branching events are then possible. However, after such an initial event the rate for reverting to the original state is 0 (1), while the rate for an additional branching event is 0 (c). This implies that the probability for the latter to occur ist is 0 (c). Since the rate for the ist branching event is already 0 (c), the elective rate for a sequence of two branching events is then 0 ( $c^2$ ). On our O (c<sup>1</sup>) tim escales this type of process can be neglected, and we need only concern ourselves with processes involving a single branching event. One possible process is then  $1_j 0_k ! 1_j 1_k ! 0_j 1_k$ , with j; k NNs. Its rate is  $\frac{1}{2}$ , c being the branching rate and  $\frac{1}{2}$  the probability for the particular, subsequent coagulation (rather than  $1_j 1_k ! 1_j 0_k$ , which would take us back to the initial state). The probability for this process to occur during the interval t is therefore  $\frac{1}{2}$  c t =  $\frac{1}{2}$  x. Note that as the lifetime of excited states is 0 (1) as argued above, we have vanishing probability 0 (c) of nding the system in an excited state  $1_{i}1_{k}$  at any given m on ent in time. Therefore, in the limit c! 0, the interm ediate excited step of our process becom es invisible and we have e ective di usion  $1_{j}0_{k}$  !  $0_{j}1_{k}$  with probability  $\frac{1}{2}$  x.

The second type of process allowed on the O (c<sup>1</sup>) timescale is the excitation of a defect at a site that has more than one NN defect, followed by a cascade of coagulation events leading to another con guration where all defects are isolated. Consider rst the case where the new defect, at site k (say), has two NN defects at sites j and l, so that our process leads from  $1_j 1_k 1_1$  to  $1_j 0_k 0_1$  or  $0_j 1_k 0_1$  or  $0_j 0_k 1_1$ . The corresponding probabilities are  $\frac{1}{4} \times \frac{1}{2} \times \frac{1}{4} \times$ 

To sum marise the dynam ics on the O (c<sup>1</sup>) timescale, we have division  $1_j0_k ! 0_j1_k$ with rate  $\frac{1}{2}$  per interval of rescaled time x. The processes  $1_j0_k1_l ! 1_j1_k1_l ! :::$ discussed above can then be represented consistently as produced by a division event followed by (in the limit c ! 0) instantaneous coagulation. For instance,  $1_j0_k1_l ! 1_j0_k0_l$ amounts to division  $0_k1_l ! 1_k0_l$  (with rate  $\frac{1}{2}$ ) followed by coagulation  $1_j1_k ! 1_j0_k$ (which has probability  $\frac{1}{2}$  of occurring before  $1_j1_k ! 0_j1_k$ ), giving the overall rate  $\frac{1}{2} = \frac{1}{4}$  obtained above. One can check that the same decomposition into division and instantaneous coagulation also holds for processes involving an initial excitation at a site with more than two NN defects.

Our discussion so far leads to the following conclusions. Clearly any single-defect state  $s_j^+$  j)i is blocked on the O (1) timescale. Therefore \_2(t) = 1 and r<sup>2</sup>(t) = 0 in equilibrium and for O (1) times, according to the dual representations (80) and (81). But on the O (c<sup>1</sup>) timescale the defect diluses away from its starting site j. This still predicts \_2(t) = 1 since dilusion conserves the number of defects E = 1. The quantity r<sup>2</sup>(t) in dual representation, on the other hand, now measures them can squared

displacement of a single, di using defect which is given by  $r^2$  (t) = 2dD<sub>0</sub>t. Our result that the di usion rate is  $\frac{1}{2}$  in time units of x = ct tells us that D<sub>0</sub> = c=2. This is the exact low-density scaling of D<sub>0</sub> and precisely what we found in our simulations; com pare Figure 3.

Let us now turn to dynamics on the O ( $c^2$ ) timescale, corresponding to  $y = c^2 t =$ 0 (1). During such a time interval there is now a nonzero probability for the occurence of processes involving two successive branching events, where one defect is rst excited next to an existing one and another defect is then created on a NN site to either of the other two. In order to determ ine the fate of this defect triple  $1_1 1_k 1_1$  we consider its evolution on the faster 0  $(c^1)$  timescale. This argument is analogous to the one above, where a defect pair is created on the  $0 (c^1)$  timescale but we have to bok at 0 (1)tim es to determ ine its relaxation. In further analogy we note that an arbitrarily sm all but nonzero increment y on the  $0 (c^2)$  timescale corresponds to an in nite increment  $x = y = c \circ f O(c^{1})$  time as  $c ! O \cdot T$  he following possibilities then arise: because NN defects coagulate instantaneously on the O (c<sup>1</sup>) timescale there is a probability of  $\frac{1}{2}$  for im m ediate relaxation  $1_j 1_k 1_l ! 1_m$  where m = j or k or l. Subsequently the defect  $1_m$ diuses with diusion rate  $\frac{1}{2}$  for a time x ! 1, moving arbitrarily far from its initial position. With the remaining probability of  $\frac{1}{2}$  an instantaneous relaxation of the middle defect takes place,  $1_{j}1_{k}1_{l}$ !  $1_{j}0_{k}1_{l}$ . The defects  $1_{j}$  and  $1_{l}$  can now dive independently for an e extively in nite interval x of 0 ( $c^1$ )-time; if they do not coagulate in the process, their distance grows without bound and we can say the original defect has branched irreversibly. We derive in Appendix B the 'survival probability'  $P_d(x)$  for this outcom e; here x = x (1) x (j) is the initial separation of the di using defects.

We can now assemble the probability t that during a time interval  $t = y^2$ ca single defect interversibly branches into two defects. Starting from a single defect there is a rate c for branching on a given NN site. Since (on a hypercubic lattice in d dimensions) there are 2d such states, the overall branching rate is 2dc. The probability for a second branching event on a neighbouring site to take place before either of the two possible relaxations back to a single defect is c=2. A cluster of two NN defects has 4d 2 NN sites, two of which lead to a linear and 4 (d 1) to an angled defect triple  $l_j l_k l_1$ . A ltogether the rate for creation of a linear triple is  $2dc^2$  while it is  $4d(d 1)c^2$  for an angled one. In either case, we need to multiply by the probability  $\frac{1}{2}$  of the m iddle defect k relaxing rst, leading to a pair of next nearest neighbour (NNN) defects. In term s of the eventual

survival probabilities P<sub>d</sub> (x) of this pair we thus obtain

This is a nontrivial result. To clarify its intuitive meaning, note that we are considering initially a single defect  $s_j^+$  jDi. The following trajectories are then possible during a time interval t = x = c = y = c on the O ( $c^2$ ) scale: (i) no branching occurs. The defect di uses with rate  $\frac{1}{2}$  for a time x = y = c! 1 in the c! 0 limit. The defect at the beginning and end of the interval t are then completely decorrelated. (ii) W ith probability d(2d 1) $c^2$  t = d(2d 1) y the defect branches into a pair of NNN defects.

Again, on the O ( $c^1$ ) timescale this pair has an in nite time x available to diuse through the system . (ii.a) There is a nite probability that the pair coaqulates during this di usive motion. In this case we have within the time interval ta bubble' in the space-time diagram of the defect trajectories [3], where the initial defect separates into two but these re-coaqulate shortly afterwards. The tem poral extent of this bubble, i.e. the time during which the two defects exist, is  $0 (c^1)$ . The probability of detecting such a bubble on the O ( $c^2$ ) time scale is therefore vanishingly small in the limit c! O. This is in analogy to excited states becoming invisible on the  $0 (c^1)$  timescale. Hence the trajectories (i) and (ii.a) cannot be distinguished on the  $0 (c^2)$  timescale. (ii.b) The defects may dive forever (x ! 1) without encountering each other; this means that the trajectory branches irreversibly on the 0 ( $c^2$ ) time scale. Due to the existence of bubbles the probability for this event, t, is renormalised relative to the bare' probability  $d(2d = 1)\hat{c}$  t for an initial branching event. Each defect in the resulting pair has travelled an in nite distance during t and so completely decorrelates from the initial defect.

We can now make predictions for the dynamics on the O ( $c^2$ ) timescale. First we note that in d = 1;2 the survival probabilities  $P_d(x)$  vanish, see Appendix B. Hence = 0 and defect trajectories do not branch on the O ( $c^2$ ) timescale. However, in d > 2 the  $P_d(x)$  are nite, and hence so is  $_d = = c^2$ . Now  $_2$  (t) is just the probability that the number of defects has not increased during the time intervalt, which means that no irreversible branching processes have taken place. The rate for occurrence of the latter being , it follows that  $_2$  (t) = exp( t) = exp(  $_dc^2$ t). This completes our derivation of Equation (84).

O ne can go further and extract the probability  $p_t(E)$  of having E 1 at time t. Since each irreversible branching event produces in nitely separated defects, these will then continue to branch independently in the same way. Thus, if E defects are present, the rate for generating an additional one by irreversible branching is E . This gives the m aster equation

This can be solved straightforwardly, for example by Z -transform, to give

The number of defects thus has an exponential distribution; the most likely outcome is E = 1 at any time and has probability  $p_t(1) = {}_2(t) = e^{t}$ . The average number of defects, on the other hand, grows exponentially as hE  $i_t = e^{t-t}$ . We have checked in our simulations the full form of  $p_t(E)$  (data not shown), and found excellent agreement. The exponential increase in the number of defects limits the time range that can be conveniently simulated; the lowest value of  ${}_2(t)$  that can be measured reliably is of the order of the inverse of the maximum number of defects one is prepared to track.

### 4.4. Persistence functions and discussion of earlier data

In order to characterise a dynamical xed point in the presence of a time-reversal symmetry, we must determ ine three independent exponents. One such set is (z;z;). Our simulations as well as the scaling analysis have con meed the RG prediction that z = 2 and z = 1; further, z = 1 is known rigorously from detailed balance. Consequently the scaling of the FA model in d = 3 is Gaussian.

In Ref. [4], the authors found that the directed percolation (DP) xed point is relevant to the FA model in three dimensions and at low temperatures. This conclusion seems unsatisfactory: we nd no evidence for uctuation corrections in our simulation data. Further, and more importantly, the DP xed point is characterised by a diverging static lengthscale : for a process in the DP universality class, one expects  $hn_{i}(0)n_{i}(0)i_{DP}$  $\ln f_{\rm P}$  to be a scaling function of jx (i) x(j)j = where diverges at criticality. On the other hand, detailed balance with respect to the non-interacting energy function (1) tells us that  $hn_i(0)n_j(0)i_{FA}$  $\ln \frac{2}{4}$  / ij in the FA model. The absence of this diverging lengthscale in the FA model indicates that the underlying physics is di erent from that of the DP xed point. Finally, we note that the exact result = 1 arises naturally from our RG treatment: this situation would appear more satisactory than the argum ent of R ef. [4] that the exponents z and should be given by their DP values while is independently xed to the non-DP value = 1 by detailed balance.




Figure 5. Simulation data (symbols) for the equilibrium persistence function P (t) in the d = 3 FA model with branching rates  $c = 10^{-3}$ ;  $10^{-4}$ ;  $10^{-5}$  and  $10^{-6}$ . The main panel shows data collapse for G aussian scaling of the relaxation time  $c^{-2}$ . The inset demonstrates that the data are inconsistent with DP scaling  $_{DP}$   $c^{-2:105}$ . We used the coordinate-based continuous-time M C algorithm to measure P (t) in direct equilibrium simulations; since P (t) is e ectively a correlation function of events at a continuous range of times, the duality relations for two-time correlations cannot be used. The size of the virtual simulation box is  $64^3$ ;  $200^3$ ;  $640^3$  and  $2000^3$ , respectively, which should be su cient to avoid nite-size e ects. Results are averaged over 1000; 100; 10 and 3 repeats, again in order of decreasing c. We expect relative errors of no more than 1% in the data show n.

W e argue that the conclusions of R ef. [4] regarding the D P xed point are artefacts of an RG treatment that does not respect the presence of detailed balance and of the duality symmetry of the FA model; see also the comments after Equation (78). To remedy this, we have shown explicitly that writing the action as in (79) allows one to perform the RG analysis in a way that preserves these symmetries. We attribute the apparent uctuation e ects in the data for the relaxation time of Ref. [4], which were derived from the persistence function P (t), to a combination of pre-asymptotic corrections in c and possible nite size e ects. It should be emphasised that preasymptotic corrections are substantial: our simulations for  $_2$  (t) show that branching rates of  $c = 10^3$  are still too large to see the true critical scaling. Sim ilar comments apply to the persistence function: we do nd Gaussian scaling as shown in Figure 5, but to see this clearly requires very small c. Note that in order to obtain data for  $c = 10^5$ and  $c = 10^6$  we used virtual simulation boxes of size 640<sup>3</sup> and 2000<sup>3</sup>, respectively z. These cannot be reached by conventional lattice-based codes so that the data of R ef. [4] were of necessity taken from smaller systems, with potentially signi cant nite size e ects. Although the DP exponents  $z_{DP} = 1.9$  and  $_{DP} = 0.58$  in d = 3 [8] di er

z W hile our coordinate-based M C algorithm is extremely memory e cient (in a 2000<sup>3</sup> lattice and at  $c = 10^{-6}$  there are on average only 8000 defects) keeping track of the persistence status is a problem for large lattices. We associate single bits with the persistence status of each lattice site so that we can track persistence in lattices up to  $1000^3$  using a memory block of 125M b. At  $c = 10^{-6}$  we split the  $2000^3$  virtual simulation box into eight  $1000^3$  blocks but only track persistence in four of them to limit the memory requirement to 500M b.

only slightly from the Gaussian ones, our data clearly allow us to rule them out: the dashed line in Figure 3 represents DP scaling of the dynam ical correlation length and is inconsistent with our data. The inset in Figure 5 demonstrates similarly that the persistence functions P (t) do not collapse when plotted against  $t = _{DP}$  with the DP scaling  $_{DP}$   $c^{2:105}$ ; a rather similar picture { thus not shown { is obtained when plotting the two-point susceptibility  $_{2}$  (t), Figure 4, against  $t = _{DP}$ .

We conclude that the DP xed point is irrelevant for the FA model, for the same reason that it is irrelevant for the AA model and for parity conserving models of branching and annihilating random walks: these models possess extra symmetries that must be preserved in RG calculations and, in the case of the FA model, lead to G aussian scaling. This conclusion parallels that of C ardy and T auber [9], who showed that an early paper [18] on the parity conserving reaction-di usion system (A ! 3A;2A ! 0) had produced a similar erroneous conclusion that the upper critical dimension was four and the exponents those of DP.

# 5. Conclusion

To summarise, we showed in Section 2 that the FA and AA models with hard core exclusion share the same correlation functions (at equilibrium, and considering a single time-di erence). This was established by means of an exact mapping at the level of the master equation. An important generalisation which includes additional di usive processes demonstrated that the same mapping connects more generally the reactiondi usion models with reversible coaquilation A + A and reversible annihilation A + A \$ 0. Further, we showed in Section 3 that the bosonic versions of the FA and A A models are appropriate e ective theories for the low tem perature limits of the hard core m odels and have analogous sym m etries and relations between each other. F inally, in Section 4 we discussed the critical properties of the bosonic models using renorm alisation group arguments. Im plan enting the mapping at the level of the eld-theoretic action showed that the FA (and more generally  $A + A \$  A) model renorm alises like the AA  $(or A + A \ddagger 0)$  model. We not that the directed percolation xed point is irrelevant to the FA model, because of the presence of detailed balance and of an additional hidden symmetry inherited from the parity symmetry of the AA model. Instead, the A + Amodel and its special case, the FA model, have upper critical dimension two; detailed balance together with the two exactly known scaling exponents is su cient to nd all exponents exactly also in d < 2.

From the point of view of reaction-di usion systems and, more generally, nonequilibrium stochastic models, the most signi cant outcome of this work is the result that a hidden symmetry suppresses uctuations in the  $A + A \$  A model and lowers its upper critical dimension to  $d_c = 2$ . The mapping to  $A + A \$  O can, however, also be used to more quantitative purposes. For example, it enables one to calculate new exact results for two-time non-equilibrium correlation and response functions in d = 1; we will report on these shortly [15]. The results of such an analysis are instructive also more generally with regard to non-equilibrium uctuation-dissipation relations for activated dynamics [6]. In fact the FA model is an alm ost paradigmatic example of such dynamics, given that any evolution away from a metastable state containing only isolated defects requires the therm al excitation of additional defects.

From a di erent angle, one may ask what our results have to say about the usefulness of the FA model for capturing the qualitative behaviour of structural glasses [2, 3, 4]. We have seen that in the physically relevant case of three spatial dimensions, uctuation e ects at low defect densities are of a classical (mean-eld, Gaussian) nature. Nevertheless, the models will still exhibit a degree of dynamical heterogeneity. Violations of the Stokes-Einstein relation [5] may also persist, but will be at most by a constant (rather than diverging) factor as c ! 0; this is consistent with simulation results [19]. In summary, 'glassy' e ects will be present, but probably rather weak. This is consistent with the fact that FA models also have relatively benign, A menius-type increases of relaxation time scales at low temperature:

 $\hat{c}$  exp(2=T) in d > 2 as we saw above. These models are therefore suitable

at best for modelling for what are known as strong glasses. For fragile glasses with their super-A mhenius timescale divergences, models with facilitation by more than one spin { or with directed constraints { will inevitably have to be used. Their much more cooperative dynamics [2] continues to make them physically attractive models for understanding non-trivial aspects of glassy dynamics.

### Appendix A. Large-S expansion

To see m athem atically the equivalence between the bosonic and hard core m odels in the lim it of sm all particle densities, one can replace the spin-1/2 operators of the hard core case by their spin-S analogues and perform a form al large-S expansion, valid for states with sm all density. For example, we can de ne a new M aster operator by generalising  $L_{FA}$  from (18) to S > 1=2, as follow s:

where  $S_i^z$  etc are operators in the spin-S algebra. In the spin-half case we have S = 1=2,  $(S + S_j^z)=(2S) = s_j^+ s_j$ ,  $(S = S_i^z)=(2S) = s_i s_i^+$  and so recover immediately  $L_{SFA} = L_{FA}$ .

The M aster operator  $L_{SFA}$  describes a system in which the number of particles on each site is restricted to the range 0  $n_i$  2S; the particle number operators are  $\hat{n}_i = S_i^z + S$ . Con gurations  $fn_ig$  are mapped onto kets  $\begin{bmatrix} 0 \\ i \end{bmatrix} = \begin{bmatrix} 0 \\ i \end{bmatrix} \begin{bmatrix} 0 \\ i$

where we have introduced the coe cients  $_{S_m} = (2S)^n h0j(S_i)^n (S_i^+)^n j0i$  for ease of writing. These obey the recursion  $_{S_m+1} = _{S_m} (n + 1) [1 \quad n = (2S)]$ , yielding explicitly  $_{S_m} = n!(2S) \models [(2S \quad n)!(2S)^n]$ . From (A 2), conservation of probability requires that

We have defined a family of interpolating models with increasing S that allow us to gradually remove the hard core constraints. We will now use a large-S expansion to show that the models without constraints coincide with the bosonic models defined above. As long as there is no qualitative change in behaviour on increasing S we therefore expect the bosonic models to be suitable elective theories for the low temperature (small c) behaviour of the hard core ones. An example of a qualitative change that would render the large-S expansion invalid is a transition to a quantum disordered state as S is reduced [20]: there is clearly no such singular behaviour here. Indeed, in our case the stationary states (A.5) of the models are known for general S. Bearing in mind that  $_{S;0} = _{S;1} = 1$ , they are all of electively the same form if c is small so that only states with  $n_i = 0$ ; 1 have significant probability.

O ur claim that the above interpolating model becomes equivalent to the bosonic one in the lim it S ! 1 can be con med directly from (A.4): as long as c is small so that the relevant values of  $n_i$  stay small compared to 2S, the large-S lim it of the transition rates gives the bosonic model (4). Correspondingly, the stationary state (A.5) becomes the bosonic one in this lim it since  $S_m$  ! n!.

M ore form ally, one can establish the large-S limit of our interpolating model by looking at the H erm it ian version of the Liouvillian. U sing detailed balance this is de ned as H<sub>SFA</sub> =  $\begin{bmatrix} & & \\ & & \\ & & \end{bmatrix}_{SFA} \begin{bmatrix} & & & \\ & & \\ & & \\ & & \end{bmatrix}_{c^{\hat{n}} = 2} L_{SFA} \begin{bmatrix} & & & \\ & & \\ & & \\ & & \\ & & \\ & & \end{bmatrix}$  or explicitly

In spin language, all the states of interest are then localised on a small part of the surface of the spin sphere, and the non-trivial structure of the spin algebra can be neglected in favour of a simple bosonic one via  $S_1^+$   $\frac{P}{2S}a_1^y$ . Taking the S ! 1 lim it as explained, we get

This coincides with the Herm itian form (49) of the Liouvillian of the bosonic FA m odel as claimed, with the expected correspondence c = c. An exactly analogous procedure can be applied to construct a family of m odels that interpolates sm oothly between the hard core and bosonic AA m odels. We therefore expect that the bosonic FA and AA m odels will be appropriate e ective theories for their hard core counterparts at sm all particle densities.

## Appendix B.Random walk survival probabilities

For the scaling analysis of equilibrium correlation functions given in Section 4.3 we required particular random walk survival probabilities; these are derived in the follow ing. Consider a pair of di using defects. We can think of these as random walkers on a d-dimensional hypercubic lattice  $Z^d$ ; whenever they occupy NN sites, where their positions have distance  $jk_2 = x_1 jj = 1$ , they coagulate instantaneously. We are interested in the probability  $P_d(x)$  that the walkers survive to in nite time, i.e. never coagulate. This survival probability depends on the spatial dimensionality d and on the initial separation  $x = x_2 = x_1$  of the walkers. The distance vector  $x_2 = x_1$  also performs a random walk, with twice the elective di usion constant. The problem is therefore to calculate the probability  $P_d(x)$  that a random walker starting from position x will never reach one of the NN sites of the origin. If we picture these sites as absorbing, then  $Q_d(x) = 1 = P_d(x)$  is the probability that the walker is absorbed eventually; for absorption at the origin itself, these quantities are well known.

The key insight is that, in its rst step, the walker random ly moves to one of the NN sites of x; we write these as y 2 N (x). The absorption probability starting from x is therefore the average of those that would be obtained when starting from any of these NN sites:

The only exception to this relation is the case where x itself is already an absorption site so that  $Q_d(x) = 1$ . We can correct for this by adding a source term at these sites; the latter then has to be set at the end of the calculation to give the correct values of  $Q_d(x)$  at the absorption sites. Since all lattice directions are equivalent, all 2d source term s will be equal and we can write 2 3

We remark that for x = 0 one nds, by retaining the  $_{x,0}$  term, that  $Q_d(0) = 1$  as it must be: starting from the origin, already the rst move reaches an absorption site. Given the derivation of (B.5), it is not too surprising that the result is similar to that for the standard case of absorption at the origin, where one nds the same expression but with the denom inator replaced by  $\begin{bmatrix} R \\ 0 \end{bmatrix} d e^d I_0^d()$ .

In dimensions d = 1;2 the original pair of walkers always coagulate eventually, regardless of the initial separation and thus  $P_d(x) = 0$ . (This can be seen form ally from the fact that both the numerator and denominator integrals in (B.5) are dominated by their divergent tails; these have x-independent prefactors, giving  $Q_d(x) = 1$ .) In d > 2, on the other hand, Equation (B.5) yields a nonzero probability  $P_d(x)$  that the walkers survive inde nitely. The two particular values we need in the main text are

The rather signi cant di erence between the numerical values (B.6) and (B.7) has a simple reason: when starting at initial separation x = (1;1;0) there are 12 possible rst m oves since each walker has 6 NN sites to m ove to. Out of these, 4 lead to the walkers being on NN sites where they coagulate instantaneously, while for x = (2;0;0) only 2 m oves produce this outcom e. There are similar di erences in subsequent m oves which accumulate to the numbers given above.
