# Test of classical nucleation theory on deeply supercooled high-pressure sim ulated silica

We test classical nucleation theory (CNT) in the case of simulations of deeply supercooled, high density liquid silica, as modelled by the BKS potential. We nd that at density =  $4.38 \text{ g/cm}^3$ , spontaneous nucleation of crystalline stishovite occurs in conventional molecular dynamics sim ulations at tem perature T = 3000 K, and we evaluate the nucleation rate J directly at this T via \brute force" sam pling of nucleation events in num erous independent runs. We then use parallel, constrained M onte C arlo simulations to evaluate G (n), the free energy to form a crystalline em bryo containing n silicon atom s, at T = 3000, 3100, 3200 and 3300 K.By comparing the form of G (n) to CNT, we test the ability of CNT to reproduce the observed behavior as we approach the regin e where spontaneous nucleation occurs on simulation time scales. We nd that the prediction of CNT for the n-dependence of G (n) ts reasonably well to the data at all T studied. , the chem ical potential di erence between bulk liquid and stishovite, is evaluated as a t param eter in our analysis of the form of G (n). Compared to directly determined values of extracted from previous work, the tted values agree only at T = 3300 K; at lower T the tted values increasingly as T decreases. We nd that n , the size of the critical nucleus, is approxim ately overestim ate 10 silicon atom s at T = 3300 K.At 3000 K, n decreases to approximately 3, and at such small sizes m ethodological challenges arise in the evaluation of G (n) when using standard techniques; indeed even the therm odynam ic stability of the supercooled liquid com es into question under these conditions. We therefore present a modied approach that permits an estimation of G (n) at 3000 K.Finally, we directly evaluate at T = 3000 K the kinetic prefactors in the CNT expression for J, and nd physically reasonable values; e.g. the diusion length that Siatom s must travel in order to move from the liquid to the crystal embryo is approximately 0.2 nm. We are thereby able to compare the results for J at 3000 K obtained both directly and based on CNT, and nd that they agree within an order of magnitude. In sum, our work quanties how certain predictions of CNT (e.g. for ) break down in this deeply supercooled limit, while others [the n-dependence of G (n)] are not as adversely a ected.

## I. IN TRODUCTION

In recent years, com puter sim ulations have increasingly been used to study the nucleation and grow th of crystals from the supercooled liquid state. M olecular dynam ics (MD) simulations have been particularly useful in testing, on a m olecular level, the predictions of classical nucleation theory (CNT) [1, 2, 3, 4, 5, 6]. In large m easure, this has been m ade possible by the developm ent of novel com putational techniques that perm it the determ ination, from simulations, of free energy barriers, kinetic prefactors, and the order param eters required to quantitatively test the predictions of CNT [7, 8, 9, 10, 11]. A key feature of these techniques is that they allow the study of nucleation under therm odynam ic conditions at which spontaneous crystal nucleation does not occur on the short physical time scales accessible to conventional M D simulations. As a consequence, much previous work has focussed on testing CNT, and calculating the nulcleation rate, at low to interm ediate degrees of supercooling, where CNT is expected to best apply.

At the same time, spontaneous crystal nucleation is observed in a number of simulated liquid systems under very highly supercooled conditions where the nucleation time is comparable to or less than the simulation time scale (e.g. Refs. [12, 13, 14, 15, 16]). Current conventionalMD simulations typically are able to study systems of a few thousand m olecules over a time scale of tens of nanoseconds. W ithin these restrictions, a spontaneously crystallizing system will exhibit quite small crystal nuclei com pared to those found at higher tem perature T, and it is generally expected that CNT will not predict well the behavior of the system in this regime. Consequently, relatively few studies exam ine this deep ly supercooled lim it of nucleation behavior in the context of CNT.

The purpose of the present work is to explore this deeply supercooled lim it of nucleation behavior, with the goal of testing the lim its of CNT and quantifying how the theory begins to fail in this regime; and also to determ ine the technical lim its of applicability of the simulation m ethods usually employed at higher T. We are interested in determ ining if it is possible to compare a nucleation rate calculated using CNT, and a rate found directly from a spontaneously crystallizing MD simulation. The latter question is particularly interesting, since only a few simulation studies compare nucleation rates found from CNT to a rate calculated independently [8, 11, 17], yet such comparisons are a key tool for developing and testing in proved theoretical descriptions of nucleation.

To achieve these goals, we study liquid silica as modelled by the BKS potential [18]. The therm odynam ic and transport properties of the supercooled liquid state of this model have been characterized in detail [19, 20]. Previous work has also evaluated the phase diagram of the system, providing the coexistence conditions dem arcating the liquid, and several crystalline phases [21]. M ost signi cant for the current purpose, we nd that the liquid spontaneously crystallizes to stishovite [22] in our simulations when cooled to approximately T = 3000 Kat density  $= 4.38 \text{ g/cm}^3$ . The liquid at this T exhibits the two-step relaxation in its dynam ical quantities characteristic of a deeply supercooled uid, but it is still di usive enough to reach m etastable equilibrium on a tim e scale much shorter than the tim e scale for crystal nucleation. Consequently, we are able to make a direct calculation of the rate at 3000 K using an ensemble of independent M D simulations, while at the same tim e, we can determ ine the properties of the m etastable liquid.

W e also use constrained M onte C arb simulations of the liquid to calculate the free energy barrier to nucleation at the same density, over a range of tem peratures from 3000 K to 3300 K, to test the degree to which the predictions of CNT are satis ed on approach to T = 3000 K. The key predictions of CNT we wish to test relate to the central quantity of the theory, N (n), the equilibrium cluster size distribution, or the num ber of clusters containing n particles [6]. In this work, we will track Si atom s on ly, and assume from stoichiom etry that a cluster nom inally of size n (n Siatom s) actually contains 3n atom s (n Si atom s and 2n O atom s). N (n) is interpreted to yield the work G (n) of form ing a cluster of size n from the surrounding m etastable liquid via,

where N (0) is the num ber of liquid-like Si atom s; so dened G (0) = 0. W hether the distribution of cluster sizes is extensive or intensive (i.e., norm alized or not), the barrier is system size independent. W ithin the CNT fram ew ork, the phenom enological m odel for the work is given by,

where =  $_{stish}$   $_{liq}$  is the di erence in chemical potential between the bulk stable and metastable phases and a is a surface term that is proportional to the surface tension and depends on the shape of the nuclei. At a critical cluster size n , G (n) has a maximum and clusters larger than n will grow spontaneously, forming the new phase. G (n) then represents the free energy barrier to nucleation. In this study, we use computer simulation techniques that connect G (n) with the probability of appearance of an n-sized cluster within the simulation, where the cluster is identiaed by a specic c cluster criterion [7, 10, 23]. We can then compare our barrier calculations with the general form suggested by Eq. 2.

A coording to CNT, the rate of nucleation, i.e. the rate at which critical nuclei go over the barrier, is

where the kinetic prefactor is given by,

where Z =  $p_{j} = 6 k_B T n_{s}$  is the Zeldovich factor, D the di usion constant,  $k_B$  is the Boltzm ann constant,  $n_{s}$  is the num ber density of particles, is a typical distance particles must di use in order to go from the metastable liquid to the embryonic cluster, and  $f_{crit}^{+}$  is the rate at which particles are added to the critical nucleus. We note that the use of  $f_{crit}^{+}$  is an innovation introduced in Ref. [10]. In the case of di usive barrier crossing  $f_{crit}^{+}$  can be calculated from simulation via,

where hi denotes an ensemble average.

Our Monte Carlo simulations of liquid silica between 3300 and 3000 K show that CNT describes the liquid well. at the highest T , but that deviations in the observed and predicted behavior em erge at low er T. At the low est T, we also identify technical di culties associated with obtaining N (n) and we describe an alternative strategy that at least partially addresses them . Notw it hstanding these challenges, at the lowest T = 3000 K, we are still able to calculate the kinetic prefactors for the nucleation rate as described in CNT, so that we can compare the predicted rate to that calculated from direct M D simulations. Despite the worsening correspondence between our results and the therm odynam ic aspects of CNT at low T, the rates com pare reasonably well. W hether the correspondence of the rates at this large degree of supercooling is peculiar to our system, or whether this is a general result is an open question. We also nd that N (n), as obtained for the equilibrium system (i.e., the system that samples the equilibrium distribution of embryos, including those em bryos near to, at, and beyond the nucleation barrier), is di erent from the analogous quantity for the m etastable liquid state (i.e., the m etastable equilibrium sampled in a conventional MD simulation prior to the onset of nucleation), raising the question of which distribution is more signi cant in determ ining the rate.

In Section II, we desscribe the model system. Section III describes the direct M D nucleation rate calculation, while Section IV describes the CNT calculations and explores the use of the metastable liquid in determining the free energy barrier. We subsequently present our D iscussion and C onclusions. Appendix I describes our methods and criteria for de ning a crystalline cluster.

# II. SYSTEM OF STUDY

W e study a system of 444 Si and 888 O ions governed by a modi ed BKS potential and in a cubic simulation cell with periodic boundaries. The modi cation includes




FIG.1: Location of studied liquid state points ( lled circles) in the (a) PT and (b) VT phase diagram of BKS silica. At a given P and T, stishovite has a higher density than that of the liquid. Therefore, we also plot the stishovite state points corresponding to the liquid P (open squares) in (b). The phases shown in the diagrams are the liquid (L), -quartz (Q), coesite (C) and stishovite (S). (b) At xed V, therm odynam ic ground states are often m ixtures of two coexisting phases. The liquid state points studied fall within the onephase stability eld of stishovite. Despite the proximity of our chosen state points to the stishovite to stishovite-plus-coesite boundary in the VT plane, the location in the PT plane is deep within the stishovite region. Dashed lines are metastable extensions of stishovite and -quartz transitions, and dotted lines represent the uncertainty in the location of the melting lines. V is given permolion.

a short range additive patch to prevent \fusion" events, and a tapering of the real space part of the potential with a polynom ialtail so that it smoothly reaches zero at 1 nm. Long range forces are handled via the Ewald sum mation. The details of the potential are given in Ref. [20].




FIG.2: Stishovite at 3000 K, as viewed down the crystallographic c-axis. Only Siatom s are shown.

The phase diagram of BKS silica has been recently evaluated in Ref. [21] (Fig. 1). In that work, the stability elds of the liquid, stishovite, -quartz and coesite have been determined. In this study we focus on the molar volume  $V = V_0 = 4.5733$  cm<sup>3</sup>/mol (= 4.3793 g cm<sup>3</sup>) liquid isochore, which as shown in Fig. 1(b), falls in the one-phase stability eld of stishovite. A view of stishovite along the c-axis showing Siatom s only is provided in Fig. 2. In stishovite, there are six 0 atoms surrounding each Siatom in an octahedralarrangem ent. These octahedra, connected along edges and at corners, arrange them selves in a compact manner.

We perform our simulations in the NVT ensemble, where N is the number of molecules. Usually, nucleation experiments and simulations are done at constant pressure, P. However, we nd that for the state points of interest, the critical nuclei we observe are small, and do not noticeably change the P of the system . Only once the crystallization process advances well into the growth stage does P or the potential energy U of the system change signi cantly. Therefore, the critical nucleus form s within a liquid that is characterized to a good approxim ation either by the system 's P or V. How ever, the density of the nucleus itself is not known. Hence, we also show in Fig. 1 (b) the V of bulk stishovite at the pressure at which the liquid is studied.

P and U are needed along the  $V_0$  isochore to determine , which we obtain by extending the calculations described in Ref. [21]. The di usion coe cient is also needed in order to calculate the kinetic prefactor. To obtain these quantities, we perform MD simulations at constant V in both the liquid and stishovite, near and along  $V_0$ . First we equilibrate the system near the desired T with simple velocity scaling every 100 tim esteps, and then we allow the system to continue in the N V E ensemble for about 1 ns (E is the total energy). For the T = 3000 K and T = 3100 K cases, num erous independent runs are performed, and only those that do not show any signs of crystallizing are used to determ ine desired quantities.

For the liquid at  $T = T_0 = 3000$  K and  $V_0$ , the Si di usion coe cient is  $D = 8.04 \quad 0.2 \quad 10^7 \text{ cm}^2 \text{ s}^1$  as determ ined from the slope of the m ean squared displacement of Siatom s as a function of time t, and the pressure is found to be  $P_0 = 44.0$  GPa. This and higher T state points are shown to be in the stishovite stability eld in the PT phase diagram [Fig.1(a)].

At  $P_0$ , stishovite has a lower molar volume (V = 4:364 cm<sup>3</sup> mol<sup>1</sup>) than the melt. The stishovite state points corresponding to the pressure of the liquid [shown in Fig. 1(b)] are the state points used to calculate :

is calculated between the two phases at the same P , for which (in general) the volumes are dimenst.

# III. NUCLEATION RATE FROM MD SIM ULATIONS

W e use M D simulations in the N V T ensemble to calculate the nucleation rate at  $T_0$  and  $V_0$  in a \brute force" way. We rst equilibrate the liquid at 5000 K, and then quench 198 independent con gurations to 3000 K, employing the Berendsen therm ostat [24] with a time constant of 1 ps. O ther simulation details are the same as given in the previous section. The simulation continues at 3000 K until the system crystallizes.

Fig. 3 (a) shows two sample time series, illustrating a large drop in potential energy associated with the phase change. Fig. 3 (b) shows components of the radial distibution function  $g(r) = g_{\text{SiSi}}(r) + 2g_{\text{SiO}}(r) + g_{00}(r)$  for the metastable liquid (i.e., when the time series is stable), the crystallized system, and pure stishovite at  $T_0$ . The comparison of each g(r) shows that we indeed crystallize to stishovite.

Fig. 3 (c) shows  $F_{SiSi}(q;t)$ , the dynam ic structure factor at xed wavenum ber q obtained by considering only Si atom s (which di use more slow ly than 0), obtained from the metastable liquid portion of a simulation before the onset of crystallization. As a reference for the three wavenum bers chosen, we plot the static structure factor S (q) in the inset. W e do not observe any time evolution of S (q) during the steady state liquid portions of the time series. W ith regards to the N V E simulations, we do not observe any signi cant di erences in F (q;t) or S (q).

From  $F_{SiSi}(q;t)$ , we see that the -relaxation time for the system at  $V_0$  and  $T_0$  is approximately 100 ps. Thus, even though the system exhibits two-step (glassy) relaxation, the relaxation time is typically much shorter than the nucleation times and we are able to achieve a m etastable liquid state.




FIG.3: Crystalizing liquid. (a) Determ ination of  $t_x$  from the potential energy as a function of time. At t = 0, the therm ostat is reset from 5000 K to 3000 K.W hen the system reaches a potential energy of  $U_x = 1.81$  (M J/m ol), it is well underway to crystallizing. (b) Structure at 3000 K as m easured by  $g_{\rm SiSI}(r)$  and  $g_{\rm SiO}$  (r) (inset), of the liquid (Liq), the system after crystallization (X -Liq) and stishovite (Stish). (c)  $F_{\rm SiSI}(q;t)$ , the dynam ic structure factor for Si atom s for threeq. Inset show s the static structure factors (q) along w ith its components: total (circle), SiSi (square), OO (triangle), and SiD (diam ond).

If the fraction R (t) of unnucleated systems obeys a simple rst-order rate law, then the rate of nucleation J can be obtained from

where V is the volume of the system and  $t_0$  is the lag time, i.e. the time required to achieve a steady state of precritical nuclei [25]. However, to take advantage of Eq. 7 we must be able to identify the time when a particular system from our ensemble of runs has nucleated. Variousm ethods can be used to detect crystallization such as exam ing the Voronoi volum es or counting the num ber of particle neighbors [25]. In this study, we contrast three approaches: rst, we employ a simple energy criterion speci c to the state point studied so that the crystallization timet, for a M D run is the time at which the potential energy rst reaches a value of  $U_x = 1.81 \text{ M J/m ol}$ . That very few simulation runs reached  $U_x$  and then returned to a steady state liquid m eans that the system has progressed well past nucleation. In a sense, this m im ics experimental measures which only identify a nucleation event by observing post critical clusters that are growing. Second, we allow runs to continue 500 ps after the system reaches a lower potential energy  $U_{low} = 1.82 \text{ M J/m ol.}$  $U \sin g U_{low}$  , we can also check the sensitivity of our rate calculation on the chosen energy threshold.

O ur third criterion is based on identifying the critical nucleus. In Section IV, we nd the size of the critical nucleus, using the cluster criteria outlined in Appendix I to identify an n-sized cluster, to be about 3. We can then de ne a new time,  $t_{\rm nuc}$  as the latest time at which the largest cluster in the system  $n_{\rm m\,ax}$  1, i.e., the last time the liquid is precritical, and com pare the nucleation rates based on our di erent criteria. By choosing  $n_{\rm m\,ax}$  1, we err on the side of making  $t_{\rm nuc}$  a lower bound on the nucleation time.

Thus, we have three m easures of the nucleation time: the time  $t_x$  it takes to reach a potential energy  $U_x$  indicative of the beginning of crystallization; the time it takes to reach a low energy threshold  $U_{\rm low}$ ; and the last time  $t_{\rm nuc}$  at which the system possesses a largest cluster of size 1.




FIG.4: Determ ination of nulceation rate from R.The function  $R_{\rm x}$  (circles) is shown here to be well described (except for very early times) by exponential decay with rate constant 0:60  $\,$  0:02 ns $^1$ , determ ined from the line of best t.D at between 1 ns and 5 ns were used to obtain the t.The functions R $_{\rm low}$  (t) and R $_{\rm nuc}$  (t) have the same slope to within uncertainty. Inset: close-up at sm all t.

Fig. 4 shows a plot of R using these three criteria  $R_x$ ,  $R_{low}$  (t) and  $R_{nuc}$  (t), obtained using the upper and low er energy criteria and the critical cluster criteria respectively, as a function of time. The slope of each of these functions is the same within the error suggesting that our rate calculation is not highly sensitive to the nucleation criteria, while the lag time, obtained from the intercept, is sensitive. Using  $t_x$ , we not that the 198 quenches from 5000 K to 3000 K yield a shortest crystallization time of 0.28 ns, and longest time of 10.53 ns, with an average time of 2.12 ns. The slope of the line of best t is 0.60 0.02 ns<sup>1</sup>, where we have om itted data from times before 1 ns in the t, and the time lag t = 0.4 ns. G iven that our cubic box length is 2.1627 nm, this yields a rate of J = 0.059 - 0.002 nm<sup>3</sup> ns<sup>1</sup>, or 6 - 10<sup>34</sup> m<sup>-3</sup> s<sup>-1</sup>.

W e m easure  $t_{\text{nuc}}$  in each of our 198 nucleation runs

to a resolution of 0:005 ns and nd a lower estimate of the lag time  $t_0$  0:260 ns. The average time difference is  $t_x$   $t_{nuc} = 0.212$  ns, with standard deviation 0:117 ns. Comparing these two criteria, we nd them ean value of the largest cluster at  $t_x$  is  $h_{max}(t_x)i = 39$ , i.e. about 10% of the system, with a standard deviation of 23. Therefore, for our system, the crystallization process signi cantly lowers the energy only when about 10% of the system has crystallized. We also note that in about 5% of the runs, the U<sub>x</sub> criterion is triggered prematurely, i.e., a low-energy uctuation goes below U<sub>x</sub>, but then the system energy remains in steady state.

We note that calculating the rate directly from the slope of the plots in Fig. 4 m ay ignore e ects due to transient nucleation, i.e. that R decreases smoothly at early times instead of remaining at 1 until  $t_0$  [25], so that our estimate of the rate and lag times are strictly lower bounds. Nevertheless, the independence of our slope on the nucleation criteria suggests that our calculation of the rate is robust and any corrections would be small.

Fig. 5 (a) shows a critical nucleus at 3300 K (obtained from constrained M C simulations described later), while Fig. 5 (b) shows a postcritical crystallite of size 23 from an M D simulation at  $T_0$ . Fig. 5 (c) shows a representative con guration at the end of a crystallization simulation. These pictures provide a visual con mation that the liquid does indeed crystallize to stishovite; that sm all nuclei (at least for  $n_{m \ ax}$  10) resemble the bulk phase; and that the procedure used to de ne clusters is able to track the nucleation process.




FIG.5: Top: Sam ple critical nucleus at 3300 K containing 10 Siatom s. M iddle: A snapshot of the growing crystal embryo from a dynamic crystallization simulation at 3000 K when it contains 23 Siatom s. Bottom : Sam ple end con guration of a crystallization simulation.

#### IV. CNT CALCULATIONS

#### A. Free energy barrier

The central quantity of CNT is N (n). However, it is not feasible to obtain N (n) through direct simulation for two reasons: critical clusters are typically rare, and hence it is di cult to gain statistics; and after the form ation of the critical cluster, the system irreversibly evolves tow and the crystalline state. To overcom e this, we add a bias to the system H am iltonian which constrains the clusters of interest into existence. The new constrained H am iltonian is then

where H  $_{\rm B\,K\,S}$  is the unbiased H am iltonian derived from our BKS potential and

is the contraint with  $and n_0$  being constants, and where  $n_{m \ ax}$ , the size of the largest cluster in the system, is an orderparameter [10]. The N (n) measured under the constraint is then related to its value in the unconstrained system through the relation

where  $h:_{C}$  denotes an average in the constrained ensemble. In the case where a cluster of size n is rare N (n) = P (n<sub>m ax</sub>), the probability that the largest cluster in the system is of size n<sub>m ax</sub>, and Eq. 10 becomes,

It is important to note that our cluster de nition ignores 0 atom s, and only uses Siatom s. Thus, a cluster of size n contains n Siatom s, or n SiO<sub>2</sub> units (see Appendix).

Since it is easier in practice to measure P ( $n_{m ax}$ ) than N (n), we will use P ( $n_{m ax}$ ) interchangeably with N (n) in the regime where the two are shown to be equal. Formally, this occurs when clusters are rare, and can be justiled by the following. Let  $P_n$  be the probability that there is at least one cluster of size n in the system, and  $P_n$  (i) be the probability that there are exactly i clusters of size n. Then,

W hat we mean by a rare cluster of size r is that  $P_r(1)$ is small, and additionally that rare cluster appearance is independent of what other clusters are present, i.e.  $P_{r}(2) P_{r}(1) P_{r}(1)$ 0. This immediately leads to  $P_n = N$  (n) [10, 23]. By extension, two rare clusters of di erent sizes appearing at the same time also occurs with vanishing probability  $P_{r+m}$  (1)  $P_r$  (1) 0 [assuming  $P_{r+m}$  (1) <  $P_r$  form > 0, i.e. larger clusters are rarer], and so a rare cluster will also be the largest cluster in the system . From these arguments, we obtain  $P_n(1) = P_n = N(n) = P(n_{max}), \text{ for } n$ r (the equality holds up to a normalization constant that is irrelevant in determ ining the free energy). Of course, when N (n)  $\notin$  P (n\_m  $_{\rm ax})$  , we measure N (n) directly.

The basic MC scheme follows that presented in Ref. [26], where short NVE MD trajectories generate

new con gurations that are tested against the Boltzm ann distribution. M one explicitly, we begin with a con guration C<sub>1</sub> with largest cluster  $n_{m\,ax}^{[1]}$ . New random velocities drawn from the M axwell distribution appropriate to the desired T are assigned to all the particles, and at this point the total energy is H<sub>BKS</sub><sup>[1]</sup>. W ith these new velocities, the system evolves along a constant NVE M D trajectory for 10 tim esteps, with forces derived from H<sub>BKS</sub>, to arrive at a new con guration C<sub>2</sub> with total energy H<sub>BKS</sub><sup>[2]</sup>, and largest cluster  $n_{m\,ax}^{[2]}$ . W ith a perfect integration scheme, H<sub>BKS</sub><sup>[2]</sup> = H<sub>BKS</sub><sup>[1]</sup>. C<sub>2</sub> is accepted with propability p given by,

$$p = m in 1; exp = \frac{1}{k_B T} H_C^{[2]} H_C^{[1]} : (14)$$

It is important to note that the acceptance criterion for this hybrid M D -M C m ethod uses the total energy (kinetic plus potential), rather than just the potential.

W ith this hybrid M C m ethod, it is only necessary to evaluate the cluster size distribution of the system at the end of each M D m initrajectory. The m ethod also provides a way of incorporating the E wald sum s through multiparticle M D m oves, i.e., energy changes arising from single particle m oves are di cult to calculate e ciently when there are long range forces.

In order to facilitate equilibration, we employ parallel tempering over a matrix of runs having di erent values of  $n_0$  and T. O ur tempering scheme follows the descriptions given in Refs. [10, 27]. The particulars are as follows. C om pute nodes running in parallel decide whether to attempt switches of con gurations with neighboring nodes every 10 M C steps, alternating between T-switch and  $n_0$ -switch attempts. For T-switches, an attempt is m ade with each neighbor with probability 0:36. For  $n_0$ switches, an attempt is made with each neighbor with probability 0:19. The probabilities for accepting switches are given in Refs. [10, 27]. In practice, it is computationally faster to switch H am iltonians or T between processors, rather than con gurations.

To gather data, we set up a grid of simulations with several values of  $n_0$  for each T. Simulations are seeded from con gurations sampled from the MD crystallization runs at  $T_0$ . To initially locate n, we set up a grid as given in Table I(a), with = 8 kJ/m ol. A fler equilibration, and after roughly determining the shape of the G (n) curves, we set up other grids with = 16 kJ/m ol, as shown in Table I(b-c).

Our results for T = 3100, 3200 and 3300 K come from Table I(b), and the run time is 700 000 M C steps. The starting con gurations are those from Table I(a).

G (n) is calculated over the interval from 100000 to 700000 M C steps, checking that G (n) as calculated separately from the intervals 100000 400000 M C steps and 400000 700000 M C steps do not show appreciable di erences. For these T, N (n) P ( $n_{m ax}$ ) for n 2 and so we use P ( $n_{m ax}$ ) to determ ine G (n). The rst part of G (n) is obtained by calculating N (n) directly from

simulations where  $n_0$  is small. The simulation grid in Table I(c) provides a consistency check on the results for T = 3100 K and T = 3200 K. The run time is 350000 MC steps.




FIG.6: Portions of G (n) before shifting, based on unnormalized histograms for N (n) and P ( $n_{max}$ ). These are data transformed via Eq.10 and 11 from the constrained into the BKS silica ensemble. These distributions are for T = 3200 K, for processors 5, 6, 7, 8 and 9 from Table I(b). Legend shows the values of  $n_0$  used to constrain the system. Symbols and bold lines indicate portions of the data used to obtain the complete G (n). For the cases of  $n_0 = 1$  and 3, N (n) is obtained directly. The dashed line shows P ( $n_{max}$ ) for the  $n_0 = 1$  case, illustrating that already N (n) = P ( $n_{max}$ ) for n 2. For larger values of  $n_0$ , P ( $n_{max}$ ) is used to obtain G (n).




FIG.7: G (n) obtained from N (n) after piecing together results from parallelsim ulations such as those shown in Fig.6. Filled symbols are for data described in Table I(b), open diam onds are for hard wall constraints described in Table II. The solid curves are ts to the form given by Eq.2. For T = 3000 K only points with n 4 are used for the t. For T = 3300, a one-parameter t is shown: in Eq.2 is obtained from independent calculations, and only a t is left to t.

Fig. 6 shows pieces of N (n) and P ( $n_{max}$ ) obtained from parallel simulations for T = 3200 K and for various  $n_0$ . We see from the  $n_0 = 1$  case that for n 2, P ( $n_{max}$ ) = N (n). Therefore, only P ( $n_{max}$ ) need be calculated for determining G (n) beyond n = 2. Fig. 6 also shows the consistency of the sampling between simulations of di erent  $n_0$  near the top of the barrier. For each  $n_0$ , a portion of N (n) is recovered up to a multiplicative constant, or additive constant in G (n). The pieces are m atched using the self-consistent histogram m ethod [27], and the resulting G (n) curve is shown in Fig. 7. The curves for T = 3300 and 3100 K are produced by the sam e m ethod.

# B. M ethodological challenges at T = 3000 K

For T = 3000 K, we encounter m ethodological di culties using the parabolic constraint in our M C simulations, apparently due to the small size of the critical nucleus. At this T, as we shall see, P ( $n_{max}$ )  $\in$  N (n), and so we must nd N (n) directly, but the parabolic constraint together with Eq.10 does not yield adequate statistics. For example, in Table I(c), node 0 infrequently samples states over the barrier, and because of the large factor of exp [ ( $n_{max}$ )= $k_B$ T] in Eq.10, these particular states dom inate the resulting N (n).

To obtain N (n) at 3000 K, we replace the parabolic constraint with a vertical, hard wall potential by set-

ting upper and lower bounds on  $n_{m ax}$ . Any MC move which violates  $n_{m ax}^1$   $n_{m ax}$   $n_{m ax}^u$  is rejected. Eq.10 is modi ed to simply be hN (n)i = hN (n)i for  $n_{m ax}^1$   $n_{m ax}$   $n_{m ax}^u$ , i.e., N (n) is the same in the constrained and unconstrained ensembles within the upper and lower bounds on  $n_{m ax}$ . The constrained H am iltonian in this case becomes,

We then set up the hard wall simulation as outlined in Table II, taking initial congurations from Table I(c) and running for 1400000 MC steps. For each node, N (n) is determined for  $n_{m ax}^{l}$  n  $n_{m ax}^{u}$ . Small windows in n are use to gather good statistics as well as to prevent nucleation in the bin closest to n = 0. Error estimates are taken by considering di erent time intervals in determining N (n). Ideally, G (n) for T = 3100 K should be the same when calculated either with hard wall or parabolic constraints. A ny discrepancy between the curves is another measure of our uncertainty in G (n).




FIG. 8: G (n) obtained from N (n) and P (n  $_{max}$ ) for T = 3000 K, compared to results for T = 3100 K.Open and led diam onds represent the same data as in Fig. 7. C rosses show results for T = 3100 K obtained from simulations in Table I(c), while open circles are from hard wall constraint simulations described in Table II. All three curves agree up until the critical size. The line connecting plus symbols (+) shows for Table II the approximate equality of P (n<sub>max</sub>) and N (n) for n 2. The line connecting stars () shows that this equality breaks down for T = 3000 K.

As described above, we have calculated G(n) for T = 3100 K with three sets of simulations, as described in Tables I(b-c) and II. In Fig. 8 we plot as crosses the results from Table I(c), and see that the data show good consistency with those obtained from Table I(b), deviating only beyond n = 5, the last  $n_0$  in Table I(c). The hard wall curve also shows good consistency with the parabolic constraint results.

Fig.8 also show s that while N (n) P ( $n_{m ax}$ ) holds for T = 3100 K, it breaks down for T = 3000 K, necessitating the direct calculation of N (n) which we accomplish with our hard wall constraints.




FIG.9: Breakdown of  $n_{m ax}$  order parameter at T = 3000 K. Time series are shown for node 0 in Table II for U (a) and n<sub>m ax</sub> (b). In (a), U begins in a steady state sim ilar to the unconstrained M D simulations at 3000 K (0 300 000 M C steps), and following period of sm all decrease (300 000 500 000 M C steps) enters a regime with slightly larger uctuations and where lower energy states are probed more often. Panel (b) shows a crossover near 400 000 MC steps to a regime where  $n_{m ax} = 2$  is favored over  $n_{m ax} = 0$ . The e ect on ln N (n) + const is shown in (c), where distri-G(n) =butions taken from dierent portions of the time series are plotted: the early time pro le is distinct from the later-time steady state. Panel (d) plots  $\ln P (n_{max}) + const, show ing it$ to be monotonically decreasing at late times, apparently indicating a barrierless regime. However, it is more likely that the nucleation process is simply not adequately described by using n<sub>m ax</sub> alone.

However, despite the narrow binning of  $n_{m ax}$  outlined in Table II, all the bins at T = 3000 K eventually nucleate. Fig. 9 shows for node 0 in Table II the U and  $n_{m ax}$ time series [panels (a) and (b)] as well as early and late time distributions N (n) [panel (c)] and P ( $n_{m ax}$ ) [panel (d)]. The U time series at rst glance seems stable, but does show larger uctuations at later stages than at the

beginning. The  $n_{m ax}$  time series also shows a change in behavior: at early times (up to 400000 MC steps)  $n_{m ax} = 0$  or 1 is favored, while at later times  $n_{m ax} = 1$ or 2 is favored. The early and late time N (n) pro les show a signi cant di erence, as do the P ( $p_{m ax}$ ) curves. In fact, at time beyond 500000 MC steps,  $\ln P (n_{m ax})$ m onotonically decreases.

Since  $n_{max}$  is an order parameter, the quantity  $k_{\text{B}}\,\text{T}\,\ln\text{P}$   $(n_{\text{m}\,ax})$  is a free energy. The later-time curves shown in panel (d), therefore, would seem to indicate that there is no barrier to increasing  $n_{m \; ax}\,$  for the system , i.e. that the liquid is no longer a metastable phase. A lternatively, these data m ight suggest that it is no longer su cient to describe the nucleation reaction coordinate solely in terms of n and that an additional parameter such as cluster quality m ay be needed [28]. For example, it could be the case that sm all clusters that are well ordered m ay be over the barrier, as indicated in the second half of the tim e series, while other less ordered clusters of the sam e size are on the liquid side of the barrier. Thus, for late times, this bin no longer contains the metastable liquid, but rather a post-critical state. The late-time G (n) pro les, therefore, represent a lower bound of the CNT barrier for this T. The early time behavior, how ever, still shows a metastable liquid according to  $\ln P(n_{max})$ , and is therefore used to estim ate the CNT barrier. The curves for T = 3100 K show no such di culties.

These observations highlight the di culty in determ ining G (n) for such small values of n, where the quality of the cluster may signicantly a lect whether a cluster of

a given size is post-critical. A possible solution is to introduce another order parameter that takes into account the quality of the cluster when determ ining free energy pro les.

Our main result from Fig. 8 is that we obtain G (n)= $k_B T = 7.86$  0.6 for T = 3000 K. The uncer-

tainty is obtained by considering dimensions of the (early) time series when constructing G(n). We also obtain n = 3 Siatoms (SiO<sub>2</sub> molecules), or 9 atoms including O.

## C . Comparison with $C \; N \; T$

Fig.7 shows the full G (n) curves for the di erent T. We see from Fig.7 that both n and G (n) decrease as T decreases. Furtherm ore, we see that n ranges from 3 to 10. These sm all values make it unlikely that periodic boundary conditions induce catastrophic nucleation in our system [29]. Moreover, for T = 3000 K we nd n = 3, and analyzing our M D simulation runs, we con m that the energy (or pressure) signature of crystallization occurs after nucleation occurs, and that the creation of a critical nucleus at this T does not detectably a ect the pressure.

The results in Fig. 7 allow us to compare the observed behavior to the form of G (n) predicted by CNT, given in Eq.2. We t Eq.2 to the data at each T, and determine the constants a t and t as thing parameters. These ts are shown as solid lines in Fig. 7, and show that the functional form of Eq.2 satisfactorily describes the data at all T. For T = 3000 K, the t is satisfactory only up to the top portion of the curve.

Next, given that the presence of the critical nucleus does not a ect the system pressure, we calculate between stishovite and the liquid at the T and P of the liquid VT state point under consideration (calculated as the di erence in Gibbs free energy per mole of Si, or  $SiO_2$  unit), based on the results presented in Ref. [21]. The values are presented in Table III, and compared to the corresponding values of t. We nd that t. at T = 3300 K, but that di erences com pares well to appear at lower T, getting larger as T decreases. Thus, though the form of Eq.2 ts the data for G(n) at all T, the ability of CNT to predict is lost for T < 3300 K.

A ssum ing that we have an approximately spherical nucleus, we estimate the surface tension from the t parameter  $a_t$  for our range of T to be  $=k_B T = 25 \text{ nm}^2$ ; see

Table III. Note that a = 4  $(3=(4_{n}))^{2=3}$  for spheres. For silica at am bient P and near T = 1500 K, experimental values for range from 0:3 to 0:7 Jm<sup>2</sup>, or =k<sub>B</sub> T = 15 to 34 nm<sup>2</sup> [30]. For comparison, the value recently reported for N aC l at 800 K is  $_{NaC l}$  = 80 erg cm<sup>2</sup>, or  $_{NaC l}$ =k<sub>B</sub> T = 7.2 nm<sup>2</sup>. Thus, we see that at our high P and T, where the liquid is simpler, i.e., does not have a tetrahedral network, is still close in value to what it is at am bient P, and does not have a value closer to that of a simple ionic liquid. Table III also shows that despite the breakdown in the ability of CNT to predict in this T range, a to fEq. 2 to our G (n) data still gives a relatively consistent estimate of .

Furtherm ore, it is interesting to note that while  $_{t}$ =k<sub>B</sub>T changes some 80% as T decreases from 3300 to 3000 K, =k<sub>B</sub>T roughly changes by only 25%. This perhaps indicates that the structure and/or density of the critical nucleus interior undergo larger changes with T than surface properties.

#### D. K inetic prefactor

The crucial quantity in the kinetic prefactor is either , or f<sup>+</sup><sub>crit</sub> from Eqs. 4 and 5. Following the work of Frenkel and co-worders [10, 11], we calculate  $f_{crit}^+$  through Eq. 6. Eq. 6 follows the assumption that the addition and detachm ent of particles from the near-critical crystallite is a di usive process. In order to measure the deviation of the cluster size from the critical value, i.e., the right hand side of the equation, we isolate 80 clusters near the critical size from constrained M C simulations and use them to seed N V E simulations lasting 150 pswith random ized initial velocities corresponding to T = 3000 K . W e then use multiple time origins from each time series, where at each time origin the con guration has  $n_{max} = n \cdot Ad$ ditionally, to ensure we are measuring the properties of clusters of critical size, each time origin is only chosen when the average cluster size for the preceding 1000 fs is between 2 and 4. Varying the averaging time or these upper and lower bounds does not appreciably a ect the results.

<sub>D</sub> We in<sub>F.</sub> Fig. plot 10(a) the quantity  $[n_{max}(t) n(0)]^2$ . The plot shows a very rapid early time increase to a value of about 4 (inset shows early time behavior) or a uctuation in size of the cluster of about 2 particles. Notw it standing the early time change in  $[n_{max}(t) n (0)]^2$ , we see that the tim e series enters into a di usive regim e that is linear in time, with  $jn_{max}(t)$  n (0) j between 2 and 3. By tting a line to this section, we obtain an estimate of the slope  $m = (2:0 \quad 0:2) \quad 10^2 \text{ ns}^1$  which gives  $f_{crit}^+ = m = 2 = (1:0 \quad 0:1) \quad 10^2 \text{ ns}^1$ . This is about 3 tim es larger than the value obtained for molten NaClat T = 825 K and atm ospheric P of 0.033 ps<sup>1</sup> [11]. The early time behavior of  $[n_{max}(t) n(0)]^2$ is




FIG. 10: Calculation of  $f_{crit}^+$ . Panel (a) shows a plot of  $[n(t) n(0)]^2$  as a function of time at 3000 K. A fler a briefearly time regime, the size of the cluster shows di usive behavior. The slope of the line of best t in the linear regime is (2:0 0:2)  $10^2$  ns<sup>1</sup> =  $2f_{crit}^+$ . Inset shows early time behavior. Panel (b) shows  $n_{max}$  (t) for a portion of an NVE simulation seeded with a cluster of size  $n^2 = 3$ .

plotted in the inset of Fig. 10(a), and shows a rapid increase corresponding to short-time uctuations in the cluster size. These rapid uctuations are seen in Fig. 10(b), where we plot a representative portion of an NVE simulation with a critical cluster in it. A lthough short-time uctuations can be considerable given that  $n^2 = 3$ , the general trend shown here suggests  $n_{max}$  uctuates around  $n^2$ .

A llthe factors required to calculate the nucleation rate via Eq.3 are sum m arized in Table IV. The resulting rate is  $J^{C N T} = 4.1 \ 10^{35} \text{ m}^{-3} \text{ s}^{-1}$ , and given the uncertainties in the calculated quantities, this result should be accurate within a factor of 2. Note that we have calculated the rate using j jas obtained from independent free energy calculations. It could be argued that j tj is the appropriate quantity and this introduces an additional

factor of uncertainty of  $j_{tj=j} = 1.25$ The quantity can be obtained by solving Eqs. 4 and 5, resulting in,

U sing our values for D,  $f_{\rm crit}^+$  and n, we obtain = 0.20 nm. To put this in perspective, the  $\;$  rst peak of the Si-Si radial distribution function for the liquid at our state point is 0.3 nm and the width of the  $\;$  rst neighbor peak in the liquid  $g_{\rm SiSi}(r)$  is about 0.1 nm .

### E. M etastable equilibrium liquid N (n)

W e now focus on the steady-state liquid that exists in our M D runs prior to any crystallization, which we call the metastable equilibrium liquid. We ask whether we can extract inform ation about the barrier to nucleation from this metastable equilibrium liquid, i.e., without any constrained M C sampling [31]. To this end, we harvest con gurations from our direct nucleation M D runs that have 500 ps t  $t_x$  500 ps. This reasonably ensures that we have con gurations only from metastable liquid equilibrium, or steady state liquid, and have not included con gurations that have begun to crystallize. W e measure the distributions of cluster sizes to obtain N <sup>m s</sup> (n) and then de ne the free energy

where the constant is chosen to ensure  $G^{m \ s}(0) = 0$ . One might expect the two distributions N (n) and N<sup>m s</sup>(n) to be the same. However, N (n) is obtained by allowing otherwise unstable clusters to equilibrate in the surrounding liquid, while N<sup>m s</sup>(n) is obtained directly from a dynamic simulation. Furthermore, the way we obtain N<sup>m s</sup>(n) reduces sam pling of states near the top of the barrier.




FIG. 11: Work of cluster form ation at T = 3000 K derived from N<sup>ms</sup>(n) distributions obtained directly from NVT MD simulations where no crystal nucleation has occurred. Panel (a) shows G<sup>ms</sup>(n)=k<sub>B</sub>T (led cirles) along with the equilibrium G (n)=k<sub>B</sub>T (open diamonds), the curve (j jn + 92n<sup>2=3</sup>)=k<sub>B</sub>T (solid curve), and a t of the linear part of G<sup>ms</sup>(n)=k<sub>B</sub>T at high n. Panel (b) shows the quantity [G<sup>ms</sup>(n) + j jn]=k<sub>B</sub>T, that according to Eq. 2 should be linear function of n<sup>2=3</sup>. The line of best t passing through the origin and through the data points corresponding to n = 1, 2, 3 and 4, has slope 92.

We plot  $G^{m s}(n)$  in Fig. 11(a) ( led circles). A lthough the rst part of the data behaves like a usual barrier, the curve at larger n is straight. A linear  $G^{m s}(n)$ im plies an exponential  $N^{m s}(n)$ . It also im plies that the work required to add a particle to the cluster is independent of n. C learly, this does not t the CNT picture, where increasing the size of the cluster reduces the work required to add a particle.

In order to extract some inform ation from  $G^{m \ s}(n)$ , we calculate the quantity  $[G^{m \ s}(n)+j \ jn]=k_B T$ , which should be a linear function of  $n^{2=3}$ , and plot it in Fig. 11 (b). The resulting curve does indeed show a linear dependence on  $n^{2=3}$  at small n. A t through the origin and the rst 4 non-zero data points yields a slope of 92. Using this slope, we construct the CNT curve  $C^{m s}(n) = j$  jn + 92 $n^{2=3}$  and plot it in Fig. 11 (a) (solid line). From this curve, we obtain  $G^{m s}(n) = 10.74$  and n 6. Using these parameters, while keeping  $f_{crit}^+$  calculated earlier, we obtain an estimate of the nucleation rate of  $J^{m s} = 1:6 \quad 10^{34} \text{ s}^1 \text{ m}^3$ , a value closer to J than that obtained from N (n) (see Table IV).

This close agreement with J still leaves us with question of why  $G^{ms}(n) \in G(n)$ . In Fig.11(a), we plot for comparison G(n), and see that is it signicantly lower than  $G^{ms}(n)$ .

### V. DISCUSSION

In this study, we take advantage of a liquid state point that spontaneously nucleates on a time scale long enough to allow the determ ination of the properties of the m etastable liquid. By sam pling m any nucleation events, we obtain the rate directly as shown in Fig. 4, where we show that the nucleation process enters a regime of

rst-order kinetics. The criterion used to determ ine when nucleation has taken place, whether an energy criteria or an exam ination of the cluster size, does not signi cantly alter our estimate of the rate.

W ith the direct rate in hand, we wish to test the prediction of CNT. First, we calculate G (n) for a series of T above and including T<sub>0</sub>. As it is de ned in Eq.1, G (n) is only form ally a (relative) free energy for the case when n-sized clusters are rare. In such a case, G (n) becomes equivalent to  $\ln P(n_{max})$ , which is form ally a free energy. However, N (n) is the quantity of central in portance in CNT, and the interpretation of G (n) as a free energy, and G (n) as a free energy barrier, is valid for m ore m oderate supercooling or for liquid condensation from the supersaturated vapor.

In this work, we probe T low enough that a considerable (small-n) portion of N (n) is not equivalent to P ( $n_{m ax}$ ). Indeed, at T = 3000 K, where the small value of n makes all cluster sizes of interest su ciently com - mon, N (n) and P ( $n_{m ax}$ ) are di erent everywhere. This does not a loc the form alism of CNT, merely the identication of G (n), as de ned in Eq.1, as a free energy.

This becomes in portant at T = 3000 K, where it is di cult to keep the metastable liquid from nucleating, even at the smallest range of  $n_{max}$ . At this T, the free energy barrier according to P ( $n_{max}$ ) is about 1.5  $k_B$  T [Fig. 9(d)]. The possibility of a spinodal-like loss of liquid stability to the crystal becomes a prominent possibility [32]. On the other hand, a set of criteria are used in order to distinguish liquid and crystal states. Thus, in a system where nucleation is taking place in a localized region, most of the system will still be labeled as liquid. Therefore, there will be more liquid-like particles (corresponding to n = 0) than single crystal-like particles (corresponding to n = 0)

responding to n = 1), so that G (n) will always show a barrier. Hence, if nucleation is unavoidable because of som e spinodal process, the usefulness of interpreting G (n) as a free energy barrier is not clear.

W ith these thoughts in m ind, we proceed to discuss the progression of G (n) with T. At T = 3300 K, the identi cation of N (n) with P ( $n_{m ax}$ ) holds very well. The resulting G (n) is well described by Eq.2. Indeed, even the bulk value for calculated independently accurately describes the data, necessitating a t only to determ ine the surface tension term. It is important to note that our approximation that the appearance of the critical nucleus does not a ect P should be weakest at this highest T since the critical nucleus is largest. The

result upholds our approximation.

The G (n) pro les for T = 3200 and 3100 K are sim ilar to the 3300 K case, except that the bulk value of

shows increasing deviation from t. This deviation stems from either violating the assumption of cluster incompressibility used in the derivation of Eq. 2 [6, 33], or from the (near certain) possibility that the structure of the small nuclei is di erent from bulk stishovite, and therefore follows a di erent equation of state (the bulk equation of state is used calculate ).

Here, a note about ensembles is in order. Since we are at constant V, G (n) [or  $\ln P(n_{m\,ax})$  for that matter] represent a change in Helm holtz free energy of the system. The use of in Eq. 2, however, is still form ally correct [34]. Moreover, as we have shown, the critical nucleus does not signic cantly alter the P in our system. Hence, the nucleus can be regarded as being in either a constant V or a constant P environment.

At T = 3000 K, clusters are insu ciently rare to identify N (n) with P ( $n_{m ax}$ ). Therefore, we calculate N (n) directly using hard-wall constraints, a method giving the same results for 3100 K as those obtained from the parabolic constraint. Furtherm ore, we see a breakdown in the ability of our single order parameter  $n_{m ax}$  to suf-

ciently characterize the critical cluster. A high quality cluster of size 2 can be post-critical, resulting in what appears to be a spinodal-like prole in Fig. 9 (d) for late times. For our current purposes, we use the portion of the time series which explicitly shows the metastable liquid state in order to calculate G (n). In order to calculate P ( $n_{max}$ ) accurately at T near 3000 K, more stringent measures should be taken, including perhaps using an extra order parameter to help characterize the critical state better.

Calculating the kinetic components of the CNT expression for the rate, though more straightforward, requires comment. The parameter is usually dened as the distance a particle must di use when moving from the surrounding uid to the nucleating phase, which is an intuitive interpretation in the case of condensation in a dilute gas. In the case of crystal nucleation, its meaning is not so clear, especially when we ask how should be interpreted with respect to a cluster criteria which identi es correlations between particle environments. Neverthe less, by calculating D and  $f_{crit}^+$ , we nd = 0.2 nm. This value is physically appealing, as it is less than the

rst neighbor Si-Si distance of 0:3 nm and the distance between the two sub peaks of the rst  $g_{\rm iSi}(r)$  peak for stishovite (the rst peak is split), is about 0:1 nm. This reasonable value of is evidence that CNT provides an adequate description of nucleation in our system, a contrast to the case of molten N aC l, where was found to be unphysically large [11].

O ur calculation of  $f_{\rm crit}^+$  suggests there are two time scales associated with the dynam ics of the critical cluster.  $[h_{\rm m\ ax}\ (t)\ n\ (0)\ j^2$  grows rapidly over the  $\ rst\ 40\ fs$  before reaching a plateau near 4, after which, it increases at a much shower rate. The di usive grow th of the cluster occurs show ly and measurements of  $f_{\rm crit}^+$  on the longer time scale leads to reasonable values of . The short-time uctuations most likely arise arise from particles close to the cluster de nition thresholds, for which sm all motions result in their being included or excluded in the crystalline cluster.

We emphasize that despite the di culties at 3000 K, the rates J and  $J^{C N T}$  compare quite favorably, given similar comparisons done previously [11]. At higher T, there are no di culties with the formalism used to calculate G (n). Furthermore, the quantitative agreement between G (n) and Eq. 2 is excellent, especially given the fact that is calculated independently for bulk phases.

A nother intriguing aspect of this study is the di erence between G (n) and G<sup>m s</sup>(n). G (n) is obtained through equilibrium simulations of the constrained system. The constraint allows for a rigorous determ ination on N (n), allowing post-critical states to be sam pled while determ ining the barrier. G<sup>m s</sup>(n) is determ ined through M D simulations of liquid quenched from T = 5000 K to T<sub>0</sub>, allowing the liquid to relax for several -relaxation times, and collecting data only until 500 ps before crystallization is detected through the energy. Only three runs have t<sub>x</sub> t<sub>nuc</sub> > 500 ps, with the largest di erence being 781 ps. Increasing the cuto of the time series to 800 ps before t<sub>x</sub> does not signi cantly alter G<sup>m s</sup>(n).

Thus,  $G^{m \ s}(n)$  is constrained in a peculiar way. The data are pruned to include post-critical structures, so long as they happen to dissolve through some uctuation. Therefore, post-critical states are sam pled in a non-equilibrium fashion. A lso, pre-critical uctuations that happen to carry the system over the barrier quickly are not sam pled well either. Therefore, near-critical states are sam pled less offen than in equilibrium [and hence  $G^{m \ s}(n) > G(n)$ ]. We have not determ ined whether this sam pling di erence is su cient to account for the di erence between  $G^{m \ s}(n)$  and G(n).

Given these di culties, the agreem ent between J and the rate calculated from  $N^{m s}(n)$ , following from our seem ingly logical procedure to obtain a barrier height from  $G^{m s}(n)$  [ $C^{m s}(n)$ ], may be fortuitous. However, another possibility regarding the discrepancy between  $G^{m s}(n)$  and G(n) is that the time scale on which the N (n) evolves is much longer that the -relaxation time of the liquid. We note that quantities like g(r) and the structure factor are constant during the time 500 ps < t < t<sub>x</sub> 500 ps. However, it is possible that N (n) evolves more slow ly. In this case, the N<sup>ms</sup>(n) that we measure is not expected to be the same as N (n), and is perhaps more physically relevant in calculating the rate. Perhaps this is why J<sup>ms</sup> agrees better with J than does  $J^{CNT}$ . Clearly, the comparison of the metastable liquid distribution and the equilibrium distribution raises a number of interesting questions that warrant further investigation.

### VI. CONCLUSIONS

W e perform N V T M D simulations of liquid silica at  $T_0=3000\,K$  and  $V_0=4\pm5733\,cm^{3}/m$  ol, corresponding to  $P_0=44\,\Omega$  G Pa, and calculate the rate of hom ogenous nucleation to stishovite to be  $J=(6\,\Omega-0\,2)-10^{34}\,m^{-3}\,s^{-1}$ . This state point is located deep in the stishovite eld in the P T phase diagram , and within the single phase coexistence region of stishovite in the V T phase diagram .  $T_0$  is at about half the melting tem perature at this  $P_0$ .

W e also compare this rate to that predicted by CNT. The work in forming a cluster of size n [G (n)] follows the form predicted by CNT (Eq. 2) for T = 3000 K, 3100 K, 3200 K and 3300 K. At 3300 K, an independent calculation of using bulk phase values allows for a successful one-parameter t of G (n). A ssuming a spherical nucleus, an estimate for surface tension in this range of T is  $=k_{\rm B}T$  25. At T = 3000 K, the CNT form only ts the data well only up to n = 4, one larger than the critical size. Furtherm ore, the usual identication N (n) P (n<sub>max</sub>) breaks down strongly at this T.

We also nd that N (n) and  $N^{m s}$  (n) di er. In fact, using N<sup>m s</sup> yields a CNT result that is closer to direct measurement. This may indicate a subtle dependence of the nucleation rate on the initial T from which the system is quenched, via slow evolution of the cluster distribution.

Calculating the kinetic prefactor, we obtain  $f_{crit}^+ = 100 \quad 10 \text{ ns}^1$ , resulting in a calculated rate of 4:1  $10^{35} \text{ m}^{-3} \text{ s}^1$ , with an uncertainty of a factor of 2. Therefore CNT overestim ates the rate by an order of m agnitude. The average distance that a Si atom must di use in attaching itself to a crystalline cluster is = 0.2 nm. This length is approximately twice the width of the rst neighbor shell of the Si-Si radial distribution function.

# VIII. APPENDIX:DETERM IN ING CLUSTER SIZE

W e only consider Si atom s in our sam ple when determ ining crystallinity. There are three reasons for this: Si and O atom s have di erent local geometry and so the analysis ism ade easier by looking only at Si-Si structure; it is computationally faster to do so; and our order param eter does not track, and therefore does not in uence, what the O atom s are doing, allowing for greater structural freedom during the constrained M C simulations.

In term s of determ ining local geom etry, the di culty arises in describing the di erent environments of Si and O atom s. In the case of NaCl, both species have the same coordination environment in the solid, and therefore can be described with one scheme. In the case of SiD<sub>2</sub>, rather than nding a way of describing SiO, O -O and SiSi bonds separately, we choose to account for Si atom s only. This is also computationally faster. We assume that the strong local stoichiom etry will persist in the growing clusters as well.

In order to de ne a crystalline cluster form ing within the liquid, we follow the procedure laid out in [7]. We need a bond order parameter that captures crystal structure. To begin with, we use spherical harm onics  $Y_{lm}$  ( $\hat{r}_{ij}$ ), where  $\hat{r}_{ij}$  is a unit vector pointing along a bond between particles i and j (and thus providing elevation and azim uth angles with respect to a xed coordinate system). For FCC and BCC crystals, l = 6 has been used, while for salt (having cubic structure), l = 4 has been used [11]. The rst step is to de ne a local quantity on the particle






FIG.12: Determ ination of characterization thresholds. We plot the probability distribution of  $c_{ij}$  values in (a) for the liquid, stishovite and the spontaneously crystallized liquid at  $T_0$  and  $V_0$ . The results in each case are averages from ve con gurations. Based on this plot, we choose a value of  $c_{cut} = 0.5$ . In (b) we plot the probability distribution of N  $^\circ$  values based on  $c_{cut}$ . At this T, stishovite appears to always have ten SiSi connections per Si. Based on this plot, we choose a value of N  $^\circ_{cut} = 5$ , at or above which a Si ion is deem ed to be crystal-like.

U sually, N<sub>b</sub> is determined via a cuto distance near the rstminimum in the radial distribution function. Ideally, FCC, BCC and HCP structures have twelve neighbors, while simple cubic has six. However, during a simulation, N<sub>b</sub> will uctuate. In the present work, instead of de ning a distance cut-o, we always choose the closest ten silicon neighbors of a given silicon atom, i.e., N<sub>b</sub> = 10 always. In stishovite, the rst Si-Sineighbor shell contains ten atom s, although the shell is split with two neighbors slightly closer than the other eight.

In Table V, we list the Q<sub>1</sub> values for l = 4, 6 and 8, for various crystal structures as well as for both the m etastable liquid and the state after the liquid has spontaneously crystallized (crystal with defects). We see that both Q<sub>6</sub> and Q<sub>8</sub> give high values form ost crystals. How – ever, l = 8 seem to be less sensitive to the value of N<sub>b</sub> chosen. In particular, for N<sub>b</sub> = 10 in the case of the sim – ple cubic structure, Q<sub>6</sub> fares m uch worse that Q<sub>8</sub>. For our study, we do not know what the structure of precritical nuclei of stishovite is, and thus we prefer to have an order parameter that is more accepting of di erent structures. Therefore, we choose l = 8

Having selected N<sub>b</sub> = 10, and l = 8, we now proceed to determ ine what a crystal-like atom is, and whether two crystal-like atom s are part of the same cluster. Having de ned  $q_{\rm h}$  in Eq.20, we can form a dot product c (1 c 1) between two neighboring Siatom siand j,

and q is the complex conjugate of q. In this way, c is determ ined for every pair of neighboring atom s. For two atom s with very similarly oriented bonding geometry, c will have a value close to unity.

The distribution of c values is plotted in Fig.12 (a) for stishovite, liquid and spontaneously crystallized liquid all at  $T_0$  and  $V_0$ . We see from the plot that very few atoms pairs in the liquid have a value greater than about 0:75, while very few atom pair in stishovite have a value less than 0:75. However, a value of c = 0.5 provides a better criterion for di erentiating between the liquid, and the spontaneously crystallized con guration. Therefore, we choose a cut-o value of  $c_{ut} = 0.5$ . A pair of neighboring atom s i and j that have  $c_{ij}$   $c_{cut}$  are considered to be connected by a crystal-like bond.

To de nea crystal-like atom , we say that the number of connections N  $^{\rm c}$  an atom possesses must be greater

than or equal to N  $_{cut}^{c}$ . To determ ine N  $_{cut}^{c}$ , we plot the distribution of N  $^{c}$  in Fig.12(b) for the same cases as for c. W e see that all atom s in the stishovite crystal have N  $^{c}$  = 10, while the distribution for the liquid vanishes near N  $^{c}$  = 5. From the plot, any value between 5 and

10 would serve to distinguish the liquid from the crystal. We choose N $_{cut}^{c}$  = 5 to be less restrictive in our choice of order parameter. Beyond this, clusters are de ned by considering connections only between crystal-like atom s.
