## Origin of Ferrom agnetism and its pressure and doping dependence in T $\frac{1}{2}$ M $n_2$ O $_7$

U sing NM TO -downfolding technique, we explore and establish the origin of ferrom agnetism in the pyrochlore system, T  $\frac{1}{2}$ M  $n_2$ O<sub>7</sub>. It is found to be driven by hybridization induced spin-polarization of the delocalized charge carriers derived from T l-s and O -p states. The mean-eld estimate of the ferrom agnetic transition tem perature, T<sub>c</sub>, estimated using computed exchange integrals are found to be in good agreement with the measurements. We nd an enhancement of T<sub>c</sub> for moderate doping with nonmagnetic Sb and a suppression of T<sub>c</sub> upon application of pressure, both in agreement with experimental ndings.

A range of compounds, mostly perovskites based on manganese oxide, have been found with astoundingly large negative magnetoresistance (MR). The search is on for materials with better MR properties, either in the form of colossalm agnetoresistance (CMR) or tunneling m agnetoresistance (TMR). Examples include systems such as double perovskites,<sup>1</sup> pyrochlores,<sup>2</sup> FeC  $r_2S_4$  and Fe0:5Cu0:5Cr2S4 chalcospinels,<sup>3</sup> layered rare-earth iodide  $G dI_2$ .<sup>4</sup> W hile work in 1950s and 1960s uncovered<sup>5</sup> the role of double-exchange (DEX) mechanism in providing a qualitative understanding of stabilization of the ferrom agnetic (FM) phase in perovskite manganites, the underlying driving mechanism for the magnetic order in diverse class of magnetoresistive materials need not be the same. Our work<sup>6</sup> on Sr<sub>2</sub>FeM oO<sub>6</sub> in the past has shown that driving mechanism acting in  $Sr_2FeM$  oO  $_6$  is neither the conventional double-exchange mechanism nor the super-exchange, instead a novelkinetic energy driven mechanism explains its unusual electronic and magnetic behavior. In the present communication, we focus on a pyrochlore m anganite  $T \downarrow_2 M n_2 O_7$ , which has a number of contrasting properties com pared to perovskite manganites. For example,  $T \downarrow M n_2 O_7$  does not have mixed Mn<sup>3+</sup> - Mn<sup>4+</sup> valences, they do not exhibit Jahn-Teller distortions in the M nO 6 octahedra, and in spite of sim ilar CMR e ect observed, both the ferro-and para-m agnetic phases show a metal-like behavior.

Since the discovery of CMR e ect in T  $\frac{1}{2}$  M  $n_2$  O  $_7$ , it has been recognized as a class of compounds that does not twithin the DEX fram ework. Nevertheless, no com m on consensus has emerged concerning the driving mechanism in this interesting class of compounds. Considering the fact that M n-O -M n bond angle in T LM n<sub>2</sub>O 7 is substantially reduced<sup>7</sup> from  $180^{\circ}$  to  $133^{\circ}$ , a value that falls in the range where a sign change of the exchange interaction from antiferrom agnetic to ferrom agnetic is expected according to G oodenough-K anam ori rule,<sup>8</sup> a ferrom agnetic superexchange picture was proposed originally.<sup>9</sup> Later on this interpretation has been questioned in view of the fact that ferrom agnetic T<sub>c</sub> is enhanced by introduction ofm oderate am ount of nonm agnetic cation like Sb in the M n sublattice<sup>10</sup> and gets suppressed by application of pressure,<sup>11</sup> contrary to the expectation based on superexchange. The extended version of super-exchange idea<sup>12</sup>

has been used to explain the ferrom agnetism in low T $_{\rm c}$  pyrochlorem aterials, making the case of T  $_{\rm k}M$   $n_2O_7$  with a much larger T $_{\rm c}$  even more intriguing. M ishra and Satpathy proposed^{13}a mechanism which is a combination of negative H und's rule energy (J\_H) driven double exchange mechanism, antiferrom agnetic super-exchange mechanism and an indirect exchange mechanism, though lacking rigorous microscopic justication for these mechanisms. In view of the enhancement of the ferrom agnetic scenario^{10} has also been suggested with antiferrom agnetic (AFM) coupling between nearest-neighbor(NN) M n ions dominated by longer-ranged FM interactions due to the frustration of the form er in the pyrochlore lattice.

G iven the diversity of disparate mechanisms for ferrom agnetism, we considered it worthwhile to study the underlying electronic structure model, responsible for magnetism within a rigorous and microscopic ab-initio theory of T  $l_2$ M n<sub>2</sub>O<sub>7</sub>. For this purpose, we have analyzed the electronic structure of T  $l_2$ M n<sub>2</sub>O<sub>7</sub>, pristine, doped with Sb and under pressure, computed within the fram ework of local spin density approximation (LSD A) of density functional theory (DFT) in terms of mun-tin orbital (MTO) based NMTO-downfolding technique. We have also computed the magnetic exchange interaction strengths from ab-initio DFT calculations.

The pyrochlore structure of general stoichiom etry  $A_2B_2O_6O^{\circ}$  can be described as two interpenetrating networks. The smaller B cations (Mn) are octahedrally coordinated by 0-type of oxygens, with the BO<sub>6</sub> octahedra sharing corners to give rise to a BO3 network composition. The cage-like hole of this network (cf. Fig. 3) contains the second network comprising of A (T 1) and  $0^{-}$ type oxygens form ing A- $0^{\circ}$  chains with a form ula A<sub>2</sub> $0^{\circ}$ . Self-consistent calculations were carried out within the fram ework of tight-binding LM TO<sup>14</sup>, for T  $l_2$ M  $n_2$ O<sub>7</sub> in F d3m symmetry. The calculation yields a net spinmoment of 2.90  $_{\rm B}$  per M n atom , consistent with the the m easured values (2.74  $_{\rm B}$  and 2.59  $_{\rm B}{}^{2,15}$  ) and the previous band-structure calculations.<sup>13,16</sup> Each M n site with a radius of 1.2 A contributes 2.57  $_{\rm B}$  , while each 1.0 A 0 sphere and each 1.5 A T1 sphere contribute 0.24 and  $0.08_{\rm B}$ , respectively.




FIG. 1: Spin-polarized LDA band-structure of T kM n<sub>2</sub>O<sub>7</sub>. The upperpanels correspond to up-spin channel and the lower panels correspond to down-spin channel. The fatness associated with the bands in each panel is proportional to the orbital character corresponding to that indicated on top of each panel.

The well-studied<sup>13,16</sup> band-structure of T  $hM n_2 O_7$ , shown in Fig. 1, may be summarized as follows. The dp hybridized band-structure extends in an energy range from about - 6 eV to 6 eV with the zero of energy set at the LSDA Ferm i level, E<sub>F</sub>. The occupied band-structure in both spin channels are dom inated by 0-p contributions (not shown in the gure). In the majority or up spin channel the upper part of the occupied manifold, starting from -2 eV is also strongly contributed by the Mn-t<sub>2a</sub> states. The crystal eld split Mn-e<sub>a</sub> states span an energy range from 1.5 eV to 4 eV overlapping with the T Ls  $O^{-}$ p hybrid bands. The alm ost full M n-t<sub>2g</sub> bands separated by a gap from M n- $e_{\alpha}$  bands produce tiny hole pockets in the majority spin channel form ed out of three almost at bands. In the minority or down spin channel, the exchange split M n-d bands are shifted up in energy by

2~eV, thereby making the M n-d states close to empty in the down-spin channel. The noticeable feature is the highly dispersive M n-t\_{2g} band hybridized with T l-s and 0°-p that crosses  $E_{\rm F}$ , producing an electron pocket in the minority spin channel. The unusually large T1 0° hybridization produces T l-0° bonding like states at the bottom of the spectrum at both spin channels spanning the energy from -7~eV to -6 eV .

The band-structure of T  $\frac{1}{2}$  M  $n_2$  O  $_7$  shows a striking sim – ilarity with that of Sr<sub>2</sub>FeM oO  $_6$  over the low to medium energy scale. In case of Sr<sub>2</sub>FeM oO  $_6$ , Fe-d states are com – pletely full in the majority spin channel, while com pletely empty M o-d states appear separated from E<sub>F</sub> by a gap of

1 eV. In the m inority spin channel the  $t_{2g}$  m anifold of the crystal eld split Fe-d bands, strongly hybridized with M o- $t_{2g}$  (and O-p), cross the Ferm i level. These bandstructure aspects suggest a strong renorm alization of the spin-splitting of the M o- $t_{2g}$  bands (or m ore precisely the M o- $t_{2g}$  O-p hybridized states) over its bare value, since M o is usually nonmagnetic with 0.1 - 0.2 eV intrinsic exchange splitting. This was explained<sup>6</sup> in terms of the

large spin splitting at the Fe site and the presence of substantial hopping between Fe and M o sites. This situation m ay be directly compared with that of T  $\lg M n_2 O_7$  with half-lled  $\lg 3d^3$  state of M n in T  $\lg M n_2 O_7$  playing the role of half-lled  $3d^5$  state of Fe in Sr<sub>2</sub>FeM oO<sub>6</sub> and the hybridized T  $lO^\circ$  state playing the role of delocalized M o-O state in Sr<sub>2</sub>FeM oO<sub>6</sub>.




FIG. 2: Positioning of various energy levels as obtained by NMTO-downfolding calculation before and after switching on the hybridization between the magnetic and nonmagnetic ions.




FIG. 3: (Color on-line) E ective  $M \circ t_{2g}$  like and T be like W annier orbital corresponding to massively downfolded NMTO Ham iltonian in the down spin channel. Shown are the orbital shapes (constant-am plitude surfaces) with lobes of opposite signs colored as red and blue.

In the following we attempt to unravel the exchange mechanism by application of NMTO-downfolding technique.<sup>17</sup> NMTO-downfolding technique provides a useful way<sup>17</sup> to derive few -orbital H am iltonians starting from a full LDA/LSDA Ham iltonian by integrating out degrees of freedom that are not of interest. This procedure naturally takes into account the renorm alization effect due to the integrated-out orbitals by de ning energyselective, e ective orbitals which serve as the W annier or W annier-like orbitals for the few -orbital H am iltonian. We employ the NMTO-downfolding technique to construct the real-space H am iltonian in the NM TO -W annier function basis for Sr<sub>2</sub>FeM oO 6 and T 1/2 M n<sub>2</sub>O 7. The O degrees of freedom for  $Sr_2FeM$  oO  $_6$  and O degrees of freedom in case of T  $\frac{1}{2}$  M  $n_2$  O  $_7$  are downfolded to de ne effective M o-O and T 1-O states respectively. The on-site m atrix elem ents of these real-space H am iltonians give the estimate of various energy level positions in absence of the hybridization between the localized magnetic (Fe or Mn) and the delocalized non-magnetic (e ective Mo-O or e ective THO) states. As illustrated in Fig. 2, the essentially non-magnetic Mo-O or T HO states with a tiny exchange splitting  $(0.2 \text{ eV})^{18}$  appear in between the exchange split Fe-d or  $M n-t_{2q}$  states<sup>19</sup>, respectively. On switching on the hybridization, as depicted in the right hand side of the level diagram in Fig. 2, the Mo-0 or THO levels get pushed up in the up-spin channel and pushed down in the down-spin channel resulting into a large, renorm alized negative spin-polarization of the mobile electron due to purely hopping interactions. The renormalized spin-splittings of the Mo-O or THO states, after switching on the hybridization, have been estim ated by massive downfolding calculations. In these calculations, only the Mo- $t_{2q}$  or TLs states have been kept active and all other degrees of freedom, including Fed or  ${\tt M}$  n-t\_{2g}, have been downfolded to take into account the hybridization induced renorm alization e ect. Fig.3 shows the W annier orbitals corresponding to massively downfolded NMTO Ham iltonian in the down-spin channel for  $Sr_2$ FeM oO<sub>6</sub> and T  $l_2$ M  $n_2$ O<sub>7</sub>. The central M o site  $(Sr_2FeM \circ O_6)$  or Tlsite  $(T \downarrow_2 M n_2 O_7)$  shows the expected M o-t<sub>2q</sub> or T l-s character, while the tail of the orbital sitting at the Fe and O sites  $(Sr_2FeM \circ O_6)$  or Mn, O and

O<sup>°</sup> sites (T  $\lg M n_2 O_7$ ) has appreciable weight shaped according to Fe+ $_{2g}$ , O-p or M n+ $_{2g}$ , O-p, O<sup>°</sup>-p symmetries indicating the basic hybridization e ect responsible for the renorm alization. This kinetic energy driven mechanism enforces a particular spin orientation of the mobile carriers with respect of that of the localized spin, thereby providing a mechanism of ferrorm agnetic ordering at the localized spin sub-lattice. This is a general mechanism and will take place whenever the nonm agnetic, partially occupied level is placed within the exchange split energy levels of the magnetic ion as was emphasized in ref20.

The above exercise demonstrates beyond any doubt that the hybridization induced negative spin-polarization mechanism similar to Sr<sub>2</sub>FeM oO<sub>6</sub> to be operative also in case of T  $\[Mm_2O_7$ . The reason that in case of T  $\[Mm_2O_7$ , T l in contrast exhibits a net positive m om ent as opposed to the ferrim agnetic spin alignment of Fe and M o states in Sr<sub>2</sub>FeM oO<sub>6</sub>, is the unusual covalency of T  $\[Mm_2O_7$ .



We now turn to estimate quantitatively the exchange interaction strengths, and therefore T<sub>c</sub>. W e com pute the exchange integrals by comparing the LSDA total energies of di erent spin con gurations to that of an e ective Heisenberg Ham iltonian constructed out of M  $n^{4+}$  spins. The network of M n ions in T  $l_2$  M  $n_2$  O  $_7$ , as shown in Table I, is an in nite three-dimensional lattice of corner-sharing tetrahedra. Such a geom etrical arrangem ent gives rise to a very high degree of frustration for AFM, NN interactions. Due to this frustration, it is not possible to satisfy the antiferrom agnetism completely, and the chosen AFM con gurations invariably have net magnetic moments. The energy di erences of all the AFM con gurations relative to FM con guration are positive, in plying FM state as the stable ground state consistent with experimental ndings.

The e ective H eisenberg H am iltonian, considering till 3NN interactions (six NN, twelve second NN and twelve third NN), can be written as,

where  $S_i$  denotes the spin-3/2 operator corresponding M n<sup>4+</sup> states at site i, and  $J_1$ ,  $J_2$ ,  $J_3$  denote the NN, 2NN and 3NN m agnetic exchange interaction strengths. For the calculation of exchange couplings, the com puted LSDA energies were tted to the m ean- eld H eisenberg m odel, which contains Ising term s of the fullH am iltonian (1). A well-known limitation of this approach is that in som e cases the result depends on the choice of spin con-

gurations. To overcom e this we obtained seven di erent estim ates of J<sub>1</sub>, J<sub>2</sub> and J<sub>3</sub> em ploying various independent combinations of ve di erent energies listed in Table I. O ur calculation gives the average estim ate of J<sub>1</sub>, J<sub>2</sub>, J<sub>3</sub> as -2.52 m eV, -0.11 m eV and 0.33 m eV with a standard deviation of 0.24 m eV, 0.06 m eV and 0.08 m eV, respectively. Substituting the estim ated values of J<sub>1</sub>, J<sub>2</sub>, J<sub>3</sub> in the mean-eld estim ate of T<sub>c</sub>:  $T_c^{m f} = \frac{S(S+1)J_0}{3k_B}$ , where

 $J_{\rm o}$ , the net e ective interaction is  $6J_1$  +  $12J_2$  +  $12J_3$ , S=3/2 and  $k_{\rm B}$  is the Boltzm ann constant, gives a  $T_{\rm c}$  of 181 K. This is a very reasonable estimate considering mean-eld overestimation and experimentally measured value of 142 K  $^2$ 

As mentioned in the beginning, magnetic properties of T 12M n2O7 exhibit interesting variations with Sbsubstitution and under pressure. We have addressed these issues within the present approach. We mention here only the salient points of our study, the details of the calculation will be reported elsewhere.<sup>22</sup> To m in ic the Sb-substitution, we have carried out calculations with eight form ula unit supercells, where 1 and 2 out of 16 M n atom s are replaced by Sb, corresponding to a doping level of 6.25% and 12.5%, respectively. Due to the slightly larger size of Sb, lattice parameters and bond lengths increase by less than 1% with no appreciable change in bond angles.<sup>10</sup> The computed electronic structure shows the overall band shapes to rem ain more or less sam e with electron doping in the strongly hybridized T | $s\{0 - p\{M n - t_{2q} \text{ conduction band in the dow n spin channel.}\}$ This causes a substantial rise in the density of states of the conduction band at  $E_F$  , from 0.2 eV  $^1$  for the undoped case to  $1.0 \text{ eV}^{-1}$  and  $1.4 \text{ eV}^{-1}$  for 6.25 % and 12.5% doped cases, respectively. W ithin the fram ework of the proposed mechanism, this is expected to lead to a strong enhancem ent of the magnetic coupling.<sup>21</sup> This is supported by our computed J's from LSDA total energy calculations, which necessarily includes the proposed kinetic energy driven exchange. The mean eld estimate of  $\rm T_{c}$  is found to be 382 K and 420 K for 6.25 % and 12.5 %doping concentrations, respectively. Though the trend is in agreem ent with the experim ental observations,  $^{10}$  the enhancem ent is grossly overestim ated, presum ably due to clustering and disordering e ects, not taken into account in the calculation.

Existing proposals for structural changes under pressure are controversial. The st paper<sup>11</sup> reported a decrease of M n-O-M n bond angle, in addition to a decrease of bond lengths. Subsequent m easurements<sup>23</sup> claim the M n-O-M n bond angle to increase. In absence of a clear consensus about the structural changes, we carried out two sets of calculations. In the structural changes, we carried out two sets of calculations. In the structure applied is assumed to be isotropic, so that only the bond

lengths are assumed to decrease. In the second set, we also changed the M n-O -M n bond angle, taken according to Fig. 2 of ref.23. Using the rst set of calculations, the mean eld estimate of T<sub>c</sub> derived from our computed  $J^0$ s, show a decrease of T<sub>c</sub> by 40 K upon 2 % change in bond lengths. In second set of calculations, where we also changed the M n-O -M n bond angle, which according to ref<sup>23</sup> for 2% decrease in bond length, increases by less than  $1^{\circ}$ , the T<sub>c</sub> is found to decrease further by 7 K<sup>24</sup>. From analysis of electronic structure, upon application of pressure, the bond lengths shorten which in turn enhances the Mn-O and THO interactions resulting into the broadening of the net band width. The more im portant e ect for the present issue, how ever, is that the delocalized T  $10^{\circ}$  e ective levels are found to shiff<sup>25</sup>. As is evident from the level diagram in Fig. 2, the strength of the hybridization between the magnetic and the nonmagnetic states depends crucially on the positioning of the various energy levels. The movem ent of the energy levels causes changes in hybridization strengths, leading to suppression in the kinetically driven magnetic interactions and hence in a reduction of T<sub>c</sub>. The sm all increase ofM n-O-M n bond angle in the second set of calculations, which is a secondary e ect on top of the former e ect, increases the antiferrom agnetic super-exchange contribution resulting into further suppression of ferrom agnetic T<sub>c</sub>.

To conclude, we have shown by means of NM TO based downfolding study that the underlying mechanism of ferrom agnetism in T  $\rm kM$   $\rm n_2O_7$  is a kinetic energy driven mechanism originally proposed for  $\rm Sr_2FeM$  oO\_6. The mean eld T\_c, estimated using computed J^0s is in good agreement with experiments. For T  $\rm kM$   $\rm n_2O_7$  moderately doped with Sb, we found an enhancement in T\_c and on application of pressure, T\_c is found to decrease, both in agreement with experimental observations. The microscopic origin of these changes in T\_c are found to be dominantly due to changes in the magnetic interaction strengths arising from the proposed kinetically-driven mechanism .

tively, which overestim ates the experim entalestim ate of -1.6 { -1 K/GPa. However, it is necessary to clarify the experim ental scenario in terms of precise structural determination. If M n-O-M n bond angle indeed decreases as was suggested in the rst paper, then the theoretical estimate of dT  $_c$ /dP will be closer to experim ental value.

 $^{25}$  The energy level positions obtained by NMTOdownfolding technique show a shift of T1O derived states relative to Mn-t2g by +0.3 eV on applying the pressure. This energy shift more than compensates for the slight increase in the hopping interaction due to the 0.07 A compression in Mn-T1bond length.
