# Form ation of bright $m$ atter-w ave solitons during the collapse of B ose $\{E$ instein condensates

#### Abstract

W e observe bright $m$ atter-w ave solitons form during the collapse of ${ }^{85} \mathrm{Rb}$ condensates in a threedim ensional magnetic trap. The collapse is induced by using a Feshbach resonance to suddenly sw itch the atom ic interactions from repulsive to attractive. $R$ em nant condensates contain ing several tim es the critical num ber of atom $s$ for the onset of instability are observed to survive the collapse. U nder these conditions a highly robust con guration of solitons form s such that each soliton satis es the condition for stability and neighboring solitons exhibit repulsive interactions.

Bose\{E instein condensates (BEC s) w ith tunable interatom ic interactions have been the sub ject of intense theoretical and experim ental interest in recent years. $M$ any aspects of these system s are now well understood. H ow ever, severalquestions rem ain pertaining to the response of the BEC to a sudden change in the nature of the interactions from repulsive to attractive. Resolving such questions is critical if a com plete understanding of these basic atom ic system $s$ is to be developed and if related, more com plex phenom ena, such as the form ation ofm olecular BECs and super uidity in degenerate Ferm isystem $s$, are to be thoroughly explained.

The $m$ acroscopic wave function of an atom ic BEC obeys a nonlinear Schrodinger equation, known as the G ross $P$ itaevskii (G P ) equation. The nonlinearity results from the interatom ic interactions w hose nature and $m$ agnitude are described by the s\{w ave scattering length (a). H om ogeneous condensates in free space are inherently unstable when the interactions are attractive ( $a<0$ ). H owever, in a ham onic trapping potential, the zero\{ point kinetic energy can stabilize the condensate provided the num ber of atom $s$ in the BEC $\left(\mathbb{N}_{0}\right)$ is less than a critical value $\left(\mathbb{N}_{\text {critical }}\right)$ :

$w$ here $a_{h}$ o is the $m$ ean harm onic oscillator length which characterizes the kinetic energy in the trap, and $k$ is a dim ensionless constant known as the stability coe cient. $T$ he exact value of $k$ depends on the ratio of the trap frequencies [1] [1] and for our trap we have $m$ easured it to be $\mathrm{k}=0: 46$ (6)

In the vicinity of a Feshbach resonanœe, a depends sensitively on the $m$ agnitude of an extemally applied $m$ agnetic eld $\left[\begin{array}{l}\overline{3} \\ \hline 1\end{array}\right.$ sign of the atom-atom interactions to be tuned to any
value. W e have previously exploited such a resonance in ${ }^{85} \mathrm{Rb}$ to investigate the collapse of the condensate follow ing a sudden change in the nature of the interactions from repulsive to attractive [id]. The resulting dynam ics of the imploding \Bosenova" were both fascinating and unexpected. M ost notable was our observation of an anisotropic burst of atom $s$ that explodes from the condensate during the early stages of collapse, leaving behind a highly excited rem nant condensate that survives for $m$ any seconds. Curiously, we frequently observed that the num ber of atom $s$ in the rem nant condensate, $\mathrm{N}_{\text {rem nant, }}$ was signi cantly greater than N critical. It wasn't understood why this rem nant BEC didn't undergo further collapse until the num ber of atom s rem aining was less than the value of $N$ critical predicted by the GP equation. It was particularly puzzling that the stability condition in Eq. ${ }_{1}^{\prime}$ I accurately predicted the onset of the collapse, but did not seem consistent w ith num ber of atom $s$ in the rem nant. In the work presented here, we explain this result by show ing that the rem nant is com posed ofm ultiple solitons.

Solitons are localized w aves that propagate over long distances w ithout change in shape or attenuation. T he existence of solitonic solutions is a comm on feature of nonlinear wave equations. Solitons are therefore pervasive in nature, appearing in $m$ any diverse physical system s. BEC system s described by the nonlinear G P equation can support both dark (local minima in the condensate $w$ ave function) and bright (local maxim a) solitons depending on whether the interactions are repulsive $(a>0)$ or attractive ( $a<0$ ), respectively. D ark solitons have been observed in repulsive ${ }^{87} \mathrm{Rb}$ condensates $\left[\overline{I N}_{1}\right.$, 'qion, while bright solitons have been created using one-dim ensional (1D ) ${ }^{7}$ Licondensatesw ith attractive interactions $\overline{[9}, 1]$ when the attractive atom ic interactions exactly balance
the wave packet dispersion. G ap bright solitons have also been observed using ${ }^{87} \mathrm{Rb}$ condensates con ned in an optical lattice [1]. In this letter we show that during the collapse of the condensate described in ref. [6] a robust con guration of $m$ ultiple solitons form $s$ in our three-dim ensional (3-D) trap. Com parison with sim ulations show s that, rem arkably, the solitons are created w ith set relative phases such that they repel each other and oscillate in the trapping potential for $m$ any seconds w ithout degradation. Since the num ber of atom $s$ in each soliton never exceeds $\mathrm{N}_{\text {critical }}$ and the repulsive solitons never overlap, the condition for condensate stability is never violated.

The experim ental apparatus and the magnetic eld ram ps for probing the condensate collapse have been described in detail elsew here [G|, [12 densates were produced within the positive scattering length region of a broad Feshbach resonance by radiofrequency evaporation in a $m$ agnetic trap. The frequencies of the cylindrically sym $m$ etric cigar-shaped trap w ere radial $=17: 3 \mathrm{~Hz}$ and axial $=6: 8 \mathrm{~Hz}$. Condensates of up to 15000 atom $s$ were form ed with a shot-to-shot standard deviation of less than 600 atom s. The noncondensate therm al fraction was less than 500 atom s. A fter the evaporation at $162: 2 \mathrm{G}$ auss, the m agnetic eld was adiabatically increased to $165: 5 \mathrm{G}$ where $\mathrm{a}=+9 \mathrm{a}_{0}$ ( $a_{0}=0: 0529 \mathrm{~nm}$ is the B ohr radius). The collapse of the condensate was then induced by quickly sw itching the scattering length through zero to a variable negative value $a_{\text {collapse }}$ by increasing the m agnetic eld in $0: 1 \mathrm{~m} \mathrm{~s}$. A fter a variable hold time tevolve at the negative scattering length, one of tw o im aging procedures was used to interrogate the rem nant condensate. In the rst, the scattering length w as increased to a large positive value in order to use the large repulsive atom ic interaction to expand the condensate prior to the standard rapid trap tumo follow ed by absorption im aging sequence [6]|]. This procedure ensured that the size of the condensate was well above the resolution lim it of the im aging system (7 m full-w idth at halfm axim um (FW HM)), allowing the num ber of atom $s$ to be $m$ easured reliably. In the second, the $m$ agnetic trap was tumed $o$ immediately and the condensate im aged with $m$ inim um delay ( 2 m s), effectively probing the size and shape of the rem nant condensate w thout any expansion.

The number of condensate atom s surviving the collapse w as investigated as a function ofboth $a_{\text {collapse }}$ and the initial population of the condensate. The hold tim e at $a_{\text {collapse }}$ was su ciently long ( $t_{\text {evolve }}=50 \mathrm{~ms}$ ) to ensure that all collapse-related atom loss had ceased [6] ${ }_{1}$ ]. The results are plotted in Fig ${ }_{2}^{1} \overline{1}$ in as the ratio of the rem nant num ber to the critical num ber (calculated according to Eq. $1 \overline{11}$ in for each scattering length). D epending upon the conditions of the collapse, $\mathrm{N}_{\text {rem nant }}$ varied from below the critical num ber to m uch greater than the critical number (for $\mathrm{a}_{\text {collapse }}=100 \mathrm{a}_{0}$, the rem nant conden-

sate contained approxim ately 10 the critical num ber of atom s). Interestingly, the fraction of atom s surviving the collapse depends only on the scattering length and is independent of the initial num ber of condensate atom $s$ (in the rangewe investigated). $T$ his fraction varies sm oothly from $60 \%$ for $a_{\text {collapse }}$ ' $5 a_{0}$ to $30 \%$ for $a_{\text {collapse }}$ ' $50 \mathrm{a}_{0}$. The lifetim e of the rem nant condensate at $\mathrm{a}_{\text {collapse }} \mathrm{w}$ as several seconds and com parable to the lifetim e of a condensate for sm all positive scattering lengths, even for $\mathrm{N}_{\text {rem nant }}>\mathrm{N}_{\text {critical }}$.

In a separate set of experim ents, the evolution of the size and shape of the unexpanded rem nant condensate was investigated. From the im ages, the axial and radial column density distributions were calculated and tted w ith G aussian pro les to obtain both the axial and radialFW HM. The result of this analysis is shown for the (w eaker) axialdirection in $F$ ig , (a). A ny variation in the width of the rem nant condensate in the radial direction was below the resolution lim it of our im aging system. $T$ he rem nant condensate is highly excited, w ith the variation in the axialwidth being well tted by sinusoidal oscillations at the tw o low est collective m ode frequencies $(1=2$ axial and $2=2$ radial). The $m$ easured frequencies were $1=13: 67(1) \mathrm{Hz}$ and $2=33: 44$ (3) H z. The am plitude of the 2 oscillation was 29 (7)\% as large as that of the 1 oscillation and contained a signi cant contribution from the radial focus of the atom burst associated w th the collapse [G]]. There was no discemible dam ping during our 3 second observation tim e.

C lose inspection of the im ages, how ever, revealed that the observed variation in the w idth is not due to the ex-

citation of collective $m$ odes. T he rem nant condensate is observed to separate into two (or m ore) distinct clouds which we associate w ith solitons ( $F$ ig ${ }^{2}$, served oscillation in the axialw idth of the rem nant then results from the oscillation of two solitons along the axial direction of the trap. A s w as observed for the solition trains created in the ${ }^{7}$ Liexperim ents [id], neighboring solitons form w ith a relative phase, , that ensures that they interact repulsively ( $=2 \ll 3=2$ ) even though the atom ic interactions are attractive $[1]$ the solitons do not pass through each other at the center of the trap, but rather rebound o one another. C onsequently, as the solitons never fully overlap, the critical density for collapse is never reached and the solitons re$m$ ain stable. This conclusion is supported by the observation that the soliton structures persist for over three seconds ( F ig. $\overline{\mathrm{Z}} \mathrm{I}(\mathrm{l})$ ) w ith only a sm all degradation in the quality of the im ages due to the presence ofm ore them al atom $s$ as the condensate $m$ elts. T he solitons collide over 40 tim es during this period. Several authors propose that bright $m$ atter $w$ ave solitons form due to a m odulation in-
 previous observations of local spikes' in the condensate density [ [6] $]$ are consistent $w$ ith this $m$ echanism.

The num ber of solitons that form depends both on the m agnitude of $\mathrm{a}_{\text {collapse }}$ and the initial num ber of condensate atom $s$. In $F$ ig. ${ }_{1}^{2} 1 \mathbf{1}, \mathrm{w}$ e present im ages and cross sections show ing tw ○ (F ig. $\overline{12} 1$

$T$ hese im ages $w$ ere acquired $w$ ith $t_{\text {evolve }}=200 \mathrm{~m} \mathrm{~s}$, w hen the axial width was a maxim um and the solitons were m axim ally separated. For com parison, Fig a rem nant condensate for which the num ber of rem nant atom $s$ w as below the critical num ber. U nder these conditions the rem nant w as never observed to separate into two or m ore solitons. W e have observed up to six solitons present ( $F$ ig '3 ${ }_{1}^{\prime}$ ' (d)). H ow ever, the quality of the in ages was signi cantly reduced when $m$ ore than three solitons were present because the spacing betw een solitons becam e com parable to the im aging resolution lim it. In F ig. sam e num ber of atom $s$. This w as not alw ays the case, how ever, and we often observed an unequaland (usually) sym $m$ etric population distribution across the solitons.

In $F$ ig $\overline{4} \overline{4}$ we exam ine in $m$ ore detail the conditions under which multiple solitons form. For a xed initial number of atom $s$ in the condensate $\left(\mathbb{N}_{0}\right.$ 8000), the num ber of solitons created was investigated as a function of $a_{\text {collapse }}$. The im ages were again acquired with
 tons is plotted. T he data show a gradual increase in the num ber of solitons as them agnitude of $a_{\text {collapse }}$ increases. $T$ he ratio of the num ber of rem nant condensate atom $s$ to

the critical number for the same $\mathrm{N}_{0}$ is also plotted in Fig. $\overline{4} 1 \mathbf{1}(\mathrm{a})$. This ratio exhibits the sam e general trend as a function of $a_{\text {collapse }}$ as the observed num ber of solitons. M ost im portantly, it never exceeds the num ber of solitons. From this observation we deduce that the num ber of atom $s$ in each soliton is alw ays less than or equal to the critical num ber. E ach soliton is therefore stable against collapse, explaining the unexpected stability of rem nant condensates for which the number of atom $s$ is greater than the critical num ber. This point is further illustrated in $F$ ig $\frac{14}{4}(b)$ where the ratio of the num ber of rem nant condensate atom sto the critical num ber is plotted against the observed $m$ ean num ber of solitons. A 11 the points lie on or below the critical condition de ned by Eq, $1_{1}^{11}$ (dashed line).

In contrast to the previous observations of bright soli-
 experim ents were perform ed in a 3D trap w ith an aspect
ratio of radial= axial $2: 5$. U nder such conditions, 3D bright solitons are predicted to be stable only if the attractive atom ic interaction is sm aller than a critical value [1]ilil, consistent w ith our observations. Sim ulations of our experim ent based on a num erical integration of the 3D GP equation show that multiple solitons are only stable provided they interact repulsively [1]]. A ttractive interactions betw een the solitons w ould lead to energetic excitations of the soliton w ave function during each bollision' (in this case the solitons pass through one another), and ultim ately a loss of particles from the BEC.M oreover, when the relative phase betw een solitons is xed at in the sim ulation, the $m$ axim um number of solitons that is predicted to be stable at a particular scattering length is in good agreem ent w ith our observations shown in $F$ ig $\frac{14}{2}$.
$T$ he sudden change in the nature of the atom ic interactions in a Bose\{E instein condensate from repulsive to attractive leads to a violent collapse process, in which a signi cant proportion of the initial condensate is ejected in a highly energetic burst. Yet, surprisingly, out of this violent explosion em erges a robust con guration of solitons that preserves a large fraction of the initial condensate population. It is particularly striking that this behavior holds over a large range of attractive interaction strengths.
