Corrections to scaling in multicom ponent polymer solutions

A bstract

We calculate the correction-to-scaling exponent  $!_T$  that characterizes the approach to the scaling limit in multicomponent polymer solutions. A direct M onte C arbo determination of  $!_T$  in a system of interacting self-avoiding walks gives  $!_T = 0.415 - 0.020$ . A eld-theory analysis based on veland six-loop perturbative series leads to  $!_T = 0.41 - 0.04$ . We also verify the renormalization-group predictions for the scaling behavior close to the ideal-mixing point.

### I. IN TRODUCTION

The behavior of dilute or sem idilute solutions of long polym ers have been investigated at length by using the renormalization group,  $^{1}$  which has explained the scaling behavior observed in these systems and has provided quantitative predictions that become exact when the degree of polymerization becomes in nite. Most of the work has been devoted to binary systems, i.e. to solutions of one polymer species in a solvent. The method, however, can be extended to multicomponent polymer systems, i.e. to solutions of several chemically dierent polymers. The general theory has been worked out in detail in Refs. 4{6. In the good-solvent regime in which polymers are swollen, the scaling limit does not change. For instance, the radius of gyration  $R_g$  increases as  $N_g$ , where  $^{7,8}$  0.5876 and  $N_g$  is the length of the polymer. However, the presence of chemically dierent polymers gives rise to new scaling corrections in quantities that are related to the polymer-polymer interaction. In the dilute regime one may consider, for instance, the second virial coecient  $R_g$  between two polymers of dierent species. Its scaling behavior is  $^{4}$ 66

where  $R_{g;1}$  and  $R_{g;2}$  are the gyration radii of the two polymers, A, A, A, A are functions of  $R_{g;1}=R_{g;2}$ , and  $P_T$ ,  $P_T$  are correction-to-scaling exponents. Eq. (1.1) is valid for long polymers in the good-solvent regime; more precisely, for  $N_1$ ;  $N_2$ ! 1 at xed  $N_1=N_2$  (or, equivalently, at xed  $R_{g;1}=R_{g;2}$ ), where  $P_T$  and  $P_T$  are the lengths of the two polymers. The exponent  $P_T$  is the one that controls the scaling corrections in binary systems. The most accurate estimate of the exponent so far yields  $P_T$  =  $P_T$  = 0.517 0.007  $P_T$  0.000, corresponding to  $P_T$  = 0.880 0.012  $P_T$  0.000. The exponent  $P_T$  is a new exponent that characterizes multicom ponent systems. Perturbative calculations  $P_T$  indicate that  $P_T$  is quite small,  $P_T$  0.4. Thus, scaling corrections decrease very slow by in multicom ponent systems and can be quite relevant for the values of  $P_T$  and  $P_T$  that can be attained in practice. Therefore, the determination of the scaling behavior in multicom ponent systems may require extrapolations in  $P_T$  and  $P_T$  which, in turn, require a precise knowledge of the scaling exponents.

In this paper we improve the previous determinations  $^{9,6}$  of  $!_T$ . First, we extend the perturbative three-loop calculations of Ref. 6. We analyze the ve-loop expansion of  $!_T$  in powers of d=4, d being the space dimension, and the six-loop expansion of  $!_T$  in the xed-dimension massive zero-momentum (MZM) scheme. Second, we compute  $!_T$  by numerical simulations. For this purpose we consider interacting self-avoiding walks and compute the second virial coecient. A careful analysis of its scaling behavior provides us with a estimate of  $!_T$ . We also consider the ideal-mixing point where the interaction between the two different chemical species vanishes. A renormalization-group analysis of the behavior close to this point was presented in Ref. 6. An extensive Monte Carlo simulation allows us to verify the theoretical predictions.

The paper is organized as follows. In Sec. II we present our renormalization-group calculations. In Sec. III we determ ine the correction-to-scaling exponent by means of a Monte Carlo simulation. In Sec. IV we discuss the ideal-mixing point where the elective interaction between the two chemically dierent species vanishes. Conclusions are presented in Sec. V.

# II. PERTURBATIVE DETERM IN ATION OF !T

The starting point of the calculation is the Landau-G inzburg-W ilson Ham iltonian6

where  $_1$  and  $_2$  are n-component elds. A susual, the polymer theory is obtained in the limit  $n \cdot ! = 0$ . In this special case, the xed-point structure of the theory is particularly simple and is explained in detail in Ref. 6. The exponent  $!_T$  can be computed directly in the O (n = 0) '  $^4$  m odel. Indeed, as discussed in Ref. 6,  $!_T = y_4$ , where  $y_4$  is the renormalization-group dimension of  $\frac{2}{1}$   $\frac{2}{2}$  in the symmetric theory with  $u_0 = v_0 = w_0$ . It corresponds to an O (2n) vector theory and, for n ! 0, one is back to the O (n = 0) '  $^4$  m odel. Using the results of Ref. 10 one can also show that, for n ! 0,  $\frac{2}{1}$   $\frac{2}{2}$  is a spin-4 perturbation of the O (2n) m odel and thus  $y_4$  is the renormalization-group dimension of the cubic-symmetric perturbation  $\frac{P}{a}$ '  $\frac{4}{a}$  of the O (n = 0) '  $^4$  m odel. Thus, one can use the perturbative expansions reported in Refs. 11 and 12. The expansion of  $!_T$  is

At order  $^3$  it agrees with that given in Ref. 6. In the  $\,$  xed-dim ension M ZM  $\,$  scheme we have at six loops

where g is the four-point zero-m om entum renormalized coupling normalized so that  $(g) = g + g^2 + O(g^3)$ , as used in, e.g., Ref. 13; the xed point corresponds to  $14^{18}$  g = 1.40 0.02. In order to obtain quantitative predictions, the perturbative series must be properly resummed. We use here the conformal-mapping method 13;19 that takes into account the large-order behavior of the perturbative series.

From the standard expansion we obtain in three dimensions ( = 1)  $\frac{1}{1}$  = 0.42 0.04, while in the xed-dimension M ZM scheme we nd  $\frac{1}{1}$  = 0.37 0.04. Using the pseudo-expansion, Ref. 20 obtained  $\frac{1}{1}$  = 0.380 0.018 in the M ZM scheme. Though compatible, the M ZM result is lower than the -expansion one. This phenomenon also occurs for other exponents and is probably related to the nonanalyticity of the renormalization-group functions at the xed point.  $\frac{14}{21}$ ;  $\frac{15}{16}$ 

A more precise estimate is obtained by considering  $!_T$  !=2. The perturbative expansion of has smaller coe cients than that of  $!_T$  and thus can be determined more precisely. Its expansion is

The term proportional to is missing, while the other coe cients are smaller by a factor of 5-10 approximately. Similar cancellations occur in the MZM scheme:

where the error should be quite conservative.

### III.M ONTE CARLO RESULTS

In order to determ ine  $!_T$  num erically, we consider lattice self-avoiding walks (SAW s) with an attractive interaction between nonbonded nearest-neighbor pairs. If =kT is the reduced inverse temperature, this model describes a polymer in a good solvent as long as < , where 0.269 corresponds to the collapse transition. We consider two walks with dierent interaction energies  $_1$  and  $_2$ , i.e. with dierent  $_1$  and  $_2$ . We assume  $_1$ ;  $_2$ < , so that both walks are in the good-solvent regime. Then, we consider the second virial coe cient

where the statistical average is over all pairs of SAW s such that the first one starts at the origin, has N<sub>1</sub> steps, and corresponds to an inverse reduced temperature  $_1$ ; the second one starts at r, has N<sub>2</sub> steps, and corresponds to an inverse reduced temperature  $_2$ . Here H (1;2) is the reduced interaction energy: H (1;2) = +1 if the two walks intersect each other; otherwise, H  $(1;2) = _{12}$ N  $_{nnc}$ , where N  $_{nnc}$  is the number of nearest-neighbor contacts between the two walks and  $_{12}$   $_{12}$ =kT is the reduced inverse temperature. In order to generate the walks we use the pivot algorithm  $^{24}$ {28 with a M etropolis test, while the second virial coe cient is determined by using the hit-or-miss algorithm discussed in Ref. 29. We study the invariant ratio

where f(x) is universal. This applies for  $_1$ ;  $_2$  < and, as we shall see, for  $_{12}$  su ciently small. Note that all the dependence on the inverse temperatures is encoded in a function of a single variable. Moreover, f(x) is also the scaling function associated with a polymer

solution made of two dierent types of polymers that have the same chemical composition (hence  $_1 = _2 = _{12}$ ) but dierent lengths. In that case  $R_g(N_2; _2) = R_g(N_1; _1) = (N_2 = N_1)$ , so that Eq. (3.3) in plies that  $A_2(N_1; N_2; ; ; ) = g(N_1 = N_2)$ , with g(x) = f(x) universal. The function f(x) satisfies the condition f(x) = f(1=x) and de Gennes' relation f(x) = f(x).

We will be interested here in the corrections to Eq. (3.3). In the scaling lim it we can write

where  $R_g(N_2; 2)=R_g(N_1; 1)$ ,  $x=[R_g(N_2; 2)R_g(N_1; 1)]^{1-2}$ , and we have neglected the contributions of the additional correction-to-scaling operators with renormalization-group dimensions  $!_i$ . They give rise to additional corrections proportional to  $x^p$ ,  $p=n!_T+m!_+P_{n_i}!_i$ . Little is known about  $!_i$ , though we expect them to satisfy  $!_i > !_T$ ,  $!_i > !_T$ . In the following we will assume that all such exponents satisfy  $!_i & 3!_T = !_T + !_T$ . The scaling functions  $g_{nm}$  ( ) are universal once a special normalization has been chosen. We have simulated two SAW swith  $_1 = 0.05$  and  $_2 = 0.15$ , two values that are well within the good-solvent region. Then, we have computed  $A_2$  for  $100 \, N_1 = N_2 \, 64000$  and several values of  $_{12}$  in the range  $0 \, _{12} \, 0.30$ . The results are plotted in Fig. 1. For  $_{12} < 0.25$ , as  $N = N_1 = N_2$  increases, the estimates of  $A_2$  tend to become independent of  $_{12}$  although the convergence is very slow. The behavior changes for  $_{12} \& 0.25$  and indeed the data indicate that  $A_2 = 0$  for  $N + 1 \, \text{for some} \, e_{12} = \, e_{12}$  slightly larger than 0.25. This value corresponds to the case in which the short-distance repulsion is exactly balanced by the solvent-induced attraction proportional to  $_{12}$ . In eld-theoretical terms, this means that the renormalization-group ow is no longer attracted by the symmetric xed point discussed in Sec. II, but rather by the unstable xed point with w = 0. Thus, at  $w = 12 \, \text{mass} \, \text{mass$ 

becomes negative signalling demixing. The behavior of  $A_2$  does not change signicantly if  $_1$  and  $_2$  are varied. In Fig. 2 we report results for shorter walks for dierent pairs of  $_1$  and  $_2$ , and also for walks with  $N_1 = 4N_2$ . Note that  $_{12;c}$  depends very little on the parameters  $_1$  and  $_2$ .

In order to determ ine  $!_T$ , we have considered the data with  $_{12} = 0;0:05;0:10;0:15$  that are su ciently far from the critical value  $_{12;c}$ . We perform ed a t that is linear in  $!_T$

where  $_{12}=0.95;0.10;0.15$ . The exponents  $!_a$  and  $!_b$  should take into account the additional scaling corrections. Since  $2!_T$   $!_a$ , we should have  $!_a$   $!_T$   $!_T$ . U sing the eld-theory estimate of  $!_T$  and  $!_a$  0.38 0.03 (Ref. 7), it should be safe to take  $^{31}$   $!_a$  = 0.43 0.06. As for  $!_b$  we should have  $!_b$   $2!_T$   $!_a$ . Moreover, there is also the possibility that there exists an additional correction exponent  $!_a$  not very much different from  $3!_T$ , which would contribute a correction with exponent  $!_a$  1. For this reason we have taken  $!_b$  = 0.85 0.20. The error should be large enough to include all possibilities. The results are reported in Table I. The systematic error reported there gives the variation of the estimate as  $!_a$  and  $!_b$  vary within the reported errors. The results with  $N_{min}$  = 250 and 500 are compatible within errors and thus we can take the estimate that corresponds to  $N_{min}$  = 500 as our nal result. To be conservative, however, the error bar takes also into account the possibility that the observed small trend is a real one. If the neglected corrections are of order  $x^{-3!_T}$  we expect the results to depend on  $N_{min}$  as  $N_{min}^{-3}$ . This implies that the estimate of  $!_T$  can decrease at most by 0.005 when  $N_{min}$  is further decreased. This leads to the result

where  $_{\rm T}$  =  $!_{\rm T}$  . The results are reported in Table I. They agree with those obtained before and allow us to estimate the universal constant  $A_2$   $A_2$  = f() for 124; f() is de ned in Eq. (3.3)]:  $A_2$  = 5:495 0:020.

### IV. IDEAL-MIXING POINT

In this section we consider the behavior close to the ideal-m ixing point (MP)  $_{12,c}$  where the electric interaction between the two chemically different species vanishes. The renormalization-group analysis is presented in Ref. 6. The behavior is controlled by an unstable xed point characterized by an unstable direction with renormalization-group dimension  $y_{\rm I} = 2$  and by a stable direction with exponent !, where! 0:88 is the usual correction-to-scaling exponent. These results imply that close to the IMP a renormalization-group invariant quantity R (for instance, the invariant ratio  $A_2$  introduced above) scales as

In this section we wish to verify this scaling behavior for the second virial coe cient. For this purpose we have made simulations for six dierent pairs of  $_1$  and  $_2$  with N $_1$  = N $_2$  and 0.25  $_{12}$  0.28. The critical value  $_{12;c}$  can be characterized by requiring  $A_2$  (N ! 1;  $_1$ ;  $_2$ ;  $_{12;c}$ ) = 0. where  $g_R$  (b; ) vanishes at the IM P b = 0. Eq. (4.6) is more suitable for a numerical check close to the IM P than Eq. (4.2), since scaling corrections vanish at the IM P and are therefore small close to it. In the following we verify numerically predictions (4.5) and (4.6).

In Fig. 3 we show  $^{\rm e}_{12;c}$  (N) vs N  $^{!}$  for three dierent pairs of  $_{1}$  and  $_{2}$ . The data show a quite good linear behavior: only the two points corresponding to N = 2000 and 4000 are in some cases of the linear t, probably because our sampling is not yet adequate for these large values of N. These results allow us to obtain  $_{12;c}$ :

Note that the dependence on 1 and 2 is tiny.

Then, we verify Eq. (4.6). In Fig. 4 we report  $A_2$  vs the scaling variable ( $_{12}$   $_{12\kappa}^{\rm e}$ )N for different  $_1$ ,  $_2$ . All points with 100 N 1000 fall on top of each other confirming the scaling behavior predicted by the renormalization group. The scaling functions depend on  $_1$  and  $_2$  through the ratio  $_1$ . Moreover, one should also take into account that the scaling variable is only defined up to an arbitrary prefactor. We now show that the dependence on is tiny for the range of values of we have considered, since all data with different values of N,  $_1$ , and  $_2$  fallon a single curve once one takes as scaling variable R ( $_1$ ;  $_2$ ) ( $_{12}$   $_{12\kappa}^{\rm e}$ )N, where R ( $_1$ ;  $_2$ ) is a properly chosen constant that depends on  $_1$  and  $_2$ . This is evident in Fig. 5, where we report data with different  $_1$  and  $_2$ . We only consider N = 500 for clarity, since we have already verified that data with different values of N show the predicted scaling. The scaling is very good, indicating that the dependence is negligible. If we choose R (0.05; 0.10) = 1 the scaling curve can be parametrized as  $A_2 = 19.773x - 46.457x^2$ , with x = R ( $_1$ ;  $_2$ ) ( $_{12}$   $_{12\kappa}^{\rm e}$ )N. Finally, note that R ( $_1$ ;  $_2$ ) does not depend very much on  $_1$  and  $_2$ . For instance, R (0.15; 0.20)=R (0.05; 0.10) 0.38.

# V.CONCLUSIONS

In this paper we have considered the corrections to scaling expected in multicomponent polymer solutions. A high-precision M onte Carlo simulation with very long walks, up to N=64000, gives  $!_T=0.415-0.020$ . This estimate is consistent with the estimate  $!_T=0.41-0.04$  obtained by using the perturbative renormalization group. Previous perturbative renormalization-group calculations gave  $!_T=0.37$  (Ref. 9) and  $!_T=0.40$  (Ref. 6): they substantially agree with our estimate. On the other hand, the numerical result  $!_T=0.35$  obtained by exploiting the relation between  $!_T$  and the growth exponent for four-arm star polymers seems slightly too small.

One should note that !  $_{\rm T}$  is quite small and thus convergence may be quite slow. For instance, in the case we have considered numerically,  $A_2=5:495-0:020$  for N! 1. On the other hand, for  $_{12}=0$  (resp.  $_{12}=0:15$ ) we nd  $A_2=5:790-0:005$  (resp.

 $A_2 = 5.232$  0.005) for  $N = N_1 = N_2 = 64000$ . Even if the walks are very long, there is still a 5% discrepancy. For N = 1000, di erences are larger, approximately of 15%.

In order to obtain a better qualitative understanding of the corrections we have also perform ed additional simulations. The results are reported in Fig. 2. The qualitative behavior is very similar in all cases and almost independent of  $_1$  and  $_2$ . In particular, corrections appear to vanish in all cases for 0.05.  $_{12}$ . 0.10 and to increase strongly for  $_{12}$  & 0.20. Morever,  $_{12,c}$  is always close to  $_1$ , and shows a tiny dependence on  $_1$  and  $_2$ .

The discussion presented here addressed the behavior of multicom ponent solutions, but it should be noted that the results are also relevant for copolymers in which chemically dierent polymers are linked together. A lso in this case scaling corrections with exponent  $!_T$  are present.

Finally, we have also considered the behavior close to the ideal-m ixing point, where there is no e ective interaction between the two chem ically dierent polymer species. Our numerical results are in very good agreement with the renormalization-group predictions of Ref. 6.





FIG. 1. Invariant ratio  $A_2$  for  $_1 = 0.05$ ,  $_2 = 0.15$  vs  $_{12}$  for several  $N = N_1 = N_2$ . The two gures di er only by the vertical and horizontal scales. Lines connecting points with di erent  $_{12}$  are only intended to guide the eye.




FIG.3. Finite-N ideal-m ixing point  $^e_{12;c}$  vs 1=N  $^{!+}$  for three dierent pairs of  $_1$  and  $_2$ . The line corresponds to the t  $^e_{12;c}$  =  $_{12;c}$  + a=N  $^{!+}$  .








FIG.4. Invariant ratio  $A_2$  vs ( $_{12}$   $_{12;c}^e$ )N for three dierent pairs of  $_1$  and  $_2$ .




FIG.5. Invariant ratio A  $_2$  vs R (  $_{12}$   $_{12;c}^{\rm e}$ )N for N = 500. We report results corresponding to six di erent pairs of  $_1$  and  $_2$ .
