Correlation in the transition metal based Heusler compounds Co<sub>2</sub>M nSiand Co<sub>2</sub>FeSi

A bstract

Half-m etallic ferrom agnets like the full Heusler compounds with formula X2YZ are supposed to show an integer value of the spin magnetic moment. Calculations reveal in certain cases of X = Co based compounds non-integer values, in contrast to experiments. In order to explain deviations of the magnetic moment calculated for such compounds, the dependency of the electronic structure on the lattice param eterwas studied theoretically. In local density approximation (LDA), the minimum total energy of Co<sub>2</sub>FeSi is found for the experimental lattice parameter, but the calculated magnetic moment is about 12% too low. Half-metallic ferrom agnetism and a magnetic m om ent equal to the experim ental value of  $\theta_B$  are found, however, only after increasing the lattice param eter by m ore than 6%.

To overcom e this discrepancy, the LDA+U scheme was used to respect on-site electron correlation in the calculations. Those calculations revealed for Co2FeSi that an elective Coulomb-exchange interaction  $U_{\mathrm{eff}} = U$  J in the range of about 2eV to 5eV leads to half-m etallic ferrom agnetism and the measured, integer magnetic moment at the measured lattice parameter. Finally, it is shown in the case of Co2M nSi that correlation may also serve to destroy the half-metallic behavior if it becomes too strong (for Co2M nSiabove 2eV and for Co2FeSiabove 5eV). These indirected that on-site correlation may play an important role in the description of Heusler compounds with localized m om ents.

#### I. INTRODUCTION

Halfm etallic ferrom agnetism was rst predicted for the halfH eusler compound N iM nSb by de G root et all. A halfm etallic ferrom agnet is a material with a gap between spin states at the Ferm i energy ( $_F$ ), such that the majority states are conducting and the minority states are sem i-conducting. Halfm etallic ferrom agnets (HMF) are supposed to exhibit a real gap in the minority (or majority) density of states (DOS). This gap has in compounds with integer site occupancies the consequence that the magnetic moment has to be an integer, because the number of occupied minority states is integer. It should be noted that the HMF character is lost if an already small deviation from an integer value is observed.

Certain  $X_2YZ$  Heusler compounds have also been predicted to show half-metallic ferrom agnetism  $^2$ . Co and M n containing Heusler compounds have attracted particular attention, as they are strongly ferrom agnetic with high Curie temperatures (above 900K) $^3$ . One of them  $-Co_2M$  nSi-is an attractive candidate form any applications in spin dependent electronics. This compound was used by several groups to produce thin  $\lim_{n \to \infty} s^{4,5,6,7,8,9}$  and devices  $^{10,11}$ . It was recently shown that  $Co_2FeSi$  is also a very good candidate as it exhibits a very high Curie temperature of 1100K and a magnetic moment of  $^6$  B  $^{12}$ . This compound is somewhat peculiar regarding its Curie temperature and magnetic moment of magnetic moment because both are reaching the highest values observed up to now in this class of materials.

In Heusler as well as other compounds, the half-metallic ferrom agnetism has not yet been unambiguously con med by experiments, although there is strong evidence in some cases. Despite a lot of work on Co and Mn containing Heusler compounds<sup>5,13,14,15,16,17,18,19,20,21,22</sup>, a breakthrough is still required to prove the existence of halfmetallic ferrom agnetism in these materials.

The electronic structure plays an important role in determining the magnetic properties of the Heusler compounds. In this work, a comprehensive investigation of the equilibrium structural, electronic and magnetic properties of  $Co_2FeSi$  is presented and compared to  $Co_2M$  nSi. The dependence of the magnetic moment on the lattice parameter was analyzed, focusing on the dierences between LSDA (local spin density approximation) and GGA (generalized gradient approximation) treatments. A series of calculations for  $Co_2$  based Heusler compounds was performed which shows that mostly all  $Co_2$  based Heusler compounds exhibit half-metallic ferromagnetism<sup>23</sup>, in agreement with Ref.<sup>24</sup>. The Slater-Pauling rule<sup>12,24,25,26,27</sup>

ts for most  $Co_2$  based Heusler compounds and may be used as a rule of thumb for estimating their magnetic moments. A coording to this rule the magnetic moment of  $Co_2FeSi$  is expected to be 6 B per unit cell.

This work was stimulated by a recent experimental study that was devoted to the magnetic moment and Curie temperature of the  $Co_2FeSi$  compound<sup>12</sup>. To provide a concise picture of the  $Co_2YSi$  systems (Y = Mn, Fe), a theoretical investigation will be presented utilizing the local (spin) density approximation (L(S)DA), GGA, and LDA+U methods.

#### II. COM PUTATIONAL DETAILS

Heusler compounds belong to a group of termary intermetallics with the stoichiom etric composition  $X_2YZ$  ordered in an  $L2_1$ -type structure, space group F m  $\overline{3}m$ , many of which are ferrom agnetic  $^2$ . Remarkably, the prototype  $Cu_2M$  nAlis a ferrom agnet even though none of its constituents is one  $^3$ . In general, the X and Y atoms are transition metals and Z is a main group element. In some cases Y is replaced by a rare earth element. The X atoms are placed on 8a (1/4,1/4,1/4) W yoko positions and the Y and Z atoms on 4a (0,0,0) and 4b (1/2,1/2,1/2). The cubic  $L2_1$  structure consists overall of four interpenetrating for lattices, two of them equally occupied by X. The latter two  $X_2$  for sub-lattices combine to a simple cubic sub-lattice. Thus, the, compound may be seen as a CsCl (B2) superstructure with the cubic vacancies of the  $X_2$  sub-lattice led alternatingly by Y or Z atoms. Other than in a simple CsCl structure, the nearest neighbor polyhedra of each X atom are given by two different tetrahedra (rotated by 90 with respect to each other) that are built from either Y or Z atoms. The point of the param agnetic structure has the symmetry  $O_h$ . However, the wave functions at the point have to be described by  $C_{4h}$  in the ferromagnetic state to account for the correct transformation of the electron spin.

Self-consistent band structure calculations were carried out using the full potential linear augmented plane wave (FLAPW) method as provided by P.Blaha et al (Wien2k) $^{31}$ . The calculations were performed using the von Barth-Hedin $^{32}$  parametrization of the exchange-correlation functional within LDA. Further, the Perdew-Burke-Emzerhof $^{33}$  implementation of GGA was used. GGA accounts specifically for density gradients that are neglected in pure L(S)DA. The energy threshold between core and valence states was set to -6Ry. We considered  $2.3a_{Bohr}$  for the mun-tin radii (R<sub>MT</sub>) of all atoms leading to nearly touching

spheres. 455 irreducible k points of a 25  $\,$  25 m esh, were used for Brillouin zone integration. The number of plane waves was restricted by R<sub>M T</sub>  $\,$  k<sub>m ax</sub> = 7. The energy convergence criterion was set to 10  $^5$ . Sim ultaneously, the charge convergence was monitored and the calculation was restarted if it was still above 10  $^3$ .

Finally, the LDA+U m ethod  $^{34}$  was used to account for on-site correlation at the transition m etal sites. The LDA+U m ethod accounts for an orbital dependence of the Coulomb and exchange interaction that is absent in pure LDA. Here, the elective Coulomb-exchange interaction ( $U_{\rm eff} = U = J$ ) was used for the calculations. This particular scheme is used in W ien2k to include double-counting correction. One leaves the framework of density functional theory (DFT) by applying the LDA+U method. However, it is one of the most popular and easiest approaches to consider electron-electron correlation. It will be shown that the LDA+U method gives qualitative and quantitative improvements compared to the bare LDA or GGA approaches, when applied to Co<sub>2</sub>FeSi.

## III. RESULTS AND DISCUSSION

The main focus was put on the magnetic moment as this shows a very strong discrepancy if comparing the experimental and calculated values reported for Co<sub>2</sub>FeSi. Niculescu et al<sup>35</sup> reported already a magne, tic moment of 5.9 per unit cell at 10K, whereas band structure calculations using the screened Korringa-Kohn-Rostocker method (KKR) predicted later only 5.27 pc al The present LSDA calculations (FLAPW) revealed also a total magnetic moment of only 5.29 pc. This value is much lower than the measured value of about 6 pc alculations discrepancy points clearly that the actual electronic structure of this compound is different from the calculated one. Even so the calculations for Co<sub>2</sub>M nSi agree with the experiment concerning the magnetic moment, their reliability concerning the details of the electronic structure may have to be called in question as long as the differences obtained for Co<sub>2</sub>FeSi stay unexplained.

The discrepancy between experiment and calculation was not removed when using the GGA parametrization resulting still in a too low value ( $5.56_{\rm B}$ ). Inspecting the spin resolved density of states (DOS) and band structure revealed the appearance of a gap in the minority bands, but located below the Fermi energy (see Figs.8b,9e in Sec.IIIB 2). This is nally one reason why the magnetic moment is too low and not an integer. In the following, details of

the electronic structure calculations will be discussed.

### A. Structure optim ization

First, a structural optim ization was performed for  $Co_2FeSi$  and  $Co_2M$  nSi to determine whether the experimental lattice parameter minimizes the total energy. It was found that the optimized lattice parameter from the calculation agrees very well with experimental values of  $a_{\exp_iF} = 5:64A$  and  $a_{\exp_iM} = 5:645A$ . Within the FLAPW scheme the structure optimization for  $Co_2YSi$  (Y = Mn, Fe) was performed using the GGA parametrization and a spin polarized (ferromagnetic) setup. The initial crystal structural parameter for a=a=0 is taken from the experimental value  $a_{\exp_i}$  and varied in steps of 2%. For each of the diement a parameter, the iteration procedure was performed up to self-consistency. The energy minimum then define the optimal value of a.




FIG.1: Structural optim ization for  $Co_2FeSi$ .

For  $Co_2FeSi$ , the energy minimum (ferromagnetic) was found to appear at a = 5.63A (corresponding to  $a=a_{exp}$  0.2%, see Fig.1 GGA). It was also found that the ferromagnetic (spin polarized) con guration has the lower minimum total energy compared to the paramagnetic (non spin polarized) case, not shown here. Similar calculations revealed for  $Co_2M$  nSi that the energy minimum appears at a=5.651A (corresponding to  $a=a_{exp}$  +0.1%.

Figure 1 displays in addition the results of a structural optim ization using the LDA+U schemew ith  $U_{\rm eff}$  as variational parameter. The results of this optim ization being performed for dierent values of  $U_{\rm eff}$  will be discussed below in Sec.IIIB.

# 1. Electronic structure and lattice parameter

In order to understand why LSDA and GGA do not give the expected magnetic moment and position of the gap, the dependence of both on the lattice parameter was carefully inspected for  $Co_2FeSiaswellasCo_2M$  nSi. It is important to compare the electronic structure of  $Co_2FeSiw$  ith  $Co_2M$  nSi as the latter is predicted to be a half-metallic ferromagnet with the measured magnetic moment of  $So_2M$  found in calculations using the experimental lattice parameter. However, a spin polarization of only about  $So_2M$  was obtained for this compound as determined by point contact Andreev rejection spectroscopy  $So_2M$ . The spin polarization

at the Ferm i energy determ ined by means of photo emission was even lower (8:::11%)8.




FIG. 2: Lattice param eter dependence of the magnetic moments.

The calculated total and site speci c m agnetic m om ents are shown in Fig 2 for Co<sub>2</sub>FeSi and Co<sub>2</sub>M nSi. In Co<sub>2</sub>FeSi (Fig 2b), the calculated atom ic resolved m agnetic m om ents of Co and Fe increase both with a and the overall magnetic moment follows the same trend, it increases from  $4.96_B$  to above  $6_B$  with increase of a. The experimental value of  $6_B$  is found for an enlargement of the lattice parameter by about 6:::10%. The site speci c moments seem to saturate above +6% change of the lattice parameter at about  $1.5_B$  and  $3_B$  for Co and Fe, respectively. (Slightly higher values are compensated by an anti-parallel alignment of the moments at Si sites and in the interstitial.)

The total m agnetic m om ent of  $Co_2M$  nSi (Fig 2a) increases also slightly with the lattice parameter but it stays at 5  $_B$  in the range of 6% change of a. There is a signi cant change in the magnetic moment at M n sites, it increases with lattice parameter. At the same time, the magnetic moment of Co decreases. Thus the Co moment counter balances

the M n m om ent such that the overall magnetic moment keeps constant while changing the lattice parameter.

At this point one can say that a moderate change of the lattice parameter does not change the overall magnetic moment of  $Co_2M$  nSi. The case of  $Co_2FeSi$  is completely dierent and an overall change of about  $1_B$  is observed in the same range of a=a as for  $Co_2M$  nSi. O verall, the magnetic moment of  $Co_2FeSi$  is less stable against variation of the lattice parameter (at least if using the same parameters for integration and convergence criteria as for the  $Co_2M$  nSi calculations). It exhibits some uctuations about the integer value at very large lattice parameter.

The form ation of the gap and localized magnetic moments in Heusler compounds is due to hybridization as was explained in detail by Kubler et al $^{7,38}$ . There is a close relation between the magnetic moment and the HMF character. The appearance of the gap in the minority density constrains the number of minority electrons to be integer. However, an integer value of the magnetic moment may not result automatically in a real gap in the minority (or majority) density. The band structure of  $Co_2FeSi$  (see also below in Sec.IIIB 2) revealed already a small gap in the minority states in the calculation for the experimental lattice parameter, but this gap is located below the Fermi energy ( $_F$ ). Therefore, the band




FIG. 3: Dependence of the m inority band gap on the lattice parameter.

structure was closer inspected in order to proof whether the integer moment is related with the appearance of a real HMF minority gap.

Figure 3 shows the dependence of the extremal energies of the lower (valence) band and the upper (conduction) band of the minority states enveloping the gap. For both materials the magnetic moment has to be integer in the region were  $_{\rm F}$  falls into the gap (gray shaded areas in Fig.3), that is the region of half-metallic ferromagnetism.

Figure 3a shows the dependence of the gap on the lattice param eter for  $Co_2M$  nSi. The shaded area corresponds to the region of half-m etallic ferrom agnetism. It is clearly seen that  $Co_2M$  nSi behaves like a HMF within 5% change of the lattice param eter. Therefore, a moderate change of the lattice param eter does not change the HMF behavior of  $Co_2M$  nSi. Figure 3b shows the dependence of the gap on the lattice param eter for  $Co_2FeSi$ . It is seen that the gap encloses the Fermi energy between 7.5% and 12% enlargement of the lattice param eter. The gap is completely closed for lattice param eter being 4% smaller than  $a_{exp}$ . Obviously the gap ( $E_{max} = 0.4eV$  at +12%) is smaller compared to  $Co_2M$  nSi ( $E_{max} = 0.9eV$  at -2.5%) and appears in a narrower range of the lattice param eter. So far it is seen that the HMF character and thus the integer magnetic moment is more stable against variation of the lattice param eter in  $Co_2M$  nSi compared to  $Co_2FeSi$ .

An enlargement of the lattice parameter by 8:::12%, as needed to explain the magnetic moment of  $Co_2FeSi$ , corresponds to a volume-expansion of about 26:::40%. Such a large




FIG. 4: Electronic structure of  $Co_2$ FeSiw ith enlarged lattice parameter. (LSDA-GGA, a=62A)

expansion of the crystal volum e by about 1/3 is rather unrealistic and falls far out of the expected uncertainties for the experimental determination of a. However, it may be interesting to inspect which changes in the electronic structure are caused by such an expansion.

The density of states (DOS) and the band structure of  $Co_2FeSi$  are shown in Fig.4 for the enlarged lattice parameter. The calculations were performed using the GGA scheme. An expansion of a=a=10% was used in the calculation (for a=a=0 see Sec.IIIB 2 and also  $Ref.^{12}$ ). This particular value was chosen as it is the case where the Fermi energy lies just in the middle of the gap of the minority DOS (see Fig.4a,b) and thus the material would securely be in a HMF state.

There are no m inority states at  $_{\rm F}$  con  $_{\rm F}$  in the compound to be in a HMF state. The high density below  $_{\rm F}$  is dominated by d states being located at Co and Fe sites. The small density of states near  $_{\rm F}$  in the majority DOS emerges from the strongly dispersing majority bands crossing the Fermienergy. From the spin resolved bands, it is seen that the majority bands cross or touch the Fermienergy ( $_{\rm F}$ ) in rather all directions of high symmetry. On the other hand, the minority bands exhibit a clear gap around  $_{\rm F}$ . For Co<sub>2</sub>FeSi, the width of the gap is given by the energies of the highest occupied band at the  $_{\rm F}$ -point and the lowest unoccupied band at the or X-point. The smaller value is found between and X, thus it is an indirect gap. The conclusion drawn from the displayed electronic structure is that the states around the Fermienergy are strongly spin polarized and the system is according to the calculations indeed a half-metallic ferrom agnet, at least for an enlarged lattice parameter. The gap in the minority DOS has the compelling result that the magnetic moment is integer with a value of 6  $_{\rm B}$ , as expected from the experiment.

The change of the electronic structure with the lattice parameter is clear from two basic

points of view . Firstly, from a free electron like band structure one expects a change of the band gradients and thus simply a shift of  $_{\rm F}$  due to the accompanied changes in the DOS. Secondly, from a tight binding like approach one expects a dierence in both, overlap and hopping integrals. In particular, they will be smaller for larger lattice parameter. With a decrease of a, the interaction between the atoms becomes stronger and the higher overlap results in a stronger de-localization of the electrons. O by by the overlap is too large in the calculation using the experimental lattice parameter of  $Co_2FeSi$ . On the other hand one may make use for nearly HMF compounds that small deviations of the magnetic moment from integer values can be compensated by small variations of the lattice parameter supposed the LSDA (GGA) calculations result in the correct electronic structure. Unfortunately, the opposite is also true. If the calculated Fermi energy is not just in the middle of the minority gap, then a small deviation of the lattice parameter may destroy the HMF character.

The major conclusion that can be drawn from the needed increase of the lattice parameter of  $Co_2FeSi$  is that bare LSDA (GGA) calculations are not su cient to explain its electronic and geometric structure at the same time and thus may fail for similar compounds, too. Moreover, it is suggested that electron-electron correlation might play an important role for opening the gap in the minority states and to get the magnetic moment with an integer value. The veri cation of the experimental results has to be full led independent of the material for both, lattice parameter and magnetic moment. In the following section it will be analyzed whether this goal can be reached possibly by inclusion of correlation.

## B. Electron correlation

The relative importance of itinerant versus localized properties of delectrons in metal alloys was already discussed by van V leck<sup>39</sup> and Slater<sup>25,40</sup>. Heusler compounds are generally thought as systems exhibiting localized magnetic moments as was rst mentioned by Pauling for  $Cu_2M$  na  $l^{26}$ . In particular, the magnetic moments of the  $Co_2YZ$  half-metallic ferrom agnets follow strictly the localized part of the well-known Slater-Pauling curve<sup>12</sup>. It is clear that the delectrons are de-localized in metals. Thus, the question about correlation in transition metalbased compounds is to what extent the on-site Coulomb interaction between delectrons is preserved such that important atom is properties like Hund's rule correlation are signicant and determine the magnetic properties at least partially<sup>41</sup>.

The idea from the above discussion is, after the structural optim ization failed to explain the magnetic moment of  $Co_2FeSi$ , that inclusion of electron-electron correlation may be necessary in order to respect a partial localization of the delectrons in a better way. Therefore, the LDA+U method was used to recalculate the electronic structure of  $Co_2M$  nSi and  $Co_2FeSi$ .




FIG. 5: A tom ic Coulom b-exchange param eter.

The LDA+U scheme is designed to model localized states when on-site Coulomb interaction becomes important. It gives a self-energy correction to localized states embedded in de-localized states. The energy U of the Coulomb interaction is rather large in free atoms (17eV to 27eV in 3d transition metals, see Fig.5), while screening results in solids in a much smaller values (for example 4.5eV in bcc Fe). In the present work, the value of the elective Coulomb-exchange interaction  $U_{\rm eff} = U - U_{\rm example} = U_{\rm exampl$ 

The average on-site Coulomb energy of pairs (ij) of equivalent electrons (i = j) is calculated from the Slater integrals  $F_k$  to be:

The sum runs over all k > 0 resulting in non-zero 3j-symbols. The 3j-symbols vanish for odd k and for delectrons one has  $k_{max} = 2l_i = 4$  such that Eq.1 results in:

where the on-site Coulomb integral is  $U = F_0$  and all integrals are calculated for l = 2. The exchange integral is given by:

$$J = \frac{2}{63} (F_2 + F_4) \tag{3}$$

Equation 3 as calculated from C owans's work<sup>43</sup> diers from the one reported by Anisim ov et al<sup>34</sup> giving a factor 1/14 instead of 2/63, for unknown reasons<sup>59</sup>.

The atom ic values of  $U = F_0$ , J, and  $U_{\rm eff} = E_{\rm dd}$  as calculated for the 3d transition metals are displayed in Fig.5. In the following we will denote the  $U_{\rm eff}$  values by  $U_x$  where the subscript x stands for the values (in %) relative to the atom ic ones (neutral atom s).

It should be mentioned that the e ect of screening in solids will mainly in wence U rather than the exchange integrals J. On the other hand, the values of J depend also on the ionicity (see Fig.5b) that will be di erent in solids and dependent on the compound under investigation. From a practical point of view, the use of  $U_x$  relative to the atom ic values allows an easier comparison between dierent systems compared to the use of separate values for all quantities and atoms.

First, a structural optim ization was performed for Co<sub>2</sub>FeSi using dierent values of  $U_{\rm eff}$  in the calculations (see also Sec.IIIA). From Fig.1 it is seen that adding  $U_{\rm eff}$  results in a less pronounced change of the E (a)-dependence and shifts the energy m in in um slightly to larger values of a. The m in in a are found at 5.72A and 5.75A for  $U_{10}$  and  $U_{15}$ , respectively. These values correspond to  $a=a_{\rm exp}$  of about +1.6% and thus are slightly higher compared to the experimental value.  $U_{\rm eff}$  has the elect that the total energies at the experimental lattice parameter are about 3eV lower for  $U_{15}$  compared to  $U_{10}$ . At the same lattice parameter, the total energy of the LSDA calculation is about 6 eV higher compared to  $U_{10}$ . It is worthwhile to note that the total energy taken from the LDA+U calculation does not correspond to the LDA ground state energy anymore and thus may lead to wrong conclusions about the structure. However, E (a;  $U_{\rm eff}$ ) will still give an idea about the optimal structure.

## 1. Magnetic moment and minority gap in LDA+U

In the following the dependence of the magnetic moments on the type of the exchange-correlation functional is analyzed and compared to the experimental values. The results of the calculations for  $Co_2FeSi$  using dierent approximations for the potential as well as the parametrization of the exchange-correlation part are summarized in Tab.I.

TabelI gives the site resolved m om ents at C o and Fe sites and the totalm agnetic m om ent. The induced m om ent at the Si sites (not given in Tab I was aligned in all cases anti-parallel to that at the transition m etal sites. Likewise, the magnetic moment located in the interstitial is omitted in Tab I, however, both quantities have to be respected in order to not the correct total moment.

The lowest value for the total magnetic moment was found if using the v.Barth-Hedin  $(vBH)^{32}$  parametrization with a discrepancy of -0.7 B compared to the experiment. The results from Vosko-Wilk-Nussair<sup>44</sup> parametrization and GGA <sup>33</sup> are very similar but still too low compared to the experiment. It is seen that both site species moments are too low to reach the experimental value that may need values of about 1.5 B and 3 B per atom at the Co and Fe sites, respectively. From this point of view, the LSDA or GGA approaches

are not su cient to explain the magnetic structure of Co  $_2{\rm FeS}\,i_7$  independent of the type of param etrization.

The correct magnetic moment at the experimental lattice parameter was only found if using the +U functional. The use of the LDA+U scheme improves the total magnetic moment considerably ( $U_{15}$  was used for the calculation in Tab.I). The ratio of the magnetic moments of Co and Fe was measured to be m  $_{\rm Fe}$ =m  $_{\rm Co}$  = 22 at 300K in an induction eld of  $0.4T^{12}$ . The ratio of 2.1 found in the LDA+U calculations agrees very well with this value. Spin-orbit interaction (SO) was additionally included in some of the calculations to analyze its in uence on the total and partial magnetic moments. In the GGA calculations, it did not improve the total moment. The experiments delivered orbital to spin magnetic moment ratios (m  $_{\rm I}$ =m  $_{\rm S}$ ) of about 0.05 for Fe and 0.1 for Co. The LDA+U+SO calculations revealed 0.02 for Fe and 0.05 for Co, being a factor of 2 smaller compared to the experiment. O verall, the agreement of both ratios (m  $_{\rm Fe}$ =m  $_{\rm Co}$  and m  $_{\rm I}$ =m  $_{\rm S}$ ) with the experiment is better in LDA+U compared to the pure LSDA or GGA parametrization of the exchange-correlation functional. This may give advice that U corrects, at least partially, the missing orbital dependence of the potential in LSDA.




FIG . 6: Dependence of the magnetic moments on  ${\tt U_{\rm eff}}$  .

In the following the e ect of the magnitude of the Coulom b-exchange interaction on the magnetic moments will be discussed. Figure 6 compares the dependence of the magnetic moment on  $U_{\rm eff}$  for  $Co_2FeSi$  and  $Co_2M$  nSi.

It is found for  $Co_2FeSithat$  the total magnetic moment increases from 5.6  $_B$  to 6  $_B$  while increasing  $U_{eff}$  from 0 to  $U_{7.5}$  and stays at the integer value up to  $U_{20}$ . Above that value the moment exhibits a further increase. The situation is dierent for  $Co_2M$  nSiw ith 5  $_B$  at  $U_{eff}=0$ . The moment stays integer up to about  $U_{7.5}$  and then increases with increasing  $U_{eff}$ .

In  $Co_2M$  nSi, the moment at the M n sites increases nearly linearly with  $U_{\rm eff}$ . At the same time, the moment decreases at the Co sites up to  $U_{10}$  counterbalancing the M n moments. At higher  $U_{\rm eff}$ , the Co moment increases and the HMF character is lost. The situation is dierent in  $Co_2FeSi$ , both site special moments show an overall slight increase with increasing  $U_{\rm eff}$ . Moreover, they stay rather constant in the range of  $U_{7.5}$  to  $U_{20}$  such that the total moment stays integer in this region. In both materials, the moment at the Co sites reacts stronger on  $U_{\rm eff}$  than the ones at Y sites for  $U_{\rm eff}$  being above the region of integer total moments. The increase of the site special moments is much less pronounced

in  $Co_2FeSi$  compared to  $Co_2M$  nSi. This gives advice that the Fe compound is much more stable against correlation e ects in comparison to the Mn compound, at least concerning the magnetic moments.




FIG. 7: Dependence of the m inority gap on the electrice Coulom b-exchange parameter. Shown are the extremal energies of the gap involving states for  $Co_2M$  nSi (a) and  $Co_2FeSi$  (b). The shaded areas assign the region of half-metallic ferromagnetism. Lines are drawn to guide the eye.

Again, it is interesting to nd out whether the integer magnetic moment of  $Co_2FeSi$  is related to a real HMF gap in the minority band structure and to compare the behavior of the gap to the one of  $Co_2M$  nSi. The extremal energies of the gap enveloping bands are shown for both compounds in Fig.7.

In both cases the size of the gap increases with increasing  $U_{\rm eff}$ . From Fig.7a it is found that  $Co_2M$  nSi stays in an HMF state in the range up to about  $U_8$ , that is the range of the integer magnetic moment. Taking larger values shifts  $_F$  to be outside the gap. In  $Co_2FeSi$  (Fig.7b), the minority gap involves  $_F$  from about  $U_8$  up to  $U_{20}$ . That means, the integer value of the magnetic moment is related to the minority gap in both compounds and thus the direct consequence of the HMF state.

In both compounds, the gap is completely destroyed at very large values of  $U_{\rm eff}$  ( 8eV). The e ect of the Coulomb-exchange interaction on single atoms (Co, Mn, or Fe) on the minority band gap was also investigated. It was found that the minority gap is destroyed in both materials if  $U_{\rm eff}$  is added only to one of the 3d elements, as expected. However, small changes in only one of the  $U_{\rm eff}$  values about the balanced value did not change the general behavior.

## 2. Electronic structure in LDA+U




FIG. 8: Spin resolved densities of states for Co<sub>2</sub>M nSi and Co<sub>2</sub>FeSi.

In the following the in wence of the correlation on the electronic structure will be discussed in more detail. Figure 8 compares the spin resolved density of states for  $Co_2M$  nSi and  $Co_2FeSi$  calculated in LSDA and LDA+U approximation. The low lying sp-bands emerging from  $_{5g}$  (majority) and  $_{6g}$  (minority) s states are located at (8::: 10)eV. They are not shown here (compare Fig.4). These states are coupled to p states ( $_{5u;6u}$ ) and mainly located at the Si atom s.

In both m aterials, the majority d states spread from 8eV below to about 4eV above  $_{\rm F}$  where the onset of the high lying, unoccupied s states becomes visible. s states are also present at below -4eV due to the s d coupling of the  $_{5g}$  states. p states are contributing to the density over the hole range of the d bands. They are mixed to s and d states due to the coupling of states with even and odd parity if going away from the -point. The high density of states at -1eV in Co<sub>2</sub>M nSior-2eV in Co<sub>2</sub>FeSiem erges mainly from  $_{8g}$  like states.

The situation is sim ilar in the m inority density of states where additionally a gap exists. This gap splits the m inority d-states and the unoccupied part above  $_{\rm F}$  is mainly of  $_{\rm 7g}$

character. The m inority gap is clearly dierent in both compounds and depends strongly on the applied e ective Coulomb-exchange interaction as already discussed above.

In the case of Co<sub>2</sub>FeSi, where the experiment clearly indicates the total magnetic moment to have an integer value, the LSDA results seems to be incorrect. On the other hand, it should be noted that the unoccupied d states are sharply peaked at  $_{\rm F}$  , resulting in a D O S that would imply an inherently unstable system in usual, simple ferrom agnetic materials. This is despite the spin polarization. The system is, however, stabilized by the gap in the m inority states that xes the number of occupied states not only in the m inority but also and more important - in the majority channel. In LDA, the paramagnetice, (located at the Co sites) and  $t_{2q}$  (at Fe) states are rather narrow at  $_{\rm F}$  suggesting that Coulomb correlation of the Hubbard U kind, being ignored within LSDA, will make Co2FeSi insulating in the m inority states. Attempting to treat electron correlation, the electrons become stronger localized by applying the LDA+U method. One of the major issues here is that the LDA+U type correlation is in portant for the electronic and magnetic structure of Co<sub>2</sub>FeSi. In more detail, the majority states at around -4 eV (arising from  $t_{2q}$  states in the param agnetic case) are shifted by  $U_{15}$  to -6eV below  $_{\rm F}$  . At the same time the unoccupied m inority states seen in the LSDA calculation just above  $_{ ext{F}}$  exhibit a larger shift of the param agnetic  $\mathbf{e}_{ ext{q}}$  states (to 2 eV above  $_{\rm F}$ ) compared to the paramagnetic  ${\rm t_{2g}}$  states (to 0.5 eV above  $_{\rm F}$ ). The

occupied states of the m inority DOS exhibit a less complicated behavior, they are mainly shifted towards the Fermi energy.

For  $Co_2FeSi$  as shown in Fig.8b,  $U_{15}$  was chosen because for this value the Ferm i energy lies just in them iddle of the gap. It is clearly seen that the splitting between the occupied  $g_g$  and the unoccupied  $g_g$  states becomes larger. Them inority  $g_g$  states exhibit an additional splitting after applying + U, whereas the unoccupied majority states stay rather una ected. At the same time the gap in the minority states becomes considerably larger and the Ferm i energy is clearly within this gap con rming that the compound is in a HMF state.

In Fig.8a the DOS of Co<sub>2</sub>M nSi is compared in LSDA and LDA+U approximation using  $U_{10}$  being above the limit of the HMF state. The majority distates being mainly located at the Co and Mn sites are clearly seen below  $_{\rm F}$  and possess a width of about 7eV. Near  $_{\rm F}$  one independent of majority states emerging from strongly dispersing dispersing dispersing to LSDA, there are hardly any minority states at  $_{\rm F}$  coniming the compound to be a half-metallic ferrom agnet. Using LDA+U, the dispersities are shifting away from  $_{\rm F}$  similar to Co<sub>2</sub>FeSi. However, the occupied part of the minority DOS also changes if applying  $U_{\rm eff}$ : it shifts closer to the Fermi energy and crosses it for high values of  $U_{\rm eff}$ . Once it touches  $_{\rm F}$  the maximum value of is reached that still results in the HMF state what is here the case for about  $U_{7.5}$ .




FIG. 9: B and structure of  $Co_2FeSiw$  ith variation of the C oulom b-exchange interaction. The gray lines assign the upper and lower bands dening the gap at the X-point in the minority states. (See text for the particular values of  $U_{\$}$  at the dierent sites.)

Figure 9 shows the changes of the band structure of  $Co_2FeSi$  if applying the LDA+U method. For easier comparison, details of the band structures are shown along X that is the -direction of the paramagnetic state. The -direction is perpendicular to the  $Co_2$  (100)-planes. As was shown earlier<sup>45</sup>, just the -direction plays the important role for the understanding of the HMF character and magnetic properties of Heusler compounds as was also pointed out by 0 gut and Rabe<sup>46</sup>.

The developing of the band structure with increasing  $U_{\rm eff}$  is shown in Fig.9 using values of 1.26eV, 2.52eV, and 3.78eV at the Co sites and simultaneously 1.2eV, 2.38eV, and 3.56eV at the Fe sites ( $U_5$ ,  $U_{10}$ , and  $U_{15}$ ). The upper panels (a-d) display majority and the lower panels (e-h) the minority band structures. It is seen that only slight changes appear in the majority band structure, the width of the visible bands at stays rather una ected and the main changes appear close to X.

M ore interesting is the behavior of the m inority bands as those determ ine the HMF character of the compound. One nds that the energies of the occupied states at stay

nearly the same. The shapes of the bands close to are similar, too. The situation is dierent at X where the unoccupied states are shifted away from  $_{\rm F}$  resulting in a gap that increases with  $\rm U_{\rm eff}$ . It is clearly seen that it is an indirect gap. At  $\rm U_{10}$  the Ferm ienergy falls within the gap and the HMF state is reached. The minority gap is larger at or at other points of high symmetry (not shown here) compared to X. Therefore, it is obvious that the states at X determine the HMF character of the compound.

The situation is clear at this stage: the gap in the minority states stays only within a certain range of the e ective Coulom b-exchange interaction. If one goes away from that lim it the Ferm i energy falls not longer inside of the gap and the material loses its HMF character. It is also obvious that the mechanism leading to the half-metallic ferromagnetism in  $Co_2FeSi$  serves to destroy it in  $Co_2M$  nSi. The worst case would appear for both materials at about 7:::8% of the atom ic values of  $U_{eff}$  where LDA+U predicts still values very

close to the m easured m agnetic m om ents but also is the borderline for the loss of the HMF character. From this point of view, nearly integer m agnetic m om ents alone do not verify the half-m etallic ferrom agnetism and one may have to search for alternative materials.

Previous band structure calculations using LSDA predicted Co<sub>2</sub>M nSito be a HMF at the experim ental lattice param eter<sup>24,47</sup>. Here, LDA+U calculations were performed in order to consider the in wence of on-site electron correlation in this compound. It was found that the gap in the minority DOS stays up to  $U_{\rm eff} = 2.3 {\rm eV}$  for Mn and 2.5 eV for Co. For larger values of  $U_{\rm eff}$ , that means for stronger correlation, the system loses its HMF character, by shifting  $_{\rm F}$  outside the minority gap. Co<sub>2</sub>M nSi is expected to exhibit 100% spin polarization at the Fermi energy. In reality this was not verified up to now. We anglet al<sup>8</sup> found only about 10% spin polarization at room temperature from a spin-resolved photo emission experiment. The spectra shown in Ref.<sup>8</sup> give no advice on the existence of a surface state that may serve to lower the spin polarization at  $_{\rm F}$ . Here, it was found that an already moderate correlation will destroy the gap. The spin polarization at  $_{\rm F}$  amounts to 75% if applying  $U_{10}$ , a value that is compatible to about 55% found in Ref.<sup>37</sup>. From that point of view, on-site correlation might be one more reason why no complete spin polarization was found in this compound (for others see:<sup>48</sup>).

M any e ects have been considered to explain the missing experimental proof of the complete spin polarization in predicted half-metallic ferromagnets For sure, each of these e ects may serve by itself to reduce the spin polarization at the Fermienergy. On the other hand, none of these e ects is able to explain a dierence of 15% between the observed and calculated magnetic moments like for the case of  $Co_2FeSi$ . The appearance of surface or interface states  $^{49,50}$  may decrease the spin-polarization in certain layers but will not in uence drastically the measurements of the magnetization of bulk samples. Magnon excitations  $^{51,52,53,54,55}$  will lead to a decrease of the magnetic moment with temperature rather than in an increase and thus can easily been disregarded here. Spin-orbit interaction couples, indeed, spin-up and spin-down states but does not enhance the magnetic moment, as was shown above. From this point of view, correlation might be one of the main causes of the too low spin polarization being observed in experiments. In the presented work, a static correction was used in the LDA+U approximation. Dynamic correlation extens may be respected by means of the LDA+D MFT approximation using dynamical mean eld theory 0 MFT). Using this method for N M nSb, it was shown by Chioncel et a 1 magnetic magnetic moments approximation by Chioncel et a <math>1 magnetic magnet

particle e ects m ay also serve to change the properties of the gap in the m inority states. The use of bulk sensitive angle, energy, and spin-resolved photo em ission becomes highly desirable in order to explain the details of the band structure in the most complete experimental way and to proof the existence of correlation in predicted half-metallic ferromagnets on the one hand and the true existence of half-metallic ferromagnetism on the other.

#### IV. SUM MARY AND CONCLUSIONS

Structural param eters, m agnetic m om ents and electronic properties of the H eusler compounds  $Co_2M$  nSi and  $Co_2FeSi$  were presented. The obtained, optimized lattice parameter leads for  $Co_2FeSi$  to a too small magnetic moment, using LSDA or GGA calculations. The measured value of the magnetic moment was only found for a lattice parameter enlarged by about 10% compared to the experiment. It was also shown that the magnetic moment of  $Co_2M$  nSi is more stable against structural changes in the LSDA or GGA approaches. At present, it seems that simple LSDA and GGA methods are not su cient to explain the electronic structure of Heusler compounds completely, at least they fail for  $Co_2FeSi$ .

In the step beyond LSDA, it was shown for the case of  $Co_2FeSi$  that electron correlation is able to explain the experim entalm agnetic m om ent at the experim entally observed lattice param eter. It was found that the LDA+U scheme reproduces satisfactorily the experimental observations. At moderate elective Coulomb-exchange correlation energies of about 2.5eV to 4.5eV, the LDA+U calculations agreed very well with the measured total and site specic magnetic moments. At the same time the compound was predicted to be clearly a half-metallic ferromagnet.

Finally, it was checked how the inclusion of correlation will change the calculated properties of similar Heusler compounds.  $Co_2M$  nSi is a compound being close to  $Co_2FeSi$  in the series of known Heusler compounds based on  $Co_2$ . It is obvious that on-site correlation will also play an important role in the Mn compound, if it does in the Fe compound. It was found that a small correlation energy of only about 2.5eV destroys the half-metallic ferrom agnetism what may explain why a complete spin polarization was not observed in this compound up to now.

In conclusion, it is suggested that it will be necessary to include electron-electron correlation beyond LSDA and GGA in the theoretical description of all potential half-m etallic

ferrom agnets and in particular for Heusler com pounds.
