Fringe spacing and phase of interfering matter waves

We experimentally investigate the outcoupling of atoms from Bose-Einstein condensates using two radio-frequency (rf) elds in the presence of gravity. We show that the fringe separation in the resulting interference pattern derives entirely from the energy dierence between the two rf elds and not the gravitational potential dierence. We subsequently demonstrate how the phase and polarisation of the rf radiation directly control the phase of the matter wave interference and provide a semi-classical interpretation of the results.

Ever since the rst realisations of Bose-Einstein condensates (BECs) in dilute atom ic gases, their coherence properties have been the subject of much investigation. The rst clear demonstration that BECs possess long range phase coherence was through the interference of two spatially separated condensates [1]. Since then, other experiments have studied the coherence properties using atom laser output from an array of tunnel coupled condensates in an optical standing wave [2], Bragg spectroscopy [3], density uctuations [4] and intereferom etry [5, 6]. An elegant scheme to probe condensate coherence, based on interfering atom laser beam s, was reported by Bloch et al. [7, 8]. This used two radio frequency (rf) elds to outcouple atoms from dierent locations within a condensate. A high contrast matter wave interference pattern was observed at temperatures well below the BEC transition temperature, con m ing the phase coherence of the condensate. A numerical model of two outcoupled modes agreed with the experimental observations [9]. More recently, the atom-by-atom build up of a matter wave interference pattern has been observed using single atom detection [10]. To date, experiments have primarily focussed on the visibility of the interference patterns. In this paper, we describe experiments which address the fringe spacing, phase and nature of the interference.

Outcoupling atoms from Bose-Einstein condensates with rf elds has been used extensively to produce beams of atoms, generally referred to as \atom lasers" [11, 12, 13]. The rf radiation drives resonant (stimulated) transitions from a trapped Zeem an sublevel to an untrapped state in which the atom falls under gravity. Outcoupling occurs at locations where the total energy dierence between the trapped and untrapped states is equal to \sim ! rf. This is usually determined by the Zeem an potential so that the resonant condition may be written

$$\sim!_{rf} = {}_{B} g_{F} \beta (r) j$$

where $_{\rm B}$ is the Bohrm agneton, $g_{\rm F}$ is the Lande g-factor and B (r) is the magnetic $\,$ eld.

Consider a condensate trapped in a cigar-shaped magnetic potential of the form U (r) = $m!_z^2 (^2x^2 + y^2 + z^2) = 2$ where m is the mass of the atom, $!_z = !_v$ is the trapping frequency in the tight directions of the trap and $= !_{x} = !_{z}$. A tom s can be outcoupled from the surface of an ellipsoid of the magnetic equipotential which satis es the resonance condition (1). However, gravity will cause a displacement of the minimum of the total potential from the magnetic eld minimum. This gravitational sag means a harm onically trapped condensate will be displaced from the magnetic eld minimum by a distance, $z_0 = g = \frac{1}{2}$, where $\frac{1}{2}$ is the trapping frequency in the direction of gravity. This displacem ent is typically greater than the size of the condensate, so that the ellipsoidal equipotential surfaces can be approximated by planes which intersect the condensate at dierent heights, z. In this situation, the dependence on the x and y coordinates can be neglected form any quantitative purposes and only the z dim ension need be considered.

In previous work [7,8], two rf elds of frequencies, $!_1$ and $!_2$, were used to outcouple atom s from a condensate. The two spatially separated resonances were interpreted as creating two slits from which atoms were extracted from the condensate. The outcoupled atoms formed two matter waves which interfered, in close analogy with a Young's double slit experiment. The visibility of the interference pattern provided a measure of the rst order phase coherence of the condensate.

The outcoupling points, z_1 and z_2 , used in [7, 8], were chosen to be centred around the m iddle of the condensate, located at z_0 , the m inimum of the combined magnetic (harmonic) and gravitational (linear) potential. Under this condition, the gravitational energy dierence between the two outcoupling points, determined by the slit separation, $z=z_1-z_2$, is exactly equal to the difference in energy between the two applied rfields. This can easily be seen from the derivative of the magnetic potential, where $E=m!\frac{z}{z}z$ z. At the central position, z_0 , we not $E=\sim(!-1-!2)=m$ g z.

However, this result is only true when $z = z_0$, (where $z = (z_1 + z_2)=2$, is the distance from the magnetic




FIG. 1: (a) Totalenergy (solid lines) of atom s in the trapped, m $_{\rm F}$ = 1 and untrapped m $_{\rm F}$ = 0 states, for the parameters used in our experiments. The dashed and dash-dotted lines represent two pairs of rf elds, with equal !, used to outcouple atom s from the BEC at dierent locations. The gravitational energy dierence m g z m ay vary for a xed !, however, when the interaction energy (shaded) of atom s in the untrapped state is included, the total energy dierence between the two outcoupled m atter waves is always equal to \sim !. (b) The measured outcoupled m atter wave beam s display an interference pattern with a constant fringe spacing (z) given by equation 4 for a xed ! (in this case equal to $1000~{\rm s}^{\,1}$), independent of z.

eld m inim um to the centre of the two slits). If the two resonant points are not sym m etrically located about the centre of the trap, the z^2 dependence of the magnetic potential means that the slit separation for a xed $!=!_1$ $!_2$ varies inversely with z. Thus the gravitational energy dierence between the two resonance positions, is not necessarily equal to \sim ! and z may change signicantly across the width of a condensate. For a harmonic potential, the slit separation is approximately

$$z = \frac{\sim !}{m ! \frac{2}{3}z} : \tag{2}$$

In a Young's double slit experiment, the fringe spacing, , of the interference pattern is proportional to z^{-1} . However, in dual rfoutcoupling experiments with a xed !, is independent of z. While the gravitational energy dierence, mg z, between the two resonant locations can change, this is not the only energy to consider. The fringe spacing of the interference pattern depends on the total energy dierence between the two indistinguishable outcoupling paths and must always equal \sim ! to satisfy energy conservation. This is a general result which we discuss below, for a BEC in the Thom as Ferm i (TF) regime.

Consider the speci c case of an F = 1^{87} Rb TF condensate. The total energy of the trapped state F = 1; $m_F = 1$ i consists of the sum of its magnetic, gravita-

tional and m ean eld energies. The untrapped (outcoupled) state jl;0i experiences negligible m agnetic potential, but, while still within the condensate, experiences both the m ean eld and gravitational potentials. In 1D, the total energy of a particular substate can be written as

$$E_{m_F}(z) = m_F (\frac{1}{2}m!_z^2 z^2 + B_g g_F B_0) m_g z + g_{ld} j(z)_j^2$$

where B₀ is the magnetic eld at the minimum of the trap, g_{1d} is the 1D elective interaction strength (assumed to be the same for all m_F, which is approximately true but not an essential point in this discussion) and $j(z)_f^2 = \int_{m_F} j_{m_F}(z)_f^2$ is the total atom is density. The energies of the trapped jl; 1i state and the untrapped jl;0i state are plotted (solid lines) in Fig. 1(a) for the parameters used in our experiments. The shaded regions indicate the mean eld contribution to the total energy. Also shown are two pairs of rfelds, dashed and dash-dotted lines, with the same ll, chosen to lie within the width of the condensate. As the two pairs are centred around dierent z, the resulting z for each pair is dierent, but the total energy dierence is ll is ll.

In the TF lim it the interaction energy between the condensate and the outcoupled state exactly compensates for the di erence in gravitational potential at di erent slit locations. The density pro le, j (z) \mathring{f} , mirrors the shape of the magnetic trapping potential so that the energy splitting between the two states is always given by the di erence in their magnetic potentials. A dditionally, the energy of trapped atoms within the condensate is independent of z so that only the nallenergies on the m $_{\rm F}$ = 0 curve determ ine the energy di erence between the two outcoupled beam s.

Having established that the fringe spacing, , depends only on $\,!$, it can easily be shown that

$$(z) = \frac{p}{\frac{2g(z - z_0)}{f}}; \qquad (4)$$

where f = !=2. varies with z because the outcoupled atoms accelerate in the z-direction under gravity, as can be seen in Fig. 1 (b).

We have performed a range of experiments to verify this for several values of ! with the resonant points centred around various z positions. Our experimental procedure for producing condensates has been described elsewhere [14] and was used here with only slight modications. An atom chip is used to produce near pure condensates containing 2 $10^{5~87}$ Rb atoms in the jl; 1i ground state. Our chip design facilitates the production of relatively large condensates in highly stable trapping elds. The nal trapping frequencies are 160 Hz in the tight direction and 6.7 Hz in the weak direction. The elongated geometry of the trap means we must cool well below the 3D critical temperature T_c to produce fully phase coherent condensates (typically T for our parameters is less than $T_c=2$ [15]). Outcoupling is induced by

turning on two rf elds of the sam e am plitude, with frequencies $!_1$ and $!_2$ tuned to be resonant with atom s in the condensate, and Rabi frequencies, = _B g_F $\not\!\!$ $\not\!\!$ $\not\!\!$ = 2~, of 50 H z for each rf source. A fler outcoupling for 10 m s, the trap is left on for a further 3 m s before being turned o abruptly. An absorption im age is taken after 5.3 m s of free expansion.

We rst checked the reproducibility of the fringe spac-1000 s ¹ as z was varied ing for a xed ! of 2 over the range 390 nm to 560 nm by varying z.W hile the visibility of the interference pattern decreased near the edges of the condensate, the wavelength was consistent with the value predicted by equation (4) to within 1%. Experim ental values of were determined by taking an im age of the outcoupled atom s, sim ilar to that shown in Fig. 1(b), converting the z spatial axis into a time axis through the relation t = $2(z z_0)=g$, integrating the output over x and tting a cos^2 function to the data. The uncertainty in is determined by the uncertainty in the tted frequency of the cos² function. Variations at the level of 1% are within our experimental uncertainties and not signi cant when compared to what would be expected if was determined by z 1. This would lead to a variation of more than 30% across the range of values we measured.

A sem i-classical interpretation of these dual rf outcoupling experiments, based on the interference of the applied rf elds, may also be used to understand these experiments. De ning the mean frequency, $!=(!_1+!_2)=2$, and the beat frequency, $=(!_1-!_2)=2$, and recalling the standard trigonom etric identity

$$\sin !_1 t + \sin !_2 t = 2 \sin ! t \cos t \tag{5}$$

we see that the sum of two oscillating elds is equivalent to an amplitude modulated carrier wave. In our case, the carrier frequency, !, is typically three orders of magnitude higher than the beat frequency, . Adding a phase, , to one of the rf elds shifts the phase of both the carrier and beating terms by half this amount.

We may now consider the condensate interacting with a single rfeld at the carrier frequency, which is am plitude modulated in time. The number of atoms outcoupled is proportional to the Rabi frequency squared (ie. proportional to the amplitude squared of the rfeld at timet) and is modulated at $2 = ! \cdot 0$ now outcoupled, the atoms fall under gravity and, provided they have a low spread of initial momenta, the outcoupled density will be modulated in time.




FIG. 2: The phase of the interfering matter wave beams is determined by the phase of the beating rf elds used in to drive the outcoupling. (a) and (b) represent dierent runs of the experiment under identical conditions apart from dierent phases of the applied rf eld. On the left are absorption images of the condensate (top) and outcoupled atoms and on the right is the beat note of the corresponding rf used to drive the outcoupling, measured on an oscilloscope. The vertical axis indicates the time before the image was taken and was obtained for the atom images through the relationship, $t = \frac{1}{2(z-z_0)-g}$

To dem onstrate this, a sequence of dual rf outcoupling experim ents was perform ed using xed values ! $_1$ and ! $_2$ (! = 2 $\,$ 500 s 1) but varying the relative phase of the two rf elds. This has the e ect of shifting the phase of the rf beat note. All other experimental parameters were kept xed. Two examples of the data obtained are shown in Fig. 2. Absorption images of the outcoupled atoms appear on the left and the beat note of the corresponding rf elds used for outcoupling (measured on an oscilloscope) are shown on the right. The z axis of the

absorption im ages has been rescaled by $\frac{r}{2(z-z_0)=g}$ to linearise the time axis for ease of comparison with the rf. It is clear from these images that the outcoupled atoms correspond to the largest amplitude of the rf beat note.




FIG. 3: Plot of the tted phase of the modulated atom beam against the phase of the beating rf eld. Filled circles represent experim entally measured data using a single coil and the dashed line is a plot of y = x. Open squares are experimentally measured phases when the rf is produced by two separate (near) orthogonally mounted coils and the dotted line is a plot of y = x + 0.55 .

In order to quantify this, we have analysed a series of similar data in which the relative phase of the rf elds was allowed to vary random by over the range 0 to 2. The thing procedure described earlier was applied to all of the absorption in ages to determ ine the phase of the outcoupled beam. A similar twas applied to the square of the measured rf beat note and the two phases are plotted against each other (led sircles) in Fig. 3. The dashed line through this data is a plot of y = x. The phase of the modulated atom beam matches very well the phase of the applied rf eld.

In these experiments both rf elds were provided by passing the two rf currents through the same coil. This means the rf eld in the vicinity of the BEC was linearly polarised, perpendicular to the quantisation axis x. We have also performed experiments using separate, orthogonally mounted coils where each rf current was sent through a dierent coil. The rf interference is no longer linearly polarised but rather a eld whose polarisation varies from vertical linear, to left hand circular, to horizontal linear, to right hand circular and back to vertical linear in a single beat period (T = 1 = 1). This is analogous to the optical eld used in lin? lin sub-Doppler (Sisyphus) laser cooling [16] but the eld is periodic in time rather than space.

The outcoupling transition from jl; 1i to jl;0i requires + ~ of angular m om entum , and can only be driven

by ⁺ radiation. When the rf is derived from a single coil, it is easy to see that the maximum amplitude of ⁺ radiation occurs when the two rf elds are in phase. The linearly polarised eld may be decomposed into two counter rotating circular elds and it is the ⁺ component of this which couples to the atom. With perpendicularly oriented coils however, the maximum amplitude of the ⁺ eld occurs during the circular polarised phase of the beat note. This happens when the rf elds are =2 out of phase.

Also shown in Fig. 3 (open squares) is a plot of the phase of the atom laser versus the phase of the beating

rf elds perform ed with (near) perpendicularly oriented coils. The atom ic output is phase shifted by approximately =2 from the rf as expected. The slight m ismatch between the measured shift of 0:55 and the expected shift of 0:5 was due to imperfect alignment of the rf coils (precise perpendicular alignment would have impeded optical access in our setup). For coils mounted antiparallelm aximum outcoupling would occur when the two rf elds are out of phase.

In conclusion, we have studied the origins of the fringe spacing and phase of matter wave interference patterns, produced by outcoupling atoms from a BEC with two rf elds. We have shown that the energy dierence between the two rf elds determ ines the spacing of the interference pattern, not the gravitational potential di erence determ ined from the classical slit separation. Sem iclassical argum ents based on interfering rf elds correctly predict the experim ental observations. These also show how the phase and polarisation of the rf eld determ ine the phase of the observed matter wave interference pattem. This extends previous work which looked at the fringe visibility for the speci c case where \sim ! = m g z [7]. Our ndings do not contradict the phase coherence studies reported in ref. [7]. Indeed, any random phase gradients within the BEC would lead to random initial velocities that would degrade the observed interference patterns. Finally, we note that we have also perform ed experim ents with cold therm alatom s and see (as in [7]) that the visibility of interference pattern dim in ishes, due to the therm alspread of velocities in the trapped gas.
