C oherent transport of cold atom s in angle-tuned optical lattices

O ptical lattices with a large spacing between the minim a of the optical potential can be created using the angle-tuned geom etry where the 1-D periodic potential is generated by two propagating laser beams intersecting at an angle di erent from . The present work analyzes the coherent transport for the case of this geom etry. We show that the potential depth can be kept constant during the transport by choosing a magic value for the laser wavelength. This value agrees with that of the counterpropagating laser case, and the magic wavelength does not depend of the optical lattice geom etry. M oreover, we may that this scheme can be used to implement controlled collision experiments under special geom etric conditions. Finally we study the transport of hyper ne-Zeem an states of rubidium 87.

I. IN TRODUCTION

Neutral atoms trapped in an articial periodic potential form ed by laser light, the so called far detuned optical lattice, have been proposed as the individual qubits for quantum information processing. In an optical lattice, neutral atoms can be trapped in the intensity maxima (orminima) of a standing wave light eld owing to the optical dipole force. A con guration with one single atom trapped in each site of the optical lattice is realized in the con guration of a M ott-insulator transition associated to the loading of Bose-Einstein condensates (BECs) in optical lattices[1]. In order to realize quantum gates with neutral atoms within the ideal environm ent of the M ott insulator several schem es have been proposed. The common idea is to control the quantum atom ic states through the preparation and coherent m anipulation of atom ic wave-packets by m eans of application of standard laser cooling and spectroscopic techniques. By using spin dependent, or more precisely state dependent, optical lattice potentials, the control can be applied independently to multiple atom ic qubits based on dierent internal states. A state dependent potential m ay be created for a one dim ensional optical lattice in the so-called lin- -lin con quration, where the travelling laser beams creating the optical lattice are linearly polarized with an angle between their polarizations [2, 3, 4]. In this con guration the optical potential can be expressed as a superposition of two independent optical lattices, acting on dierent atom ic states. By appropriately choosing the atom ic internal states, the atom s will be trapped by one of the

two potentials depending on their internal state. By changing the angle between the linear polarizations of the two laser beams producing the optical lattice, the wavepackets corresponding to orthogonal atom ic states can be coherently transported relative to each other [5, 6, 7]. Once the atom ic qubits are brought together they interact through controlled collisions. In the coherent transport experiment of M andel et al [8], by a proper control of the angle the wavepacket of an atom initially localized at a single lattice site was split into a superposition of two separate wave packets, and delocalized in a controlled and coherent way over a de ned num ber of lattice sites of the optical potential.

In an optical lattice created by the counterpropagating standing wave con guration, the spacing between neighboring m inim a of the optical lattice potential is one half the wavelength of the lasers creating the optical lattice. Optical lattices with m ore widely separated wells can be produced using long wavelength lasers, as CO_2 lasers [9]. A lternatively, optical lattices with a larger spacing between the minim a/m axim a of the optical potential are formed using the angle-tuned geometry. There the periodic potential is created by two laser beams propagating at an angle and the lattice constant is $d = = [k \sin (-2)], w ith k = 2 =$ the laser wavenum ber [10, 11, 12, 13].

The aim of the present work is to analyze the coherent transport associated to the lin- -lin polarization con guration for the angle-tuned lattice geometry. We analyze rubidium atoms in a given Zeem an level of a hyper ne state loaded within a 1-D optical-lattice. The 1-D geometry of the Bose gas may be generated by a tight con nem ent along the orthogonal directions. For instance a two-dimensional array of 1-D Bose gases (tubes) is produced by con ning the atoms through a two-dimensional optical lattice generated by independent

lasers, as realized in Ref. [14].

Section II de nes the geometry of the angle-tuned optical lattice. In Section III we analyze the e ective optical potential created by an optical lattice in the angle-tuned con guration. The potential contains a component with a vectorial symmetry described through an e ective magnetic eld, as derived in [15]. The dependence of the potential depth on the angles de ning the lattice geometry is analyzed in Section IV. Section V reexam ines the coherent transport for the counterpropagating laser geom etry. Section VI extends the coherent transport to the angle-tuned geometry and determines the condition for a constant optical lattice depth during transport. The application to the hyper ne-Zeem an states of rubidium is presented in Sec VII, and in the following Section the minimum time required to realize the coherent transport in the adiabatic lim it is brie y discussed.

II. LASER GEOMETRY

The lasers generating the 1-D lin- lin con guration are composed by two phase-correlated propagating electric elds with frequency ! and amplitude E $_0$. Their wavevectors




FIG.1: Laser con guration determ ining the angle tuned geometry. The laser elds propagate within the (y;z) plane with wavevectors k_i^f at an angle between them, and polarizations e_j^f , with (j = 1;2). These wavevectors and polarizations are generated applying the rotations described in the text to two laser elds counterpropagating along the z axis and with polarizations e_j^i , with (j = 1;2) within the (x;y) plane.

lying on the (y;z) plane create the angle-tuned geom etry with angle , as shown in Fig. 1. The spatio-tem poral dependencies of the electric elds are

for j = 1;2, with polarizations e_j^f de ned in the following. This geometry creates a 1D optical lattice along the z-axis. The laser elds con ning along the transverse directions are not required for the following analysis and not listed here.

The above laser geometry is obtained by applying proper spatial rotations to a 1D optical lattice initially created by two counterpropagating laser elds along the z axis. Let's introduce the rotation R_x () of an angle around the x axis

and the rotation R_z () of an angle around the z axis

In the lin--lin counterpropagating con guration the laser wavevectors are

Notice that, in addition to the angle between the two polarization directions, we have introduced the angle $_1$ between the polarization vector \hat{e}_1^i and the x axis. The wavevectors $k_{1;2}^f$, given by Eq. (1), are obtained applying the follow ing rotations:

Such rotations are applied as well to the polarization vectors [16]

The electric elds $E_1^f(x)$, $E_2^f(x)$ are obtained by substituting Eqs. (7) and (8) into Eq. (2), and the total electric eld is given by

where \mathbf{e}_{L} (x) de nes the local polarization, not necessarily unit norm .

III. OPTICAL POTENTIAL

The optical potential experienced by the atom s is obtained from the analysis of ref. [15]. For alkali atom s, in the lim it that the laser detuning is much larger than the hyper ne splittings in both the P $_{1=2}$ and P $_{3=2}$ excited states, the optical potential has the following form [17]:

representing the scalar and vector polarizabilities, derived for instance in [18]. The operators $\hat{1};^{\wedge}$ are the identity and Pauli operators in the electron ground-state manifold. The polarizabilities \sim_{D_1} and \sim_{D_2} corresponding to the excitations to the P $_{\frac{1}{2}}$ and P $_{\frac{3}{2}}$ excited states respectively, depend on the dipole operator reduced matrix element $hJ^0kdkJ = \frac{1}{2}iw$ ith $J^0 = \frac{1}{2};\frac{3}{2}$:

Here $_{D_{1,2}}$ is the detuning of the laser frequency ! from the resonance between the states $F_{max} = 2i$ and $F_{max}^{0} = 2i$ or $F_{max}^{0} = 3i$, for the D_{1} or D_{2} lines of 87 Rb respectively.

The substitution of Eqs. (8) for the local polarization in the right sides of Eqs. (10b) and (10c) leads to

The elective magnetic eld B $_{\rm eff}$ [19] varies spatially with a d period. Its components along the three axes have amplitudes depending on the angles dening the lattice geometry. If the light eld is everywhere linearly polarized, $_1 = 0$, the elective magnetic eld vanishes and the light shift is independent of the magnetic atom is sublevel: $\hat{U}(x) = U_J(x)\hat{I}$. For the counterpropagating geometry, i.e. = , investigated by [5, 6] and in plemented in [8], the elective magnetic eld is oriented along z-axis.

IV. HAM ILTON IAN EIGENVALUES

M aking the assumption of neglecting the kinetic energy of the atom s, the elective potential corresponds to the full ham iltonian acting on the atom ic states, and the position z can be treated as an external parameter. If we consider the two-dimensional subspace characterized by the electron spin component, i.e., $\beta = \frac{1}{2}$; $m_s = \frac{1}{2}i$ and $\beta = \frac{1}{2}$; $m_s = \frac{1}{2}i$, the eigenvalues of the ham iltonian are

with a constant term V⁰ left out. These quantities represent the optical potential experienced by the atom s. In an equivalent description, dene the energies of the $\beta; m_s = \frac{1}{2}i$ atom is states when the electron spin is aligned along the local direction of the magnetic eld, i.e., ^ = b=b. The eigenvalues of Eqs (18) can be expressed as

The potential depth U₀($_1$; ;) and the relative phase 2 $_0$ ($_1$; ;) are given by

Eq. (20) demonstrates the spatial periodicity of the potentials experienced by the atom ic eigenstates. Ultracold atom s are trapped at the spatial positions corresponding to the m inim a of the optical lattice potentials. For positive U₀, the z_{+} and z_{-} m inim a positions for the $\beta = \frac{1}{2}$; $m_{s} = \frac{1}{2}i$ and $\beta = \frac{1}{2}$; $m_{s} = -\frac{1}{2}i$ states respectively are given by

with 1 an integer. For instance at $_0 = =2$, the j+i atom s are localized at $z_+ = (l + \frac{1}{4})d$ and the j i atom s at $z = (l + \frac{3}{4})d$. At $_0 = 0$ both species are localized at the $(l + \frac{1}{2})d$ positions.

V. COUNTERPROPAGATING GEOMETRY

We consider the case = of an optical lattice created by two counterpropagating laser elds. Then the functions u and b_j determining the optical lattice potential reduce to

For this geom etry the functions u and b_j do not depend on the angle $_1$ but only on the relative angle . This is a consequence of the sym metry of the system . Since the two beams form ing the optical lattice propagate along the direction z, the system is invariant under rotations around that axis.

At = the potential depth U_0 () and the phase shift $_0$ () become




FIG.2: Eigenvalues + (continuous line) and (dashed line), in units of V⁰, plotted for di erent values of (0, =3 and =2 from left to right) in the case of the counterpropagating geometry corresponding to = and for the value = 0.5.

Fig. (2) reports the two eigenvalues of Eqs. (20) as a function of z for di erent values of the relative angle between the two linear polarizations. The laser frequency is chosen such that $V^{1} = 0.5V^{0}$, that is = 0.5. At

= 0 with the laser polarizations parallel, + and coincide. By increasing j j the m in m a of the potential curves + and m ove in opposite directions along the z axis, and the potential depth decreases. At = =2 the m in m a of + coincide with the m axim a of , and their amplitudes are at the m in m um. Let us suppose to start at = =2 preparing a j i atom at the site id and a j i atom at the site (i $\frac{1}{2}$)d. Varying adiabatically

from =2 to 0 (or to) the two particle will occupy the same site. This protocol was used to transport the atom s from one site to the other in order to produce controlled collisions [5, 6, 8]. We recall that in this counterpropagating geometry the elective magnetic eld is oriented along the z axis and is equal to zero for = 0, when the atom s collide.




FIG.3: Potential depth U_0 as a function of for j jranging between 0 and 2 in steps of 0.2, from bottom to top. For j j= 1 the potential is a constant independent of .

Fig. 3 shows that the potential depth does not rem ain constant by varying . A spointed in refs [5, 7], this difculty is avoided for a particular choice of the param eter . In fact for $^2 = 1$, the term \cos^2 disappear in Eq. (25) and U₀ becomes a constant independent of and

equal to V^0 .

By assuming equal dipole m on ents for the D₁ and D₂ lines $hJ^0 = \frac{1}{2} kdkJ = \frac{1}{2}i^2 = hJ^0 = \frac{3}{2} kdkJ = \frac{1}{2}i^2$ [20], the parameter (!) becomes:




FIG. 4: Plot of the dimensionless parameter 2 as a function of the laser wavelength $\,$. The two continuous vertical lines denote the position of the resonant wavelengths $_{\rm D\ 2}$ and $_{\rm D\ 1}$, respectively. The dashed vertical line indicates them agic wavelength $\,$.

Fig. 4 reports the parameter versus the laser wavelength . The constraint $^2 = 1$ implies = 1 or = 1. The rst condition is satis ed for $_{D1} = 0$ which is not an acceptable value, since the whole treatment for the optical lattice potential is valid only for detunings $_{D1;2}$ large with respect to the typical hyper ne splitting. The = 1 relation is satis ed if the laser wavelength is equal to the magic value

where D_1 and D_2 denote the resonant wavelengths for the D_1 and D_2 lines. For = 1 the relative phase 0 becomes

Therefore for the magic wavelength the potential depth is independent on and the phase $_0$ varies linearly with the relative angle .




FIG.5: Optical lattice phase shifts $_0$ and $_1$ versus for the laser at the magic wavelength, corresponding to = 1. For $_0$ the continuous line corresponds to $_1 = =4$ and = 3 =4. The dashed line plots $_0$ at $_1 = 0$ whichever value of . The same $_0$ values are obtained for = whichever value of $_1$. For $_1$ the dotted line corresponds to $_1 = 0$ whichever value of $_1$. For $_1$ the dotted line corresponds to $_1 = 0$ whichever value of $_1$. For $_1$ the dotted line corresponds to $_1 = 0$ whichever value of $_2$ as initial value and 0 as nal value. A complete transport cannot be realized for the conditions corresponding to the continuous line, but instead can be realized for the dashed and dotted lines.

VI. ANGLE-TUNED CONFIGURATION

For dimension the potential depth U_0 and the phase $_0$ depend on the angle $_1$ as well. This rejects the fact that for $\frac{6}{5}$ the system is not invariant under rotations around the z axis.

For the U_0 dependence on $_1$ the magic wavelength plays again a key role. In fact by choosing = 1 Eqs. (21) reduce to

Therefore the potential depth $U_{\,0}\,$ depends only on the laser wavelength.

The remaining dependence of $_0$ on the angles (1; ;) de ning the optical lattice represents a di culty for the coherent transport operation. For instance for the values of $_1 = =4$ and = 3 =4 the phase shift $_0$ versus is plotted as a dashed line in Fig. 5 and is compared to the value corresponding to the counterpropagating geom etry, plotted as a continuous line. For those values of and $_1$ the range of variation of is smaller than . This means that by varying the two potential curves corresponding to the two atom ic eigenstates are shifted by a quantity smaller than the spatial period d. Thus them inim a of the potentials for the two atom ic eigenstates do not coincide and a complete transport is not realized. How ever under the special condition of $_1 = 0$ Eq. (17) holds, and the phase $_0$ becomes

Therefore by choosing = and $_1 = 0$, the phase shift becomes fully equivalent to that of the counterpropagating case. Thus, it is possible to move the two potential curves of Eqs. (20) without changing the potential depth, and a spatial coherent transport with am plitude d can be produced by varying the angle of the laser polarizations. For this angle-tuned con guration, even if the e ective magnetic eld is null at = 0 where the atom s collide, it includes a component along the y axis at other values of .

VII. TRANSPORT OF RUBIDIUM STATES

The vector component and the total potential of Eqs. (10) experienced by the atoms depend on the projection of the electron magnetic moment or, equivalently, of the total angular momentum \hat{F} along the local magnetic eld. D i erent e ective potentials are experienced by di erent Zeem an levels of the ground hyper ne state, and the laser parameters required for the coherent control depend on the atom ic computational basis. Here we consider two di erent hyper ne-Zeem an states \hat{F} ; m $_{\rm F}$ i of

the 87 Rb atom as in the analysis of [5, 6, 8]. A s described in [6] the potential experienced by the atom s in these internal states is derived from the potential of Eq. (10a) by considering the components of the electron spin for these states. However in the angle tuned geometry with

 ϵ , the elective magnetic eld also includes components oriented along the x and y axes. As a consequence the potential experienced by the atom ic states depend on the optical lattice loading process and the occupation amplitudes for the Zeem an states. In fact R am an coherences of the type F; mill F^{0} ; mill are created by the

e ective magnetic eld. As pointed out in ref. [22], in the tight binding regim e where each lattice site can be considered as an independent potential well, the W annier states constituting an orthonorm albasis within each well in general become spinors.

For simplicity we analyze the case of an adiabatic bading of the ${\rm F}$; m $_{\rm F}$ i states in the lattice so that their m $_{\rm F}$ component is oriented along the local magnetic eld B $_{\rm e}$. Thus we impose the atom ic states under consideration to be the ${\rm F}$; m $_{\rm F}$ i eigenstates along the local magnetic eld. Let's consider the follow ing states:

W e obtain two di erent e ective lattice potentials trapping the atom s in the Di and jlihyper ne-Zeem an states.

Because Eqs. (33) have the same structure as Eqs. (29), the coherent transport is determ ined by the u() dependence at xed values $_1$ and . By using this analogy we conclude that, in order to perform a controlled-collisions experiment, the potentials seen by the two hyper ne states j(); lim ust m ove in opposite direction when

is varied. The comparison Eq. (3b) to Eq. (21b) indicates that this condition is satisfied when the jli state is chosen such that $_{\rm c} > 0$, that is, when $\dot{\rm p}$ j> $\dot{\rm p}_{\rm f}$ j. For the states f = 2; $m_{\rm F} = 2i$, f = 2; $m_{\rm F} = 1i$, f = 1; $m_{\rm F} = 1$ it his inequality is satisfied.

The optim alcoherent transport is obtained when the potential depth is constant by varying the control param eter. In Section V the constance of the optical depth was realized by xing the laser wavelength at the magic value. For the present case of two hyper ne states a unique magic wavelength where the U_0 and U_1 potential depths are both independent of does not exist. While the U_0 constance im poses $^2 = 1$ and produces the magic wavelength Eq. (27), the U_1 constance im - poses ($_c)^2 = 1$ leading to a di erent laser wavelength. For instance, at $_1 = 0$ and xing the laser wavelength to the value of Eq. (27) such that = 1, the potential depths for the D; 11 states become

W hen is varied from $\frac{1}{2}$ to 0 or , while the U₀ potential depth is independent of , the U₁ potential depth depends on and its range is determ ined by c, whence by the c values. Therefore, when is varied the potentials experienced by the j); li states move with di erent velocities. The phase 0 is linearly dependent of , while the dependence of 1 on has a more complicated behavior. For the case of the F = 1; m $_{\rm F} = 1$ is state the

 $_1$ dependence is shown by the dotted line in Fig. 5. The coherent transport condition of phase shifts $_{0;1}$ varying from $=\!2$ to 0 is realized for both the hyper ne-Zeem an states. D i erent results for the change in the potential depth and for the phase dependence on $\,$, and therefore for the displacem ents of the two potentials, are obtained for a laser wavelength di erent from the magic one.

VIII. AD IABATIC TRANSPORT

In order to realize an e cient quantum gate, the time dependence of polarization angle should be chosen so that the transport of the atom ic states is realized in the adiabatic limit, i.e. the atom s rem ain in the ground state of local optical potential. For an analysis of the adiabaticity constraint necessary for the coherent transport we approxim ate the atom ic potential of Eq. (20) with a harm onic one. For non interacting atom s experiencing a harm onic potentialm oving with respect to the laboratory frame, the H am iltonian m ay be written as [23]

where z denotes the coordinate of the atom in the harmonic potential frame, z_{hp} represents the acceleration of the harmonic potential in the laboratory frame, and the oscillation frequency of the harmonic oscillator is

If we consider the last term of the above H am iltonian as a time-dependent perturbation, the probability of transferring an atom to the rst excited level of the harm onic potential is

where $a_{ho} = \frac{p}{\sim -M}$ is the ground state radius for the harm onic potential, and T is the time required for the coherent transport process.

The amplitude of the transfer probability of Eq. (39) depends greatly on the time dependence of the z_{hp} acceleration. At rst we will suppose that, as in the theoretical analysis of ref. [6] and in the experimental investigation of ref.[8], the potential moves at a constant speed, by imposing an in nite acceleration at t = 0 and t = T. For this transform ation the adiabatic condition for the atom ic transform ation requires

O wing to this dependence on , for a constant speed of the potential the time T required to realize an adiabatic coherent transport in the angle-tuned con guration is much longer than in the counterpropagating case, for a given depth of the optical potential. Such result could im pose a strong constraint for performing quantum com putation with angle-tuned lattices.

However, the condition on T for realizing the adiabatic lim it becomes less restrictive if we assume a di erent motion for the lattice harmonic potential con ning the atoms. For instance, let us assume that the lattice is constantly accelerated from t = 0 to $t = \frac{T}{2}$ and constantly decelerated from $t = \frac{T}{2}$ to t = T. Thus the adiabatic condition becomes

Therefore using this motion of the potential, the dependence of the minimum time for the coherent transport on the angle is modiled causing a decrease in the time by a factor which for 5 is larger than 2. Moreover the additional dependence on $, U_0,$ and the physical constants of Eq. (41) contributes to the decrease of the time scale, so that for the experimental conditions of ref. [8] transport times around 10 s can be achieved.

IX. CONCLUSIONS

In quantum computation experiments with neutral atom s loaded in optical lattices, a crucial aspect is the single site addressability. In the angle-tuned con guration where the lattice constant could be large, the question of the single site addressability is shifted to a fram e ofm ore accessible dimensions. For this geometry the coherent transport protocol requires speci c conditions of the laser beam polarizations, linked to the breaking of the rotational sym m etry associated to the counterpropagating geometry. An additional request is the constance of the optical potential depth during the coherent transport. This constance is realized by choosing a magic wavelength for the laser elds producing the lattice. The value of the magic wavelength is independent of the lattice geom etry. How ever an unique magic wavelength for the transport of all hyper ne-Zeem an atom ic states does not exist.

C oherent transport within an optical lattice represents a component of the process based on ultracold collisions and leading to entanglement of neutral atoms and im – plementation of quantum logic. By storing the ultracold atoms in the microscopic potentials provided by optical lattices the collisional interactions can be controlled via laser parameters. At the low temperature associated to the M ott insulator, the collisional process is described through s-wave scattering. In the $_1 = 0$ laser con guration of the angle-tuned geometry, at = 0 the elective magnetic eld is null and the scattering potentials associated to the di erent atom ic states have an identical spatial dependence. How ever, as new feature brought by the angle-tuned geometry, at $\in 0$ the elective magnetic eld is di erent from zero and oriented along di erent directions for di erent hyper ne-Zeem an states. Therefore during the whole collisional process the colliding atom s m ay be oriented along di erent spatial directions. In order to treat this collisional con guration, the atom ic interaction m ay be described through the pseudopotential m odels introduced in refs. [24, 25] for asym m etric trap geom etries.

The atom ic control is based on a the realization of a M ott insulatorphase, in which the num berofatom soccupying each lattice site is xed. The physics of such a system is described in term sofa Bose-H ubbard m odelwhose H am iltonian contains the on-site repulsion resulting from the collisional interactions between the atom s, and the hopping m atrix elements that take into account the tunneling rate of the atom s between neighboring sites. B oth the repulsive interaction and the hopping energy can be tuned by adjusting the lasers setup, as reviewed in [26]. The M ott insulator phase is realized under precise conditions between the on-site repulsion and the hopping m atrix elements. The dependence of these parameters de ning the angle-tuned lattice should be investigate in order to realize a M ott insulator in an angle tuned geom – etry.
