# The breaking of quantum double sym $m$ etries by defect condensation

#### Abstract

In this paper, we study the phenom enon of opform ore speci cally quantum double sym $m$ etry breaking. W e devise a criterion for this type of sym $m$ etry breaking $w$ hich is m ore general than the one originally proposed in $[1,2]$, and therefore extends the num ber of possible breaking pattems that can be described consistently. W e start by recalling why the extended sym $m$ etry notion of quantum double algebras is an optim al tool when analyzing a wide variety of two dim ensional physical system s including quantum uids, crystals and liquid crystals. T he pow er of this approach stem $s$ from the fact that onem ay characterize both ordinary and topologicalm odes as representations of a single (generally non-A belian) H opf sym m etry. In principle a fill classi cation of defect $m$ ediated as well as ordinary sym $m$ etry breaking pattems and subsequent con nem ent phenom ena can be given. T he form alism applies equally w ellto system s exhibiting global, local, intemaland/or extemal (i.e. spatial) sym $m$ etries. $T$ he subtle di erences in interpretation for the various situations are pointed out. W e show that the $H$ opf sym $m$ etry breaking form alism reproduces the know $n$ results for ordinary (electric) condensates, and we derive form ulae for defect ( $m$ agnetic) condensates which also involve the phenom enon of sym $m$ etry restoration. These results are applied in two papers which will be published in parallel $[3,4]$.

In recent years it has becom e clear that in the setting of two-dim ensional (quantum ) physics, the notion ofquantum double algebras or quantum groups plays an im portant role. O ne of the $m$ ain reasons is that these extended sym $m$ etry concepts allow for the treatm ent of topological and ordinary quantum num bers on equal footing. This $m$ eans that the representation theory of the underly ing - hidden -H opf algebra A labels both the topological defects and the ordinary excitations. This is also the case in non-A belian situations where the mutual dependence of these dual quantum num bers would otherw ise be untractable. M oreover, as the H opf algebras involved tum out to be quasitriangular they are naturally endowed w th a $R$ m atrix which describes the topological interactions betw een the various excitations in the $m$ edium of interest $[5,6]$. This theory has found interesting applications in the dom ain of Q uantum $H$ all liquids $[7,8,9,10,11]$, exotic phases in crystals and liquid crystals [3], as well as 2-dim ensional gravity [12]. It also appears to fumish the appropriate language in the eld of topologicalquantum com putation [13,14,15,16].

O nce this (hidden) extended symmetry was identi ed, the authors of [1,2] studied the breaking the H opf sym $m$ etry by assum ing the form ation of condensates, respectively of ordinary (which we call electric), defect (m agnetic), or m ixed (dyonic) type. A s was to be expected, the ordinary condensates reproduce the conventional theory of sym m etry breaking, though the analysis of con nem ent of topological degrees of freedom, using the braid group, is not standard. In [1,2] it was shown that when considering H opf sym m etry breaking, the usual form alism of sym $m$ etry breaking had to be extended with signi cant novel ingredients. O ne assum es the condensate to be represented by a xed vector in som e nontrivial representation of the Hopf algebra A. $T$ his leads to the de nition of an interm ediate algebra $T$ as the suitably dened stabilizer subalgebra of the condensate. The com plication that arises at this level is that certain representations of $T \mathrm{~m}$ ay braid nontrivially w th the condensate, which in tum $m$ eans that the condensate cannot be single valued around a particle belonging to such a representation. If this happens to be the case, it im plies that such particles (representations) necessarily are conned. Thee ective low energy theory of the non-con ned degrees of freedom is then characterized by yet a sm aller algebra called U. So the breaking of H opf sym $m$ etries involves three algebras: the unbroken algebra $A$, the interm ediate algebra $T$, and the uncon ned algebra $U$.

In this paper we show that the assum ptions $m$ ade about the structure of the interm ediate residual sym $m$ etry algebra $T$ in [1,2] can be relaxed. $T$ his leads to a new de nition of the residual sym $m$ etry algebra $T_{r}$ which contains $T$ as a subalgebra, which $m$ eans that the residual phase $m$ ay have a ridher spectrum . W ew illdiscuss the new criterion in som e detail and point out its im portance.

W e conclude by deriving general form ulae for $\mathrm{T}_{\mathrm{r}}$ and U for the case of electric and defect condensates, in phases whose corresponding H opf algebra is what we calla $m$ odi ed quantum double $F\left(H_{m}\right) \quad C H_{\text {el }}$, where $H_{m}$ and $H_{e l}$ are nite groups. $\mathrm{H}_{\mathrm{m}}$ is the m agnetic group, i.e. the defect group. $\mathrm{H}_{\text {el }}$ is the electric group, or the residual sym $m$ etry group ${ }^{1}$. W e know what to expect for electric condensates, and for that case ourm ethod reproduces the known results. The problem of defect condensates is $m$ ore interesting, and provided the $m$ ain $m$ otivation for this work. In this paper we focus on the basic structure and the $m$ ore form alaspects of the sym $m$ etry breaking analysis and wem ainly present general results, involving both con nem ent and liberation phenom ena. In tw o separate papers we give detailed applications of these results: one paper on defect $m$ ediated $m$ elting [4] (which discusses also the phenom enon ofsym $m$ etry restoration), and another on the classi cation of defect condensates in nonabelian nem atic crystals [3].

The starting point in this paper w illbe situations where a continuous intemal or extemal (space) sym $m$ etry $G$ is broken to a possibly non-abelian, discrete subgroup H. This m ay happen through some Higgs mechanism in which case we speak of discrete gauge theories [17], or by form ing som e liquid crystal for exam ple. Topological (line) defects can then be labelled by the elem ents h of the discrete residual sym m etry group ${ }^{2}$ H. Fam iliar exam ples of such defects are dislocations, disclinations, vortioes, ux-tubes etc. Such a theory has a (hidden) H opfsym $m$ etry corresponding to the so called quantum double $D$ ( H ) of $H$. This $H$ opf sym $m$ etry is an extension of the usual group sym $m$ etry ${ }^{3}$. The elem ents a ofD ( $H$ ) are denoted by $a=(f \quad h)$, where $f$ is som efunction on the group $H$, and $h$ som e elem ent of the group algebra CH of H (later on wewill om it the sign). A basis for the space of functions F ( H ) on a discrete group H is a set of delta functions which project on each group elem ent. W e denote these pro jectors by $\mathrm{P}_{\mathrm{g}}$, these are just delta fiunctions $\mathrm{g}(\mathrm{g} 2 \mathrm{H})$ de ned by: $f P_{g}\left(g^{0}\right) \quad g\left(g^{0}\right)=g ; g^{0} j 8 g^{0} 2 \mathrm{H} \quad g . T$ he elem ent $f$ is basically a $m$ easurem ent operator (projecting on a subspace), while h involves a sym m etry operation. In other words, if we denote the elem ents of the group $H$ by $g_{i}$, where i labels the group elem ents, we can w rite

where the $i$ and $i$ are com plex num bers. This follow sfrom the fact that the $P_{g_{i}}$ span $F$ ( $H$ ), and the $g_{i}$ span the group algebra of $H$, which we denote by CH . An altemate notation for $\mathrm{D}(\mathrm{H})$ is $\mathrm{F}(\mathrm{H}) \mathrm{CH}$, which show sthat it is a combination of $\mathrm{F}(\mathrm{H})$ and CH .

The multiplication of two elem ents ofD ( H ) is de ned by

N ote that the multiplication on the group part is just the ordinary group m ultiplication, but the multiplication of the functions is not just pointw ise but tw isted by a con jugation. This is a nontrivial feature which im plies that the product is not a sim ple tensor product. There are two structures on a H opfalgebra A ofspecial interest to our purposes (for an introduction to H opf algebras, see for exam ple [18]). O ne is the so called counit " which tums out to be ofparticular relevance in the present context. " is an algebra $m$ orphism from the H opfalgebra to C, de ned through " $(\mathrm{f} \quad \mathrm{h})=\mathrm{f}(\mathrm{e})$. The other structure we w ish to m ention is the antipode S which is a kind of inverse needed to introduce conjugate or antiparticle representations. $S$ is an algebra antim orphism from A to A, which satis es $S\left(P_{g} \quad h\right) \quad P_{h}{ }^{1} g^{1} h \quad h{ }^{1}$. A quantum double is further endowed with an invertible elem ent R 2 A A which implem ents the braiding of representations. It encodes the topological interactions and in particular the possible exotic \quantum statistics properties" ofthe excitations in the system.

The sectors of the theory, or the physical excitations for that $m$ atter, can be labelled by the irreducible representations of ( H ). T hese are denoted as
${ }^{A}$, where the label A denotes the conjugacy class $C_{A} \quad H$ to which the topological ( $m$ agnetic) charge of the excitation belongs, whereas denotes a representation of the centralizer group $\mathrm{N}_{\mathrm{A}}$ of a chosen preferred elem ent $h_{A}$ of $C_{A}$. xes the \ordinary" or electric charge. C learly, ${ }^{A}$ describes in general a $m$ ixed electric and $m$ agnetic, usually called dyonic, excitation. P ure defects or ordinary excitations correspond to the special cases where one of the tw o labels becom es trivial. $W$ e denote the carrier space on which ${ }^{A}$ acts as $V^{A}$. The $H$ opf algebra structure requires a well de ned com ultiplication which ensures the existence of well de ned fusion or tensor product rules for the representations of the algebra.

The quantum double appears when the defect group $H_{m}$, which we call the $m$ agnetic group, and the residual sym $m$ etry group $H_{e l}$, which we call the electric group, are the same group H. This is often the case, because the $m$ agnetic group is equal to $H_{m}=1\left(G=H_{e l}\right)=H_{\text {el }}$, when $G$ is connected and sim ply connected. H ow ever, there are cases where $H_{m}$ and $H_{\text {el }}$ are not equal. For exam ple, if we want to distinguish between chiral and achiral phases, we have to include inversions (or re ections). T he inclusion of inversions does not alter the defect group (because the inversions live in a part of $G$ that isn't connected to the identity), but it can alter the electric group. W e are thus led to the structure of a modi ed quantum double $F\left(H_{m}\right) \quad C H_{e l}$, which is a special case of what is called a bicrossproduct ${ }^{4}$ of the H opf algebras $\mathrm{F}\left(\mathrm{H}_{\mathrm{m}}\right)$ and $\mathrm{CH}_{\mathrm{el}}$. The structures in $\mathrm{F}\left(\mathrm{H}_{\mathrm{m}}\right) \quad \mathrm{CH} \mathrm{H}_{\mathrm{el}}$ are very sim ilar to those in $\mathrm{D}(\mathrm{H})$,
we give them in appendix A. The crucial point is that the electric group acts on the $m$ agnetic group, nam ely a residual sym $m$ etry transform ation $h 2 \mathrm{Hel}$ transform sthe defects. We denote the action of $2 \mathrm{H}_{\mathrm{el}}$ on $\mathrm{g} 2 \mathrm{H}_{\mathrm{m}}$ by h g. In the case of $D(H)$, the action is smply conjugation: $h \quad g=h g h^{1}$. To obtain the structures of $D(H)$ from those of $F\left(\mathrm{H}_{\mathrm{m}}\right) \quad \mathrm{CH}$ el, one basically replaces all occurrences of $h \quad g$ by hgh ${ }^{1}$.

2 B reaking, braiding and con nem ent

In the previous section we $m$ entioned that a H opf sym $m$ etry captures the fusion and braiding properties of excitations of spontaneously broken phases. In particular we $m$ entioned the $m$ odi ed quantum double $F\left(H_{m}\right) \quad C H_{e l}$, which is relevant for a phase w th $m$ agnetic group $H_{m}$ and electric group $H_{e l}$. In this section we will show that this H opf sym metry description allow s for a system atic investigation of phase transitions induced by the condensation of som e excitation. Since electric, $m$ agnetic and dyonic $m$ odes are treated on equal footing, we will unify the study of phase transitions induced by the form ation of condensates of all three types ofm odes.

The use of H opf sym m etries to analyze phase transitions was pioneered by B ais, Schroens and Slingerland [1,2]. In this article we stay close to their w ork . A $n$ im portant departure how ever, is the de nition of "residual sym $m$ etry operators". Based on physicalargum ents we put forw ard a new de nition, which, though sim ilar, is m ore general than the previous one.

### 2.1 B reaking

W e want to study the ordered phases arising if a condensate form s, corresponding to a non-vanishing vacuum expectation value of som e vector which we denote as $j_{0}>$ in some representation of the H opf algebra. This vacuum vector breaks the $H$ opf-sym $m$ etry A, and just as in the conventional cases of spontaneous sym $m$ etry breaking we have to analyze what the residual sym $m$ etry algebra $T$ is.
$T$ he natural criterion to determ ine the residual sym $m$ etry that was proposed in $[1,2]$ is

where is the representation in which $j$ oi lives. The motivation for this criterion is that an operator a is a residual sym $m$ etry operator if it acts on
j oi as the trivial representation ".
This condition was subsequently analyzed in [1,2], where it was argued that one must im pose further restrictions on T.Nam ely, it was im posed that T be the maxim al H opf subalgebra of A that satis es the condition (2). This restriction was $m$ ade under the quite natural physical assum ption that one should be able to fuse representations of $T$.

W e have taken a closer look at this restriction, and the point we $m$ ake in this paper is that $T$ need not be a H opf algebra. It tums out that there is no physical reason to require T to be H opf, and in fact lifting that requirem ent opens up a number of very interesting new possibilities that appear to be essential in describing realistic physical situations. $R$ ather than talking about a single H opf-algebra $T$ we have to distinguish two algebras (not necessarily $\mathrm{Hopf} \mathrm{T}_{\mathrm{r}}$ and $\mathrm{T}_{1}$. O ne can choose either one and we choose to de ne the breaking w ith $T_{r} . T_{r}$ is de ned as the set of operators in $A$ that satisfy

W e w ill explain the physical m otivation for this criterion later on. Stated in words: the residual sym $m$ etry operators belonging to $T_{r}$ are operators that cannot distinguish whether a given particle has fused with the condensate $j_{0}>$ or not. Therefore these operators are so to say \blind" to the condensate, and the $m$ easurem ents they are related to are not a ected by the presence of the condensate. $W$ e note for now that $T_{r}$ need not be a H opf algebra, but that it contains the H opf algebra $T$ as a subalgebra. Still, all its elem ents a satisfy (a) $j_{0}>="(a) j_{0}>$, thus the operators in $T_{r}$ also act as the vacuum representation on $j_{0}>$.

The im portant di erence $w$ th the previous analysis of $[1,2]$, is that, as we have lifted the H opf algebra requirem ent on T , we will in general no longer have a well de ned tensor product for the representations of $\mathrm{T}_{\mathrm{r}}$. At rst sight this seem s problem atic from a physicalpoint of view, but the opposite tums out to be the case, the am biguity that arises re ects the physical situation perfectly well. Im agine that we bring som e localized excitation into the medium, $m$ oving it in from the left, then it $m$ ay well be that the vacuum is not single valued when \m oved" around this excitation. If such is the case the excitation will be con ned, and we obtain a situation as depicted in $F$ igure 1. The con ned particle is connected to a dom ain wall. The condensate to the right of the $w$ all is in the state $j_{r}>$, and to the left it is in the state $j_{l}>$. Thus the question arises where the condensate takes on the original value $j_{0}>. W$ hen we say the condensate is in the state $j_{0}>$, and we want to study con ned excitations, we m ust specify whether the state of the condensate is $j_{0}>$ to the far left or the far right of the plane, aw ay from any excitations. W e cannot a priori im pose that the state of the condensate to the far left and the far
right is the sam e, because then we wouldn't allow for con ned excitations. Choosing to set $j_{r}>=j_{0}>$, ie. setting the state of the condensate to the far right, gives $T_{r}$ as interm ediate sym $m$ etry algebra. Choosing $j_{1}>=j_{0}>$ gives us a di erent interm ediate algebra $\mathrm{T}_{1}$. A s m entioned before we'll w ork $w$ th $\mathrm{T}_{\mathrm{r}}$.

$F$ ig.1.A con ned particle in the broken vacuum $w$ ith a dom ain wall attached. The state $j_{r}>$ of the vacuum on the right di ers from the state $j_{1}>$ of the vacuum on the left.

O nem ay now restrict oneselfto the uncon ned representations and obtain that they form the representations of yet another algebra, the uncon ned ( H opf ) algebra U.Putting it all together we have arrived at the picture in gure 2 for the generic sym $m$ etry breaking schem $e$. $T$ he $m$ athem atical structure is appealing and exactly re ects the subtlety of having to deal with con ned particle representations.
O ne $m$ ay show that the $m$ axim al $H$ opfsubalgebra $T$ satisfying the criterion (2) is contained in the intersection of $\mathrm{T}_{\mathrm{r}}$ and $\mathrm{T}_{1}$ :

It is also possible to dem onstrate that if $\mathrm{T}_{\mathrm{r}}$ is a H opf algebra then we have necessarily the relation $T=T_{r}=T_{1} . W e \mathrm{w}$ ill show these and other results later.

In the follow ing sections we m otivate the H opf sym $m$ etry breaking form alism by way of exam ples, and we fully analyze electric and defect condensates starting w ith phases whose Hopf symmetry is a modi ed quantum double $\mathrm{F}\left(\mathrm{H}_{\mathrm{m}}\right) \quad \mathrm{CH}$ el. The breaking by electric condensates proceeds along fam iliar lines (i.e. Landau's theory of phase transitions). H ow ever, our argum ents are m ore com plete also in these situations, because w ithin our form alism we arrive at a residual sym $m$ etry algebra $T_{r}$ where all defects are still present, and we then nd U by analyzing which defects are con ned, and rem oving them from the spectrum .

The fact that we reproduce the theory of electric condensates is encouraging. $M$ ore interesting nontrivial results occur when we analyze defect condensates.


Fig. 2. A schem atic of the quantum symmetry breaking form alism. O ne has to distinguish three levels: The unbroken $H$ opfalgebra $D$ ( $H$ ), the interm ediate algebra $T_{r}$, and the e ective uncon ned algebra $U$. This schem e should be com pared w ith the sim ple schem e of ordinary sym $m$ etry breaking where one only has to distinguish betw een the unbroken group $G$ and som e residual sym m etry group H G .

A pplications of the results ofthis paper to defect condensates in general classes ofnem atic liquid crystals [3], and defect m ediated m elting [4], w illbe published elsew here.

Excitations in the broken phase, which has $\mathrm{T}_{\mathrm{r}}$ as its sym $m$ etry algebra, should form representations of $T_{r}$. $W$ em ust now take a close look at these excitations: som e of them tum out to be attached to a dom ain wall, ie. their presence would require a half-line singularity in the condensate, and such a wall costs a nite am ount of energy per unit length (as we will show later in a simple exam ple). To see this, wem ust rst discuss braiding. It is also usefulto discuss the issue ofbraiding, to point out characteristic di erences betw een phases in which local and global sym $m$ etries are broken.

### 2.2 Braiding

Braiding addresses the question of what happens to a multi-particle state when one particle is adiabatically transported around another. To answ er this question one is led to introducing a braid operator, whose properties we brie y recall.W e focus ourdiscussion on phasesw ith a $F\left(H_{m}\right) \quad C H_{e l} H$ opfsym m etry. $W$ e start $w$ ith som e heuristic argum ents rst involving the braiding of a defect and an ordinary excitation, then the braiding of two defects, and nally that of two ordinary excitations. $W$ e will assum e throughout that $H_{e l}=H_{m}=H$ is discrete.

C onsider the braiding of an electric $m$ ode $w$ ith a defect in the gauge theory case, because the global case is m ore subtle. T his question goes back to the very de nition (orm easurem ent) ofthe defect [19]. Ifwe have a discrete gauge theory w ith a defect $g$, then $g$ is the \topological charge" of the defect, and it is de ned as the path-ordered exponential of the gauge eld along a path around the defect:

This phase factorbasically corresponds to the change ofthew ave function $j \geqslant$ (which takes a value in som e irreducible representation of the gauge group H) of som e particle coupled to the gauge eld when it is parallel transported around the defect. The outcom $e$ is

So $\mathrm{j}^{0}>$ is de ned through the condition of a vanishing covariant derivative: $D_{i} j^{0}>=0$.

Thus as an electric $m$ ode is transported around the defect, it is acted on by the topological charge $g$ de ning the defect. W e can choose a gauge such that the eld $v$ is constant everyw here except along a line going \up" from the origin. Then halfbraiding already gives $v 7 g \quad v$, because undemeath the defect $v$ is constant, i.e. v braids trivially w ith the defect if it passes below the defect. $T$ his just show s that this distinction is gauge dependent, because the operator itself is. Indeed, even the path ordered exponential in (5) is not gauge invariant in the nonabelian case, how ever the con jugacy class to which it belongs is. In a locally invariant theory any physical outcom e can only depend on som e gauge invariant expression involving this path ordered exponential.

Let us now discuss the braiding of two defects [17,6]. If we carry a defect $h$ counterclockw ise around a defect $g$ then $h$ gets conjugated by $g$ and becom es ghg ${ }^{1}$, while $g$ gets conjugated to hgh ${ }^{1}$. W e can encode this behavior by de ning a braid operator $R$. If $g \gg$ lives in $V^{A}$ and $\dagger>$ in $V^{B}$, then $R$ is a $m$ ap from $V^{A} \quad V^{B}$ to $V^{B} \quad V^{A}$ whose action is de ned by (in the localtheory this involves adopting som e suitable gauge xing):

The braid operator encodes the braiding properties of the defects. $N$ ote that it braids the defect to the right halfw ay around the other defect, it im plem ents a half-braiding or an interchange. To achieve a fullbraiding, we have to apply the $m$ onodrom $y$ operator which equals $R^{2}$.
$T$ he equation for the braiding of defects $j g$ and $\dagger \gg$ we have just discussed applies equally well to the cases of global and local sym $m$ etry breaking.
$F$ inally, it is clear that electric m odes braid trivially w ith each other ${ }^{5}$ :

Before tuming to $m$ ore form al aspects ofbraiding let us com $m$ ent on the case of global sym $m$ etry. For exam ple in a crystal the defects are de ned using a Burgers vector (giving a displacem ent after circum venting a dislocation) or a Frank vector (specifying a rotation being the de cit angle after one carries a vector around a disclination). The rst has to do with translations and the otherw ith discrete rotations, both are elem ents ofthe discrete sym m etry group of the lattice. The story is thus very sim ilar to the local case. T he essence is that the local lattice fram e is changed while circum venting the defect (one speaks of \fram e dragging") and that will obviously a ect the propagation of local degrees of freedom, whether these are ordinary $m$ odes or other defects.

There is also a \continuum approach" to lattice defects where these are considered as singularities in the curvature and torsion of som e m etric space. In other words, the defects a ect the space around them, which will leave its traces if one is to bring a particle around the defect. T his idea has been used in crystals, and the resulting geom etry is of the $R$ iem ann- $C$ artan type ${ }^{6}$ where the disclinations and dislocations can be considered as singular nodal lines of curvature and torsion respectively. For an introduction, see [20] and [21]. C learly this geom etrical approach to defects assum es som e suitable continuum lim it to be taken, which tums the theory into an ISO (3) gauge theory (just like gravity is an SO (3;1) gauge theory).

D escribing phases w ith global sym $m$ etries in term s of gauge elds leads to the analog of the A haronov-B ohm e ect in global phases. This has been studied in $m$ any phases, such as super uid helium [22], crystals [23], and uniaxial nem atic liquid crystals [24] (neglecting di usion).

So far it is clear that for the global theory, the outcom e ofbraiding is basically the sam e as in the localcase. T he fram e dragging how ever is locally $m$ easurable and cannot be changed by local gauge transform ations. This $m$ eans that the global theory $m$ ay adm it additional (nonívariant) observables.

W e have seen that in basically allsituations the action of the braid operator on a two-particle state consisting of a defect and an ordinary (electric) excitation is

The beauty of $m$ any Hopf algebras A - and the quantum double is one of
them - is that they are quasitriangular, which $m$ eans that they are naturally endowed w ith a universal $R$ m atrix denoted by $R . R$ is an elem ent of A $A$. It encodes the braiding of states of the irreps of A : to braid two states, $j_{1}>$ in $1_{1}$ and $j_{2}>$ in $2_{2}$, act with $R$ on $j_{1}>j_{2}>$, and then apply the ip operator . This gives the action of the braid operator $R$ :

The braid (or rather $m$ onodrom y) operator show $s$ up in invariant physical quantities. For exam ple in the gauge theory case, the expression for the cross section for the nonabelian analogue of A horonov-B ohm scattering involving the m onodrom y operator was given by E. Verlinde [25]:

where $j$ in $>$ is the initial intemal wavefunction of the whole system, and $p$ the incom ing $m$ om entum. For exam ple, for the case of an electric $m$ ode $j v$ to the left of a vortex $\dot{j}>$, we have $j$ in $>=j \geqslant \dot{j} \gg$. If the braiding is trivial, ie. $R^{2} j$ in $>=j$ in $>$, then there is no scattering.

The question whether this expression for the cross section is also valid in the case of $g l o b a l$ sym $m$ etries, has not been answ ered conclusively, see for exam ple [26]. As far as the analysis of conœivable ways to break H opf sym $m$ etries, the general theory applies to both situations, but in the actual application there is a precise $m$ athem atical di erence betw een phases w th local or global sym $m$ etries.

### 2.3 C on nem ent

W e have already indicated that excitations which braid nontrivially w ith the vacuum state cannot be strictly bcal excitations, because the condensate cannot be single valued around them. Such an excitation can only be excited at the price of creating a physical hal ine singularity attached to it. O ne has to create a con guration of a dom ain wallending at a defect and therefore we say that such a defect is con ned. The fate - such as con nem ent - of defects in phase transitions where the topology changes was discussed in relation w ith a particular exact sequence of hom otopy $m$ appings in [27]. W e w ill see that the

condensate and hence the vacuum vector takes a di erent value to the left and to the right of the dom ain wall. A nd since the dom ain wallem anating from the excitation costs a nite am ount ofenergy per unit length, we have to conclude that such an excitation willbe linearly con ned.A nite energy con guration requires another con ned excitation on the other end of the wall. We will call a con guration consisting of a num ber of con ned constituents connected by a set of w alls, a hadronic com posite, in analogy w ith the hadrons in Q CD , being the uncon ned composites of con ned quarks (see Figure 3). The excitations that braid trivially w ith the condensate are clearly uncon ned, and they can propagate as isolated particles.

To illustrate som e of these aspects in m ore detail, we take a look at the ubiquitous XY m odel in two dim ensions, and reinterpret the phase transition to the ordered state as an exam ple where con nem ent plays a role.

Let (x) be the angular variable of the XY model, and $=j j^{j}{ }^{j}$ the order param eter. T he equation that (x) has to satisfy in order to $m$ inim ize the free energy of the X Y m odel is Laplace's equation in tw o dim ensions:

$N$ ote that for $=n 2 \mathrm{Z}$, there is indeed no line singularity. For $Z \mathrm{Z}$, there is a line starting at $x_{0}$ and going out to in nity, along which $=v e^{i}$

is discontinuous (we assume $j j=v$ is constant in the ordered phase). To see that there is a discontinuly, we follow a loop around $x_{0}$, and notioe that as we go fiull circle tums by an angle 2 . If $z \mathrm{Z}$, does not retum to its original value as we nish travelling along our loop (rem ember that is de ned $m$ odulo 2 ). Thus there is a half line singularity in ,which implies a half line singularity in . O ne easily checks that this line singularity carries a nite am ount of energy per unit length. Thus, if $z Z$, the free energy of the con guration ${ }_{i=0}$ increases linearly w th the system size. Such a wall with an end is not a topological defect in the strict sense, since it does not carry a $\quad 1$ ( $\mathrm{G}=\mathrm{H}$ ) charge, but its appearance can be understood from analyzing the appropriate exact hom otopy sequence [27]. W e will call it a vortex $w$ ith noninteger charge , and conclude that this vortex is con ned. It is attached to a half-line singularity which corresponds to a dom ain wall, because the "line" bounded by the defect is of one dim ension lower than the dim ension of the space. The usual de nition im plies that an excitation is con ned if its energy increases linearly w th the system size.

A fter sym $m$ etry breaking, the vortices of non-integer charge are con ned. It is conceivable that there are noninteger charges in this phase, connected together by half-line singularities, such that the overall charge is integer. Se Figure 4 for an exam ple of a hadronic com posite of two charge $\frac{1}{2}$ vortioes.

A s m entioned, the crucial characteristic of con ned excitations is that the condensate takes on a di erent value to the left and right of the excitation. W e started by condensing the order param eter eld, such that it took on the value $j_{0}>$ everywhere. Now we have an excitation such that the order param eter eld takes the value $j_{1}>$ to the left, and $j_{r}>$ to the right of the half-line singularity connected to the excitation. To unam biguously de ne the vacuum state $j_{0}>$, we m ust $m$ ake a choige how we treat the excitations. T his
we do by specifying that excitations, both con ned and uncon ned, enter the system from the left. Thus, we set $j_{0}>=j_{r}>$, and as a con ned excitation com es in from the left the condensate to the left of the excitation takes on the value $j_{1}>j_{0}>$. If an uncon ned excitation comes in from the left, then $j_{1}>=j_{r}>=j_{0}>$.

Im agine a particle in a state $j v$ com ing in from the left. $W$ e want to know whether $j>$ is con ned of not, i.e. we need to know if $j_{l}>=j_{r}>$, in which case $j>$ is uncon ned. This is where braiding comes in: $j_{1}>$ is the outcom e of halfforaiding $j_{r}>$ counterclockw ise around $j \geqslant$.Thus, to nd out whether $j>$ is con ned, we braid the condensate around the excitation, using the braid operator R.For jv to be uncon ned, the condensate $j_{r}>$ has to braid trivially around ji > , both clockw ise and counterclockw ise. We m ust check that both braidings are trivial, because the half-line singularity could run along the positive or the negative $x$-axis in $g .4$. This leads to the follow ing test of whether an excitation is con ned or uncon ned:

Let us apply this criterion to the vortices in the XY m odel, to see which ones are uncon ned. Denote a vortex of charge by $j>. W e$ set $j_{r}>=v . T$ hen $j_{r}>$ gets frame dragged as we braid it counterclockw ise around $j>$, and picks up a phase factor $\mathrm{e}^{\mathrm{i} 2}$. C lockw ise braiding is trivial, since we've chosen the convention that the clockw ise braiding of an electric $m$ ode to the right of a defect is trivial ${ }^{7}$. Thus

and a vortex is uncon ned () 2 Z . Thus the defects are precisely the uncon ned vortices.

In the high tem perature phase, the \electric" excitations are irreps of the electric group $U(1)$. If we also consider projective irreps, then the electric excitations are irreps of the universal covering group $U(1)=R$ of $U$ (1). The irreps are denoted by $r$, they are labelled by an $r 2$ R. All these irreps braid trivially $w$ ith the condensate $j_{r}>=v$, because the condensate is in a state $j_{r}>$ in an electric irrep, and electric irreps braid trivially $w$ ith each other. Thus in the ordered phase all the electric excitations are uncon ned. The
situation is di erent from the situation where defects condense as is discussed in [4].

So indeed the phase transition from the high tem perature to the ordered phase in the $X Y$ m odel can in this sense be described as a con ning transition.

3 H opf sym m etry breaking: the form alism

In this section we will rst study sym m etry breaking for a phase described by a general H opf algebra A. Then we will specialize to the cases where A is a modi ed quantum double: $\mathrm{A}=\mathrm{F}\left(\mathrm{H}_{\mathrm{m}}\right) \quad \mathrm{CH}$ el $\cdot$ Thequantum double $\mathrm{D}(\mathrm{H})$ is a special case of the modi ed quantum double, w ith $H_{m}=H_{e l}=H$.

### 3.1 T he criterion for sym $m$ etry breaking

W e consider a physical system whose excitations (or particles) are labeled by irreps of a quasitriangular $H$ opfalgebra A. W e say that a condensate form $s$ in a state $j_{r}>$ of an irrep ofA, so that ourground state is a state lled w ith the particles in the state $j_{r}>$. W e now have to de ne the residual sym $m$ etry algebra $T_{r}, w h i d h$ is a sym $m$ etry algebra $w$ ith the property that the excitations of the new ground state form irreps of $T_{r}$.
$T$ he residual sym $m$ etry algebra $T_{r}$ consists of the operators that are $w e l l$ dened w ith respect to the condensate'. B efore we explain w hat that m eans, let us rst consider the case of a system whose sym m etry is an ordinary group G. $G$ is broken spontaneously to $H$ by a condensate in a state $j_{r}>$ ofan irrep of $G . H$ is the stabilizer of $j_{r}>$, i.e. the subset of sym $m$ etry transform ations in $G$ that leave the condensate invariant. A nd because they leave the condensate invariant we can im plem ent these transform ations on excitations of the condensate. Thus they act on the excitations, and since by de nition they also com m ute w th the H am ittonian, they transform low energy excitations into excitations of sam e energy, which can therefore be organized in irreps of $H$.

N ow consider a particle in state $j>$ of an irrep of the original sym $m$ etry $G$. If we fuse $j \geqslant w$ ith $j_{r}>$, and act on the outcome $j>j_{r}>$ of this fusion w ith an h 2 H , the result is the same as when we act on j $\gg \mathrm{w}$ th h rst, and then fuse the outcom e w ith $j_{r}>$. This follow from

$H$ to be the set of transform ations that are insensitive to fusion $w$ ith the condensate. W hether a particle j $\gg$ in an irrep ofG fuses $w$ ith the condensate or not, the action ofH is the sam e. Thuswe de ne residualsym $m$ etry operators to be operators that are not a ected by fusion w ith the condensate. W hen the sym $m$ etry is spontaneously broken from $G$ to $H$, the residual sym $m$ etry operators are the elem ents of H.
$T$ his de nition of residualsym $m$ etry operator can be carried over to the case of a condensate $j_{r}>$ in an irrep of a $H$ opfsym $m$ etry A. The residualsym $m$ etry operators are the operators that are not a ected by fusion $w$ ith the condensate. $T$ he residual sym $m$ etry operators form a subalgebra of A, whidh we call the residual sym $m$ etry algebra $\mathrm{T}_{\mathrm{r}}$. There is a subtlety in the de nition of $\mathrm{T}_{\mathrm{r}}$ : an operator a 2 A is an elem ent of $\mathrm{T}_{\mathrm{r}}$ if its action on any particle j $\mathrm{J}>$ in any irrep of $A$ is the sam e whether $j \geqslant$ has fused $w$ ith the condensate $j_{r}>$ or not. But we must specify whether $j v$ fuses $w i t h j_{r}>$ from the left or the right! N am ely, in the system s we are considering $\mathrm{j}^{\prime}>j_{r}>$ and $j_{r}>\mathrm{j}_{\mathrm{N}}>$ are not (necessarily) the sam e state, because of the possibility of nontrivial braiding. Thus we have to x a convention. This convention is set by our earlier choige of having allparticles com $e$ in from the left. Rem em ber that we had to $m$ ake this choice because som e excitations of the condensate $m$ ay be con ned. Thus we de ne $\mathrm{T}_{\mathrm{r}}$ as follows: $2 \mathrm{~T}_{\mathrm{r}}$ ( ) for any particle j $\mathrm{j}>$ in any irrep of $A$, we have

In Appendix A we show how to write elem ents of ( $\mathrm{H}_{\mathrm{m}}$ ) CHel as functions f $2 \mathrm{~F}\left(\mathrm{H}_{\mathrm{m}} \quad \mathrm{H}_{\mathrm{el}}\right)$. In this notation the derivations to com e are m ore elegant. C onsider sym $m$ etry breaking by a condensate $j_{r}>$ in an irrep ${ }^{A}$ of $A$.

It is interesting to com pare this criterion to the one in [2]. T here, the residual symmetry algebra is denoted by $T$, and is de ned as the largest Hopf subalgebra of A whose elem ents satisfy

The m otivation for this criterion is: $T$ he residual sym $m$ etry operators act on the condensate like the vacuum irrep " does.

The im portant di erence between $T$ and $T_{r}$ is that we don't require $T_{r}$ to be a H opf algebra. In particular, we don't expect the residual sym $m$ etry to have a coproduct. In fact there is a physical reason why we don't need to have a coproduct for $\mathrm{T}_{\mathrm{r}} . W$ e have chosen the condensate to be $\mathrm{j}_{\mathrm{r}}>$ on the right. If we bring in a con ned excitation from the left, the condensate will be in a state $j_{1}>$ to the left of this excitation. Now consider a second particle com ing in from the left, it sees the condensate $j_{1}>$, and it is therefore an excitation associated w th the residual sym metry of $j_{1}>$, which needn't be equal to the residual sym $m$ etry of $j_{r}>!T h u s$, we have to keep track of the ordering of the particles, i.e. it is crucial to know in which order we brought in the particles from the left. W ew ill see that - not surprisingly -this translates into the absence of a coproduct in $\mathrm{T}_{\mathrm{r}}$, nam ely we can't sim ply fuse irreps of $\mathrm{T}_{\mathrm{r}}$. Before we can discuss this in m ore detail, we need to take a closer look at the structure of the residual sym $m$ etry algebras.

### 3.2 Relationship between $T, T_{r}$ and $T_{1}$

W ew ill now establish a num ber of interesting connections betw een $T, T_{r}$ and $\mathrm{T}_{1}$. All the operators in $\mathrm{T}_{\mathrm{r}}$ and $\mathrm{T}_{1}$ satisfy (23):

Sim ilarly, $T_{1}$ is a Hopfalgebra () $\mathrm{T}_{1}=\mathrm{T}$. A lso, $\mathrm{T}_{\mathrm{r}}=\mathrm{T}$ () $\mathrm{T}_{\mathrm{r}}=\mathrm{T}_{1}$. Thus $\mathrm{T}_{\mathrm{r}}$ and $\mathrm{T}_{1}$ are interesting extensions of T : if they are equal to each other, then they are equal to $T$. Thus, the di erence between $T_{r}$ and $T_{1}$ is a m easure of the departure of $\mathrm{T}_{\mathrm{r}}$ (and $\mathrm{T}_{1}$ ) from being a H opf algebra.

W e need one assum ption about A to prove these propositions: the antipode $S$ ofA must satisfy $S^{2}=i d . M$ odi ed quantum doubles, for exam ple, satisfy this property.

If the original phase is a $D(H)$ phase, then we have sim ilar results: $T_{r}$ is a $H$ opfalgebra if $H$ is abelian, or if $g_{A}$ is in the center of $H$. W e needn't dem and
that all of $H$ acts trivially on $g_{A}$, since this im $m$ ediately follow from $g_{A}$ being in the center of $H$.

### 3.4 Requirem ent on the condensate $j_{r}>$

If the condensate is $j_{r}>$, then our ground state is led $w$ ith the particles in the state $j_{r}>$. We know that if an excitation of this ground state braids nontrivially $w$ ith the condensate, then it is connected to a dom ain wall which costs a nite am ount of energy per unit length. Thus, if $j_{r}>$ were to braid nontrivially w ith itself, it w ouldn't $m$ ake sense to think of a condensate. Thus we require of our condensate $j_{r}>$ that it braid trivially $w$ ith itself:

$N$ ote that we are braiding indistinguishable particles, and if $j_{r}>$ has spin $s$, then the braiding picks up an extra phase factor $\mathrm{e}^{\mathrm{i} 2} \mathrm{~s}$. The spin factor should be taken into account when verifying the trivial self braiding condition.

R ecently ferm ionic condensates have received considerable theoretical and experim ental attention [28], and we could de nitely treat those as well w ith our $m$ ethods.W em ay then relax the trivialselfbraiding condition exactly because identical ferm ions don't braid trivially w ith each other: they pidk up a m inus sign under halftbraiding.

### 3.5 U ncon ned excitations and the algebra U

### 3.5.1 The conditions of trivial braiding

N ow that we've leamed how to derive $\mathrm{T}_{\mathrm{r}}$, we want to study the uncon ned excitations of $T_{r} . W$ e found a criterion for determ ining whether an excitation was con ned: If the excitation doesn't braid trivially $w$ th the condensate $j_{r}>$, then it is con ned.

The condensate is in a state $j_{r}>$ of an irrep of $A$. Now consider an excitation of the ground state, sitting in an irrep of $T_{r}$. Since the universal $R m$ atrix $R={ }_{(R)} R^{(1)} \quad R^{(2)} 2 A \quad A$, we cannot sim ply act $w$ ith $R$ on states in the tensor product representation , because we can only act w ith elem ents of $T_{r}$ on states of . W e need a projection $P$ ofA onto $T_{r}$, so that we can act with (id $P$ )R on states of . If A has an inner product, then we can use this inner product to de ne the projection P. Take an orthonorm al basis $f a_{i} g$ of $T_{r}$, and an orthonom albasis ${ }^{9}$ fbjg of $T_{r}$ ? . Together, the $a_{i}$ and
$b_{j}$ form an orthonorm albasis ofA, such that the $a_{i}$ span $T_{r}$, and for all $i$ and j we have ${ }^{10}$

acts. W e still need a de nition of "trivial braiding". A natural de nition is: braids trivially w ith the condensate if it braids just like the vacuum irrep " does. This de nition immediately implies that the vacuum irrep " is uncon ned, since obviously " braids like " does. Thus the conditions for trivial braiding of an irrep of $T_{r} w$ th the condensate $j_{r}>$ living in the irrep ${ }^{A}$ off ( $\mathrm{H}_{\mathrm{m}}$ ) CHel become

If these equations are satis ed, then we can replace $1 j_{r}>$ in these equations by $j v>j_{r}>$ for any state $j v$ of.$T$ hus if satis es the trivialbraiding conditions (38) and (39), then all the states $j v>$ of braid trivially $w$ ith $j_{r}>$.

An irrep that satis es these two equations is said to braid trivially $w$ ith the condensate. If an irrep doesn't braid trivially w ith the condensate, it is a con ned excitation, attached to a physical string that goes out to in nity which costs a nite am ount of energy per unit length.

### 3.5.2 The uncon ned sym $m$ etry algebra $U$

The trivialbraiding equations (38) and (39) divide the irreps of $T_{r}$ into conned and uncon ned irreps. We cannot sim ply take the tensor product of irreps of $T_{r}$, since $T_{r}$ isn't a $H$ opf algebra. The reason for the absence of a coproduct is the presence of con ned excitations. The condensate to the right of a con ned excitation takes on the value $j_{r}>$, while it takes on a di erent value $j_{1}>$ to the left of the excitation. Thus particles com ing in from the left see a di erent condensate: they are excitations of the residual sym $m$ etry algebra of $j_{1}>$.

The situation is actually a little m ore com plicated, because the value $j_{1}>$ of the condensate to the left of a state $j \geqslant$ of an irrep of $T_{r}$ depends on the explicit state $j \geqslant>$ of.$T$ hus $j_{1}>$ is not unique for an irrep .

W e will discuss how to deal with these issues later. For now, we note that uncon ned excitations do not su er from such complications, since the condensate takes on a constant value around uncon ned excitations. Thus we expect the fusion rules of uncon ned excitations to be associative, if we only consider their com position $w$ th other uncon ned excitations. T here should be a H opf algebra U, called the uncon ned symm etry algebra, whose irreps are precisely the uncon ned irreps, and whose fusion rules give the fusion channels of the uncon ned excitations into other uncon ned excitations.

To obtain $U$, we rst determ ine all uncon ned irreps of $T_{r}$. Then we take the intersection of the kemels of all uncon ned irreps ${ }^{11}$, and denote it by I. F inally, we de ne the algebra

$T$ his is an algebra because $I$ is an ideal (ie. an invariant subalgebra) of $T_{r}$. Its irreps are precisely the uncon ned irreps.

O ur claim is that $U$ is a Hopf algebra. Though we have not attem pted to prove this in full generally, we found it to be true in all the cases we've worked out. In view of our discussion earlier, it is physically natural that U is a H opf algebra, while $T_{r}$ needn't be. H ow ever the $m$ athem atical proof if this conjecture $m$ ay not be so easy, and this de nitely deserves further study. Such a proof should $m$ ake use of the trivial self braiding condition (32) that we form ulated for the condensate $j_{0}>$, because if this condition is dropped then we have found cases where U isn't a H opf algebra.

### 3.5.3 Trivialbraiding for $\mathrm{F}\left(\mathrm{H}_{\mathrm{m}}=\mathrm{B}\right) \quad \mathrm{CN}$

In the next section, we will see that for the electric and defect condensates in a phase w ith $F\left(H_{m}\right) \quad C H_{\text {el }}$ sym $m$ etry, the residual sym $m$ etry algebra $T_{r}$ takes on a special form :

W e will now use these equations to work out $T_{r}$ and $U$ for various condensates in modi ed quantum doubles. We start $w$ ith electric condensates, and show that the conventional theory of electric condensates (Landau's theory) is reproduced. A fter that we study a variety of defect condensates.

4 C ondensates in modi ed quantum doubles

In the previous sections we form ulated the general conditions which determ ine the residual sym $m$ etries in the case where a $H$ opf sym $m$ etry is spontaneously broken by the form ation of a condensate in a state $j_{r}>$. We were led to consider an interm ediate algebra $\mathrm{T}_{\mathrm{r}}$ (or $\mathrm{T}_{1}$ ) and an uncon ned algebra U which would be $m$ anifest in the low energy spectrum of the broken phase. In this section we will present som e rather general derivations of $T_{r}$ and $U$ for certain classes of vacua $j_{r}>$.

W e start w ith a brief discussion of "conventional" sym m etry breaking by an ordinary (electric) type condensate. W e recover the well known results w ith the added feature that the con nem ent of certain types of defect follow sfrom
our form alism. This was already obtained in [2], but w ith a di erent de nition of the residual sym $m$ etry algebra.

In the next subsection we analyze the situations that arise if one considers defect condensates. W e point out that these can be of various types leading to di erent low energy phenom ena.W e refrain from discussing the case ofm ixed (or dyonic) condensates. These can de nitely be studied using our form alism, but they have to be dealt w ith on a case to case basis, while for the case of ordinary and defect condensates we were able to extract general form ulae.

### 4.1 O rdinary (electric) condensates

C onsider a phase described by a quantum double $D$ ( H ) , and condense a state $j_{r}>$ of an electric irrep ${ }^{e}$ of $D(H)$. Then equation (21) tells us that the functions $f$ in $T_{r}$ satisfy

Since the condensate is purely electric, the $m$ agnetic group is unbroken, thus allof ( H ) is present in $\mathrm{T}_{\mathrm{r}} . \mathrm{T}_{\mathrm{r}}$ is a H opf algebra in this case, which im plies that the tensor product of irreps is well de ned, and associative.

Som e defects are con ned. The trivialbraiding conditions (47) and (48) tellus that only the defects $g 2 \mathrm{~N}$ r are uncon ned. Thus the uncon ned sym m etry algebra is

O ne of the consequences of electric sym $m$ etry breaking is the lifting of degeneracies. N am ely, excitations which used to be in the sam e irrep are now split into di erent irreps, which $m$ ay have di erent energies. This splitting of energy levels is experim entally m easurable, in principle.

To treat a phase w ith inversion sym $m$ etry, such as an achiral tetrahedral ne$m$ atic with $F$ ( $T^{\top}$ ) C $T_{d}$ sym $m$ etry (see [3]), we need the form ulae for electric sym $m$ etry breaking ofm odi ed quantum doubles $F\left(H_{m}\right) \quad C H$ el . The derivation of $T_{r}$ and $U$ after the condensation of a state $j_{r}>$ of an electric irrep
of a m odi ed quantum double $\mathrm{F}\left(\mathrm{H}_{\mathrm{m}}\right) \quad \mathrm{CH}$ el is analogous to the derivation given above for a quantum double $D(H)$. The result is

A s an exam ple, we've worked out all possible electric breaking patters from F ( $T^{\prime}$ ) $\mathrm{CT}_{\mathrm{d}}$, see table 1. A though we haven't found references that system atically work out all electric condensates for all irreps as we have done, the theory behind electric condensates is well known and in that sense this is nothing new. O ur interest was to rederive the results for ordinary condensates from the $H$ opf sym $m$ etry description of liquid crystals. A reference that o ers a detailed analysis of the theory of ordinary condensates in bent-core nem atic liquid crystals is [29], where a wealth of non-abelian phases are discussed. A n analysis of the order of the phase transitions using Renom alization group calculations is done in [30].

A s a side note, the transition from $\mathrm{F}\left(\mathrm{T}^{\sim}\right) \quad \mathrm{C} \mathrm{T}_{\mathrm{d}}$ to $\mathrm{F}\left(\mathbb{D}_{2}\right) \quad \mathrm{CD} 2$ in table 1, induced by the condensate of a state in the irrep $E$ of $T_{d}$, is an exam ple of spontaneous sym m etry breaking from an achiral to a chiral phase, since $D_{2}$ does not contain any inversions or re ections, while $T_{d}$ does. This $m$ ay be the explanation of the experim ental discovery of a phase built up of achiral $m$ olecules, whose sym $m$ etry is spontaneously broken to a chiralphase [32]. For a relevant discussion, see [29].

### 4.2 D efect (m agnetic) condensates

There are di erent types ofdefect condensates which we w ish to analyze. C onsider a phase described by a quantum double $D(H)$, or a m odi ed quantum double $F\left(H_{m}\right) \quad C H_{e l}$, and pick a $m$ agnetic representation ${ }_{1}^{A}$ ( 1 is the trivial representation of the centralizer $\mathrm{N}_{\mathrm{A}}$ ). A basis of the vector space on which this irrep acts is given by $f \dot{j}_{i}^{A}>g$, where the $g_{i}^{A}$ are the di erent defects in A. W e consider the follow ing types of condensates:

where $E$ is a subset of the defects in one class. W e need only take the elem ents to be w thin one class because, as we m entioned earlier, we need only study the cases w here the condensate is the sum ofvectors in the sam e irrep.

T he single defect and class sum defect condensates are a special case of com bined defect condensate. The derivation of $T_{r}$ and $U$ for a com bined defect condensate is rather technical, so we will discuss the results for the single defect and class sum defect condensates rst, and then derive the general form ulae.

### 4.2.1 Single defect condensate

C onsider a phase with $D$ ( H ) sym metry, and condense $j_{\mathrm{A}}^{\mathrm{A}}>$ in the $m$ agnetic irrep ${ }_{1}^{A}$. W e're condensing the chosen preferred elem ent in the conjugacy class A. This is not a restriction on our choice of defect, since $g_{A} w$ as chosen arbitrarily. The condensate $\bar{j}_{A}>$ satis es the trivial self braiding condition (32).

$T$ his result for $T_{r}$ has a very natural interpretation: the residualelectric group is $N_{A}$, the subgroup of $H$ that doesn't conjugate the defect. The magnetic part $H=\left(g_{A}\right)$ is not necessarily a group. It consists of left cosets of $\left(g_{A}\right)=$ $\mathrm{f}::: \mathrm{g}_{A}{ }^{1} ; \mathrm{e}_{\mathrm{i}} \mathrm{g}_{\mathrm{A}} ; \mathrm{g}_{A}^{2} ;:: \mathrm{D}$. The defects are now de ned modulo the condensate defect $\dot{j}_{A}>$. Sum $m$ arizing, the uncon ned $m$ agnetic group is $N_{E}=K$, and the uncon ned electric irreps are those that have $(\mathbb{K})$ in their kemel, which $m$ eans that the electric group is $\mathrm{M}_{\mathrm{E}}=(\mathrm{K})$. Thus we have derived (82). H ad we started with a quantum double $D(H)\left(H=H_{e l}=H_{m}\right)$, the uncon ned sym metry algebra becom es $U=D\left(\mathbb{N}_{E}=K\right)$, because in that case $M_{E}=N_{E}$.

In this appendix we sum $m$ arize the $m$ athem atical stnucture and notation connected to the H opf algebras, which are extensively used in this paper and in previous literature. T he applications focus on the quantum double D (H) of a nite (possibly non-abelian) group H.T he essential inform ation is collected in a few com prehensive tables. In the text we m erely com $m$ ent on the $m$ eaning and the physical interpretation/relevance of the basic concepts. W e conclude w ith a discussion ofm odi ed quantum doubles.

A lgebras are an ubiquitous $m$ athem atical structure. A nother $-m$ aybe less fam iliar m athem atical notion - is that of a coalgebra, a structure that is in a precise sense a dual object to an algebra. A H opf algebra is sim ultaneously an algebra and a coalgebra, w ith certain com patibility conditions betw een the tw o structures. In the follow ing subsections we system atically go through som e de nitions and im portant exam ples.

## A. 1 A lgebras, coalgebras, and their duals

An algebra $A$ is a vector space over a eld $F$ (which we will take to be C), w th a bilinear multiplication. W e can think of the multiplication as a map
: A A 7 A. The algebras we discuss $w$ ill all have a unit elem ent, i.e. an elem ent 1 which satis es $1 \mathrm{a}=\mathrm{al}=\mathrm{a} 8 \mathrm{a} 2 \mathrm{~A}$. Thinking of it as a map one could say that the unit embeds the eld F into the center of the algebra. We write : F 7 A. W e require that be an algebra m onphism (the eld is also an algebra, w ith itself as ground eld). The algebras we consider are associative w ith respect to their m ultiplication.

A $n$ im portant exam ple for our punposes is the group algebra of a nite group. Label the groups elem ents by $h_{i}$. The group algebra is then the set of ob jects of the form ${ }^{\mathrm{P}} \mathrm{i}_{\mathrm{i}} \mathrm{h}_{\mathrm{i}}$, w ith ${ }_{i} 2 \mathrm{C}$. This algebra is im portant, as it contains all the inform ation about the group. For exam ple, irreducible representations of the group algebra are in one-to-one correspondence w ith irreducible representations of the group.
In the physical models we consider, the regular (electric) m odes transform under an irrep of the group, which is equivalent to saying that they transform under an irrep of the corresponding group algebra.

A coalgebra $C$ is a vector space equipped w ith a com ultiplication and counit. The com ultiplication is a linear map : C 7 C C.The counit is a linear $\mathrm{map}: C$ I F. They m ust satisfy the form al relations:

W e see in Table 4 that the group algebra naturally has a coalgebra structure, where the com ultiplication de nes the action of the group on the tensor product space.

G iven an algebra A, its dual ${ }^{14}$ A can be given a natural coalgebra structure. Sim ilarly, given a nite dim ensionalcoalgebra, its dualhas a algebra structure (in a slightly less natural way rem iniscent of the isom onphism A $\quad$ A for a nite dim ensional vector space). T he structure of the duals are given in Table 4 , and the structures are given explicitly for the group algebra and the function algebra, which are each other's duals. A n exam ple of a dual structure is the follow ing: given a coalgebra $C$ w ith a coproduct, the dualC has the follow ing m ultiplication (which we denote by a star ?): $\mathrm{f}_{1}$ ? $\mathrm{f}_{2}(\mathrm{x}) \quad\left(\mathrm{f}_{1} \quad \mathrm{f}_{2}\right.$ ) ( x ). Thus the coproduct of $C$ is used to de ne the multiplication in C . Sim ilarly, the counit of $C$ is used to de ne the unit in C.
$F(H)$, the set of functions from $H$ to $C$, is the coalgebra dual to the algebra CH. It is also an algebra, and in fact it is a H opf algebra (see next section). ## A. 2 H opf algebra's

A Hopf algebra is sim ultaneously an algebra and a coalgebra, with certain com patibility conditions. N am ely, we dem and that and be algebra m orphism s. This is equivalent to dem anding that and be coalgebra m orphism s (see [33]).
A H opf algebra also contains an antipodalm ap $S$, which is the unique $m$ ap from A to $A$ that satis es

Physically, the antipode $m$ ap is used to construct antiparticle representations out of particle representations. This will becom e clear if we are to talk about representation theory, where given an irrep , we de ne the antiparticle or conjugate irrep as ${ }^{-}$(a) $={ }^{\mathrm{t}} \mathrm{S}(\mathrm{a})$, where $t$ denotes transposition. ${ }^{-}$is an irrep because $S$ is an antim orphism, and so is the transposition. $W$ hen we fuse
particle and antiparticle irreps, we don't necessarily get the vacuum representation, but it is guaranteed that " is present in the fusion rules. This is com pletely analogous to the case of ordinary groups.

T he standard exam ple of a $H$ opfalgebra is the group algebra. W e have already discussed the algebraic and coalgebraic structure. It is tumed into a H opf algebra by de ning the antipode $S$ as the inverse:

So in fact all the fam iliar ingredients of a group (algebra) m ake it already into a H opf algebra. G iven a nite dim ensional H opf algebra $A$, one can quite generally de ne a H opf algebra structure on A , and A is then called the dual H opf algebra. T he de nitions are quite natural and are given in Table 4. $N$ ote that for the dual H opf algebra $F(H)=C H \quad$ the antipodalm ap again involves the inverse, in the sense that $S(f)(x)=f\left(x^{1}\right)$.

In the context of our physical applications, the dual version of the algebra has very much to do w ith the topological defects and could be called the $\backslash m$ agnetic" part of the algebra. W hen we have discussed the representation theory it w ill becom e clear what the physical states are and what the action of the elem ents of the dualalgebra $m$ ean. O ne thing that $m$ ay already be clear at this point is that, if the topological charge corresponds to a group elem ent, then the com ultiplication of the dualor function algebra determ ines the action on the tensor product representation of the dual, and therefore describes the fusion properties of the defects. It is then clear from the expressions (A.1) and (A 2) that the fision indeed leads to the required multiplication of group elem ents.

The action of the $R$ elem ent on a tensorproduct of two representations is to \braid" the two particles and is of crucial im portance to get the com plete physical picture of particles and defects which exhibit nontrivialbraid properties. From the rst equations (A.9) one derives that the Yang-Baxter equation is satis ed. Equation (A.10) is the im portant statem ent that the generators of the braid group com $m$ ute w th the action of the H opf algebra. This leads to the decom position ofm ulti-particle states in product representations of the braid and the H opf algebra, thereby allow ing for a clear de nition of what we $m$ ean by quantum statistics and nonabelian anyons, etc. W ew ill retum to this sub ject shortly.

## A. 4 The quantum double

G iven a H opf algebra A, there is a naturalw ay to \double" it, creating a new H opfalgebra D (A ) called D rinfeld's quantum double of A. A s a vector space, $D(A)=A \quad A, s o$ it's a tensor product of $A$ and its dual. For the discussion of the H opf algebra structure on D (A), see [33]. For our purposes, we need only know what the structure is like for H a discrete group. W e also specify a braid $m$ atrix, $m$ aking it a quasitriangular $H$ opf algebra.
A svector space, $D(H)$ is $F(H) C H$, which is the sam easF ( $H \quad H$ ) for nite $H$. Denote the basis elem ents of $D(H)$ as ( $f_{i} \quad h_{j}$ ) or $P_{h} g$ (the latter is the notation used in [6]), where g 2 H , and $\mathrm{P}_{\mathrm{h}} 2 \mathrm{~F}$ (H) is de ned by $\mathrm{P}_{\mathrm{h}}(\mathrm{x})={ }_{\mathrm{h} ; \mathrm{x}}$ ( x 2 H ).

This form ulation is also im portant because it can be carried over to de ne the quantum doubles of continuous groups $H$, where $H$ is com pact, or locally com pact. For results on such cases, see [34] and [35].

W e nally should $m$ ention that the quantum double has a central elem ent, denoted by c and called the ribbon elem ent. Its eigenvalue can be used as a label on the representations of the D (H ). In applications it de nes the phase obtained after rotating the particle state by 2 and is therefore called the spin factor of a given representation. It plays a central role in de ning a suitable generalization of the spin statistics connection, to which we tum next.

## A. 5 A non-A belian spin statistics connection

Let us brie y retum to the im portant role played by the $R$ elem ent which as $m$ entioned, generates the action of the braid group on a m ulti-particle states corresponding to som e state in a tensor product of representations of ( H ). W e noted already that the braiding with R com m utes w ith action of $(\mathrm{H})$ :

From this it follows that the n-particle states form representations ofD ( H ) $\mathrm{B}_{\mathrm{n}}$, w th $\mathrm{B}_{\mathrm{n}}$ the braid group on n strands. W e speak of non-abelian statistics if the theory realizes states that correspond to higher dim ensional representations of $B_{n}$. In this context it is an im portant question to what extent one can still speak of a spin-statistics connection. O ne can indeed w rite down a generalized spin-statistics theorem in term s of the action of the braid group end the central ribb on elem ent whidh corresponds to physically rotating the defect over an angle 2 and therefore generating the phase factor due to the (fractional) spin of the particle in question. It reads:

It is no longer an attribute carried by a single particle. It may involve two di erent particles (m utual statistics) and is also dependent on the channel in which they are fused.

## A. 6 Representation theory

The irreducible representations of $D(H)$ follow from the observation that it's a transform ation group algebra (see [2] for details). Since we w ill com e across other transform ation group algebras in the $m$ ain text, we give the general de nition. A s a vector space, the transform ation group algebra is F (X) CH, where X is a nite set and H is a nite group. A basis is given by

The quantum double $D(H)$ is a special case of a transform ation group algebra, w th $\mathrm{X}=\mathrm{H}$ and $\mathrm{h} \quad \mathrm{x}=\mathrm{hxh}{ }^{1}$. Thus in $\mathrm{D}(\mathrm{H})$ the orbits of $\mathrm{X}=\mathrm{H}$ under the action of $H$ are conjugacy class of $X=H \cdot N_{A}$ is the centralizer of the preferred elem ent $g_{A}$ of $A$.

W e proved earlier on that the antipode can be used to create an antiparticle irrep from any irrep ${ }^{A}$. In the case of $D(H)$, the antiparticle irrep of ${ }^{A}$ is $\underline{A}^{1}$, where $A^{1}$ is the conjugacy class of $g_{A}{ }^{1}$, and $-(n)={ }^{t}\left(n^{1}\right)$. In particle, for an electric irrep e the antiparticle ireep is e.An example of this is the 3 irrep of $S U$ (3), which is the antiparticle irrep of 3 . The quarks transform under the 3 irrep, while the antiquarks transform under the $\overline{3}$ irrep of $U$ (3).

In the $m$ ain text we cam e across phases whose $H$ opfsym $m$ etry was a variation on a quantum double, which we called a m odi ed quantum double. W e will now give the general de nition of a m odi ed quantum doub $\mathrm{e}^{16}$.

$\mathrm{T}_{\mathrm{r}}$ is not alw ays a H opf algebra, because the coproduct of A does not necessarily satisfy ( $T_{r}$ ) $T_{r} \quad T_{r}$. It does satisfy $\quad\left(T_{r}\right)$ A $T_{r}$. Thismeans that we cannot take the tensor product of irreps of $\mathrm{T}_{\mathrm{r}}$, in other words we cannot fuse two particles in $T_{r}$. We can only fuse particles in $T_{r} w$ th particles of A com ing in from the left.

The reason we can't fuse particles of $T_{r}$ is that som e excitations of the condensate $j_{r}>$ are con ned. The condensate takes on the value $j_{r}>$ to the right, and $j_{1}>j_{r}>$ to the left ofa con ned excitation, in an irrep of $T_{r}$. $T$ hus particles com ing in from the left see the condensate $j_{1}>$. $T$ hus particles to the left of are excitations of $j_{1}>$, and they transform under irreducible representations of the right residual sym $m$ etry algebra of $j_{1}>$.
$M$ atters are com plicated further.by the observation that given two states $\mathrm{j}_{1}>$ and $j_{2}>$ in a con ned irrep, the value of the condensate to the left of $j_{1}>$ need not be equal to the value the condensate takes to the left of $\mathrm{j}_{2}>$. Thus the condensate does not take a well de ned value to the left of the irrep .

O ne possible interpretation of a con guration w ith a con ned excitation , is that the condensate has only condensed to the right of .To the left of the system is in the unbroken phase, w ith A sym m etry. Thus particles to the left of are irreps of A. W e can fuse particles in irreps of A w th , and look at the fusion rules. The outcom e of this fusion tells us w hat the particle in the irrep A can becom e when it enters the ordered phase.

This interpretation of a con ned excitation is reasonable, but it is unsatisfactory. N am ely, we still want to be a able to firse the irreps of the residual
symm etry algebra. There should be a nite set of quantum numbers in the broken phase, and we should be able to tell which of these quantum num bers can form hadronic com posites. W e want to be able to talk about the fusion of the quantum numbers in the broken phase w ithout bringing in the quantum num bers of $A$. $W$ e know that if $\mathrm{T}_{r}$ is a H opfalgebra, we can fuse irreps of $\mathrm{T}_{r}$. W ew ill now discuss how to fuse irreps of $T_{r}$ when $T_{r}$ is not a $H$ opfalgebra.

## B. 1 A purely magnetic phase

Let us rst study a sim ple system that only hasm agnetic degrees of freedom. Its sym $m$ etry algebra is $F$ ( $H$ ), w th $H$ som e nite group. A s an exam ple, we consider a phase described by the quantum double of the double cover of an even dihedral group: $\mathrm{A}=\mathrm{D}\left(\overline{\mathrm{D}_{2 n}}\right)$. The group $\overline{\mathrm{D}_{2 \mathrm{n}}}$ has the follow ing structure:

W ew rite the basis of the irrep $\frac{i}{k}$ as $\ddot{i}>; j$ i>, where $\ddot{i}>$ corresponds to the defect $j r^{i}(s)>$ (rem em ber that the defects are de ned $m$ odulo the condensate $\langle s\rangle)$. The action of $\mathrm{T}_{\mathrm{r}}$ on this basis is set by

The uncon ned irreps are given in Table 8. This fusion nules im plies, for example, that ${ }_{1}^{i}$ and ${ }_{1}^{n}$ can fuse to ${ }_{2}^{n}$, which is uncon ned. Thus we have $m$ ade a hadronic com posite.

If we choose $\left(r^{i}(s)\right)=r^{i} s$, the fusion rules are the sam $e$, even though the coproduct is not coassociative. H owever, in this case the de nition of the particles is altered. N am ely, if an irrep $\underset{k}{i}$ is present to the right, then $j>$ in the irrep ${ }_{1}^{j}$ com ing in from the left should be intenpreted as j j>. This can be checked by applying the projection operators:

W e have therefore discovered that our choige of coproduct ${ }^{0}$ alters the $m$ eaning of the labels of our irreps, when they are to the right of a con ned excitation. T he reason for this is the follow ing: we can determ ine the irreps of $\mathrm{T}_{\mathrm{r}}$, and that gives us a nite set of labels. W hen we have one particle in an irrep of $\mathrm{T}_{\mathrm{r}}$ in the system, its m eaning is unam biguous. N ow if a con ned excitation is present, then we know that the residual sym m etry algebra of the condensate ${ }_{l}$ to the left of the excitation $m$ ay be di erent from the right residual sym $m$ etry algebra $T_{r}$. H ow ever, we still want to use the sam e labels for particles to the left of the con ned excitations, because they are excitations of a sym $m$ etry algebra isom onphic to $\mathrm{T}_{\mathrm{r}}$. Thus we are adding inform ation to the labels of irreps of $T_{r}$, nam ely we are de ning their m eaning w hen they appear to the left of a con ned excitation. T hey should not be considered as the sam e particle: for exam ple, 屰> $\ddot{j}>$ should not be interpreted as the fision of $\ddot{j}>$ w ith itself. The correct intenpretation is that we have the con ned excitation ii $>$ of $\mathrm{T}_{\mathrm{r}}$, and we brought in a particle from the left, which under our choige of coproduct is labelled by ï>.

In sum $m$ ary, for the $j>$ condensate in $D\left(\overline{D_{2 n}}\right)$, the fusion nules are independent of the choige of coproduct. W e do not expect this to be a general result
(although in the cases we've worked out the fusion rules don't depend on the choice of coproduct). T he physics of the phase, on the other hand, should not depend on our choige of coproduct, since this choice boils dow $n$ to a de nition of our labels. An interesting follow up on this research would be to study the in uence of the choige of coproduct on the fusion rules.

19 : W e take even dihedral groups, because in $D\left(\overline{D_{2 n+1}}\right)$, condensing is > yields $U=C e$, which is slightly less interesting, but note that we can still study hadrons! O nly the hadron $m$ ust be in the trivial irrep, since that is the only uncon ned irrep.
