Determ inistic quantum state transfer from an electronic charge qubit to a photonic polarization qubit

Building on an earlier proposal for the production of polarization-entangled m icrow aves by m eans of intraband transitions in a pair of quantum dots, we show how this device can be used to transfer an unknown single-qubit state from electronic charge to photonic polarization degrees of freedom. No postselection is required, m eaning that the quantum state transfer happens determ inistically. D ecoherence of the charge qubit causes a non-m onotonic decay of the delity of the transferred state with increasing decoherence rate.

Quantum state transfer between matter and light is a key step in the developm ent of scalable quantum networks. A qubit 10i+ i is encoded in matter degrees of freedom for the purpose of computation, and then transferred to photon ic degrees of freedom for transportation to a distant location (where it m ight be converted back to matter for storage or further processing). A prom ising schem e¹ to accom plish this in the context of atom ic physics uses a laser beam to transfer the internal state of an atom to the optical state of a cavity mode. The matter qubit in this case is a superposition of two degenerate ground states of the atom and the photonic qubit is the superposition of an occupied and an empty cavity mode. An all-electronic analogue of this scheme, to transfer a state from one matter qubit to another, has been proposed as $w \in \mathbb{R}^2$

In the context of sem iconductor quantum dots there exist several proposals for the transfer of a quantum state from electron spin degrees of freedom (spin qubit) to photon polarization degrees of freedom $3^{,4}$ A separate line of investigation in this context involves a charge qubit, $5^{,6}$ i.e. a single-electron state $A^{,i+}$ B i delocalized over a pair of quantum dots A and B. The coupling of a charge qubit to a photon cavity m ode was investigated in Ref. 7, as a way to produce polarization-entangled photon pairs at m icrow ave frequencies. Here we build on that proposal to show that the combination of a m icrow ave resonator and three quantum dots can be used to transfer an arbitrary single-qubit state from electron charge to photon polarization degrees of freedom.




FIG.1: Schematic of the model. The upper panel shows a top view of three quantum dots A; B; C connected to an electron reservoir, the lower panel shows the resonant energy levels in the quantum dots. An electron can tunnel between dots A and C or between dots B and C (solid arrows), but not directly between dots A and B. From dot C, the electron can tunnel into the reservoir (dashed arrow), while the reverse process is prevented by a large bias voltage. A radiative transition within dots A or B is accompanied by the emission or absorption of a photon, with respectively left ($_+$) or right () circular polarization. The coupled electron-photon dynamics transfers the charge qubit $A^{0}i+B^{0}i$ to the photon qubit j+i+j i.

The device for quantum state transfer, shown schem atically in Fig. 1, di ers from the photon entangle⁷ only in that it produces a single photon rather than a photon pair. The resonant transitions involve a total of ve electron levels in three quantum dots: three ground states A;B;C and two excited states A⁰;B⁰. The radiative transitions A⁰ \$ A and B⁰ \$ B are resonant with a cavity m ode. As explained in detail in Ref. 7, the con ning potential and m agnetic eld can be arranged such that the transition in dot A couples only to left circular polarization + and the transition in dot B couples only to right circular polarization .

The charge qubit is prepared initially in the state

where jDi denotes the photon vacuum. This singleelectron state in dots A and B can decay into a reservoir via a third dot C, leaving behind a photon in the cavity. The quantum state transfer has succeeded if the nal state is

where D i is the electron vacuum (all quantum dots empty) and j i represents the two photon states of opposite circular polarization. For later use we de ne also the states

The reversible radiative transitions (with rate g) are described by the $\operatorname{H}\operatorname{am}$ iltonian

The reversible tunnel transitions (with rate ${\tt T}$) between dots A or B and dot C have H am iltonian

where $\mathbbm{1}_{\text{photon}}$ is the unit operator acting on the photons.

The irreversible escape (with rate $\)$ of the electron from dot C into the reservoir is described by the jump operator

T here operators determ ine the time evolution of the density matrix (t) through the master equation 8,9

(We have set ~ to 1.) The initial condition is (0) = j_{in} in j_{in} .

Inspection of the master equation shows that the density matrix evolves entirely in the ve-dimensional subspace spanned by the states

of even parity under the exchange \$, A \$ B, A⁰\$ B⁰, + \$. The states ($A^{0}i B^{0}i$) Di, j + ij i, j ij + i, C ij i, and D ij i of odd parity do not appear.

The ve-dimensional subspace may be further reduced to a four-dimensional subspace by noting that the master equation (8) couples only to $_{55}$ and to $_{ij}$ with i;j 4. The matrix elements $_{ij}$ with $i = 5; j \in 5$ or $j = 5; i \in 5$ remain zero. We may therefore seek a solution of the form

W hat is important for determ inistic quantum state transfer is that all four eigenvalues $_{i}$ have a negative real part, for any nonzero g, T, and . 


FIG.2: Contour plot of the rate [de ned in Eq. (15)] at which the delity of the quantum state transfer approaches unity, as a function of the tunnel rates T and . All rates are norm alized by the electron-photon coupling constant g.

If one varies and T at xed g, the rate reaches its maximum of $m_{ax} = g \text{ at } T = g = 1$; =g = 4. (See Fig.2.) That vanishes for large ;T;g can be understood as a manifestation of the quantum Zeno e ect¹⁰ the electron remains trapped in the quantum dots because the decay into the reservoir is inhibited by too frequent m easurement. The optimal rate $m_{ax} = g$ in plies that about 1 optical cycle of em ission/absorption of the photon in the cavity is needed to e ectively transfer the state. This seem s fast enough, in view of the inevitable losses in the cavity.

The delity of the quantum state transfer is reduced by decoherence of the charge qubit due to coupling of the charge to acoustic phonons^{11,12} or to background charge uctuations^{1,3} Following Ref. 14 we model this decoherence (with rate) by means of the jump operators

which m easure the charge on each of the three dots. The master equation (8) now becomes

where D was de ned in Eq. (7). In what follows we take $= \frac{1}{2}^{p} \overline{2}$: since the initial state (1) is then maximally delocalized, it will be most sensitive to decoherence.




FIG. 3: Decay of the long-time delity F_1 of the quantum state transfer with increasing decoherence rate. We have taken $= \frac{1}{2}^{1}$ 2. The solid curve is for parameter values at which the quantum state transfer is least sensitive to decoherence.

Results for F $_1 = \lim_{t \le 1} F$ (t) are plotted in Fig.3 for two parameter choices. The asymptotic limits are

Note that B is independent of . By comparing the expression (20) for the coe cient A with Eq. (16) for the transfer rate , we see that $F_1 = 1 = 2 + 0$ (²) if one of the three rates ;g;T is much larger than the other two. In this regime the sensitivity to decoherence is determined entirely by how fast the state can be transferred.

As found in Ref. 7 in connection with the entanglem ent production, the e ect of decoherence on the charge qubit is minimal if T g. More precisely, the delity F_1 is maximized for xed g and if T = $g = \frac{2}{5}$ 0:89; $=g = \frac{2}{5}$ 5 39 2:50 if 1 3 0**:**87 if g. As q and if T=q =shown in Fig. 3 the delity depends non-monotonically

on , approaching the asymptotic limit $\frac{1}{2}$ from below for $T=g > \frac{1}{3=2}$ 1.22. When $F_1 < \frac{1}{2}$ the delity of the quantum state transfer can be improved by exchanging the photon polarizations ($_+$ \$), so that F_1 7 1 F_1 . With this procedure the delity may actually increase with increasing .

In conclusion, we have analyzed a mechanism for the quantum state transfer from charge qubits to photon qubits which is determ inistic (no post-selection is required) and which depends only algebraically on the decoherence rate. The mechanism relies on the coupled dynam ics of an electron and a photon in a microw ave cavity, but the transfer can be su ciently fast so that only a few optical cycles of emission/absorption are required. Decoherence rates as large as 10% of the emission rate then

do not degrade the delity of the quantum state transfer below about 0.9. These characteristics suggest that the mechanism considered here might have promising applications in quantum information processing.
