We analyse the e ciency of several simulation methods which we have recently proposed for calculating rate constants for rare events in stochastic dynamical systems, in or out of equilibrium. We derive analytical expressions for the computational cost of using these methods, and for the statistical error in the nalestimate of the rate constant, for a given computational cost. These expressions can be used to determ ine which method to use for a given problem, to optimize the choice of parameters, and to evaluate the signi cance of the results obtained. We apply the expressions to the two-dimensional non-equilibrium rare event problem proposed by Maier and Stein. For this problem, our analysis gives accurate quantitative predictions for the computational e ciency of the three methods.

I. IN TRODUCTION

R are events are processes which happen rapidly, yet infrequently. Specialized techniques are required in order to study these events using computer simulation. This is because, in \brute force" simulations, the vast maprity of the computational e ort is used in simulating the uninteresting waiting periods between events, so that observing enough events for reliable statistical analysis is generally impossible. The quantities of interest from the simulation point of view are generally the rate constant for the rare transitions between the initial and nal states and the properties of the Transition P ath E nsem ble (TPE) - the (correctly weighted) collection of transition trajectories. W hen com puting these quantities, it is very in portant to know the statistical error in the calculated value, and the likely cost of the computation. In this paper, we derive approximate expressions for these quantities, for three rare event simulation m ethods which we proposed in a recent publication [1]. These expressions tum out to be surprisingly accurate for simulations of a m odel rare event problem . Our results allow us to quantify the computationale ciency of the three methods.

The three \FFS-type" simulation methods allow the computation of both the rate constant and the transition paths for rare events in equilibrium or non-equilibrium steady-state systems with stochastic dynamics. In all three methods, a series of interfaces are de ned between the initial and nal states. The rate constant is given by the ux of trajectories crossing the rst interface, multiplied by the probability that these trajectories subsequently reach B. The latter probability is computed by carrying out a series of \trial" runs between successive interfaces; this procedure also generates transition paths, which are chains of connected successful trial runs. The methods di er in the way the trial runs are red and the transition paths are generated. In the \forward ux sam - pling" (FFS) method, a collection of points is generated

at the rst interface and trial runs are used to propagate this collection of points to subsequent interfaces – thus generating m any transition paths simultaneously. In the branched growth (BG) m ethod, a single point is generated at the rst interface and is used as the starting point for multiple trial runs to the next interface. Each successful trial generates a starting point for multiple trials to the following interface, so that a \branching tree" of transition paths is generated. In the Rosenbluth (RB) m ethod, a single starting point is chosen at the rst interface, multiple trial runs are carried out, but only one successful trial is used to propagate the path to the next interface – thus unbranched transition paths are generated. In this m ethod, a re-w eighting step is needed to ensure correctly w eighted transition paths.

A range of simulation techniques for rare events in soft condensed matter systems are currently available. In Bennett-Chandler-type methods, the rate constant is obtained via a computation of a free energy barrier [2]. In Transition Path Sampling (TPS) [3], transition trajectories (paths) are generated by shooting forwards and backwards in time from already existing paths, and are then sampled using a M onte Carlo procedure. The rate constant is obtained via the computation of a time correlation function. Bennett-Chandler-type m ethods and TPS are suitable for system swith stochastic or determ inistic dynam ics, but they require know ledge of the steady state phase space density, which means that the system must be in equilibrium . W hile the FFS-type m ethods are only suitable for system s with stochastic dynam ics, they do not require the phase space density to be known and can therefore be used for non-equilibrium steady states not satisfying detailed balance. To our know ledge, the only other path sam pling m ethod that is suitable for nonequilibrium systems is that proposed recently by Crooks and Chandler [4], which adopts a \TPS"-type m ethodology, generating new stochastic paths from old paths by changing the random num ber history.

The origin of the e ciency of the FFS-type methods is that they use a series of interfaces in phase space between the initial and nal states to divide up the transition paths into a series of connected \partial paths".

These partial paths are generated in a ratchet-like m anner - i.e. once a particular interface has been reached, the system con guration is stored and is used to initiate trial runs to the next interface. Many other rare event techniques also use a series of interfaces in phase space. In Transition Interface Sampling (TIS) [5] and Partial Path Transition Interface Sampling (PPT IS) [6], interfaces are used to facilitate the generation of transition paths by a TPS-like procedure. In M ilestoning [7], trajectories are generated between interfaces assuming a steady-state distribution at each interface, while string m ethods [8, 9] use a series of planes in phase space to allow a trajectory connecting the initial and nal states to relax to the minimum free energy path. The advantages of the FFS-type m ethods over other transition path and rate constant calculation m ethods are that no assum ptions arem ade about \loss ofm em ory" during the transition, no a priori know ledge is required of the steady state phase space density, and the rate constant is obtained in a simple and straightforward way. We have recently becom e aware that the BG method bears resemblance to the RESTART method, used for simulating telecommunications networks [10, 11, 12] (this approach was originally introduced by Bayes [13]). The e ciency of that m ethod has also been analysed [11]. A related m ethod, known as W eighted Ensemble Brownian Dynamics, has been applied to protein association reactions [14].

The key aim of a rare event simulation technique is to calculate the rate constant, or in som e cases, obtain the TPE, with enhanced e ciency, compared to brute force simulations. However, quantifying the e ciency of a particular simulation method is often di cult. O uraim in this paper is to derive simple but accurate expressions for the computational cost and statistical accuracy of the three FFS-type methods. We de ne the \e ciency" of the m ethods to be the inverse of the product of the cost and the variance in the calculated rate constant; our results then allow us to analyse the e ciency of the methods in a system atic way. From a practical point of view, we expect the expressions derived here to be of use to those carrying out simulations in two ways. Firstly, when faced with a rare event problem, one often has a limited am ount of com puter tim e available, and speci c requirem ents as to the desired accuracy of the calculated rate constant. A nalytical expressions for the cost and statistical accuracy would allow one to estimate, before beginning the calculation, whether the desired accuracy can be obtained within the available time, and thus to make an inform ed decision as to which, if any, m ethod to use. Secondly, after completing a rate constant calculation, one needs to obtain error bars on the resulting value - this is especially in portant for rare events, where both experimental and simulation results can be highly inaccurate. In general, error estimation requires the calculation to be repeated several times, which is computationally expensive. How ever, if analytical expressions were available for the statistical accuracy, in term s of quantities which were already measured during the rate constant calculation, one could obtain the error bars on the predicted rate constant, to within reasonable accuracy, without the need for lengthy additional calculations. In this paper, we derive such analytical expressions.

Approximate expressions are derived for the cost, in simulation steps, and for the variance in the calculated rate constant, for the three FFS-type m ethods. W e initially treat the simple case where all trials red from one interface have equal probability of succeeding. We then move on to the more realistic case where the probability of reaching the next interface depends on the identity of the starting point. To this end, we include in our calculations the \landscape variance" - the variance in the probability of reaching the next interface, due to the characteristic \landscape" for this particular rare event problem. Our expressions are functions of user-de ned param eters, such as the num ber of trial runs per point at a particular interface, as well as parameters characterizing the rare event problem itself, such as the probability that a trial run succeeds in reaching the next interface.

We analyse the e ciency of the three methods as a function of the parameters, for a \generalized" model system. We nd that the optimum e ciency is similar for all three methods, but that the e ects of changing the parameter values are very dierent for the three methods. In particular, the BG method performs well only within a narrow range of parameter values, while the FFS and RB methods are more robust to changes in the parameters. The RB method has consistently lower e ciency, due to its requirement for an acceptance/rejection step - how ever, RB m ay be more suitable for applications where analysis of transition paths as well as rates is needed, or where storage of con gurations is very expensive.

To test the accuracy of our predictions in the context of a real simulation problem, we then apply the three FFS-type methods to the two-dimensional nonequilibrium rare event problem proposed by M aier and Stein [15, 16, 17]. We measure the computational cost of the methods and the variance in the nal value of the rate constant, and we compare these to the cost and variance predicted by the expressions derived earlier. We nd that the expressions give remarkably good predictions, both for the cost and the variance. This suggests that the expressions can, indeed, be used to give accurate and easy-to-calculate error estimates for real simulation problem s.

In Section II, we brie y describe the three FFS-type m ethods. Expressions for the com putational cost and for the statistical error in the calculated rate constant are derived in Section III. In Section IV, these expressions are shown to be accurate for the two-dim ensional non-equilibrium rare event problem proposed by M aier and Stein. Finally, we discuss our conclusions in Section V.




FIG.1: Schematic illustration of the denition of regions A and B and the interfaces $_0::::_n$ (Here, n = 3). Three transition paths are shown.

The FFS-type m ethods use the \e ective positive ux" expression for the rate constant, which was rigorously derived by Van Erp et al [5, 6, 18, 19, 20]. The rare event consists of a transition between two regions of phase space A (x) and B (x), where x denotes the coordinates of the phase space. The transition occurs much faster than the average waiting time in the A state. We assume that a parameter (x) can be de ned, such that < A in A and > $_{\rm B}$ in B. A series of values of , $_{0}$::: $_{\rm n}$, are chosen such that 0 A/ n $_{\rm B}$ and $_{\rm i} < _{\rm i1}$. These must constitute a series of non-intersecting surfaces in phase space, such that any transition path leading from A to B passes through each surface in turn. This is illustrated in Figure 1.

The rate constant k_{AB} can be expressed as [20]

In Eq. (1), h_A is a history-dependent function describing whether the system was more recently in A or B: $h_{A} = 1$ if the system was more recently in A than in B, and $h_A = 0$ otherwise [5, 18, 20]. The over-bar denotes a time average. A_{ij} is the ux of trajectories with $h_A = 1$ that cross i for the rst time - i.e. those trajectories that cross i, having been in A more recently than any previous crossings of $j \cdot P(jj_i)$ is the probability that a trajectory that com es from A and crosses i for the rst time will subsequently reach i before returning to A: thus P ($_n j_0$) is the probability that a trajectory that leaves A and crosses 0 will subsequently reach B before returning to A. Eq.(1) states that the ux of trajectories from A to B can be expressed as the ux leaving A and crossing 0, multiplied by the probability that one of these trajectories will subsequently arrive at B rather that returning to A . P ($_{n} j_{0}$) can be expressed as the product of the probabilities of reaching each successive interface from the previous one, without returning to A:

For simplicity of notation, in what follows, we de ne $P_B = P(\underline{n}j_0), p_i = P(\underline{i+1}j_i), q_i = 1 = p_i$ and $A_{i,0} = h_A$. We also use the superscript \e" to indicate an estimated value of a particular quantity.

P reviously, we described in detail three di erent approaches-the \forward ux sam pling" (FFS), \branched growth" (BG) and \Rosenbluth " (RB) m ethods-to calculating k_{AB} , based on expressions (1) and (2) [1, 21]. For com pleteness, we brie y repeat the description here.

A. Forward ux sam pling

In FFS, the ux is measured using a free simulation in the basin of attraction of region A. When the system leaves A and crosses $_0$ for the rst time (since leaving A), its phase space coordinates are stored and the run is continued. In this way, a collection of N $_0$ points at $_0$ is generated, after which the simulation run is term inated.

The probabilities p_i are then estimated using a trial run procedure. Beginning with the collection of points at $_0$, a large number M $_0$ of trials are carried out. For each trial, a point is selected at random from the collection at $_0$. This point is used to initiate a simulation run, which is continued until the system either crosses the next interface $_1$, or re-enters A. If $_1$ is reached, the nalpoint of the run is stored in a new collection. A ffer M $_0$ trials, p_0 is given by N $_{\rm s}^{(0)}$ =M $_0$, where N $_{\rm s}^{(0)}$ is the number of trials which reached $_1$. The probability p_1 is then estimated in the same way: the new collection of points at $_1$ is used to initiate M $_1$ trial runs to $_2$ (or back to A), generating a new collection of points at $_2$, and so on. Finally, the rate constant is obtained using Eqs (1) and (2).

FFS generates transition paths according to their correct weights in the TPE [1, 21]. In order to analyse these transition paths, one begins with the collection of trial runs which arrive at $_{\rm B}$ from $_{\rm n-1}$ and traces back the sequence of connected partial paths which link them to region A. The resulting transition paths are branched – i.e. a single point at $_{\rm 0}$ can be the starting point of multiple transition paths.

B. The branched grow th m ethod

In the BG m ethod, which was inspired by techniques for polymer sampling [2, 22, 23], branched transition paths are generated one by one, rather than simultaneously, as in FFS. The generation of each path begins with a single point at $_0$, obtained using a simulation in the basin of attraction of A, as in the FFS m ethod. This point is used to initiate k_0 trial runs, which are continued until they either reach $_1$, or return to A. Each of the N s⁽⁰⁾ end points at $_1$ becomes a starting point for k_1 trial runs to $_2$ or back to A. Each of the N s⁽¹⁾ successful trial runs to $_2$ initiates k_2 trials to $_3$, and so on until n is reached. A n estim ate P_B^e of P_B is obtained as the total num ber of branches that eventually reach Q_n^n , divided by the total possible num ber: $P_B^e = N_s^{(n-1)} = Q_{1-1}^n k_1$. If, at any interface, no trials were successful, $P_B^e = 0$. To generate the next branching path, we obtain a new starting point at $_0$ from the simulation in the basin of attraction of A. A fler m any branching paths have been generated, an average is taken over the P_B^e values of all the paths. The ux is meanwhile obtained from the simulation run in region A. The branched transition paths that are generated in the BG m ethod are correctly weighted m embers of the TPE [1]. We note that the BG m ethod bears resem blance to m ethods developed for telecom m unication networks [10, 11, 12] and to a m ethod used for protein association [14].

C . The Rosenbluth m ethod

The RB path sampling method is related to the Rosenbluth scheme for sampling polymer con gurations [2, 24, 25]. The RB m ethod generates unbranched transition paths, one at a time. An initial point at $_0$ is obtained using a simulation in the A basin, which is continued until the trajectory crosses 0 for the rst time, as in the FFS and BG methods. This point is used to initiate k₀ trials, which are continued until they either reach $_1$ or return to A. If N $_{\rm s}^{(0)} > 0$ of these trials reach 1, one successful trial is selected at random and its end point at $_1$ is used to initiate k_1 trials to $_2$ or back to A. Once again a successful trial is chosen at random and the process is repeated until either no trials are successful or n is reached. The generation of the next path then begins with a new point at 0, obtained using the simulation run in the A basin.

The Rosenbluth method as outlined above does not, how ever, generate paths according to their correct weights in the TPE: for correct sam pling, paths must be re-weighted by a \Rosenbluth factor". The Rosenbluth factor for a partial path up to interface i is given by:

Note that the re-weighting factor W_i depends on the number of successful trials obtained at all the previous interfaces, while generating the path up to _i. The correct re-weighting can be achieved using a M etropolis-type acceptance/rejection scheme [2], in which a new ly generated path is either accepted or rejected based on a com – parison of its R osenbluth factor with that of a previously generated path. Ensemble averages of any quantity of interest are then taken over all accepted paths. Here, the quantity which we wish to calculate is the probability p_i that a trial run red from _i will reach _{i+1}, for each interface i. W hen we re k_i trial runs from _i, we obtain an estimate for p_i : p_i^e N s⁽ⁱ⁾ = k_i. We require the correctly weighted ensemble average for p_i^e at each interface

i; we note, however, that the same procedure could also be used to calculate the ensemble average of any other property of the ensemble of paths from $_0$ to $_i$.

From a practical point of view, each interface has associated with it two values of W $_i$ and p_i^e . The rst set of values: W $_i^{(n)}$ and $p_i^{e\,(n)}$, are associated with the transition path that is currently being generated (the \new " path). W $_i^{(n)}$ depends on the num ber of successful trials generated in creating this transition path as far as $_i$, and $p_i^{e\,(n)}$ N $_s^{(i)}$ =k_i depends on the num ber of successful trials trials red from the point at $_i$ to $_{i+1}$. The other set of values, W $_i^{(o)}$ and $p_i^{e\,(o)}$, are the <code>\old" values</code> for this interface.

The recipe for obtaining k_{AB} within the RB m ethod is as follows. Transition paths are generated as described above. W hen the path generation procedure reaches i, we calculate the Rosenbluth factor W $_{i}^{(n)}$ (using Eq.(3)) and we re k_i trial runs to obtain $p_i^{e\,(\bar{n})}$ \quad N $_s^{(i)}{=}k_i.$ W e then calculate the ratio W $_{i}^{(n)}$ =W $_{i}^{(o)}$ and draw a random number 0 < s < 1. If s < W $_{i}^{(n)}$ =W $_{i}^{(o)}$, an acceptance event takes place. In this case, the previous values of W $_{i}^{(o)}$ and $p_{i}^{e(o)}$ are replaced by the new ly obtained values W $_{i}^{(n)}$ and $p_{i}^{e\,(n)}$. If, however, s > W $_{i}^{(n)}=\!\!W_{i}^{(o)}$, a rejection tion occurs and $W_i^{(o)}$ and $p_i^{e(o)}$ remain unchanged for this interface. Regardless of the outcom e of the acceptance/rejection step, the accumulator for the probability p_i^e is incremented by the current value of $p_i^{e(o)}$ -this may be either a new ly generated value (if an acceptance just occurred) or an old value that may have been already added to the accumulator several times (if several rejections have happened in a row). To proceed to the next interface, a successful trial run is chosen out of those that have been new ly generated, and its end point at $_{i+1}$ is used as the starting point for k_{i+1} trial runs to $_{i+2}$. A corresponding acceptance/rejection step is then carried out at $_{i+1}$. We note that the \old" values W $_{i}^{(o)}$ and $p_i^{e(o)}$ for di erent interfaces need not correspond to the same transition path. A fter many complete transition paths have been generated, k_{AB} is obtained using Eq.(1), where an estim ate of the ux is calculated from the simulation run in region A. A \pseudo-code" corresponding to the above procedure is given in our previous publication [1], together with a description of an alternative, \W aste Recycling" [26] re-weighting scheme. In this paper, how ever, we shall consider only the M etropolis acceptance/rejection approach.

III. COM PUTATIONAL EFFICIENCY

In this section, we derive approximate expressions for the computational e ciency of the three m ethods. Following M ooij and Frenkel [27], we use the following de -

In Eq. (4), C represents the computational cost, which we de ne to be the average number of simulation steps, per initial point at $_0$. The statistical error in the estimated value k_{AB}^e of the rate constant is represented by V. D enoting the mean (expectation value) of variable u by E [u] and its variance by V [u], we de ne V to be the variance V [k_{AB}^e], per initial point at $_0$, divided by the square of the expectation value E [k_{AB}^e]:

where N₀ is the number of starting points at $_0$ used in obtaining the estimate k_{AB}^e . The expectation value of k_{AB}^e is, of course, the true rate constant: $E[k_{AB}^e] = k_{AB}$. The error bar for k_{AB}^e is given by k_{AB} $V=N_0$.

A. ComputationalCost

We de ne the computational cost C of a particular method to be the average number of simulation steps required by that method, per starting point at $_0$. In making this de nition, we ignore any other contributions to the CPU time, such as memory storage. To estimate the value of C, we consider a generic system that makes a rare transition between states A and B. A parameter and interfaces $_0$::: n are chosen as in Section II.

There are two contributions to the cost C. The rst is the average cost R, in simulation steps, of generating one starting point at $_0$. This is related to the ux from the A region to $_0$ by R = 1=(dt), where dt is the simulation timestep.

The second contribution to C is the cost of the trial run procedure. We est consider the cost C_i of ring one trial run from interface _i. The run is continued until it reaches either the next interface _{i+1} (with probability p_i), or the boundary _A of region A (with probability q_i). We make the assumption that the average length (in simulation steps) of a trajectory from interface _i to another interface _j is linearly proportional to j_j ij with proportionality constant S. C_i is then given by:

The basis for the assumption of linearity in Eq.(6) is that we suppose that the system undergoes one-dimensional di usion along the coordinate in the presence of a \drift force" of xed magnitude. For an equilibrium system, the origin of the drift force is the free energy barrier. Farkas and Fulop have presented analytical solutions [28] for the mean time to capture for a particle undergoing one-dimensional di usion with constant drift force, in the presence of two absorbing boundaries. In Appendix A, we show how these results lead to Eq.(6). Eq.(6) is show n to be valid for the two-dimensional Maier-Stein problem in Section IV A (Figure 7).

Expressions for the cost

G iven Eq.(6), we can compute the average cost C per starting point at $_0$ of the three m ethods.

In FFS, we make M_i trial runs from interface i and, providing at least one of these is successful, we proceed to the next interface i+ 1. In practice, M_i is expected to be large enough that at least one trial run reaches $_{i+1}$. In this case, the expected cost per starting point at $_0$ is:

Dening k_i such that $k_i = M_i = N_0$, Eq.(7) can be rewritten as:

If, however, M_i is small, we must take account of the possibility that none of the trial runs from _i reach _{i+1}. In this case, the FFS procedure is term inated at interface i and the cost is accordingly reduced. Since the probability of reaching interface i> 0 is $\begin{array}{c} Q & i \\ j=0 \end{array}$ 1 $\begin{array}{c} q_j^{M_j} \\ q_j \end{array}$ (this is the probability that at least one trial is successful at all interfaces j < i), Eq.(8) is replaced by:

A lthough the cost is reduced by failing to reach later interfaces, this of course results in a less accurate prediction of the rate constant, since the term inated FFS calculation m akes no contribution to the estimate of p_i for later interfaces. This will be rejected in our expression for the statistical error in Section IIIB.

We now turn to the BG method. Here, we generate a \branching tree" of paths, with N_i points at interface i originating from a single point at $_0$. We re k_i trial runs for each of these N_i points. The average value of N_i is:

O f course $\overline{N}_0 = 1$. The average cost per starting point at $_0$ is therefore:

Finally, we come to the RB m ethod. In this algorithm, we generate unbranched paths by ring k_i trials from interface i, choosing one successful trial at random and proceeding to interface i+ 1. If no trial runs are successful, we start again with a new point at $_0$. The probability of reaching interface i> 0 is ${Q_{i\,1}\atop j=0}^{2\,i\,1}$ 1 $q_j^{k_j}$. The cost of the RB m ethod, per starting point at $_0$, is therefore:

Once again, the \price" of failing to reach later interfaces will be paid in the form of an increased variance in the calculated rate constant. The e ect of the M etropolis acceptance/rejection step in the RB m ethod appears only in the variance in k_{AB}^{e} (Section IIIB), and not in the cost.




FIG.2: Cost C=R, for evenly spaced interfaces, $p_i = p$, $k_i = k$, R = S, $N_0 = 1000$ and $P_B = 10^8$. (a): C=R as a function of k, for n = 5. (b): C=R as a function of n, for k = 25.

For the purposes of illustration, let us consider a hypothe tical rare event problem for which $_0 = _A = 0$ and n = B = 1.W e suppose that the interfaces are evenly spaced in , have equal values of pi, and that the ring parameter k_i is the same at each interface: i.e. i = i = n, $p_i = P_B^{1=n}$ (from Eq.(2)) and $k_i = k$. We also suppose that R = S and $N_0 = 1000$. The resulting values of the cost C, obtained from Eqs (9), (11) and (12), are plotted in Figure 2a and b as functions of k and n. In the regime of smallk or smalln (im plying smallp), the BG and RB m ethods converge, while the cost of the FFS m ethod is higher. This is because, for BG and RB, the probability of reaching later interfaces is low and the cost is dom inated by the trial runs red from early interfaces. The FFS procedure is less likely to be term inated at early interfaces (note the factor of 1 $q_i^{N_0 k_i}$ in Eq.(9) as opposed to 1 $q_i^{k_i}$ in Eq. (12)), and is therefore more expensive, per initial point at 0. In the regime of large k or large n (im plying large p), a di erent scenario em erges. Here, the BG m ethod becom es by far the m ost expensive, w ith a cost that increases dram atically with increasing k or

n. This e ect is due to the rapidly increasing number of branchesper starting point at $_0$. In this regime, the FFS and RB m ethods converge to the same cost, since Eqs (9) and (12) become equivalent when 1 q^k 1 q^{N_0k} 1.

B. Statistical Error

We now turn to the relative variance V in the estimated value k_{AB}^{e} of the rate constant, per starting point at $_{0}$. k_{AB}^{e} is the product of the estimated ux through $_{0}$, multiplied by the estimated probability of subsequently reaching B: $k_{AB}^{e} = {}^{e}P_{B}^{e}$ (Eq.(1)).

In this paper, we shall ignore the error in ^e. ^e is obtained by carrying out a simulation run in the basin of attraction of A and measuring the average number of simulation steps between successive crossings of $_0$ (com - ing directly from A). As long as $_0$ is positioned close enough to the A region, the simulation run in A can be made long enough to estimate with high accuracy, with a computational cost that is minimal compared to the cost of estimating P_B. We therefore obtain:

In what follows, we shall make the important assum ption that the num bers N s of successful trial runs at different interfaces i are uncorrelated - i.e. that if, during the generation of a transition path, one is particularly successfulor unsuccessfulat interface i, this will have no e ect on the chances of success at interface i + 1. In reality, of course, there will be correlation between interfaces, especially if the interfaces are closely spaced or the system dynamics have a large degree of \m em ory".We expect this assumption to be the major limiting factor in the applicability of our results to real system s; how ever, as we shall see in Section IV, the results are surprisingly accurate for the two-dimensional Maier-Stein problem. W e expect that the expressions derived here could be modied to include the e ects of correlations between interfaces; for highly correlated system s this m ay prove necessary.

Expressions for the variance

The basis of our analysis is the fact that on ring $k_{\rm i}$ trial runs from interface i, the number of successful trials N $_{\rm s}^{\rm (i)}$ is binom ially distributed [29], with mean

We shall need to express the variance in P_{B}^{e} in terms of the variance V $[p_{i}^{e}]$ in the estimated values of p_{i} at each interface. To do this, we recall that $P_{B}^{e} = \int_{i=0}^{n-1} p_{i}^{e}$ (Eq.(2)), and we make use of the following relation [29]:

The M etropolis acceptance/rejection step (described in Section II) increases the variance in p_i^e . On reaching interface i, we re k_i trials and obtain an estim ate $p_i^{e;(n)} = N_s^{(i)} = k_i$. We either accept or reject this estimate. If we reject, $p_i^{e;(n)}$ makes no contribution to the average value of p_i^e – instead, the previously accepted estimate, $p_i^{e;(o)}$, is added to the average, even though $p_i^{e;o}$ was already added to the average in the previous acceptance/rejection step. If, instead, we accept $p_i^{e;(n)}$, it makes a contribution to p_i^e , and, if the subsequent estimates happen to be rejected, it may repeat this contribution multiple times. The nal estimate, p_i^e , is therefore an average over all the values of $N_s^{(i)} = k_i$ that we generated, we ighted by the number of times Q that each of these values contributed to p_i^e :

Eq.(38) can be understood as follows: Q = 0 corresponds to a $p_i^{e;(n)}$ value that is generated but is immediately rejected and therefore contributes zero times to the average. This occurs with probability 1 i. Q > 0 corresponds to a $p_i^{e;(n)}$ value that is generated and accepted (with probability i) -the next Q 1 values that are generated are rejected (with probability (1 i)^{Q 1}), then nally a new value is generated which is accepted (with probability i), so that the original value ceases to contribute to the average. 


FIG.3: Relative variance V, for $p_i = p$, $k_i = k$ and $P_B = 10^8$. The circles show the function $p_{i=0}^{n-1} q_i = (p_i k_i)$. (a): V as a function of k, for n = 5. (b): V as a function of n, for k = 25.

Returning to the hypothetical rare event problem with evenly spaced interfaces introduced above, Figure 3 shows V as a function of k (for n = 5) and of n (for k = 25), for $p_i = p = P_B^{1=n}$, $k_i = k$, $N_0 = 1000$ and $P_B = 10^8$. The circles show the limiting form $\prod_{i=0}^{n-1} q_i = (p_i k_i)$, which is in good agreem ent with the FFS results, since 1 q^{N_0k} 1. For sm all k or sm all n (sm all p), the RB and BG results tend to converge, since the probability of reaching later interfaces is sm all and the results are dom inated by the early interfaces. In this regime, the FFS m ethod gives the sm allest variance, since the chance ofterm inating the trial run procedure at early interfaces is low er than for the other m ethods.

It is interesting to compare expressions (23), (32) and (43). All three expressions are of the form

We note that $X_i^{s} > X_i^{tb}$, so that V^s is always less than V^{tb}, even for i = 1. Both X_i^{s} and X_i^{tb} are always less than unity: V^s approaches the limiting form $\prod_{i=0}^{n-1} q_i = (p_i k_i)$ from above as k_i increases (in fact in Fig. 3a it takes this form for all k) and V^{tb} approaches $\prod_{i=0}^{n-1} (2 i)q_i = (p_i k_i i)$. For the BG method, how ever, X_i^{bg} can increase inde nitely as k_i increases, so that this method produces the sm allest variance for large k_i , as in Figure 3a. How ever, com paring with Figure 2, we see that this is also the regime in which the BG method becomes very expensive.

Landscape Variance

So far in our analysis, we have assumed that all the points at interface $_i$ have to same p_i value - i.e. that on ring a trial run to $_{i+1}$ we have the same probability of success, no matter which point at $_i$ we start from . In reality, this is not the case; we expect there to be a distribution of p_i values am ong the points at each interface $_i$. We call the variance of this distribution the \landscape variance" U_i at interface i, and we expect it to make a contribution to the variance in P_B^e . We now extend our analysis to include the potentially in portant e ect of the landscape variance.

Let us suppose that each point j at $_{i}$ has an associated probability $p_{i}^{(j)}$ that a trial run red from that point will reach $_{i+1}$. The distribution of $p_{i}^{(j)}$ values encountered during the rate constant calculation has mean E $[p_{i}^{(j)}] = p_{i}$ and variance V $[p_{i}^{(j)}]$ U_i. O f course, the values of U_i depend on the num ber and placement of the interfaces.

In Appendix C, we re-derive expressions for the relative variance in the estim ated rate constant, taking into account the landscape variance. The nal results are:

Comparing Eqs (50), (51) and (52) to their equivalent form s without landscape variance, (23), (32) and (43), we see that for each interface the \binom ial" term softhe form piqi=ki are now supplemented by additional term su describing the landscape variance. In the lim it of very large ki, the relative variance no longer tends to zero. Instead, as k_i ! 1 (for all i), the FFS and BG expressions (50) and (51) tend to the constant value $U_0 = p_0^2$, while $_{i=0}^{n-1} U_i = p_i^2$. While the the RB expression (52) tends to \binom ial" contribution to the variance can be reduced by ring m any trial runs per point, the \landscape" contribution can only be reduced by sam pling m any points. In the FFS and BG m ethods, branching paths are generated. For very large $k_{\rm i}$, each point at $_{\rm 0}$ generates m any points at subsequent interfaces, so that only $U_{\,0}\,$ rem ains in Eqs (50) and (51) as $k_i \mid 1$. In the RB method, however, paths are not branched, so that each point at $_0$ corresponds to one (or less than one) point at each subsequent interface. In this case, as $k_i ! 1$, all the U_i values continue to contribute to V.




FIG.4: Relative variance V in k_{AB}^{e} , as predicted by Eqs (50), (51) and (52), for the model problem of Figs 2 and 3, with $P_{B} = 10^{8}$ and $U_{i} = U$. The upper curves in each group correspond to $U = 5p^{2}=n$, the middle curves to $U = p^{2}=n$ and the lower curves to U = 0. (a): V as a function of k, keeping n = 5. (b): V as a function of n, keeping k = 25.

In Figure 4, we revisit the simple model problem of Figs 2 and 3, adding in the e ects of landscape variance. We take U_i to be the same for all interfaces: $U_i = U \cdot We$ choose, somewhat arbitrarily, $U = p^2 = n$ or $U = 5p^2 = n$. These turn out to be quite realistic values for the M aier-Stein system discussed in Section IV. Figure 4 shows

the relative variance V (as in Figure 3), calculated with $U = 5p^2 = n$ (upper curves), $U = p^2 = n$ (middle curves) and U = 0 (lower curves). A lthough the landscape variance does not change the general trend that V decreases as k or N increases, it does have the qualitative e ect that V no longer tends to zero (as discussed above). D epending on the value of U, the quantitative e ects of the landscape contribution can be very signi cant, especially as k or N becomes large.






FIG.5: E ciency E, calculated using Eq.(4), for the simple m odel of Figs 2, 3 and 4. For each m ethod, results are plotted with $U = p^2 = n$ (low er curves) and U = 0 (upper curves). (a): E as a function of k for n = 5. (b): E as a function of n for k = 25.

Having calculated the computational cost and the statistical accuracy of the three m ethods, we are now in a position to assess their overall computational e ciency, as de ned by Eq.(4). Figure 5 shows the e ciency of the three m ethods as a function of k (Fig. 5a) and of n (Fig. 5b), for the simple m odel case of Figs 2, 3 and 4. Note the altered scale on the n axis in comparison to Figures 2 and 3. For each m ethod, the upper curve shows the results w ithout the landscape contribution to the variance (U = 0) and the low er curve includes a landscape contribution of U = $p^2=n$.

Firstly, we note that the optimum values of E are of the same order of m agnitude for all three m ethods, although E is consistently lower for RB, due to the acceptance/rejection step. However, the dependence of the e ciency on the parameter values k and n is very di erent for the three m ethods. For the BG m ethod, the e ciency shows a pronounced peak, both as a function of k and ofn. Although for an optim um choice of parameters, this method can be the most e cient, its perform ance is highly sensitive to the choice of parameters, decreasing sharply for non-optim al values of k or n. The FFS and RB methods are much less parameter-sensitive - in fact, as long as k or n is not too sm all, the choice of param eters appears not to be at all critical for these m ethods. In general, F ig 5 seem s to indicate that the m ethod of choice is FFS, since this method is highly robust to changes in the param eters, is the most e cient m ethod at sm allk or

n, and remains e cient as k and n become large. How ever, this interpretation must be treated with care, since several in portant factors are not included in the analysis leading to Fig.5. Firstly, our analysis does not include the e ects of correlations between interfaces. This has the e ect that neither the FFS or RB m ethods shows a maximum in e ciency as a function of n in Fig.5b. In our simple model, one can always gain more information by sam pling at m ore closely spaced interfaces - how ever, in reality, correlations between interfaces are likely to make very closely spaced interfaces com putationally ine cient. Another important factor to be considered is the fact that both the FFS and BG m ethods generate branched transition paths. In FFS, in fact, an e ect analogous to \genetic drift" m eans that if the num ber of points in the collections at the interfaces is small enough to be of the order of the number of interfaces, then all the paths that nally reach B can be expected to originate from a small num ber of initial points at 0. If there is \m em ory loss" - i.e. no correlations between interfaces, this may be unimportant. However, if the history of the paths is important, then the RB method may be the method of choice, since this generates independent, unbranched paths. Furtherm ore, the RB m ethod requires much less storage of system con gurations than FFS (for which a whole collection of points must be stored in memory at each interface) - for som e system s, this m ay be a signi cant factor in the com putational cost.

Figure 5 also shows the e ects of landscape variance on the e ciency of the three methods. Including landscape variance always decreases the e ciency, but produces rather few qualitative e ects for this simple model problem . It is interesting to note, how ever, that in Figure 5a both the FFS and RB methods show a maximum in e ciency as a function of k only when the landscape contribution is included. W hen the landscape contribution is not considered, the equations predict that arbitrarily high accuracy can be obtained by ring an in nitely large num ber of trials from a single point. In this example, we took the landscape variance to be the same for all interfaces: $U_i = U$. However, one can easily in agine that for som e system s, there is much greater variation am ong transition paths when they are close to the A basin, while for others, paths tend to diverge as they approach B. In the form er case, we can expect the RB and BG m ethods to have an advantage relative to FFS, because in these m ethods, relatively m ore points are sampled at early interfaces (since the probability of failing to complete a transition path is higher). Conversely, if the landscape variance is very large close to the B basin, the BG m ethod m ay be advantageous, since it sam ples m any points at later interfaces due to its branching tree of paths.

In this section, we test the expressions derived in Section III for a real rare event simulation problem. As our test case, we simulate the two-dimensional nonequilibrium rare event problem proposed by M aier and Stein [15, 16, 17]. This system has been extensively studied both theoretically and experimentally [15, 16, 17, 31, 32] and was also used by C rooks and C handler [4] as a test case for their non-equilibrium rare event method. W e hope that the conclusions obtained for this system will also prove to be applicable to more computationally intensive rare event problem s.




FIG.6: Typical trajectory for a brute-force simulation of the M aier-Stein system, with = 6:67, = 2 and = 0:1.

The M aier-Stein system consists of a single particle moving with over-dam ped Langevin dynam ics in a twodimensional force eld. The position vector $(x_1;x_2)$ of the particle satis es the stochastic di erential equation:

This system is bistable, with stable points at (1;0) and a saddle point at (0;0). If $\$, the force eld f cannot be expressed as the gradient of a potential. In this case, the system is intrinsically out of equilibrium and does not satisfy detailed balance. The parameter controls the magnitude of the stochastic force acting on the particle. For > 0, the system makes stochastic transitions between the two stable states, at a rate which decreases as decreases. Figure 6 shows a typical trajectory generated by a brute-force simulation. Here, and in the rest of this Section, we use = 6:67, = 2:0 (follow ing C rooks and C handler [4]) and = 0:1.Eq.(53) is integrated num erically with timestep t = 0.02 [33]. For our calculations using the FFS-type methods, we de ne $(x) = x_{1}, A$ $_{0} = 0:7 \text{ and }_{B}$ n = 0:7.

A. M easuring the param eters

In order to test the expressions of Section III, we must measure the cost parameters R and S, the probability




FIG.7: Costs of trial runs between interfaces, for the M aier-Stein system. The average length, in simulation steps, of \successful" trials (to $_{i+1}$) are shown as lled circles. For these trials, $j = _i + 0.2$ and $j_i _j j = 0.2$. The average length of \unsuccessful" trials (to $_A = 0.7$) are shown as open circles. For these trials, $j_i _j j = _i + 0.7$. The solid lines show the linear approximation, Eq.(6), with S = 131.




FIG.8: Predicted and measured values of C, for the M aier-Stein problem as described in Section IV. The lines show the theoretical predictions for the FFS (solid line), BG (dotted line) and RB (dashed line) methods. The symbols show the simulation results. Circles: FFS method, squares: BG method, triangles: RB method (with Metropolis acceptance/rejection). Simulation results were obtained with 400 blocks of N₀ = 1000 starting points for FFS and 2000 starting points per block for BG and RB. (a): C as a function of k, for n = 7. (b): C as a function of n, for k = 3, for evenly spaced interfaces.




FIG. 9: Predicted and measured values of V, for the M aier-Stein problem. The lines show the theoretical predictions for the FFS (solid line), BG (dotted line) and RB (dashed line) methods. The symbols show the simulation results. Circles: FFS method, squares: BG method, triangles: RB method (with Metropolis acceptance/rejection). Simulation results were obtained with 400 blocks of N₀ = 1000 starting points for FFS and 2000 starting points per block for BG and RB. Interfaces were evenly spaced between $_{\rm A}$ = 0:7 and $_{\rm B}$ = 0:7 (a): V as a function of k, for n = 7. (b): V as a function of n, for k = 3. In (b), the landscape contribution is not included in the theoretical calculation.

 P_B of reaching B and, for a given set of n interfaces, the probabilities fpig and the landscape variance values $fU_i g$. For most of our calculations, we used n = 7, and the interfaces were positioned as listed in Table I. For the results of Figs 8b, 9b and 11b, where n was varied, we kept the interfaces evenly spaced between $_0 =$ 0:7 and n = 0.7. R, the cost of generating an initial point at 0, was measured using a simulation in region A to be R = 59050 steps. In these calculations, points at $_{0}$ were collected upon every 10th crossing of $_{0}$ from A . To measure S (the proportionality constant in Eq.(6)), we carried out an FFS run, measuring the average length (in simulation steps) of successful and unsuccessful trials from each interface. The results are shown in Figure 7. Here, the lled circles show the average length, in simulation steps, of successful trials from interface i (plotted on the x axis) to $_{i+1} = _i + 0.2$. Since j_i j= 0:2 for all these trials, Eq.(6) predicts that all the led circles should have show the same average trial length. The open circles show the average length of unsuccessful trials, which begin at i and end at A = 0.7, so that j = i + 0:7: Eq.(6) predicts that all the open jι circles should lie on a straight line. Combining all the data, we obtain an average value of S = 131 steps. This value is used to plot the solid lines in Figure 7. The very good agreem ent that is observed between the solid lines and the circles in plies that the drift-di usion approximation, Eq.(6), is reasonable for this problem. The most signi cant deviation occurs for the successful trial runs between = 0.7 and = 0.5; these are unexpectedly short, perhaps because the \drift force" is weaker in this region.

U sing FFS, we obtained $P_B = [4:501 \ 0:007] \ 10^3$. The values of fp_ig were also measured (using FFS) and are given in Table I. The landscape variance fU_ig was measured using the procedure described in Appendix D : after generating a correctly weighted collection of points at interface $_i$ (for example using FFS), one resk_i trials from each point j and records the number of successes, N s⁽ⁱ⁾ jj. One then calculates the variance among points V N s⁽ⁱ⁾]. The intrinsic variance is given by

Table I shows that for this problem $U_i = p_i^2$ is rather sm all (a maximum of 0.27 for interface 0), indicating that the landscape variance is unlikely to have important e ects in this case. However, this may not be the case form ore complex systems in higher dimensions.

B. Testing the expressions

W e now m easure directly the cost, in simulation steps, the error in the calculated rate constant, and thus the e – ciency of the three m ethods, for the M aier-Stein problem, and com pare our simulation results to the predictions of Section III. For each m ethod, simulations were carried out in a series of blocks. For FFS, a block consists of a com plete FFS calculation with N₀ starting points. For the RB and BG m ethods, a block consists of N₀ starting points at $_0$. Each block produces a result P_B^e for the probability of reaching B. To nd V $[P_B^e]$, we calculate the variance between blocks:

where the over-line denotes an average over the blocks. The cost C per starting point at $_0$ is the average num ber of simulation steps per block, divided by N $_0$.

Figure 8 shows a comparison between the simulation values of C and the theoretical predictions (Eqs (9), (11) and (12)), for the three methods, as a functions of k (Fig.8a) and of n (Fig.8b). In these calculations, the same value of k was used for all interfaces: $k_i = k$ for all i. To obtain the data in Fig.8b, we used interfaces which were evenly spaced in and a xed value k = 3. We observe remarkably good agreement between the predicted and observed values for the cost, verifying that at least for this problem, Eqs (9), (11) and (12) are very accurate.




FIG.10: Predicted and measured values of V, for the M aier-Stein problem, for the FFS method. Solid line: Eq.(50) (with landscape variance), dotted line: Eq.(23) (no landscape variance), circles: simulation results.

The predicted and m easured values of V are shown in Figure 9, for all three m ethods. A greem ent is again excellent, showing that the approximations of Section IIIB are justiled, at least for this problem. The landscape contribution to V is included in Figure 9 for panel (a) but not for (b). In Figure 10, we show the elect of neglecting this contribution (note the altered scales on both axes). A lthough the landscape contribution is small for this problem, it becomes signile cantific the lange k as the binom ial" contribution decreases.




FIG.11: Predicted and measured e ciency E, for the M aier-Stein system. The lines show the theoretical predictions for the FFS (solid line), BG (dotted line) and RB (dashed line) methods. The symbols show the simulation results. C incles: FFS method, squares: BG method, triangles: RB method (with Metropolis acceptance/rejection). Simulation results were obtained with 400 blocks. For FFS, each block had N₀ = 1000 starting points and for BG and RB each blocks had 2000 starting points. Interfaces were evenly spaced. (a): E vs k for n = 7. (b): E vs n for k = 3.

The e ciency E is plotted in Figure 11. Excellent agreem ent is obtained between simulation and theory. It is also interesting to note that the trends in E as a function of k are qualitatively very similar to those obtained

for the model problem of Fig. 5. The BG method shows high e ciency only within a relatively narrow range of parameter values, while the FFS and RB methods are much more robust to changes in the parameters. The RB m ethod is consistently less e cient than FFS, due to the acceptance/rejection step. As the number of interfaces n becom es large, we would expect the correlations between interfaces (which are not included in our analysis) to have a greatere ect, and the theoretical predictions to becom e less accurate. This e ect is observed to a certain extent: the e ciency of FFS, for example, decreases relative to the predicted value as n increases. How ever, this is not a dram atic e ect, and in fact, even on increasing n further, as far as 100 interfaces, we nd a decrease of only a few percent in the e ciency of FFS. It seems therefore, that for FFS at least, one can use any number n of interfaces, as long as n is not too sm allor so very large that m em ory requirem ents becom e the lim iting factor.

The remarkable agreem ent between the theoretical pre-

dictions and the simulation results shown in Figures 8, 9 and 11 perhaps re ects the sim plicity of the M aier-Stein problem . The main assumption for the calculation of V - that the sam pling of pi at di erent interfaces is uncorrelated - seems to be well justi ed in this case. We would expect our theoretical predictions to be less accurate for more com plex problem s, perhaps with strong correlations between interfaces. In fact, on investigating the two examples presented in our previous paper [1] the ipping of a genetic switch and the translocation of a polymer through a pore-we nd that the quantitative estimates of both the cost and variance can dier by a factor of about 10 from the theoretical predictions. Even with this caveat, how ever, we believe that the expressions of Section III will prove to be of practical use for a wide range of rare event simulation problem s.

V. DISCUSSION

In this paper, we have derived simple analytical expressions for the computational cost of the three FFS-type rare event simulation methods and the statistical accuracy of the resulting estimate of the rate constant. The expressions were found to be in remarkably good agreement with simulation results for the two-dimensional non-equilibrium rare event problem proposed by Maier and Stein [15, 16, 17].

Our analysis allows us to draw some general conclusions about the relative merits of the three FFS-type methods. Firstly, the optimum e ciencies of the methods are all of the same order of magnitude, at least for the simple test problem studied here. However, the methods show very di erent sensitivities to the choice of param eters. The Branched G row th m ethod in particular is highly sensitive, performing well only for a narrow range of param eter values. W ithin this range, how ever, it perform swell in comparison to the otherm ethods. The FFS m ethod is the most robust to changes in the param eters, perform ing consistently well, even for parameter values where the otherm ethods are very ine cient. The Rosenbluth method is lower in e ciency than the others, as a consequence of the M etropolis acceptance/rejection step which is required in order to obtain paths with the correct weights in the Transition Path Ensemble.

These observations provide a very useful guide for choosing a rate constant calculation method. In general, unless one has a very good idea of the optimum parameters, the BG method carries a risk of being low in e ciency. Of course, strategies could be envisaged to overcome this problem - for example, one could imagine term inating a certain percentage of the branches to avoid the high cost of sampling later interfaces. The analysis used here could easily be extended to predict the likely success of such approaches. The RB method appears from this analysis to be of relatively low e ciency. How ever, that is not to say that one should not use the Rosenbluth method. On the contrary, this is the only method which generates unbranched paths, making it highly suitable for situations where one wishes to analyse the paths, in order to study the transition mechanism. The RB and BG methods also requirem uch less storage of system congurations than FFS (for which all N_i points at interface i must be stored in memory), making them potentially suitable for large system s. As a general conclusion, how – ever, the results of this paper show that the FFS method is highly robust to parameter changes and is probably them ethod of choice for calculations of the rate constant where e ects such as the storage of many con gurations in memory are not important.

These results could also suggest possible strategies for choosing the parameters for the three methods. One approach would be to use the analytical expressions derived here in an optimization scheme for inding fk_ig , f_ig and n. This is likely to be useful for the BG method, but may be less essential for the FFS and RB methods, where the choice of parameters is much less critical.

W e expect that the predictions of the cost and statistical error derived here will be useful not only for parameter optim ization, but also for assessing, before beginning a calculation, which m ethod to use and, indeed, whether to proceed at all. Some prelim inary calculation would be needed in order to obtain rough estimates for R,S, P_B , fpig and (if required) fU_ig. These prelim inary calculations are expected to be much cheaper than a full simulation. W hile the expressions for the cost and variance will be less accurate if only rough estimates for the parameters are available, we expect the results to be nevertheless accurate enough to be of use.

Furtherm ore, the expressions for V can be used, after a rate constant calculation has been completed, to obtain error bars on the calculated value of $k_{A\,B}$. In this case, the values of $P_B\,$ and fp_ig are known. The intrinsic variances fU_ig can also be easily obtained during the rate constant calculation, as explained in A ppendix D. These values can be substituted into the expressions to obtain a reliable estim ate of the statistical error in the resulting rate constant.

In this work, we provide a way to compare the e ciency of the three FFS-type m ethods. It would also be very useful to compare their e ciency to that of other m ethods, such as the m ethod of C rooks and C handler [4] for non-equilibrium rare event problem s, or TPS [3] or Transition Interface Sam pling (T IS) [5, 20] for equilibrium problem s. W e have carried out prelim inary calculations using the C rooks-C handler m ethod for the M aier-Stein system. W e nd that the value of the rate constant is in agreem ent with that of the FFS-type m ethods, but that the FFS-type m ethods are m uch m ore e cient. H ow ever, a thorough com parison would require a detailed investigation, optim izing the param eter choices of all the m ethods. W e therefore leave this to a future study.

In conclusion, we have presented expressions for the computational cost and statistical accuracy of three recently introduced rare event simulation methods. We believe that the expressions presented here will be valuable in using these m ethods to compute rate constants and in evaluating the results of such computations.

APPENDIX A:COST OF TRIAL RUNS

In order to estimate the cost of a trial run, we assum e that the system undergoes one-dim ensional di usion along the coordinate, with a constant drift velocity (the origin of which is a force due to the \free energy barrier"). The problem is then equivalent to that of a particle which undergoes di usion with drift along the x axis, after being released between two absorbing boundaries. W e are interested in the mean time or ! that the particle takes to be captured at the left or right boundary, given that it is eventually captured at that particular boundary. Farkas and Fulop have studied the problem of one dim ensional di usion with drift [28]. They give analytical expressions for the probabilities n and n_1 that the particle is absorbed at the left and right boundaries, respectively, and the rates of absorption, j and $j_{!}$ at the left and right boundaries. The mean rst passage time is the average time before the particle is absorbed at one of the boundaries:

In this case, the average time for a particle to be captured at a speci ed boundary is linearly proportional to the distance between the starting point of the particle and that boundary, and the proportionality constant is the same for particles moving against or with the drift velocity. It is therefore appropriate to approxim ate the cost of a trial run between i and j by S j j ij as in Eq.(6).

APPEND IX B:ACCEPTANCE PROBABILITY FOR THE RB METHOD

This section is concerned with the M etropolis acceptance/rejection step in the Rosenbluth m ethod. We derive the approximate expression (44) for the probability $_i$ that a new ly generated estimate $p_i^{e(n)} = N_s^{(i)} = k_i$ for the probability p_i is accepted. Upon reaching interface i, we calculate the Rosenbluth factor W $_i^{(n)} = {{{0}\atop{j=0}}^{i-1}N_s^{(j)}}$ corresponding to the new ly generated path leading to interface i. We compare this to the Rosenbluth factor W $_i^{(o)}$ corresponding to the previous path to have been accepted at interface i.




FIG. 12: (a): \Simulated" and predicted acceptance proba-23bilities i for interfaces 0 i 14, for the \simulated simulation" described in the text, for k = 2;5;8. (b): Simulated and ² predicted values of i for 0 i 6 for the M aier-Stein problem of Section IV, for k = 2;5;8. In both plots, solid lines represent predicted values for k = 2, dotted lines, k = 5 and dashed lines, k = 8. Symbols represent simulation results: circles: k = 2, squares: k = 5 and triangles: k = 8.

A lthough Eq. (B 25) is a sim ple and convenient expression for the acceptance probability i, its derivation required several approxim ations. W e have therefore tested the validity of Eq. (B25). We rst carried out a $\sin u$ lated simulation", in which we de ned a series of N = 15interfaces, each with the same value of $p_i = p = 10^{6=15}$, and \simulated" the Rosenbluth calculation, each time drawing a random number to determ ine the outcom e of a given \trialrun , for a given num ber of trialruns $k_i = k_i$ taken to be the sam e for all interfaces. W e m easured the acceptance probabilities at each interface after 2 10⁶ Rosenbluth \path generations", and com pared these to Eq.(B25). The results are shown in Figure 12a, for k = 2, k = 5 and k = 8. The agreem ent with the \sim ulation" is very reasonable. To compare with real simulation results, we also measured the acceptance probabilities i for the RB simulations of the Maier-Stein system described in Section IV. The results are compared with the predictions of Eq. (B25) in Figure 12b. Again, quite good agreem ent is obtained.

APPENDIX C:THE EFFECTS OF LANDSCAPE VARIANCE

In this section, we include the e ects of the \landscape variance" in our expressions for the relative variance V

As described in Section III, we suppose that point j at interface _i has probability $p_i^{(j)}$ that a trial run red from it will reach _{i+1}, rather than _A. The variance in the $p_i^{(j)}$ values for points at _i (sam pled according to their expected occurrence in the trial run ring procedure) is the \landscape variance", U_i.

If we choose a particular point j, re k_i trial runs and measure the number of successes $N_s^{(i)}$, we expect to obtain a mean value $\mathbb{E} \left[N_s^{(i)} j j \right] = k_i p_i^{(j)}$, and a variance $V \left[N_s^{(i)} j j \right] = k_i p_i^{(j)} q_i^{(j)}$ (in analogy with Eqs (15) and (16)). This is in fact a multinom ial distribution [29, 35], which has average E [m_j] = M_i=N_i and variance V [m_j] = M_i [1=N_i (1 1=N_i)]. Let us now do a \thought experiment" in which we rst decide how many trial will be red from each point - i.e. we x the set of values fm_jg (of course, _jm_j = M_i). 

APPENDIX D:MEASURING THE INTRINSIC VARIANCE

In this section, we describe a simple and computationally cheap procedure for measuring the landscape variance parameters U_i . Given a correctly weighted collection of N_i points at interface _i (obtained, for example, using FFS), we could re an extrem ely large number k of trial runs from each point and measure the variance am ong points in the values of N_s^(i;j) - where N_s^(i;j) denotes the number of successful trials from point j:

This is likely to be an expensive procedure. Fortunately, however, it is not necessary to reavery large number of trial runs from each point. Instead, we make use of expression (C 2), which can be written as

where the expression now holds for any value of k. In the lim it that k ! 1, Eq.(D2) reduces to (D1). As a practical procedure, therefore, we generate a collection of N_i points at interface i (using, for example, FFS), and rek trials from each point -k does not have to be a large number. For each point j, we record the num ber of successful trials N $_{s}^{(i;j)}$. The variance V [N $_{s}^{(i)}$] of these values is inserted into Eq.(D2) to give a value for U₁. Figure 13 shows the results of this procedure for the Maier-Stein problem of Section IV. For the rst interface 0:7), U_i was calculated using Eq.(D2), using k (0 = trials for each of 10000 points collected at 0. The solid line is the measured value of V [N $_{\rm s}^{\rm (i)}$]=k², while the dashed line is the value of U_i obtained from Eq.(D2). The two lines converge, of course, for large values of k. Figure 13 shows that accurate results for U_i can be obtained using Eq.(D2), using only a sm all num ber of trial runs per point.
