# Sw itching via quantum activation: A param etrically m odulated oscillator

#### Abstract

W e study sw itching betw een period-tw o states of an underdam ped quantum oscillator m odulated at nearly tw ice its natural frequency. For alltem peratures and param eter values sw itch ing occurs via quantum activation: it is determ ined by di usion over oscillator quasienergy, provided the relaxation rate exceeds the rate of interstate tunneling. T he di usion has quantum origin and accom panies relaxation to the stable state. We nd the sem iclassical distribution over quasienergy. For $T=0$, $w$ here the system has detailed balance, this distribution di ers from the distribution for $T$ ! 0 ; the $T=0$ distribution is also destroyed by $s m$ all dephasing of the oscillator. T he characteristic quantum activation energy of sw itching displays a typical dependence on tem perature and scaling behavior near the bifurcation point w here period doubling occurs.

## I. INTRODUCTION

Sw itching betw een coexisting stable states underlies $m$ any phenom ena in physics, from di usion in solids to protein folding. For classical systems in therm al equilibrium sw itching is often described by the activation law, w ith the sw itching probability being $W / \exp (U=k T), w h e r e ~ U$ is the activation energy. As tem perature is decreased, quantum uctuations becom e m ore and m ore im portant, and below a certain crossover tem perature sw itching occurs via tunneling [1, 2, 3]. $T$ he behavior of system $s$ aw ay from therm al equilibrium is farm ore com plicated. Still, for classical system s sw itching is often described by an activation type law, w th the tem perature replaced by the characteristic intensity of the noise that leads to uctuations $[4,5,6,7,8,9,10,11,12]$. Q uantum nonequilibrium system s can also sw itch via tunneling betw een classically accessible regions of their phase space $[13,14,15,16]$.

In addition to classical activation and quantum tunneling, nonequilibrium system $s$ have another som ew hat counterintuitive $m$ echanism oftransitions betw een stable states. W e call this $m$ echanism quantum activation and study it in the present paper. It describes escape from a m etastable state due to quantum uctuations that accom pany relaxation of the system 17]. T hese uctuations lead to di usion aw ay from the $m$ etastable state and, ultim ately, to transitions over the classical "barrier", that is, the boundary of the basin of attraction to the $m$ etastable state.

W e study quantum activation for periodically modulated system $s$. Sw itching mechanism $s$ for such system $s$ are shown schem atically in $F$ ig. 1 , where $g(Q)$ is the e ective potential of the system in the rotating fram e. This gure describes, in particular, a nonlinear oscillator studied in the present paper, which displays period doubling when its frequency is periodically modulated in tim e. T he energy of periodically m odulated system $s$ is not conserved. Instead they are characterized by quasienergy . It gives the change of the wave function ( $t$ ) when tim $e$ is increm ented by the m odulation pe-

C oupling to a them alreservoir leads to transitions betw een the states of the system. For $T=0$ the transitions are accom panied by the creation of excitations in the therm al reservoir. T he energy of the system decreases in each transition. H ow ever, the quasienergy $m$ ay decrease or increase, albeit w ith di erent probabilities W " and $W$ \#. This e ect has quantum origin. It is due to the functions being superpositions of the eigenfunctions N i of the energy operator of the system in the absence ofm odulation. with ${ }^{0} 7$. The values of $W n, W$ \# for the latter transitions are determ ined by the appropriate overlap integrals and depend on $;{ }^{0}$.

M ore probable transitions determ ine in which direction, with respect to quasienergy, the system will most likely $m$ ove. Such $m$ otion corresponds to relaxation over quasienergy. $F$ ig. 1 refers to the case $W_{\#}>W^{\prime}$. In this case relaxation corresponds to quasienergy decrease. Them inim a of $g(Q)$ are the classical stable states. H ow ever, quantum transitions in which quasienergy increases have a nonzero probability even for $T=0$. Because this probability is less than W \#, such transitions lead to di usion over quasienergy away from the $m$ inim a of $g(Q)$. In tum, the di usion leads to a nite-w idth distribution over and ultim ately to activated-type overbarrier transitions betw een the wells in F ig. (1). In fact, discussed in this paper and sketched in F ig. (1) are periodtw o quasienergy states, w ith quasienergy de ned by the condition $\sim\left(t+2_{F}\right)=\exp \left(2 i_{F}=\sim\right) \sim(t)$. They are $m$ ore convenient for the present problem ; their relation to the standard quasienergy states is explained in Sec. II.
$O f$ interest for the problem of sw itching is the sem iclassical situation where the basins of attraction to the $m$ etastable states (the wells in F ig. (1) have a large num ber N of localized states. In this case the rate of tunneling decay is exponentially sm all. The activation rate is also exponentially sm all since it is determ ined by the ratio oftransition probabilities $W$ " $=W$ \# raised to the power N . B oth the tunneling and activation exponents are / N for the situation sketched in Fig. 11. Indeed, the tunneling exponent is given by the action, in the units of $\sim$, for classicalm otion in the inverted e ective potential $g(Q)$ from one $m$ axim um of $g(Q)$ to the other. It is easy to see that this action is of order $N$, unless $g(Q)$ has a special form. Therefore for $\mathrm{N} \quad 1$ the activation exponent is either m uch larger or m uch sm aller than the tunneling exponent.

In this paper we develop a theory of the statistical distribution and consider sw itching of a param etrically m odulated quantum oscillator. W e show that, irrespective of tem perature, the activation exponent is sm aller than the tunneling exponent. Therefore sw itching alw ays occurs via activation, not tunneling, as long as the relaxation rate exceeds the tunneling rate.

W e study a nonlinear oscillator w ith frequency modulated at nearly tw ioe the natural frequency ! 0 . W hen the $m$ odulation is su ciently strong, the oscillator has tw o stable vibrational states w th periods $2_{\mathrm{F}} \quad 2=!_{0}$. These states di er in phase by but otherw ise are identical [18]. They correspond to the $m$ inim a of the e ective potential in F ig. [1. The low est quantized states in F ig. (1) are squeezed. Squeezing in a param etric oscillator has attracted interest in m any areas, from quantum optics [19, 20, 21] to phonons [22], m icrocantilevers [23] and electrons and ions in $P$ enning traps [24]. Recent progress in system s based on Josephson junctions and nanoelectrom echan icalsystem s [25, 26, 27, 28] m akes it possible to study squeezed states in a well controlled and versatile

environm ent. B oth classical and quantum uctuations can be investigated and the nature of Sw itching betw een the states can be explored. T he results can be fiurther used in quantum $m$ easurem ents forquantum computing, as in the case of sw itching betw een coexisting states of a resonantly driven oscillator [25].

T he probability distribution and interstate transitions of a param etrically $m$ odulated oscillator have attracted considerable attention. M uch theoretical w ork has been done for $m$ odels where uctuations satisfy the detailed balance condition either in the classical lim it [29] or for $T=0[30,31,32,33,34]$. G enerally this condition does not hold in system $s$ aw ay from equilibrium. In particular a classical nonlinear param etric oscillator does not have detailed balance. Sw itching of such an oscillator was studied experim entally for electrons in $P$ enning traps [35, 36]. The m easured sw itching rate [36] agreed quantitatively w ith the theory [37].

A quantum param etric oscillator also does not have detailed balance in the general case. The results presented below show that breaking the special condition where detailed balance holds leads to a sharp change of the statistical distribution and the sw itching rate. This change occurs already for an in nitesim ally sm all deviation from detailed balance, in the sem iclassicallim it. The fragility of the detailed balance solution is preview ed in Fig. 2. T . his gure show s the e ective inverse tem perature of the intraw ell distribution over the scaled periodtwo quasienergy $g$. The function ${ }^{1} R(g)$ is the exponent of the distribution ${ }^{1} R\left(g_{n}\right)=\quad \ln n$, where $n$ is the population of an $n$-th state and / $1=\mathrm{N}$ is the scaled P lanck constant de ned in Eq. (4) below. The effective inverse tem perature ${ }^{1} d R=d g$ depends on $g$ and di ens from the inverse tem perature of the bath $T{ }^{1}$. The

$\mathrm{T}=\mathrm{n}=0$ result for $\mathrm{dR}=\mathrm{dg}$ is obtained from the solution w th detailed balance (here $\mathrm{n}=\left[\exp \left(\sim!0_{0}=\mathrm{kT}\right) \quad 1\right]^{1}$ is the $P$ lanck number of the oscillator). It is seen from Fig. 2 that the T ! $0(\mathrm{n}!\mathrm{0})$ lim it of the solution $w$ thout detailed balance does not go over into the $T=0$ result.

The e ective quantum activation energy $R_{A}$ $\log W_{\text {sw }}$, which gives the exponent of the sw itching rate $W_{\text {sw }}$, is shown in F ig. 3. It is equal to $\mathrm{R}_{\mathrm{A}}=$ $R(0) \quad R\left(g_{i}\right.$ in $)$, where $g=0$ and $g=g_{m}$ in are, respectively, the values of $g(Q)$ at the top and the minim um of the wells in Fig. 1 . The $\mathrm{n}=0$ detailed balance value for $R_{A}$ strongly di ers from then! 0 value in a broad range of the control param eter that characterizes the detuning of the $m$ odulation frequency from $2!_{0}$, see Eq. (8) below. It is also seen from F ig. 3 that the quantum activation energy $R_{A}$ decreases $w$ ith increasing tem perature. U ltim ately when the $P$ lanck num ber of the oscillator becom es large, $n$ 1, we have $R_{A} / T{ }^{1}$, the law of therm al activation, and the results coincide w ith the results [37] obtained by a di erent $m$ ethod.

In Sec. 四we obtain an e ective $H$ am iltonian that describes the oscillator dynam ics in the rotating fram e. We describe the classical dynam ics and calculate sem iclassicalm atrix elem ents of the coordinate and $m$ om entum. In Sec. III we derive the balance equation for the distribution over quasienergy levels. T his distribution is found in the eikonalapproxim ation in Sec.IV. Its explicit form is obtained in severalphysically im portant lim iting cases in Sec. V. In Sec. VI the probability of interstate sw itching
due to quantum activation is analyzed. In Sec.V II it is show $n$ that the distribution obtained for $T=0$, where the system has detailed balance, is fragile: in the lim it of a large num ber of intraw ell states it di ers from the distribution for $T$ ! 0. It is also dram atically changed by even weak dephasing due to extemalnoise. In Sec. V III we discuss tunneling betw een the coexisting states of period two vibrations and show that interstate sw itching occurs via quantum activation rather than tunneling, if the relaxation rate exceeds the tunneling rate. In Sec. IX we sum $m$ arize the $m$ odel, the approxim ations, and the m a jor results.

## II. DYNAM ICSOFTHE PARAMETRIC O SCILLATOR

A. The $H$ am iltonian in the rotating fram $e$

We will study quantum uctuations and interstate sw itching using an im portant model of a bistable system, a param etric oscillator. T he Ham iltonian of the oscillator has a sim ple form

W ew illassum e that them odulation frequency $!_{F}$ is close to tw ice the frequency of $s m$ all am plitude vibrations ! 0 , and that the driving force $F$ is not large, so that the oscillator nonlinearity rem ains sm all,

H ere, hq ${ }^{2} i$ is the $m$ ean squared oscillator displacem ent; in what follow $s$ for concreteness we set $>0$.

We will change to the rotating frame using the canonical transform ation $U(t)=\exp \quad i \not w^{a}!_{F} t=2$, where $a^{y}$ and a are the raising and lowering operators, $\hat{a}=\left(\sim!_{F}\right)^{1=2}\left(i p+!_{F} q=2\right)$. It is convenient to introduce the dim ensionless coordinate $Q$ and $m$ om entum $P$,

H ere we used the rotating wave approxim ation and disregarded fast oscillating tem $s / \exp \left(i n!_{\mathrm{F}} \mathrm{t}\right) ; \mathrm{n} 1$. A s a result $\mathrm{H}_{0}$ is independent of tim e.

For $>1$, the function $g(P ; Q)$ has twom inima. They are located at $P=0, Q=(+1)^{1=2}$, and $g_{m}$ in $=$

For 1 the $m$ inim a are separated by a saddle at $P=Q=0$, as show $n$ in $F$ ig. 4. $W$ hen friction is taken into account, the m in im a becom e stable states of the param etrically excited vibrations in the classical $\lim$ it [18, 37] [we note that the function $G$ in $R e f .37$ is sim ilar to $g(P ; Q)$, but has opposite sign ].

The function $g(P ; Q)$ is symmetric, $g(P ; Q)=$ $g(P ; Q)$. This is a consequence of the time translation symmetry. The sign change ( $P ; Q$ ) ! ( $P ; Q$ ) corresponds to the shift in tim e by the $m$ odulation period $t!t+2=!$, see Eq. (3). In contrast to the standard Ham iltonian of a nonrelativistic particle, the function $g(P ; Q)$ does not have the form of a sum of kinetic and potential energies, and $m$ oreover, it is quartic in $m$ om entum $P$. This structure results from sw itching to the rotating fram $e$. It leads to a signi cant $m$ odi cation of quantum dynam ics, in particular tunneling, com pared to the conventionalcase of a particle in a static potential.
B. Quasienergy spectrum and classicalm otion

## 1. Period-tw o quasienergy states

The quasienergies of the param etric oscillator $m$ are determ ined by the eigenvalues $g_{m}$ of the operator $g=g(P ; Q)$, with an accuracy to sm all corrections $F=!_{F}^{2}$. They can be found from the Schrodinger equation $\hat{g} \dot{j} i^{(0)}=g_{m} \dot{j}^{n} i^{(0)}$. Because of the sym $m$ etry of $\hat{g}$ the exact eigenfunctions in $i^{(0)}$ are either sym $m$ etric or antisym $m$ etric in $Q$.

The eigenstates in $i^{(0)}$ give the $F$ loquet states of the param etric oscillator $\left(t+{ }_{F}\right)=\exp \left(i_{F}=\sim\right)(t)$. From the form of the unitary operator $U(t)=$ $\exp \left(i \not y^{a}!_{F} t=2\right)$ it is clear that $U(F)$ in $i^{(0)}=j i^{(0)}$, $w$ ith $\backslash+$ " for sym $m$ etric and $\backslash$ "for antisym $m$ etric states in $i^{(0)}$. Therefore we have $m=\left(F^{2}=6\right) g_{n}$ for sym $m$ etric and $m=\left(F^{2}=6\right) g_{m}+\left(\sim!_{F}=2\right)$ for antisym $m$ etric states.

It is convenient to de ne period-two quasienergy by the condition $\sim\left(t+2{ }_{F}\right)=\exp \left(2 i_{F}=\sim\right) \sim(t)$. In this case the relation $m=\left(F^{2}=6\right) g_{n}$ holds for both sym $m$ etric and antisym $m$ etric states. At the sam e tim $e$, there is sim ple one to one correspondence w ith the standard quasienergy states. P eriod-tw o quasienergy states are particularly convenient for describing intraw ell states jni for small tunneling between the wells of $g(P ; Q)$. Such states are com binations of sym $m$ etric and antisym $m$ etric states $\mathrm{jn}^{\left(i^{(0)}\right.}$. For this reason we use period-two quasienergies throughout the paper.

## 2. C lassical intraw ell $m$ otion

W e will study the intraw ell states ji in the sem iclassical approxim ation. T he classical equations of $m$ otion

can be explicitly solved in term $s$ of the Jacobi elliptic functions. The solution is given in Appendix A. There are tw o classical tra jectories for each $g<0$, one per well of $g(P ; Q)$ in $F$ ig. 4. They are inversely sym $m$ etrical in phase space and double periodic in tim $e$,

Here $K\left(m_{J}\right)$ is the com plete elliptic integral of the rst kind, $K^{0}\left(m_{J}\right)=K\left(\begin{array}{ll}1 & m_{J}\end{array}\right)$, and $m_{J} \quad m_{J}(g)$,
is the param eter [38]. T he realpart ofm $J$ can be positive or negative; for Rem $\mathcal{J}<0$, the period $p_{p}^{(2)}$ has not only in aginary, but also a nonzero realpart.

The vibration frequency is ! $(g)=2={ }_{p}^{(1)}$ $2=p^{(1)}(g)$. It $m$ onoton ically decreases $w$ ith increasing $g$ in the range where $g(P ; Q)$ has tw o wells, $\quad(+1)^{2}=4<$ $g<0$, and ! ( $g$ ) ! 0 for $g!0$, i.e. for $g$ approaching the saddle-point value. The periodicity of $Q(1), P()$ in im aginary tim e tums out to be instrum ental in calculating $m$ atrix elem ents of the operators $P, Q$ on the intraw ell w ave functions jni as discussed in the next section.

## C. The sem iclassicalm atrix elem ents

O f central interest to us will be the case where the num ber of states $w$ th $g_{n}<0$, that is the number of states inside the wells of $g(P ; Q)$ in $F$ ig. 4, is large. For$m$ ally, this case corresponds to the lim it of a sm alle ective P lanck constant. For 1 the wave function ji i in the classically acoessible region can be written in the form

Here, $C^{0}$ is the nom alization constant, $P\left(Q ; g_{n}\right)$ is the m om entum for a given $Q$ as determ ined by the equation $g(P ; Q)=g_{n}, Q_{n}$ is the classical tuming point, $P\left(Q_{n} ; g_{n}\right)=0$, and the derivative $@_{P} g$ is calculated for $P=P\left(Q ; g_{n}\right)$.

W e param eterize the classical tra jectories (9) by their phase $=!(g)$, which we count ( m odulo 2 ) from its value at $Q_{n} . W$ ith this param etrization we have

to low est order in . A s we discuss below, these $m$ atrix elem ents determ ine relaxation of the oscillator.

W e will be interested in calculating $\mathrm{a}_{\mathrm{m}}$ ( g ) for $\mathrm{g}<0$. $T$ hen ifw e neglect interw elltunneling, w e have tw o sets of wave functions jin, one for each well. The interw ell m atrix elem ents of the operator a are exponentially sm all. $T$ he intraw ellm atrix elem ents are the sam e for the both

wells except for the overall sign, because $Q$ and $P$ in different wells have opposite signs on the tra jectories $w$ ith the sam eg. W ew ill consider the $m$ atrix elem ents $a_{m}\left(g_{n}\right)$ for the states in the right well $\mathrm{Q}>0$.

The integral (15) can be evaluated using the double periodicity of the functions $Q, P$. It is clear that al + $2 ; g)=a(; g)$ for any complex. In addition, from Eq. A3) for $g<0$ we have $a(+0 ; g)=a(; g)$, where $0=\left(1+p_{p}^{(2)}={ }_{p}^{(1)}\right)$ is a com plex num ber, which is determ ined by the ratio of the periods of $Q$ and $P$. $T$ he shift in tim e by $0=!(\mathrm{g})$ corresponds to a transition from $Q() ; P()$ in one well to $Q() ; P()$ in the other well. $W$ e can now write the $m$ atrix elem ent $a_{m}(g)$ as

W e note that the decay is asym etric w ith respect to the sign ofm. This leads to im portant features of the probability distribution of the oscillator.

## III. BALANCEEQUATION

C oupling of the oscillator to a therm al reservoir leads to its relaxation. W ew ill rst consider the sim plest type of relaxation. It arises from coupling linear in the oscillator coordinate $q$ and corresponds to decay processes in which the oscillatorm akes transitions betw een neighboring energy levels, w ith energy $\sim!0$ transferred to or absorbed from the reservoir. W ew illassum e that the oscillator nonlinearity is not strong and that the detuning
! of them odulation frequency is sm all, whereas the density of states of the reservoir w eighted w ith interaction is sm ooth near ! o. Then the quantum kinetic equation for the oscillator density $m$ atrix in the rotating fram e has the form

W e will assume that relaxation is slow so that the broadening of quasienergy levels is $\mathrm{m} u \mathrm{uch}_{\mathrm{sm}}$ aller than the distance betw een them, ! ( $g$ ). Then 0 -diagonal $m$ atrix elem ents of on the states ji i are sm all. $W$ e note that, at the sam e tim e, o -diagonalm atrix elem ents of
on the Fock states of the oscillator N i do not have to be small.

To the low est order in $=!(\mathrm{g})$ relaxation ofthe diagonal $m$ atrix elem ents $n=h n j$ ini, is described by the balance equation

It follow sfrom Eqs. (17) and (22) that, even for $\mathrm{T}=0$, the oscillator can $m$ ake transitions to states $w$ ith both higher and lower $g$, $w$ ith probabilities $W n n^{0} w$ ith $n^{0}>n$ and $n^{0}<n$, respectively. This is in spite the fact that transitions betw een the Fock states of the oscillator for $\mathrm{T}=0$ are only of the type N i! $\mathrm{N} \quad 1 \mathrm{i}$.

The explicit expression for the $m$ atrix elem ents (17) $m$ akes it possible to show that the probability of a transition to a lower level of $g$ is larger than the probability of a transition to a higher level, that is, $\mathrm{W}_{\mathrm{n}}{ }^{0} \mathrm{n}>\mathrm{W}_{\mathrm{nn}}$ 0 for $n^{0}>n$. Therefore the oscillator is m ore likely to $m$ ove dow $n$ to the bottom of the initially occupied well in F ig.4. T his agrees w ith the classical lim it in which the stable states of an underdam ped param etric oscillator are at the $m$ inim a of $g(P ; Q)$. H ow ever, along $w$ ith the drift dow $n$ in the scaled period-tw o quasienergy $g$, even for $T=0$ there is also di usion over quasienergy aw ay from the $m$ inim a of $g(P ; Q)$, due to nonzero transition probabilities $W_{n} n^{0}$ w ith $n^{0}>n$.

Equation (21) m ust be slightly m odi ed in the presence of tunneling betw een the states $w$ th $g_{n}<0$. The m od$i$ cation is standard. O ne has to take into account that the $m$ atrix elem ents of depend not only on the num ber $n$ of the period-tw o quasienergy level inside the well, but also on the index which takes on two values $=1$, that specify the wells of $g(\mathbb{P} ; Q)$. T hese values can be associated $w$ ith the eigenvalues of the pseudospin operator $z . T$ he $m$ atrix elem ents of the operator ${ }^{\wedge}$ on the $w$ ave functions of di erent wells are exponentially sm all and can be disregarded. The operator describing interw ell tunneling can be written in the pseudospin representation as $i(2){ }^{1} T(g)[x ; ~]$, where $T(g)$ is the tunneling splitting of the states in di erent wells.
$W$ e assum e that the tunneling splitting is m uch sm aller than . Then after a transient time ${ }^{1}$, there is form ed a quasistationary distribution over the states ji in side each of the wells ofg ( $\mathrm{P} ; \mathrm{Q}$ ) in F ig. 4. T h is distribution can be found from Eq. (21) using the wave function jn i calculated in the neglect oftunneling. Interw ell transitions occur over m uch longer tim e.

## IV. D ISTRIBUTION OVER INTRAW ELL STATES

The stationary intraw ell probability distribution can be easily found from Eqs. (21) and (22) if the num ber of levels w ith $g_{n}<0$ is sm all. M uch $m$ ore interesting is the situation where this num ber is large. It corresponds to the lim it ofsm all . W ew illbe interested prim arily in the quasistationary distribution over the states in the well in which the system w as in itially prepared. It is form ed over time $\quad{ }^{1}$ and is determ ined by setting the right hand side of Eq. (21) equal to zero. The resulting equation describes also the stationary distribution in both wells, which is form ed over a much longer tim e given by the reciprocal rate of interw ell transitions.
For $\quad 1$ we can use the $W$ entzel $K$ ram ers $B$ rillouin (W K B ) approxim ation both to calculate the $m$ atrix elem ents in $W_{n n}$ (22) and to solve the balance equation. $T$ he solution should be sought in the eikonal form

Equation (25) has a trivial solution $=1$, which is unphysical. Because all coe cients $W n+m n$ are positive and $W_{n+m n}>W_{n} m_{n}$ for $m>0$, one can show that the polynom ial in the left hand side of Eq. (25) has one extrem um in the interval $0 \ll 1$. Since its derivative for $=1$ is negative and it goes to 1 for ! 0 , it has one root in this interval. This root gives the value $R^{0}\left(g_{n}\right)$. Since < 1 , we have $R^{0}(g)>0$. In tum $R^{0}(g)$ gives $R(g)$ and thus the distribution $n$. In obtaining $R(g)$ from $R^{0}(g)$, in the spirit of the eikonal approxim ation, one should set $R\left(g_{m}\right.$ in $)=0$, where $g_{m}$ in $=(+1)^{2}=4$ is the $m$ inim alquasienergy.

It is seen from Eq. (23) that ${ }^{1} \mathrm{R}^{0}(\mathrm{~g})$ has the $m$ eaning of the e ective inverse tem perature of the distribution

over period-tw o quasienergy. The function $R^{0}(g)$ can be calculated for di erent values of the controlparam eter and di erent oscillator $P$ lanck num bers $n$ by solving Eq. (25) num erically. T he num erical calculation is sim plied by the exponential decay of the coe cients $W n+m n$ with in j. The results are shown in F ig. 6. The function $R^{0}(g)=$ sm oothly varies $w$ th $g$ in the whole range $g_{m}$ in $g<0$ of intraw ell values of $g$, except for very sm all $n$.

N um erical results on the logarithm of the distribution $R\left(g_{n}\right)=\quad \ln _{n}$ obtained from Eq. (25) for $n=0: 1$ are com pared in F ig 7(a) w ith the results of the fill num erical solution of the balance equation (21). In this latter calculation we did not use the W KB approxim ation to nd the transition probabilities $\mathrm{W} \mathrm{nn}^{0}$. Instead they were obtained by solving num erically the Schrodinger equation gini $=g_{n}$ ni and by calculating $W n_{n 0}$ as the appropriately weighted $m$ atrix elem ents hn $\hat{a}^{2} \mathrm{j}_{\mathrm{i}} \mathrm{O}^{2}$, Eq. (22).

In the calculation we took into account that, for sm all , the levels of $g$ form tunnel-split doublets. T he tunneling splilting is sm all com pared to the distance betw een intraw ell states ! (g). The exact eigenfunctions of the operator 9 are wellapproxim ated by sym $m$ etric and antisym $m$ etric com binations of the intraw ell $w$ ave functions. $T$ his allows one to restore the intraw ell $w$ ave functions from the fiull num erical solution and to calculate the $m$ atrix elem ents $W_{n n}{ }^{0}$. By construction, such num ericalapproach gives $R(g)$ only for the values ofg that correspond to quasienergy levels $g_{n}$. It is seen from $F$ ig. 7(a) that the two $m$ ethods give extrem ely close results for sm all (see also below).

## V. THE D ISTRIBUTION IN LIM IT IN G CASES

Thee ective inverse tem perature $R^{0}(g)=$ and the distribution $n$ can be found in several lim ting cases. W e start $w$ ith the vicinity of the bottom of the wells of $g(P ; Q)$. H ere classical vibrations of $P, Q$ are nearly ham onic. To leading order in $g=g \quad g$ in we have $\mathrm{hn}+\mathrm{m} \hat{\beta} \mathrm{j}_{\mathrm{n}} \mathrm{i} / \mathrm{jn} j ; 1 \mathrm{~g}^{1=2}$ for $\mathrm{m} \in 0$, and therefore the transition probabilities $\mathrm{W}_{\mathrm{n}+\mathrm{m} \mathrm{n}} / j_{\mathrm{n}}^{\mathrm{j}, 1} 1$. $T$ he inverse e ective tem perature $R^{0}\left(g_{m}\right.$ in $)$ as given by Eq. (26) $m$ onotonically decreases $w$ ith the increasing $P$ lanck num ber $n$, i.e., $w$ ith increasing bath tem perature T. We note that $R^{0}\left(g_{m}\right.$ in $)$ sm oothly varies $w$ ith $n$ for low tem peratures $n \quad 1$, except for $s m$ all $j j$. $W$ e have $@ R^{0}\left(g_{m}\right.$ in $)=@ n=2^{2=3}(+1)=$ for $n!0$. For $=0$, on the other hand, we have $\mathrm{R}^{0}\left(\mathrm{~g}_{\mathrm{m}}\right.$ in $) \quad \sim!_{\mathrm{F}}=4 \mathrm{kT}$, i.e. the e ective inverse tem perature for $g=g_{m}$ in is sim ply / T ${ }^{1}$.

W e now consider the param eter rangesw here $R^{0}(g)$ can be found for all $g$.
A. C lassical lim it

For $n \quad 1$ the transition probabilities becom e nearly symm etric, $\ddagger \mathrm{N}_{\mathrm{n}+\mathrm{m} \mathrm{n}} \quad \mathrm{W}_{\mathrm{n}} \mathrm{m} n j \quad \mathrm{~W}_{\mathrm{n}+\mathrm{m}} \mathrm{n}$. From Eq. (28), the e ective inverse tem perature $R^{0}=$ is / $[(2 n+1)]^{1}$. In the high-tem perature $\lim$ it $(2 n+$ 1) $2 \mathrm{kT}=\sim!_{0}$. Therefore $\mathrm{R}^{0}=$ is $/ \mathrm{T}^{1}$ and does not contain $\sim$, as expected. Eq. (28) in this lim it coincides $w$ ith the expression for the distribution obtained in $R$ ef. 37 using a com pletely di erent $m$ ethod.

## B. $V$ icin ity of the bifurcation point

The function $R^{0}(g) m$ ay be expected to have a sim ple form for close to the bifurcation value ${ }_{\mathrm{B}}=1$ where the tw o stable states of the oscillatorm erge together and $g(P ; Q)$ becom es single well. This is a consequence of the universality that characterizes the dynam ics near bifurcation points and is related to the slow ing down of $m$ otion and the onset of a soft $m$ ode. T he situation we are considering here is not the standard situation of the classical theory where the problem is reduced to uctuations of the soff $m$ ode. The oscillator is not too close to the bifurcation point, its $m$ otion is not overdam ped and the interleveldistance exceeds the levelbroadening. Still as we show $R(g)$ has a sim ple form.

Them otion slow ing down for approaching 1 leads to the decrease of the vibration frequencies. From Eq. (11),

In the present case the latter inequality is a consequence of the relation $\operatorname{Im}(0 \quad 2) 1$ in Eq. [17), which leads to ja $m(g) j$ jem $(g) j \quad \dot{\beta}_{m}(g) j$. In tum, the above relation between 0 and can be obtained from Eqs. (12) and (18), which show that the right-hand side ofEq. > C. Z ero tem perature: detailed balance
$T$ he function $R^{0}(g)$ can be also obtained for $T=n=0$. $T$ his is a consequence of detailed balance that em erges in this case [34]. The detailed balance condition is usually a consequence of tim e reversibility, which does not characterize the dynam ics of a periodically m odulated oscillator. So, in the present case detailed balance com es from a special relation betw een the param eters for $T=0$.

D etailed balance $m$ eans that transitions back and forth betw een any two states are balanced. It is $m$ et if the ratio of the probabilities of direct transitions betw een two states is equal to the ratio of probabilities of transitions via an interm ediate state

Therefore the periods $\mathrm{p}^{(1 ; 2)}(\mathrm{g})$ of $\mathrm{P}(\mathrm{)}, \mathrm{Q}(\mathrm{)}$, Eq. (11), are sm ooth functions of $g$, except near $g_{m}$ in $=$
 $T$ his divergence of $I m{ }_{p}{ }^{(2)}$ is seen in $F$ ig. 8 . The function $R^{0}(g)$ rem ains nite near $g_{m}$ in , Eq. (26).

For $>0$, on the other hand, the function $R^{0}(g)$ has a singularity. Its location $g_{d}$ is determ ined by the condition $m_{J}=0$, which gives $g_{d}=(1 \quad \beta=4$. , Eq. (18) rem ains nite for $g=g_{d}$. Therefore $R^{0}(g)$ diverges logarithm ically at $g_{d}$, as seen from Fig.8(b).
$P$ hysically the divergence of the inverse tem perature is related to the structure of the transition probabilities $W_{n n}{ }^{0}$ for $n=0$. For $g!g_{d} w e$ have $W_{n n+m} /$ $\left(g_{\mathrm{n}} \mathrm{gil}^{2 \mathrm{~m}}\right.$ for $\mathrm{m}>0$, see Eqs. (17) and (22). This $m$ eans that, for $g_{n}$ close to $g_{d}$, di usion tow ards larger
g slow s down. The slow ing down leads to a logarithm ic singularity of $\mathrm{R}^{0}(\mathrm{~g})$. The eikonal approxim ation is inapplicable for $g$ close to $g_{d}$. $H$ ow ever, the width of the range of $g$ where this happens is $s m a l l, g \quad$, as follow $s$ from the discussion below Eq. (24). In addition, there are corrections to the balance equation due to o -diagonalterm s in the fill kinetic equation. T hese corrections give extra term $s /{ }^{2}=!^{2}\left(g_{d}\right)$ in the transition probabilities $W_{n n} n^{0}$. The analysis of these corrections as well as features of $R$ that are not described by the eikonal approxim ation is beyond the scope of this paper because, as we show, these features are fragile.
$T$ he function $R\left(g_{n}\right)=\quad \ln _{n}$ obtained by integrating Eq. (31) is com pared in Fig. 7(b) w ith the result of the num erical solution of the balance equation (21) w th nu$m$ erically calculated transition probabilities $\mathrm{W}_{\mathrm{n}} \mathrm{n}^{0}$. T he sem iclassicaland num erical results are in excellent agree$m$ ent. W e checked that the agreem ent persists for di erent values of the control param eter and for alm ost all

1, except for a few extrem ely narrow resonant bands of .

## VI. SW IT CHING EXPONENT

Q uantum di usion over quasienergy described by Eq. (21) leads to sw itching betw een the classically stable states of the oscillator at the $m$ inim $\operatorname{afg}(P ; Q)$ in $F$ ig. (4). $T$ he $s w$ itching rate $W_{S w}$ is determ ined by the probability to reach the top of the barrier of $g(P ; Q)$, that is by the distribution $n$ for such $n$ that $g_{n}=0$. To logarithm ic accuracy

where $R^{0}(g)$ is given by Eq. (25). The param eter $C_{S w}$ is of the order of the relaxation rate due to coupling to a them albath.
$T$ he quantity $R_{A}$ plays the role of the activation energy of escape. The activation is due to quantum uctuations that accom pany relaxation of the oscillator, and we callit quantum activation energy. A swe show in Sec.VIII, $\mathrm{R}_{\mathrm{A}}$ is sm aller than the tunneling exponent for tunneling betw een the $m$ inim $\operatorname{a}$ of $g(P ; Q)$. T herefore if the relaxation rate exceeds the tunneling rate, Sw itching betw een the stable states occurs via quantum activation.
$Q$ uantum activation energy $\mathrm{R}_{\mathrm{A}}$ obtained by solving Eq. (25) num erically for $R^{0}$ is plotted in $F$ ig. 3. It depends on the controlparam eter and the $P$ lanck num ber $n$, and it $m$ onotonically increases $w$ ith increasing and decreasing n . C lose to the bifurcation point $\mathrm{B}_{\mathrm{B}}=1$, i.e., for $\quad$ B $\quad$, it displays scaling behavior $w$ ith B. From Eq. (29)

$m$ etric oscillator where the oscillator $m$ otion is still underdam ped in the rotating fram e, i.e., $B$ is not to sm all [37]. It can be seen from the results of Refs . 40, 41 that the exponent $=2$ also describes scaling of the activation energy of escape due to classical uctuations closer to the pitch fork bifiurcation point w here the $m$ otion is necessarily overdam ped.

In the classicallim it $2 \mathrm{n}+1 \quad 1$ we have from Eq. It is seen that $R_{A}$ quickly approaches the classical lim it w ith increasing $P$ lanck num bern, so that even forn $=0: 1$ the di erence betw een $R_{A}(2 n+1)$ and its classical lim it is. $15 \%$. E ectively it $m$ eans that, for sm alln 1 , the exponent in the probability of quantum activation can be approxim ated by the classical exponent for activated sw itching in which one should replace

## VII. FRAGILITYOFTHEDETAILED BALANCESOLUTION

It tums out that the expression for the distribution (23) and (31) found from the detailed balance condition
for $\mathrm{T}=0$ does not generally apply even for in nitesi$m$ ally $s m$ all but nonzero tem perature, in the sem iclassical lim it. This is a consequence of this solution being of singular nature, in som e sense. A periodically m odulated oscillator should not have detailed balance, because the underlying tim e reversibility is broken; the detailed balance condition (30) is satis ed just for one value ofn and $w$ hen other relaxation $m$ echanism $s$ are disregarded.

Form ally, in a broad range of the correction / $n$ to the $T=0$ solution diverges. $T$ he divergence can be seen from Eqs. (19), (22), (31). The transition probabilities $W_{n n+m}$ have tem $s / n$ which vary $w$ ith $m$ as $\exp [2 \mathrm{~m} \mathrm{Im}]$ for $m$ 1. At the same time, the $T=0$ solution (31) gives ${ }^{m}=\exp \left[m!(g) R^{0}(g)\right]=$ $\exp \left[2 \mathrm{~m} \mathrm{Im}\left(\begin{array}{ll}0 & 2\end{array}\right)\right]$. Therefore for the series (25) w th the term / n in $\mathrm{W}_{\mathrm{n}}^{\mathrm{n}+\mathrm{m}}$ to converge we have to have

The condition (35) is $m$ et at the bottom of the wells of $g(P ; Q)$ and also close to the bifurcation values of the control param eter, $\quad$ B $1 . W$ e found that, $w$ ith increasing, the condition (35) is broken rst for $g$ approaching the barrier top, $g!0$. In this region Im 0 ; Im / $\ln j_{j}{ }^{1}$. A som ew hat tedious calculation based on the properties of the elliptic functions show s that the condition (35) is violated when $>1=2$, and for $=1=2$ we have $\operatorname{Im}(03)!0$ forg! 0 . $T$ he increase in leads to an increase of the range of g where Eq. (35) does not apply. T he detailed balance distribution is inapplicable for $T$ ! 0 in this range.

To nd the distribution for sm all $P$ lanck num ber $n$ in the range where $\operatorname{Im}\left(\begin{array}{cc}0 & 3\end{array}\right)>0$ we seek the solution of the balance equation (25) in the form

H ere again, the sum goes overpositive and negativem. In obtaining Eq. (37) we used the generalexpression (17) for the coe cients a $\mathrm{m}_{\mathrm{m}}\left(\mathrm{g}\right.$ ) in $\mathrm{W}_{\mathrm{n}+\mathrm{m} \mathrm{n}}$. In fact, the asym ptotic expressions (19) for $\mathrm{a}_{\mathrm{m}}$ (g) allow one to calculate the sum over $m$ in Eq. (37) explicitly and the result provides a very good approxim ation for .

Equations (36) and (37) give the e ective inverse tem perature $R^{0}=$ and therefore the distribution $n$ as a whole for n 1. It is clear that the n ! $0 \lim$ it is com pletely di erent from the detailed balance solution (31) for $\mathrm{n}=0$, that is, the transition to the $\mathrm{T}=\mathrm{n}=0$ regim $e$ is nonanalytic. The di erence betw een the $n=0$ and the $n!0$ solution is seen in $F$ igs. 2 and 3 .

It follow s from Eq. (37) that the perturbation theory diverges for the value of $g$ where $\operatorname{Im}\left(\begin{array}{ll}0 & 3\end{array}\right)=0$. At such $g$ the $n!0$ solution (36) coincides $w$ th the $n=0$ solution (31). For sm aller $g$ the condition (35) is satis ed and the $\mathrm{T}=0$ solution for $\mathrm{R}^{0}(\mathrm{~g})$ applies; the corrections to this solution are / n 1. The derivative of the e ective inverse tem perature $R^{0}(g)=$ over $g$ is discontinuous at the crossover between n ! 0 and $\mathrm{n}=0$ solutions, as seen in Fig. [2. Figure 2 illustrates also the sm earing of the singularity of $R^{0}(\mathrm{~g})$ due to term $\mathrm{s} / \mathrm{n}$ in $\mathrm{W} \mathrm{nn}^{0}$, which is described by the num erical solution of the balance equation (25). A w ay from the crossover the analyticalsolutions provide a good approxim ation to num erical results.

## A. B reaking of detailed balance solution by dephasing

D ephasing plays an im portant role in the dynam ics of quantum system $s$. It com es from uctuations of the transition frequency due to extemal noise or to coupling to a therm al reservoir. A sim ple $m$ echanism is quasielastic scattering of excitations of the reservoir o the quantum system. Since the scattering am plitude depends on the state of the system, the scattering leads to di usion of the phase di erence of di erent states.

For an oscillator, dephasing has been carefilly studied, both m icroscopically and phenom enologically, see Refs. 42, 43, 44 and papers cited therein. It leads to an extra term $\quad \mathrm{ph}$ in the quantum kinetic equation (20), w ith

It follow s from Eq. (19) that, for large in ${ }^{0} \mathrm{n} j$ we have $W_{n^{0} n}^{(p h)} / \exp \left[2 \mathrm{j}^{0} \quad \mathrm{nj} \mathrm{j}_{\mathrm{m}}\right.$ ], that is, the transition probability exponentially decaysw ith increasing in ${ }^{0} \mathrm{nj}$ and the exponent is determ ined by Im.

Even slow dephasing is su cient for $m$ aking the detailed balance condition inapplicable. $M$ athem atically, the e ect of slow dephasing is sim ilar to the e ect of nonzero tem perature. If the condition (35) is violated, the sum ${ }^{P} W_{n+m}^{(p h)} \exp \left(m!\left(g_{n}\right) R^{0}\left(g_{n}\right)\right)$ with $R^{0}(g)$ given by the detailed balance solution (31) diverges. $T$ he correct distribution for the appropriate $g$ and is given by Eq. (36). The param eter (g) is given by Eq. (37) in which $n$ is replaced,

It is seen from Eq. (40) and $F$ igs. 2 and 3 that, for low tem peratures, even weak dephasing, ${ }^{\mathrm{ph}}=1$, leads to a very strong change of the probability distribution.

The fragility of the detailed balance solution discussed in this section is a sem iclassicale ect. It occurs if the num ber of states in each welln / ${ }^{1}$ is large. Form ally we need $\exp \left[2 \mathrm{NN} \operatorname{Im}\left(\begin{array}{ll}0 & 3\end{array}\right)\right] \& 1$, with $c=c(g) \quad 1$. In other words, the detailed balance solution is fragile provided is su ciently sm all. A full num erical solution of the balance equation con m sthat, when is no longer sm all, the distribution for sm all n ; ${ }^{\mathrm{ph}}=$ is close to that described by the $\mathrm{n}=0 ; \mathrm{ph}^{=}=0$.

## VIII. TUNNELING

The oscillator localized initially in one of the wells of the e ective $H$ am iltonian $g(P ; Q)$ can sw itch to another well via tunneling. For sm all tunneling can be described in the W KB approxim ation. We will rst nd the tunneling exponent assum ing that the oscillator is in the lowest intraw ell state and show that it exceeds the quantum activation exponent $R_{A}=$. W e w ill then use standard argum ents to show that this is true independent of the initially occupied intraw ell state, for all tem peratures.

Ifwe now go back to the originalproblem of sw itching betw een stable states of a periodically $m$ odulated oscillator, we see that sw itching via tunneling can be observed
only where the relaxation rate is sm aller than the tunneling rate, that is the prefactor in the rate of quantum activation is very sm all. Such experim ent requires preparing the system in one of the wells. Tunneling betw een period tw o states of a strongly m odu lated strongly nonlinear system hasbeen dem onstrated in atom ic optics [45, 46, 47]. For a weakly nonlinear oscillator, tunneling splitting betw een the low est states of the $H$ am iltonian $g$ for $=0 \mathrm{w}$ as found in Ref. [48].

The e ective Ham iltonian $g(P ; Q)$ is quartic in the m om entum P . Therefore the sem iclassical m om entum $P(Q ; g)$ as given by the equation $g(P ; Q)=g$ has 4 rather than 2 branches. $T$ his leads to new features of tunneling com pared to the standard picture for one-dim ensional system $\mathrm{s} w$ ith a tim e-independent H am iltonian quadratic in $P$.

For concreteness, we will consider tunneling from the left well, which is located at $\mathrm{Q}=\mathrm{Q}_{10}=(1+)^{1=2} ; \mathrm{P}=$ 0 . The rate of tunneling from the bottom of the well of $g(P ; Q)$ in $F$ ig. 4 is determ ined by the $W$ K B wave function w th $\mathrm{g}=g_{\mathrm{m}}$ in $=(1+)^{2}=4$. This w ave function is particularly simple for $<0$. In the region $Q_{10}<Q$ and not too close to $Q_{10}$ it has the form

For $<0$ the wave function $j$ im onotonically decays $w$ ith increasing $Q$. $T$ he exponent for interw ell tunneling is $S_{\text {tun }}=$, with $S_{\text {tun }}=\operatorname{Im} S_{0}\left(Q_{10}\right)$ (we use that $Q_{10}$ is the position of the right $w e l l$ ),

A $m$ ore interesting situation arises in the case $>$ 0 . H ere, inside the classically forbidden region $\quad 1=2<$ $\mathrm{Q}<{ }^{1=2}$ decay of the wave function is accom panied by oscillations. W e leave the analysis of this behavior for a separate paper. H ere we only note that the tunneling exponent is still given by Eq. (43) .

If the levelsplitting due to tunneling is sm alloom pared to their broadening due to relaxation, the tunneling probability is quadratic in the tunneling am plitude,

The action $2 \mathrm{~S}_{\text {tun }}$ as a function of is plotted in F ig. 10 . It is seen from this gure that the tunneling exponent exceeds the quantum activation exponent $R_{A}=$ for all values of the control param eter . This indicates that, as m entioned above, it is exponentially m ore probable to sw itch betw een the classically stable states of the oscillator via activation than via tunneling from the ground intraw ell state, for not too sm all relaxation rate.

In the same lim it where the relaxation rate exceeds the tunneling rate, we can consider the e ect of tunneling from excited intraw ell states of the H am iltonian g . The analysis is sim ilar to that for system $s$ in therm al equilibrium [1, 2, 3]. O ver the relaxation tim e there is form ed a quasiequilibrium distribution over the states inside the initially occupied well of $g(P ; Q)$. A s before, we assum e that relaxational broadening of the levels $g_{n}$ is sm all com pared to the level spacing. The probability of tunneling from a given state n is determ ined by its occupation $n$. The overall sw itching probability is given by a sum oftunneling probabilities from individual intraw ell states

is the im aginary part of the action of a classical particle $w$ ith $H$ am iltonian $g(P ; Q)$ and energy $g_{n}$, which $m$ oves in complex time from the tuming point $P=0$ in one well of $g(P ; Q)$ to the tuming point in the other well. It follow sfrom the analysis in A ppendix A and Eq. A 3), that the duration of such $m$ otion is $\left(p^{(1)}+p_{p}^{(2)}\right)=2$. Therefore $@ S_{n}=@ g_{n}=\quad \operatorname{Im} p_{p}^{(2)}=2$.

Taking into account that ${ }_{n}=\exp \left(R_{n}=\right)$, we see that the derivative of the overall exponent in Eq. (45) over $g_{n}$ is Im $p^{(2)} \quad R^{0}\left(g_{n}\right)$. It w as show $n$ in Secs. IV and $V$ that this derivative is alw ays positive, cf. F ig. 8 . T herefore the exponent $m$ onotonically increases (decreases in absolute value) $w$ th increasing $g$. $T$ his show $s$ that, $w$ ith
overw helm ing probability, sw itching occurs via overbarrier transitions, i.e., the Sw itching $m$ echanism is quantum activation. W e em phasize that this result is independent of the bath tem perature.

## IX . CONCLUSIONS

In this paper we studied Sw itching betw een the states of period two vibrations of a param etrically m odulated nonlinear oscillator and the distribution over period-tw o quasienergy levels. W e considered a sem iclassical case where the wells of the scaled oscillator H am iltonian in the rotating fram e $g(P ; Q), F$ ig. 4, contain $m$ any levels. The distance between the levels is sm all com pared to $\sim!{ }_{F}$ but much larger than the tunneling splitting. W e assum ed that the oscillator is underdam ped, so that the interleveldistance exceeds their w idth. A t the sam e tim e, of prim ary interest w as the case where th is w idth exceeds the tunneling splitting.

W e considered relaxation due to coupling to a therm al bath, which is linear in the oscillator coordinate, as well as dephasing from random noise that $m$ odulates the oscillator frequency. The problem of the distribution over intraw ell states w as reduced to a balance equation. T he coe cients in this equation were obtained explicitly in the W K B approxim ation, using the analyticalproperties of the solution of the classical equations of $m$ otion. T he balance equation was then solved in the eikonal approxim ation. The eikonal solution was con $m$ ed by a full num erical solution of the balance equation, which did not use the W KB approxim ation for transition $m$ atrix elem ents.

We found that the distribution over period-two quasienergy has a form of the Boltzm ann distribution with e ective temperature that depends on the quasienergy. This tem perature rem ains nonzero even $w$ here the tem perature of the them al bath $T!0$. It is determ ined by di usion over quasienergy, which accom panies relaxation and has quantum origin: it is due to the $F$ loquet $w$ ave functions being com binations of the Fock wave functions of the oscillator.

U nexpectedly, we found that the quasienergy distribution for $T=0$, where the system has detailed balance, is fragile. It di ers signi cantly from the solution for T! 0, for a large num ber of intraw ell states. $T$ he $T=0$ solution is also destroyed by even sm all dephasing.

The probability of sw itching betw een period tw o states $\mathrm{W}_{\mathrm{sw}}$ is determ ined by the occupation of the states near the barrier top of the e ective $H$ am iltonian $g(P ; Q)$. We calculated the e ective quantum activation energy $R_{A}$ which gives $W_{S w} / \exp \left(R_{A}=\right)$. Both $R_{A}=$ and the exponent of the tunneling probability are proportional to the reciprocal scaled P lanck constant ${ }^{1}$. H ow ever, for allparam eter values and allbath tem peratures, $\mathrm{R}_{\mathrm{A}}=$ is sm aller than the tunneling exponent. T herefore in the case where intraw ell relaxation is faster than interw ell tunneling, sw itching occurs via quantum activation.

In the lim it where uctuations of the oscillator are Classical, $k T \quad \sim!_{\mathrm{F}}$, we have $\mathrm{R}_{\mathrm{A}} /(\mathrm{kT})^{1}$, and $\mathrm{W}_{\mathrm{SW}}$ is described by the standard activation law. D own to sm all $P$ lanck num bers $n \& 0: 1$ the quantum activation energy $R_{A}$ is reasonably well described by the classical expression even for sm all $k T=\sim!_{F}$ provided $k T$ is replaced by $\sim!_{F}(2 n+1)=4$, $w$ th $n$ being the $P$ lanck num ber of the oscillator. The inapplicability of this description for $s m$ all $n$ indicates, how ever, that classical and quantum uctuations do not sim ply add up. T he replacem ent $k T!\sim_{F}(2 n+1)=4$ becom es exact for all $n$ close to the bifurcational value of the control param eter $=$ в where the period-two states rst em erge. In this range $R_{A}$ scales w th the distance to the bifurcation point as $R_{A} /(\quad B)^{2}$.

The results on sw itching rate are accessible to direct experim ental studies in currently studied nano-and m icrosystem s, in particular in system s based on Josephson junctions, including those used for highly sensitive quantum $m$ easurem ents.
