Entanglem ent production with multimode Bose-Einstein condensates in optical lattices

Abstract

Deep optical lattices are considered, in each site of which there are m any Bose-condensed atom s. By the resonant m odulation of trapping potentials it is possible to transfer a m acroscopic portion of atom s to the collective nonlinear states corresponding to topological coherent m odes. Entanglem ent can be generated between these m odes. By varying the resonant m odulating eld it is possible to electively regulate entanglem ent production in this multim ode multitrap system of Bose condensates. Entanglem ent is assumed to play an important role in quantum computation and quantum information processing [1{5]. A spossible candidates for engineering entanglem ent, one considers spin assemblies, trapped ions, or Bose-condensed trapped atoms. Here we shall concentrate our attention on atom is Bose-Einstein condensates [6{9]. We shall study entanglem ent production that can be realized between di erent topological coherent modes of nonequilibrium Bose condensates. A general theory of the resonant generation of these coherent modes was advanced in Ref. [10]. The properties of these modes have been intensively investigated [10{30]. A brief survey is given in a recent publication [31].

Let us, rst, recall the meaning of the topological coherent modes [10]. We consider a dilute Bose gas, with the elective local interaction

where a_s is a scattering length, m is atom ic mass. When an atom ic system is conned in a trap and cooled down to very low temperatures, then almost all atom s can be piled down to a single quantum state, thus creating Bose-E instein condensate. The latter form s a coherent system, which is described by the G ross-P itaevskii equation

in which U (r) is a trapping potential. The solutions to the eigenproblem (2), labelled by a set of quantum numbers k, are the topological coherent modes $_{\rm k}$ (r). These are not compulsorily orthogonal, but can always be norm alized to the total number of atom s in the trap,

The lowest-energy mode $_0$ (r) represents the usual Bose-E instein condensate, while the higher-energy modes describe nonground-state condensates.

For each coherent mode $_{k}(\mathbf{r})$, one can construct the coherent state

which is a colum n with elements labelled by the index n. The coherent states are normalized to unity, $\langle _k j_k \rangle = 1$. Though, in general, coherent states are not orthogonal, it is possible to show [32] that the states (4) are asymptotically orthogonal, in the sense that

The totality of all $j_k >$, that is, the closed linear envelope $\overline{L}fj_k > g$, form s the space of states for the trapped atom ic system .

Now, let us consider a set of traps, in each of which there are many Bose-condensed atom s. Such a setup can be realized by creating a deep optical lattice. For example, cold nubidium ⁸⁷Rb atom s have been loaded [33] into an optical lattice, with adjacent sites spaced by a = 5:3 10⁴ cm. Lattice sites were practically independent, with the tunneling time between sites above 10¹⁸ s. The total number of Bose-condensed atom s in the optical lattice was about 7000. The number of lattice sites was typically between 5 to 35. So that the number of condensed atom s in each site could be varied between about 200 to 2000.

Now adays there exists a variety of optical lattices, one-dimensional, two-dimensional, or three-dimensional [34,35]. Multiphoton processes [36] can be employed for creating asymmetric lattice potentials [37]. Optical lattice potentials can be made spin-dependent [38]. Being separated in di erent lattice sites, atom s are practically independent. But if there occurs small, though nite, tunneling, phase coherence may persist on short length scales even deep in the insulating state [39].

A ssume that in each lattice site of an optical lattice there are many Bose-condensed atom s, so that each site plays the role of a trap. The space of states for a j-trap is

consists of the states having the form of the tensor products. An arbitrary state of the considered system of traps can be represented as

whose coe cients de ne the mode probabilities, or the fractional mode populations

Let the number of trapping sites be L, with M coherent modes each. If the coe cients c_k (t) in state (8) can be varied, then di erent entangled states can be created, such as the B ell states

for L = 2 and M = 2, the multicat states

W hen the system is in a pure statistical state, then its statistical operator is

Entanglem ent, generated by a statistical operator $^(t)$, is quantiled [40,41] by the measure of entanglem ent production

For L trapping sites of a lattice, we nd

In order to generate higher coherent m odes, it is necessary to apply an external resonant eld [10,31]. We assume that the same m odulating eld acts on all lattice sites. The eld has the form

Here (t) = 0;1 is a switching function that allows one to switch on and o the resonant eld (15). The frequency ! is tuned close to the transition frequency

in which E_0 is the energy of the ground-state m ode and E_1 is the energy of the desired m ode to be generated. The resonance condition is implied, such that

W ith the resonant m odulating eld (15), the time-dependent G ross-P itaevskii equation becom es

where the nonlinear Schrodinger H am iltonian is

and the function ' (r;t) is normalized to one, jj = 1.

The solution to Eq. (18) can be represented as the mode expansion

in which the coe cient functions c_k (t) de ne the fractional mode populations (9). These functions can be found as the projections

The dynam ics of the mode populations essentially depends on the strength of atom ic interactions and on the amplitude of the resonant eld [10,31]. We shall denote by b the dimensionless amplitude of the modulating resonant eld, reduced to the strength of atom ic interactions. Respectively, the tem poral behaviour of the entanglem ent production measure (14), which for the two-mode case takes the form

strongly depends on the properties of the resonant eld.

We assume that at the initial time t = 0 solely the ground-state is available, so that $n_0(0) = 1$ and $n_1(0) = 0$. Then the resonant eld (15) is switched on, generating an excited coherent mode and changing the entanglement production measure (20). There are two ways of regulating the amount of entanglement production.

First, one can vary the amplitude and frequency of the resonant pumping eld, choosing by this the required parameters, whose values de ne two main regimes of an oscillatory behaviour of "₂(t). These are the mode-locked and mode-unlocked regimes [31]. We solve numerically the evolution equations and calculate the measure of entanglement production (20). Keeping in mind that the detuning can always be made small, we set it to zero. Then the value $b_c = 0.497764$ is the critical point for the change of the dynamical regimes. Below b_c , the measure (20) oscillates with time, never reaching one, as is shown in Fig. 1. When the parameter b reaches the critical point $b = b_c$, then the oscillating "₂(t) reaches one, as is demonstrated in Fig. 2. For the dimensionless amplitude of the pumping eld $b > b_c$, the oscillations of "₂(t) are always in the interval between 0 and 1. But the oscillation period sensitively depends on the value of b. Thus, for b = 0.5, just a little above b_c , the period of oscillations, shown in Fig. 3, is more than twice shorter than that in Fig. 2 for $b = b_c$. The period for b = 0.7, as is demonstrated in Fig. 4, is about eight times shorter than in Fig. 2. Thus, by varying the amplitude of the pumping resonant eld, we can strongly in uence the evolution of "₂(t) both in its amplitude and period of oscillations.

There is one more very interesting way of regulating entanglement generation, which can be done by switching on and o the applied resonant eld. Recall that this alternating eld can be easily produced by modulating the magnetic eld forming the trapping potential in magnetic traps or by varying the laser intensity in optical traps. Then, it is possible to create various sequences of pulses for " $_2$ (t). For example, by switching on and o the resonant eld in a periodic manner, we may form equidistant pulses of " $_2$ (t), with all pulses having the same shape, as is demonstrated in Fig. 5. But we can also switch on and o the pumping eld at di erent time intervals, thus, forming nonequidistant pulses, as is shown in Fig. 6. The possibility of creating very di erent pulses is illustrated in Fig. 7. Regulating entanglem ent production by m eans of a manipulation with the resonant pumping eld, it is feasible to organize a kind of the M orse alphabet.

Here we have considered entanglem ent production in a multim ode Bose-E instein condensate baded in a deep optical lattice. The arising entanglem ent production occurs for di erent coherent m odes generated by a resonant external eld. Recently ultra-cold ferm ions in optical lattices have attracted great attention (see survey [42]). Entanglem ent production for ferm ions in optical lattices can also be considered, though requiring di erent techniques. Varying the interaction between ferm ions by m eans of the Feshbach resonance m ethods, bound ferm ionic states can be achieved, form ing bosonic m olecules. The latter can be Bosecondensed (see [43,44] and references therein). Therefore the coherent m odes of m olecules can be created, sim ilarly to those of atom s. Then the entanglem ent production form olecular coherent m odes can be studied in the way analogous to that for atom ic coherent m odes.

The measure of entanglement production (14) or (20) is directly connected with the fractional mode populations. The latter de ne the spatial features of atom ic clouds inside each lattice site. Thus, analyzing the spatial distribution of atom s, one can make conclusions on the mode entanglement production. The spatial distribution can be studied by means of scattering experiments. W ave scattering on periodic structures is known to possess a number of interesting properties [45]. A nother possibility of studying the spatial characteristics of atom ic clouds is through the time-of-ight experiments, by releasing atoms from the trapping potentials and observing the atom expansion and interference.

In conclusion, a multitrap ensemble of multimode Bose-Einstein condensates, subject to the action of a common resonant eld, is analogous to a system of nite-level atoms in a common resonant electromagnetic eld. A multitrap system can be formed, e.g., as an optical lattice with deep potential wells, incorporating many atoms around each lattice site. In the multitrap multimode condensate a high level of entanglement can be achieved. By varying the amplitude and frequency of the pumping resonant eld, di erent regimes of evolutional entanglement can be realized. Moreover, by switching on and o the pumping eld in various ways, it is feasible to create entanglement pulses of arbitrary length and composing arbitrary sequences of punctuated entanglement can, probably, be useful for information processing and quantum computing.
