Stochastic Potential Switching A lgorithm for M onte Carlo Simulations of Complex System s

This paper describes a new M onte C arbo m ethod based on a novel stochastic potential switching algorithm. This algorithm enables the equilibrium properties of a system with potential V to be computed using a M onte C arbo simulation for a system with a possibly less complex stochastically altered potential V. By proper choices of the stochastic switching and transition probabilities, it is shown that detailed balance can be strictly m aintained with respect to the original potential V. The validity of the m ethod is illustrated with a simple one-dimensional example. The m ethod is then generalized to multidimensional system s with any additive potential, providing a framework for the design of m ore e cient algorithms to simulate complex system s. A near-critical Lennard-Jones uid with m ore than 20000 particles is used to illustrate the m ethod. The new algorithm produced a m uch smaller dynam ic scaling exponent compared to the M etropolism ethod and in proved sampling e ciency by over an order of m agnitude.

I. IN TRODUCTION

Simulations of complex molecular systems are generally carried out using either the molecular dynam ics (MD) or the Monte Carlo (MC) method. Each method has its own merits. The MD method [1, 2], based on the integration of the classical equations of m otion of the particles, is conceptually the simpler of the two. W ith currently available com puter power, M D sim ulations generally cannot be carried out for very long time scales for very large system s, m aking the extraction of true equilibrium properties often di cult. The MC method [3, 4], on the other hand, relies on stochastic dynam ics to generate members of the desired ensemble. MC has the ability to execute non-physical large-scale transitions that are impossible in MD and has the potential to reach equilibrium much faster. However, devising these large-scale transitions that have reasonable acceptance probabilities is not always straightforward.

To search for ways to enable large-scale transitions to be carried out with higher probability in M C simulations, one must tackle the core problem, which is the com plexity of the interactions among the particles in the system. If there were no interactions among these particles, any transition, regardless of its scale, would always be accepted. W hen a move ismade in M C, the interactions involving those particles that are being moved will change. In general, the larger the scale of the move and the more com plicated the interactions are, the larger the change in the potential becom es. Consequently, large-scale M C m oves are very unlikely to be accepted.

A natural questions arises: Is it possible to reduce the complexity of the interactions among the particles, for instance, by replacing the actual potential V by a less complex potential V? O ne possibility is proposed in this paper. W ith this method, it is indeed possible to replace the original potential V by an arbitrary V. But the procedure has to follow a carefully constructed algorithm to guarantee that detailed balance with respect

to the original potential is maintained, so that the correct statistics are produced. An idea similar to this has been exploited in a number of previously proposed M onte C ando m ethods, such as J-walking [5, 6, 7], simulated tempering [8, 9], parallel tempering [10, 11, 12, 13], catalytic tempering [14], multicanonical J-walking [15] and the approximate potential method [16]. But we will show that when generalized to multidim ensional systems, the present method provides exibilities and potential advantages that are not available with these previous methods and establishes a theoretical fram ework for the design of possibly more e cient algorithm s for simulating com plex system s.

II. THE SPS IDEA

Let x be the con guration of a N-dimensional system and V (x) the potential energy divided by the Boltzm ann constant k_B . The statistical weight of each member of the canonical ensemble is exp (V (x)=T), T being the absolute temperature. A MC algorithm that generates congurations consistent with their statistical weights can be constructed from any set of transition rules, as long as the transition probabilities W between every pair x and x^0 satisfy the detailed balance condition:

The new MC algorithm we propose proceeds as follows:

 First, consider changing the system potential V to an arbitrary potential V. This \potential sw itching" decision is carried out with a stochastic sw itching probability

with V(x) = V(x) $\forall(x)$ and V is a constant greater than or equal to the maximum value




FIG.1: Illustration of the SPS procedure. (See text for details.)

of V (x) over all x. By incorporating V into Eqn.(2), we ensure that S (x) is between 0 and 1. Note that if V is very large, the resulting S (x) will be small, making switching very infrequent. For systems with a V that is bounded from above, it is always possible to choose a \vec{V} which yields a nite V. System s with an unbounded V will be addressed in Sect.V.

2. If the switch is made, the con guration of the system is moved from x to x^0 with transition probability $W'(x ! x^0)$ chosen to satisfy detailed balance on the switched potential V', i.e.

Any W', such as M etropolis [17], m ay be used here as long as it satis es Eqn. (3).

3. If the switch is unsuccessful, the con guration of the system is moved from x to x^0 with transition probability W (x ! x^0) chosen to satisfy detailed balance on a pseudopotential

Sim ilar to step 2, any W m ay be used here as long as it satis as detailed balance on V .

A fier the move from $x ! x^0$ is made (accepted or rejected), the cycle is over and the algorithm returns to step 1. This stochastic potential switching (SPS) idea, with the relevant potential switching and subsequent M C transition probabilities, is illustrated schematically in Fig.1. O by iously, the SPS algorithm can be used alone in a sim – ulation (if the moves are ergodic) or mixed with other M C moves.

W ith the algorithm de ned above, it is easy to prove that the composite transition probability:

when substituted into Eqn.(1), indeed satis es detailed balance with respect to the original potential V. Therefore, the MC trajectory generated by this SPS idea will produce a sequence of con gurations fxg that is consistent with the canonical ensemble for a system with potential V (x). It is important to emphasize that the choice of V is can plately with the product for all V

tentialV (x). It is important to emphasize that the choice of V is completely arbitrary | the proof works for all V. In a real application, one can exploit this arbitrariness to select a V that may be either less complex than the original V or less costly to compute. For a system where the potential is a sum of additive term $sV = \int_{i} V_i$, often the case form any-particle system s, the switching decision can be applied to each V_i separately. This generalization will be described in Sect. V.

In form described above, the SPS idea is conceptually related to J-walking [5, 6, 7], parallel tempering [10, 11, 12, 13], and the \approximate potential" method [16]. In J-walking, the simulation is stochastically switched to a con guration sampled from a highertem perature (T^{0}) simulation of the same potential with properly chosen transition probabilities. This is essentially the same as using a potential that is attenuated by a factor $T = T^0$ as \tilde{V} in SPS.Sim ilarly, in parallel tem pering, the exchange of replicas between two di erent tem peratures is equivalent to having one switched to an attenuated potential and the other to a higher potential. In the approximate potential method, the simulation is switched to an approximate potential, and the new conguration produced on the approxim ate potential is accepted or reject at the end with a \correction" rate that is designed to maintain detailed balance with respect to the original potential; whereas in SPS, the switching decision is made before the move, so that the subsequent update on $\forall w$ ill always be accepted. Even though SPS is conceptually akin to these otherm ethods, we will show in Sect.V that when SPS is generalized to multidim ensional systems, its o ers exibilities and potential advantages that are not currently available in these related methods.

III. EXAMPLE: A ONE-DIMENSION MODEL

We use a simple one-dimensional example to illustrate the basic SPS idea. The model we selected was a harmonic potential V (x) = $\frac{1}{2}x^2$, with x conned to within the range [1;1]. We used ve diment $\forall (x) = \frac{1}{2}x^n$, with n = 0, 1, 2, 3 and 4 to demonstrate that the ensemble averages were indeed invariant with the choice of \forall and the choice of \forall is hence arbitrary. For each of the ve \forall , we sampled x according to the SPS algorithm using simple M etropolism oves on both \forall and V.n = 2 is a special case, because for n = 2, \forall = V, so the switch is make with unit probability. The SPS algorithm for n = 2 is thus equivalent to the norm al M etropolis (i.e. non-SPS) algorithm.

The moments hx^m i at T = 0.2 for m = 1 to 10 are shown in Table I for the ve di erent \vec{V} . The results are clearly invariant with the choice of \vec{V} to within statistical errors, showing that detailed balance is strictly satis ed with respect to V for any \vec{V} . The switching rate R_S is

also show n for each $V \cdot R_S$ is in general low er for those V (particularly n = 1 and 3) that are very di erent from the original potential $V \cdot N$ otice also that n = 0 corresponds to a at potential. In this case, if the sw itch is made, the potential is completely turned o .

IV. RELATIONSHIP TO ISING-TYPE CLUSTER ALGORITHMS

A M C m ethod that is capable of executing large-scale m oves with high probability was proposed by Swendsen and W ang [18] for the Ising m odel in 1987. This m ethod later led to the discovery of a class of m ethods now collectively known as \cluster algorithm s" [19]. These cluster algorithm s can be shown to be special cases of the SPS algorithm . W hereas these cluster algorithm s perm it large-scale M C m oves, they are largely restricted to discrete m odels and are not generally applicable to m olecular simulations. The SPS m ethod provides a way to transfer the ideas behind these cluster algorithm s to continuous system s.

In the original Swendsen-W ang algorithm, the interaction between each pair of Ising spins $_i$ and $_j$ is stochastically deleted with a probability $p_d = \exp[J(_{i j} 1)]$, where J is the Ising interaction. W hen an interaction is successfully deleted, it has no e ect on the subsequent M C m ove. On the other hand, if an interaction is not deleted, it is frozen such that the value of this interaction is constrained to remain constant in the subsequent M C m ove. A fter all the interactions have been either deleted or frozen, the spins break up into clusters of spins having frozen interactions. Each cluster can be ipped independently of the others. Swendsen and W ang show ed that this cluster algorithm satis es detailed balance and it produces much faster equilibration com pared to the conventional M etropolis algorithm [17]._p

The Ising model has potential V = $_{(ij)}^{}$ V_{ij}, where V_{ij} = J_{ij} and the sum goes over all nearest-neighbor pairs. It is easy to show that the Swendsen-W ang algorithm can be derived from the SPS algorithm by making the special choice V_{ij} = 0. As such, the SPS algorithm can be considered as a \generalized" cluster algorithm. However, we choose not to use this term inology because calling SPS a generalized cluster algorithm would in - properly in ply some geometric origin. W hereas in discrete system s such as the Ising model there is an obvious geom etric interpretation for the SPS algorithm, there may not be any in more general continuous system s.

V. GENERALIZATION TO SYSTEMSWITH ADDITIVE POTENTIALS

W hile the validity of the SPS algorithm is clear for the basic case considered in Sect. II, the utility of the SPS algorithm in this form is rather limited. There are several reasons why this form ulation of the SPS algorithm may not be very practical. (1) The choice of a good ∇ is not obvious. (2) Because S (x) in Eqn. 2 is scaled by $e^{-\nabla} =^{T}$, unless ∇ is close to ∇ everywhere, the switching frequency will be in general small. (3) For a ∇ that is not bounded from above (as in systems with repulsive interactions), there may not be a way to choose a ∇ that keeps ∇ nite.

To make the SPS algorithm more useful, we must rst generalize it to an additive potentialV that can be written as a sum of two orm ore terms. Any V can be decom – posed into an arbitrary sum. Some systems, such as those with pairwise interactions, have potentials that break up naturally into a sum of terms. In other situations, the potential may have two or more distinct parts that are responsible for di erent physical phenom ena, such as the repulsive and attractive part of a Lennard-Jones potential [20]. W e will see that the usefulness of the SPS algorithm is related to how V is decom posed. O ur form ulation here is inspired by the ideas of K andelet al. [21] who have provided a generalization of the Sw endsen-W ang algorithm [18] for discrete-state (Ising) m odels.

To illustrate the generalization of the SPS algorithm to a continuous system with an additive potential, we consider a potential with just two terms V (x) = V₁ (x) + V₂ (x). Extension to more than two terms is straightforward. We can apply the SPS algorithm in Sect. II to each of the terms separately, attempting to switch V₁ to a new V₁ and V₂ to another V₂ with switching probabilities $S_1(x) = e^{(V_1(x) - V_1)=T}$ and $S_2(x) = e^{(V_2(x) - V_2)=T}$, respectively. Since the potential terms are additive, the switching of V₁ and V₂ are independent of each other and can be performed in any order.

For two terms in the potential, there are four possible outcom es of the switching decision. For each one, the next part of the simulation will proceed on a di erent potential: (1) if both V_1 and V_2 are switched, the new potential becomes $V_1 + V_2$; (2) if both V_1 and V_2 are not switched, the new potential becomes $V_1 + V_2$; (3) if V_1 is switched but V_2 is not, the new potential becomes $\nabla_1 + \nabla_2$; (4) if ∇_1 is not switched but ∇_2 is, the new potential becom es $V_1 + \tilde{V}_2$, where V_1 and V_2 are de ned as in Eqn. 4. A fler the switch is made, the system can be m oved from con guration $x \mid x^0$ on the new potential. At the end of the move, the original potential can be restored to restart the switching process anew . One can easily show that with this algorithm, detailed balance with respect to the original potential is strictly obeyed along any one of the four pathways. This is a direct result of the additivity of V_1 and V_2 . The sum over all four pathways therefore also obeys detailed balance.

In the above, we have considered switching both terms in V, but this needs not be. In fact, we can apply the switching to an arbitrary subset of terms. For example, we may consider switching only V_1 to \tilde{V}_1 and keeping V_2 \alive". If the switching is successful, the new potential becomes $\tilde{V}_1 + V_2$; otherwise, it is $V_1 + V_2$. This scenario is equivalent to using a $\tilde{V}_2 = V_2$ and thus also satis es detailed balance. This strategy may be useful, for example,

in the case of a V that is not bounded from above. In this case, we can decom pose the potential into the repulsive (unbounded) and attractive (bounded) parts, but apply the sw itching only to the attractive part.

It should now be clear why decomposing V into many additive terms makes the SPS algorithm more practical. In the original form upation of the SPS algorithm in Sect. II, the entire $V = \langle V \rangle$ is switched to \bar{V} . The probability for the simultaneous switching of all V_{γ} is $\langle S \rangle$. If the potential contains a large number of terms, the total switching probability will be small even if each individual S_{γ} is close to unity. Therefore, switching the entire V is alm ost in possible, but individual terms in V can be switched with a much higher probability.

C oupled with good physical insights, the additivity of V can be exploited to devise e cient SPS algorithm sthat m ay be m ore optim al than others. Some system s, such as those with pairwise interactions, have a natural decom position for V. Thism ay be used to guide the search for an optim al breakup. On the other hand, there m ay be a totally unphysical breakup that a ords higher e - ciency. The additivity of V o ers immense possibilities. In the next section, we will illustrate this using a non-trivialm any-particle example.

In fact, crude elements of the basic SPS idea have already appeared in one of our recent studies on the M onte C arb simulations of imaginary-time path integrals [22], and these ideas have been proven useful for accelerating the sampling of sti paths. The strategy proposed there was later implemented in a large-scale path integrals implant of super uid molecular H₂ clusters [23]. These studies motivated us to rene the crude ideas contained in those two papers and formulate the more general theoretical framework for the SPS algorithm that has been presented in this section.

VI. EXAMPLE: A LENNARD -JONES FLUID NEAR ITS CRITICAL POINT

The correlation length of a system diverges near the critical point. Small local uctuations of the system at large separations become correlated with each other, making M onte C arlo simulations extrem ely sluggish [4]. This so-called \critical slowing-down" problem leads to extrem ely long equilibration time for M onte C arlo simulations that em ploy only local updates, such as the conventional M etropolis algorithm. N on localm oves can also be made using the M etropolis algorithm, but such m oves are alm ost always rejected because of the reason given in the last section.

We will dem onstrate how the SPS method can be used to deal with the critical slowing-down problem in a Lennard-Jones uid. The simulations were carried out in a cubic box with periodic boundary condition. A Lennard-Jones potential u(r) = 4 $(=r)^{12}$ $(=r)^6$ that is truncated but unshifted at $r_c = 2.5$ was used for the calculations. Previously, the critical temperature T_c and density $_c$ for this system were found to be $k_{\rm B}\,T_{\rm c}$ = 1:1853 and $_{\rm c}$ 3 = 0:3197 [24]. To check scaling, we vary the box length L from L = 10 to 40, using up to 20464 particles to maintain a xed density. Since the heat capacity is expected to diverge as T_c [25], the slowing-down problem should be manifested in the energy measurement. We compared the scaling of the autocorrelation time for the energy estimator with the box length L of the SPS m ethod against the M etropolis algorithm and found a much smaller dynamical scaling exponent for the SPS method.

To implement the SPS method, we break up the total potential V = $_{i < j} u(r_{ij})$, where r_{ij} is the distance between particles i and j, in two stages. First, we can obviously break V up into the individual pair interactions $u(r_{ij})$. Next, for each of the pair interactions, we can further decompose it into its positive and neg-

ative parts, $u = u_{+} + u_{-}$, such that u_{+} (r) is everywhere zero except for r < where u_+ (r) = u(r), and u is its complement. With this, the total potential becomes $_{i < j} u_{+} (r_{ij}) + u (r_{ij})$. (We have also tried to de-V = compose u according to the W CA prescription [20] but found no major di erence in the e ciencies of the two breakups.) With this decomposition, u+ is a purely repulsive potential, whereas u is bounded from above by zero. We apply the SPS algorithm to each of the u (r_{ij}) terms to try to switch it to $\alpha = 0$ but keep all the ซ forallr, u u+ (rij) alive. Since u (r) can be simply set to 0.

The SPS algorithm, when applied to the Lennard-Jones uid, proceeds as follows. Starting from the current con guration fr_ig , we attempt to switch o each of the u (rij) one by one. A fter the switching decision has been completed for every $u(r_{ij})$, the particles now interact with a modi ed potential in which some pairs of particles interact with u while the rest have zero attraction between them . Since u_+ have been kept alive, every pair of particles also interact through the purely repulsive u₊. At this point, one can employ any M onte C arlo m ove to update the system on this stochastically modi ed potential. One simple possibility is to apply a Metropolis algorithm with a local update to the SPS modied potential, just like on the original potential. But as we will see, doing this alone will not im prove the dynam ical characteristics of the sam pling.




FIG. 2: Scaling of the autocorrelation time of the energy estimator with the box length L in the simulation of a Lennard-Jones uid at its critical point. The dynam ical exponents for the conventional M etropolis m ethod on the original potential (squares) and on the SPS m odi ed potential (triangles) are identical and equal approximately 2.8. The dynam ical exponent in the SPS algorithm with the cluster reection update (circles) is 1.3.

The autocorrelation time in MC pass for the total energy measurement is shown in Fig. 2 for di erent box sizes L, comparing the conventional Metropolis algorithm with a local update applied to the original potential (square) against the same Metropolis update applied to the SPS modi ed potential (triangles). In both simulations, one MC pass is de ned as having attempted one move for each particle in the system. Not surprisingly, the dynamic scaling behaviors of the two are identical to each other. Since both simulations are based on the same local update method and they both satisfy detailed balance, the dynamical characteristics of the two sampling methods ought to be the same. To improve sampling e ciency, nonlocal moves must be used.

In a near-critical system, the slowing-down problem is related to the divergence of the correlation length. Updatem ethods that employ only localm oves will therefore have poor dynamical scaling, since they are unable to effect large-scale rearrangem ents of the system. SPS provides a basis for designing possibly more e cient alternative update schemes. The system potential can be significantly simplied using SPS, enabling large-scale moves to be perform ed with much higher acceptance ratio com pared to the original potential.

To perform large-scale moves in the near-critical Lennard-Jones uid on the SPS modi ed potential, we employed a simple scheme based on an algorithm originally proposed by D ress and K rauth [26] to treat hard sphere systems. We changed the method to suit the present situation, and our algorithm is illustrated in




FIG.3: Illustration of the cluster re ection algorithm . (a) Particles connected by frozen u $\,$ (4-7 and 9-10) are bonded, shown in the gure connected by think lines. Particles that have a nonzero u_+ between them (3-4, 5-6 and 8-10) are show n as overlapping. Bonded and overlapping particles break up into disjoint clusters. In this example, there are six disjoint clusters. This forms the \background" con guration. The cross indicates the position of the pivot, which for this illustration is near the center of the cell. (b) All particles in the background are rejected across the pivot to generate the \foreground" con guration shown in grey. The new position of each particle i in the foreground is labeled i^0 . (c) 0 verlaying (b) on (a) generates superclusters from overlapping foreground and background clusters. In addition, foreground and background positions of the same particle are in the same cluster by default. In this example, there are three dispint superclusters: $(1^{\circ};1;11^{\circ};11)$, $(5^{\circ};5;6^{\circ};6)$, and a third encom passing the rest. (d) For each supercluster, either all the foreground or all the background positions are accepted into the new con guration. In this example, two superclusters take on the background positions and one supercluster takes on the foreground positions.

Fig. 3 and proceeds as follows.

- For every pair of particles interacting with u , we freeze their distance by placing a rigid \bond" between them .
- For every pair of particles that have a nonzero u₊ between them, we consider them to be \overlapping" and also freeze their distance.
- 3. Based on the bonds and overlaps, we break the particles up into disjoint clusters. Two clusters are disjoint if there is no bond or overlap between them. This constitutes the \background" con guration in Fig. 3(a).
- 4. To move the clusters, a point inside the simulation box is random ly selected to be the pivot (illustrated by the cross in Fig. 3(a)), and all particles in the box are rejected across the pivot to obtain the \foreground" con guration in Fig. 3(b).
- 5. When the foreground is overlaid on the background, the clusters from the foreground and background form additional overlaps (but no additional bonds). The foreground and background positions of the same particle are also by default considered to be in the same cluster. Overlapping clusters can then be broken up into disjoint superclusters as in Fig. 3 (c).
- 6. Since there is no overlap between any particles (either foreground or background) from two disjoint superclusters, we can choose random ly to accept either the foreground or background positions inside

each supercluster with equal probability. An example of the resulting new con guration is illustrated in Fig. 3(d).

This completes one pass in our SPS simulation. At this point, the simulation can start over with another cluster move from step 1, or we can carry out a M etropolis sweep before going back to 1. Notice that since the switching is done stochastically, a di erent cluster structure would be generated every time even if the switching is applied to the same con guration.

In is easy to show that the cluster re ection algorithm above satis es detailed balance in a trivial way, because the m ove conserves the nonzero part of the total potentialof the system by xing all the bonds and overlaps and the re ection clearly produces sym metric transition probabilities. However, by itself the cluster re ection algorithm is nonergodic, because particles that have no overlap with each other in the con guration before the move will have no overlap either after the move. To have an ergodic M onte C arlo simulation, this cluster re ection algorithm must be mixed with another ergodic move, such as M etropolis using a local update. In our simulations, we perform ed one M etropolis move for every 10 cluster updates, which adds minim al costs to the CPU time.

Autocorrelation times in MC pass for the total energy measurement is shown in Fig. 2 for the SPS algorithm using the cluster re ection update (circles). For the SPS algorithm, one MC pass is de ned as having made one cluster re ection move plus one-tenth of a M etropolismove (needed for ergodicity). In actual CPU time, a SPSMC pass is about 20% faster than a M etropolisMC pass. Near the critical point, the autocorrelation time is expected to scale with system size as ${\tt L}$, and the dynamical scaling exponent is a measure of the e ciency of the MC method. Clearly, the SPS method has a much smaller dynamical exponent. In term s of absolute e ciency, the SPS algorithm is more than ten times better for the largest simulations considered (L = 40 with 20464 particles), and accounting for CPU time di erence, the SPS algorithm is actually 13 times better.

A generalized geom etric cluster algorithm that is also based on the D ress and K rauth clusterm ove has also been proposed recently by Liu and Luiten [27]. In their approach, the energies of the con guration before and after the cluster m ove have to be com puted to determ ine the transition probabilities; whereas in our SPS algorithm, only the energy before the m ove has to be com puted in order to determ ine the switching probabilities. In cases where the potential is com plicated and costly to com pute, the SPS algorithm here will o er CPU time savings com – pared to the m ethod of Liu and Luiten, but it m ay su er from low er switching rates.

VII. CONCLUSIONS

In summary, we have presented a new Monte Carlo method that is based on a stochastic potential switching algorithm. This new algorithm enables the equilibrium properties of a system with potential V to be com – puted using a Monte Carlo simulation for a system with a possibly less complex stochastically altered potential V. Generalization of this method to system s with additive potentials provides for an e cient scheme for simulating complex systems. The validity of the method is illustrated with a simple one-dimensional example, and its practical utility in alleviating the critical slowing-down problem is illustrated with a Lennard-Jones uid near its critical point.
