G round states of the Josephson vortex lattice in layered superconductors

W e consider the ground state con gurations of the Josephson vortex lattice in layered superconductors. Due to commensurability e ects with the layered structure, the lattice has multiple congurations, both aligned with layers and rotated at nite angle. At low elds the lattice switches between these con gurations via rst-order phase transitions. These transitions become more frequent at smaller elds. W ith increasing magnetic eld a dilute lattice transforms rst into a sheared dense lattice. W ith further increase of eld, the shear deform ation smoothly vanishes at a secondorder phase transition.

A magnetic eld applied parallel to the layers generates a lattice of Josephson vortices with many unusual static and dynam ic properties. An important eld scale is set by the anisotropy factor and interlayer periodicity s, $B_{cr} = 0 = (2 s^2)$ (in $B_{12}Sr_2CaCu_2O_8$, 0:3 0:5T). There are two very di erent regimes Bcr depending on the strength of the magnetic eld. In the dilute lattice regime, Bx B_{cr} , the nonlinear cores of Josephson vortices are well separated and the distribution of currents and elds is very similar to that in continuous anisotropic superconductors. At high elds, $B_x > B_{cr}$, the dense lattice regime is realized where the cores of the Josephson vortices overlap. In this regime the Josephson vortices ll all layers hom ogeneously. This state is characterized by very weak modulations of the in-plane and Josephson currents. In this proceedings we consider the evolution of the ground state con guration with increasing magnetic eld.




FIG.1: (a) G eneral Josephson vortex lattice and its parameters. (b) O rientation of layered structure with respect to ideal lattice (in scaled coordinates). Layered structure to the ideal lattice only if it is oriented along one of the crystallographic directions, which is characterized by two numbers (n;m), corresponding to expansion of the direction vector over the two basic lattice vectors, e_1 and e_2 . Several possible directions are shown with the corresponding indices (n;m). The lower part of the gure illustrates the lattice parameters, a, b, and q for one possible orientation.

As the centers of the Josephson vortices must be located between the layers, the layered structure plays crucial role in selection of the ground-state lattice conqurations. The Josephson vortex lattice is commensurate with the layered structure only at the discrete set of magnetic elds. At small magnetic elds, $B_{\rm c} <$ $_{0}=(2 s^{2})$, the Josephson vortex lattice can be described by anisotropic London model (see, e.g., Refs. 2,3). This model has a simple scaling property: in scaled coordinates, z = z=s, y = y= s, the energy becomes isotropic in z-y plane, which means that the ground state in these coordinates corresponds to an ideal triangular lattice which is degenerate with respect to rotations in this plane. In real coordinates these rotations correspond to \elliptic rotations". As a consequence, the fam ily of com m ensurate lattices includes lattices aligned with the layers, as well as m isaligned ones. To make a full classi cation of com m ensurate lattices w e consider a general lattice shown in Fig. 1a^{2,3}. The lattice is characterized by three param eters: in-plane period a, distance between vortex rows in c direction b = N s, and relative shift between the neighboring vortex rows in c direction ga. The lattice shape is characterized by the two dimensionless parameters, q and ratio r = b=a. The lattice param eters are related to the in-plane magnetic eld, B_x , as $B_x = 0 = (ab)$. Structures aligned with the layers correspond to q = 1=2. As the replacement q ! 1q

corresponds to the m inform rejection with respect to x-z plane, every structure with q \Leftrightarrow 1=2 is double-degenerate.

We start with classi cation of the lattices exactly com – mensurate with the layered structure giving the set of commensurate elds (see also Ref. 4). The analysis of commensurability conditions can be done most conveniently in scaled coordinates (y; z). In these coordinates the ground-state conguration corresponds to regular triangular lattice with period $a_0 = 2 \ _0 = \frac{p}{3} \ _s^2 B_x$. It is convenient to consider orientation of the layered structure with respect to this lattice rather than the other way round. The layered structure to this lattice only if it runs along one of the crystallographic directions, see Fig. 1b. The direction (n;m) is defined by the lattice vector, $e_{n,m}$, which can be expanded over the two basic lattice vectors, $e_{(n,m)} = ne_1 + me_2$. For nonequivalent directions n and m must be relatively prime numbers. In particular, two aligned con gurations correspond to (n;m) = (1;0) and (1;1). Any such direction corresponds to set of matching elds, $B_{(n,m)}$ (N), which can be found by direct geometrical calculation⁴

This result essentially rely on the London approximpation, which implies a very strong inequality $n^2 + nm + m^2$ Ν 1. Number of vortex-free layers per unit cell is given by N 1. The case N = 1 represents a special situation when all the layers are led with vortices and equivalent. It is interesting to note that even for dilute lattice one can have the Josephson vortices in every layer (N = 1) in the case of high-order commensurability (n;m 1). In ideal situation the lattice switches between di erent com mensurate con guration via series of st-order phase transitions. Number of competing states rapidly increases with eld decrease. In addition to giving general ground state, these lattices describe multiple metastable states with unique hierarchical properties studied in Refs. 2,3.

Full analysis of the structure evolution requires energy consideration. The London model does not not describe layered superconductor at high elds. To obtain lattice structures in this region one has to consider more general Law rence-D oniach model. The transition between the aligned lattices have been studied within this model by Ichioka⁵. How ever, our analysis show s that at m any elds the true ground state is not given by aligned lattice. If we lim it ourself only to aligned con gurations, we reproduce results of R ef. 5 at high anisotropies.

W ithin the Law rence-D oniach model, at elds $B_x = (4 = c)$ the lattice energy can be represented as

where $_{ab}$ and $_{c}$ are the components of the London penetration depth, h 2 $\hat{S}B_{x} = _{0}$ is the reduced m agnetic eld, and the reduced energy u (N;q;h) is given by

To match the London $\lim\,i\!t^3$, we write u (N ;q;h) in the form




FIG. 2: The eld dependence of the energy function G (N;q;h) for the ground state and competing states. Each branch corresponds to the minimum of G (N;q;h) with respect to q at xed h and N. The curves are marked by value of N. Lattice con gurations in scaled coordinates are shown at six marked elds. The left inset shows the eld dependence of the shift parameter q near the structural transition of the dense lattice. The right inset illustrates competition between di erent con guration at smaller elds. The low - eld local minima are marked by the indices corresponding to commensurate con gurations in the form at (n;m);N.

where the function G (N ;q;h) de ned by this equation approaches the London lim it^3 , G_L (r = N $^2h=(2)$;q), for h ! 0 with

T his function depends only on lattice shape. Its absolute m in in up corresponding to the triangular lattice is given by G $_{\rm L}$ (3=2;1=2)=0.4022.

We explore the evolution of the ground-state con guration by direct num erical m in im ization of the energy (3) with respect to lattice parameter N and q de ned in Fig. 1, i.e., we computed reduced ground-state energy de ned as G (h) min_a [G (N;q;h)]. The eld dependence of the energy function G (N;q;h) is shown in Fig. 2 for the ground state and com peting states. Each curve corresponds to the minimum of G (N;q;h) with respect to q at xed h and N and it is marked by the value of N. Every branch crossing corresponds to a st order phase transition between di erent com m ensurate states. Below, we show the rst six lattice con gurations which are realized with eld decrease. At low elds we specify for each of these ground-state con gurations corresponding indices (n;m) and period N in the form at (n;m);N. At small elds the local minim a of branches occur at commensurate elds corresponding to (1).

Let us review the lattice evolution with decreasing

magnetic eld. At high elds an aligned dense Josephson vortex lattice is realized (structure a). This lattice becom es un*s*table at h 1:33. Below this value, shear deform ation develops corresponding to decrease of q below 1=2 (see structure b). The eld dependence of q near the transition point is shown in the left inset of Fig. 2. At h 0:99 this sheared dense lattice is replaced by the aligned lattice with the period N = 2 (structure 0.8 this structure transforms back into the c). At h m is aligned lattice with period N = 1 (structure d). At smaller elds, many lattice con gurations compete for the ground state, as one can see more clear in the right inset. As a consequence transitions become more and more frequent at smaller eld. At several elds (e.g., at ;0:19;0:137;0:105 :::) one or m ore lattice con gurah tions have energies very close to the ground-state energy. W e also note that there are several extended eld ranges where in the ground state all layers hom ogeneously led with vortices (N = 1) even in the region of dilute vortex lattice, e.g., for 0:115 < h < 0:17, 0:21 < h < 0:38. The layered structure favors such states. W e also found

that the layered structure does not favor aligned structures with indices (n;m) = (1;0). Such structures do not realize in ground state for 2 < N < 7.

In conclusions, we explored ground states of the Josephson vortex lattice in layered superconductors. With decreasing eld a dense lattice transforms into a dilute lattice via an interm ediate sheared dense lattice state. A fler that the lattice goes through sequence of states with di erent orientations and c-axis periods separated by rst-order phase transitions. At low elds many lattice con gurations com pete for ground state and phase transitions become very frequent. As the energy differences between di erent states induced by the layered structure become tiny at small elds, external factors, such as interactions with boundaries or with correlated disorder, may play role in selection of ground states in real sam ples. Frequently such external interactions favor con gurations aligned with the layered structure.
