E ective forces between colloids at interfaces induced by capillary wave{like uctuations

A bstract. { We calculate the e ective force mediated by them ally excited capillary waves between spherical or disklike colloids trapped at a uid interface. This C asim in type interaction is shown to depend sensitively on the boundary conditions in posed at the three-phase contact line. For large distances between the colloids an unexpected cancellation of attractive and repulsive contributions is observed leading to a uctuation force which decays algebraically very rapidly. For sm all separations the resulting force is rather strong and it may play an im portant role in two{dim ensional colloid aggregation if direct van der W aals forces are weak.

Introduction and synopsis. { The elective forces between rigid objects immersed in a uctuating medium have attracted a steadily growing interest because their understanding allows one to design and tune them by choosing suitable media and boundary conditions and by varying the therm odynamic state of the medium. Possible applications range from microm echanical systems to colloidal suspensions and embedded biological macrom olecules. A coordingly, these uctuations may be the zero{tem perature, long{ranged quantum uctuations of the electrom agnetic elds giving rise to the original Casim ir elect [1] between at or corrugated immersed metallic bodies [2,3]. O ther examples for uctuation induced long{ranged elective forces between immersed objects involve media such as bulk uids near their critical point [4], mem branes [5] or interfaces [6].

In this work we investigate the latter manifestation of therm all casim in forces for nanocolloids oating at surface (tension dom inated liquid-vapor or liquid-liquid interfaces where they are electively trapped. In the presence of charges their mutual interactions offen exhibit unexpected strong and long-ranged attractions [7] inducing mesoscale pattern form ation. However, these unusual patterns, which, e.g., are of interest for optical applications once they are xated on a solid substrate, appear also for neutral nanocolloids [8]. In spite of some progress [9], the nature of these elective forces between the colloids is not yet fully understood. This pertains in particular to the role of uctuations for these types of observations.

Therefore the present e ort aims at determining the uctuation induced contribution to these forces generated by the inevitable therm ally excited capillary waves of the uid interface. As a rst step the colloids are taken to be spherical or disklike and electroneutral. We shall c EDP Sciences

pay special attention to the fact that these colloids are of nite size and that, through their surface properties, they exert certain restrictions on the three{phase contact line form ed at the intersection of the uid interface with the colloid surface.

For the idealized situation of a pinned contact line (corresponding to D irichlet boundary conditions) this problem has already been studied, mostly in the context of membrane{type interfaces [10]; som e general results can be inferred also from Ref. [11]. For a pinned contact line and a Gaussian weight for the interfacial height uctuations these studies yield for the asymptotic decay of the uctuation induced force F (d) as function of the center-to-center distance d between the colloids (i) F (d ! 1) / d 1 (attractive) if the centers of the colloids are xed by some externalm eans and (ii) F (d ! 1) / d⁵ (attractive) if the colloids are free to uctuate vertically. Going beyond this analysis we nd that F (d ! 1) / d⁹ (attractive) if, corresponding to the generic situation, the uctuations of the three{phase contact line are included, governed by a boundary Ham iltonian which is derived from the surface properties of the colloids and of the interface. This highlights the importance of boundary conditions in Casim ir problem s. In our case they render the long { ranged tail of the e ective force virtually unimportant. However, if the colloids approach each other with a surface to (surface distance h! 0 we nd that the force increases / h $^{3=2}$. Thus for actual systems the uctuation induced force is e ectively short { ranged and therefore it m ay play an important role in the coagulation of interfacially trapped colloids. This behaviour cannot be captured if the colloid is approximated by an essentially pointlike object as it has been done in Ref. [6]. We shall also discuss experimental possibilities to separate the uctuation induced forces from the ubiquitous dispersion forces acting in colloidal system s.

Model. { We consider an interface between two uid phases I and II at which two nano{ or m icroscopic colloids are trapped, either spherical with radius R or disklike with radius R and thickness H. Since the weight of such colloids is negligible, the equilibrium (or reference) con guration is the at interface with the centers of the spherical colloids vertically positioned such that Y oung's law holds at the horizontal three-phase contact circle with radius $r_0 = R \sin$. Young's angle is determined by $\cos = (I_{III}) = where is the surface tension of the I/II interface, and <math>I_{IIII}$ the surface tension between the colloid and phase I [II]. For the disks, the contact line is either the upper (< =2) or low er (> =2) circular edge, so that $r_0 = R$. Deviations from the planar reference interface z = 0 are assumed to be sm all which allow s us to use the M onge representation (x;y;z = u(x;y)) = (x;z = u(x)) as a param etrization of the actual interface positions. The free energy cost for therm al uctuations with sm all gradients around the at interface is determined by the the change in interfacial energy of all interfaces (I/II, colloid/I [II]):

Here, H $_{cw}^{0}$ is the standard capillary {wave H am iltonian. In eq. (1) the capillary length is given by $_{c} = [=(j_{II} _{Ijg})]^{1-2}$, where $_{k}$ is the mass density in phase k and g is the gravitational constant. The set term in H $_{cw}^{0}$ expresses the energy needed for creating the additional interface area associated with the height uctuation, the second one the corresponding cost in gravitational energy. U sually, one has $_{c}$ R; how ever, care is required in taking the lim it $_{c}$! 1 (see below), corresponding to the lim it of a vanishing pinning force g ! 0. The integration domain S is given by the plane \mathbb{R}^{2} (z = 0) m inus the enclosed areas S₁ and S₂ of the projections of the contact lines on the second colloid, respectively, onto this plane. Thereby the H am iltonian depends explicitly on the positions of the colloids. In the reference con guration, the projections S⁰ of the contact lines are the aform entioned circles

with boundary (B_i^0) and common radius r_0 . As discussed in the Introduction, in the case of spheres the contact line itself may uctuate around its reference position with an energy cost which is determined by changes of the projected meniscus area S and of the interfaces colloid/I,II ($A_{I,II} \in 0$ in eq. (1)) with respect to the reference con guration. We introduce the vertical position of the contact line at colloid i as a function of a polar angle 'i de ned on (BS_i^0) by f_i u $((BS_i^0) = P_{i0} + \prod_{m=1} P_{im} cosm 'i + Q_{im} sinm 'i)$. The expansion coe cients P_{im} and Q_{im} are referred to as multipole moments of the contact line. Furtherm ore, h_i is introduced as the uctuation induced change in vertical position of the colloid centers with respect to the reference con guration. Following Ref. [12], we restrict the integration in H^0_{cw} to the reference dom ain \mathbb{R}^2 n S_i^0 and expand the remaining energy di erences up to second order in f_i and h_i , introducing a boundary H am iltonian H_{b_i} so that $H_{tot} = H_{cw} + \prod_i H_{b_i}$:

The elective force $F(d) = \frac{@F}{@d}$ as function of the mean local distance between the colloid centers is determined by the free energy $F(d) = k_B T(\ln Z(d))$. The partition function Z(d) is obtained by a functional integral over all possible interface con gurations u and f_i ; the boundary con gurations are included by -function constraints, as introduced in Ref. [13]:




Fig. 1 { (a) Numerically calculated therm al total C asim ir force F (symbols) for various boundary conditions compared with the analytic results in eq. (12) (lines). The inset shows the results for the two contributions to the short range regime: numerically calculated uctuation contribution (F_{uc}) and mean-eld contribution ($F_{m f}$) compared with the analytic expressions in eqs. (8) (dashed) and (13) (dotted), respectively. (b) Sketch of the various boundary conditions. For (B1)-(B3), the disks may be replaced by Janus spheres.

 Z_0 is a normalization factor such that Z(d! 1) = 1. We shall discuss two dimensions of the boundary conditions for the contact line (see Fig. 1). (A) The contact lines and the vertical colloid positions uctuate freely; this corresponds to the physical situation of sm ooth, spherical colloids. In this case, the integration measure is given by $D f_i = dh_i m dP_{im} dQ_{im}$. (B) The contact lines are pinned in the reference conguration and do not uctuate with respect to the colloid surfaces. This corresponds to disks or Janus spheres consisting of two dimensions. Within the pinning case, we furthermore distinguish the following three physical situations: (B1) The colloid positions are xed, e.g., by using optical tweezers; thus there are no integrations over the boundary terms. (B2) The vertical positions of the colloids

uctuate freely, so that D $f_i = dh_i dP_{i0}$ (P_{i0} h_i). (B 3) The vertical position and the orientation of the colloids (tilts) uctuate freely. Up to second order in the tilts this corresponds to D $f_i = dh_i dP_{i0} dP_{i1} dQ_{i1}$ (P_{i0} h_i). The -function expresses the pinning condition. All these cases can be discussed conveniently after splitting the eld u of the local interface position into a mean { eld and a uctuation part, $u = \mu_{f} + v$. The mean { eld part solves the Euler{Lagrange equation ($+ c^2$) $u_{m f} = 0$ with the boundary condition $u_{m f} j_{BS_1^0} = f_i$. Consequently the uctuation part vanishes at the contact line: $v_{ijS_1^0} = 0$. Then the partition function $Z = Z_{uc}Z_{m f}$ factorises { due to the Gaussian form of H_{cw} { into a product of a uctuation part independent of the boundary conditions and a mean eld part depending on

the boundary conditions (which may uctuate them selves, see the cases (A), (B2), and (B3)):

The rst exponential in $Z_{m\,f}$ stems from applying G auss' theorem to the capillary wave H am iltonian H_{CW} [$u_{m\,f} + v$]. In this term $@_n u_{m\,f}$ denotes the normal derivative of the mean { eld solution towards the interior of the circle $@S_i^0$, and d'i is the in nitesimal line segment on $@S_i^0$. In the following we provide only the main steps of the subsequent evaluation of both the uctuation and the mean-eld part. For more details the reader is referred to Ref. [14].

Fluctuation part. { The uctuation part appears in all cases introduced above. In the case (B1) it constitutes the full result for the partition function because in that case $u_{m\,f} = 0$ and $Z_{m\,f} = 1$. The -functions in the uctuation part of the partition function can be removed by using their integral representation via auxiliary elds $_i(x_i)$ de ned on the interface boundaries $0S_i^0$ [13]. This enables us to integrate out the eld u leading to

Here, we introduced G reen's function G (x) = K_0 ($\dot{x} \neq c$) = (2) of the operator (+ c^2) where K_0 is the modi ed Bessel function of the second kind. In this form, the uctuation part resembles 2d screened electrostatics: it is the partition function of a system of uctuating charge densities i residing on the contact circles. For large d=r₀ it can be calculated by a multipole expansion [10]. In this limit and for c=d! 1 we nd for the uctuation force:

Note, however, that here the lim it $_{\rm c}$! 1 is attained slow by with a leading correction term of the order 1=(d ln ($_{\rm c}$ =r₀)), and that in this lim it the free energy di erence F (d) F (1) is actually ill(de ned (F (d) ln ln (d=r)) and therefore the elective colloidal interaction in case (B1) { xed colloids and pinned interface { is only meaningful for a nite capillary length $_{\rm c}$ [15], sim ilar to a free two{dimensional interface the width of which is determined by the capillary wave uctuations and diverges logarithm ically $_{\rm c}$.

In the opposite limit of small surface to {surface distance $h = d 2\pi$ the uctuation force can be calculated by using the well{known result for the uctuation force per length $f_{2d}(h) = k_B T = (12h^2)$ between two lines a mean distance h apart [13], together with the Derjaguin (or proximity) approximation [16]:

This strong increase as h! 0 is a consequence of the nite (m esoscopic) size of the colloids and is m issed if the colloids are approximated as pointlike objects [6]. It also turns out (see below) that this increase is not cancelled by any mean { eld contributions. Thus it constitutes the dominant short{ranged contribution in all cases (A) and (B1){(B3). For intermediate distances d between these limits F $_{\rm uc}$ must be evaluated numerically. In eq. (6) the integral over the auxiliary elds i can be carried out because they appear only quadratically in the exponent. The resulting determinant is divergent and requires regularisation. However, the derivative of its logarithm with respect to d (corresponding to the force) is nite and convergent in a numerical analysis (see Refs. [3,14] for further details). A ctual numerical results, which recover the limiting behaviors given by eqs. (7) and (8), are presented in Fig.1.

M ean { eld part. { The calculation of Z_{mf} (Eq. (5)) requires to determ ine the solution of the di erential equation (+ $_{c}^{2}$) $u_{mf} = 0$ for the (uctuating) boundary conditions $u_{mf}(x_{i}) = f_{i}(x_{i})$ for $x_{i} 2 (C_{i}^{0})$ and $u_{mf}(x)$! 0 for jxj ! 1. We use the superposition ansatz $u_{mf} = u_{1} + u_{2}$ where $u_{i} = \int_{m} K_{m} (r_{i} = c) A_{im} \cos n'_{i} + B_{im} \sin n'_{i}$] is the general mean { eld solution in \mathbb{R}^{2} n S₁⁰. The solution has to match to the boundary conditions at both circles (C_{i}^{0}) and (C_{i}^{0}) . This can be achieved by a projection of u_{2} onto the complete set of functions on (C_{i}^{0}) , fcosm $'_{1}$; sin n'_{1} , and vice versa. Equating this expansion with the multipole moments $\hat{f}_{i} = (P_{i0}; P_{i1}; Q_{i1}; :::)$ of the values $f_{i}(x_{i})$ of the eld u(x) at the contact lines leads to a system of linear equations for the expansion coe cients A_{im} ; B_{im} g. This system can be solved analytically within a system atic 1=d expansion or num erically, observing rapid convergence (even for small d), allowing us to truncate the expansions at m_{max} 20. The mean eld part of the partition function can then be written as

where H $[u_{m f}]$ is a symmetric quadratic form of the multipole moments of the contact lines,

so that the d{dependent part of $Z_{m\,f}$ is given by det E. Before discussing the analytic structure of the dependence on d, we recall that the integration measure D f_i di ers for the cases (A), (B2), and (B3). In all cases, the large d expansion of the mean { eld part of the partition function (with $_{c}$! 1) leads to a repulsive e ective force between the colloids:

Due to $Z = Z_{uc}Z_{mf}$ the totale ective force is $F = F_{uc} + F_{mf}$. The leading term s in F_{mf} and F_{uc} (Eqs. (11) and (7)) cancel. The same holds for the rst subleading term s, and in the cases (A) and (B3) also for the second-next subleading term s. Due to these cancellations it turns out that in all four cases for large distances the e ective force is attractive with the leading term stem s from the uctuation part. This can be sum marized as follows $\frac{d}{b_{c}} = 1; \frac{d}{b_{c}} ! 0$:

In the opposite limit, h = d = 2R ! 0 the e ective mean { eld force f_f is repulsive. In case (B2) the leading behaviour for h ! 0 can be estimated analytically [14]:

We nd num erically that the inclusion of higher (beyond the zeroth order) multipole moments of the contact line, as relevant for the cases (A) and (B3), slightly changes the prefactor in Eq. (13) but does not alter the 1=h behaviour. The increase of the mean { eld force for h ! 0 is weaker than that of F $_{\rm uc}$ so that for all cases the leading behaviour of the total e ective force at sm all distances is also attractive and given by Eq. (8).

Discussion. { The restrictions which two rotational symmetric colloids trapped at a uid interface in pose on its them ally excited capillary waves, lead to a them al C asim ir force between them. At large separations d r_0 there is an interesting interplay between the attractive interaction due to the interface uctuations and a repulsive interaction generated by the mean-eld contribution to the uctuating boundary conditions. This results in a cancellation of leading terms up to a certain order in 1=d, which depends on the speci c type of boundary conditions. In the opposite lim it of small separations h = d2ŋ r₀, the e ect of the boundary conditions is much less pronounced, and the resulting force is h $^{3=2}$ (attractive) compared with F $_{\rm m\,f}$ dom inated by F uc h^{1} (repulsive), leading to a strong attractive Casim ir interaction in this regime (see Fig. 1). Note that for colloid { colloid separations h of the order of the m olecular length scale of the uids, the capillary { wave model is no longer valid. In this lim it the total e ective force stays nite and can be understood by taking into account the formation of a wetting Im around the colloids [17]. At sm all separations typically also van der W aals (vdW) forces becom e in portant, leading to a strong tendency of colloid aggregation if not compensated by a repulsive interaction. For spherical colloids at small separations and = = 2 the well{known D erjaguin result for

the vdW force is given by $F_{D\,erj}^{vdW} = A_{H} = (12) R = h^{2}$ where the (e ective) Ham aker constant A_{H} is determined by the frequency dependent dielectric permittivities of both the colloids and the two uid phases. $F_{D\,erj}^{vdW}$ shows an even stronger increase for h ! 0 and hence will dominate the C asim in force (8) since the Ham aker constant is typically A_{H} 1:::10k_BT. How ever, refractive index matching between colloids and uids can result in a signi cantly smaller value of A_{H} . For $A_{H} = k_{B}T < (3=4)^{6}h=R$ we have $f_{uc}j > f_{D\,erj}^{vdW}$ j and therefore in this distance regime an increased in uence of the uctuation induced force on particle aggregation. In the case of two cylindrical disks with height H the D erigquin approximation leads to $F_{D\,erj}^{vdW}$ (H = \hat{H}) (R = h)¹⁼² if h R; H. How ever, for very thin disks (H h R, c.f. cases (B1){(B3)}, integration over atom ic pair potentials r⁶, which give rise to the vdW force, results in

For these systems $F_{vdW} = F_{uc} = 15 (A_H = k_B T) (H = h)^2$ 1, so that for H h R the driving mechanism for occulation is entirely given by the uctuation induced force. Thus, the uctuation induced force can strongly enhance the tendency of colloids at interfaces to

occulate. This e ect is independent of material parameters, as long as the system is in the capillary wave regime, i.e., for h . In order to discriminate the uctuation induced force from the vdW force we propose three experimental scenarios. The rst one is to weaken the vdW force by lowering the Hamaker constant via index matching which increases the importance of the uctuation force. Second, for this disks, the uctuation induced force dominates, independent of the dielectric properties of the materials. A third mechanism consists of reducing the vdW force by a light polymer coating of the colloids so that in eq. (8) $h = h_{\rm sts}$ is given by the surface (to (surface distance between the polymer shells, whereas the distance $h = h_{\rm core} > h_{\rm sts}$ between the cores of the two colloids enters into $F_{\rm Derj}^{\rm vdW}$. Thus for a su ciently thick polymer shell the uctuation induced force will be the dominant interaction at sm all distances.
