N odal Structure of Superconductors with T im e-R eversal Invariance and Z₂ Topological N um ber

A topological argument is presented for nodal structures of superconducting states with timereversal invariance. A generic H am iltonian which describes a quasiparticle in superconducting states with time-reversal invariance is derived, and it is shown that only line nodes are topologically stable in single-band descriptions of superconductivity. U sing the time-reversal symmetry, we introduce a real structure and de ne topological numbers of line nodes. Stability of line nodes is ensured by conservation of the topological numbers. Line nodes in high- T_c materials, the polar state in p-wave paring and mixed singlet-triplet superconducting states are examined in detail.

I. IN TRODUCTION

Nontrivial nodal structures are one of the most noticeable features of unconventional superconducting gap functions. Conventionally, the nodal structures have been investigated by power law behaviours of the tem perature dependences of the specic heat, the NMR relaxation rates and so on [1, 2]. Although the power law behaviours give a hint of the nodal structures, they can not give the details such as the number and the position of nodes. Recently, it has been increasingly clear that the angular-controlled m easurem ents of thermal conductivity and specic heat in a vortex state are useful probes to determ ine the details of the nodal structures [3, 4, 5]. Various unexpected nodal structures of superconductors have been found in this method [6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20]. This makes urgent the need for a better theoretical understanding of nodal structures of superconductors.

The purpose of this paper is to reveal theoretically a generic nodal structure of superconducting states with tim e-reversalinvariance. We use two di erent methods to investigate the nodal structures. The rst one is based on a universal H am iltonian we will construct, and the other is an argument using topological numbers in momentum space. Unless stated explicitly, our results do not rely on any speci c symmetry of superconducting states except the tim e-reversal symmetry.

Topological arguments in momentum space are powerful tools to investigate a nonperturbative aspect of quantum theories [21, 22, 23, 24]. For superconducting states with broken tim e-reversal invariance, a topological characterization of the nodal structures was given in Refs.[25, 26, 27]. On the other hand, we will present here a topological characterization of nodal structures of superconducting states with tim e-reversal invariance. W e will introduce novel topological num bers and discuss stability of the nodal structures.

The organization of this paper is as follows. In Sec.II, we derive a generic H am iltonian describing a quasiparticle in superconducting states with time-reversal invariance. The quasiparticle spectra are given and their nodal structures are discussed. In Sec.III, we exam ine stability of line nodes for high-T_c m aterials, the polar state in p-wave paring, and m ixed singlet-triplet states, respectively. In Sec.IV, a real structure is introduced and novel Z₂ topological num bers of line nodes are de ned. We calculate the Z₂ topological num bers for high-T_c m aterials, the polar state in p-w ave paring, and m ixed singlet-triplet states. It is shown that the existence of the topological num bers ensures stability of the line nodes. C onclusions and discussions are given in Sec.V.

II. HAM ILTON IAN W ITH TIM E-REVERSAL SYM METRY AND NODAL STRUCTURE

W e derive here a generic H am iltonian which describes a quasiparticle in superconducting states with timereversal invariance. Let us consider a single-band description of superconducting state and start with the following B ogoliubov-de G ennes type H am iltonian,

where c(k) is a four component notation of electron creation and annihilation operators in momentum space,

W e also dem and that the Ham iltonian is time-reversal invariant. The time-reversal operation T is de ned as

W e solve Eqs.(2.4) and (2.6) to obtain a generic H am iltonian of a quasiparticle in superconducting states with tim e-reversal invariance.

To solve Eq.(2.6), we rewrite the 16 components of H (k) in terms of the identity matrix, 5 D irac matrices a = [a; b] = (2i) [28],

In addition to Eq.(2.6), we impose Eq.(2.4) on Eq.(2.7). Using = 1 and the commutation relation of a's, we nd that the following 8 functions should be identically zero,

Therefore, the H am iltonian contains 16-8=8 independent functions. It is convenient to introduce a new notation of the remaining functions,

All of them are real functions. Here (k) and (k) are even functions of k, and g (k) and d (k) are odd functions of k. In term s of them, H (k) is written as

Now physical meanings of these functions are evident. The function (k) is a band energy of electrons measured relative to the chemical potential , and (k) is a gap function of a superconducting state. ((k) and d(k) represent the spin-singlet and spin-triplet gaps, respectively). The function g(k) is a parity breaking term in the norm al state. For example, the Rashba term is represented by this.

The quasiparticle spectra E(k) in the superconducting state are given by the eigenvalues of H(k). The eigenvalues can be obtained straightforwardly, and the resultant spectra E(k) are

Zeros of E (k) determ ine the nodal structure of the superconducting state. First, it can be shown that E_+ (k) has no zero in general; For E_+ (k) to be zero, we have (at least)

which can not be m et generally in three dimensionalm om entum space. Even if E_+ (k) has an accidental zero at som e k, we can easily rem ove this by a sm all deform ation of the H am iltonian. Therefore, the zero of E_+ (k) is topologically unstable.

Let us now consider the condition E(k) = 0. The Herm it is property of H(k) ensures that the eigenvalue E(k) is real. Therefore, we have the inequality,

E (k) is zero when the equality in (2.19) is attained. We rewritten this as

W ith xed ², ², g^2 and d^2 , we can maxim ize the right hand side of (2.20) at g d =. Then if we assume g d =, the equality in (2.20) is attained if we have $^{2} + d^{2} = ^{2} + g^{2}$. Therefore, E (k) becomes zero when

We can show that these two equations are the necessary and su cient condition for E (k) = 0; If the equality in (2.20) is attained under a condition di erent from Eqs.(2.21) and (2.22), the right hand side of Eq.(2.20) exceeds the left hand side by in posing Eq.(2.21). This contradicts the inequality (2.20). Therefore, only Eqs.(2.21) and (2.22) lead to E (k) = 0.

The two equations (2.21) and (2.22) define two surfaces in three dimensionalmomentum space. They intersect in a line in general, and the intersection line gives zeros of E (k). Small deformations of the Ham iltonian change the surfaces slightly, but the intersection line does not vanish. Thism eans that for superconductors described by H (k), we have a line node in general and the line node is topologically stable. On the other hand, a point node is accidental and it can be rem oved by a small deformation of the Ham iltonian.

It is interesting to compare this result with that of group theoretical analyses. Superconducting states are known to be classi ed by using a group theoretical technique and the generalized G inzburg-Landau theory [2, 29, 30, 31, 32, 33]. The classi cation shows that point nodes exist in a superconducting state with tim e-reversal invariance. For example, Table VI in Ref.[2] shows that the gap function in the $_2$ representation of the tetragonal group D $_{\rm 4h}$ has the form

This gap function preserves the time-reversal symmetry, and it has two point nodes on k_z axis. This result does not contradict ours. Since the existence of the point nodes are due to a symmetry property of the $_2$ representation, we can remove these nodes by a small perturbation which are not the $_2$ representation. Indeed, they are removed by the deformation

where $2k_z$ is the $_1$ representation of D_{4h}. Generally, the group theoretical method does not ensure the stability of the nodal structure against any perturbations which change the representation of the group. On the other hand, our results are robust against any time-reversal invariant perturbations.

III. EXAMPLES

U sing Eqs. (2.21) and (2.22), we can exam ine stability of line nodes. Here we consider three exam ples, 1) high- T_c m aterials, 2) the polar state in p-wave pairing, and 3) m ixed singlet-triplet superconducting states.

A . high- $T_{\rm c}$ m aterials

In high-T $_{\rm c}$ m aterials, the parity is conserved, thus we have

The band energy (k) mainly depends on k_x and k_y , and the Ferm i surface given by (k) = 0 is two dimensional. The gap function is




FIG.1: Line nodes in high-T $_{\rm c}$ superconductors.

In this state, E_+ (k) = E (k), and we have four line nodes on the Ferm isurface at $k_0 = (k_F; k_F) = \frac{p}{2}$. (See Fig.1.) We will show that the line nodes are stable. We

perturb the param eters of the H am iltonian as

First, consider the case of g = d = 0. In this case, the perturbation does not break the parity sym m etry. Now Eqs.(2.21) and (2.22) reduce to

These equations can be satisfied by a small change of the position of the line nodes $k = k_0 ! k = k_0 + k_0$. Indeed, expanding Eq.(3.4) around $k = k_0$, we have

(Here we have used $(k_0) = (k_0) = 0$.) For any and , there exists k_0 which satis es these equations. Therefore, the perturbation m oves the position of the line nodes, but it does not rem ove the line nodes.

W hen g and d are not zero, Eqs.(2.21) and (2.22) become




FIG.2: (a) Two curves given by Eqs.(3.6) (the solid lines) and (3.7) (the dotted lines). Here we show the case of $g^2 d^2 > 0$ and g d > 0. (b) A schematic gure of the line nodes in high-T_c superconductors with a parity breaking perturbation.

These two equations give two curves in the (+; +) plane. As is shown in Fig.2 (a), these two curves always

have two intersection points near the origin. Therefore, we have two di erent conditions of line nodes corresponding to the two intersection points. This im plies that each line node splits into two after the perturbation as illustrated in Fig2(b). A lthough the number of line nodes becomes eight, the line nodes do not vanish by the perturbation.

These line nodes vanish if the time-reversal symmetry is broken. For example, by deforming (k) as

we can completely remove the line nodes.

B. polar state in p-w ave paring

Here we consider the polar state in p-wave paring. The polar state is given by




FIG.3: A line node of the polar state in p-wave paring.

It is a solution of the G inzburg-Landau theory neglecting the spin-orbit coupling [1]. O by iously, the gap has a line node on the equator. See Fig.3.

The line node is unstable, because, for example, the following deformation of the gap function removes the line node completely,

where is a small real number. This line node is not given by an intersection line of Eqs.(2.21) and (2.22), thus it is accidental and topologically unstable.

C. m ixed singlet-triplet states

For noncentrosym m etric m aterials, the parity sym m etry is broken in the norm al states. In the presence of the spin-orbit interaction, the absence of inversion sym m etry give rise to parity breaking term s g (k) in the norm al states. In such system s, singlet and triplet parings can be m ixed in the superconducting states [34]. We exam ine stability of line nodes in the m ixed singlet-triplet superconducting states.

As a concrete example, consider a s+ p superconducting state proposed to explain the superconducting state in CePt₃Si. In this m aterial, the existence of line nodes was reported experimentally [12]. In CePt₃Si, the absence of inversion symmetry give rise to the Rashba interaction,




FIG.4: A schematic gure of line nodes on the Ferm isurface of $C \exp t_3 Si$ [35]. The sphere and the solid lines denote the Ferm isurface and the line nodes, respectively.

Here $_0$ and $_0$ are real numbers. As is shown in Ref.[35], one can show that under a suitable choice of , $_0$ and $_0$, E (k) has two line nodes. (E₊ (k) has no node.) We show a schematic picture of the nodes in Fig.4. As in the high-T_c case, it can be shown that the line nodes are stable against any small time-reversal invariant perturbations; The line nodes are intersection lines of the surfaces given by Eqs.(2.21) and (2.22) in momentum space. Under a small perturbation,

these surfaces moves slightly, but the intersection lines do not vanish unless the lines shrink to points.

In a similar manner, we can show generally that line nodes are topologically stable in mixed singlettriplet superconducting states with time-reversal invariance. For example, the line nodes proposed for $L_{2}Pd_{3}B$ and $L_{2}Pt_{3}B$ [36] are topologically stable.

IV. Z₂ TOPOLOGICALNUMBER

In the previous sections, we have seen that line nodes can be stable in superconducting states with timereversal invariance. In this section, we show that the stability is explained by the existence of topological numbers de ned by wavefunctions of quasiparticles. The topological numbers are closely related to a real structure of the H am iltonian H (k). A lthough H (k) is not a real m atrix in general, it has another real structure due to the timereversal symmetry.

A. Real structure and Z₂ topological num ber

1. Real structure

In order to nd a real structure, it is convenient to consider the following 8 8 H am iltonian,

The relation (4.3) implies a real structure of H (k). To see this, we introduce an operator K = K where K is the ordinary complex-conjugation operator. The new operator obeys $K^2 = 1$, then we can think of it as a new complex-conjugation operator. The extended H am iltonian H (k) is \real" in term softhe new complexconjugate operation,

2. Z_2 topological num ber




FIG .5: S^1 around a line node. S^1 is covered by U_+ and U_- . The overlap of U_+ and U_- consists of the regions I and II.

To de ne topological numbers of a line node, let us consider rst an in nitesimal circle S¹ around the line node and solve the eigenequation H (k)u(k) = E(k)u(k) on S¹. (See Fig.5.) Because of the gauge freedom

u(k) is not determ ined uniquely. We have to x the gauge. Generally, a gauge xed solution has a singularity on S¹, thus it can not be well-de ned on the entire S¹. Two or more solutions with di erent gauge xings are needed to cover the entire S¹. We consider a couple of solutions u⁽¹⁾(k) and u⁽²⁾(k), and dem and that the rst component of u⁽¹⁾(k) and the second one of u⁽²⁾(k) are real. Because of these di erent dem ands, the solutions u⁽¹⁾(k) and u⁽²⁾(k) have di erent singularities from each other. Therefore, we can cover the entire S¹ by using them.

Let us next consider the K ram ers doublet of $u^{(2)}(k)$, $u^{(2)}(k)$. By de nition, the K ram ers doublet has the real rst component as well as $u^{(1)}(k)$. Therefore the following two possibility arises,

Here we concentrate on the latter case, since only this is relevant to the topological numbers of the line node [47]. In this case, u⁽²⁾ (k) has a di erent singularity from u⁽¹⁾ (k), thus we can use u⁽²⁾ (k) instead of u⁽²⁾ (k) to cover the entire region of S¹. A fler all, the following two solutions with the real rst component are obtained,

Now it is convenient to introduce the eigenfunctions of H (k) instead of $u^{()}(k)$ (=). The eigenfunctions of H (k) with the reality condition (4.6) are constructed from $u^{()}(k)$ as

It is easily nd that the eigenfunctions $A^{()}(k)$'s (A = R;I) are regular in U .

On the overlap $U_+\setminus U_-$, both ${}^{(+)}_A$ (k) and ${}^{(-)}_B$ (k) are regular and they are related by the transition function $T_{A,B}$ (k),

The reality condition (4.6) and the norm alization (4.12) in ply that the transition function T (k) (T_{AB} (k)) is an element of O (2). Moreover, T (k) reduces to

since $\binom{(\)}{R}(k)$'s have the real rst components but $\binom{(\)}{I}(k)$'s have the imaginary ones. Therefore, $\binom{(+)}{R}(k)$ (or $\binom{(+)}{I}(k)$) is identified with $\binom{(\)}{R}(k)$ ($\binom{(\)}{I}(k)$) on $U_+ \setminus U$. As we will show immediately, the transition function determ ines the global topology of the wavefunctions.

For the sake of sim plicity, we assume in the following that both U₊ and U are connected regions as illustrated in Fig.5. In this case, the overlap U₊ \setminus U consists of two regions I and II. The generalization to other cases in which U₊ and U consist of m any disconnected segments is straightforward.




FIG. 6: Possible con gurations around a line node. (a) A contractable loop. (b) A noncontractable loop.

Let us exam ine the topology of $^{()}_{R}$ (k). On S¹, it has two transition functions $t_R (k_I)$ and $t_R (k_{II})$ where k_{I} and k_{II} are arbitrary points on the regions I and Π_{r} respectively. If $t_R (k_I) = t_R (k_{II})$, R (k) are glued to $_{\rm D}^{()}$ (k) without twisting, thus we have a trivial topology similar to a cylinder. (See Fig 6.) This con guration is a contractable loop in the Hilbert space, therefore nothing interesting happens. On the other hand, if $t_R (k_{II})$, $R_R^{(+)}(k)$ and $R_R^{(-)}(k)$ are glued tot_R (k_T) = gether with twisting, thus we have a nontrivial topology sim ilar to the M obius strip [37]. Since this con guration is a noncontractable loop around the line node, the line node can be considered as a kind of topological defect (vortex). Therefore, in this case the line node is stable against a continuous deform ation of the H am iltonian. If we twist the wavefunction in twice, we have a trivial con guration again. Thus, the corresponding hom otopy group is $_1 = Z_2$.

By this argument, we naturally introduce the following Z $_2$ topological number I_{R} ,

The line node is topologically stable when $\rm I_R=1$ (m od 2), and the stability is explained by the conservation of the topological number.

In a sim ilar m anner, another Z $_{\rm 2}$ topological num ber can be de ned as,

U nless the tim e-reversal sym m etry is broken, the two topological numbers I_R and I_I are conserved independently. However, once the tim e-reversal invariance is lost, they are not conserved. The reality of the Ham iltonian (4.6) is lost and $_R$ (k) cannot be distinguished from $_I$ (k). Although the sum mation of I_R and I_I may be conserved, it is identically zero

Therefore, the line node loses the topological stability and it disappears in general.

It can be shown that the topological numbers are gauge invariant if the gauge transform ation is nonsingular. Consider the following gauge transform ation




FIG.7: S^1 around a line node in high-T_c superconductors

As long as the parity is conserved, the eigenfunctions of H (k) stay the eigenfunctions of . Therefore, I_{1A} and I_{2A} (A = R;I) are not mixed, and the stability of the line node is ensured by conservation of these topological numbers.

If the parity is broken, the degeneracy between E_+ (k) and E_- (k) is resolved and only E_- (k) has line nodes. W hen the perturbation is small enough, the topological numbers I_R and I_I de ned by the eigenfunction with E_- (k) are calculated on the same S^1 as

This is consistent with the splitting of the line nodes shown in Sec.IIIA; The line node in Fig.7 is divided into two as is shown in Sec.IIIA, and each divided line node has the topological num bers $I_R = I_I = 1$. Because S¹ encloses both the divided line nodes, the topological num bers calculated on S¹ become $I_R = I_I = 1 + 1 = 0$ which is the same as Eq.(4.36).

C. polar state in p-w ave paring

The Ham iltonian of the polar state in p-w ave paring is

At a rst glass, it seems to suggest that the line node has nontrivial topological numbers. However, on the contrary to the high- T_c case, there is no quantum number which distinguishes $u_1^{(\)}(k)$ from $u_2^{(\)}(k)$ (=). Therefore, only the summations $I_{1A} + I_{2A} = 0$ (A = R;I) are preserved, and the line node has no nontrivial topological numbers. This result is consistent with the result in Sec.IIIB; The line node is unstable against a sm all perturbation of H (k).

D. m ixed singlet-triplet state

The Ham iltonian of mixed singlet-triplet states is

From these transition functions, we can calculate the topological numbers I_R and I_I of line nodes in mixed singlet-triplet superconducting states. For example, the straightforward calculation shows that both the line nodes of CeSi_3Pt in Fig.4 have nontrivial topological numbers, $I_R = I_I = 1.$ We can also show that the line nodes proposed for Li_2Pd_3B and Li_2Pt_3B [36] have non-trivial topological numbers. These results are consistent with the stability of the line nodes exam ined in Sec.IIIC.

N ote that the time-reversal symmetry is essential for the stability of the line nodes. For example, when (k) becom es com plex, the tim e-reversal sym m etry is broken. In this case, the quasiparticle spectra are given by

If Im (k) is a nonzero constant, the line nodes in the mixed singlet-triplet states vanish completely.

V. CONCLUSIONS AND DISCUSSIONS

(1) First we would like to outline the results of this paper. We exam ined topological stability of line nodes in superconducting states with time-reversal invariance. A generic H am iltonian of time-reversal invariant superconducting states was presented. We found that only line nodes are topologically stable in single-band descriptions of superconductivity. It was shown that line nodes in high-T_c m aterials and m ixed singlet-triplet superconducting states are topologically stable, while one in the polar state is not. U sing the time-reversal symmetry, we introduced a real structure and de ned Z₂ topological numbers. Stability of line nodes was explained by conservation of the topological numbers.

(2) Besides the superconducting states examined in this paper, æveral superconductors such as C eC oIn₅ [42], C eIrIn₅ [43] and Sr₂RuO₄ [7, 15, 16, 44] are believed to host line nodes. Among them, the gap function of C eC oIn₅ is a d-wave paring, thus its line nodes are topologically stable in a similar manner as high-T_c materials. On the other hand, the line nodes of Sr₂RuO₄ are not topologically stable since its superconducting state breaks the tim e-reversal symmetry [45].

(3) An analysis based on the KR theory [39] shows that point nodes have a Z $_2$ topological number in a nonrelativistic Ferm i system with the time-reversal symmetry. However, our analysis in Sec.II indicates that point nodes have only the trivial topological number if the superconducting state is described by single-band electrons.

(4) If the superconductivity occurs in multi-bands of electrons, a topologically stable point node is possible to exist. In other words, if the time-reversal symmetry is not broken, the existence of a topological stable point node im plies a multi-band superconductivity.

(5) For mixed singlet-triplet superconducting states, the existence of the line nodes is not explained by the group theoreticalm ethod in R efs. [29, 30, 31, 32, 33]. The topological stability studied here is essential for the existence of these line nodes.

(6) In addition to the time-reversal symmetry, if the party is conserved, the H am iltonian becomes

This is a real symmetric matrix, thus we have a natural real structure. Using this real structure, we can intro-

duce a Z₂ topological number which is di erent from that given in Sec.IV as follows [40]. Let us consider the eigenfunction of H (k)u(k) = E(k)u(k),

Here we can dem and a(k), b(k), c(k) and b(k) to be real since H (k) is a real matrix. If we impose the normalization condition on u(k), we have $a(k)^2 + b(k)^2 + c(k)^2 + d(k)^2 = 1$, and by using the gauge freedom of the eigenequation, u(k) can be identified with u(k). Therefore, u(k) is given by an element of S³=Z₂ [48].

Now consider a map determ ined by u (k) from an innitesim al S¹ around a line node into S³=Z₂. The map is classi ed by $_1$ (S³=Z₂). Using the hom otopy theory [41], we obtain

Therefore, we have a Z₂ topological number corresponding to $_1$ (S³=Z₂). The line node is topologically stable if the map corresponds to the nontrivial element of Z₂. A straightforward calculation shows that the map around a line node in high-T_c materials gives the nontrivial element. This is another explanation of topological stability of the line nodes in high-T_c materials.

A lthough the construction of this topological number

is easier than that given in Sec.IV , it is available only when the parity is conserved.

(7) We have noticed that when a line node splits in two as was shown in Sec.IIIA, there remains a degenerate point between E_+ (k) and E_+ (k) near the line node. The degenerate point is topologically stable since it is given by an intersection point of the three equations (k)g(k) +

(k)d(k) = 0 in three dimensional momentum space. The degenerate point has a topological number similar to that of the chiral ferm ion in Ref.[21]. In order to describe the splitting of the line node in terms of the topological numbers given in this paper, we need to take into account the conservation law of this also.

Note added. A fler completing this work, the author noticed a preprint [46] by G.E.Volovik in which the topological stability of line nodes in high- T_c superconductors was discussed very recently. There is some overlap between his paper and Sec.IV B in this paper. H is argument was restricted to the case where the H am iltonian is real, while the argument described here is not restricted.
