Exact Landau Levels in Two-D im ensional Electron Systems with Rashba and Dresselhaus Spin-Orbit Interactions in a Perpendicular Magnetic Field

We study a two-dimensional electron system in the presence of both Rashba and D resselhaus spin-orbit interactions in a perpendicular magnetic eld. De ning two suitable boson operators and using the unitary transformations we are able to obtain the exact Landau levels in the range of all the parameters. When the strengths of the Rashba and D resselhaus spin-orbit interactions are equal, a new analytical solution for the vanishing Zeem an energy is found, where the orbital and spin wave functions of electron are separated. It is also shown that in this case the Zeem an and spin-orbit splittings are independent of the Landau level index n. Due to the Zeem an energy, new crossing between the eigenstates  $j_1;k_1;s=1;$  and  $j_1+1;k_1;s^0=1;$  is produced at certain magnetic eld for larger Rashba spin-orbit coupling. This degeneracy leads to a resonant spin Hall conductance if it happens at the Ferm i level.

Recently spintronics, operating the spin of charge carriers in sem iconductors, has attracted much attention in both theory and experiment due to its potential application for information technology [1-7]. One crucial step in spintronics is to produce and e ciently control the spin current. The Rashba spin-orbit interaction [8], which can be adjusted up to 50% by the application of gate voltages, is used to arrive this goal [9]. The Rashba coupling stems from the lack of structure inversion symmetry, and can be strong in semiconductors (InGaAs, Al-GaAs) [10,11]. Besides the Rashba coupling there also exists a D resselhaus spin-orbit interaction in semiconductors like InSb/InAlSb [12], which originates from the lack of bulk inversion symmetry.

The coexistence of the Rashba and D resselhaus spin-orbit interactions gives rise to some novel spin-dependent phenomena in semiconductors. Recently the spin Hall e ect in two-dimensional electron system in the absence of a magnetic eld has been studied [13,14]. When the Rashba and D resselhaus spin-orbit interactions have the same strength, the spin state of the wave functions is independent of the wave vector. The phenomenon was proposed to design a nonballistic Spin-Field-E ect Transistor [15]. The experimental observations of a spin-galvanic e ect and spin-orbit coupling weak localization e ects have been used to understand the interplay between different spin-orbit types and to obtain the ratio of the Rashba and D resselhaus spin-orbit coe cients [16,17].

In the presence of a perpendicular magnetic eld, the Rashba and D resselhaus spin-orbit interactions couple all states in each Landau level, and an analytical solution to the full problem has been attempted, but without success [18-23]. As a result, the spin Hall conductance in this system does not get understood. In Refs. [20,21], Shen et al. investigated transport properties of the electron system with a pure Rashba or D resselhaus coupling. A resonant spin Hall conductance is found for the Rashba type due

to the level crossing induced by the Zeem an energy at the Ferm i level. It is very interesting to know whether the resonant spin Hall conductance still exists in the presence of both spin-orbit couplings. When the strengths of both spin-orbit interactions are equal, an exact solution is obtained in the absence of the Zeem an energy [22-25]. However, we shall see below that the energy spectrum is incomplete. The approximate energy spectrum is obtained in Refs. [21-23] by using the perturbation theory. In the present work, we solve analytically this open problem and construct the eigenvalues and eigenstates for such a system so that the spin Halle ect could be investigated in the fiture.

The Ham iltonian for a single electron with spin $\frac{1}{2}$  in a plane under a perpendicular magnetic eld is given by

where =  $p + \frac{e}{c}A$ ,  $_i$  (i = x;y;z) are the Paulim atrices for electron spin,  $g_s$  is the Lande g-factor,  $_B$  is the Bohr m agneton. Here we choose the Landau guage A = yB. The spin-orbit interaction has the form

where and represent the Rashba and the D resselhaus spin-orbit couplings, respectively. Note that  $p_x = k$  is a good quantum number due to  $[p_x; H] = 0$ .

In order to diagonalize the H am iltonian (1), we introduce the bosonic annihilation operator  $b_k = \frac{1}{p^2} \int_{\mathbb{R}^2} f_y + \frac{c}{eB} (k+ip_y) + \frac{p}{ja_R a_D} j_1$  ] and the corresponding creation operator  $b_k^y = (b_k)^y$ , with the cyclotron radius  $l_c = \frac{c}{eB}$ ,  $a_R = \frac{m l_c}{eB}$ ,  $a_D = \frac{m l$ 

orbital space of electron is divided into two in nitely dimensional subspaces described by the occupied number representations associated with  $b_k$  and  $b_k^y$  due to this constant term (also see Ref. [23]). When  $a_D=a_R$  and g=0, the total Hamiltonian (1) can be diagonalized in by a unitary transformation [22,23]. It is surprising that in the special case the eigenstates obtained in

Ref. [22-25] are nothing but the basis vectors of two subspaces. This means that the Landau levels decouple. However, in these works, another solution where all the Landau levels couple each other is om itted. In terms of the bosonic operators  $b_k$  and  $b_k^y$ , the Ham iltonian (1) can be rewritten as  $H = H_{-1} - H_{1}$ , and

where the cyclotron frequency  $! = \frac{eB}{mc}$ ,  $= \frac{1}{2} (x i_y)$ ,  $= 2ja_D a_R j + \frac{1}{2}$ , and  $g = \frac{g_s m}{2m_e}$  with  $m_e$  the free electron mass.

We can see from Eq. (3) that a state jn;"> in the basis of is coupled to jn + 1;#> due to the D resselhaus coupling, which is further coupled to jn + 2;"> due to the R ashba coupling. Therefore a Landau level is coupled to an in nite number of other Landau levels. This means that in general the eigenstates for the H am iltonian (3) in are convergent in nite series in terms of the parameters  $a_0$ ,  $a_R$  and  $a_R$  and  $a_R$  are tedious but straightforward calculation, we not that the two-component eigenstate for the nth Landau level with quantum numbers s and has the form

where the spin index s = 1,  $_{ns}$  is a parameter to be determined below by requiring  $_{ms}^{n}$  and  $_{ms}^{n}$  to be nonzero,  $_{mk}$  is the eigenstate of the mth Landau level in  $_{ns}$ , i.e.  $b_{k-mk}^{y} = \frac{p}{m+1} \frac{1}{m+1k}$ ,  $b_{k-mk} = \frac{p}{m} \frac{1}{m} \frac{1}{m}$  and  $a_{m-k}^{y} = \frac{p}{m} \frac{1}{m} \frac{1}{m} \frac{1}{m} \frac{1}{m}$  and  $a_{m-k}^{y} = \frac{p}{m} \frac{1}{m} \frac{1}{$

We note that  $E_{ns=-1}$  for g=0 is nothing but the exact eigenvalue obtained previously [22-25]. Therefore, the exact energy spectrum is incomplete due to the lack of the eigenvalue for s=1 in Eq. (5). Obviously, the energy splitting induced by the Zeem an energy and spin-orbit coupling is independent of the Landau level index n, i.e.  $E=E_{ns=1}$   $E_{ns=-1}=-1$   $E_{ns=-1}$ 

Because the eigenvalues are independent of the parameter  $n_s$ , for simplicity, we choose  $n_s = 0$ . For the corresponding eigenstate, we have the recursion relation

Equations (5) and (6) are derived by demanding the coexcient determinant of  $\frac{n}{m}s$  and  $\frac{n}{m}s$  to be zero. The same approach is employed in deriving Eqs. (7)-(11) below. When g=0, from Eq. (6), we have the solution  $\frac{n}{n}s=\frac{n}{n}s$  and  $\frac{n}{m}s=\frac{n}{m}s=0$  (m for the nth Landau level with spin index s=1 in , which recovers the exact eigenstate [23]. We would like to stress that new solution obtained here describes the electron with spin index s=1 in . Note that when g=0, there is no spin polarization in each Landau level, i.e. < n;k;s;  $\frac{1}{2}z$  j;k;s; >=0. So it is not expected that there exists an out of plane spin current. In this case, the orbital and spin wave functions of electron are separated, and the spin part  $\frac{p}{2}$  (1 sT )<sup>T</sup> is independent of the wave vector k, which is similar to that observed in the absence of a magnetic eld [15].

where s = 1 for n = 0 and the parameter  $n_s$  is determined by the following equation

If  $j_{a_D}$  j=0 or  $j_{a_R}$  j=0, Eq. (8) is automatically satisfied and the eigenvalue (7) becomes that in the presence of a pure Rashba or D resselhaus spin-orbit interaction [8, 12]. When  $g=2j_{a_R}^2$   $a_D^2$  j we have the analytical expression for the eigenvalue

Here, we have used  $n_S = sgn(a_R^2 - a_D^2)$ . Note that when  $a_D(a_R)! a_R(a_D)$ , the energy spectrum described by Eq. (9) is identical to that in Eq. (5) with  $a_D = a_R$  and g = 0.

The eigenstate for the nth Landau level with s and is determined by the recursion relation

We note that when  $a_D = 0$  or  $a_R = 0$ , the corresponding eigenstates presented in Refs. [8,12,20-25] can be easily obtained from Eq. (10).

Fig. 1 shows several low-lying Landau levels as functions of  $j_{a_R}$  jfor j j= 0.2j j.0.6j j and 1.2j jand g = 0 and 0.1. When  $j_{a_R}$  j is small, the energy levels  $E_{ns=1}$  and  $E_{n+1s=-1}$  are approximately degenerate for g = 0 [see Fig. 1(a), (c) and (e)]. If g = 0, the approximate degeneracy is lefted in Fig. 1(b), (d), and (f). However, the Landau levels shift in an opposite way for  $j_{a_R}$  j>  $j_{a_D}$  j and  $j_{a_R}$  j<  $j_{a_D}$  j. Fig. 1(b) and (d) while there is no new mixing for  $j_{a_R}$  j<  $j_{a_D}$  jin Fig. 1(f). This new degeneracy induced by the Zeem an energy leads a resonant spin H all conductance if it happens at the Ferm i level, sim ilar to the case in the presence of the pure R ashba spin-orbit

interaction [20,21]. It is expected that the resonant spin H all conductance can be applied in device design. The degenerate point at the Ferm i level is easily controlled by the gate voltage, which changes the R ashba coupling strength. We note that with increasing the D resselhaus coupling, the resonance is moved to the lower magnetic elds.

In sum m ary, we have analytically derived the complete energy spectrum in 2D electron systems in the presence of both Rashba and Dresselhaus spin-orbit interactions under a perpendicular magnetic eld. The eigenvalue for the nth Landau level with s and is determ ined by the parameter ns, which satis es the highly nonlinear equation (8) for  $ja_D$   $j \in ja_R$  j. For  $ja_D$   $j = ja_R$  j we obtain a new analytical solution when the Zeem an energy vanishes. Each Landau level possesses two-fold degeneracy because it is independent of the orbital index . We also note that the eigenvalues depend only on the absolute values of the Rashba and Dresselhaus spin-orbit coe cients rather than their signs. The corresponding eigenstates are convergent in nite series except those at  $j_R$   $j=j_{a_D}$  jg = 0 and s = 1.0 noe the energy spectrum is known, we can use it to calculate physical properties of the system, such as charge and spin Hall conductance. The work in that direction is in progress.




FIG. 1: (Color online) Landau levels in unit of  $\sim$ ! as a function of the dimensionless parameter  $ja_R$  j. The parameters  $ja_D$  jand q are shown in the panels. Solid, s = 1; dot, s = 1.
