Full quantum distribution of contrast in interference experiments between interacting one dimensional Bose liquids

We analyze interference experiments for a pair of independent one dimensional condensates of interacting bosonic atom s at zero temperature. We show that the distribution function of fringe amplitudes contains non-trivial information about non-local correlations within individual condensates and can be calculated explicitly using methods of conformal eld theory. We point out interesting relations between these distribution functions, the partition function for a quantum impurity in a one-dimensional Luttinger liquid, and transferm atrices of conformal eld theories. We demonstrate the connection between interference experiments in cold atom s and a variety of statistical models ranging from stochastic growth models to two dimensional quantum gravity. Such connection can be used to design a quantum simulator of unusual two-dimensional models described by nonunitary conformal eld theories with negative central charges.

I. IN TRODUCTION

The hallmark of a Bose-Einstein condensate (BEC) is the existence of a well de ned m acroscopic phase. Indeed experiments with large condensates display robust matter wave interference with negligible uctuations in the fringe contrast¹. From this point of view, large three dim ensional condensates m ay be thought of as classical ob jects. How ever, there is a continuous range of possibilities interm ediate between perfect condensates on one side and system s that do not display an interference pattern, like high tem perature therm algases, on the other². For exam ple, one-dim ensional interacting bosons display interference patterns with a reduced contrast and with non negligible shot to shot uctuations of the fringe contrast³. In this paper we analyze the full distribution associated with this quantum noise, and discuss what it can tell us about the underlying strongly correlated state.

By virtue of its direct connection to the concepts of quantum measurement, study of quantum noise has deepened our understanding in a variety of areas. Understanding the noise in photo detection⁴ prom pted the creation of nonclassical states of light and led to the development of quantum optics. In mesoscopic electron system s, current uctuations contain inform ation that is not available in simple transport measurements. For example, they can be used to distinguish electrical resistance due to di usive scattering from the resistance due to point contact tunneling (see Ref. 5] for a review). Single atom detectors have been used recently to perform Hanburry-Brown-Twiss experiments with cold atom $s^{6/7}$. Finally, analysis of noise correlations in time of ight experiments of ultra cold atoms has been proposed⁸ and tested^{9,10}, prom ising a powerful new technique to access m any-body correlations in such system s. In these applications, the quantities of direct interest are contained in the rst few moments of the noise distribution, such as the noise power spectrum . However deeper insights into quantum systems may be gained by obtaining the full statistics of the uctuations.

One of the central problems in the eld of ultra cold atom s is nding new ways of characterizing m any-body quantum states. In this paper we dem on strate that analysis of the distribution function of contrast in interference experiments between interacting one dimensional Bose liquids provides a novel probe of non-local correlations and entanglem ent present in these system s. It is known that the average am plitude of interference fringes can be used to extract two point correlation functions in uctuating condensates². This idea has been successfully em ployed by Hadzibabic et al. to measure the Kosterlitz-Thouless transition in two dimensional system s¹¹. Interference experiments, however, contain more information than the average value of the contrast. Each observation of the interference pattern is a classical measurem ent of a quantum mechanical state, so the result of each individual m easurem ent will be di erent from the average value. As we discuss below, higher m om ents of the distribution function of interference amplitudes correspond to high order correlation functions. Hence the know ledge of the entire distribution function reveals global properties of the system that depend on non-local correlation functions of arbitrarily high order. So far, the discussion of full counting statistics has been lim ited mainly to system s of non interacting particles¹². The main result of this paper, by contrast, is an expression for the full distribution of am plitudes of interference fringes arising from one dimensional interacting Bose liquids, that can be described by a Luttinger liquid.

The approach used in this paper for analyzing interference experiments can be generalized to a variety of other measurements in cold atom systems. For example, one can analyze uctuations in particle number in systems with pairing¹³ and uctuations in magnetization in M ott states of atom s with magnetic exchange interactions. In both cases distribution functions will contain non-trivial information about underlying many-body states. O ne can also consider time dependent phenomena such as evo-

lution of phase coherence between a pair of condensates coupled by a nite tunneling amplitude³. In this paper we focus on the distribution function of contrast in interference experiments between independent Bose liquids in their ground states. A lready in this case we nd a non-trivial evolution of the distribution function from the non-uctuating perfect contrast for the case of noninteracting atom s to the Poissonian distribution of contrast for atoms in the regime of in nitely strong repulsion. We think that our work constitutes one of the rst steps in the direction of developing a new method for characterizing interacting many-body quantum states of cold atom susing full distribution function of som e extensive quantum operator, such as the total magnetization or the interference amplitude operator de ned in equation (1). Dierent kinds of cold atom systems and experim ental probes can be studied following this general approach.

W e start our analysis by establishing the relation between the probability distribution function of the interference am plitude and the partition function of a boundary sine-G ordon m odel. U sing m ethods of conform al eld theory, we reduce this problem to that of nding a spectral determ inant of a sim ple one-dim ensional, singleparticle Schrodinger equation. We solve this problem num erically, as well as analytically using the W K B approxim ation, to obtain the desired fringe distribution for any value of the Luttinger param eter.




FIG.1: Schematic view of the possible experimental setup, which produces interference pattern between two independent 1D condensates.

It is interesting to point out that one can take the alternative point of view on the relation between interference experiments with BEC and the quantum impurity problem. By measuring the distribution function of the interference amplitudes experimentally one obtains the full partition function of the boundary Sine-Gordon problem (see eq. (6) below). This model describes a range of interesting problems such as an impurity in a 2

Luttinger liquid¹⁴, the asym m etric K ondo m odel¹⁵, and the tunneling of a particle in the presence of dissipation within a Caldeira-Leggett approach¹⁶. A swe discuss below, interference experiments can be used to obtain the partition function of these systems not only in the ground state but also in the non-equilibrium regimes (e.g. in the presence of a nite voltage). Hence interference experiments can be considered as a quantum solver of these non-trivialm any-body problem s.

Another surprising implication of our analysis is that interference experiments with one dimensional cold atom s can be used as a quantum simulator of several fundam ental problem s in physics. This connection relies on the fact that many models of systems with critical behavior in two-dimensional statistical mechanics, one dimensional eld theories and many-body quantum system s can be described by continuum theories with conform al invariance. Basic ingredients of any conform al eld theory are the central charge and conform aldim ensions of operators. One dimensional quantum systems of interacting particles have positive central charges and correspond to the so-called unitary class. On the other hand, there is a non-unitary class of models which have negative central charges. Such models appear in contexts as di erent as two dimensional quantum gravity and stochastic growth models and they have very unusual properties (see e.g. Ref. [17]). In this paper we dem onstrate that interference experiments with one dimensional condensates can be used to analyze models in nonunitary universality class by virtue of the exact m athem atical relation between the distribution function of interference amplitude and the so-called Q-operators of conform al eld theories. In Fig. 4 below we show a diagram which illustrates severalm odels that can be studied using interference experim ents.

II. FULL QUANTUM DISTRIBUTION OF THE INTERFERENCE CONTRAST

The setup for the interference experiments we consider is sketched in Fig.1. Two independent quasi-condensates are allowed to expand in the transverse direction. A fler su cient time of expansion, the integrated density prole is measured by the imaging beam which is sent at an angle to the condensate axis. This setup is quite common for the interference experiments in cold atom s and was already realized by several groups [11,18].

Everywhere in this paper we consider the two condensates to be identical, although our analysis can be generalized to the case of di erent condensates (see also Ref. [19]). We assume that before the expansion, atom s are con ned to the lowest transverse channels of their respective traps and that the optical in aging length L (which is smaller than or equal to the size of the system in the axial direction) is much larger than the coherence length of the condensates. This allow s us to use an elective Luttinger liquid description of the interacting $bosons^{20}$. The operator corresponding to the interference signal of the two condensates² is given by

Here a_1 and a_2 are the bosonic operators in the two system s before the expansion, and the integrals are taken along the condensates. The seem ing winding of the relative phase between the two systems, described by the exponential term in equation (1), can either com e from the measurement process itself or from the actual motion of the condensates². If the condensates are at rest, we have $p = (m d = v) \tan p$, where m is the atom 's m ass, d is the separation between the two condensates and t is the time when the measurement was done after the free expansion started. With some abuse of term in ology we will call $\ensuremath{\mathtt{p}}$ the relative momentum . W hen condensates one and two are independent, one nds that the expectation value of hApi vanishes, how ever hApfi is nite. This means that individual measurements show a nite am plitude of interference fringes, how ever their phase is com pletely unpredictable. Higher m om ents of the interference fringe am plitude are given by²

where C is a constant of order unity, is the particle density in each condensate, $_{\rm h}$ is the short range cuto equal to the healing length, and K is the Luttinger parameter describing the interaction strength. In this letter we assume that K > 1, which is always the case for bosons with -function type repulsive interactions³⁸. Coe cients Z _{2n} in Eq. (2) are given by²¹:

where p is the relative m om entum m easured in units of 2 =L:p = pL=2 .

Coe cients Z $_{2n}^{(p)}$ originally appeared in the grand canonical partition function of a neutral two-component C oulom b gas on a circle

Here x is the fugacity of C oulom b charges and Z_{2n} describe contributions from con gurations with 2n charges (i.e. canonical partition functions). The partition function (4) with K > 1 and p being half-integer describes several problem s in statistical physics (see Ref. [22] and references therein). In particular, it describes an im purity in a one-dimensional interacting electron liquid. At

low energies this problem is described by a Luttinger liquid (LL) with an additional local non-linear term due to backscattering from the impurity:

where g is the amplitude of backscattering on the inpurity and (x) is a bosonic phase eld associated with the electron eld operator (x) eⁱ. In the bosonized form the electron-electron interaction becomes quadratic and is e ectively described by the Luttinger parameter K. Perturbative expansion of the corresponding partition function in powers of g produces the series (4) with the fugacity given by $x = g (2 =)^{1=2K}$. Here is a non-universal renorm alization factor, which sets the scale for the long distance asymptotics of the correlation functions: hexp[2i((x;) (0;0))]i ($x^2 + 2$)^{1=K}. Finally, the single in purity K ondo m odel is related to Z_p (K;x) as well¹⁵.

It is easy to understand the origin of the relation between interference experiments and a quantum impurity problem. Moments of firinge amplitudes are determined by high order correlation functions computed at the same time but in dimension functions computed at the same expansion of the partition function for a quantum impurity contains correlation functions computed at the same spatial point but at dimensions computed at the same spatial point but at dimensions computed at the same analogue of the nite imaging angle in the interference experiments is a nite voltage in the quantum impurity problem²³. This analogy can be also understood from the interchanged roles of space and time in the two systems.

W hen describing interference experiments it is convenient to de ne the normalized amplitude of interference fringes = $A_p^2 = A_0^2$. From eq. (2) we nd that $h^n i = Z_{2n}^{(p)}$, so by measuring the distribution function $W_p()$ experimentally, we get direct access to the partition function (4). We point out that $W_p()$ can be used to compute all moments of A_p^2 , and therefore contains information about high order correlation functions of the interacting B ose liquids.

U sing Taylor expansion of the modi ed Bessel function as well as Eq. (4) and the fact that $h^{n}i = Z_{2n}^{p}$ we nd

Inverting Eq. (6) we can express the probability W $_{p}$ () through the partition function $Z_{p}(K;x)$. Noting that $I_{0}(ix) = J_{0}(x)$ and using the completeness relation for Bessel functions, $_{0}^{1} J_{0}(x)J_{0}(y)\dot{x}jd = (\dot{x}j \dot{y})$, we obtain

It is important that the last equation has the partition function at imaginary value of the coupling constant. This should be understood as analytic continuation of Z_p (K;x).

There are several ways how one can compute W $_{\rm p}$ (). The most straightforw and approach is to evaluate the coe cients Z $_{2n}^{(p)}$ and thus determ ine all the moments of the distribution. Explicit expressions for $Z_{2n}^{(p)}$ can be obtained using orthogonal Jack-polynom ials²². However, each of these coe cients is given as a series of products of -functions and their evaluation becomes extremely cumbersom e for n 3. Another approach to nding W_{p} () is to compute Z_{p} (K;x) using the therm odynam ic Bethe Ansatz for the quantum impurity problem²². This method works only for half integer K and requires solution of coupled integral equations. Besides, relating Z_p (K ;x) to the distribution function of interference am plitudes requires analytic continuation of Z_p (K;x) into the complex plane, x ! ix (see Eq. (7)), which introduces additional com plications. In this paper we will use a different m ethod, w hich is based on studies of the integrable structure of conformal eld theories²⁴. In particular, it was shown that the vacuum expectation value of Baxter's Q operator, central to the integrable structure of the models, coincides with the grand partition function of interest up to an overall $prefactor^{24}$ (see supplem entary m aterial for m ore details):

where x is related to the spectral parameter as x =

= sin (=2K) and the central charge c = 1 $6(2K = (2K))^2$. It was conjectured in Refs. [25,26] that the vacuum expectation value Q_p^{vac} () is proportional to the spectral determ inant of the single particle Schrödinger equation

To evaluate the distribution function we solve the Schrodinger Eq.(9) numerically. Details of the analytical treatment and comparison with numerics will be reported elsewhere²⁷. We checked the accuracy of the numerics as well as conjecture (10) by comparing coecients $Z_2^{(p)}$ (K) and $Z_4^{(p)}$ (K) evaluated for various K using (i) the spectral determinant (e.g. $Z_2^{(p)}$ P $1=E_n$, $Z_4^{(p)}$ ($1=E_n$)² $1=E_n^2$), and (ii) the exact expressions of Ref. [22] based on Jack polynomials. We found perfect agreement between the two methods.




FIG.2: Evolution of the distribution function W $_0$ (~) for different values of K at p = 0. At larger values of K the function W $_p$ tends to the delta-function (see text for details).

To compare distributions at dierent K with each other it is convenient to use a normalized interference am plitude $\sim = =$ h i = A²=hA² i instead . This change of variable is also convenient for comparison with experiments. The distribution function W_0 (~) is shown in Fig. 2 for several values of K . For K close to 1 (Tonks-G irardeau lim it) W 0 is a wide Poissonian function, which gradually narrow sasK increases, nally becoming a narrow -function at K ! 1 (the lim it of noninteracting bosons). Interestingly, the distribution function remains asymmetric for arbitrarily large K . In fact we nd that W $_0$ (~ 1) tends to a universal scaling form, parameterized by a single number characterizing the width of the distribution: ~ h~²i 1 = 6K (see Ref. [2]). W e conjecture that this $\lim \lim form of W_0$ is the Gum beldistribution²⁸, which frequently appears in problem s of extrem e value statistics²⁹: W_0 (~ 1)! W_G (~; K;), where 0:577 is the Euler gam m a-constant and




FIG. 3: Scaled distribution function $\neg W_0$ ((~ 1)= \neg), where \sim is the width of the distribution, for large K. The function W_0 is multiplied by \sim to preserve the total probability, which must be equal to unity. The dashed and dotted lines correspond to di erent values of K. The solid line corresponds to the conjectured G um bel distribution.

scaled distribution We plot the functions: $\sim W_0$ ((~ 1) = ~). Note that W_0 was multiplied by ~ to preserve the normalization condition (so that the total probability is equal to unity) for K = 10;20;40. For comparison in Fig. 3 we also present the scaled Gumbel distribution. One can see that as K increases the function W $_0$ indeed approaches to W $_{\rm G}$. Gumbel distributions are frequently associated with random walks in strongly correlated system s²⁹. Indeed one can view the interference signal in Eq. (1) as a sum of contributions coming from dierent points along the condensates. For weak interactions (large K) these contributions are strongly correlated because the phases of each of the condensates only weakly uctuate along z. Thus there is no surprise that W_0 approaches the Gumbel distribution. One can also understand this result noting that for K 1 the distribution function of the interference amplitude is dom inated by rare events which reduce the contrast. The Gumbel distribution was introduced precisely to describe rare events such as stock market crashes or earthquakes. In supplementary materials (sec. VB) we also discuss distribution functions for nite values of the observation angle (i.e. nite p).

Interestingly, the distribution function W $_{\rm p}$ () provides a very simple and convenient framework for describing both the partition function (4) and the expectation values of the Q -operator. Indeed, W $_{\rm p}$ () is a smooth well behaved function at all values of K and it can be easily approximated by simple analytic expressions.

III. QUANTUM SIMULATION

As we mentioned earlier, the distribution function $W_p()$ can be used to obtain the partition function $Z_p(K;x)$ (see Eq. (6)) describing a range of various problem s like quantum in purity in a one-dimensional elec-

tron liquid, asym metric K ondo problem, and dissipative tunneling. It is easy to see that momentum p in the interference experiments corresponds to the external applied voltage in the impurity problem (ip V). This follows from the interchanged roles of space and time in the two problems. Thus measuring W () experimentally and taking its integral transform one directly simulates these problems in or out of equilibrium. Moreover, after substituting $I_0(2x^{-1})$! $J_0(2x^{-1})$ in Eq. (6) one

The partition function with the imaginary coupling also gives the expectation values of the Baxter Qoperator (see Eq. (8)) corresponding to various conform al eld theories (CFTs). In general, such theories are particularly in portant because m any m odels of two-dimensional statistical mechanics, eld theory, and m any-body quantum system s at critical points can be described by som e continuum theories having a property of conform al invariance. This leads to a description of critical system s on the basis of conform al eld theory, which basic ingredients are the central charge and conform aldim ensions. This set of data classify di erent universality classes, which often describe very di erent physicalm odels. The property of positivity of the central charge leads to a unitary theory. Physically, the central charge determines the vacuum (Casimir) energy of the system and governs the nite-size scaling e ects. On the other hand there is a class of models whose universality classes of critical behavior are described by the conform al-invariant m odels with negative central charges. These theories are nonunitary and their properties are thus very di erent from those described by positive central charges.




FIG. 4: Dependence of the central charge of conform al eld theories corresponding to interference experiments on the Luttinger liquid parameter K. The red circles correspond to some particular examples discussed in the text.

Conformal eld theories corresponding to Eq. (8) are characterized by negative central charge c = 1 6 (2K $1=(2K)^2$ and the highest weight = $(2pK)^2 + (c 1)=24$ (see Ref. [24]). These relations give c 2 for K 1. Theories with negative central charges appear in di erent contexts of statistical mechanics, stochastic growth models, 2D quantum gravity, models of 2D turbulence and even high-energy QCD. In particular, c =2 CFThas the eld-theoretical representation in terms of the ghost (anticom muting) elds and also corresponds to the critical behavior of the non-intersecting loop model on a 2D lattice³¹ as well as to the special case of the stochastic Loew ner evolution equation, describing the grow th of random fractal stochastic conform al-invariant interface (see e.g. R ef. [32]). The classic exam ple of CFT with negative c is the Yang-Lee singularity c = 22=5 describing the critical behavior of the Ising model in im aginary magnetic eld. M odels of 2D quantum gravity described by the uctuating lattice geometry are related to negative c as well. Possibly, the high-energy lim it of multicolor QCD is described by the integrable CFT with negative (or zero) central charge³³. W e illustrate the dependence of c on K as well as particular examples of m odels corresponding to di erent values of c in Fig. 4. The spectrum of Q -operator can be used to reconstruct the transfer m atrices of the above m entioned negative c m odels. Particular example of such procedure for c = 2 universality class was explicitly constructed in Ref. [24]. In this case only the vacuum expectation value was needed to reconstruct the whole transferm atrix. The transferm atrices contain all the information about the properties of underlying models. In this sense interference experi-

m ents simulate these models. Experimentally, the central charge can be tuned by varying the interaction K and the scaling dimensions of corresponding physical operators can be manipulated by changing the observation angle p. An interesting challenge here is the experimental determination of nonvacuum values of the Q and T operators. This is an open question.

N eedless to say that the range of m odels m entioned above, which belong to nonunitary universality classes is di cult (if possible at all) to realize by other ways. The interference of condensates provides a possible and a plausible way to explore the interesting physics of various m odels ranging from statistical to high energy physics.

IV. SUMMARY

To sum m arize, in this paper we analyzed interference experiments between two independent one dimensional quasi-condensates. We computed the distribution function of the amplitude of interference fringes relating this problem to the properties of Q operators of conform al

eld theories with negative central charges. W e showed how one can use the distribution function of the interference am plitude to reconstruct the partition function of a two-dimensional C oulomb gas con ned to a circle. This partition function is related to a variety of statistical and eld-theoretical models. Thus studying the interference distribution function experimentally, one can directly simulate these interesting models.

We considered only a particular example of interference between two one-dimensional condensates and showed the connection between the distribution function of fringe amplitudes and the properties of various models. This analysis can be extended to other system s with quasi long-range order, e.g. to two-dimensionalB ose systems at nite temperature. One can expect that there will be analogous connections to di erent classes of problem s, som e of which m ight not be exactly solvable. The interference experiments open new ways of solving these problem s by direct simulation of the underlying m odels.

V. SUPPLEMENTARY MATERIAL

A. M athem atical details

Function Z (K;g) can be computed using the Therm odynam ic Bethe Ansatz. This was used in Refs. [15,22] to evaluate the current through a boundary in purity. How – ever to compute the distribution function W we need analytic continuation of the partition function Z (K; ig). Expression for Z (K;g) is given as a solution of coupled integral equations and perform ing its analytic continuation is not easy. In this paper we use an alternative approach.

In a recent series of papers Bazhanov, Lukyanov, and Zam olodchikov explored an integrable structure of conform al eld theories focusing on connections to solvable problem s on lattices²⁴. Key ingredients of solvability of lattice models are is the so-called transfer matrix T () operators. These operators contain information about all integrals of motion as well as excitation spectra of the system. Transfer matrices are de ned as a function of the so-called spectral parameter (in the continuum lim it corresponds to rapidity) and commute for di erent values of . The latter property is a direct manifestation of the existence of in nite number of commuting integrals of motion. In his studies of 8-vertex model, $Baxter^{35}$ introduced the operator Q () which helps to nd an eigenvalues of T. Operators T and Q satisfy a set of commutation relations, in particular²⁴

where $q = \exp(i = 2K)$. So T matrices can be obtained explicitly when one knows the Q operators.

Operators A () = Q () $^{4p=K}$ act in the representation space of V irasoro algebra, which can be constructed from the Fock space of bosonic operators a n satisfying an $\dot{p}i = 0$, (n > 0). The Fock vacuum state $\dot{p}i$ is an eigenstate of the momentum operator, P $\dot{p}i = p\dot{p}i$. For p = N = 2 (N = 0;1;2:::) the vacuum eigenvalues of the operator A (), A () $\dot{p}i = A^{(vac)}\dot{p}i$, are given by (below we consider only the quantities with the + subscript which correspond to the positive p)

The function A (vac) has known large- asymptotics24

where the constant M (K) is given by

The function A $^{\rm (vac)}$ () is entire function for K > 1 and is completely determined by its zeros $_{\rm k}$, k = 0;1;:::. Therefore A $^{\rm (vac)}$ () can be represented by the convergent product

On the basis of analysis of a certain class of exactly solvable model, corresponding to the integrable perturbation of the conformal eld theory, it was conjectured in²⁵ that the so-called Y-system and related T system (where $Y = e^{T}$ and $_{T}$ are the Bethe-ansatz energies param etrized by r, the nodes of the D ynkin diagram s) satisfy the same functional equations and possess the sam e analytical structure and asym ptotics as the spectral determ inant of the one-dimensional anharm onic oscillator. Further, the sam e functional equations, analytical properties (17) and asym ptotics (15) are satis ed for the vacuum eigenvalues of Q-operator for special values of p and the latter are given by the spectral determ inant of the follow ing Schrodinger equation

The spectral determ inant is de ned as

Soon after, in R ef. [26], this conjecture has been extended to all values of p:

where now D (E) is the spectral determ inant of Eq. (9) with 1 = 4pK 1=2. Here = $(4K)^{2} = 1-K$ [(1 1=(2K))]².

Typically, for n 5 10 the spectrum of the equation (9) is very well approxim ated by the standard W K B expression

where n = 1;2; ... Here $_1(K)$ is the M aslov index. For 1=2 < K < 1, $_1(K) = \frac{1}{4} - \frac{1}{2}$, for K = 1, $_1(K) = 1=2$

and for $0 < K < \frac{1}{2}$, $_1(K) = \frac{4K}{8K} \frac{21}{8K}$. Note that the Eq. (9) has an interesting duality sym m etry (generalizing the C oulom b-harm onic oscillator duality) which allows to relate the K > 1=2 and 0 < K < 1=2 sectors. The point K = 1=2 is a self-dual point of this transform ation. The function (K) in Eq. (21) reads

In principle, the function $_1$ (K) can be a smooth function interpolating between limiting values given above and can be considered as a noninteger M aslov index³⁶. This interpolation allow sto (approxim ately) evaluate the partition function and the distribution function in many cases. In the limiting cases K ! 1 and K ! 1 the W K B approximation gives the exact spectrum, which was discussed in the main text. We point how ever, that the using the approximate W K B spectrum can result in nonphysical results, e.g. negative values of the distribution function W (), and thus have to be used with care.

B. A nalysis of distribution functions

A nalytic expressions for Z can be obtained explicitly for K = 1 since in this case equation (9) corresponds to a singular harmonic oscillator (with a parabolic potential replaced by the potential $x^2 + 1(1+1)=x^2$, singular at x = 0). Eigenvalues of this Schrodinger equation are $E_n = 4n + 21$ 1, n = 1;2;... Exact result for the spectral determ inant can be computed using the W eierstrass representation of the gam m a function. W e nd,



where C is a nonuniversal constant which arises due to the logarithm ic divergence of the integrals in Eq. (3) and involves the cuto dependence of h i at K = 1. If we are interested in distances much larger than the cuto then C 1 and the function Z_p becomes a simple gaussian. A fler the integral transform this leads to the Poissonian distribution W_p (). The case K ! 1 is recovered by the in nite well potential for which the eigenenergies are given by zeroes of the Bessel function. Therefore

From equations (7) and (24) one sees that when p = 0, the distribution function is a delta function. As p increases, W $_{\rm p}$ () rapidly broadens. In the limit of large K, the function W $_{\rm p}$ depends only on the product K p and takes a simple form : W $_{\rm p}$ () 4K p (1 $\int^{K p - 1}$ for < 1 and zero for > 1. This function is peaked at = 1 for K p < 1=4, it becomes a step function exactly at K p = 1=4, and for K p > 1=4 W $_{\rm p}$ is a monotonically decreasing function of . When the product K p

becom es large K p & 1 the function W $_{\rm p}$ becom es Poissonian: W $_{\rm p}$ () 4K pexp (4K P). In general, the tendency of broadening of the distribution function remains true for all values of K. In particular, we show the behavior of W at xed K = 2 for various p in Fig. (5).
