# A swollen phase observed between the liquid-crystalline phase and the interdigitated phase induced by pressure and/or adding ethanol in DPPC aqueous solution

A swollen phase, in which the mean repeat distance of lipid bilayers is larger than the other phases, is found between the liquid-crystalline phase and the interdigitated gel phase in DPPC aqueous solution. Tem perature, pressure and ethanol concentration dependences of the structure were investigated by small-angle neutron scattering, and a bending rigidity of lipid bilayers was by neutron spin echo. The nature of the swollen phase is sim ilar to the anom alous swelling reported previously. However, the tem perature dependence of the mean repeat distance and the bending rigidity of lipid bilayers are di erent. This phase could be a precursor to the interdigitated gel phase induced by pressure and/or adding ethanol.

I. IN TRODUCTION

Lipid bilayers are interested in these decades as model biological membranes not only from a view point of biology but also of physics. [1] They exhibit a richness of structures and phase equilibria depending on their environm ental conditions such as water content, ionic strength, tem perature, pressure, etc. A uid lam ellar phase (liquid-crystalline L phase) is a basic structure of biological m em branes appears at higher tem perature. In this phase, bilayers are regularly stacked and at on average, forming multi-lam ellar vesicles. With decreasing tem perature, several therm otropic phase transitions have been observed; a "main transition" from the liquid-crystalline phase to a gel (P<sup>0</sup>) phase and a "pretransition" from the  $P^0$  to another gel ( $L^0$ ) phase. In these gelphases, the hydrophobic tails of lipid m olecules are extended and ordered, whereas the tails are conform ationally disordered in the liquid-crystalline phase. In the middle-tem perature P<sup>0</sup> phase, a two-dimensional lattice structure is form ed in which the lipid bilayers are distorted by a periodic ripple in the plane of lam ellae.

A nother interesting structural polym orphism is an interdigitated gel (L  $_{\rm I}$ ) phase, which is characterized by an alternative alignment of hydrophilic headgroups and hydrophobic tails of phospholipid molecules. A ddition of small molecules, for example alcohol, is known to stabilize the interdigitated structure. [2] An origin of the stabilization by adding alcoholwas explained with the experimental results by A dachi et al:, [3] which indicated that two alcohol molecules are led in a volume surrounded interstitially by the headgroups of phospholipid molecules. This picture was veried by a simulation done by K ranenburg and Sm it. [4]

The e ects of pressure on lipid m em branes have been interested in relation to the pressure-anesthetic antagonism; pressure may suppress the e ect of anesthesia molecules on structures of bio-m em branes. From this viewpoint, K aneshina et al: investigated the e ect of ethanol on the P-T phase diagram of lipids including dipalm itoyl-sn-glycero-3-phosphatidylcholine (DPPC) aqueous solution. [5] They have shown that the interdigitated phase appeared at low er pressure with adding sm all am ount of ethanol. This result im plied that the e ects of pressure and ethanol on the structural form ation of DPPC m em branes were the sam e. How ever,




FIG.1: Pressure-dependence of the SANS prole observed at T = 56:0 C for the sample with 0.70 M ethanol. The verticalaxis indicates the absolute scattering intensity, and shifts 10 cm<sup>-1</sup> each for better visualization. The liquid crystalline phase transforms to the \swollen phase" at P = 60M Pa, and to the interdigitated phase above P = 69M Pa.

the detailed mechanisms of the ethanol-induced and the pressure-induced interdigitation and their equality remain to be answered. [6]

In order to com pare the e ects of adding ethanol and increasing pressure on the structural form ation of lipid m em branes, com prehensive set of sm all-angle neutron scattering (SANS) data on the tem perature, pressure and ethanol concentration dependences of the structure of DPPC aqueous solution were collected. The results indicated that the phase boundary of the liquid crystalline phase (L ) and the interdigitated phase (L  $_{\rm I}$ ) was not changed by adding ethanol. How ever, the transition pressure from the gelphases (L  $^0$  and P  $^0$ ) decreased by adding ethanol.

A new \swollen phase", in which the thickness of lipid bilayers is almost the same as in the gel phases and only the thickness of the water layer is larger than the other phases, is found between the L phase and the L \_ phases. [7] This phase is induced only by increasing pressure (without adding ethanol) and only by adding ethanol (without increasing pressure). The nature of this phase is similar to the anom alous swelling observed between the liquid crystalline phase and the gel phase; [8] how ever, the bending rigidity estim ated by neutron spin echo (N SE) experiments indicated that the bilayer is not soften unlike the case of the anom alous swelling.

# II. EXPERIMENT

DPPC was purchased from A vanti Polar Lipids, Inc. Deuterated water of 99.9 % purity and ethanol (EtOH) of 99 % were obtained from Isotec Inc. and Katayama Chemical Co. Ltd., respectively. All the chemicals were used without further puri cation. DPPC was rst milled in an agate mortar and dissolved in water at 15 wt.%. Molar ratios of ethanol against water were 0.00 M, 0.30 M, 0.50 M, 0.70 M, 0.80 M, and 1.20 M for SANS and 1.21M for NSE. All the mixtures were incubated at 50 C (above the main transition temperature) for 24 hours and kept at room temperature for more than 24 hours.

The SANS experiments were carried out at SANS-U installed at the cold neutron guide hallof JRR-3M in JAEA (Japan Atom ic Energy Agency), Tokai, Japan. [9, 10] A 7.0 A beam of incident cold neutrons with the wavelength resolution of about 10% was used. The cam era length for the sam ples without ethanoland with 0.30 M, 0.50 M and 0.70 M ethanolwas 1.5m, that for the sample with 0.80 M ethanolwas 1 m, and that for the sam ple with 1.20 Methanolwas 2 m. The measured momentum transfer Q  $0:17 A^{1}$ , ranges for those conditions were 0:017 Q 0:03 Q  $0:3 A^{1}$ , and 0:014 Q $0:14 \text{ A}^{-1}$ , respectively. Exposure time for one measurement was between 300 and 1800 s.

The samples were contained in two types of highpressure cells. The rst one, which achieves up to 100 MPa, [11, 12] was used for the samples with higher ethanol content (0.70 M , 0.80 M , and 1.20 M ). The other one, which could be pressurized over 200 MPa, was used for the samples with low ethanol content because the transition pressure to the interdigitated phase increases with decreasing ethanol. In all the cases, the sample thickness was 1 mm. Hydrostatic pressure was applied by using a hand pum p and the pressure wasm easured with a HEISE gauge within an accuracy of 0:1 M Pa. Tem perature of the high-pressure cells was controlled with a personal computer and its accuracy was less than 0:01 C. The observed 2-dimensional scattering intensities were azim uthally averaged, corrected for the transm ission, background scattering and sample thickness, and were scaled to the absolute di erential scattering cross sections by using a secondary standard sam ple m ade of Lupolen (a polyethylene slab calibrated with the incoherent scattering intensity of Vanadium).

The NSE measurements were performed at iNSE in JAEA, Tokai, Japan. [13] A 7.1 A incident neutron was mechanically selected by a neutron velocity selector with the resolution of 12 %, so that the ranges of momentum transfer and Fourier time are 0.05 Q 0:13 A  $^1$  and 0.08 t 15 ns, respectively. The sample with 1.21 M ethanol was used and measured at 36.0, 38.5 and 41.0 C controlled by a water circulation system within the accuracy of 0.1 C.

## III. RESULTSAND DISCUSSION

In Fig. 1, a typical example of a pressure-dependence of SANS prole is shown. In this measurement, 0.70 M of ethanol was added in the DPPC aqueous solution and temperature was kept at 56.0 C. The peak positions of these proles are obtained by the thing with the function proposed by M ason et al:, [14]

where the st term means a di use scattering around Q = 0 originated from the concentration uctuation of lipids, and the second term represents the Bragg peak due to the lam ellar structure.

The phase at am bient pressure is the liquid-crystalline L and the SANS pro le has a Bragg peak at  $Q = 0.095A^{-1}$  due to the regular stacking of lipid bilayers. This pro le does not change up to P = 55 M Pa. Above

P = 60M Pa, the peak at Q = 0.095 A  $^1$  disappears and a new peak is born at Q = 0.078 A  $^1$ . This peak shifts to higher-Q with increasing pressure, coexists with the peak of the L  $_{\rm I}$  phase at P = 69 M Pa, and vanished above P = 70 M Pa. As described in our previous paper, [7] this pro le is typical for the new phase existed between the liquid-crystalline phase and the interdigitated gelphase. At high pressure above 70 M Pa, a B ragg peak exists at Q = 0:125A  $^1$  because the interdigitated gel phase (L  $_{\rm I}$ ) is induced.

In order to characterize these structures, further ttings with the scattering function given by Lemmich et al: [15] were performed. They described the scattering function from bilayer structure as,

with d and being thickness and standard deviation. The su xes H;L;W are of headgroup, hydrocarbon chain and water, and D m eans a whole bilayer, i.e., the m ean repeat distance of lam ellar d is equal to  $d_D = 2d_H + d_L + d_W$ . Here <sub>r</sub> is described as,

with the scattering amplitude densities of these parts.

The t function explains the proles at the single phases well. The estimated thickness t's of a lipid bilayer were 43.4 A for L phase, 32.7 A for L I phase, 47.3 A for P<sup>0</sup> phase, and 47.1 A for L<sup>0</sup> phase, respectively. These values are consistent with those in the literature. [3, 16, 17]

The thickness of a bilayer in the new phase is estimated to be 47.5 A, which is almost the same as that in the gel

phases (P  $^0$  and L  $^0$ ). Therefore, the intra-layer packing of lipid m olecules in this new phase should be the same as that in the gelphases, and only the thickness of water layer between bilayers, 33.0 A at P = 60 M Pa, is larger than the other phases. Therefore, here we named this phase as a \swollen phase" (L<sub>s</sub> phase).




FIG. 2: Pressure and temperature dependences of the SANS prole for the sample with 0.80 M ethanol. Each peaks at higher pressure is shifted upward for better visualization. The peak due to the swollen phase ( $Q' 0.06 A^{-1}$ ) appeared between T = 40 C and 44 C with a peak belonging to the P<sup>0</sup> phase ( $Q' 0.09 A^{-1}$ ). Thus, the swollen phase exists as a coexistence phase with the P<sup>0</sup> phase.

In Fig. 2, pressure-dependences of SANS pro le of the sample with 0.80 M ethanol at T = 44 C , 42 C , and 40 C are shown. In these conditions, the swollen phase exists as a coexistence phase with the ripple gel phase. The position of the B ragg peak depends slightly on temperature, on the other hand, changes very little with increasing pressure.




FIG.3: P T phase diagram s obtained from the SANS experiment. The red areas are the regions of the single swollen phase ( $L_s$ ), and the blue areas are the coexistence phase ( $L_s + P^0$ ). The circles indicate the points measured by the present SANS experiment. The arrows indicate the lines of experiments of Fig. 1 and Fig. 2.

Figure 3 sum marizes the phase diagram s determ ined by the SANS experiments. It is clear that the phase boundary between the liquid-crystalline L phase and the gel phases does not change by adding ethanol. How –

ever, the transition pressure to the interdigitated gel (L  $_{\rm I}$ ) phase decreases with increasing ethanol concentration. Thus, it is could be mentioned that the e ect of ethanol on the interdigitation is identical with pressure. The swollen phase, indicated by the red areas (single L<sub>s</sub> phase) and the blue areas (coexistence with the P<sup>0</sup>), exists in all the ethanol concentrations. Both temperature and pressure of these areas decrease with increasing ethanol concentration. This tendency is the same as that of the L  $_{\rm I}$  phase. Thus we conclude that the swollen L<sub>s</sub> phase.




FIG.4: P ressure-and tem perature dependences of the m ean repeat distance d in the  $L_s$  phase (red) with that in the L phase (green) of the sam ples with 0.70 M ethanoland 0.80 M ethanol.

Figure 4 shows pressure- and tem peraturedependences of the mean repeat distance d in the  $L_s$  phase together with d in the L phase. The pressuredependence of d is not very signi cant; it decreases a little with increasing pressure. On the other hand, it decreases monotonically with increasing temperature. This tendency is similar to that of the anomalous swelling observed in similar systems. [18, 19, 20] The d-spacing of lipid bilayers increases from 63 A (in the case of DMPC) up to around 67 A with approaching the main transition temperature from the liquid-crystalline phase, and pressure suppresses the anomalous swelling. [20] However, the details of the tem perature dependence of d in the Ls phase is di erent from those of the anom alous swelling: In the case of the anom alous swelling, the mean repeat distance d follows the power law behavior from the L phase to the main transition temperature with decreasing temperature. On the other hand, in the present case, d jumps at the phase boundary between the L phase and the  $L_s$  phase. The value of d in the  $L_s$  phase is much larger than that in the anomalous swelling. Thus we emphasize that the present observation can not be explained by the anomalous swelling.

P abst et al: indicated that the origin of the anom alous swelling is an abrupt decrease in the bending rigidity of lipid bilayers near the m ain transition tem perature. [19] Thus, in order to check the rigidity of lipid bilayers of the swollen phase, we investigated dynam ical behaviors by m eans of NSE, because the therm al uctuation of lipid bilayers can be observed directly by this m ethod.




FIG.5: SANS proles observed at NSE (left) and the interm ediate structure factor I (Q;t)=I (Q;0) (right) obtained from the NSE measurement for the sample with 1.21 M ethanol. (a) T = 41:0 C in L phase. (b) T = 38:5 C in L<sub>s</sub> phase. (c) T = 36:0 C in L <sub>I</sub> phase. The lines in the SANS prole is guides for the eyes, and the lines in the NSE data are the t results. The arrows in the SANS proles are the positions where the NSE data are depicted.

In Fig. 5, experimental results of the sample with 121 M ethanolat ambient pressure obtained by NSE are shown. At T = 41.0 C, the system is in the L phase and the SANS pro lehas a Bragg peak at Q ' 0.09A <sup>1</sup>. The system transforms to the L<sub>s</sub> phase at T = 38.5 C in which a peak exists at Q ' 0.07 A <sup>1</sup>, and to the L<sub>I</sub> phase at T = 36.0 C with a peak at Q ' 0.12 A <sup>1</sup>.

The interm ediate structure factors I(Q;t)=I(Q;0) at these temperatures obtained by the NSE experiment are shown in the right part of Fig. 5. In the DPPC aqueous solution, the authors have already showed [21] that I(Q;t)=I(Q;0) can be explained with the theoretical function describing a single membrane uctuation given

by Zilm an and Granek, [22]

and the bending rigidity of lipid bilayers is obtained by

Here, parameters and could be assumed as 1 and 0.025, respectively. The viscosity of surrounding medium

is that of  $D_2O$ . In multi-lam ellar systems, a scattering intensity around a Bragg peak will be in uenced by a strong elastic scattering, and the nature of the thermal uctuation of a bilayer should be estimated from o -Bragg region.

Thus we tted eq. (7) to I(Q;t)=I(Q;0)'s of  $Q = 0.13A^{-1}$  at  $T = 41.0 C, Q = 0.11A^{-1}$  at T = 38.5 C,

and  $Q = 0.09A^{1}$  at T = 36.0 C. From these analysis, the coe cient A is estimated to be 15.9 A<sup>3</sup>ns<sup>1</sup> at T = 41.0 C, 1.44 A<sup>3</sup> ns<sup>1</sup> at T = 38.5 C, and 4.92  $A^{3}ns^{1}$  at T = 36:0 C, respectively. The bending rigidity is estimated from these values of A using eq. (9) to be = 1:9 10<sup>19</sup> JatT = 41:0 C, = 2:1 10<sup>17</sup> Jat T = 38:5 C, and  $= 1:6 10^{18} J at T = 36:0 C$ . The value in the liquid-crystalline phase ( = 1:9  $\,$  10  $^{19}$  J at T = 41:0 C) is consistent with the previous estim ation. ( =  $2.56 \quad 10^{19} \text{ Jat T} = 50.0 \text{ C}$ ) [21] It is reasonable that the bending rigidity of bilayers in the interdigitated phase ( = 2:1  $10^{17}$  J at T = 38:5 C) is larger than that in the gelphases. [12, 23, 24] And also, it is clear that the bending rigidity in the swollen phase ( = 1:6 10  $^{18}$  J at T = 36:0 C) is harder than that in the liquid-crystalline phase. This is the most striking result in this NSE experiment, that the rigidity of bilayers in the swollen phase is hard as those in the gel phases, unlike the case of the anom alous swelling.

The dynam ical behavior of bilayers is also characterized by the tting to I(Q;t)=I(Q;0)'s of  $Q = 0.05 A^{-1}$ for all the tem peratures observed. The coe cient A's are  $55.9 A^{3}ns^{-1}$  at T = 41.0 C,  $5.0 A^{3}ns^{-1}$  at T = 38.5 C,

and 13.1 A<sup>3</sup>ns<sup>1</sup> at T = 36.0 C, respectively. The bending rigidity could not be extracted from these values due to the elect of the elastic scattering; how ever, the tendency that bilayers in the L<sub>s</sub> phase is harder than that

in the L phase is clearly veried.

So far, an origin to determ ine the m ean repeat distance of lipid bilayers in multilam ellar vesicles is discussed in term s of a balance of interactions between bilayers. Because DPPC is a neutral lipid and no salt is added in the present mixture, the C oulom bic interaction should be neglected and only 3 interactions are taken into account; the van der W aals attractive force between two parallel at bilayers, a short-range repulsive force due to the hydration layer in the vicinity of lipid bilayers, and the long-range repulsive force originated from the thermal uctuation of lipid bilayers. [21, 25] If one tries to explain the origin of the sw ollen phase in this fram ew ork, any changes of strengths of interactions com paring with the other phases are necessary. How ever, there is no reason that the van der W aals force is weaker or the other two repulsive forces are stronger than the other phases. Thus, at present, we can not explain the origin of the sw ollen phase quantitatively.

It should be noted that another long-priod structure named  $L_X$  phase was observed in the process of the transition from L phase to L phase in DEPC aqueous solution. [26] This result suggested that a quasi-static potential minimum of the long-spacing structure exists in the vicinity of the L phase, and the origin of the  $L_X$  phase could be the same as the present  $L_s$  phase.

### IV. CONCLUSION

In this paper, we present SANS results by changing temperature, pressure, and ethanol concentration. It is veri ed that the adding ethanol has no e ect on the phase boundary between the liquid-crystalline phase and the gel phases, on the other hand, have the same e ect as pressure on the interdigitation. Between the liquidcrystalline phase and the interdigitated phase, a new sw ollen phase is observed. The nature of this phase is sim ilar to the anom alous sw elling; how ever, the tem perature dependence of the mean repeat distance and the bending rigidity of bilayers are di erent from those of the anom alous sw elling.
