# The one-dim ensional H ubbard m odel with open ends: U niversal divergent contributions to the m agnetic susceptibility

A bstract. The magnetic susceptibility of the one-dimensional Hubbard model with open boundary conditions at arbitrary lling is obtained from eld theory at low temperatures and small magnetic elds, including leading and nextleading orders. Logarithm ic contributions to the bulk part are identied as well as algebraic-logarithm ic divergences in the boundary contribution. As a manifestation of spin-charge separation, the result for the boundary part at low energies turns out to be independent of lling and interaction strength and identical to the result for the Heisenberg model. For the bulk part at zero temperature, the scale in the logarithms is determ ined exactly from the Bethe ansatz. At nite temperature, the susceptibility pro le as well as the Friedel oscillations in the magnetisation are obtained num erically from the density-matrix renorm alisation group applied to transfer matrices. A greem ent is found with an exact asymptotic expansion of the relevant correlation function.

## 1. Introduction

The one-dimensional Hubbard model plays a central role in the understanding of interacting electrons in one dimension. The Hamiltonian

arises naturally in the tight-binding approximation of electrons on a chain with L sites. In (1), the magnetic eld h couples to the z-component of the total spin. The interaction parameter  $u = U = j \cdot j > 0$  is the ratio between the on-site C oulom b repulsion U and the hopping amplitude t. N ote that the eigenvalues of H are invariant under a sign change t ! t [1]. Furtherm ore, H is invariant under reversal of all spins and under a particle-hole transform ation (the so-called Shiba transform ation) [1]. Therefore we restrict ourselves here to positive magnetisation and lattice lling less than or equal to one.

The appealing simplicity of the Hamiltonian, combined with its Bethe-Ansatz solvability and its adequateness for eld-theoretical studies are the reasons for its wide popularity.

Recent experimental achievements in two areas additionally motivate our studies: On the one hand, the fabrication and characterisation of carbon nanotubes have shown that these can be considered as realisations of one-dimensional Hubbard models [2]. Especially, kinks in these quantum wires have been realised experimentally [3, 4]. A kink locally weakens the hopping amplitude at one specic lattice site in the Hamiltonian. Such a modi cation is known to be a relevant perturbation, which, at u > 0, is governed by a xed point with zero conductance through the kink [5]. Thus at low energies the chain is e ectively cut into two pieces.

On the other hand, ultracold ferm ionic atom s in optical lattices can be described by a one-band Hubbard model [6]. Given the recent progress in realizing quasionedimensional bosonic quantum gases [7], it is likely that similar experimental progress will be made with ferm ions.

In order to model these situations, we consider open boundary conditions in (1). Compared to the case with periodic boundary conditions, an additional surface contribution  $f_B$  to the free energy occurs, de ned as

where  $F_{obc}$  ( $F_{pbc}$ ) is the total free energy for open (periodic) boundary conditions. In this work, we will focus on the magnetic susceptibility per lattice site =  $_{bulk}$  +  $_{B}$  =L both at T = 0, h 0 and T 0, h = 0, at arbitrary llings.

For half lling, the bulk contribution  $_{bulk}$  at T = h = 0 has rst been given by Takahashi [8], where also the existence of logarithm ic contributions at nite h is mentioned. Later on, Shiba [9] calculated  $_{bulk}$  at T = h = 0 for general lling. The free energy at nite temperatures was given by Takahashi (for an overview and original literature, cf. the book [10]), and later by K lum per (the book [11] contains a detailed account of this work). How ever, it seems as if the explicit behaviour of  $_{bulk}$ at T = 0, h & 0 and T & 0, h = 0 has not been derived so far. In this work, this gap will be lled.

A lthough the boundary quantity  $_{\rm B}$  is only an O (1)-correction to the total bulk contribution, it may become in portant in experiments if it shows a divergency with respect to the tem perature T orm agnetic edd h. Indeed, such divergences have been discovered and analysed in the spin-1/2 Heisenberg chain [12, 13, 14, 15, 16]. Since the isotropic spin-1/2 Heisenberg chain is obtained from (1) in the limit u ! 1, related divergences are also expected to occur in (1). In the case of half-lling for T = 0, it has in fact been shown in [14, 17] that the boundary m agnetic susceptibility is divergent,  $_{\rm B}$  1= (h ln<sup>2</sup> h), for h ! 0. Exactly the same result for  $_{\rm B}$  has also been obtained for the supersymmetric t J m odel [18]. The OBC s do not only lead to 1=L-corrections but also break translational invariance. Therefore quantities like the m agnetisation or the density become position dependent. Localm easurements of such quantities then provide a way to obtain inform ation about the impurity m aking theoretical predictions about the behaviour of such one-point correlation functions desirable.

In section 2 we give the functional forms of both the bulk and the boundary contributions by using a eld-theoretical argument. Leading and next-leading logarithm ic contributions to the nite bulk susceptibility are found both at nite T and nite h.On the other hand, the boundary contribution diverges in a Curie-like

way with logarithm ic terms, where again we give both the leading and next-leading divergences. These results depend each on two constants, which are the spin velocity and the scale involved in the logarithms. At magnetic elds or temperatures much smaller than this scale the result for the boundary susceptibility becomes independent of the spin velocity and the scale and therefore completely universal. This is a manifestation of spin-charge separation as will become clear in the next section. For the bulk susceptibility, on the other hand, only the functional dependence on eld or temperature will be universal for low energies. The value at zero eld and zero temperature, how ever, is a non-universal constant which does depend on lling and interaction strength via the spin velocity.

The spin velocity has been determ ined previously from the Bethe ansatz solution [9]. In section 3, for T = 0, the scale in the logarithm s will be determ ined exactly as well. The calculation of boundary e ects at T > 0 based on the Bethe ansatz solution still remains an open problem, as for all Yang-Baxter integrable models (reasons for that are given in [15, 19] for the special case of the spin-1/2 X X Z chain). In section 4 we therefore calculate the susceptibility prole (x;T) and magnetisation proles (x;T) in the asymptotic low-energy limit (that is, for large distances and sm all temperatures) by making use of conformal invariance. Due to the open boundaries, s(x;T) shows the characteristic Friedel oscillations [20, 21, 22]. To test the eld-theory predictions, we perform num erical calculations in the fram ework of the density matrix renorm alisation group applied to transferm attrices, which is particularly suited for in purity and open-boundary models. In the last section we will present our conclusions and discuss in which experimental situations the calculated boundary e ects might become important.

#### 2. The low -energy e ective H am iltonian

First, we brie y review the e ective eld theory for the Hubbard model following in large parts Refs. [23, 11]. From the e ective H am iltonian we then obtain the magnetic susceptibility at small magnetic eld and low temperature.

Let a be the lattice spacing. We introduce ferm ionic elds (x) in the continuum by

where x = j a and the usual splitting into left- and right-moving parts has been performed. The Fermi momentum depends on both the density n and the magnetisation s as  $k_F = (n + 2s) = (2a)$ ,  $k_F = (n - 2s) = (2a)$  (the magnetisation is de ned as  $s = (m - m_{\#}) = 2$ , with m = M =L being the density of particles with spin

). In the following, we will consider the zero-eld case where  $k_{F^{"}} = k_{F^{\#}} = n = (2a)$ . Eq. (3) allows it to introduce a H am iltonian density H (x), such that H = H dx. In terms of the right- and left-m overs in (3) the kinetic part of the H am iltonian (1) in a lowest order expansion in a becomes

Here \:" denotes norm alordering. For brevity, the x-dependence of the operators has been dropped. The Ferm i velocity is given by  $v_F \coloneqq 2a \sin(k_F a)$ . The second term in (5) represents backward scattering processes whereas the last term is due to Um k lapp scattering. Only in the half-lled case, where  $k_F = = (2a)$ , is the Um k lapp term non-oscillating and has to be kept in the low-energy elective theory. For all other llings it can be dropped.

To make the Ham iltonian manifestly SU (2) invariant under spin-rotations one can also express H in terms of the following currents [24, 11, 25]:

As far as the interaction part (5) is concerned, we rst consider the case n  $\notin$  1, that is away from half-lling. Then Um klapp scattering can be ignored leading to h H<sub>int</sub> = g<sub>c</sub> :J<sup>2</sup> :+ :J<sup>2</sup> :+ g<sub>s</sub> :J J :+ :J J+: c :JJ :+ :J J : (7)

and coupling constants  $g_c = ua, g_s = 4ua=3, c = 2ua$  and = 8ua.

Taking Eqs. (6), (7) together, we see that the Ham iltonian is a sum of two terms: one depending on the scalar currents  $J; \overline{J}$  only (corresponding to charge excitations) and the second depending on the vector currents  $J, \overline{J}$  (associated with spin excitations).

The charge and spin parts commute,  $[H_c; H_s] = 0$ .

Let us not focus on H  $_{\rm c}$  . The term with coe cient g  $_{\rm c}$  gives rise to a renorm alisation of  $v_F$  , yielding the charge velocity

Note, that in this eld-theoretical approach the Luttinger parameter K  $_{c}$  is calculated only up to the linear order in u. The same is true for  $v_{c,s}$ . Contributions in higher u-order would occur if the perturbational approach is pursued further. Fortunately, the Bethe-ansatz solvability of the model allows it to calculate  $v_{c,s}$ ; K  $_{c}$ exactly [11]. We will come back to this point in the next section.

In H<sub>s</sub>, the g<sub>s</sub>-term leads to a renorm alisation of the spin velocity

The remaining interaction of vector currents is a marginal perturbation. By setting up the corresponding renorm alisation group equations, it turns out that it is marginally irrelevant (relevant) for sgn() < 0 (sgn() > 0) [23, 26]. In our case, = 8ua < 0. The remarkable point about this is that the spin part of the low energy elective H ubbard m odel is identical to the corresponding expression for the X X X - H eisenberg chain [27, 28], whereas the charge part is described by free bosons (away from half

lling). For this case, eld theory has been em ployed [27, 28, 26] to obtain the bulk contribution to the magnetic susceptibility in the form

where E = h;T (magnetic eld or temperature),  $E_0 = h_0;T_0$  is some scale and  $_0 := (T = 0;h = 0)$  is given by the inverse of the spin velocity. For the open X X X -chain, the boundary contributions have been found to be [12, 13, 16]:

From the above considerations we conclude that the bulk and boundary contributions to the magnetic susceptibility in the Hubbard model are also of the form (14)-(17), where, compared to the X X X -model,  $_0, T_0, h_0, _{T;h}, _{T;h}^{(B)}$  are renorm alised by the charge part.

M ost interestingly, the pre-factor of  $_{\rm B}$  remains una ected by the charge channel. The divergent boundary contribution for T  $T_0^{(\rm B)}$  or h  $h_0^{(\rm B)}$  is therefore completely universal

This can be understood as follows: As the charge-and spin-part of the H am iltonian separate at low energies, the only way how the charge channel can e ect the spin channel is by a renorm alisation of  $v_s$  and  $K_s$ . The Luttinger parameter  $K_s$  in the spin sector, however, is xed to  $K_s$  1 due to the SU (2) symmetry and cannot renorm alise. The explicit calculations of the pre-factor of  $_B$  for the X X X -m odel in [12, 13, 16] show, on the other hand, that it does not depend on the spin-velocity  $v_s$ .

It therefore remains completely independent of the lling factor and the interaction strength.

Let us now comment on the scales involved in Eqs. (14), (16), (17). Including the order O (ln  $^{2}$  E) in Eq. (14), this equation can be written as

It is convenient to de ne a new scale E  $_0$  =  ${\rm I\!E}_0 e^{2~\epsilon}$  . Then, again up to the order 0  $\,$  ln  $^2\,E$  , we have

where the term  $\ln^2 E$  has been absorbed in the term  $\ln^1 E$  by the rede nition of the scale. This procedure xes the scale uniquely [26].

One proceeds analogously with Eqs. (16), (17) and obtains

Let us now turn to the half-led case n = 1. The additional Um klapp term in (5) can also be bosonised and is proportional to  $\cos \frac{8}{8}$ . When we now again rescale the eld  $^{0} = ^{P} \frac{K_{c}}{K_{c}}$  we obtain a relevant interaction  $\cos \frac{8}{8} = K_{c}^{0}$  for any nite u > 0 because  $K_{c} < 1$  in this case. This means that the charge sector will be massive. Indeed, at u ! 1, the excitations of the Hubbard model at half lling are exactly those of the X X X -chain [11]. The form ulas (14,16,17) remain valid at half-lling as well. The leading term in Eq. (17), including the constant  $h_{0}$ , was given in [17]. There, a phenom enological argument was found that generalises this result to arbitrary lling. The constant  $h_{0}$  was left undeterm ined in the arbitrary lling case.

# 3. Bethe ansatz

In the fram ework of the Bethe ansatz (BA) solution, the energy eigenvalues of (1) are given in terms of certain quantum numbers, the Bethe roots. These roots have to be calculated from a set of coupled algebraic equations. In the therm odynam ic limit, these algebraic equations can be transformed into linear integral equations for the densities of roots, with the energy being given by an integral over these densities. In this section, the Bethe ansatz solution is rst used to verify the small-coupling expressions for  $v_c; v_s; K_c, cf. Eqs. (10,12,13)$ .

A flerwards, we obtain the magnetic susceptibility at T = 0. Therefore, we rst analyse the integral equations in the small- eld limit, thereby determining the constants in Eqs. (14) (for T = 0). The pre-factor  $_0$  has been calculated by Shiba [9]. Our essential new results are twofold: On the one hand, the leading h-dependence of the bulk-susceptibility is calculated exactly at small elds, including the scale, for arbitrary llings. On the other hand, the result for the boundary susceptibility (17) is con rm ed within the exact solution. How ever, due to cum bersom e calculations, the

constant  $_{h}^{(B)}$  in Eq. (17) is left undeterm ined here. Finally, we consider some special cases and present num erical results.

In order to introduce our notation, we shortly state the main results of the BA solution. For any further details, the reader is referred to [11], which also contains an extensive list of the original literature. The BA solution for the one-dimensional Hubbard model with open boundary conditions has been found by Schulz [29], based on the coordinate Bethe ansatz. The algebraic BA for this model has been perform ed in [30]. The BA equations read

Here, we analyse the groundstate, where the N -m any  $k_js$  and the M  $_{\#}$ -m any  $_1s$  lie on one half of the real axis, except the origin. These equations can be solved analytically in the small coupling limit, cf. Appendix A. However, this solution has to be treated with care. It has been shown in [31] that a small-coupling expansion of the ground-state energy in the therm odynam ic limit has zero radius of convergence. This does not come as a surprise when considering again the low energy elective theory presented in Sec. 2: At u = 0 the interaction of vector currents in Eq. (9) changes from marginally relevant to marginally irrelevant. Thus in the following we perform the therm odynam ic limit before considering any smalled or small-coupling approximations and compare with the results of Appendix A afterwards.

In the therm odynam ic lim it, one can set up equations equivalent to (27), (28), by introducing the density of ps, (k), and the density of s, (v). These densities are solutions to the following set of coupled linear integral equations [29, 14]

#### 3.1. Velocities and Luttinger parameter

Before proceeding further, we rst make contact with the eld-theoretical results (10,12,13) in the previous section. Since these concern only bulk-quantities, we discard the 1=L-corrections in this subsection. We also set the lattice parameter a 1 here.

Furtherm ore, the results (10,12,13) have been obtained for densities n  $\pm$  1 (such that both the charge and spin channels are massless). Analogously, we restrict ourselves here to densities away from half-lling. W ithin the BA, charge- and spin-velocities are calculated as



The susceptibility  $_{\rm c} = 0$  n in turn can be expressed by  $^{0}(k) j_{k=B}$ , (B) and a related function [32]. Although the analytical solution of the integral equations in the lim it u ! 0 is di cult to obtain due to singular integration kernels, these equations can be solved numerically to high accuracy. Figs. 1, 2 show the velocities and the Luttinger parameter at di erent llings as a function of u, together with the analytical predictions (10,12,13) for sm all u. A greem ent is found in all cases.



## 3.2. Spin susceptibility

Our aim is to perform a low – eld expansion, i.e. an expansion around s = 0. From Eq. (38), this corresponds to an asymptotic expansion of (v > B = 0). This expansion is done by generalising Shiba's approach [9], who calculated  $_0$  for pbc in a di erent way than via the spin velocity.

Let us estimate the error involved in the above approximations. We will see later that B ln h for small magnetic elds h. Corrections to the rst term in Eq. (54) are higher-order exponentials and thus would add terms  $h^{2n}$  to the susceptibility (the term taken into account here yields a constant contribution  $h^{2}$ ). In the second term, higher-order algebraic terms have been dropped. These would contribute in order  $1=(h h^{n} h), n > 3$ , to the boundary susceptibility. The expected result (17) shows that all these term s are negligible for our purposes. The same holds for Eq. (57).

W e continue and treat the bulk and boundary contributions separately.

# 3.3. Bulk contribution

For the bulk, the quantities  $I_{Q;bulk}^{(\)}$  ( = 1;2) and the function  $P_1$  (v) have to be calculated. The crucial observation is that Eq. (59), which determ ines  $P_1$ , is well known in the study of the spin-1/2 X X X -H eisenberg chain: Exactly the same function determ ines the T = 0 susceptibility in that model, cf. # 3.4. Boundary contribution

Let us go back to Eqs. (54), (58). The boundary contribution is calculated by plugging these equations into Eqs. (50), (51). The resulting expression is lengthy and we do not write it down here. We rather apply the approximation to neglect terms of the order

where  $P_2$  is given by Eq. (60). Note that the only dimension with respect to the bulk is the dimension of s on B, cf. Eq. (79). (65), cause a logarithm is divergence in the magnetisation: 1=B = 1=h(h), yielding the divergence indicated in Eq. (17). where  $h_c$  is the critical eld above which the system is fully polarised,  $s_{bulk}$  (h  $h_c$ ) = n=2, [11]. (82), (83) are consistent with known results for the X X X -chain with coupling constant J = 1=u:

The small coupling limit is technically more involved: The integration kernels in the integral equations become singular. A numerical evaluation of  $_0$  (u) (see section 3.6 below) con m s the eld-theoretical prediction Eq. (A 15). As far as the scale  $h_0$  is concerned, it is clear that it must diverge for u ! 0: Exactly at the free-ferm ion point u = 0, the logarithm ic corrections in Eq. (14) vanish altogether; corrections to  $_0$  at u = 0 are algebraic with integer powers. The leading contributions  $h^2$ ;  $T^2$  for u = 0 are calculated in the Appendix, cf. Eqs. (B 1, B 2, B 5, B 6).

To describe the divergence of  $h_0 j_{1:0}$  quantitatively, consider 1st the half-lling case where  $h_0 \in e^{\text{onst=u}}$ . From the general expressions of  $I_{Q,\text{pulk}}^{(1,2)}$ , Eq. (55), it is clear that this is the case for arbitrary lling. Thus in the small-coupling limit, the nite-eld susceptibility is obtained from Eq. (14) with jlnhj jlnh\_0 j i.e.  $h_0 = h_1 = h_0 = \exp[1=u]$ :

#### 3.6. Num erical results

In order to compare the low – eld expansion Eqs. (69), (80) to the outcome of the non-approximated integral equations (29), (30), we rst compute  $_0$ ,  $h_0$  numerically. To do so, we follow Shiba [9] and rewrite the quantities  $Q_0 e_0$ ;  $Q_0 n_0$  as solutions of linear integral equations. Namely, from Eqs. (33), (32),

where  $Q_Q$  (k) is obtained from Eqs. (29), (30) at h = 0 (i.e. B = 1):




Figure 3. The susceptibility  $_{bulk}$  over u at densities n = 0.2;0:3;0:4;0:5;0:7;1 (from top to bottom at u = 0). A similar gure has been shown by Shiba [9]. Here, we additionally compare with the eld-theory result at smallu (A 15) (blue dashed lines) and with the X X X -lim it (for better comparison the inset shows the same gure on a larger scale; the n = 1-line is printed bold here).

These linear integral equations, together with Eqs. (73), (74), are solved num erically. The result for  $_0$  as a function of u for di erent llings is given in Fig. 3, together with the small-u expansion (A.15) and the X X X -lim it. We checked num erically




Figure 4. The scale  $h_0$  over u for n = 0.2;0:3;0:4;0:5;0:7;1:0 (from bottom to top). In a), the large-coupling result Eq. (82) is veri ed; in b), the sm all-coupling form ula Eq. (87) is visualised (dashed lines).

that this way of obtaining  $_0$  is equivalent to calculating  $v_s$  from Eq. (34) and then using Eq. (15). The scale  $h_0$  as a function of u at di erent llings is depicted in Fig. 4. Besides con m ing the small-coupling result Eq. (86), we observe that the numerical data are well described by assuming the following form of the constant of proportionality in Eq. (86):

The exponent is exact (cf. Eq. (86)), the constant is conjectured from observing good agreement with the numerics, cf. Fig. 4. Having calculated  $h_0$ ,  $_0$ , the next step consists in nding (h) numerically and comparing with Eqs. (69), (80). The calculation of  $_{\rm bulk}$  (h) is described in [11] (appendix to chapter 6). The idea is to rewrite the energy in terms of dressed energy functions (rather than in terms of dressed density functions like in Eqs. (29),(30)). The magnetic eld enters the linear integral equations for the dressed energy functions. Once these equations are solved, both the eld and the magnetisation are determined. By varying slightly the integration boundaries while keeping the density xed, one performs a numerical derivative s= h to obtain . The results shown in the sequel demonstrate that this procedure is highly accurate.




Figure 5. The bulk susceptibility for n = 0.2 in a) and for n = 1 in b) at u = 1;2;10 (from bottom to top). The dashed blue curves are the analytical result (69). The diam onds indicate  $_0$ , showing the decrease of the scale  $h_0$  with increasing u.

Fig.5 shows  $_{bulk}$  for densities n = 0.2; 1 at di erent couplings, together with the analytical result (69). The boundary contribution  $_{B}$  (h) can be calculated sim ilarly to  $_{bulk}$  (h) as sketched above, because the equations are linear in the 1=L contribution.




Figure 6. The boundary susceptibility  $_{\rm B}$  (h) for u = 1 in a) and for u = 10 in b) with n = 0.2;1 (from top to bottom). The dots are the num erical data, the lines the asymptotic form (17) where  $h_0^{(B-)}$  has been determined by a t. The insets show  $_{\rm B}$  h  $\ln^2$  h, the red horizontal line denotes the asymptotic value 1=4.

Results for u = 1;10 and densities n = 0.2; 1 are shown in Fig. 6.

# 4. Friedel oscillations

Due to the open boundary conditions, translational invariance is broken. This m eans that one-point correlation functions like the density or the magnetisation will no longer be just constants but rather become position dependent. In particular, they will show characteristic oscillations near the boundaries, the so called Friedel oscillations [22]. These oscillations are expected to decay algebraically with distance x from the boundary, nally reaching the mean density or magnetisation, respectively, for x! 1. From a eld-theoretical point of view, such a one-point correlation function can be obtained from the holom orphic part of the corresponding two-point function [34]. We therefore rst recall here the asymptotics of two-point functions in the Hubbard model according to [35, 11]. After that, we will derive the one-point correlation functions for the density n(x) and the magnetisation  $s^{z}(x)$ . This will then allow us to obtain the local susceptibility (x). By a conform alm apping we will generalise our results to sm all nite tem peratures. A s nuclear m agnetic resonance Knight shift experiments yield direct access to (x), the predictions obtained here about its position, tem perature as well as density dependence should be valuable for experiments on one-dimensional itinerant electron systems. To test our conformal eld theory results, we present som e num erical data based on the density-m atrix renorm alisation group applied to transfer m atrices (TMRG).

## 4.1. Two-point functions

In the following, we content ourselves with stating the results for the asymptotics of pair-correlation functions, without giving any derivations. For any further details, the reader is referred to [11, 35]. We also restrict ourselves to the case n  $\pm$  1, i.e., we do not consider half-lling. The reason to do so, is that at half-lling the charge sector is massive and the correlation functions will be identical to those of the H eisenberg m odel up to the amplitudes and the spin velocity which do depend on u. The local m agnetisation and susceptibility for this case, however, have already been discussed in [36, 15].

The Hubbard model away from half-lling has two critical degrees of freedom with di erent velocities and the low-energy elective theory outlined in section 2 is therefore not Lorentz-invariant. As the spin and charge excitations are independent from each other we can, how ever, still apply conform all eld theory in this situation based on a critical theory which is a product of two V irasoro algebras both with central charge c = 1. D ue to conform all invariance, the exponents of the correlation functions of prim ary elds can then be obtained from the nite-size corrections of low -lying excitation energies for the nite system. These in turn can be calculated exactly via B ethe Ansatz. Then the remaining challenge is to relate the prim ary elds to the original elds of the model. This goal can be achieved by considering the selection rules for the form factors involved and by using additional restrictions obtained from the B ethe ansatz solution for the nite size spectrum [35].

In this situation, the correlation function of two prim ary elds at zero tem perature is given by (we include here the dependence on the imaginary time  $\)$

## 4.2. One-point functions in the open system

Note that we have ignored logarithm ic corrections to the algebraic decay of the correlation functions throughout this section. Multiplicative logarithm ic corrections will be present due to the marginal operator in (9). These corrections have been discussed for the leading term in (91) in [37].

## 4.3. Num erical results




Figure 7. TM RG data (black circles) for the local magnetisation  $hs^{z}$  (x) i where u = 1:0;T = 0:131;s = 0:037 and n = 0:886. In comparison the eld theory result (93) is shown (blue squares) where the amplitudes and phases have been determined by a t.

To calculate num erically the localm agnetisation  $s^{z}(x)$  and susceptibility (x) at nite tem peratures we use the density-matrix renormalisation group applied to transfer matrices (TMRG). The advantage of this method compared to Quantum -Monte-Carb algorithms is that the thermodynamic limit can be performed exactly. This is particularly helpful in the present situation where we want to study boundary e ects, i.e., corrections which are of order 1=L compared to bulk quantities. The method is explained in detail in [38, 39, 15]. Here we concentrate on the localm agnetisation for h  $\notin$  0 and on the local susceptibility for h = 0, both times for generic lling n  $\notin$  1. In Fig. 7 TMRG data for hs<sup>z</sup>(x) i are shown in comparison to the ekd theory result (93). Here the exponents and velocities have been determined exactly by the Bethe ansatz solutions Eqs. (90,34) whereas the amplitudes and phases have been used as tting

param eters. The agreem ent is very good. In particular, the exponential decay of the correlation function is correctly described by the exponents and velocities obtained by Bethe ansatz. The surprisingly rich structure of  $hs^{z}(x)i$  is caused by a competition between the rst three terms in (93) which oscillate with di erent wave vectors but have similar correlation lengths given by  $_{1} = 1:906; _{2} = 1:903$  and  $_{3} = 1:708$  (the correlation lengths  $_{1}$  should not be confused with the matrix ^ in (90)).




Figure 8. TMRG data (black circles) for the local susceptibility (x) where u = 1:0;T = 0:131;s = 0:0 and n = 0:886. In comparison the eld theory result (95) is shown (blue squares) where the amplitudes and phases have been determ ined by a t.

In Fig. 8 the local susceptibility for the same set of parameters as in Fig. 7 but zero magnetisation is shown. The TM RG data are again compared to the eld theory result (95) and good agreement is found. Here only the rst term of (95) has been taken into account because the correlation length belonging to the second term is small compared to that of the rst one.

# 5. C onclusions

We studied the low-energy them odynam ic and ground-state properties of the onedimensional Hubbard model with open ends. In particular, we concentrated on the bulk and boundary parts of the magnetic susceptibility. Based on the low-energy e ective theory for this model we argued that the functional form of  $_{bulk;B}$  (h;T = 0) and  $_{bulk;B}$  (h = 0;T) is universal, i.e., does not depend on lling n or interaction strength u. For the bulk susceptibility only the zero temperature and zero eld value  $_{0} = (2 v_{s})^{-1}$  depends on n;u via the spin-wave velocity  $v_{s}$  as does the scale E  $_{0}$ appearing in the logarithm s. For E  $_{0}$  with E = T;h, however, the scale is not

in portant and the bulk susceptibility becomes

For the boundary part we even nd that the result for T = 0,  $h = h_0$

are completely universal. In particular,  $_{\rm B}$  (T = 0; h) and  $_{\rm B}$  (T; h = 0) are identical to the results obtained for the Heisenberg model [12, 13]. The same expression for  $_{\rm B}$  (T = 0; h) has also been obtained for the supersymmetric t  $_{\rm J}$  model [18]. The universal behaviour of  $_{\rm B}$  at low energies has nothing to do with the special properties making the Hubbard model integrable. Instead, the universal behaviour will hold for any system whose low energy elective theory is identical to the one for the Hubbard model described in Sec. 2. Therefore even in a generic itinerant electron system , non-magnetic impurities or structural defects can give rise to a Curie-like contribution to the magnetic susceptibility. This has profound consequences for experiments on

such system s, where a Curie term in the susceptibility is often assumed to be directly related to the concentration of magnetic in purities in the sample. In the light of the results presented here a more sophisticated analysis is necessary. In particular, the temperature dependence of the Curie constant has to be analysed carefully - in the case of a boundary considered here the Curie constant will show a logarithm ic dependence on temperature. In addition, it m ight be useful to investigate if the Curie contribution can be reduced by annealing as one would expect if it is caused by structural defects.

Based on the Bethe ansatz solution for the Hubbard model at zero temperature we have been able to calculate  $_{bulk}$  exactly beyond the limit h  $h_0$  by determining the scale  $h_0$  for arbitrary lling. In addition, the exact solution has con med that the bulk and boundary parts show indeed the universal functional dependence on magnetic eld which has been obtained by the low-energy elective theory.

For the Friedel oscillations in magnetisation and density caused by the open boundaries we have derived an asymptotic expansion by making use of conformal invariance. We have also calculated the local susceptibility near the boundary which is a quantity directly measurable in nuclear magnetic resonance K night shift experiments. We con meed our results by comparing with numerical data obtained by the density-matrix renormalisation group applied to transfermatrices.

# Appendix A . Sm all-u expansion

The Bethe ansatz equations for a nite system are expanded with respect to the coupling constant at sm all couplings, in analogy to the model of an interacting Ferm i gas [40]. Before turning to the open boundary case, we rst perform this expansion for periodic boundary conditions. The comparison with open boundary conditions yields the surface energy in this approximation.

It is important to note that Eq. (A 13) has been derived at nites, in the limit of vanishing u. In the limit of small elds, s / h, and thus the small-eld expansion of (A 13) reads

with s = s(h). The order of the limits is important here: The small-coupling limit has been taken before the smallh-limit. That is, Eq. (A 14) is valid at small but still nite elds, where the eld-dependent term shave been neglected (in the main part, cf. Eq. (84), a lower bound on the eld is given in terms of the scale  $h_0$ , namely  $h = 1=h_0$ ). These singular limits are due to the non-analytic behaviour of  $h_{bulk}$  as a function of the magnetic eld in the therm odynam ic limit, cf. Eq. (17).

The result for  $_{bulk}$  (h ! 0;u > 0), that is, with interchanged limits compared to Eq. (A.14), is obtained from the low-energy elective Ham iltonian given in section 2:

If the boundary susceptibility is derived from this expression as in the previous section, one would obtain a constant depending on n and u only. This result cannot be related to Eq. (17), showing again the non-commutativity of diverse limits at  $u \in 0$ .

# Appendix B.Free Ferm ions

In this section we give  $_{bulk}$ ,  $_{B}$  for free ferm ions (u = 0) in the low-energy lim it. The corresponding quantities are marked by an index <sup>(ff)</sup>.

At T = 0, (ff) (h) is directly obtained from Eqs. (A.10) (the bulk part) and (A.20), both at u = 0, with the magnetic eld given by  $h = G_{s}e$ . In the small-eld limit, one obtains

To calculate the susceptibility at nite temperatures, one starts with the free energy per lattice site  $f^{(ff)}$ ,

As in the T = 0-case,  ${}^{(ff)}_{bulk} = {}^{(ff)}_{B}$  for n = 1 only.
