# W eak chaos and $m$ etastability in a sym plectic system of many long-range-coupled standard maps

#### Abstract

W e introduce, and num erically study, a system of N sym plectically and globally coupled standard m aps localized in a $d=1$ lattice array. T he global coupling is m odulated through a factor r , being $r$ the distance betw een $m$ aps. Thus, interactions are long-range (nonintegrable) when $0 \quad 1$, and short-range (integrable) when $>1 . W$ e verify that the largest Lyapunov exponent m scales as $\mathrm{m} / \mathrm{N}$ ( ), where ( ) is positive when interactions are long-range, yielding weak chaos in the them odynam ic lim it N ! 1 (hence m! 0). In the short-range case, ( ) appears to vanish, and the behaviour corresponds to strong chaos. W e show that, for certain values of the control param eters of the system, long-lasting $m$ etastable states can be present. $T$ heir duration $t_{c}$ scales as $t_{c} / \mathrm{N}$ ( ) , where ( ) appears to be num erically consistent w ith the follow ing behavior: $>0$ for $0<1$, and zero for 1 . A ll these results exhibit $m$ ajor conjectures form ulated w ith in nonextensive statisticalm echanics (N SM). M oreover, they exhibit strong sim ilarity betw een the present discrete-tim e system, and the $-X Y \mathrm{H}$ am iltonian ferrom agnetic $m$ odel, also studied in the fram e of N SM.

## I. IN TRODUCTION

T he study of com plex system s has been lately one the m ost active areas of investigation. This $m$ ultidisciplinary sub ject has interest in naturalsciences as w ell as in social and arti cial system s . In physics, a m a jor area involved is statistical $m$ echanics. It is precisely for such system $s$ that nonextensive statistical m echanics (NSM) [1] [1] appears to have its applicability. Typical features present in com plex system s are long-range interactions, long-term m em ory, fractalphase-space structure, scale-free netw ork structure, or even com binations of these characteristics. Q uite frequently these system s cannot be correctly described by the well-established Boltzm ann-G ibbs statis-

[^0]ticalm echanics (BG SM). Indeed, they often fail to verify its basic assum ptions (equiprobability of phase-space occupation $\left.{ }^{[12}\right]$ and ergodicity $\left[\begin{array}{ll}{[1]}\end{array}\right]$ at the them al equilibrium state). N SM generalises the usualBG SM form alism through the de nition ${ }_{R}$ of the $q$-entropy $S_{q} \quad \frac{1 d x[p(x)]^{q}}{q 1}$ (w th $S_{1}=S_{B G} \quad d x p(x) \ln p(x)$, where B G_ stands for Boltzm ann-G ibbs) under sim ple constraints $\left[\begin{array}{l}{[4]}\end{array}\right]$.

This theory has been extensively applied to nonlinear
 m ost w idespread and usefiul ways for $m$ odelling com plex phenom ena. For exam ple, H am iltonian system s are at the core of physics and consequently their relevance is evident. There has been an im portant num ber of results indicating that certain conservative $m$ odels (e.g., the -
 -Lennard-Jones-like gas [12'1) can present a behaviour departing from the one predicted by the BG form alism. For certain classes of initial conditions and param eters, the system is prevented from virtually attaining its ex-
pected equilibrium state in nite time when $N$ ! 1 . In other words, if the N ! 1 lim it is taken before the t! 1 lim it, the system becom es nonergodic. This nonergodicity is also re ected in a variety of anom alous behaviours such as non-G aussian $m$ om enta probability density functions, negative speci c heat, aging, and others $[1], 1], 1]$ pler) nonlinear dynam ical system $s$, as for exam ple $m$ aps, have em erged in $m$ any contexts, very often exhibiting new and interesting results. Am ong these system $s$ we nd the logistic $m a p$, the standard $m$ ap, coupled $m$ ap lattices, discretised Lorentz gas, and $m$ any others [ $\left.1 \bar{T}_{1}^{1}\right]$. B oth low - and high-dim ensionaldiscrete-tim e dynam ical system s have been studied under the fram ew ork of N SM, exhibiting various connections w ith Ham iltonian dynam ics [18, 19,

It is known quite well that the number of degrees of freedom of a system de nes the possibilities that its dynam ics $m$ ay approach. A clear ilhustration of this fact in low-dim ensional system s (e.g., the 2-dim ensional C hirikov-T aylor standard $m$ ap) is the K AM tori, a com plex structure in the $m$ ap phase-space that separates chaotic from regular regions. W hile $m$ uch is known for system s with few degrees of freedom, the situation is $m$ ore intricate when $m$ any elem ents are involved. T his is because the phase-space grows in an extrem ely rapid $m$ anner. In addition to this, studying continuous-tim e $m$ any-body system $s$ can tum out to be very di cult, if not im possible at all, due to the considerable com putational tim e needed to integrate the evolution equations. $T$ his is even $m$ ore so when long-range forces are involved, as it is not justi ed to neglect any interaction betw een the elem ents.

An altemative for this problem is the substitution of the continuous-tim e system for sim pler discrete-tim e system $s$, such asmaps, which conserve $m$ any of the im portant features of the physics involved. This substitution is in fact justi ed interpreting a dim ensional map system as the intersection (in the Gibbs phase-space) of a Poincare plane w th the orbit of a higher dim ensional H am iltonian. M ore precisely, if we consider a tim e-independent H am iltonian system with $(\mathbb{N}+1)$ degrees of freedom ( $2 \mathrm{~N}+2$ )-dim ensional phase-space), a ( 2 N )-dim ensional sym plectic m ap is the result of taking a Poincare section over the constant energy hypersurface $\left[\bar{l}_{1}\right]$. The recurrence tim $e$ is discrete and the $m$ ap is usefiul in displaying various properties of the original H am iltonian system .

N SM concepts have been show $n$ to have an im portant role in low-dim ensionalm aps at the edge of chaos. T he archetypical logistic $m$ ap (a $D=1$, dissipative, nonlinear $m \mathrm{ap}$ ) is one of the m ost $w$ idely studied dissipative system s . In part due to its sim plicity, it is often used to illustrate $m$ any of the $m$ ost im portant features of chaos. In recent works, R obledo and Baldovin [21] have analytically proved, using standard renorm alisation-group techniques, that the dynam ics of the logistic $m$ ap at its critical point is unm istakenly well-described w thin
a NSM frame. The sensitivity to initial conditions is a $q$-exponential function $[2 \overline{2}-1$, and is related to the entropy production through the q-generalised Pesin-like identity, linking the sensitivity to initial conditions to the q-entropy $S_{q} w$ th $q=0: 2445:::$. M oreover, the logistic-m ap with noise (a Langevin-like generalisation of the usual logistic $m \mathrm{ap}$ ) has been found to present tw o-step relaxation processes and aging (presenting_interesting com $m$ on points $w$ th slow glassy dynam ics [ $[2 \overline{2}]$ ]. O ther aspects of the N SM form alism were also studied in them ore generalcase ofone-dim ensionalz-logistic_fam ily ofm aps considering the attractor fractal nature [24]. Regarding two-dim ensional ( $(\mathrm{D}=2$ ) dissipative system s (as the $H$ enon $m$ ap or its linearised version, the Lozim ap), results indicate that it presents the sam e value of $q$ as the logistic m_ap, therefore suggesting a com $m$ on universality class [2] 먹. Regarding two-dim ensional $(\mathbb{D}=2)$ conservative $m$ aps, a very interesting exam ple, the triangle $C$ asati-P rosen $m$ ap ( $m$ ixing, ergodic, but $w$ ith vanishing Lyapunov exponent), has been recently been studied in connection to the entropy $S_{q} w$ ith $q=0$ [6].

M oving further into conservative discrete-time system s , tw o-step relaxation has been also observed at the edge of chaos for the Chirikov-Taylor standard $m$ ap, a paradigm atic one for 2 -dim ensional sym plectic $m$ aps. This $m$ ap has been thoroughly_studied and explained by $m$ eans of the KAM theorem [ $\left.]_{1}\right]$. $T$ his $m$ ap is know $n$ to be area preserving, hence its variables are often considered as \coordinate" and $\backslash \mathrm{m}$ om entum ", in analogy w ith H am iltonian system s . A long this lines, it is appealing to look to the $m$ ore general case of a sym plectic system of N coupled standard m aps ( $\mathrm{D}=2 \mathrm{~N} ; \mathrm{N} \quad 1$ ). Dierent e orts were done for values of N as low as $\mathrm{N}=2$ up to $\mathrm{N}=500\left[20_{1}^{2}, 2\right.$ relaxation $w$ as found as w ell as other features pointing to a NSM applicability. But in all these cases, the coupling $w$ as done trough the $m$ om entum variables. Even though this has its ow n interest, it w ould be instructive to see the e ects of coupling such a system through the coordinate variables, as in $m$ ore realistic situations.

In this work we will study a high-dim ensional globally coupled conservative $m$ ap system that, as discussed above, presents $m$ any of the characteristics of $H$ am iltonian dynam ics. O ur purpose is to contribute to the understanding of the role that N SM plays in the anom alous features present in long-range-interacting dynam icalsystem s. O ur results show interesting sim ilarities betw een this $m$ ap $m$ odel and $m$ any-body long-range-interacting H am iltonian dynam ics, in particular the -X Y m odel. In both cases, long-lasting m etastable states, as w ellas w eak chaos, are present in the them odynam ic lim it. B oth features point out that under certain initial conditions, orbits do not visit w ith equalprobability the entire phase space, or in other words there is a failure in ergodicity.

In the next section we introduce and describe the m odel, as well as som e relevant details of our sim ulations. In section 'IIITw w present our num ericalresults. W e report on the scaling behaviour of the largest Lyapunov expo-
nent w ith the system size $N$, and point out connections w ith H am ittonian dynam ics. W e analyse the relaxation to equilibrium, and we m ake a system atic characterisation as a function of the system param eters. Finally, a discussion and sum $m$ ary are presented in section ' 'IV…

## II. M ODEL

O urm odel is a set of N sym plectically coupled (hence conservative) standard $m$ aps, where the coupling is $m$ ade through the coordinates as follow s:

$w$ here $t$ is the discrete tim e $t=1 ; 2 ;:::$, and 0. The a param eter is the usual nonlinear constant of the individualstandard $m$ ap, whereas the b param eterm odulates the overallstrength of the long-range coupling. B oth param eters contribute to the nonlinearity of the system; it becom es integrable when $a=b=0$. For sim plicity, we have studied only the cases $a>0, b>0$, but we expect sim ilar results w hen one or both of these param eters are negative. T he system atic study of the whole param eter space is certainly welcom e. N otice that, in order to describe a system whose phase space is bounded, we are considering, as usual, only the torus (mod 1). A dditionally, the $m$ aps are localised in a one dim ensional ( $d=1$ ) regular lattioe w ith periodic boundary conditions. The distance $r_{i j}$ is the $m$ inim distance betw een $m$ aps i and $j$, hence it can take values from unity to $\frac{N}{2}$ ( $\frac{N-1}{2}$ ) for even (odd) number $N$ of $m$ aps. Note that $r_{i j}$ is a xed quantity that, m odulated w ith the power , enters Eq. [11) as an e ective tim e-independent coupling constant. A s a consequence, regulates the range of the interaction betw een m aps. $T$ he sum is global (i.e., it includes every pair of m aps), so the lim iting cases $=0$ and $=1$ correspond respectively to in nitely long range and nearest neighbours. In our case $d=1$, thus $0 \quad 1$ ( > 1) m eans long-range (short-range) coupling. M oreover, the coupling term is norm alised by the sum $\left[\bar{g}_{1}, \overline{2} \overline{2}_{1}^{2}\right] N \quad \mathrm{~d}_{1}{ }^{1=\mathrm{d}} \mathrm{dr} \mathrm{r}^{\mathrm{d}}{ }^{1} \mathrm{r}=\frac{\mathrm{N}^{1}=\mathrm{d}}{1=\mathrm{d}}=\mathrm{d}$, to yield a non-diverging quantity as the system size grow s (for sim plicity, we have replaced here the exact discrete sum over integer $r$ by its continuous approxim ation).

If $G(x)$ denotes a $m$ ap system, then $G$ is symplectic when its Jacobian $@ G=@ x$ satis es the relation [171]:

I being the $\mathrm{N} \quad \mathrm{N}$ identity m atrix. A consequence of Eq. (Zli) is that the Jacobian determ inant $j 0 \mathrm{G}=@ \times j=1$; indicating that the map G is (hyper)volum e-preserving. In particular, for our $m$ odel

This quantity, multiplied (from the right side) by the $m$ atrix ([4) yields J. Therefore our system is sym plectic. Consequently, the 2 N Lyapunov exponents 1
м ; 2; 3 ;::; 2N are coupled tw o by tw o as follow s: $1_{1}=$

In other words, as a function of time, an in nitely sm all length typically diverges as e ${ }^{1 t}$, an in nitely sm all area diverges as $\left.e^{(1+}{ }^{2}\right) t$, an in nitely $s m$ all volum e diverges as $\left.e^{\left({ }^{1+}\right.}{ }^{2+}{ }^{3}\right) \mathrm{t}$, an in nitely sm all N -dim ensional hy-

For exam ple, a ( $2 \mathrm{~N} \quad 1$ )-hypervolum e diverges as $\mathrm{e}^{\mathrm{t}}$, and nally a 2 N hypervolum e rem ains constant, thus recovering the conservative nature of the system (of course, this corresponds to the Liouville theorem in classical H am iltonian dynam ics).

For $=0$, sim ilarm odels exist in the literature though in di erent contexts $\left[129_{1}^{\prime}\right.$ choice for the coupling $w$ as $m$ ade $w$ th the purpose of com parison w ith $m$ any-body $H$ am iltonian system $s$. Indeed, one can derive the $m$ ap set of equations (1) by applying a discretisation procedure to the -XY m odel $w$ ith an extemal eld (for $m$ ore details see $\left.\left[17_{1}^{\prime \prime}, \overline{3}_{1}^{1}\right]\right)$. As a consequence of having $N \quad 1$ term $s$ in the coupling sum $m$ ation and the fact that there are N m aps, the sim ulation tim es are of order $O\left(\mathbb{N}^{2}\right)$. For this reason it is a di cult task to num erically sim ulate ( Íl $_{1}^{\prime}$ for large values of N. To overcom e this problem, we used an algorithm that takes advantage of the sym $m$ etry of the lattice [32, ${ }^{2}$ ] $]$ and shortens the simulation tim e to $O(N \ln N)$.

In itial coordinates and $m$ om enta were random ly taken from the follow ing uniform distributions: i 2 [ 0
; $\left.0^{+} \quad\right]$ and $\mathrm{p} 2\left[\mathrm{p}_{0} \quad \mathrm{p} ; \mathrm{B}+\mathrm{p}\right]$. For the coordinateswe used $0=\quad=0: 5$ (i.e., i $2[0 ; 1]$, hom ogeneous coordinate initial conditions). For the $m$ om enta, we concentrated in tw o cases. To study the sensibility to initial conditions we used a uniform distribution over the whole phase-space ( $p_{0}=0: 5$ and $p=0: 5$ ). In the analysis of the relaxation to equilibrium we used a thin waterbag intial condition w ith $\mathrm{p}_{0}=0: 3$ and $\mathrm{p}=0: 05$. W e also checked inhom ogeneous in itial conditions, in particular $p_{0}=0=0: 3$ and $p=\quad=0: 05$ (not show $n$ in this paper). N ote that in this case there is no traslational sym $m$ etry in the coordinates. For su ciently long tim es, our sim ulation syield the sam e sensitivity to in itialconditions that we obtain for the sym $m$ etric case i $2[0 ; 1]$. On the other hand, this inhom ogeneous initial condition in the coordinates has an im portant in uence in the shape of the relaxation to equilibrium . This will be further com $m$ ented in the next section. W e note that the system atic study of the role of initial conditions is very instructive, but it is out of the scope of the present work.

## III. RESULTS

## A. Sensitivity to in itial conditions

In order to analyse the sensibility to initial conditions, we num erically studied the largest Lyapunov exponent (LLE ) for di erent values of param eters $a, b$, and $N$. W e used the well-known $m$ ethod developed by Benettin et al [331]. A s a consequenœ of the sym plectic structure of (11), the Lyapunov spectrum in the 2 N -dim ensionalphase space of the $m$ ap is, as already discussed, characterised by $N$ pairs of Lyapunov coe cients, where each elem ent of the pair is the negative of the other. T herefore, the LLE sets an upper bound for the absolute value of the entire spectrum of exponents.

W e concentrated on the evolution ofthe LLE fordi erent values of N starting w ith $0=0: 5, \quad=0: 5 ; 0=0: 5$ and $p=0: 5 ; 8$. In a typical (su ciently long) realisation, the nite-time LLE, $\quad$, is a good estim ator for the analytical de nition of the LLE (both quantities
 realisations (typically 100) in Order to have sm allstatistical uctuations. W e checked that, for appropriately long tim es, $m$ does not depend on the initial conditions [3251].

In $F$ ig. ${ }^{1} 1 \mathbf{1} 1 \mathrm{l}$ we show the N -dependence of m for typical values of the interaction-range param eter, and xed values of param eters $a=0: 005 ; b=2$. O ur results show that the value of $m$ vanishes $w$ ith increasing value of N (consequently, so does the rest of the Lyapunov spectrum ) as a power-law m N () for / 1, and is a positive constant for $>1(0)$. In the inset we detail asa function of . This show $s$ that the $m$ ap system is weakly chaotic for long-range coupling ( m ! 0 when N ! 1 ), whereas for short-range interactions, m rem ains positive for all $N$, m eaning strongly chaotic dynam ics (as expected $[\overline{3} \overline{6}, \overline{3}, \overline{3} / 1])$. Interestingly, this result is totally sim ilar to the one num erically m easured and analytically predicted for the $-X Y \mathrm{~m}$ odel $\overline{1} \overline{8} \overline{1}$, thus suggesting equivalent behaviours. Indeed, and as stated by A nteneodo and Vallejos, this scaling is typical of system s $w$ th couplings of the form $1=r$ [ $[$ [d]. P relim inary sim $u$ lations suggest that the fact that the w eak chaos region extends slightly over $=1$ is an expected consequence of nite-size and nite-tim ee ects.
$T$ he dependence of $m$ with the nonlinear param eter a for di erent ranges of the interaction is shown in F ig. in. We can see that, for $<1$, $m$ decreases $w$ th a and saturates for a 1 . $T$ his ilhustrates the in uence of this nonlinear term. For increasing $a$, the sensibility to in itial conditions raises. On the other hand a has alm ost no e ect when $>1$, where the $m$ is approxim ately constant on the whole a-range. $W$ e veri ed that for a $>1$ a slight increase appears for $>1$ (as in the long-range

case), but this e ect is negligible.

In Fig. 盉 we exhibit the dependence on the coupling param eter b, also varying . Forhigh vahes ofb (b 1), $\mathrm{m}=\mathrm{c}() \mathrm{b}^{0: 63} 8$, being $\mathrm{c}($ ) a nonlinear function. Prelim inary sim ulations show that this exponent varies only slightly $w$ th $a$ and $N$, suggesting that it $m$ ay be unique. In the case $b=0$, we veri ed that $m=0 ; 8$. For $>1$ this scaling is valid even for $b 1$. On the other hand, if $<1$, a deviation from this power-law behaviour em erges when b 1 .

O ur characterisation ilhustrates the fact that, quite
generically, the sensibility to initial conditions is strongly govemed by the range of the interactions. Orbits are clearly chaotic in the short-range case (as expected) and strong num ericalevidence ofvanishing LLE em erges when interactions are long-range, revealing a weakly chaotic regim e.

O ur present results for the $m$ axim al Lyapunov exponent can be approxim atively sum $m$ arised as follow $s$ :

where $0 \quad a \ll 1 ; 0 \quad b / 2 ; N \gg 1, \quad 0$, and $f(b)$ is som efunction of ( $b ;$ ) (e.g., $f(b) / b^{0: 63}$ for $>1$ ).
B. Tem perature evolution

A s stated above, system $\overline{11}$ ) is sym plectic, hence (hyper)volum e preserving, like H am iltonian system s. A consequence of this is that $m$ ay be intenpreted as a $100-$ ordinate" variable and $p$ as the conjugate $\backslash \mathrm{m}$ om entum ". W e may de ne a concept analogous to a tem perature as tw ice the $m$ ean $\backslash$ kinetic energy" per particle [12, $\left.2_{2}^{2} 1\right]$,

where h:::i denotes an ensem ble average. This quantity can be interpreted as a dynam icalanalog, and plays a role sim ilar to the physical tem perature. W e refer to as the $B G$-tem perature, $T_{B G}$, the tem perature associated $w$ th an uniform ensemble distribution in phase space. This quantity $m$ ay be analytically calculated,

which yields $\mathrm{T}_{\mathrm{BG}}=1=12$ ' $0: 083$ ( 8 N ).
W e studied the evolution of the dynam ical tem perature $T$ for typical values of the param eters as described above, focusing on the relaxation tow ards $\mathrm{T}_{\mathrm{B}} \mathrm{F} . \mathrm{W}$ e used waterbag initial conditions $w$ ith hom ogeneous coordinate distribution i $2[0 ; 1]$, and m om enta centered at $\mathrm{p}_{0}=0: 3$ $w$ ith $w$ idth $p=0: 05$. The $m$ anner in which the relaxation takes place depends strongly on the initial conditions. For exam ple, using $0<p_{0} \quad 1 \mathrm{~m}$ akes the system to tem porarily reach a tem perature greater than $T_{B G}$, as a consequence of the periodic boundary conditions (torus (m od 1)). In general di erent initial conditions produce di erent relaxation shapes, but scaling $w$ th N rem ains sim ilar. W e also checked inhom ogeneous coordinate distributions as intial conditions ( $0=0: 3 ;=0: 05$ ), and obtained results qualitatively sim ilar to those corresponding to the hom ogeneous case we present here. A lthough the tem perature value in the $m$ etastable state
is not as low as in the hom ogeneous case, long-lasting $m$ etastable plateaux appear (very $m$ uch as in the $=0$ case of the -XY m odel, also know $n$ as $H$ am iltonian $m$ ean eld ( H M F) for in itialm agnetisation $\mathrm{M}=1$ [40 $\mathbf{O}^{\prime}$ ). . The duration of these plateaux also scalesw ith $N$ in a qualitatively sim ilar m anner as for the hom ogeneous case. T he particular choioe of initial conditions used in this work $y$ ields a rather sm ooth relaxation $w$ ith, for exam ple, only one in exion point, thus sim plifying our analysis. The whole scenario is consistent w ith the con jecture advanced in [411].

This type of relaxation has already been reported for the particular case $=0$ [19']. A tw o-step process appears: rstly a stage where $\bar{T}<T_{B G}$, and then a nal relaxation to the predicted tem perature $\mathrm{T}_{\mathrm{B}}$. . T he in itial regim e varies very slow ly in tim e yielding quasistationary (Q S) states.

$=0 ;=1$, and hence $t_{c} / \mathrm{N} . \mathrm{G}$ iven the non-neglectable error bars due to nite size e ects, the relation $=1$ is not excluded as possibly being the exact one for $0<1$ ( $=0$ otherw ise); $m$ ore precisely, it is not unplausible that $t_{c} / \frac{N^{1}}{1} \quad$ (hence, for $=1, t_{c} / \ln N$ ).

In $F$ ig. $\overline{1 /} \overline{1}$ we show the tem perature evolution for $=$ $0: 6$ and $=2$ for sizes $\mathrm{N}=100 ; 400 ; 1000 ; 4000$. T he curves crossed by the arrow correspond to the $=0: 6$ case, being the rst one (from left to right) $\mathrm{N}=100$. A 11 four curves for $=2$ relax approxim ately at the sam e tim e, so it has the appearance of a single curve. For = $0: 6$ the typical tw o-step relaxation is obtained. From now
on, we de ne the crossover tim e $t_{c}$ from the Q S state to the BG equilibrium state by $m$ eans of the in exion point, i.e. the tim e that corresponds to a m axim um in the time derivative of $T$. The dependence of $t_{c} w$ th $N$ for this choice of param eters and initial conditions is reported in the bottom left panel. The crossover tim e scales as $t_{c} \quad \mathrm{~N}$ () 8 . For ' 1 ; ( ) 0 and then $t_{c}$ rem ains constant (as depicted for $=2$ in Fig. ', 'Al'). For / 1; ( ) > 0, i.e., $t_{c}$ diverges in the therm odynam ic lim it N ! 1 . T his result indicates the inequivalence, for longrange interactions, of the orderingst! 1 and then N !
1 , and N ! 1 and then t ! 1 . Consistently, these Q S states becom e perm anent (and therefore de nitively relevant) when N ! 1 . O nœ again, the situation that is found coincides w ith that of the $-X Y \mathrm{~m}$ odel $\left[\underline{\rho}_{1}^{1}\right]$.

$F$ inally, we studied the dependence of $t_{c} w$ th the nonlinear param eter $a$, for di erent values of , xed coupling param eter $b=2$, and size $N=100$. In this case, as w ellas in the other situations analised in this w ork, di erent behaviours are reported for short-and long-range interactions. For $>1$, the value of $t_{c}$, in the lim it a! 0 , tends to a nite value. The situation is di erent in the long-range case, where, for 1 , the crossover tim e $t_{c}$ scales as $t_{c}=d() a^{1: 84}$ being $d()$ a nonlinear function. P relim inary calculations show that the deviation for the case $=0: 9$ and a 1 is due to nite-size e ects. This scaling law im plies that, for long-range interactions and vanishing nonlinear param eter $a$, the system stays in the $m$ etastable regim e perm anently.

O ur present results for the crossover tim e $t_{c}$ can be approxim atively sum $m$ arised as follow $s$ :

## IV . CONCLUSIONS

In this work we have analysed a system of N symplectically and globally coupled standard $m$ aps, for both short- and long-range interactions. O ur results connect w ith studies $m$ ade in long-range $H$ am iltonian system $s$ as well as w th other $m$ ap system $s w$ th vanishing largest Lyapunov exponent. W e studied a suitably de ned dynam icaltem perature for a region of the param eter space, and report the appearance of long-lasting quasistationary states, follow ed by a relaxation to the predicted equilibrium value. The relaxation time scales as $t_{c} \quad \mathrm{~N}()$, with () 0 when , 1, and ( ) > 0 when 0 / 1, thus diverging as N ! 1 . This is a feature also present in the -XY H am iltonian model, and constitutes a major conjecture in nonextensive statisticalm echanics (N SM). Regarding the sensitivity to initial conditions, we calculated the $m$ axim um Lyapunov exponent $m$ asafunction of the di erent system param eters, nam ely, the size of the system $N$, the nonlinear param eter a and the coupling constant b. W e found that, as the number $N$ of $m$ aps grow $s$, $m$ vanishes as $N$ () with
( ) $>0$ for $0 / 1$, and 0 for , 1. The dependence of $w$ ith is reported and com pared to be the sam e as in the -XY m odel. W e note that, even though the initialevolution of $m$ depends strongly in the initial conditions (as the tem perature does), this scaling does not. In fact, it coincides w ith that calculated w ith uni-
$<1$, form initial conditions (ie., in itial $p_{i}$; i uniform ly distributed in the $[0 ; 1]$ interval) for $t$. O ur results exhibit that, in the presence of long-range interactions, the system tends to be weakly chaotic in the therm odynam ic lim it. This is another feature also present in the nonextensive theory that suggests its applicability. T he lack of ergodicity exhibited in our model is thought to be related to a ( m ulti) fractal constraint in the available phase-space that is enhanced in certain lim its such as N ! 1 . This possibility would be connected to extrem ely low A mold di usion caused by the rem anent of KAM tori and islands, as has been suggested for sim ilar high-dim ensional system $s\left[\begin{array}{l}{[1]} \\ 2\end{array}\right]$. The sim ilarities of the present coupled $m$ ap $m$ odel $a n d$ the $-X Y$ H am iltonian $m$ odel suggest that both share features that $m$ ay have a com $m$ on dynam ical behaviour. This fact, together with recent results obtained for low-dim ensional $m$ aps, $m$ ay clarify the role that N SM plays in the correct description of long-range dynam ical system s.
