W e introduce, and num erically study, a system of N sym plectically and globally coupled standard m aps localized in a d = 1 lattice array. The global coupling ism odulated through a factor r , being r the distance between maps. Thus, interactions are long-range (nonintegrable) when 0 1, and short-range (integrable) when > 1.W everify that the largest Lyapunov exponent  $_{M}$  scales (), where () is positive when interactions are long-range, yielding weak chaos as <sub>M</sub> / N in the therm odynamic limit N ! 1 (hence  $_{M}$  ! 0). In the short-range case, () appears to vanish, and the behaviour corresponds to strong chaos. We show that, for certain values of the control parameters of the system, long-lasting metastable states can be present. Their duration  $t_c$ scales as  $t_c / N$  (), where () appears to be num erically consistent with the following behavior: > 0 for 0 < 1, and zero for 1. All these results exhibit major conjectures formulated within nonextensive statistical mechanics (NSM). Moreover, they exhibit strong similarity between the present discrete-time system, and the -XY Ham iltonian ferrom agnetic model, also studied in the fram e of N SM .

# I. IN TRODUCTION

The study of com plex system s has been lately one the m ost active areas of investigation. This multidisciplinary subject has interest in natural sciences as well as in social and articial system s. In physics, a major area involved is statistical mechanics. It is precisely for such system s that nonextensive statistical mechanics (NSM) [1] appears to have its applicability. Typical features present in com plex systems are long-range interactions, long-term m em ory, fractal phase-space structure, scale-free network structure, or even com binations of these characteristics. Q uite frequently these systems cannot be correctly described by the well-established Boltzm ann-G ibbs statis-

tical mechanics (BGSM). Indeed, they often fail to verify its basic assumptions (equiprobability of phase-space occupation [2] and ergodicity [3] at the therm al equilibrium state). NSM generalises the usual BGSM form alism through the de nition of the q-entropy  $S_q = \frac{1 \text{ dx } [p(x)]^q}{q \text{ 1}}$  (with  $S_1 = S_{BG}$  dx p(x) ln p(x), where BG stands for Boltzm ann-G ibbs) under simple constraints [4].

This theory has been extensively applied to nonlinear dynam ical systems [1, 5, 6, 7], as they are one of the most widespread and useful ways for modelling complex phenomena. For example, Ham iltonian systems are at the core of physics and consequently their relevance is evident. There has been an important number of results indicating that certain conservative models (e.g., the -XY model [8, 9], the -Heisenberg model [10, 11], the

-Lennard-Jones-like gas [12]) can present a behaviour departing from the one predicted by the BG form alism. For certain classes of initial conditions and parameters, the system is prevented from virtually attaining its ex-

pected equilibrium state in nite time when N ! 1. In other words, if the N ! 1 limit is taken before the t! 1 limit, the system becomes nonergodic. This nonergodicity is also re ected in a variety of anom alous behaviours such as non-Gaussian momenta probability density functions, negative speci c heat, aging, and others [13, 14, 15, 16]. On the other hand, other (sim pler) nonlinear dynam ical system s, as for exam ple m aps, have emerged in many contexts, very often exhibiting new and interesting results. Among these systems we nd the logistic map, the standard map, coupled map lattices, discretised Lorentz gas, and many others [17]. Both low-and high-dim ensional discrete-tim e dynam ical system s have been studied under the fram ework of NSM, exhibiting various connections with Ham iltonian dynam ics [18, 19, 20].

It is known quite well that the number of degrees of freedom of a system de nes the possibilities that its dynamics may approach. A clear illustration of this fact in low-dimensional systems (e.g., the 2-dimensional Chirikov-Taylor standard map) is the KAM tori, a com plex structure in the map phase-space that separates chaotic from regular regions. W hile much is known for systems with few degrees of freedom, the situation is m ore intricate when m any elements are involved. This is because the phase-space grows in an extrem ely rapid manner. In addition to this, studying continuous-time m any-body system s can turn out to be very di cult, if not impossible at all, due to the considerable computational time needed to integrate the evolution equations. This is even more so when long-range forces are involved, as it is not justi ed to neglect any interaction between the elements.

An alternative for this problem is the substitution of the continuous-time system for simpler discrete-time systems, such as maps, which conserve many of the important features of the physics involved. This substitution is in fact justied interpreting a dimensional map system as the intersection (in the Gibbs phase-space) of a Poincare plane with the orbit of a higher dimensional Hamiltonian. More precisely, if we consider a time-independent Hamiltonian system with (N + 1) degrees of freedom ((2N + 2)-dim ensional phase-space), a (2N)-dimensional symplectic map is the result of taking a Poincare section over the constant energy hypersurface [17]. The recurrence time is discrete and the map is useful in displaying various properties of the original Ham iltonian system .

NSM concepts have been shown to have an important role in low-dimensional maps at the edge of chaos. The archetypical logistic map (a D = 1, dissipative, nonlinear map) is one of the most widely studied dissipative systems. In part due to its simplicity, it is often used to illustrate many of the most important features of chaos. In recent works, Robledo and Baldovin [21] have analytically proved, using standard renorm alisation-group techniques, that the dynamics of the logistic map at its critical point is unmistakenly well-described within a NSM frame. The sensitivity to initial conditions is a q-exponential function [22], and is related to the entropy production through the q-generalised Pesin-like identity, linking the sensitivity to initial conditions to the q-entropy  $S_q$  with q = 0.2445 .... M oreover, the logistic-m ap with noise (a Langevin-like generalisation of the usual logistic map) has been found to present two-step relaxation processes and aging (presenting interesting com m on points with slow glassy dynam ics [23]). O theraspects of the NSM formalism were also studied in them ore general case of one-dim ensional z-logistic fam ily ofm aps considering the attractor fractal nature [24]. Regarding two-dimensional (D = 2) dissipative systems (as the Henon m ap or its linearised version, the Lozim ap), results indicate that it presents the same value of q as the logistic m ap, therefore suggesting a com m on universality class [25]. Regarding two-dimensional (D = 2) conservative m aps, a very interesting example, the triangle Casati-Prosen m ap (m ixing, ergodic, but with vanishing Lyapunov exponent), has been recently been studied in connection to the entropy  $S_q$  with q = 0 [26].

Moving further into conservative discrete-time system s, two-step relaxation has been also observed at the edge of chaos for the Chirikov-Taylor standard map, a paradigm atic one for 2-dim ensional sym plectic m aps. This map has been thoroughly studied and explained by means of the KAM - theorem [17]. This map is known to be area preserving, hence its variables are often considered as \coordinate" and \m om entum ", in analogy with Ham iltonian system s. A long this lines, it is appealing to look to the more general case of a symplectic system of N coupled standard m aps (D = 2N;N 1). Dierent e ortswere done for values of N as low as N = 2 up to N = 500 [20, 27, 28]. In these cases, the same two-step relaxation was found as well as other features pointing to a NSM applicability. But in all these cases, the coupling was done trough the momentum variables. Even though this has its own interest, it would be instructive to see the e ects of coupling such a system through the coordinate variables, as in more realistic situations.

In this work we will study a high-dimensional globally coupled conservative map system that, as discussed above, presents many of the characteristics of H am iltonian dynamics. Our purpose is to contribute to the understanding of the role that N SM plays in the anom alous features present in long-range-interacting dynam ical system s. Our results show interesting similarities between this map model and many-body long-range-interacting H am iltonian dynamics, in particular the -X Y model. In both cases, long-lasting metastable states, as wellas weak chaos, are present in the therm odynam ic lim it. B oth features point out that under certain initial conditions, orbits do not visit with equal probability the entire phase space, or in other words there is a failure in ergodicity.

In the next section we introduce and describe the model, as well as some relevant details of our simulations. In section III we present our num erical results. We report on the scaling behaviour of the largest Lyapunov expo-

nent with the system size N , and point out connections with H am iltonian dynam ics. We analyse the relaxation to equilibrium , and we make a system atic characterisation as a function of the system parameters. Finally, a discussion and sum mary are presented in section IV .

## II. MODEL

O urm odel is a set of N sym plectically coupled (hence conservative) standard m aps, where the coupling is m ade through the coordinates as follow s:

where t is the discrete time t = 1; 2; ..., and0.The a parameter is the usual nonlinear constant of the individualstandard m ap, w hereas the bparam eterm odulates the overall strength of the long-range coupling. Both param eters contribute to the nonlinearity of the system ; it becomes integrable when a = b = 0. For simplicity, we have studied only the cases a > 0, b > 0, but we expect sim ilar results when one or both of these param eters are negative. The system atic study of the whole parameter space is certainly welcome. Notice that, in order to describe a system whose phase space is bounded, we are considering, as usual, only the torus (m od 1). Additionally, the m aps are localised in a one dimensional (d = 1)regular lattice with periodic boundary conditions. The distance  $r_{ij}$  is the minimum distance between maps i and j, hence it can take values from unity to  $\frac{N}{2}$   $(\frac{N-1}{2})$ for even (odd) number N of maps. Note that  $r_{ij}$  is a xed quantity that, modulated with the power, enters Eq. (1) as an e ective time-independent coupling constant. As a consequence, regulates the range of the interaction between maps. The sum is global (i.e., it includes every pair of m aps), so the  $\lim i t ing cases = 0$ and = 1 correspond respectively to in nitely long range and nearest neighbours. In our case d=1, thus 0 1 ( > 1) m eans long-range (short-range) coupling. M oreover, the coupling term is normalised by the sum [9, 29]  $\tilde{N}$  d  $a_{1}^{R_{N^{1-d}}} dr r^{d-1} r = \frac{N^{1} - d}{1 - d} r^{d-1}$ , to yield a non-diverging quantity as the system size grows (for sim plicity, we have replaced here the exact discrete sum over integer r by its continuous approxim ation).

If G (x) denotes a map system, then G is symplectic when its Jacobian (G = 0x satis es the relation [17]:

where the superindex T indicates the transposed m atrix, and J is the Poisson m atrix, dened by

I being the N N identity matrix. A consequence of Eq. (2) is that the Jacobian determ inant  $j^0G = 0xj = 1$ ; indicating that the map G is (hyper)volum e-preserving. In particular, for our model

This quantity, multiplied (from the right side) by the matrix (4) yields J. Therefore our system is symplectic. Consequently, the 2N Lyapunov exponents 1 M; 2; 3; :::; 2N are coupled two by two as follows: 1 =::: <sub>N</sub> = N + 1 0. In 2 = 2N 1 2N other words, as a function of time, an in nitely small length typically diverges as e<sup>1t</sup>, an in nitely small area diverges as  $e^{\begin{pmatrix} 1 & + & 2 \end{pmatrix}t}$ , an in nitely small volum e diverges as  $e^{\begin{pmatrix} 1 & + & 2 \end{pmatrix}t}$ , an in nitely small N-dimensional hypervolum e diverges as  $e^{\left(\begin{array}{c} N\\i=1\end{array}\right)t}$  ( $\begin{array}{c} P\\i=1\end{array}$ ) being in fact equal to the Kolm ogorov-Sinai entropy rate, in agreementwith the Pesin identity), an in nitely small (N + 1)hypervolum e diverges as  $e^{\begin{pmatrix} I & N & 1 \\ i=1 & i \end{pmatrix}t}$ , and so on. For example, a  $(2N \quad 1)$ -hypervolum e diverges as  $e^{1t}$ , and nally a 2N -hypervolum e rem ains constant, thus recovering the conservative nature of the system (of course, this corresponds to the Liouville theorem in classical H am iltonian dynam ics).

For = 0, sim ilarm odels exist in the literature though in di erent contexts [19, 30, 31]. The present particular choice for the coupling was made with the purpose of comparison with many-body Ham iltonian systems. Indeed, one can derive the map set of equations (1) by applying a discretisation procedure to the -XY model with an external eld (for more details see [17, 31]). As a consequence of having N 1 terms in the coupling sum mation and the fact that there are N m aps, the sim ulation times are of order 0 (N<sup>2</sup>). For this reason it is a di cult task to num erically simulate (1) for large values of N. To overcom e this problem, we used an algorithm that takes advantage of the symmetry of the lattice [32] and shortens the simulation time to 0 (N ln N).

Initial coordinates and m om enta w ere random ly taken from the following uniform distributions:  $_{\rm i}$  2 [  $_0$ 

] and  $\underline{p}_{2}$  [ $p_{0}$ p; p + p]. For the coordi-; 0 + natesweused  $_0 =$ = 0:5 (i.e.,  $_{1}2$  [0;1], hom ogeneous coordinate initial conditions). For the momenta, we concentrated in two cases. To study the sensibility to initial conditions we used a uniform distribution over the whole phase-space ( $p_0 = 0.5$  and p = 0.5). In the analysis of the relaxation to equilibrium we used a thin waterbag intial condition with  $p_0 = 0.3$  and p = 0.05. We also checked inhom ogeneous initial conditions, in particular  $p_0 = 0 = 0.3$  and p = 0.3= 0.05 (not shown in this paper). Note that in this case there is no traslational sym metry in the coordinates. For su ciently long times, our simulations yield the same sensitivity to initial conditions that we obtain for the symmetric case  $_{i} 2$  [0;1]. On the other hand, this inhom ogeneous initial condition in the coordinates has an important in uence in the shape of the relaxation to equilibrium . This will be further com m ented in the next section. W e note that the system atic study of the role of initial conditions is very instructive, but it is out of the scope of the present work.

## III. RESULTS

## A. Sensitivity to initial conditions

In order to analyse the sensibility to initial conditions, we num erically studied the largest Lyapunov exponent (LLE) for di erent values of param eters a, b, and N. W e used the well-known m ethod developed by B enettin et al [33]. As a consequence of the sym plectic structure of (1), the Lyapunov spectrum in the 2N -dim ensional phase space of the m ap is, as already discussed, characterised by N pairs of Lyapunov coe cients, where each element of the pair is the negative of the other. Therefore, the LLE sets an upper bound for the absolute value of the entire spectrum of exponents.

We concentrated on the evolution of the LLE for di erent values of N starting with  $_0 = 0.5$ , = 0.5;  $p_0 = 0.5$ ; and p = 0.5; 8. In a typical (su ciently long) realisation, the nite-time LLE,  $_M$ , is a good estimator for the analytical de nition of the LLE (both quantities

will coincide when t ! 1 [34]). We averaged between realisations (typically 100) in order to have sm all statistical uctuations. We checked that, for appropriately long times,  $_{\rm M}$  does not depend on the initial conditions [35].




FIG.1: Lyapunov exponent dependence on system size N in log-log plot, showing that  $_{\rm M}$  N  $^{()}$ . Initial conditions correspond to  $_0$  = 0.5,  $_{\rm H}$  = 0.5,  $_{\rm H}$  = 0.5 and  $_{\rm H}$  = 0.5. Fixed parameters are a = 0.005 and b = 2. We averaged over 100 realisations. Inset: vs. , exhibiting weak chaos in the lim it N ! 1 when 0 / 1.

In Fig.1 we show the N -dependence of  $_{\rm M}$  for typical values of the interaction-range parameter, and xed values of parameters a = 0.005; b = 2.0 ur results show that the value of M vanishes with increasing value of N (consequently, so does the rest of the Lyapunov spectrum) as a power-law MN () for / 1, and is a positive constant for > 1 ( 0). In the inset we detail as a function of . This shows that the map system is weakly chaotic for long-range coupling (  $_{\rm M}$  ! 0 when N ! 1 ), whereas for short-range interactions, M rem ains positive for all N, meaning strongly chaotic dynam ics (as expected [36, 37]). Interestingly, this result is totally similar to the one num erically measured and analytically predicted for the -XY model [38], thus suggesting equivalent behaviours. Indeed, and as stated by Anteneodo and Valleps, this scaling is typical of system s with couplings of the form 1=r [39]. Prelim inary simulations suggest that the fact that the weak chaos region extends slightly over = 1 is an expected consequence of nite-size and nite-time e ects.




FIG. 2: Lyapunov exponent dependence on a for di erent values of .Fixed constants are N = 1024 and b = 2. Initial conditions correspond to  $_0 = 0.5$ , = 0.5, p = 0.5 and p = 0.5. W e averaged over 100 realisations.

The dependence of  $_{\rm M}$  with the nonlinear parameter a for dierent ranges of the interaction is shown in Fig. 2. We can see that, for < 1,  $_{\rm M}$  decreases with a and saturates for a 1. This illustrates the in uence of this nonlinear term. For increasing a, the sensibility to initial conditions raises. On the other hand a has alm ost no e ect when > 1, where the  $_{\rm M}$  is approximately constant on the whole a-range. We veried that for a > 1 a slight increase appears for > 1 (as in the long-range

case), but this e ect is negligible.




FIG. 3: Lyapunov exponent dependence on b in log-log plot. Fixed constants are N = 1024 and a = 0:005. Initial conditions correspond to  $_0 = 0.5$ , = 0:5, p = 0.5 and p = 0.5. W e averaged over 100 realisations. Inset: Sam e data in linearlinear plot.

In Fig. 3 we exhibit the dependence on the coupling parameter b, also varying . For high values of b (b 1),  $_{\rm M}$  = c() b<sup>0:63</sup> 8, being c() a nonlinear function. P relim inary simulations show that this exponent varies only slightly with a and N, suggesting that it may be unique. In the case b = 0, we veried that  $_{\rm M}$  = 0; 8. For > 1 this scaling is valid even for b 1. On the other hand, if < 1, a deviation from this power-law behaviour emerges when b 1.

Our characterisation illustrates the fact that, quite

generically, the sensibility to initial conditions is strongly governed by the range of the interactions. O rbits are clearly chaotic in the short-range case (as expected) and strong num erical evidence of vanishing LLE em erges when interactions are long-range, revealing a weakly chaotic regim e.

Our present results for the maxim al Lyapunov exponent can be approxim atively sum marised as follows:

where 0 a << 1; 0 b / 2; N >> 1, 0, and f(b) is some function of (b; ) (e.g., f (b) /  $b^{0:63}$  for > 1).

#### B. Tem perature evolution

As stated above, system (1) is symplectic, hence (hyper)volum e preserving, like H am iltonian system s. A consequence of this is that may be interpreted as a \coordinate" variable and p as the conjugate \m om entum ". W e may de ne a concept analogous to a tem perature as twice the m ean \kinetic energy" per particle [19, 28],

where h:::i denotes an ensemble average. This quantity can be interpreted as a dynam icalanalog, and plays a role sim ilar to the physical temperature. We refer to as the BG-temperature,  $T_{B\,G}$ , the temperature associated with an uniform ensemble distribution in phase space. This quantity may be analytically calculated,

which yields  $T_{\rm B\ G}$  = 1=12  $\prime$  0:083 (8N ).

W e studied the evolution of the dynam ical tem perature T for typical values of the param eters as described above, focusing on the relaxation towards  $T_{B\,G}$  . We used waterbag initial conditions with hom ogeneous coordinate distribution  $\frac{1}{2}$  [0;1], and m om enta centered at  $p_0 = 0.3$ with width p = 0.05. The manner in which the relaxation takes place depends strongly on the initial conditions. For example, using  $0 < p_0$ 1 m akes the system to tem porarily reach a tem perature greater than  $T_{B\,G}$  , as a consequence of the periodic boundary conditions (torus (m od 1)). In general di erent initial conditions produce di erent relaxation shapes, but scaling with N remains sim ilar. W e also checked inhom ogeneous coordinate distributions as initial conditions ( $_0 = 0.3$ ; = 0:05),and obtained results qualitatively sim ilar to those corresponding to the hom ogeneous case we present here. A though the temperature value in the metastable state

is not as low as in the hom ogeneous case, long-lasting m etastable plateaux appear (very m uch as in the = 0 case of the -X Y m odel, also know n as H am iltonian m ean eld (HMF) for initial m agnetisation M = 1 [40]). The duration of these plateaux also scales with N in a qualitatively sim ilar m anner as for the hom ogeneous case. The particular choice of initial conditions used in this work yields a rather sm ooth relaxation with, for example, only one in exion point, thus sim plifying our analysis. The whole scenario is consistent with the conjecture advanced in [41].

This type of relaxation has already been reported for the particular case = 0 [19]. A two-step process appears: rstly a stage where T <  $T_{B\,G}$ , and then a nal relaxation to the predicted tem perature  $T_{B\,G}$ . The initial regim e varies very slow ly in time yielding quasistationary (Q S) states.




FIG. 4: Upper panel: Tem perature evolution for = 2 and = 0:6 and four system sizes N = 100;400;1000;4000. Initial conditions correspond to  $_0 = 0.5$ , = 0.5, p = 0.3and p = 0.05. Fixed constants are a = 0.05 and b = 2. For = 2 the four curves coincide alm ost com pletely, all having a very fast relaxation to  $T_{BG}$ . For = 0.6 the same sizes are shown, growing in the direction of the arrow. Left bottom panel: crossover time t<sub>c</sub> vs. N, showing a power-law depen-N<sup>()</sup>with () 0. Right bottom panel: dence to vs shows that for long-range interactions the QS state lifetime diverges in the therm odynam ic limit. Note that when = 0; = 1, and hence  $t_c / N$ . G iven the non-neglectable error bars due to nite size e ects, the relation = 1is not excluded as possibly being the exact one for 0 < 1 = 0 otherwise); more precisely, it is not unplausible that N  $\frac{1}{1}$  (hence, for = 1, t<sub>c</sub> / ln N). t<sub>c</sub> /

In Fig. 4 we show the temperature evolution for = 0:6 and = 2 for sizes N = 100;400;1000;4000. All four curves for = 2 relax approximately at the same time, so it has the appearance of a single curve. For = 0:6 the typical two-step relaxation is obtained. From now

on, we de ne the crossover time  $t_{\rm c}$  from the QS state to the BG equilibrium state by means of the in exion point, i.e. the time that corresponds to a maximum in the time derivative of T. The dependence of t<sub>c</sub> with N for this choice of parameters and initial conditions is reported in the bottom left panel. The crossover time scales as N<sup>()</sup>8.For '1; () 0 and then  $t_c$  rem ains t<sub>c</sub> constant (as depicted for = 2 in Fig. 4). For / 1; () > 0, i.e.,  $t_c$  diverges in the therm odynam ic lim it N! 1. This result indicates the inequivalence, for longrange interactions, of the orderingst ! 1 and then N ! 1, and N ! 1 and then t ! 1. Consistently, these QS states become permanent (and therefore de nitively relevant) when N ! 1 . Once again, the situation that is found coincides with that of the -XY model [9].




FIG.5: Temperature dependence on a. Fixed constants are N = 100 and b = 2. Initial conditions correspond to  $_0 = 0.5$ , = 0.5, p = 0.3 and p = 0.05. We averaged over 100 realisations.

Finally, we studied the dependence of  $t_c$  with the nonlinear parameter a, for dierent values of , xed coupling parameter b = 2, and size N = 100. In this case, as wellas in the other situations analised in this work, di erent behaviours are reported for short-and long-range interactions. For > 1, the value of  $t_c$ , in the lim it a ! 0, tends to a nite value. The situation is di erent in the long-range case, where, for 1, the crossover time  $t_c$ scales as  $t_c = d() a^{1:84}$  being d() a nonlinear function. P relim inary calculations show that the deviation for the case = 0:9 and a 1 is due to nite-size e ects. This scaling law implies that, for long-range interactions and vanishing nonlinear parameter a, the system stays in the m etastable regim e perm anently.

Our present results for the crossover time  $t_{\rm c}$  can be approximatively summarised as follows:

where 0.001 = a < < 0.1, 0 = b / 2, N >> 1, 0 < and g (b) is some function of (b; ).

# IV. CONCLUSIONS

In this work we have analysed a system of N symplectically and globally coupled standard m aps, for both short- and long-range interactions. Our results connect with studies made in long-range H am iltonian system s as well as with other map systems with vanishing largest Lyapunov exponent. W e studied a suitably de ned dynam icaltem perature for a region of the param eter space, and report the appearance of long-lasting quasistationary states, followed by a relaxation to the predicted equilib-N<sup>()</sup>, rium value. The relaxation time scales as t<sub>c</sub> ' 1, and () > 0 when with 0 when () 0 / 1, thus diverging as N ! 1. This is a feature also present in the -XY Ham iltonian model, and constitutes a major conjecture in nonextensive statisticalm echanics (NSM). Regarding the sensitivity to initial conditions, we calculated the maximum Lyapunov exponent M as a function of the di erent system parameters, namely, the size of the system N, the nonlinear parameter a and the coupling constant b. W e found that, as the num ber N of m aps grow s,  $_{\rm M}$  vanishes as N  $^{()}$  with 0 for ' 1. The de-() > 0 for 0 / 1, and pendence of with is reported and com pared to be the same as in the -XY model. We note that, even though the initial evolution of M depends strongly in the initial conditions (as the tem perature does), this scaling does not. In fact, it coincides with that calculated with uni-

< 1, form initial conditions (i.e., initial pi; i uniform ly distributed in the [0;1] interval) for t 1. Our results exhibit that, in the presence of long-range interactions, the system tends to be weakly chaotic in the therm odynam ic lim it. This is another feature also present in the nonextensive theory that suggests its applicability. The lack of ergodicity exhibited in our model is thought to be related to a (multi) fractal constraint in the available phase-space that is enhanced in certain limits such as N ! 1 . This possibility would be connected to extrem ely low A mold di usion caused by the rem anent of KAM tori and islands, as has been suggested for sim ilarhigh-dim ensional system s [42]. The sim ilarities of the present coupled m ap m odel and the -XY H am iltonian m odel suggest that both share features that m ay have a com m on dynam ical behaviour. This fact, together with recent results obtained for low-dimensional maps, may clarify the role that NSM plays in the correct description of long-range dynam ical system s.
