# Parity meter for charge qubits: an e cient quantum entangler

W e propose a realization of a charge parity m eter based on two double quantum dots alongside a quantum point contact. Such a device is a speci c example of the general class of m esoscopic quadratic quantum m easurem ent detectors previously investigated by M ao et al. Phys. Rev. Lett. 93, 056803 (2004)]. Our setup accomplishes entangled state preparation by a current m easurem ent alone, and allows the qubits to be e ectively decoupled by pinching o the parity m eter. Two applications of the parity m eter are discussed: the m easurem ent of B ell's inequality in charge qubits and the realization of a controlled NOT gate.

#### I. IN TRODUCTION

Recently, it has been realized that parity meters based on solid state structures should be very prom ising candidates to create entanglem ent of electronic system s.<sup>1,2,3</sup> W hereas previous proposals and applications of parity meters in the solid state have dealt with the entanglem ent of the spin degree of freedom, we presently investigate a parity m eter based on charge gubits, which is able to generate entanglem ent in a solid state system just by measuring a DC current through a quantum point contact (QPC). The setup under consideration, schematically shown in Fig.1 (A), is a particular example of the general class of m esoscopic quadratic quantum m easurement devices investigated by M ao et al. in Ref. 4. The design of our device has been inspired by the work of Ruskov and Korotkov, where it has been demonstrated that current and noise measurements of a OPC coupled to two charge qubits can be used as an entangler.<sup>5</sup> W e propose a setup, in which this task can be achieved by a current m easurem ent only.

The charge qubits, e.g. a single electron in a tunnelcoupled double quantum dot (DQD), are coupled capacitively to the measurement device (the parity meter). Recently, coherent quantum oscillations have been measured in DQD systems.<sup>6</sup> Quantum detectors based on QPC's coupled to DQD qubit systems have been studied intensively in the past, both theoretically<sup>7</sup> as well as experimentally.<sup>8</sup> Transport properties of C oulom b coupled DQD systems have also been analyzed.<sup>9</sup>

Generally speaking, the idea of a parity meter is that it can distinguish between the subspaces of two parity classes of quantum states but it cannot distinguish between di erent states in each parity class. It has been demonstrated that such a device can be used to im plement a controlled NOT (CNOT) gate.<sup>1</sup> A CNOT gate is a universal quantum gate, and therefore enables universal quantum com putation when com bined with single qubit gates.

The design of the parity m eter that we propose in this

article is very straightforward. It just relies on two qubit system s (based on DQD's) and a single measurem ent device (based on a QPC). All elements of the parity meter can be built with standard lithographic techniques in the lab. If we think about these qubits as DQD's in GaAs heterostructures then dephasing due to coupling of the charge on the dots to accustic phonons<sup>10</sup> and dephasing due to background charge uctuations<sup>11</sup> cause severe problem s. Nevertheless, charge qubits based on DQD's in other structures such as carbon nanotubes<sup>12</sup> or sem iconductor nanow ires m ight have much better coherence properties (due to the fact that they are essentially one dim ensional system s), which would make our predictions m easurable. Recently, charge qubit operations of an isolated (leadless) silicon double quantum dot have been reported with an extrem ely long coherence tim e.<sup>13</sup>

The article is organized as follows. In Sec. II, we propose a speci c realization of a charge parity meter, i.e. a quadratic quantum measurement device. Subsequently, in Sec. III, we demonstrate how the parity meter acts as an entangler. In Sec. IV, we discuss two applications of the parity meter: (i) the measurement of a violation of Bell's inequality and (ii) a realization of a CNOT gate. We conclude in Sec.V.

### II. REALIZATION OF A CHARGE PARITY METER

It has been pointed out in Ref. 4 that a general quadratic quantum m easurem ent device provides a sim – ple way of entangling two otherwise noninteracting qubits. In such a m easurem ent device, the transm ission am plitude t of som e particles, e.g. electrons, should depend on the m easurem ent basis operators  $\binom{()}{z}$  of the two qubits = 1;2 in the following way




FIG.1: Parity meter setup. In (A), two DQD's are shown with a QPC in between them. By measuring the current through the QPC, we are able to determ ine the parity class of the two-qubit state form ed by a single electron in each DQD qubit. In (B), a capacitive model is illustrated for the setup considered in (A). The two grey boxes in the middle correspond to the dipole across the QPC.

In this section, we demonstrate that a physical realization of a parity meter for charge qubits consists of two DQD's and a single QPC. The setup we have in m ind consists of two DQD's alongside a QPC, cf. Fig.1 (A). We will show that a capacitance model based only on linear relations between charge and potentials explains the existence of the desired quadratic coupling (1) in our device. While in Ref. 4 the quadratic measurement is achieved by considering an in ection point of the transmission with dt=dU = 0, where t is the transmission am - plitude and U the potential of the measurement device, the quadratic coupling which we discuss below is realized for arbitrary transmission since it is a consequence of the spatial symmetry of our arrangement. A similar idea, using geometric symmetry (in a more complicated interferom etric structure) to realize a quadratic detector has been proposed in Ref. 14.

W e assume that each DQD contains a single electron, which therefore acts as a charge qubit, and can be described by the H am iltonian

Here = 1;2 (for the two di erent qubits), is the di erence of single particle energy levels in each dot,

is the tunnel coupling between the dots, and  $\begin{pmatrix} c \\ x \end{pmatrix}$  is a Paulim atrix acting on qubit . The direct electrostatic coupling between the two DQD's is neglected. However, the two qubits are indirectly coupled to each other via the QPC.

The corresponding coupling term, in our setup, may be written as

where  $\hat{E}$  is a charging energy operator with a quantum expectation value  $E = E_E = E_0$  h  $\hat{E}$  i equal to the di erence in charging energy of the even (index E) and odd (index O) parity class. In the tunnelling regime, the operator  $\hat{E}$  can be associated with the standard detector input variable  $a_R^Y a_L + H \approx$ ; where is the coupling constant,  $a_R^Y$  is the creation operator for an electron in the one lead of the detector, and  $a_L$  an annihilation operator in the other lead.<sup>24</sup> The combined H am iltonian of the two DQD's, the QPC, and the coupling (3) then reads

where  $H_{\mbox{QPC}}$  is the H am iltonian of the detector.

To justify the interaction H am iltonian (3) in the case of an arbitrary two qubit parity detector, the coupling H am iltonian m ay be expressed in the basis, de ned with each of the con gurations fj"'i; j##i; j"#i; j#"ig, where we assign pseudo-spins to the position of the electron in the DQD: spin " corresponds to the case where the electron is in the upper dot and spin # corresponds to the case where the electron is in the lower dot. The even parity class contains the states fj""i; j##ig, while the odd parity class contains fj"#i; j#"ig. W e will show below that the parity detector can distinguish only between the even and the odd parity classes. This de nes the basis that is accessible to the parity detector. The parity detector cannot distinguish the states in either even or odd subclass, but it can distinguish between parity subclasses. In particular, the energy of both even con gurations are equal, and the energies of both odd con gurations are equal, but the even energy is not equal to the odd energy. Therefore the coupling H am iltonian can be expressed as

Introducing the projection operators,  $P_{i;i}^{(\ )}$  on the up or down state of qubit , going to sum and di erence variables, ^= ( $\hat{E}_E + \hat{E}_O$ )=2;  $\hat{E} = (\hat{E}_E - \hat{E}_O)$ , and recalling that  $P_i^{(\ )} + P_{i}^{(\ )} = 1^{(\ )}; P_i^{(\ )} - P_{i}^{(\ )} = \frac{(}{2},$  we not that the coupling H am iltonian may be rew ritten as

The rst term may be absorbed into the detector H am iltonian, and the second term recovers our coupling H am iltonian (3).

W e will now dem onstrate that a single QPC placed in a special way between two DQD's has a Ham iltonian of the form (3). As illustrated in Fig.1 (B), we divide the two DQD's as well as the QPC in two regions with two corresponding charges each. The left DQD has charge  $Q_1 = Q_2 = Q_L$  in dots with potentials  $U_1$  and  $U_2$ . The right DQD has charge  $Q_3 = Q_4 = Q_R$  in dots with potentials  $U_3$  and  $U_4$ . We set e 1 and ~ 1. Suppose that, in the odd parity class with  $Q_L Q_R = 1$ , the QPC has a potential V (x) along the x-axis given by<sup>15</sup>

W e are interested in the change of the potential  $V_0$  at the saddle point as the qubit con guration changes from the odd to the even parity class. W e call the saddle point potential of the even parity class  $V_1$ . The saddle point potentials allow us to determ ine the transm ission coe cient of the QPC.

As compared to the odd parity class, the even class will polarize the QPC, i.e. there will be an additional electrical eld E at the saddle point with a potential V (x) = V\_0 + eE x  $\frac{1}{2}m !_x^2 x^2 + :::, which will give rise to a shift in the location of the saddle point and an increase in its height$

To estimate the eld E we consider the capacitive model shown in Fig.1 (B). The QPC dipole is described with a capacitance  $C_p$  and the dipole charges  $Q_5 = Q_d$  and  $Q_6 = Q_d$  exist in regions with potentials  $U_5$  and  $U_6$ .<sup>16</sup> A charge on a dot next to a dipole region has a capacitance

C and the interaction of the charges across a DQD is described by an (internal) capacitance  $C_i$ . For simplicity, we assume that only nearest neighbor charge con gurations couple to each other. This is justiled because the QPC screens the DQD's, and, therefore, decreases the direct coupling between the DQD's substantially. We now have for the DQD charges the equations

and for the QPC dipole charges

These become a complete set of equations if we assume that the region over which the dipole extends has a density of states D such that a small variation of the potential in these regions gives rise to a charge  $Q_5 = DU$  and  $Q_6 = DU$  with  $U = (U_5 \quad U_6)=2$ . Here we have assumed that the QPC potential is spatially symmetric in the odd parity con guration. This requires that the QPC is located symmetrically in between the DQD's and permits us to take the density of states to the right and the left of the QPC to be equal to D  $D_L = D_R$ .

W e obtain for the C oulom b energy

W e see that there exist a contribution to the C oulom b energy proportional to Q  $_{\rm L}$  Q  $_{\rm R}\,$  given by

This contribution a ects the saddle point potential in such a way that the QPC acts as a parity m eter. Eq. (14) can be identi ed w ith Eq. (3).

We now estimate the saddle point potential, in the even con guration, which determines the transmission. The voltage drop of the dipole is 2U and, assuming that the center of its charges is separated by a distance 2d, we nd an electric eld E = U = d. Hence, using Eqs. (8) and (12) we obtain




FIG.2: Upper part: Top view of QPC in the parity meter setup. In the odd parity class, where  $(Q_L; Q_R)$  is (1; 1)or (1;1), no dipole is generated across the QPC and it is nicely symmetric. In the even parity class, where  $(Q_L; Q_R)$  is (1;1) or (1; 1), the situation is di erent. There, a dipole is generated across the QPC by the particular position of the electrons in the quantum dots. The dipole shifts the saddle point to the right (left) depending on the direction of the polarization of the dipole, but for both polarizations the shift is to higher energies. Note that the QPC in this gure is rotated by 90 with respect to the QPC in Fig.1. Lower part: Illustration of the saddle point potential for the two con gurations.

Thus, the QPC has a saddle point height  $V_0$  for the odd con guration  $[D_LQ_R = 1]$  and a som ewhat higher saddle point potential  $V_1$  for the even con guration  $[D_LQ_R = 1]$ . We illustrate in Fig. 2 the symmetric potential landscape of the QPC in the odd case and the generated dipole across the QPC in the even case as well as the corresponding saddle point potentials. The transmission probability  $T = \frac{1}{2}f$  of the QPC is directly related to the saddle point height via<sup>15</sup>

where  $E_F$  is the Ferm i energy in the QPC, = 0 for the odd case, and = 1 for the even case. This shows that the transmission probability through the system considered here has indeed the desired property stated in Eq. (1).

To sum marize, there are three physically distinguishable situations: (i) There is no charge dipole (both odd con gurations), (ii) there is a QPC charge dipole pointing up (the even con guration j""i), and (iii) there is a QPC charge dipole pointing down (the even con guration j##i). A though all three situations are distinguishable in principle, the crucial fact is that the potential height experienced by the transport electrons is the same in both even con gurations. Therefore, the current di ers only between the even and the odd con guration. For later reference, we de ne here the two currents

where  $V_{\rm bias}$  is the bias voltage across the QPC and we have re-introduced e and ~ for clarity. During the measurem ent, the QPC should be operated in the regime of linear  $V_{\rm bias}$  . The reason is that a large

bias would break the sym m etry between the j""i and the j##i state, so the parity m eter could then distinguish the two states of the even class. In typical systems (for instance the ones investigated in Ref. 8), 10 eV,  $V_{\rm bias}$  1 mV, and the I-V characteristics of the QPC is linear. Thus, the above stated requirem ents can be easily m et. The parity m easurem ent tim e<sup>7</sup>

with  $S_I = 0$  dth I (t) I (0)i, and I (t) = I (t) hIi is the time scale required to a obtain a signal-to-noise ratio of order 1. In current (present day) G aA s-based quantum dot devices this time scale will be of the order of a few s (see e.g. Ref. 17) and therefore much longer than typical coherence times of the order of a few ns. For quantum dots in other physical system s such as carbon nanotubes or nanow ires the coherence times should be much longer and therefore them easurem ent time  $T_M$  can, in principle, becom e of the same order as the coherence time or even sm aller.

For the Bell measurement (discussed below), it is important that the coupling between the two qubits (the two DQD's) can be turned o after the state has been prepared. In our setup, the coupling between the two DQD's is minimized by removing the bias voltage  $(V_{\text{bias}} = 0)$  and by pinching o the QPC, therefore, reducing E. For all operations that are done on a time scale t 2= E, the density m atrix of the two DQD's experiences little coherent evolution due to the coupling term (3). Therefore, on such short time scales the two qubits would behave as if they were decoupled.

### III. PARITY METER AS ENTANGLER

At the sym m etry point of the two-qubit system, where  $_1 = _2 = 0$  and  $_1 = _2$ , our device acts as an entangler just by m easuring the current through the QPC.

The Ham iltonian of the two qubits at the symmetry point (index SP) reads

The eigenstates of H  $_{\rm SP}\,$  are the two anti-symmetric Bell states

The state j  $_{B\,1}i$  belongs to the odd parity class and the state j  $_{B\,2}i$  to the even one. Thus, both eigenstates of the H am iltonian H  $_{SP}$  can be distinguished from each other by a current m easurem ent through the QPC in Fig. 1. The other two symmetric Bell states

are transformed into each other, obeying the timeevolution

Here, is an arbitrary phase.

Since the states (21) { (24) form a complete basis of the two-qubit system, we can conclude that a measurement of the current through the QPC can take three possible outcomes: (i)  $I_{odd}$ , which means that the system is driven into the steady state (21) by the measurement, (ii)  $I_{even}$ , which means that the system is driven into the steady state (22) by the measurement, and (iii)  $I_{m ix}$  ( $I_{odd} + I_{even}$ )=2 (with  $I_{odd} < I_{m ix} < I_{even}$ ), which means that the system is driven into the state the system is driven into the state (25), which means that the system is driven into the state (25), which exhibits a dynamical detector signal that is both oscillatory and noisy.

This behavior can be demonstrated within a simple model of continuous parity measurement state preparation with a series of projective parity measurements. Using a master equation description of the time evolution of the density matrix of the two-qubit system, we have veri-

ed that the latterm odel is in agreem ent with continuous weak measurement. In the master equation description, we have treated the electrons in the QPC as bath variables and integrated out the bath degrees of freedom in the weak coupling and Markovian regime. The resulting master equation is of the Lindblad form, where the decay rates are proportional to the auto-correlation function of the input variable of the parity detector. The algorithm of our model of continuous parity measurement state preparation is as follows:

- 1. Fix the desired initial state in the measurement basis. It can be random by chosen, or can be xed as a state that is experimentally simple to prepare.
- 2. Apply a unitary transformation to change to the Bell basis, where Ham iltonian evolution is simple. M ore explicitly, if we represent an arbitrary state as

a simple basis transform ation enables us to write the sam e state as

Then, the time evolution in the Bell basis is simply given by

- 3. Apply H am iltonian evolution with a random ly chosen time.
- 4. Transform back to the measurem ent basis.
- 5. Do a parity m easurem ent:

F ind the probability of getting the result even (E), or odd (O) from the state.

Use these probabilities to choose a random outcom e, E or O .

Based on the result, update the state.

- 6. Transform back to the Bell basis.
- 7. Repeat the algorithm from step 2.

A s m entioned before, this algorithm gives three possible outcom es: (i) the parity m eter m easures 0 all the time ! state  $j_{B1}$  i has been prepared, (ii) the parity m eter m easures E all the time ! state  $j_{B2}$  i has been prepared, and (iii) the parity m eter m easures a string of a m ixture of 0 and E results ! a dynam ical superposition of the states  $j_{B3}$  i and  $j_{B4}$  i has been prepared, which is not a steady state of H  $_{\rm SP}$ . A long sequence of either O 's or E 's, corresponding to cases (i) or (ii), indicates a statistically con dent preparation of a Bell state.

A statistical analysis of our model shows that if we start with a product state in one of the two parity classes, e.g. j"#i in the odd class, which can be easily prepared experimentally, then the parity meter drives the system with probability 1=2 into the Bell state j  $_{B1}$ i. (The same holds for the other parity class and the Bell state j  $_{B2}$ i.)

If we, how ever, start with a random state, e.g. a fully m ixed state, then the parity m eter still accomplishes a Bell state preparation of the two states  $j_{B1}i$  and  $j_{B2}i$  with a success probability of 1=4 each. If there are non-ideal symmetries, e.g.  $_{1} \in _{2}$ , then, on longer time scales, there will be random switching between the different parity classes.

Before proceeding to the next section, we brie y note that the needed sym metry in the coupling constants between detector and each of the qubits may be tested by DC current measurements, using gate voltages to force the quantum dots into each of the four classical con gurations. If there is any asym metry, this will show up in a slight current di erence when comparing the di erent con gurations. The di erence of the couplings constants can by slightly tuned with the use of top gates.

## IV. APPLICATIONS OF THE PARITY METER

We describe two applications of the parity meter of interest for quantum information processing. The rst one is a new proposal to test Bell's inequality in the solid state. The second one is an example of a realization of a CNOT gate using QPC's and DQD's as building blocks.

#### A. Testing Bell's inequality




FIG. 3: Bell inequality setup. In order to be able to do a measurem ent of a violation of a Bell inequality, we use a QPC as a parity meter between two qubits to create a Bell state. The two outer detectors are then used to projectively measure charge in the  $_z$  basis of each qubit.

A slight modi cation of our setup as schematically shown in Fig. 3 can be used to violate Bell's inequality. The Bell's inequality measurement consists essentially of four consecutive steps:

- 1. Preparation step. D uring the preparation step, the two DQD's have to be held at the sym m etry point, i.e.  $_1 = _2 = 0$  and  $_1 = _2 =$ , where the H am iltonian H  $_{\rm SP}$  describes the two-qubit system. A m easurement of the parity m eter, i.e. the center QPC, is done. If the m easurement is either I<sub>odd</sub> or I<sub>even</sub>, then we know that either state j B1i or state j B2i, respectively, has successfully been prepared.
- 2. Decoupling step. Once we know that the system is in one of the two Bell states  $j_{B1}i$  or  $j_{B2}i$ , we would like to turn the coupling between the two qubits o . In our setup, the coupling between the two DQD's can be minimized by setting  $V_{\text{bias}} = 0$ and by pinching o the QPC.

- 3. Single qubit rotation step. In order to do a measurem ent of a violation of a Bell inequality in the C lauser-H ome-Shim ony-Holt (CHSH) form,<sup>18</sup> we have to rotate each qubit and afterwards measure qubit-qubit correlators in di erent bases. The single qubit rotation can be done by pulsing 1 (t) and 2 (t) independently of each other. Thus, during this step, we drive the system away from the symmetry point. Note that this is the only option to measure the two qubits in di erent bases, because typical measurement devices for charge qubits can only measure in the z basis of the qubit. Therefore, we have to rotate the state instead of the measurement device (which is the usual practice in Bell inequality measurements with photons).
- 4. M easurem ent step. Im mediately after the single qubit rotation step, we should be able to do a strong (projective) measurement in the  $_z$  basis of the qubit using high-delity single shot detectors. This can, for instance, be accomplished by single electron transistors as illustrated in Fig. 3. The time delay between the two projective measurements is analogous to the relative phase between the beam splitters in the original CHSH proposal.

An alternative to fast time resolved projective measurements required for both the Bell inequality, and the CNOT gate of the next section, is making a series of many weak \kicked" quantum nondem olition measurements at a repetition rate commensurate with the Rabiperiod of the qubits. In this alternative, the qubits are not detuned from their symmetry point, and single-qubit rotations are accomplished by simply waiting.<sup>19</sup>

W e have to repeat the four steps m any times with the same time delay to obtain the correlation function

of the direct product of a \spin" m easurem ent in qubit 1 along unit vector a and in qubit 2 along unit vector b.




FIG.4: CNOT gate setup. This setup contains three qubits and two parity meters, i.e. QPC's, in between them. The qubits are the control qubit (C-Qubit), the ancilla qubit (A – Qubit) and the target qubit (T-Qubit). An additional projective measurement device is attached to the A-qubit.

Note that in our proposal the di erent angles a,  $a^0$ , b, and  $b^0$  are realized by an appropriate application of the single qubit rotation step. A coording to B ell, correlations are nonclassical if we violate the inequality

$$B = jC_{ab} + C_{a^0b} + C_{ab^0} - C_{a^0b^0} j - 2; \qquad (29)$$

A simple way of analyzing the dephasing time in the system would be to choose di erent time delays after which the single qubit rotation step sets in.

# B. CNOT gate

The setup of a realization of a CNOT gate using charge parity m eters is shown in Fig. 4 and follows the idea of R ef. 1. It consists of three di erent charge qubits and two parity m eters. During the operation time of the CNOT gate  $t_{op}$  coherent evolution of the charge qubits should be negligible, which m eans that  $t_{op}$  1. Furtherm ore,  $t_{op}$  has to be smaller than the typical dephasing time  $T_2$  of the qubits. Note that in superconducting charge qubits, a CNOT gate operation has already been demonstrated experimentally<sup>20</sup> and interesting proposals for the implementation of di erent kinds of two-qubit gates exist.<sup>21</sup>

The Ham iltonian of the CNOT gate may be written as

$$H_{CNOT} = H_{QD} + H_{QPC} + H_{int}$$

with

The energies and (=1;2;3) can (in principle) be controlled at any time by changing the gate voltages

W e now assume that the control qubit and the target qubit are in a given state. It is in portant for the scheme to work that the ancilla qubit is prepared in the state  $j_{AQ}i = (j''i + j#i) = 2$ . It should be rather easy to prepare the desired state of the ancilla qubit because it is the ground state of the DQD system when the tunnel coupling is nite.<sup>22</sup> Under the constraint  $t_{op}$ 1, mentioned above, the outcome of the parity measurement can just take two values, corresponding to I<sub>odd</sub> or  $I_{\rm even}\,$  of Sec. III. Then, a measurement of  $I_{\rm odd}\,$  shows that the two qubits involved in that measurem ent exist in the subspace spanned by the states j "#i and j #"i, whereas a measurement of  $\mathrm{I}_{\mathrm{even}}$  indicates that the two qubits involved in that measurement exist in the subspace spanned by the states j""i and j##i.

Apart from the measurements of the two parity meters, the only other ingredients needed to build a deterministic CNOT<sub>p</sub> gate are single qubit H adam and gates H = (x + z) = 2. A H adam and gate acting on qubit can be realized by tuning the corresponding single qubit H am iltonian

$$H = \frac{1}{2} \qquad {}^{()}_{z} + {}^{()}_{x} \qquad (34)$$

to the special symmetry point = and letting it act for a time  $t_H = -\frac{1}{2}$ . For this single qubit rotation, we need to raise and temporarily.

The operation scheme of the CNOT gate goes as follows:

- 1. Preparation of the ancilla qubit. This can be either done by acting with H  $_2$  on state Ji of qubit 2 or by ground state preparation of a tunnel-coupled double dot.
- 2. Parity measurement with QPC 1. The outcome of that measurement  $p_1$  has to be stored.  $p_1 = 0$  corresponds to the odd parity class, whereas  $p_1 = 1$  corresponds to the even parity class. The same holds, of course, for  $p_2$ , i.e. the outcome of the parity measurement 2 below. A flerwards, we need to decouple the control and the ancilla qubit.
- 3. Hadam and step 1. Acting with H  $_2$  on the ancilla qubit and with H  $_3$  on the target qubit, which m eans in practice to wait for an appropriate time t<sub>H</sub> after tuning the single qubit H am iltonians.
- 4. Parity measurement with QPC 2. The outcome of that measurement p<sub>2</sub> has to be stored. A flerwards, we need to decouple the ancilla and the target qubit.
- 5. Hadam and step 2. Once more, acting with H  $_2$  on the ancilla qubit and with H  $_3$  on the target qubit.
- 6. M easurem ent of ancilla qubit. This m easurem ent has to be done in a projective way.

7. Post-processing step. Depending on the outcome of the measured state of the ancilla qubit as well as  $p_1$  and  $p_2$ , we nally have to apply single qubit operations to the control and the target qubit, which we call  $_c$  and  $_t$ . For the control qubit,  $_c = _z$ if  $p_2 = 0$ , while no post-processing of the control qubit is needed if  $p_2 = 1$ . For the target qubit,  $_t = _x$  if the ancilla qubit is down and  $p_1 = 1$ , or if the ancilla qubit is up and  $p_1 = 0$ . O therw ise, no post-processing of the target qubit is needed. Applying a conditional operation of  $_x$  or  $_z$ , this means in practice making for the form er case or vice versa for the latter one.

As demonstrated in detail in Ref. 23, the di erent steps described above allow for a CNOT operation on the control and the target qubit.

# V. CONCLUSIONS

W e have proposed a realization of a charge parity m eter, i.e. a device that can distinguish between the subspaces of two parity classes of quantum states but cannot distinguish between di erent states in each parity class. If the states are two-qubit states (in our case, the states that characterize two charge qubits) a parity m eter based on a QPC placed in a proper way between the two qubits acts as an entangler just by a current measurem ent. Such a device is a speci c realization of a mesoscopic quadratic quantum measurem ent.<sup>4</sup>

Furtherm ore, we have dem onstrated that the charge parity m eter supplem ented by two single qubit charge detectors can be used to do a m easurem ent of a violation of B ell's inequality in the solid state. To accomplish this, we have exploited the idea to use single qubit rotations instead of a rotation of the m easurem ent device in order to be able to m easure CHSH correlators in four di erent bases.

Finally, a CNOT gate operation has been described using two parity m eters and three qubits. Thereby, one of the three qubits just acts as an ancilla qubit to enable a determ inistic gate, whereas the other two qubits are the standard control and target qubit that are manipulated by the CNOT operation.
