M ass enhancement, correlations, and strong coupling superconductivity in the -pyrochlore K O s₂O ₆

Abstract

To assess electron correlation and electron-phonon coupling in the recently discovered – pyrochlores KO s₂O ₆ and RbO s₂O ₆, we have perform ed speci c heat m easurements in m agnetic elds up to 14T. We present data from high quality single crystalline KO s₂O ₆, showing that KO s₂O ₆ is a strong coupling superconductor with a coupling parameter $_{\rm ep}$ 1:0 to 1:6 (RbO s₂O ₆; ep 1). The estimated Sommerfeld coe cient of KO s ₂O ₆, = 76 to 110m J=(m olK²), is twice that of RbO s₂O ₆ [= 44m J=(m olK²)]. U sing strong-coupling corrections, we extract useful therm odynamic parameters of KO s₂O ₆. Quantifying $_{\rm ep}$ allow s us to determ ine the mass enhancement over the calculated band electronic density of states. A signi cant contribution in addition to the electron-phonon term of $_{\rm c} = 1:7$ to 4:3 is deduced. In an e ort to understand the origin of the enhancement m edhanism, we also investigate an unusual energetically low -lying phonon. There are three phonon m odes per RbO s₂O ₆, suggestive of the phonon source being the rattling m otion of the alkali ion. This dynamic instability of the alkali ions causes large scattering of the charge carriers which shows up in an unusual temperature dependence of the electrical resistivity.

I. IN TRODUCTION

Long standing interest in the pyrochlores stem s from their inherent geom etrical frustration due to the m etal ions form ing a network of corner-sharing tetrahedra. For insulating pyrochlores, where localized m agnetic m om ents sit on the vertices of these tetrahedra, com – peting interactions lead to a wealth of novel states of fundam ental interest. G round states of in nite degeneracy are a typical signature of such frustrated system s.[1, 2, 3] W hile for insulating system s the intim ate connection between spins and the lattice topology leads to the observed frustration e ects, it is an open question how charge, spin, and lattice degrees of freedom are coupled in itinerant system s and how they in uence each other.

In this context, the superconductivity recently found in KO s_2O_6 has been of considerable interest:[4] It has been thought that a spin liquid ground state resulting from frustration in these structures m ight favor superconductivity through singlet pairing by a resonating valence bond.[5] At the time of its discovery, KO s_2O_6 was the second pyrochlore superconductor known after $Cd_2Re_2O_7$.[6, 7, 8] Soon after, the discovery of superconducting RbO s_2O_6 [9, 10] and $C sO s_2O_6$ [11] followed. $Cd_2Re_2O_7$ crystallizes in the so-called -pyrochlore structure, the structure adopted by num erous insulating pyrochlores, and AO s_2O_6 (where A = C s, Rb, or K) has the -pyrochlore structure. W hile the AO s_2O_6 com pounds could be expected to be very sim ilar in their physical properties, there is in fact quite a variation am ong them.

For example, T_c decreases from 9:5K for KOs₂O₆ to 6:4K for RbOs₂O₆ and to 3:3K for CsOs₂O₆. The nature of the superconducting state is still under discussion: while RbOs₂O₆ appears to be a fully gapped s-wave superconductor with a critical temperature $T_c = 6:4K$, [12, 13, 14, 15, 16] -SR m easurements point towards an anisotropic or multigapped superconducting state in KOs₂O₆. [17] This question has not been settled conclusively. It has been found that KOs₂O₆ single crystals show B ragg peaks that violate the F d 3m symmetry and the structure has been identied as non-centrosymmetric F 4 3m .[18] Furtherm ore, it remains to be determined to what degree the quasiparticle m ass is enhanced by interactions other than those with ordinary phonons, e.g. to what extent electron-electron correlations play a role in these compounds. In order to address these questions a detailed characterization of these compounds is required.

In this paper, we present eld and tem perature dependent therm odynam ic and transport measurements on RbO s_2O_6 and KO s_2O_6 . The data provide evidence for a signi cant addi-

tional electronic m ass enhancement beyond the contribution from the coupling to phonons and evidence for low -lying vibrationalm odes. We discuss similarities and dierences between the two compounds and compile an extended list of the basic therm odynamic parameters.

II. EXPERIMENTAL

KOs₂O₆ single crystals have been grown by an encapsulation technique in an evacuated quartz tube. In this method, a stoichiom etric amount of Osmetal (Alfa Aesar, 99:9%) and KO₂ (Alfa Aesar, 95%) is thoroughly mixed in an argon lled dry box and pressed into a pellet. The pellet with a mass of 0.2 to 0.25g is put into a quartz tube and silver oxide A g₂O (Aldrich, 99%) is added to create an appropriate oxygen partial pressure during the synthesis. The evacuated and sealed tube is then inserted into a fumace preheated to 600 C, kept there for 1 h, cooled to 400 C at a rate of 5 C = h, and then cooled to room temperature at a rate of 150 C = h. The resulting black single crystals of size up to 0.3 mm in diameter have grown on the wall of the quartz tube and on the surface of the precursor pellet. The crystals have di erent shapes characteristic for the cubic structure such as octahedra or cubes. The lattice parameter re ned from x-ray single crystal measurements is found to be a = 10.0968 (8) A. No signature of in purity phases like 0 sO₂ or KO sO₄ was found in heat capacity and m agnetization measurements.

For the speci c heat m easurem ents, we have selected about ve dozen of the m ost regularly shaped single crystals out of a single badge. The total m ass of these crystals amounts to 2:12 m g (see inset to Fig. 2), which is enough to m easure speci c heat with a relaxation m ethod. Special attention m ust be paid, how ever, to m easure the addendum contribution as it m akes up a signi cant fraction of the total m ass. The speci c heat has been m easured in a physical properties m easurem ent apparatus using an adiabatic relaxation technique (Q uantum D esign, PPM S). Resistivity has been m easured by a standard four term inal approach also using the PPM S and the dc m agnetization has been m easured in a SQU ID m agnetom eter (Q uantum D esign, M PM S). M easurem ents on RbO s_2O_6 have been perform ed on a sam ple previously reported upon in R ef. [15]. The synthesis procedure of these polycrystalline RbO s_2O_6 sam ples is described elsewhere.[4, 19]

III. RESULTS

In order to determ ine the mass enhancement in the normal state and the magnitude of the electron-phonon coupling, it is necessary to measure the Sommerfeld coe cient of the superconductor by driving it into the normal state. U sually this is achieved by applying a magnetic eld exceeding the upper critical eld H $_{c2}$. Owing to a high H $_{c2}$ (OK) of KO s₂O $_{6}$ which is unaccessible by our 14T magnet, it is not possible to tune KO s₂O $_{6}$ into its normal state below about 62K. We therefore resort to an extrapolation method to estimate the Sommerfeld coe cient: rst we measure the phase boundary line H $_{c2}$ (T) to as low a temperature and high eld as possible. We then extrapolate H $_{c2}$ to 0K and estimate the Sommerfeld coe cient based on the measured C $_{p}$ =T versus magnetic eld curve at a low temperature. The details of this procedure are given in the following.

A. Upper critical eld H_{c2}

W e extract the upper critical eld H $_{c2}$ from C $_{p}$ (T) data for K O s₂O $_{6}$ and from both C $_{p}$ (T) and C $_{p}$ (H) data for RbO s₂O $_{6}$. For both m ethods, we use a construction of equal area to determ ine the critical eld. The two m ethods result in almost identical H $_{c2}$ as can be seen in Fig. 1. In our experience, the H $_{c2}$ slope at T $_{c}$ for both RbO s₂O $_{6}$ and K O s₂O $_{6}$ are rather stable quantities varying little from sample to sample. We therefore have a high level of con dence that the observed slope is indeed intrinsic to the material and not mainly limited by a mean free path caused by in purity scattering.

The initial slope of the critical boundary at T_c for KO s_2O_6 is 3:6T=K, in agreement with the revised value in R ef. [10, 20]. The full H_{c2} (T) dependence cannot be mapped out with the 14T magnet, so we need to extrapolate to lower temperatures and we proceed in two dimensions ways: rst, we notice that H_{c2} (T) in RbO s_2O_6 is rather well described by the standard W HH expression, with an initial slope of 1.2T=K and $_{0}H_{c2}$ (0K) = 6T (Fig. 1).[12] If we were to assume the same functional form to hold also for KO s_2O_6 , $_{0}H_{c2}$ (0K) = 24T is estimated. Considering that a typical energy of low-lying phonons in KO s_2O_6 is around 30K, H_{c2} m ight be underestimated in this way. A liternatively, one can extrapolate linearly to T = 0K and would estimate $_{0}H_{c2}$ (0K) = 35T. Pursuing this second extrapolation further is motivated by our observation that the last data points in our data lie closer to a straight line extrapolation of the lower-eld data, while the W H H curve starts deviating from the data in this region. In the rest of this paper, we thus consider both extrapolations, denoting with (A) the W H H version, and with (B) the linear method. Numerical values for (B) will be enclosed in braces fg.

It is worth noting that the RbO s_2O_6 data are tted best by the W HH formula in the orbital limit ($_{SO}$ = 1). This is in agreement with a large $_{SO}$ expected for the heavy O s ion. Therefore, pair-breaking e ects of the magnetic eld on the spin degrees of freedom are negligible due to the random izing e ect of the spin-orbit scattering on the phase of the superconducting electrons. An upper limit of the critical eld in the case where spinorbit scattering could be ignored, is given by the Pauli-limiting eld: for KOs_2O_6 it is $_{0}H_{P} = (0K) = (\frac{p}{2}_{B})^{p} \frac{1}{1 + ep} = 37T f 27Tg, while for RbO s_{2}O_{6}$ it is about 18T. Here we have used the values for (0 K) and $_{ep}$ determ ined from our measurem ents as described later and listed in Table I. For R bO s_2O_6 , this eld is well above the measured upper critical eld, while for KO s_2O_6 the comparison depends on the extrapolation of H $_{c2}$. Support for the fact that H_{c2} is determined by the orbitalm otion of the electrons and not by their spin, is provided by the ratio of the slopes d_0H_{c2} =dT j_c for the two materials RbO s_2O_6 and K O s₂O $_6$. The slopes are proportional to 1=(v_F^2), where is the electronic scattering time and v_F the Fermi velocity. For the Fermi velocities we use 2:587 10 cm =s for R bO s_2O_6 and 2:671 10 cm = s for K 0 s₂0 $_{6}$. [21] The ratio of the Ferm ivelocities squared, taking into account the renorm alization of the Ferm i velocity and assuming the same for both materials, is 2.4 f4:7g. This is indeed close to the ratio of d $_{0}H_{c2}$ =dT \dot{H}_{c} for RbOs₂O₆ and KOs₂O₆: 3.6=1.2 = 3, suggesting that the pair-breaking is caused conventionally by the e ect of the magnetic eld on the orbital magnetism of the electrons. The di erence in magnitude of the upper critical elds is therefore in line with the di erent m assenhancem ents.

B. Heat capacity in a magnetic eld

We have measured the eld dependence of $C_p=T$ of KO s₂O₆ at 0:46K, shown in Fig. 2. The addendum is 10% of the total heat capacity at ₀H = 14T, 20% at ₀H = 7T, and 50% at ₀H = 3T. Below ₀H = 1:7T, the addendum makes up more than 90% of the total heat capacity, and even though both data sets are very smooth, this leads to relatively larger scatter after taking the di erence of the two data sets. For this reason, data below 1:7T have been om itted in the graph and in the tting procedure.

W e param eterize the m easured curve by $C_p=T = a (H = 0 e)^b + c$. A least squares t down to 1:75T using this form results in $a = (5:86 \ 1:3) \ 10^4 \text{ m J} = (m \text{ olK}^2), b = 0:9512 \ 0:02,$ and $c = 0:35 \ 0:4m \text{ J} = (m \text{ olK}^2)$, where H is given in 0 ersted. An extrapolation of the C_p (H) curve at 0:46K to the upper critical eld H $_{c2}$ of 24T f35Tg results in a rather high Som m erfeld coe cient for K0s $_20_6$ of $= 76m \text{ J} = (m \text{ olK}^2)$ f110m J= (m olK²)g.

The fact that we have measured a vanishingly small $C_p=T$ at H = 0.0 e and T = 0.46 K is of significance for the interpretation of the electronic and vibrational excitation spectrum. First, it indicates that the superconducting state a ects the entire electronic system that gives rise to the large value [76 to $110 \text{ m J} = (\text{m olK}^2)$]. Secondly, the vibrational excitation spectrum (at 0.46 K) is not characterized by a glass-like spectrum (C_p / T) as one m ight expect from a broad distribution of 2-level con gurations possibly associated with the particular lattice potential experienced by the K ions.[22]

In addition to estimating the Sommerfeld coection, measurements of the magnetic eld dependent heat capacity can be helpful to reveal nodes in the gap function. It is generally thought that a square root dependence $C_p=T$ / H with = 1=2 indicates a gap with nodes, while a linear dependence = 1 indicates a fully gapped state.[23] This is because the electronic excitations in the vortex state of conventional superconductors are predom inantly low energy excitations localized in the vortex core. On the other hand, the density of states for superconductors with lines of gap nodes results mostly from delocalized states outside the vortex which are located in the vicinity of the gap nodes in momentum space.

W e expect that the exponent in the above t to C_p versus H tends even closer tow and 1 as T ! 0 K, since the exponent decreases when m easuring at increasingly higher tem peratures (data not shown). The eld-dependence of the heat capacity of K O s₂O ₆ thus appears to be in line with a fully gapped state. However, since the m easurem ents do not extend up to H _{c2}, further experimental evidence is needed to settle this point conclusively.

C. Density of states and m ass enhancem ent

The speci c heat for KOs_2O_6 in various elds is shown in Fig. 3. In addition to the anomaly indicating the transition into the superconducting state, there are two additional peaks at $T_{p;1}$ (6.5K) and $T_{p;2}$ (7K). The origin of these peaks is unclear at this point.

They are likely to be associated with the dynam ics of the potassium ions in this compound. W hile we measure two peaks for our sample, a single peak has been reported in Ref. [10, 20] at a slightly higher temperature (about 7.5 K) - the transition seems to be very sensitive to microscopic details.

From the speci c heat jump at T_c , $C_p \dot{f}_c = T_c = 204 \text{ m J} = (\text{m olK}^2)$, the norm alized speci c heat jump $C_p \dot{f}_c = (T_c) = 2.7 \text{ fl} \cdot 9 \text{ g}$ is extracted. It is significantly larger than in the weak-coupling limit and corresponds to an electron-phonon coupling constant $_{ep} = 2 \frac{R_1}{0} - 2 \text{ F}(!) = ! \text{ d!}$ 1:6 fl $\cdot 0 \text{ g}, [24]$ i.e. KO $s_2 O_6$ is a superconductor in the strong-coupling regime. Here, $^2 \text{ F}(!)$ is the spectral density of the electron-phonon coupling function. U sing the calculated band Sommerfeld coe cient $_b = 9.8 \text{ to } 11.36 \text{ m J} = (\text{m olK}^2) \text{ of KO} s_2 O_6$ from Refs. [22, 25], this result indicates a significant enhancement of the electronic specific heat of $(1 + _{ep})(1 + _c) = [76 \text{ m J} = (\text{m olK}^2)] = [10.6 \text{ m J} = (\text{m olK}^2)] - 7.2 \text{ fl} 0.4 \text{ g}$, i.e. about double the enhancement found in $\text{Sr}_2 \text{RuO}_4$ of 3.8 to 4.[26, 27] This quantification of $_{ep}$ then leaves a significant additional enhancement $_c$ 1:7 f4.3 g ascribed to electron-electron correlations.

Figure 4 illustrates the density of states for KOs₂O₆ and RbOs₂O₆ and the weak-coupling -pyrochlore superconductor Cd₂Re₂O₇ for comparison. The depicted band density of states for AOs₂O₆ is the arithmetic mean of the two calculated values in Refs. [2, 25], and the values for Cd₂Re₂O₇ are taken from Refs. [6, 28]. It increases very slightly on going from A = K to A = Rb to Cd₂Re₂O₇, but is rather similar overall. The electronic structure in the LDA as a whole is in fact very similar for all AOs₂O₆. The electron-phonon enhancement, on the other hand varies signicantly: ep is less than about 0.4 for Cd₂Re₂O₇, but falls in the intermediate to strong-coupling range for the osmates (1 to 1:6), indicating that there is a signi cant di erence in the coupling functions leading to the superconducting state. The di erence in the additional enhancement c is pronounced: it increases more than twofold from RbOs₂O₆ to KOs₂O₆, in the same direction as ep.

To gain further insight into the mechanisms responsible for the density of states enhancement, it is helpful to consider the magnetic susceptibility (Fig. 5). Since samples of RbOs₂O₆ also contain som e OsO₂, the intrinsic magnetic susceptibility is calculated according to $_1 = _{m}^{1}$ ($_{m}^{1}$ 1) $_2$, where $_1$ is the magnetic susceptibility of RbOs₂O₆, $_2$ that of OsO₂, and is the measured susceptibility of the mixed system (c.f. Sec. IIIE). The susceptibilities in this form ula are given permass. The correction due to OsO₂ is very sm all, since the susceptibility perOs is very similar in both systems. Even after taking into account

the correction for $0 \le 0_2$, the susceptibility of R b0 $\le 0_6$ still shows a slight increase at low tem peratures and also a shoulder around 25K. This is probably due to m inute am ounts of m agnetic R b0 $\le 0_4$. We note that a sim ilar T dependence as for the susceptibility has been observed for the K night shift in both R b0 $\le 0_6$ and K 0 $\le 0_6$.[29]

We correct for the diam agnetism of the core using = exp 12, core with core =20, 13, and 18 cm³=molfor 0^2 , Rb⁺, K⁺, and 0 s^{6+} ions respectively. Landau diamagnetism can be neglected, due to the enhancement of the electron mass. For the experim ental susceptibility, we use the value at 150 K, resulting in a susceptibility for KO s_2O_6 of 3:7 10^4 cm³=m ol. The Som m erfeld-W ilson ratio evaluates to $R_W = 0.93 \text{ G}^2$ cm³=erg em u f0:65 G² cm³=ergg where we have used the renorm alized Sommerfeld coe cient = $(1 + _{ep})$ since the Paulim agnetic susceptibility is not a ected by electron-phonon interactions. For $RbOs_2O_6$ follows ^{em u} 5:3 10^4 cm³=moland R_W = 1:75G² cm³=erg. In view of a calculated Stoner enhancement of the magnetic susceptibility of roughly 2 for all AO s_2O_6 (Refs. [22, 25]), the W ilson ratio for RbO s_2O_6 closely m atches the expected result. On the other hand, R_W for KO s₂O ₆ is clearly sm aller than what would be expected. In this simple estimate, we have neglected possible orbital van V leck terms that may also contribute to the param agnetic susceptibility.

D. Superconducting Properties

It is instructive to calculate the various them odynam ic parameters for KOs₂O₆ and RbOs₂O₆. We get a strong-coupling parameter $x = k_B T_c = (-!_n) = 0.13$ f0.06g by applying the approximate sem iphenom enological form of the strong-coupling correction to the weak coupling BCS ratio which holds for many superconductors $C_p j_c = (T_c) = 1.43 [1 53x^2 \ln (3x)]$. [30] Here $-!_n$ is the Allen-Dynes expression for the average phonon energy. With this strong-coupling parameter we further get a normalized energy gap of 2 (OK) = (k_B T_c) = 3.53 [1 12.5x^2 \ln (2x)] = 4.57 f3.83g. Since we know from RbOs₂O₆ that another strong-coupling correction, 1=(8) $\hat{f}=(F) = 0.168 [1 + 12.2x^2 \ln (3x)]$, holds quite well, [15] it is reasonable to assume that it also holds for KOs₂O₆. Using the experimental T_c , and the strong-coupling parameter from above, we can estimate the condensation energy of KOs₂O₆: F = 2050 m J=m olf 2533 m J=m olg, corresponding to a therm odynam ic critical eld of $H_c = 25790 \text{ e} 128670 \text{ eg}$. In this conversion we have used the

calculated m ass density of KO s_2O_6 using the lattice constant from x-ray, = 6:653 g=cm³. The ratio 1=(8) ($\frac{2}{3}$)=(F) itself evaluates to 0:135 f0:157g.

O noe the condensation energy is known, various therm odynam ic quantities can be evaluated: for bT_c (T C $_p$) \dot{f}_c =(F) we get 9.02 f7:30g, giving a normalized critical eld slope Q = 4.25 f3:82g. The critical eld slope itself evaluates to dH $_c$ =dT \dot{f}_c = 5750 e=K. The slope of the upper critical eld is about 3 times steeper than the one from RbO s₂O $_6$: with d $_0H_{c2}$ =dT \dot{f}_c = 3:6T=K (Fig.1) we get a G inzburg-Landau parameter at the critical

tem perature of $(T_c) = 45$. At T ! 0K, we estimate $(0K) = 1 = \frac{p}{2}$ $H_2 = H_c = 66$ f86g and thus a penetration depth of 243 nm f265 nm g, which compares well with results from - SR experiments (270 nm).[17] The G inzburg-Landau coherence length amounts to = 37A f31 Ag and the lower critical eld $H_{c1} = \ln = (\frac{p}{2})H_c = 1160 \text{ e}$ f1050 eg. This lower critical eld is in agreement with magnetization measurements (not shown). The G inzburg-Landau coherence length is about half that of RbO s₂O₆. The parameters are listed in Table I, where they are compared to the values of RbO s₂O₆ taken from Ref. [15] for convenience.

 H_{c2} for KO s₂O ₆ is beyond the 14T accessible in our current setup, so that the samples cannot be tuned to the norm all state below about 6.2K. There is thus no reference m easurement for the heat capacity in the norm all state and the superconducting electronic species heat C_{es} cannot be determined by a simple subtraction of a norm all state and a superconducting state m easurement. This renders determining additional contributions to the heat capacity other than the usual phononic and electronic terms discut.

E. Unusual low -energy atom ic vibrations

The speci c heat of RbO s_2O_6 is analyzed using the condensation energy analysis (CEA) developed in Ref. [15]. This is necessary because it is not yet possible to synthesize a fully phase pure RbO s_2O_6 sample. $O \, sO_2$ has been identified by x-ray diffection analysis as a secondary phase. This shortcoming is compensated by the fact that by using the CEA it is possible to extract the intrinsic properties of superconducting RbO s_2O_6 even if the samples contain some unreacted $O \, sO_2$ starting material.

The full tem perature dependence of the intrinsic heat capacity of R bO s₂O₆ is therefore obtained by subtracting the appropriate amount of the O sO₂ heat capacity contribution according to $C_1 = {}_m{}^1C$ (${}_m{}^1$ 1)C₂. Here, C_1 is the heat capacity of R bO s₂O₆, C_2 of O sO₂, and C is the measured heat capacity of the mixed system, all in energy per temperature per mass. To this end we have measured a sample of the starting material O sO₂. Its heat capacity is shown in Fig. 6 (C₂) together with the heat capacity of a RbO s₂O₆ sample (C) with a superconducting mass fraction of ${}_m = 74.9\%$. Hence, the difference between the mixed system heat capacity C and 25:1% of C₂ (shaded region) is 74:9% of the intrinsic heat capacity of RbO s₂O₆ C₁. The Som merfeld coe cients used in the plot are = 27.5 J=(gK²) for 0 sO₂ and = 70.3 J=(gK²) for the RbO s₂O₆ sam ple.

The resulting speci c heat of RbO s_2O_6 (C₁) on a logarithm ic temperature scale is shown in Fig. 7. In such a plot, an Einstein contribution to the heat capacity appears as a bellshaped feature with a peak at $T = T_E = 4.93$.[31] The data clearly indicate such a contribution with an Einstein temperature of 60 K and a density of 0.33 9m odes=fu:. A ssum ing this phonon involves the displacement of the Rb atom s, this means an elective number of 3 m odes per Rb ion. Three modes are compatible with a 3-dimensional potential for the Rb ions to move in as is expected from the tetrahedral symmetry of the Rb site.

A s the KO s_2O_6 samples are high-quality single crystals, the KO s_2O_6 data can be analyzed as measured. We have observed a vanishingly small residual Sommerfeld coecient (C $_p$ =T !

0:4 m J= (m olK²) as H ! 00 e at 0:46K) as expected from a single phase sample 0:35 and indicative of a fully gapped electronic excitation spectrum. The tem perature dependent lattice heat capacity data is shown in Fig. 8. In the normal state above 62K, T was used for the electronic heat capacity C_{el}. The low temperature data from 2 to 3:8K were obtained using the electronic heat capacity of an isotropic superconductor $C_{el} = C_{es} =$ 8.5 $T_c \exp(1.44 \ 2 \ (0 \text{ K})=3.53 \ \text{T})$. The data does not t as nicely to a combined Debye-Einstein model as does the data for RbOs₂O₆. This might be due to the alkaliion potential being very anham onic, leading to a vibrational spectrum that is not simply modeled by an Einstein mode. Nevertheless, we show a best tofan Einstein contribution to the data in the gure, resulting in n = 0.15 9m odes=fu: and T = 31K. For the D ebye contribution which is expected to result mainly from the rigid 0 s-0 network we have reused the D ebye tem perature from $RbOs_2O_6$. The question about the low energy lattice dynamics appears to be central to the physics of KOs_2O_6 . The calculated anham onic potential for the K ion results in a set of discrete vibrational energies, leading to a distinct T dependence of the speci c heat.[32] The data deviates markedly from this model calculation at low tem perature (Fig. 8). Possibly, this indicates a freezing of the dynam ic motion of the alkali ion.

F. Resistivity

As has been noted before,[4] the resistivity of $K O s_2 O_6$ shows a peculiar downward curvature, which extends to the lowest measured temperatures. This downward curvature also exists in the other AO $s_2 O_6$ compounds, though at di erent temperatures: the curve looks

like an additional hump superimposed on a more smooth background, the hump having its peak at a temperature shifting system atically to higher temperatures on going from A = K to A = C s. We analyze this behavior by taking the derivative of the resistivity with respect to temperature and then locating the maximum of the resulting curve. Owing to varying e ective geometric factors due to grain sizes, the absolute values of the resistivities among samples vary signi cantly. In Fig. 9 we therefore show the normalized derivative of the resistivity where we have set the peak value to unity.

For illustrative purposes, we compare these results with a model calculation for the resistivity caused by an Einstein phonon:[33]

where m is the averaged band mass, ${}^{2}F_{E}$ is an Einstein spectral function, n is the number of conduction electrons per unit volume, e is the elementary charge, and $k_{B}T_{E}$ is the energy of the Einstein mode. The inset of Fig. 9 shows the derivative of the model resistivity for a peak at 50 K. It describes the data well at low temperatures, but deviates at higher temperatures, where the model predicts a resistivity linear in T.

The resulting temperatures T_{peak} at which d =dT peaks are plotted in Fig. 10 versus $T_{E \text{ instein}}$, the energy of the E instein phonon m ode extracted from the heat capacity m ea-70K for $C sO s_2O_6$ is taken from Ref. [10, 34]. It can be shown that surement. T_{E instein} the derivative of the model resistivity d $_{ph}=dT$ shows a maximum at $T_{peak} = T_E = a$, where а 2243.[43] For illustrative purposes, this line is shown along the experimental results from AO s₂O₆ in Fig. 10. A sone m ight expect, this simple E instein phonon m odel is not su cient to describe the entire (T) curves, because scattering at other phonons is not included. If a second phonon is considered and the resulting resistivity is assumed to be simply the sum of the two single-phonon results according to M atthiessen's rule, then the location of the peak m oves m ore toward the m easured points: in an analysis of the speci c heat data, H iroi et al.[10, 34] have explained their data using a second phonon at around 140K for R bO s_2O_6 and around 175K for C sO s_2O_6 . Including a phonon at these tem peratures moves the peak location up in temperature to 51 K for R bO s_2O_6 and 64 K for C sO s_2O_6 , shown by blue stars and arrows in Fig. 10. The deviation of the C $sO s_2O_6 T_{peak}$ towards even higher tem peratures m ay be due to the fact that at these tem peratures a signi cant contribution to the phonon spectrum already stems from the Debye-phonons neglected up to now in the

transport model. The overall trend, however, is well represented by such an analysis and it points to the signi cant scattering by the A atom s.

IV. DISCUSSION

The system atic variation of the position of the maximum slope in the resistivity indicates a close connection between the dynamics of the alkali ion A and the electronic transport properties. $K O s_2 O_6$ is somewhat di erent from the other two compounds, because its peak tem perature is lower than expected from the simple Einstein phonon model (Fig. 10). This m ight be a result of the strong anharm onicity of the cage potential. It is known that the alkali ions move in a strongly anham onic potential and couple to the conduction electrons owing to their large excursion from equilibrium, and previous results have been interpreted in this scenario.[10, 34]. This results in the electron-phonon coupling parameter ento increase, driving KOs₂O₆ more towards the strong-coupling regime. Electron scattering from the alkalim ode as the reason for the downward curvature of the resistivity has been suggested before by K unes et al., (Ref. [22]). W hile the scattering at phonons seem s to be the most plausible mechanism at this point, other scenarios for the peculiar behavior of the resistivity are also conceivable: Ferm i surface nesting has been found in KOs_2O_6 and has been proposed as the driving force for strong spin uctuations.[35] It remains to be worked out in detail to what degree such uctuations or even m ore exotic excitations could account for the measured resistivity. We note, however, that the static susceptibility of KO s_2O_6 is not signi cantly enhanced; rather it is smaller than expected based on the band density of states.

In the following we try to identify the various contributions to the measured mass enhancement relected in the Sommerfeld coellist. It is known that C oulomb and electron-phonon elects in a metal can be combined in a multiplicative fashion [36] An interpretation of the additional enhancement in terms of C oulomb correlations would therefore mean a parametrization according to $1 + = (1 + _{ep})(1 + _{ep})$. In this interpretation the over-all bandwidth is reduced by a factor of $1 + _{ep}$ due to electron-electron interactions. The resulting C oulomb enhancement parameter $_{c}$ for RbO s₂O $_{6}$ is 1:0 and for KO s₂O $_{6}$ it is 1:7 f4:3g, from which we estimate the interaction strength: assuming a conduction electron density of n = 2 electrons per O s, we can make a crude estimate of the C oulomb interaction potential:

 $V_c = n_c = N(0)$ 2 eV for RbO s₂O₆ and 3 eV f9 eV g for KO s₂O₆. Here, N(0) = g(E_F)=2 is the density of states at the Ferm i level for one spin direction. Both of these values indicate a large electron correlation.

It is instructive to compare the $A O s_2 O_6$ series with a Ru based -pyroch lore series, where variations of the Ru-O-Ru angle results in a drastic change of the density of states. The com pound Y_{2x} B i_x R u₂O₇ is a M ott insulator for sm all x and a norm all param agnetic m etal for 2. The band Som m erfeld coe cient of $B_{1,2}Ru_2O_7$ is calculated to be 8.0 m J= (m ol K²) [37], х resulting in a very small mass enhancement (023). The correlations increase upon Y substitution resulting in an increase of the Som m erfeld coe cient from about 10 m J= (m olK 2) 2 to alm ost 90 m J= $(m \circ 1K^2)$ at x 0:9.[38] The enhancement at x = 0:9 is thus subat x 10. Below this critical value correlations become so strong that a gap opens stantial: in the density of states and the Sommerfeld coe cient decreases rapidly and vanishes in the M ott insulating state. U sing the same arguments as above for AO s_2O_6 , the interaction potential V_c in Y_{1:1}B i_{0:9}R u₂O₇ is of the order of 10 eV, certainly large enough to cause a gap for a bandwidth of typically 3eV. At the same time the Ru-O-Ru angle is reduced from about 139 for Bi2Ru207 to 129 for Y2Ru207. [39] This strongly indicates that a decreasing B-O-B angle causes the band to narrow and the correlations among conduction electrons to increase. A $0 \ge 0_6$ shows the same tendency: the $0 \ge 0 - 0 \le 0$ angle in Rb0 $\le 0_6$ is 139.4 $[= 44 \text{ m J} = (\text{m olK}^2)]$, while that for KOs₂O₆ is 137:9 $[= 76 \text{ to } 110 \text{ m J} = (\text{m olK}^2)]$. We thus interpret the mass of A 0 s_20_6 to be increasingly enhanced by electron correlations going from A = C s to A = K. Possibly the correlations are especially strong in some subband, leading to a CDW like or orbitally ordered state at around 7K ($T_{p;1}$ and $T_{p;2}$ in Fig. 3).

This is consistent with another series of pyrochlores: according to Solovyev (R ef. [40]), a decreasing M o-O-M o angle in $R_2M o_2O_7$ reduces the interaction between M o (t_{2g}) orbitals which is mediated by O (2p) states, causing diminishing overlap and thus enhanced m ass. A lthough this author inds the lattice parameter to be the relevant parameter determining the physics of the compound, the physical properties of various pyrochlores appear to be more appropriately parameterized by the M o-O-M o angle.

An elective Hubbard U of 2 eV is in line with other transition metals. According to [28], this is not enough to classify $Cd_2Os_2O_7$ as a strongly correlated system. In Ref. [40], however, a U of 1:5 to 2:5 eV explains the Mott-insulating properties of $R_2Mo_2O_7$ very well. This might be a somewhat weak argument, because $Cd_2Os_2O_7$ is a 5d material while

 $R_2M o_2O_7$ is 4d, which are usually more strongly correlated. On the other hand, the LDA bandwidth of AO s_2O_6 is in the region of W 3 eV [22, 35] and the interaction potential V_c is therefore comparable to W and thus the M ott-H ubbard localization concept is applicable. The anom alous pressure dependence of the superconducting transition temperature is in line with these ndings: [41] H ydrostatic pressure reduces the correlations working against superconductivity, thus initially increasing the critical temperature. For this reason it would be of interest to see if N aO s_2O_6 shows m etallic or insulating behavior.

It is enlightening to compare the electronic structure of AO s_2O_6 to the one of O sO_2 , since, in a (limited) way, O sO_2 can be regarded as AO s_2O_6 without the A. It has a nutile structure with the O sO_6 octahedra sharing edges in the c direction and corners in the plane perpendicular to c.[42] W hile the O sO s distance to the neighboring octahedron with the shared edge and the length of the shared edge itself are shorter than the O sO s and O -Odistances in AO s_2O_6 , all other O sO, O -O, and O sO s distances in O sO_2 are slightly longer than the ones in AO s_2O_6 . The O sO -O s angles in O sO_2 are 105:O along the c axis and 127:5 perpendicular to it. Pyrochlores with a B -O -B angle around 127 usually are in an insulating state. D irectional resistivity measurements on O sO_2 could thus be quite insightful in this respect.

The density of states at the Ferm i level for $0 \ sO_2$ of about 13 to 15 states= (u c:Ry spin) from the band structure calculation in Ref. [42] results in a Sommerfeld coe cient $_{\rm b}$ 2:4 m J= (m olK²). We measure a of about 6:1 m J= (m olK²), resulting in a speci c heat enhancement of about 1+ = 6:1=2:4 2:5. A ssum ing a small electron phonon coupling in $0 \ sO_2$ of $_{\rm ep}$ 0:2 and an enhancement of the form $=_{\rm b} = (1 + _{\rm ep})(1 + _{\rm c})$, this results in an enhancement due to correlations of $_{\rm c}$ 1:1. This is quite a large enhancement parameter sim ilar to the one of AO s₂O ₆, providing further evidence that the C oulom b correlations are inherent to the 0 s-O system.

Recent calculations have shown that the electronic structure does not change signi cantly on changing the alkalim etal ion A .[25] Therefore, all these considerations point to the need to consider interactions that are not captured in the electronic structure calculations. In light of the signi cant electron-phonon interaction, and even stronger elects due to electron correlations, it will be of interest to further focus on the possible role played by the 3D triangular geometry of the 0 s-0 network. In view of the strong electron correlations, the further focus in these materials.

We take the non-superconducting state of Y_{2 x} B i_x R u_2 O₇ to be a clear indication that the additional enhancement mechanism is to be regarded separately from the pairing mechanism. Both AO s_2 O₆ and Y_{2 x} B i_x R u_2 O₇ show significant enhancement due to correlations, but only AO s_2 O₆ is superconducting. The question thus remains why AO s_2 O₆ is superconducting and Y_{2 x} B i_x R u_2 O₇ is not. The answer may lie in the electron-phonon coupling, which is unusually large in AO s_2 O₆. We expect this to be due the -pyrochlore instead of the - pyrochlore structure, which leaves the 16d site empty and the 8b site occupied by A instead of an oxygen atom. This should significantly modify the phonon spectrum, resulting in a large ∞ .

V. CONCLUSION

Our data from high quality single crystalline KOs206 show that KOs206 is a particularly interesting transition m etal oxide: it is an interm ediate to strong coupling type-II superconductor with a coupling parameter $_{ep}$ 1 to 1:6. KO s_2O_6 has a high Som m erfeld ∞ coe cient for a pyroch lore of 76 to 110 m J= (m olK²). We estimate a G inzburg-Landau ∞ -31 to 37A , about half the one in RbO $s_{2}\mathrm{O}_{6}$ due to the renorm alization herence length of the Fermi velocity v_F . We estimate the condensation energy F = 2.0 to 2.5 J=mol. The e ective mass, even after the measured strong electron-phonon renormalization is taken into account, is threefold enhanced over the LDA band mass. We interpret this as due to Coulomb correlations. The renormalization a ects those electrons that are paired to form the superconducting condensate. W hile for RbO s_2O_6 the additional heat capacity can be well characterized by an Einstein model, the contribution for KOs_2O_6 is somewhat more unusual, possibly due to strong anham onicity. We associate this special phonon with a rattling motion of the alkali ions, resulting in three modes per Rb for RbOs₂O₆. In KOs₂O₆, the absence of lattice heat capacity at low temperatures may indicate the freezing of this motion. The dynamics of the alkali ions causes large scattering of the charge carriers which shows up in an unusual temperature dependence of the electrical resistivity which varies system atically with the alkali ion.




FIG.1: The upper critical eld $H_{c2}(T)$ of KOs₂O₆ and RbOs₂O₆. The squares () are data points extracted from $C_p=T$ versus T data, while the circles () are extracted from $C_p=T$ versus H data. For KOs₂O₆, two methods to extrapolate to 0K are used: (A) The dashed line is from the W HH form ula in the orbital lim it ($_{SO} = 1$), providing a good description of the data up to about 9T, while a description with smaller spin-orbit scattering strength (dotted lines) deviates markedly. (B) The dash-dotted line is a linear t to the data. The stars mark the Pauli-lim iting eld $_{0}H_{P}$ for KOs₂O₆. $T_{p;1}$ and $T_{p;2}$ mark two additional peaks observed in the speci c heat (Fig. 3) that might be associated with K ordering.




FIG.3: (Color online) Heat capacity versus temperature of KOs₂O₆ for various magnetic elds. The speci c heat jump at T_c, C_p $\dot{\mathbf{j}}_c$ =T_c is 204m J=(m olK²), from which the normalized speci c heat jump C_p $\dot{\mathbf{j}}_c$ =(T_c) = 2:7 f1:9g is extracted. It is significantly larger than that for the weak-coupling case and corresponds to an electron-phonon coupling constant _{ep} 1:0 f1:6g, i.e.KOs₂O₆ is a superconductor in the strong-coupling regime. There are two transitions at T_{p;1} 6:5K and T_{p;2} 7K that might be associated with K ordering.




FIG.4: Comparison of the Sommerfeld coe cients for RbOs $_{2}O_{6}$, KOs $_{2}O_{6}$, and the weak-coupling -pyrochlore superconductor $Cd_{2}Re_{2}O_{7}$. Shown are the calculated bare coe cients $_{b}$ in white, the electron-electron enhanced coe cients $(1 + _{c})_{b}$ in hatched, and the measured coe cients $(1 + _{ep})(1 + _{c})_{b}$ in cross hatched. The bare band value from DFT calculations in the LDA is rather similar for all three pyrochlores. The electron-phonon coupling $_{ep}$ increases from < 0.4 (weak coupling) for $Cd_{2}Re_{2}O_{7}$ to 1 for RbOs $_{2}O_{6}$ to 1.0 to 1.6 for KOs $_{2}O_{6}$. The two sets of values (A) and (B) for KOs $_{2}O_{6}$ correspond to the two choices of extrapolating H $_{c2}$ (T) in Fig.1.




FIG.5: M agnetic susceptibility of KO s_2O_6 and RbO s_2O_6 m easured at 1T. The data is corrected for the core diam agnetism (+1:22 10⁴ cm ³=m olfor RbO s_2O_6 , +1:15 10⁴ cm ³=m olfor KO s_2O_6), resulting in susceptibilities taken at 150 K of ^{em u} 3:7 10⁴ cm ³=m olfor KO s_2O_6 and ^{em u} 5:3 10⁴ cm ³=m olfor RbO s_2O_6 .




FIG. 6: $(C_p = T)=T^3$ versus temperature on a logarithm ic scale of a RbOs₂O₆ sample with 74.9 m ass % RbOs₂O₆ and 25:1 m ass % OsO₂ and an OsO₂ sample. It illustrates the signi cant additional heat capacity present in RbOs₂O₆. The di erence between C and the shaded region is 74.9% of the intrinsic heat capacity of RbOs₂O₆.




FIG. 7: (Color online) Decomposition of the lattice heat capacity (C_p T)=T³ of RbO s₂O₆ into Debye and E instein-m ode components. In such a plot, an E instein contribution to the heat capacity appears as a bell-shaped feature with a maximum at T = T_E =4:93.[31] The data are well described by a combined Debye-E instein model with _D = 325K, T_E = 60K, and n 0:33 9 m odes per fu.




FIG.8: (Coloronline) ($C_p \quad C_{el}$)=T³ of KOs₂O₆ on a logarithm ic temperature scale. The dashed line shows a combined Einstein-Debye contribution with n = 0:15 9m odes=fu:, F = 31K, and $_D = 325$ K to illustrate a best t to the data if an Einstein-type contribution is assumed. We use the Debye temperature from RbOs₂O₆ (Fig. 7). The dotted line indicates the large lattice contribution expected at low temperatures from a K ion in an anharmonic potential.[32] The absence of such a contribution m ay indicate a freezing of the rattling motion at T_{p;i}. (A) and (B) refer to the two extrapolations used to extract as described in the main text.




FIG. 9: Tem perature derivative of the electrical resistivity d = dT normalized to the value at its maximum showing the systematic variation of the peak location with the A ion. The data for C sO s₂O₆ (dotted curve) and KO s₂O₆ (dashed curve) are taken from Ref. [11] and Ref. [4] respectively. The two curves are smoothed. The inset shows the calculation for a single E instein phonon.




FIG.10: (Color online) System atic variation with the A ion of the maximum in the temperature derivative of the resistivity T_{peak} versus the characteristic temperature of the low-energy phonon $T_{E \text{ instein}}$ extracted from heat capacity measurements. For illustration we show where the maxima are expected to lie according to the solution of the linearized Boltzmann equation for a single phonon by a dashed line.[33] Inclusion of a second phonon by M atthiessen's rule at around 140K for RbO s₂O₆ and around 175K for C sO s₂O₆ [10, 34] m oves the peak temperature up towards the measured value shown by the blue stars and arrow s.
