## C om posite-ferm ion description of rotating B ose gases at low angular m om enta

We study the composite ferm ion construction at and below the single vortex (L = N) state of weakly interacting rotating Bose gases, presenting a new method for handling the large number of derivatives typically occurring via the Slater determ inant. Remarkably, the CF wave function at L = N becomes asymptotically exact in the therm odynamic limit, even though this construction is not, a priori, expected to work in the low angular momentum regime. This implies an interesting mathematical identity which may be useful in other contexts.

IN T R O D U C T IO N

Rotating atom ic Bose condensates have been subject to ever increasing theoretical and experim ental interest in recent years [1]. On the experim ental side, substantial progress has been m ade in increasing the rotation such as to produce ever larger am ounts of vortices [2, 3, 4, 5] and, very recently, com ing close to the point where the vortex lattice is expected to melt and the system is expected to enter the quantum Hall regime [6]. Theoretical studies have addressed the entire range of angular m om enta, from few-vortex states (L N where L is the total angularmomentum and N the number of particles), up to N  $^2$  where the system displays a number the regime L of close analogies to the fractional quantum Halle ect (FQHE) [7, 8, 9].

A theoretical tool which has been very successful in describing the physics in the quantum Hall regime is the com posite ferm ion (CF) construction [10]. O riginally developed in the context of the fractional quantum Hall e ect, CF wave functions have, more recently, been applied to the high angular momentum states of weakly interacting Bose gases [9, 11, 12, 13]. By construction, this method has been assumed to be applicable only in the FQH regime, L  $\mathbb{N}^2$ . However, as was pointed out in [11], there were some indications that the CF wave functions might do surprisingly well even at the lowest angular m om enta. In this work we thus discuss the CF construction in the regime 0 L N. In particular, we present a num erical study which shows that the CF wave function for the single vortex (L = N) becomes exact in the large N limit. One of our main motivations for studying this case in m ore detail were earlier calculations by Cooper et al [9], which revealed an increase in the overlap as function of N for up to 10 particles. W e con m that this trend continues in a system atic way for higher N, with the deviation of the overlap from unity decreasing as 1=N. Since the exact ground state wave function is known analytically in this case [7, 14, 15], this result suggests a non-trivial m athem atical identity, valid asymptotically in the limit N ! 1, which may tum out useful in other contexts. Our solution involves

a new way of handling the large num ber of derivatives typically occurring in the CF construction when going to low angular m om enta. This large num ber of derivatives has been one of the main obstacles to taking the CF construction to higher particle num bers than, say, 10 [16]. We have computed the overlap of the single vortex CF wave function with the exact one for up to 43 particles, which is a far higher number than could be achieved previously. This was done by taking advantage of the mathematical properties of the determ inants involved, which enabled us to rewrite the wave functions in a simpler way, without derivatives, before perform ing the num erical calculation of the overlaps. A straightforward modi cation of this method allowed us to study other angular m om enta as well, and revealed som e peculiar m athem atical properties of the CF construction. We would like to emphasize that this is mainly a technicalwork in the sense that our main emphasis is on this new method and on the mathematical properties of the CF construction. W hile our study was performed in an angular m om entum regim e w here exact analytical w ave functions are known, we hope that our results and methods m ay turn out useful to study states beyond the single vortex, where this is not the case. For example, the same approach m ay be used to study the case L = 2N, where the system is expected to be close to the transition between a two-and a three-vortex state. Our prelim inary ndings indicate that the aforem entioned m athem atical structures m ay greatly sim plify the CF study of this and other few -vortex states.

The paper is organized as follows: We start by reviewing the construction of CF trial wave functions in the context of rotating hard-core bosons, illustrated by some simple examples. We then present evidence that the overlap of the single vortex CF wave function with the exact one converges towards 1 in the large N limit. Since we believe that (m odi ed versions of) our approach may provide a useful tool for studying other CF wavefunctions with a high num ber of derivatives, our method of handling the derivatives is explained in some detail. In the following section, we discuss the region L < N. The CF wavefunctions are, in general, not exact here but do

reproduce the exact wave function for L = 0;2;3 which, again, suggests som e interesting m athem atical identities. F inally, we sum m arize our work.

# CF DESCRIPTION OF ROTATING BOSE SYSTEMS

Consider a system of N spinless bosons with mass m in a harmonic trap of strength !, rotating with angular frequency and interacting via a short-range (delta function) potential H $_{\rm I}$ . In a rotating frame the Hamiltonian can be written as

where  $L_z$  denotes the angular momentum around the rotation axis. Reshu ing a few terms, this is straightforwardly rewritten as

with A = m ! ( y;x), H<sub>ho</sub>(z) denoting the z-part of the harm onic oscillator H am iltonian and k denoting the planar (x;y) part of the Ham iltonian. This is how the formallink to the quantum Hall system com es about: We see that the planar part of H takes the form of particles moving in an elective "magnetic" eld  $B'_{eff} = r$ A~ = 2m ! 2. Now, the interaction is assumed to be weak in the sense that it does not m ix di erent harm onic oscillator levels. W e will be interested, for a given total angular momentum, only in the lowest many-body states (the "yrast" band). In this lim it, the model may be rew ritten as a lowest Landau level (LLL) problem in the e ective "magnetic" eld  $B_{eff} = 2m!$  (and of course,  $n_z = 0$  for the harm onic oscillator in the z-direction). The Ham iltonian then takes the form

(h = 1) where we now use L to denote the total angular momentum,  $L = \lim_{i=1}^{r} l_i = L_z$ .

The single particle states spanning our H ilbert space (the lowest Landau level) are

where  $z = \frac{p}{2m!} (x + iy)$  are complex coordinates denoting the particle positions in the plane, and l is the angular momentum of the state. A general bosonic manybody wave function  $(z_1; :::z_N)$  will then be a hom ogeneous, symmetric polynom ial in the  $z_i$  s, times the exponential factor exp $\begin{pmatrix} i \\ j \\ z_i \\ j \\ z = 4 \end{pmatrix}$  (which will be suppressed throughout this paper for sim plicity). The degree of the polynom ial gives the total angular momentum of the state. A special class of such wave functions are the so-called composite ferm ion (CF) wave functions. They were rst introduced by Jain [10] and have been extrem ely successful in describing FQH states, quantum dots in high magnetic elds [17] and, more recently, highly rotational states of Bose condensates[9, 11, 12, 13]. In quantum Hallphysics, the main idea of this construction is, roughly speaking, to attach an even number of ux quanta to each electron, thus mapping them into weakly interacting composite ferm ions which can be thought of as moving in a reduced magnetic eld. Technically, "attaching a ux quantum "means multiplying the wave function by a Jastrow factor,

W e see that the Jastrow factor has the e ect of keeping the particles apart { it goes to zero if any two coordinates  $z_i$  and  $z_j$  approach each other. Therefore, it "takes care of" much of the repulsive interaction between the particles. In the simplest approach, the so-called non-interacting composite ferm ion (NICF) approach, the wave function is then simply constructed as a Slater determ inant of (non-interacting) com posite ferm ions in the reduced m agnetic eld, tim es an even power of Jastrow factors. In the case of bosons, whose wave function has to be sym m etric rather than antisym m etric, one instead absorbs an odd power of ux quanta, m apping the bosons to weakly interacting composite fermions. In other words, bosonic trial wave functions with angular momentum L are constructed as non-interacting ferm ionic wave functions with angularm om entum L m N (N 1)=2, multiplied by an odd number m of Jastrow factors (m = 1throughout this paper), and projected onto the LLL,

Here,  $f_{\rm S}$  denotes a Slater determ inant consisting of single-particle wave functions  $_{n1}(z;z)$  /  $z^{1}{\rm L}_{n}^{1}(zz=2)$  where n is the (CF) Landau level index (l n) and  ${\rm L}_{n}^{1}$  a generalized Laguerre polynom ial. The LLL projection P amounts to the replacement  $z_{i}$ ! 20=0 $z_{i}$  in the polynom ial part of the wave function { the recipe is to replace all z swith derivatives in the nalpolynom ial, afterm ultiplying out the Slater determ inant and the Jastrow factors and moving all z s to the left. It has been shown [10] that with this projection method, the single-particle wave functions in the CF Slater determ inant may be written as

with all derivatives acting only to the right. As this method tends to get computationally heavy in numerical

calculations with m any particles and a large number of derivatives, slightly di erent m ethods of obtaining LLL w avefunctions have been employed in m ost of the CF literature[10]. These, too, are often referred to as projection. N evertheless, in this paper, "projection" will refer to the above brute force procedure.

Before m oving on to low angularm om enta, let us illustrate them ethod on two sim ple and well-known exam ples in the Q H regim e: First, consider the case L = N (N 1). Taking m = 1, the Slater determ inant  $f_S$  has to contribute an angularm om entum N (N 1)=2 and is given by putting all CFs into the low est CF Landau level, from l = 0 to l = N 1,

W e in m ediately see from Eq.(6) that the full wave function is simply the bosonic Laughlin wave function

with angular m om entum L = N (N 1). This is the exact ground state for the delta function interaction. Next, consider the angular m om entum N (N 1) N, corresponding to a bosonic quantum H all "quasiparticle" (as opposed to quasihole). In order to decrease the angular m om entum by N as compared to the Laughlin state, we need to m ove one CF to the second Landau level, i.e. construct the Slater determ inant

This gives the full trial wave function (again, apart from the exponential factor)

with  $_{\rm L}$  denoting the Laughlin state (9). This wave function has very high overlap with the exact one (e.g., 99.7 % for 4 bosons [11]). Its ferm ionic counterpart has been proven to capture correctly both the fractional charge and the anyonic statistics of the Q H quasielectron [18, 19], and the sam e is expected to be the case for this bosonic version.

Trial wave functions for other yrast states are constructed in sim ilarways. The lower the angularm om entum, the larger the num ber of derivatives.

### SINGLE VORTEX, $\mathbf{L}$ = N

In the examples above, we considered angular mo-N $^2$ . Let us now turn to the regime L m enta L Ν which, for large systems, corresponds to much smaller angularm om enta. Note that since the Jastrow factor in Eq.(6) has itself an angular momentum of m N (N 1)=2, we need to act with 0 (N  $^2$ ) derivatives in order to get N. One would expect that these derivadown to L tives acting on the Jastrow factor destroy most of the good correlations which are at the very heart of the CF construction, which would thus fail in this regime. Surprisingly, however, we shall see that this is not the case. As shown in [11], the Slater determ inant for the ground state trial wave function at L = N is constructed by occupying the single-particle states n; n for n = Nthrough n = 0, and the state  $_{0;1}$ ,

where, again, the z's are to be replaced by derivatives acting on the Jastrow factor. Thus, the trial wave function m ay be written as [11]

O n the other hand, it has been show n [7, 14, 15] that the exact wave function for L = N , the single vortex, is given by

where  $Z = {P \atop i z_i = N}$  is the center of m ass. It was shown in Ref. [9] that, surprisingly, the overlap between (13) and (14) appeared to increase with increasing particle num ber (but only results up to N = 10 were available at the time). Here we have studied this point system atically and computed the overlaps for up to 43 particles. The m athem atical approach which enabled us to handle such large num bers of derivatives, will be described shortly. F irst, how ever, let us state the result: The overlap between the CF trial wave function (13) and the exact one (14) converges towards 1 in the large N limit, see g. 1. The overlap equals 98:64% already at N = 5 and 99:47%

for N = 10. For N = 43  $\pm$  equals 99:90%. We have checked that this is not a trivial result in the sense that the two wave functions m ight simply share the same leading term and all other term s become irrelevant for large  ${\tt N}$  . Rather, we found that the leading term of the two wave functions,  $\tilde{z}_i$ , only corresponds to a weight of about 50% of the total wave function, and that the subleading term softhe two wave functions converge tow ards each other as well. This suggests that the functions (13) and (14) are identically equal to each other in the lim it N! 1. This is a non-trivial mathematical identity which we have so far not been able to prove analytically; how ever, we noticed by sim ple curve- tting, that the deviation of the overlap from unity decreases as 1=N . W e will discuss other, sim ilar identities in the section on L < N.




FIG.1: The overlap between the L = N CF trial wave function (13) and the exact one (14) as function of the number of particles.

#### C om binatorics and num erical m ethod

For the sake of clarity, we will illustrate our approach to the single vortex wave function for the single case N =4. The generalization to arbitrary N is straightforward, and the general result will be stated at the end. A fler projection, the CF Slater determ inant (12) takes the form

This determ inant may be rewritten as a permutation sum , V

with denoting all permutations over the particle indices (1,2,3,4), and () = 1 for even/odd permutations. Similarly, we rewrite the Jastrow factor as

Now, the rst crucial observation is that an equivalent way of writing the permutation sum (17) is by xing the particle indices and sum m ing over all permutations of the exponents instead,

M oreover, since reordering the term s will have the sum unchanged, we may apply any permutation to all the indices as long as we make sure to change the signs accordingly:

Noting that () () = (), we can now combine the Slater determ inant  $f_{\rm S}$  and the Jastrow factor J to give the following expression for the (unnormalized) single vortex wave function,

W e note that the outer sum is simply a (symmetric) sum over all permutations of the particles indices. Therefore, it is su cient to study one term, denoted as f<sub>U</sub>, in this permutation sum and perform the symmetrization only at the very end. Choosing this term to be = (1;2;3;4), we get

The next important observation is that the above sum may again be expressed as a determ inant,

Thus, to sum marize, we have expressed both the Slater determ inant and the Jastrow factor in (6) as permutation sum s, com bined these, perform ed all derivatives, and cast the nal expression in the form of a new determ inant. The full wave function  $_{(L=N)}$  is obtained by adding all permutation of the particle indices in (22). We have obtained an explicit form of the CF polynomial, without derivatives, which may then be used in num erical calculations, to compute overlaps etc.

The generalization of (22) to arbitrary N is straightforward; one nds that

A particularly appealing property of this matrix is its near-triangular form, which greatly reduces the calculation cost.

Before ending this section, let us brie y outline how we used this result to com pute overlaps between the CF wave function and the exact one (14). The polynom ial part of  $_{(L=N)}$  may be regarded as a vector in the space of sym metric polynom ials. A convenient basis for this space consists of the sym metrized sum s of individual polynomial term s. For example, the sym metrization of  $z_1 z_2 z_3^2$  is

and may be regarded as one basis vector. (The factor 2 arises from the fact that both eg.  $z_1 z_2 z_3^2$  and  $z_2 z_1 z_3^2$  occur in the sum .) Since  $_{(L=N)} = S[f_U]$  (S denoting sym m etrization), it is therefore straightforward to determine the representation of  $_{(L=N)}$  in the sym m etric basis by sym m etrizing each term of  $f_U$  individually.

Since overlap integrals between polynom ialterm s with non-m atching powers are zero, our symmetric basis is orthogonal. This means that if both (L=N) and ex (L=N) are normalized and represented in a normalized symmetric basis, then the overlap may be computed as a simple dot product. This also implies that all calculated overlap values are exact (up to num erical precision). To express

 $_{(L\,=\,N\,\,)}^{ex}\,$  in this basis, let us rephrase the product (14) as the sum

where  $s_i = s_i (z_1; :::; z_N)$  are the fundam ental symmetric polynom ials of degree i,

The products  $s_N$ ;  $s_1 s_{(N-1)}$ ;  $\dots$ ;  $s_1^N$  appearing in this sum form another, non-orthogonal, basis. Through a change

of basis we can therefore convert  $\mathop{}_{(L\,=\,N\,)}^{ex}$  to the orthogonal sym m etrized basis, enabling us to compute the overlaps.

The m ethod described in this section m ay be straightforwardly m odi ed to other values of L. In the next section we illustrate how it m ay be used to shed light on som e yrast states at even lower angular m om enta.

### BELOW THE SINGLE VORTEX, $\rm L < N$

Exact ground state wave functions are known not only for the single vortex (14) but for all angular momentum states 2 L N. As was shown some years ago [14, 15], they are simply given by fundam ental symmetric polynomials  $s_L(z_i)$  where  $z_i = z_i$  Z and Z is again the center-ofm ass coordinate:

For example,  $_{L=2} = S[(z_1 \ Z)(z_2 \ Z)]$ , with S denoting symmetrization over all particle coordinates. Note that these states are translation invariant (T I), i.e. invariant under a simultaneous constant shift  $z_i ! z_i + a$ of all the coordinates [1, 20]. We see that the single vortex (14) is merely a special case of this series of wave functions. (At L = 0 the polynomial part of the exact ground state is trivially a constant as all particles are in the l= 0 state, while the only possible way pf constructing the ground state at L = 1 is  $_{L=1} = _{i} z_{i}$ , which corresponds to a center of m ass excitation of the L = 0 state.)

As discussed in Refs. [11, 20], the space of T I polynomials for 2 L N is spanned by the basis states

where  $L = {P \atop n=2}^{P} nk_n$ . We thus see that the states (27) are special cases of such basis states, with  $k_L = 1$ , all other  $k_n = 0$ . In anticipation of the discussion below, note that for L = 2; 3, they are the only possible basis states, and thus it is obvious that (27) has to be exact for L = 2; 3. (For larger L this is no longer the case; for example, the basis for L = 4 consists of  $\frac{1}{2}0000$ :::i as well as  $\frac{1}{2}0100$ :::i.)

G iven these results, let us discuss som e m athem atical peculiarities of the CF construction in the regim e L < N. F irst of all, the CF construction im m ediately reproduces the exact wave function for L = 0: In order to cancel all the angularm om entum of the Jastrow factor, the CF Slater determ inant with low est possible (quasi) Landau level energy is uniquely given by occupying the CF Lan-

dau level states n; n for n = 0 through N 1,

A fler projection, this will give a Jastrow factor of derivatives acting on the corresponding Jastrow factor of z s, thus resulting in a constant. This can be made explicit using the notation of the previous section. Proceeding exactly as in equations (16)-(22), again taking N = 4, we may define the function of  $f_U$  (1); (2); (3); (4)) with

where now denotes all permutations over (0,1,2,3). This is identified with the determ inant

which obviously gives the correct wave function (up to norm alization) for L = 0 (all bosons in the l = 0 state).

The CF construction reproduces the exact ground state wave functions for L = 2 and 3 as well. In contrast to the case L = N, these identities are not asymptotic { they are exact for all N. This is not surprising, for the following reason [11]: For these angular momenta, one can construct compact CF wave functions which are thus known to be translation invariant (T I) [21]. On the other hand, as discussed above, for these lowest angular momenta there only exists one basis state in the space of T I polynom ials. Therefore, the CF com pact state has to correspond to this basis state, which is the exact wave function.

W hat is som ewhat surprising, however, is how this com es about m athem atically. Consider again the L = 0 state discussed above. From this we can construct com – pact L = 2 states by m oving any of the particles (except the one at (0;0)) from the CF Landau level state (n; n) to (n 1; n + 2). There are thus N 1 di erent ways of constructing the L = 2 CF Slater determ inant which are all degenerate in CF kinetic energy. In m athem aticalterm s, this corresponds to replacing one of the states n; n =  $(n^n \text{ by } z (n^{n-1}) (see (7))$ . It thus looks as if there are N 1 di erent CF candidate wave functions for the L = 2 state, while according to the above argum ents, we would expect the CF wave function to be unique and exact! The solution to this apparent paradox is that while the N 1 possible Slater determ inants are certainly not equal to each other, they all result in the same polynom ial after acting on the Jastrow factor. To see how this comes about, consider again the case of four particles. The rst possible Slater determ inant is

P roceeding in the sam e way for the other two possibilities gives  $f_U = 12 (z_3^2 \quad z_2 z_3)$  and  $f_U = 12 (z_4^2 \quad z_3 z_4)$ , respectively. Thus, since the full wave function is constructed from  $f_U$  by summing over all permutations of the indices (1,2,3,4), the nal, symmetrized sum will be the same for all these constructions.

Exactly the same thing happens for L = 3. There are N 2 ways of constructing the Slater determ inant, obtained from the L = 0 one by letting any  $e^n ! ze^{n^2}$ . Again, these di erent constructions simply correspond to picking out di erent parts of the nal, symmetrized polynom ial.

Of course, similar things may happen at other angular momenta as well. For example, there are two ways of constructing the Slater determinant for L = N = 1. Again, these result in the same polynomial, though in this case the CF construction does not give the exact wave function even in the large N limit.

The fact that the wave functions resulting from the CF construction for L = 2;3 are equal to the very sim ple and com pact expressions in (27), again provides non-trivial and potentially usefulm athem atical identities.

## SUM MARY AND OUTLOOK

To sum marize, we have shown that the CF construction for bosons at low angular momenta may be taken to far higher particle numbers than previously by handling the derivatives of the CF Slater determ inant in a new way. In particular, we used this to show that for the single vortex, L = N, the CF construction becomes exact in the high N lim it, leading to a non-trivial and potentially usefulm athem atical identity. For other L, the CF construction does, in general, not produce the exact wave functions. We have argued why it is expected to give the exact ground state for L = 2;3 (all N). However, work remains to get a better understanding of what makes L = N special. Moreover, we used our methods to show examples of other mathematical peculiarities of the CF construction in the regime L < N. Our hope is that the results of this paper may provide new insight into properties of CF wave functions in the few-vortex regime beyond L = N, where no exact, analytical wave functions are known. For example, a prelim inary study of the case L = 2N suggests that while the number of possible CF Slater determ inants increases linearly with N, these m ay reduce to just two di erent wave functions; nding the ground state as a linear combination of these would then just be a one-parameter problem . There is thus hope that one m ay construct rather sim ple analyticaltrialwave functions in the regime L N, which may directly reveal the vortex structures of these states. The present paper indicates that in this regime, the CF construction m ay do far better than previously assumed in the literature.
