## Theory of trapped polaritons in patterned m icrocavities

We consider the system of a quantum wellem bedded in a planar sem iconductor m icrocavity with a shallow circular mesa patterned on top of the cavity spacer. For this system we develop the linear coupling theory of polaritons. We then compute polariton eigenstates and the corresponding optical spectrum. The theory predicts the existence of laterally con ned polariton states with a discrete energy spectrum, as well as continuum states above the nite mesa potential barrier.

Polaritons in planar semiconductor microcavities (MCs) are quasi-particles ideally characterized by free motion in two-dimensions. The most remarkable experimental signature of free two-dimensional motion is the continuous energy-momentum dispersion curve [1, 2]. More direct evidence was recently provided by measurements of the polariton motion along the plane [3, 4], that showed ballistic propagation over hundreds of m when polariton wave-packets were resonantly excited at large momentum.

The free particle picture, how ever, does not hold exactly. The structural disorder in the system breaks the translational invariance along the plane and produces localized polariton states. The polariton localization length in a GaAs-based high-quality sample was estimated in the range of a few tens of m close to the band bottom, by measuring the momentum broadening of the dispersion curve [5], whereas recent measurements of spatially-resolved photolum inescence from a ZnSe-based sam ple [6] directly showed the spatial pattern of localized polariton states. P resum ably, polariton localization occurs mainly due to disorder in the photonic structure. The very sm all polariton e ective m ass, as com pared to the exciton m ass, is indeed expected to produce m otional narrowing [7] that strongly suppresses the e ect of exciton disorder on the polariton states. In the MC, on the other hand, sm all thickness uctuations can produce sizeable local variations of the photon resonant energy, that are expected to a ect the polariton motion.

The idea of producing a polariton trap by a local variation of the MC thickness was recently put forward [8] for engineering a \polariton quantum box", namely a photonic structure able to con ne polaritons in the three spatial directions. Given the very light polariton mass, of the order of 10<sup>5</sup> exciton masses, the trap size required for producing a sizeable energy quantization is 300 times larger than in the case of bare excitons. Polariton quantum boxes as large as 10 m can thus be designed. Compared to quantum dots [9], these photonic structures are easier to fabricate, allowing perfect control over size, shape and positioning. Addressing a single quantum box with optical spectroscopy would also

becom e a trivial experim ental task. A nother advantage with respect to extended polaritons is the reduced spectral linew idth { as is the case for quantum dots [10, 11] { due to the fact that a spatially localized state sam ples a hom ogeneous portion of the disordered M C plane. Finally, trapped polaritons still retain their quasi-bosonic character, contrarily to electron-hole states in quantum dots. Indeed, in order for the Pauliexclusion to break the bosonic behaviour, it is required that the exciton density approach its saturation value [12]. Populating a single con ned state with a few polaritons still keeps the exciton density wellbelow this lim it. This quite unique situation, thanks to the discrete energy spectrum, would allow Bose-Einstein condensation of polaritons, in contrast to the ideally hom ogeneous two-dimensional case, for which the Hohenberg-Merm in-Wagner theorem [13] strictly forbids the occurrence of this quantum phase transition.

Let us assume a  $\ _{\rm c}\mbox{-thick}\ {\rm M}\ {\rm C}\ {\rm w}\ {\rm ith}\ {\rm distributed}\ {\rm B}\ {\rm ragg}$ m irrors (DBRs). Following the scheme proposed by El Daif et al. [8], in order to create a polariton trap, the thickness of the MC spacer is made slightly larger by an amount L within a limited region of the MC plane that we call mesa, as sketched in Fig. 1 (a). This local variation is obtained by etching the mesa pattern on top of the cavity spacer and then growing the top DBR. To an increased cavity thickness corresponds a local decrease of the resonant photon-m ode energy. A s the photon couples to the exciton, form ing a polariton mode, the mesa acts as a polariton trap. We point out that only the MC spacer thickness is varied, while the optical thickness of the DBR layers is assumed everywhere equal to  $_{\rm c}$ =4. Therefore, within the mesa the DBRs are slightly detuned with respect to the spacer thickness. This makes fabrication easier and implies a less pronounced dependence of the local mode energy on L. In fact, the lowest MC resonant fequency is obtained as the solution of (n<sub>c</sub>=c)[(! !<sub>c</sub>)L<sub>c</sub> + (!  $!_{m}$  )L<sub>DBR</sub> ] = 0, where  $L_c$  is the local cavity thickness,  $!_c$  and  $!_m$  are respectively the resonant frequency of the cavity spacer and of the DBRs, and  $L_{DBR} = (c_2)n_1n_2 = [n_1(n_1) + (n_2)n_2]$  $n_2$ )] is the eld penetration length in the DBRs, expressed in term s of the two DBR refraction indices  $n_1 > n_2$ . replacing  $L_c = {}_c + {}_L$ ,  $!_m = (c=n_c)^2 = {}_c$ , and  $!_c = (c=n_c)^2 = ({}_c + {}_L)$ , we obtain  $!_c = {}_m {}_L = ({}_c + {}_L_{D BR})$ . For ideal DBRs tuned to the spacer frequency, instead,  $!_c = {}_m {}_L = {}_c$ . This weaker dependence on L has thus the further advantage of allow ing ner control over the energy o set of shallow mesas, for which a L of only a few nm m ust be obtained in the fabrication process. For typical G aA s/A IA s DBR s,  $L_{D BR}$  ' 3 c. G iven L = 6 nm in Ref. [8], the previous expression predicts a mesa energy o set of h  $!_c = 9 m eV$ , in agreem ent with the optical characterization of the sam – ple.

For a shallow m esa of lateral extension larger than the optical wavelength, we can safely assume that the electrom agnetic m odes at in-plane position are locally equivalent to those of a planar m icrocavity:

where  $k_z$  ( ) is piecew ise constant. Neglecting border ef-

fects at the m esa contour, M axwell equations give

where  $_0$  is the spacer dielectric constant. Outside the mesa, the MC resonance is  $k_z = 2 = c$ . Inside the mesa we can relate the oset  $k_z$  to the energy oset  $!_{c}$ , as  $k_z = \frac{p_{-}}{0} !_{c} = c$ . Eq. (2) is then solved in cylindrical coordinates, assuming a circular mesa of diam eter D. The eigenm odes are therefore expressed as E () =  $U_{nm}$  () exp(im), where n = 0;1;::: and m = n;:::;n are the radial and angular m ode num bers respectively. The mode eigenenergies and the corresponding energy-m om entum spectral function are plotted in Fig. 1 (b) and (c). A discrete energy spectrum appears, whose modes show a at extended signature in momentum space, re ecting their spatial con nement. At energy above the 9 m eV barrier, we nd a continuum of states whose energy-momentum signature practically coincides to that of a planar M C . This result already suggests that the structure is able to con ne photons in the three spatial directions.

We similarly express the exciton center-ofm ass wave function in terms of Bessel functions of the rst kind, nm () =  $N_{nm} J_m$  ( nm ) exp(im ), where nm are the exciton eigen-momenta and  $N_{nm}$  is a normalization constant. These are the modes of a free particle, as the exciton motion is not a ected by the mesa structure. By introducing Bose operators  $\hat{A}_{nm}$  and  $\hat{B}_{nm}$  for photon and exciton modes respectively, the linear exciton-photon H am iltonian can be nally expressed in second quantization as

where  $!_{mn}^{(\text{ph})}$  and  $!_{mn}^{(\text{exc})}$  are the eigenenergies of the photon and of the (free) exciton m odes. As required by symmetry, the angular number m is conserved in the coupling. The energies h  $\binom{(m)}{nn^0}$  are expressed in terms of the R abi splitting of the planar cavity h <sub>R</sub> and of exciton-photon overlap integrals

For a planar geom etry, momentum conservation im – plies a one-to-one coupling between exciton and photon modes. Here, on the contrary, no selection rule on the radial quantum number n exists. For the num erical solution we therefore choose to retain only a nite number of cavity modes N<sub>c</sub> and exciton modes N<sub>x</sub> for each value of m. The resulting polariton modes are obtained by num erical diagonalization of the (N<sub>c</sub> + N<sub>x</sub>) (N<sub>c</sub> + N<sub>x</sub>)

matrix obtained from the Hamiltonian (3). Polariton eigenvalues obtained for D = 3:5 m and D = 8:6 mare plotted in Fig. 2 (a) and (c) respectively. A detuning of + 6:5 m eV for the planar cavity m ode with respect to the exciton was assumed, in order to bring the lowest con ned photon modes in resonance with the bare exciton. The result in Fig. 2 (a) and (c) brings clear evidence of a discrete energy spectrum, followed by a continuous spectrum at higher energy, both for the lower and for the upper polariton. For the sm aller m esa, only three lower polariton and four upper polariton states are present in the discrete spectrum, with energy spacings in the order of a few m eV. The spectra recently m easured by ElD aif et al. on m esas of com parable size show spectral features in agreem ent with the present model. The polariton operators obtained from the diagonalization of (3) are expressed as  $\hat{P}_{nm} = \sum_{n^0} (X_{nm}^{n^0} \hat{B}_{n^0m} + W_{nm}^{n^0} \hat{A}_{n^0m})$ . Each polariton mode exhibits an angular em ission pattem according to its photon component in momentum

space, de ned as  $I_{nm}(k) = \frac{1}{2}k p_{nm}^{\gamma} \text{Dif}$ , that is easily computed from the model. By assuming for each mode a lorentzian energy spectrum, we can nally compute energy-momentum spectral function, as shown in Fig. 2 (b) and (d). In the discrete part of the spectrum, polariton modes present a at, broad energy-momentum signature, which corresponds to the Fourier transform of spatially con ned states (not shown). The continuous part of the spectrum , on the other hand, sim ply corresponds to the dispersion of free two-dimensional polaritons. These are the scattering states above the nite energy barriers of the potential form ed by the mesa. Correspondingly, the energy-momentum dispersion is well de ned, with a negligible broadening in k-space. We point out that the discrete modes for D = 8.6 m are less extended in momentum space than those for D = 3.5 m, forming a quasi-continuum that m im icks the energy-m om entum dispersion pattern of 2-D polaritons. For diam eters larger than 20 m, the simulations show a spectrum practically identical to that of 2-D polaritons in a MC of thickness <sub>c</sub> + L.

In conclusion, we have developed a theoretical model of polaritons in patterned mesa structures. The model predicts a discrete energy spectrum of con ned polariton states both for the upper and the lower branch, each coexisting with a continuous spectrum of extended states above the trap barrier. The con ned states are extended in momentum space { a feature that should be detected in angle-resolved spectroscopy. Polariton quantum boxes are interesting in several respects. The quantum con nement is produced in a way that is not as invasive as in m icropillars [14], which seem to considerably reduce the quality factor of the photonic structure, presum ably by opening lateral em ission channels. Con ned polaritons represent a quite unique system of quantum -con ned interacting bosons. They can undergo param etric scattering processes { due to the mutual C oulom b interaction { that have recently been exploited for producing nonclassical states of polaritons [15]. In quantum boxes, m om entum conservation no longer holds and param etric processes between quantum con ned states become allow ed. This might be exploited for designing a quantum optical device. Recently, rigurous proof was given, that a discrete energy spectrum allows Bose-E instein condensation [16], otherwise impossible in two-dimensions [13]. Polariton quantum boxes, could therefore be the ideal system for observing the long sought Bose-E instein condensation of polaritons.
