G lass transition in biom olecules and the liquid-liquid critical point of water

Abstract

U sing molecular dynam ics simulations, we investigate the relation between the dynam ic transitions of biomolecules (lysozym e and DNA) and the dynam ic and thermodynam ic properties of hydration water. We not that the dynam ic transition of the macromolecules, sometimes called a \protein glass transition", occurs at the temperature of dynamic crossover in the diusivity of hydration water, and also coincides with the maxima of the isobaric specic heat C_P and the temperature derivative of the orientational order parameter. We relate these indings to the hypothesis of a liquid-liquid critical point in water. Our simulations are consistent with the possibility that the protein glass transition results from crossing the Widom line, which is defined as the locus of correlation length maxima emanating from the hypothesized second critical point of water.

Both experiments and computer simulation studies have shown that hydrated proteins undergo a \glass-like" transition near 200 K [1, 2, 3, 4, 5], above which proteins exhibit diffusive motion, and below which the proteins are trapped in harmonic modes. An important issue is to determ ine the elects of hydration water on this dynamical transition [6, 7, 8, 9, 10]. Experiments and computer simulations suggested that when a protein is solvated, the protein glass transition is strongly coupled to the solvent, leading to the question of whether the protein glass transition is directly related to a dynamic transition in the surrounding solvent [11].

It has been hypothesized that the deeply supercooled region of the phase diagram of liquid water may contain a rst order phase transition between a high density liquid (HDL) and a low density liquid (LDL) [12]. This line of phase transition has a negative slope in the P-T phase diagram and term inates with a critical point, C_2 [12, 13, 14, 15], which is located at $T_{C2} = 200 - 20$ K and $P_{C2} = 250 - 100$ MPa [16]. Upon crossing the rst order phase transition line above the critical pressure, the thermodynam ic state functions change discontinuously. Below the critical pressure they rapidly but continuously change upon cooling.

Computer simulations of the TIP 5P and ST2 models show that response functions such as isobaric specic heat C_P and isothermal compressibility have maxima as functions of temperature if the system is cooled isobarically at $P < P_{C2}$ [15]. The loci of these maxima asymptotically approach one another [17] as the critical point is approached, because response functions become expressible in terms of the correlation length which diverges at the critical point. The locus of the correlation length maxima is called the W idom line.

Experim ental studies of supercritical water [18] indeed show that various response functions have sharp maxima in the region of the phase diagram above the liquid-vapor critical point C_1 , but no direct experim ental indication of a liquid-liquid critical point C_2 had been available due to unavoidable crystallization of bulk water. It was found that water remains unfrozen in hydrophilic nanopores for $T>200\,\mathrm{K}$ [19, 20]. Moreover when cooled at constant pressure for $P<P_{C2}$ the dynamics changes from non-Arrhenius to Arrhenius at T=T (P). The line T (P) is located in the range of temperatures between 200 230 K and has a negative slope in the P-T phase diagram. Computer simulations suggest that this line may be associated with T_W (P), the Widom line, near which the local dynamic characteristics must rapidly change from those resembling the properties of HDL at high temperature to those

of LD L at low temperature [15].

Here we explore the hypothesis [21] that the observed glass transition in biom olecules is related to the liquid-liquid phase transition using molecular dynamics (MD) simulations. Speci cally, we study the dynam ic and therm odynam ic behavior of lysozym e and DNA in hydration TIP 5P water, by means of the software package GROMACS [22] for (i) an orthorhom bic form of hen egg-white lysozym e [23] and (ii) a Dickerson dodecam er DNA [24] at constant pressure P = 1 atm, several constant tem peratures T, and constant number of water molecules N (NPT ensemble) in a simulation box with periodic boundary conditions. We rst allow the system to equilibrate at constant temperature and pressure using the Berendsen method. This initial equilibration is followed by a long production run during which we calculate the dynamic and static properties. Equilibration times vary for dierent tem peratures from a few ns for high tem peratures to as much as 40 ns for low tem peratures. The MD for DNA was performed using the Amber force eld [25]. For lysozyme simulations, the system consists of a single protein in the native conformation solvated in N = 1242TIP 5P water molecules [14, 26, 27]. These simulation conditions correspond to a ratio of water mass to protein mass of 1.56. The DNA system consists of a single DNA helix with 24 nucleotides solvated in N = 1488 T IP 5P water molecules, which corresponds to an experim ental hydration level of 3:68.




FIG. 1: M ean square uctuation of (a) lysozyme, and (b) DNA showing that there is a transition around $T_p = 242 - 10$ K for lysozyme and around $T_p = 247 - 10$ K for DNA. For very low T one would expect a linear increase of $< x^2 > w$ ith T, as a consequence of harmonic approximation for the motion of residues. At high T, the motion becomes non-harmonic and we tithe data by a polynomial. We determine the dynamic crossover temperature T_p from the crossing of the linear to for low T and the polynomial to for high T. We determine the error bars by changing the number of data points in the two ting ranges. Disconstant of hydration water surrounding (c) lysozyme, and (d) DNA shows a dynamic transition from a power law behavior to an Arrhenius behavior at T = 245 - 10 K for lysozyme and T = 250 - 10 K for DNA, around the same temperatures where the behavior of $< x^2 >$ has a crossover.

The simulation results for the mean square uctuations < x^2 > of protein are shown in Fig.1(a). We calculate the mean square uctuations < x^2 > of protein from the equilibrated con gurations, rst for each atom over 1 ns, and then averaged over the total number of atoms in the protein. We not that < x^2 > Fig.1(a)] changes its functional form below T_p 242 10 K. Moreover, upon cooling, the discipling of hydration water exhibits a dynamic crossover from non-Arrhenius [28] to Arrhenius behavior at the crossover temperature T 245 10 K Fig.1(c)]. A similar temperature dependence of discipling of bulk TIP5P water was observed in Ref. [15]. The coincidence of T with T_p within the error bars indicates that the behavior of the protein is strongly coupled with the behavior of the surrounding solvent, in agreement with recent experiments [21]. Note that T is much higher than the glass transition temperature estimated for TIP5P as $T_g = 215K$ [14]. Thus this crossover is not likely to be related to the glass transition in water. Here we will explore the possibility that instead it is related to a change in the properties of protein hydration water.

We next calculate C_P by numerical dierentiation of the total enthalpy of the system




FIG.2: The speci cheat of the combined system (a) lysozyme and water, and (b) DNA and water, display maxima at 250 $\,$ 10 K and 250 $\,$ 12 K respectively, which are coincident within the error bars with the temperature T_p where the crossover in the behavior of < $x^2 >$ is observed.

(protein and water) by thing the simulation data for enthalpy with a fith order polynomial, and then taking the derivative with respect to T. Figure 2 (a) displays a maximum of C_P (T) at T_W 250 10 K for the case of lysozyme-water system [29]. The fact that T_P T T_W is evidence of the correlation between the changes in protein uctuations [Fig. 1 (a)] and the hydration water them odynamics [Fig. 2 (a)]. Thus our results are consistent with the possibility that the protein glass transition is related to the W idom line (and hence to the hypothesized liquid-liquid critical point). Crossing the W idom line corresponds to a continuous but rapid transition of the properties of water from those resembling the properties of a local HDL structure for $T > T_W$ (P) to those resembling the properties of a local LDL structure for $T < T_W$ (P) [15, 20]. A consequence is the expectation that the uctuations of the protein residues in predom inantly LDL-like water (more ordered and more rigid) just below the W idom line should be smaller than the uctuations in predom inantly HDL-like water (less ordered and less rigid) just above the W idom line.

To test this interpretation, we analyze the structure of hydration water on the two sides of the W idom line. Fig. 3 (a) shows the oxygen-oxygen radial distribution function g (r) on two sides of the W idom line for lysozyme hydration water. The rst peak of g (r) on the low temperature (T = 230 K) side is sharper and the rst m in in um is shallower compared to the g (r) on the high temperature (T = 270 K, 300 K) side of the W idom line, suggesting that water is more structured on the low temperature side. Further, we calculate the structure factor S (q) of lysozyme hydration water [Fig. 3 (c)]. The rst peak of the structure factor associated with the hydrogen bond is very sharp and pronounced, for $T < T_W(P)$, it is diminished and moves to larger wave vectors for $T > T_W(P)$, consistent with a LD L-like local structure for $T < T_W(P)$ and a HD L-like local structure for $T > T_W(P)$.

Previous simulations [10] and experiments [9] suggest a \glass-like" transition of DNA around temperature 230 K. Hence to test if the dynamic crossover depends on the solute, we performed a parallel study of the DNA Dickerson dodecamer [24]. We not that uctuations [30] of the DNA molecule [Fig. 1 (b)] change their behavior approximately at the same temperature as lysozyme, with T 247 10 K. The dynamic crossover in the hydration water upon cooling from non-Arrhenius to Arrhenius behavior takes place at T 250 10 K [Fig. 1 (d)]. For DNA hydration water system C_P has a maximum at T 250 12 K, similar to the case of protein (see Fig. 2 (b)) [31]. Fig. 3 (b) and Fig. 3 (d) show g (r) and S (q) for the DNA hydration water [32]. Further to describe the quantitative changes in structure

of hydration water, we calculate the local tetrahedral order parameter Q [33] for hydration water surrounding lysozym e and DNA. Figs. 3 (e) and 3 (f) show that the rate of increase of Q has a maximum at 245 10 K for lysozym e and DNA hydration water respectively; the same temperatures where we not a crossover in the behavior of mean square uctuations and a change in the behavior of the dynamics of hydration water.

The quantitative agreement of the results for DNA and lysozyme suggests that it is indeed the changes in the properties of hydration water that are responsible for the changes in dynamics of the protein and DNA biom olecules. Our results are in qualitative agreement with recent experiments on hydrated protein and DNA [34] which found the crossover in side-chain uctuations at $T_{\rm p}$ 225 K .

Note Added in Proof: After this work was submitted, we learned of interesting parallel work on silicon, which also interprets structural change in g(r) and S(q) as crossing the Widom line [35].

- [29] The error bars in the enthalpy calculation do not exceed 1%. To assess the error bar on the position of the maximum we perform 1000 ttings of the data points by adding random Gaussian variables. The standard deviation of the Gaussian noise was taken to be the error bars in enthalpy.
- [30] The $< x^2 >$ for DNA was calculated in the same fashion as for lysozyme.
- [31] The values of C_P are dierent in each case with C_P^{DNA} (T_W) > $C_P^{protein}$ (T_W), probably because DNA hydration level (368%) is larger than lysozym e hydration level (156%) and the fact that

- the speci cheat of water is larger than protein and DNA.
- [32] The di erence in the height of the rst peak of g(r) for lysozym e and DNA hydration water is due to the di erent hydration levels of the two systems.




FIG. 3: (Color online) O xygen-O xygen pair correlation function g(r) for (a) lysozym e hydration water, and (b) DNA hydration water, on crossing the W idom line from the HDL side (T = 270 K, 300 K) to the LDL side (T = 230 K). Structure factor of hydration water surrounding (c) lysozym e, and (d) DNA on two sides of the the W idom line. Upon crossing the W idom line, the local structure of water changes from more HDL-like to more LDL-like, rejected in the sharper and more prominent instpeak. The instpeak associated with the hydrogen bond distance also moves to small wave vectors, suggesting a change from the HDL to the LDL-like local structure of water at low temperatures. Derivative with respect to temperature of the local tetrahedral order parameter Q for (e) lysozym e and (f) DNA hydration water. A maximum in jdQ =dT jat W idom line temperature suggests that the rate of change of local tetrahedrality of hydration water has a maximum at the
