## Dynamics of a quantum phase transition in the random Ising model

A quantum phase transition from param agnetic to ferrom agnetic phase is driven by a time-dependent external m agnetic eld. For any rate of the transition the evolution is non-adiabatic and nite density of defects is excited in the ferrom agnetic state. The density of excitations has only bgarithm ic dependence on the transition rate. This is much weaker than any usual power law scaling predicted for pure system s by the K ibble-Zurek m echanism.

According to the book [1] our understanding of quantum phase transitions is based on two prototypicalm odels: the quantum Ising chain and the Bose-Hubbard model. It is well established in the exactly solvable Ising model [5{7] and there are indications in the Bose-Hubbard model [8] that essential properties of a dynam icalquantum phase transition are captured by the K ibble-Zurek (KZ) mechanism of defect formation [2]. This theory was originally developed for therm odynam ic transitions and tested both by num erical sim ulations [3] and by experiments in nite-temperature condensed matter system s [4]. It is based on the observation that, because of the critical slowing down, a system driven across its criticalpoint must go out of therm al equilibrium no matter how slow is the transition rate. Using only combination of general casuality and universality argum ents it shows that in a transition from a disordered to ordered phase the system ends in a non-equilibrium state with nite ordered dom ains of average size

Here z and are critical exponents and  $_{\rm Q}$  is time of the transition (or quench). No matter how slow is the transition the system does not have enough time to order throughout its whole volume and average size of ordered domains is limited to a nite ^ which is a power of the transition time  $_{\rm Q}$ .

The short list of the two prototypical models must be supplemented by a prototypical disordered system i.e. the random Ising chain de ned by the Ham iltonian [10,11]

Here  $J_n$ 's are random ferrom agnetic couplings,  $J_n > 0$ , and h is external magnetic eld. This model has a quantum critical point at  $h_c = \exp \frac{\ln J_h}{\ln J_h}$  separating ferrom agnetic (h < h\_c) from paramagnetic (h > h\_c) phase. When h ! 1 the ground state becomes fully polarized along the x-axis,

but when h = 0 there are two degenerate ferrom agnetic ground states

The critical point at  $h_c$  is surrounded by the Gri th regime (or phase) of in nite linear susceptibility.

The random Ising m odel is in portant because real condensed m atter spin system s are random . Their random ness is not a mere small perturbation on top of pure m odels because the disorder is changing their universality class. For example, the random ness of  $J_n$  in the model (2) is changing its universality class with respect to the pure Ising chain with a constant  $J_n = J$ . No matter how weak is the random ness of  $J_n$  renorm alization group transform ations drive the model tow ards an in nite disorder xed point [11]. As a result, the random Ising chain has = 2 instead of = 1 and, more importantly, z ! 1 instead of z = 1. The diverging dynam ical exponent marks a qualitative di erence between the pure and the disordered model. As the dynam ical exponent is relevant to dynam ical phase transitions, its singularity is suggesting that an outcom e of the transition in a disordered system can be qualitatively di erent from that in its pure counterpart. This expectation has never been tested in the theory of dynam ical phase transitions.

In the m odel (2) a dynam ical param agnet-ferrom agnet transition is not adiabatic and, as a result, the state after transition is a superposition over excited states like

with nite ferrom agnetic dom ains separated by dom ain walls or kinks. The diverging dynam ical exponent z implies that, in rst approximation, the size of the ordered dom ains  $\hat{}$  in Eq.(1) does not depend on the quench time. No matter how slow is the transition the average density of kinks d  $\hat{}$  1 rem ains the sam e.

In second approximation we can follow general principles of the KZ mechanism [2] to derive `when z ! 1. These ideas were originally proposed for classical transitions [2], but they were generalized recently to quantum phase transitions [8,9,5,6]. The basic idea is that when a system is driven through a quantum phase transition, then the evolution of its state is adiabatic when the system is away from the critical point, but it must be non-adiabatic in a neighborhood of the critical point where the gap between the ground state and the rst excited state tends to zero. It is convenient to measure the distance from the critical point by a dimensionless parameter =  $\frac{h_c - h}{h_c}$ : The evolution is non-adiabatic between ^ and + ^, where ^ are the two points when transition rate equals the gap . On one hand, assuming that (t) can be linearized near = 0,

we can estimate the rate as  $-\frac{1}{0 \text{ jj}}$ . On the other hand, we know that for jj! 0 the gap behaves like

see Ref. [11]. The rate and the gap equal at ^ when

Here = 0 (1) is a single thing parameter. Quick analysis of this equation shows that  $^{!}$  0 when  $_{Q}$  ! 1 : for very slow transitions the evolution is non-adiabatic only in a very close neighborhood of the critical point, where we can use Eq.(8) self-consistently.

In the adiabatic-in pulse approximation the state of the system follows its instantaneous ground state before  $^{,}$  then its evolution becomes in pulse between  $^{,}$  and  $^{,}$  when the state does not change because reaction of the system is too slow as compared to the transition rate, and nally the evolution becomes adiabatic again after  $^{,}$ . A couracy of the adiabatic-in pulse approximation was tested in the quantum context in Refs. [7,9]. The state of the system at  $^{,}$  is the ground state with a nite correlation length

This state does not change until + ^ when the evolution becomes adiabatic again. In this way the correlation length ^ becomes imprinted on the state of the system after the transition. This length becomes the average size of ordered domains in the nalferrom agnetic state (6). For example, in the random Ising model ( = 2) approximate solution of Eq.(9) in the limit of  $_{\rm Q}$  ! 1 together with Eq.(10) gives

when  $\ln_Q$  1. Again, as in our rst approximation, the dependence on  $_Q$  is very weak as compared to any power law scaling.

A sm entioned before, validity of Eq.(8) is limited only to close vicinity of the critical point. Further away from this point we can expect spectral properties of the model to be more like in the pure Ising model. Thism ust be true at least for weak disorder, when the random  $J_n$ 's have a narrow distribution around a nite J. As a result, for moderately slow transitions, when ^ is large enough, we can expect

like in the pure Ising model with z = 1 [5,6], see Eq.(1).

B efore proceeding with num erical simulations of a dynam ical transition we need better understanding of spectral properties of the random Ising chain. To this end I assume for convenience that N is even and make the Jordan-W igner transform ation,

introducing fermionic operators  $c_n$ , which satisfy anticommutation relations  $c_m$ ;  $c_n^y = {}_{m n}$  and  $fc_m$ ;  $c_n g = c_m^y$ ;  $c_n^y = 0$ . The Ham iltonian (2) becomes

are projectors on subspaces with even (+) and odd ( ) num bers of c-quasiparticles and

are corresponding reduced H am iltonians. The  $c_n$ 's in H satisfy periodic boundary conditions  $q_{N+1} = c_1$ , but the  $c_n$ 's in H<sup>+</sup> must obey  $q_{N+1} = -q_1$ , what I call \antiperiodic" boundary conditions.

The parity of the number of c-quasiparticles is a good quantum number and the ground state has even parity for any value of h. A ssum ing that the quench begins in the ground state we can con ne to the subspace of even parity. In this subspace the quadratic H  $^+$  is diagonalized by a B ogoliubov transform ation

The index m numbers Bogoliubov modes which are eigenmodes with positive ! of the stationary Bogoliubov-de G ennes equations

Here I suppressed the mode number m and de ned  $j_n = J_n$  for n < N and  $j_N = J_N$  to take into account the antiperiodic boundary conditions. The eigenstates  $(u_{nm}; y_{nm})$  with positive energy  $!_m > 0$ , norm alized so that  $_n ju_{nm} f + jv_{nm} f = 1$ , de ne quasiparticle operators  $_m = u_{nm} c_n + v_{nm} c_n^V$ . Each positive energy eigenstate has a partner  $(u_{nm}; v_{nm}) = (v_{nm}; u_{nm})$  with negative energy  $!_m$  which de nes a quasiparticle operator  $_m = (u_{nm}) c_n + v_{nm} c_n^V = \frac{y}{m}$ . A feter the transformation (18) the Ham iltonian  $H^+ = \frac{1}{2} \prod_{m=1}^{N} \prod_{m=m}^{Y} \prod_{m=m}^{Y} m$  equivalent to

which is a simple-looking sum of quasiparticles. However, thanks to the projection  $P^+ H^+ P^+$  in Eq.(15) only states with even numbers of quasiparticles belong to the spectrum of H.




FIG.1. A verage logarithm of the critical gap  $\overline{ln_c}$  as a function of N . Each circle is an average over 500 realizations of J\_n and the solid line is the best t  $\overline{ln_c}$  = 0.74 0.58  $\overline{N}$ .

In nite Ising chain would have zero energy gap at the critical point but in num erical simulations we must use a nite chain with a nite gap  $_{\rm c}$  at  $h = h_{\rm c}$ . As the - nite gap can alter the adiabaticity condition (9) for slow quenches, it is in portant to know how the gap depends on the system size N. For example, in the pure Ising chain  $_{\rm c}$  decays only like 1=N and relatively large N would be required for accurate num erical simulations. In the random Ising chain the \critical gap", which is a sum of energies of the two lowest energy quasiparticles  $_{\rm c} = !_1 + !_2$  at  $h = h_{\rm c}$ , can be found by diagonalization of Eqs.(19). The best t to an average over di erent realizations of J<sub>n</sub> is

see Figure 1. For a given  $_{\rm Q}$  (logarithm of) the critical gap is much less than (logarithm of) the transition rate  $'_{\rm Q}{}^1$  provided that N  ${\rm ln}^2 (_{\rm Q})$ . This condition can be easily met on a relatively small lattice. It is not quite surprising that the condition is equivalent to  $^{\rm N}$  N, com pare Eq.(11).

Finally, after these preparations, I can proceed with numerical simulations of a dynamical quantum phase transition. In my simulations I assumed that the independent random  $J_n$ 's have a uniform distribution in the range (0;2) and the critical eld is  $h_c = \exp \ln J_n = \frac{2}{e}$ . For the sake of simplicity the transition is driven by a linear quench

with t2 (1;0). The system is initially prepared in the ground state at a large initial value of the magnetic eld  $h_i$  i.e. in the Bogoliubov vacuum state for the quasiparticles at  $h_i$ . As the magnetic eld is being turned o to zero, the state of the system j (t) is getting excited from its instantaneous ground state. How ever, in a sim ilarway as in Ref. [5], we can follow the tim e-dependent Bogoliubov m ethod and assume that the excited state j (t) i is a Bogoliubov vacuum for a set of tim e-dependent quasiparticle annihilation operators

This Ansatz is a solution of Schrödinger equation when the Bogoliubov modes  $u_{nm}$  (t) and  $v_{nm}$  (t) solve time-dependent Bogoliubov-de Gennes equations

with the initial condition that at  $h_i$  each mode is a positive frequency eigenmode of the stationary BdG equations (19). The evolution stops at h = 0 when the nal average density of kinks is

U sing the Jordan-W igner transform ation (14) followed by the B ogoliubov transform ation (23), together with the assumption that  $\sim$  (0) j (0) i = 0, the density of kinks can be transform ed into




FIG.2. Density of kinks d as a function of transition time  $_{\rm Q}$  on a lattice of N = 512 sites. Circles are nalkink densities averaged over 4 realizations of J<sub>n</sub>. Error bars set the size of the circles. The solid line is the best td( $_{\rm Q}$ ) =  $\frac{0.15}{^{-2}(3:4_{1}_{\rm Q})}$  where ^(;  $_{\rm Q}$ ) is a solution of Eq.(9). The dotted line is the best power law td  $_{\rm Q}$  <sup>w</sup> to the left-m ost 3 data points and the dashed line is the best power law t to the right-m ost 2 data points. The exponents are w = 0.48 and w = 0.13 respectively. The exponent w = 0.48 for the fastest transitions is consistent with the  $\frac{1}{2}$  in the pure Ising m odel.

The time-dependent BdG equations (24) were solved for a range of alm ost ve decades of  $_{\rm O}$  with the quench (22) starting at  $h_i = 10 h_c$ . Final densities of kinks were collected in Figure 2. To test the equation (9), valid for slow transitions, the data for the slowest quenches were tted by  $d(Q) = \frac{1}{2} (Q)$  with = 2. Here  $^{(; 0)}$  is a solution of Eq.(9) and ; are two thing parameters. Both = 3.02 and = 0.15 turned out to be 0 (1) and the data are in reasonably good agreement with the best t. Although Eq.(9) is con med by num erical simulations, even the slowest quenches with  $_{\circ}$  = 16384, obtained with substantial num erical e ort, are not slow enough to clearly show the asymptotic behavior in Eq.(11) for  $_{\rm Q}$  ! 1 . This is not unexpected because this asymptote is achieved when not only o 1 but also  $\ln_Q$ 1.

The same gure shows two power-law ts d  $_{Q}^{W}$ . Relatively fast left-most quenches were tted with the exponent w = 0.48 which is close to the 1=2 in the pure Ising model. These quenches, whose ^ is relatively large, cannot feel the random ness of  $J_n$ 's and, as predicted, their nal defect density scales like in the pure Ising model [5{7]. For comparison, the two right-most data points were also tted by a power law d  $_{Q}^{W}$ , but this time the exponent is a mere w = 0:13. The exponent w decays with increasing  $_{Q}$  as expected from the quasilogarithm ic solution ^(;  $_{Q}$ ) of Eq.(9).

Conclusion. This paper is the rst test of the Kibble-Zurek mechanism in a disordered system. The test is passed nicely but with an anom alous result that

density of defects after a transition depends only logarithm ically on the transition rate. C rudely speaking, the density is more or less the same no matter how slow is the transition. This result is in sharp contrast to the standard power law scaling predicted for pure system s. This strongly non-adiabatic behavior can be attributed to the anom alously small energy gap near the critical point which is characteristic for a random system with an in nite disorder xed point.
