D ressed molecules in an optical lattice

A bstract. We present the theory of an atom ic gas in an optical lattice near a Feshbach resonance. We derive from rst principles a generalized Hubbard model, that incorporates all the relevant two-body physics exactly, except for the background atom—atom scattering. Form ost atom s the background interactions are negligible, but this is not true for ⁶Li, which has an exceptionally large background scattering length near the experimentally relevant Feshbach resonance at 834 G. Therefore, we show how to include background atom—atom scattering by solving the on—site two-body Feshbach problem exactly. We apply the obtained solution to ⁶Li and not that the background interactions indeed have a signicant elect in this case.

1. Introduction.

The eld of ultracold atoms has recently seen many exciting developments in which strong interactions play a crucial role. Examples are the observation of the quantum phase transition between the super uid and the Mott-insulator phase of a Bose gas in an optical lattice [1], the observation of the BEC-BCS crossover in a Fermi gas [2, 3, 4, 5, 6, 7], and the observation of fermionization in an one-dimensional Bose gas [8, 9]. To a large extent these developments are due to the successful implementation of two new experimental techniques, namely the use of optical lattices [10] and the application of Feshbach resonances in the collision of two atoms [11, 12]. Both techniques have contributed greatly to the unprecendented control over the relevant physical parameters of an atom ic gas.

In this article, we focus on the combination of these two important techniques and present the microscopic theory of an atom ic gas in an optical lattice near a Feshbach resonance. This problem was already studied in ref. [13], where it was argued that an optical lattice could be very well suited to overcome the experimental diculties in studying the quantum phase transition that occurs in an atom ic Bose gas near a Feshbach resonance [14,15]. The observation of this quantum Ising transition between a

phase with only a molecular condensate and a phase with both an atom ic and a molecular condensate is complicated by the fast vibrational relaxation of the Feshbach molecules due to collisions, which appears to prevent the creation of a molecular condensate [16]. In an optical lattice with low lling fractions, collisions can essentially be neglected and this problem is expected to be much less severe. Furthermore, in a subsequent study, a resonantly-interacting Bose-Ferm imixture in an optical lattice was considered, which led to the prediction of another XY-like quantum phase transition, associated with the Bose-Einstein condensation of the bosons in the mixture [17].

In both studies [13,17], a generalized Hubbard model was obtained by incorporating the relevant two-body physics exactly. As a result, simple mean—eld techniques could be used to accurately describe the many-body physics of the atom ic gas near the Feshbach resonance in the optical lattice. This approach led to some discussion [18, 19], which motivated us to rederive in this article the proposed generalized Hubbard model from rst principles by means of a eld-theoretical calculation. In this manner, the validity of the original approach is put on an even more rigorous basis.

A nother aspect that we discuss in this article, is the e ect of background atom -atom scattering on the Feshbach physics. This e ect was not incorporated in the previously mentioned studies, since only systems with a small background scattering length were considered. However, for ⁶Li, which has an exceptionally large background scattering length near the experimentally relevant Feshbach resonance at 834 G, the neglect of the background interactions is no longer allowed. In this article, we therefore show how to include the background atom -atom scattering by exactly solving the two-body Feshbach problem on a single site of the optical lattice. The exact know ledge of the two-body physics on a single site can then be directly incorporated into a generalized Hubbard model that describes the many-body physics of ⁶Li in an optical lattice near a Feshbach resonance, in a similar manner as recently achieved for ⁴⁰K [20].

2. E ective atom -m olecule theory.

In this section, we give an ab initio eld-theoretical derivation of the e ective atom—molecule theory that describes an atom ic gas in an optical lattice near a Feshbach resonance. The theory is formulated in the tight-binding limit and incorporates all the relevant two-body physics exactly. If desired, this rather technical section can be omitted in a rst reading of the article. To facilitate this, section 3 has been written in such a way that it stands on its own. There, we show how to solve analytically the two-channel Feshbach problem for two atoms on a single site including background atom—atom scattering. We also apply the obtained theory to ⁶Li.

2.1. Elective action.

The quantity of interest in a quantum – eld theory is the generating functional Z of all the G reen's functions. This functional determ ines all the possible correlation functions

of the system. Specically, let us consider the eld theory for an atom-molecule gas that is described by the action $S[_a;_a;_m;_m]$, with $_a$ and $_m$ being the atom ic and molecular elds, respectively. The generating functional in imaginary time is dened by

where the source currents couple to the elds according to,

By taking functional derivatives of \mathbf{Z} with respect to the currents we can calculate all the correlation functions of the theory.

Instead of working with Z we usually prefer to work with the generating functional W of all the connected G reen's functions, which is related to Z through $Z = \exp(W)$. The functional derivatives of W with respect to the currents are the expectation values of the elds, i.e.,

Similar equations hold for the expectation values of the complex conjugated elds $_a(x;)$ and $_m(x;)$. Instead of using W, which only depends on the current sources, it is possible to de ne a functional that depends explicitly on the elds $_a(x;)$ and $_m(x;)$, and which is related to W by means of a Legendre transform ation, i.e.,

The reason for de ning this functional is that is related to the exact e ective action of the system through $S^e = h$. Technically, is the generating functional of all one-particle irreducible vertex functions. In our case, the exact e ective action for the atom -m olecule theory can be written as

where $G_{a=m}$ is the exact propagator of the atom s/m olecules, and g is the exact three-point vertex. The dots denote all possible other one-particle irreducible vertices, which turn out to be less relevant for our purposes.

2.2. M icroscopic action.

Starting from the microscopic atom-molecule theory in an optical lattice, it is our goal to derive an elective quantum eld theory, that contains the relevant two-body physics

exactly. For calculational convenience and to facilitate comparison with previous work [13], we consider the case of bosonic atoms. The generalization to ferm ionic atoms is then straightforward.

The totalm icroscopic action S describing resonantly-interacting atom s in an optical lattice can be split up in three parts, namely a purely atom ic part S_a , a purely molecular part S_m and a coupling between atom s and molecules S_{am} ,

The purely atom ic part S_a is given by

with the chem ical potential, m_a the atom ic m ass, a_{bg} the background scattering length and $V_0(x)$ the external periodic potential due to the optical lattice. In stinstance, we neglect the background atom -atom scattering, since we are primarily interested in the resonant interactions between the atoms and the molecules. For most atoms, this is an accurate approximation. Furthermore, the same approximation was also used in previous work [13], with which we ultimately want to compare the following derivation. Finally, in section 3 we overcome this approximation and show how to include the elect of background atom -atom scattering.

The purely molecular action $S_{\text{m}}\,$ is given by

where $_{\rm B}$ is the so-called bare detuning (see also section 3). The action $S_{\rm am}$ corresponding to the atom -m olecule coupling that describes the form ation of a bare molecule from two atoms and vice versa, is given by

where g(x) denotes the atom -m olecule coupling.

We can write the actions involving the atom ic elds in a more convenient way as

From the microscopic atom-molecule action we can calculate the grand-canonical partition function Z as the functional integral

Since the integral is G aussian in the atom ic elds, we can perform this integral exactly, giving

where the traces are taken over a 2 2 m atrix structure, coordinate space, and im aginary time. By integrating out the atoms, we have obtained an elective action for the bare molecules that consists of three terms. The rest term represents the contribution from the ideal atomic gas, which does not depend on the bare molecular elds. The second term can be brought in a more illuminating form by expanding the logarithm. Because of the trace, only even powers in the expansion give nonzero results, yielding

The rst nonzero term is of second order, namely $Tr[G_a G_a]=4$, and expresses that a molecule can break up into two atoms and recombine again. This term can be interpreted as corresponding to the self-energy of the bare molecules and a diagram matric picture of the term is shown in gure 1. The higher-order terms in equation (18) pertain to interactions between the bare molecules.

2.3. Molecular self-energy.

Next, we evaluate the molecular self-energy term, $Tr[G_a G_a]=4$, by explicitly carrying out the trace. As a rst step, we introduce center-of-mass coordinates




Figure 1. Diagram matic representation of the term $Tr[G_a G_a]=4$, which expresses that a bare molecule can break up into two atoms and recombine again. The coupling strength between the atoms and the molecule is given by g. This diagram can be interpreted as a self-energy of the bare molecules.

 $R = (x^0 + x^0) = 2$, $R^0 = (x + x^{00}) = 2$ and relative coordinates $r = x^0 - x^0$, $r^0 = x^{00} - x$. Writing out the trace in these coordinates yields

where in the last line we made use of the usual pseudopotential approximation g(r) = g(r).

In order to proceed, we rewrite the atom ic G reen's functions by perform ing an expansion for both their spacial and temporal arguments. For the expansion of the space dependence, we use the complete set of atom ic B loch wave functions $a_{n,k}$, which are solutions to the Schrödinger equation for a particle in a periodic potential

Here, the exact B loch wave functions are given by

with $w_n^a(x)$ the so-called (atom ic) W annier functions, x_i the location of the optical lattice sites, N_s the total number of sites, k the lattice momentum, and n a set of quantum numbers for the various B loch bands in the optical lattice. The Fourier expansion in imaginary time is performed by using the well-known M atsubara modes [21]. Combining the two expansions, we obtain

Next, we also expand the space and imaginary-time arguments of the molecular elds $_{m}$ (x;). For the temporal expansion we use again the M atsubara modes and for the spacial expansion we use the (molecular) W annier functions w_{n}^{m} (x). As a result,

with the complex conjugated version for $_{m}$: The operators $b_{n,i}$ annihilate a molecule with a set of quantum numbers n on site i of the lattice.

The integrals over the imaginary time variables and 0 can now easily be performed, resulting in the conditions $!_{n} = !_{n^{0}} = !_{m} + !_{m^{0}}$. Furthermore, if the optical lattice is deep, it can at every site be well approximated by an harmonic potential, characterized by the frequency !. Then, we are also allowed to use the so-called tight-binding limit, in which the W annier functions w_{n} are replaced by the tight-binding functions n, i.e.

Here, $_{\rm n}$ (R) are the eigenstates of the three-dimensional isotropic harmonic oscillator potential given in spherical coordinates by

where $L_n^{(1=2+\ ')}$ (X) are the generalized Laguerre polynom ials and Y_m (;) the spherical harm onics. For the atom s, the harm onic oscillator length 1 is given by $l_a=h=m_a!$; for the molecules, the harm onic oscillator length 1 is given by $l_a=2$. Furtherm ore, in the extreme tight-binding lim it the energies l_n , in equation (23) are given by l_n , l_n = l_n (2n + '+ 3=2)h! and only depend on the radial and angular momentum quantum numbers n and ', respectively. Similarly, we have that l_n (n;k;i!m) = l_n (n;i!m). Also note that in the tight-binding limit, the overlap for wave functions on dierent lattice sites is negligible. As a result, we can consider only the terms on the right-hand side of equation (25) that have all atom is and molecular W annier functions centered around the same site l_n . Furtherm ore, because of translational invariance of the lattice, we can set l_n to zero in the integrant. Next, we evaluate the sum over M atsubara frequencies, keeping the external frequency $!_m + !_{m^0} = !_n$ of the molecules xed. First, we rewrite the product of G reen's functions as

Subsequently, we perform the sum and take the two-body lim it, which amounts to taking the atom ic distribution functions, obtained after the M atsubara sum m ation, equal to zero [21]. We nd

where $_{n}^{m=a}$ (R) denotes the molecular/atom ic tight-binding function. For systems of interest to us, the molecules occupy only the lowest Bloch band, i.e., we take the band indices m and m⁰ of the molecular elds in the last expression equal to zero. The tight-binding function $_{0}^{m}$ is given by $_{0}^{m}$ (R) = $(2=\frac{1}{2})^{3=4}$ e $^{(R=1_a)^2}$.

where on the right-hand side of the above equation the integration variable R is made dimensionless using the length l_a . The integrations over the angles can be directly evaluated using the orthonormality relations for the spherical harmonics. To evaluate the remaining integral over R, we make use of the following relation [22]

2.4. Generalized Hubbard model

So far, we have calculated the self-energy of the bare molecules, but we have not yet taken into account the e ects due to the purely molecular action S_m and the purely atom ic action S_a . This is what we do next.

From equation (50), we see that the elective Hamiltonian depends on several parameters. In particular, it depends on the energies of the dressed molecular elds and the wavefunction renormalization factors Z. In this section, we calculated these parameters from retprinciples by a eld-theoretical calculation. But from a comparison with ref. [13], we see that exactly the same results can be obtained from just a two-body calculation on a single site. This is as expected, since the poles of the molecular

G reen's function correspond to the physical eigenstates of the on-site two-body Feshbach problem .

So far, we did not take into account background atom -atom scattering, which is expected to be of particular in portance for $^6\mathrm{Li}$, which has an extremely large background scattering length. Because we use an elective Hamiltonian and dressed molecular elds, we can include the background scattering in a very convenient way. Namely, if we are able to solve the two-body physics on a single site including background scattering, then, through the notion of our dressed elds, the background scattering gets automatically incorporated into the many-body theory. This is what we achieve in the next section.

3. Two-body physics on a single site.

Consider the Feshbach problem for two atoms on a single site of an optical lattice. In the typical case of experimental interest, the optical lattice potential is deep and the energy of the atoms is low. As a result, the on-site potential is well approximated by an isotropic harmonic potential with angular frequency! Furthermore, the atoms interact with each other through the potential V_{aa} which depends only on their relative coordinate r, while the atom-molecule coupling is given by V_{am} . The resulting problem can be separated into a center-of-mass part and a relative part. Only the relative part is important in solving the two-body physics on a single site, while the center-of-mass part determines the tunneling of molecules between adjacent sites.

Taking all this into account, the relative Schrodinger equation for the two-channel Feshbach problem on a single site becomes

Note that in writing down equation (52) we have assumed that the energy of the bare molecular state j_m i is not a ected by the optical lattice. This is well justified, since the spatial extent of the bare molecular wavefunction, gentered around r=0, is very small compared the the harmonic oscillator length l_a $h=m_a!$. 3.1. No background atom -atom scattering.

The energy-independent divergence in equation (58) is an ultraviolet divergence resulting from the use of pseudopotentials, and was rst obtained by Busch et al. in the context of a single-channel problem [23]. which has two major advantages. Not only do we absorb the ultraviolet divergence in the de nition of , but this renormalized detuning also has a relevant experimental meaning, in contrast to $_{\rm B}$. Namely, corresponds to the detuning from the magnetic eld ${\rm B_0}$, at which the Feshbach resonance takes place in the absence of an optical lattice. This can be understood from the treatment of the homogeneous Feshbach problem without an optical lattice [24]. Here, the condition for the location of the Feshbach resonance is that the dressed molecular energy is equal to the threshold of the atomic continuum. This leads to the resonance condition $_{\rm B} = \lim_{\rm r! \ 0} \, {\rm mag^2} = 4 \, h^2 \, {\rm r. As a result}$, the de nition in equation (59) places the resonance in the absence of an optical lattice conveniently at = 0 and, by construction, the (renormalized) detuning is of the following form

which allows us to calculate the eigenenergies of the Feshbach problem on a single site given a certain detuning . Note the similarity between equation (61) and equation (47). The only two di erences are a constant shift in the energy of 3h! = 2 and a factor of 2, which are both readily explained. The shift of 3h! = 2 is just the center-of-m ass energy neglected in this relative calculation. The factor of 2 is due to the fact that here we consider ferm ions, while in the previous section we considered bosons. Since equations (47) and (61) are for the rest completely equivalent, we see that indeed the energies of the dressed molecular elds b, needed for the e ective H am iltonian of equation (50), can just as well be determined from a two-body calculation, as from a eld-theoretical calculation. An obvious advantage of the two-body approach is that it is much simpler. Furtherm ore, as we show in the next paragraph, the two-body approach also allows for an incorporation of atom -atom scattering e ects, which is of course also possible, but much more dicult from a eld-theoretical point of view. These e ects are particularly im portant for the ferm ion 6Li, which has a very large background atom -atom scattering length a_{bg} near the extrem ely broad Feshbach resonance at B $_0$ = 834 G , nam ely on the order of $1500a_0$, where a_0 is the Bohr radius.

3.2. With background atom -atom interaction.

The relative Schrodinger equation for two atoms in a harmonic potential interacting through the pseudopential $V_{aa}=V_{0}$ (r) without coupling to a molecular state

can be solved analytically for s-wave scattering following a treatment along the lines of ref. [23]. We just note that in this reference a suspicious in olecular' bound state appears, which we believe to be unphysical for several reasons. Most convincing is probably to consider the lim it $a_{bg} ! 0^+$, in which case the interaction vanishes and we should recover the case of a simple harmonic oscillator. This is indeed what happens in ref. [23], except for the suspicious bound state, whose energy goes to minus in nity. Since such a state does not arise in the treatment of the harmonic oscillator, we conclude that the state is unphysical and we will exclude it from further calculations. Note also that for the special case of 6 Lithis issue is not relevant, since the suspicious state only occurs for positive values of a_{bg} .



This relation is illustrated by gure 2, where aa , $^{0}_{k}$ p 2 $k_{l_{a}}A$ $_{k}$ = \sin $_{0}$ and their di erence are plotted as a function of r. We see that the di erence indeed vanishes for small r and increases with increasing r. The scattering states $_{k}$ (r) are the solutions of






Figure 2. (a) Plot of the wavefunctions aa and $^{0}_{k}$ as a function of the interatom ic distance r. On the scale of the gure, the two wavefunctions cannot be distuinguished. (b) Plot of the difference between the wavefunctions aa and $^{0}_{k}$ as a function of the interatom ic distance r. Note that this difference is extremely small compared to the value of the wavefunctions them selves. All quantities on the axes are made dimensionless using the atom ic harmonic oscillator length l_a

the relative two-atom s-wave scattering problem without optical lattice and without atom -m olecule coupling [24]. The physical reason for the similarity between (r) and $_k$ (r) near r=0 is due to the following: for small r compared to l_a , the atom s experience an electively constant harmonic potential by which they are not a exted. Therefore, for small r the wavefunction from the theory with optical lattice should, up to a normalization, reduce to the wavefunction from the theory without optical lattice. Since it is known how to solve the homogeneous Feshbach problem without an optical lattice [24], we are able to prote from this knowledge. This is what we do in the next paragraph.

3.3. Solving the two-atom Feshbach-problem.

By combining equations (66) and (72), we obtain

where by construction = (B B_0) again. As in section 3.1, the term on the right-hand side of equation (77) can be interpreted as a molecular self-energy h $_m$ (E). Furtherm ore, upon going to a many-body theory, the solutions of equation (77) can be interpreted as the energies of the dressed molecular elds b, resulting in a generalized Hubbard Ham iltonian in the same way as before.

For ${}^6\text{Li}$, which has a very large a_{bg} , we expect the e ects of the background scattering to be of particular importance. Therefore, in the next paragraph, we study equation (77) for the specie case of ${}^6\text{Lito}$ see if it leads to significant differences from the results given by equation (61), which doesn't take background scattering into account.

3.4. Lithium

Figure 3a shows the energy-levels of two interacting $^6\mathrm{Li}$ atoms in the hyper ne states jli and j2i on a single site near the Feshbach resonance at 834 G. The diagram has been obtained by numerically solving equation (77), where we used the known experimental values for g(B) and a_{bg} (B) corresponding to $^6\mathrm{Li}$ [25]. Note that for the extremely broad Feshbach resonance at 834 G these parameters depend on the magnetic eld B. Furthermore, we took for l_a the realistic value 10 7 m, corresponding to ! = 10^6 s 1 . In gure 3b the same diagram is shown, but this time without taking the background atomatom scattering into account. This diagram has been obtained by numerically solving equation (61), where again the experimental value of the parameter g(B), corresponding to $^6\mathrm{Li}$, was substituted.

From gure 3, we see that for ^6Li near the Feshbach resonance at 834 G it is important to include background atom -atom interactions, since it leads to a signi cant adjustment of the corresponding two-body energy-level diagram. Upon inclusion of the background atom -atom interactions, the horizontal asymptotes are shifted to dierent energy values and the avoided crossings, see also ref. [13], become much less broad. Physically, this is a result of the fact that the large value of a_{bg} e ectively reduces the atom -m olecule coupling.




Figure 3. (a) Relative energy levels (solid lines) as a function of the magnetic eld B for a system consisting of two $^6\mathrm{Li}$ atoms in the hyper ne states jLi and j2i near the Feshbach resonance at 834 G in a harmonic potential of $!=10^6$ s 1 with background atom—atom scattering taken into account. The dashed line corresponds to the binding energy of a dressed $^6\mathrm{Li}_2$ —molecule in the absence of an optical lattice. Note that as the eigenenergy of the dressed molecular ground state with optical lattice (solid line) decreases, it converges to the dressed molecular eigenenergy without optical lattice (dashed line). (b) Similar to panel (a), only this time the background atom—atom scattering is not taken into account. Note that as a result both panels dier signicantly.

The di erence between equations (61) and (77) in the case of $^6\mathrm{Li}$ becomes even clearer when we look at the corresponding wavefunction renormalization factors Z given by equation (48), which are needed for the construction of the elective Hamiltonian given by equation (50). For the calculation of Z we need the molecular self-energy h m, which is given by the right-hand side of equation (61) for the case without background atometom scattering and by the right-hand side of equation (77) for the case with background atometom scattering. In gure 4, the corresponding wavefunction renormalization factors Z are plotted for both cases as a function of the magnetic eld B. Here, Z_0 corresponds to the groundstate of the relative on-site two-body Hamiltonian, Z_1 corresponds to the rst excited state, and so on. Note that the two-body renormalization factors Z obtained including background interactions (gure 4a), are very different from the factors obtained without background interactions (gure 4b).




Figure 4. (a),(b) W avefunction renormalization factors Z for $^6\mathrm{Li}\,\mathrm{near}$ the Feshbach resonance at 834 G as a function of the magnetic eld B with background atom-atom scattering taken into account. Z₀ is the renormalization factor corresponding to the ground state of the two-body on-site Feshbach problem, Z₁ is the renormalization factor corresponding to the rst excited state, and so on. (c),(d) W avefunction renormalization factors Z for $^6\mathrm{Li}$ as a function of the magnetic eld B without background atom-atom scattering. Note that the panels on the left dier signicantly from the panels on the right.

A lso note that these factors are directly experim entally observable as demonstrated by Partridge et al. [7]. We thus conclude that background atom—atom scattering plays a signi cant role for an atom ic gas of $^6\mathrm{Li}$ atom s in an optical lattice near the Feshbach resonance at $834~\mathrm{G}$.

4. Conclusion

In sum mary, we have derived from rst principles an elective atom -molecule theory that describes an atom ic gas in an optical lattice near a Feshbach resonance. The theory was formulated in the tight-binding limit and incorporated all the relevant two-body physics exactly. The eld-theoretical derivation recon rmed that an atom ic gas in an optical lattice near a Feshbach resonance is accurately described by a generalized Hubbard model, as rst obtained in ref. [13]. In the original approach of ref. [13] the

generalized Hubbard model was derived in an easier way by starting from a two-body calculation on a single site. Due to the equivalence of both approaches, we used the latter to form ulate a way in which to include the background atom -atom scattering into the many-body theory, which has not been done previously. To this end, we showed how to solve exactly the two-channel Feshbach problem for two atoms on a single site including background atom -atom scattering. The solution was applied to ⁶Linear the experimentally relevant Feshbach resonance at 834 G. Specically, the two-body on-site energy levels and the wavefunction renormalization factors Z were obtained, which are needed for the generalized Hubbard Hamiltonian describing the many-body physics. As it turned out, the various energy levels and the wavefunction renormalization factors obtained with background interactions taken into account, are signicantly dierent from the energy levels and the renormalization factors obtained without background interactions taken into account. From this we conclude that in the case of ⁶Libackground atom-atom scattering plays an important role and cannot be neglected for an accurate microscopic description of future experiments with atom ic lithium in an optical lattice.
