N on-universal suppression of the excitation gap in chaotic Andreev billiards: Superconducting term inals as sensitive probes for scarred states

W hen a quantum -chaotic norm al conductor is coupled to a superconductor, random -m atrix theory predicts that a gap opens up in the excitation spectrum which is of universal size $E_g^{RMT} = 0.3 \sim = t$, where t_D is the mean scattering time between Andreev rejections. We show that a scanned state of long lifetime t_S to suppresses the excitation gap over a window $E = 2E_g^{RMT}$ which can be much larger than the narrow resonance width $s = \sim = t_S$ of the scar in the normal system. The minimal value of the excitation gap within this window is given by s=2. E_g^{RMT} . Hence the scarred state can be detected over a much larger energy range than it is the case when the superconducting term inal is replaced by a normal one.

Typical wavefunctions in classically chaotic quantum system s [1, 2] display a structure-less speckle pattern which is well captured by Berry's random plain-wave model [3]. These quantum systems obey a strong degree of universality which makes them amenable to a random – matrix theory (RMT) description. Recent advances of sem iclassical techniques [4, 5, 6, 7] link the random – matrix universality to the condition of well-developed wave chaos. Two sources of deviations from this condition have been identi ed. The rst source is rooted in the quasi-determ inistic quantum -to-classical correspondence of the dynam ics for times shorter than the Ehrenfest time t_E [4, 5, 6, 7, 8]. The second source is the scarring of wavefunctions along the trajectories of periodic orbits [9, 10, 11, 12, 13].

The complementary nature of both sources of nonuniversality becom es apparent when the system is opened up, so that typical states acquire a width of order $E_{Th} = -t_p$ (the Thouless energy), where t_p is the classicalmean dwelltime in the system [14]. Quantum-toclassical correspondence then induces anom a lously shortlived states with resonance width much larger than E_{Th} [15]. Scarred states, on the other hand, can acquire lifetimes t_s much larger than the typical lifetime t_D when the openings are not visited by the periodic orbits which support the scar. The resulting narrow resonances of width $s = -t_s$ have been observed experimentally and num erically in a large variety of physical system s, such as lateral quantum dots [16], m icrow ave cavities [17], resonant tunnel diodes [18], m icro-optical lasers [19], and surface waves [20].

In general, scarred states are a rare fraction of all states of a system [9, 10, 11, 12, 13] and their in uence can be ignored for alm ost all energies, with the exception of the resonance intervals of size $_{\rm S}$. The purposes of this paper is to dem onstrate that scarred states can be detected over much larger energy ranges when the norm al opening is replaced by a superconducting term inal so that the system form s a so-called Andreev billiard [21]. Chaotic




FIG.1: Left panel: Excitation spectrum as function of the Ferm ienergy E_F , obtained by numerical computations for the Andreev billiard shown in the right panel. The lowest excitation energy (triangles) determ ines the excitation gap. The second, third, forth and fith excitation energy are shown as led circles. The energy of the scarred eigenstate is highlighted by open squares. The dashed line shows the random – m atrix prediction E_g^{RMT} for the gap. 0 ther lines are guides for the eye. R ight panel: The Andreev billiard is a segment of a Sinaibilliard with W = 0.21 a, h = 0.58 a, and R = 0.83 a. The pair potential in the superconductor is $_0 = 0.015 E_F$. In the energy range of the left panel, there are N = 25 open channels in the superconducting lead.

A ndreev billiards have attracted m uch attention over the past years [22] because they display a gap E_g in the excitation spectrum which is induced by the superconductor due to the dynam ical process of A ndreev re ection (retro-re ections at the superconducting interface which convert electrons into holes or vice versa, at the expense of C coper pairs which are absorbed or em itted from the superconductor). R andom -m atrix theory predicts that this gap is of size $E_g^{RMT} = 0.3 E_{Th}$, where the T houless energy refers to the system with the norm alopening (the associated dwell time t_D is identical to the mean time between successive A ndreev re ections in the Andreev billiard) [22, 23].

We show that a long-lived scarred state with lifetime t_S t_D reduces the excitation gap over an energy window E $2E_{\alpha}^{RMT}$ s. The scar hence determines




FIG.2: The square moduli $j_{1}j_{1}$ of the electron and $j_{2}j_{1}$ of the hole components of the wavefunction for $E_{\rm F} = E_{\rm Th} =$ 707:434 < $E_{\rm F,m}$ in (a), for $E_{\rm F} = E_{\rm F,m}$ in (b) and for $E_{\rm F} = E_{\rm Th} =$ 707:695 > $E_{\rm F,m}$ in (c).

fundam ental system properties over a much larger range of energies than in the open norm alsystem. The sm allest value of the excitation gap within the window is given by $E_{g;min} = S^{-2}$. The minimal size of the gap is therefore much sm aller than the RMT prediction E_g^{RMT} . In particular, the reduction of the excitation gap can be far stronger than the reduction due to both the quantum – to-classical correspondence for times sm aller than the Ehrenfest time, observed in Refs. [24, 25], and the meso-scopic uctuations, studied in [26].

We rst present num erical evidence for these results and then develop a theoretical description which relates the excitation energy of scarred states in the Andreev billiard to properties of the scar in the norm albilliard.

The excitation energies " of an Andreev billiard are given by the eigenvalues of the Bogoliubov-de G ennes (BdG) equation

Here $\hat{H}_0 = \frac{\tilde{r}^2}{2m}r^2$ E_F is the single-particle H am iltonian with the chem ical potential in the superconductor set equal to the Ferm ienergy E_F in the norm alpart of the system. The wavefunction is composed of an electronic part u (r) and a hole part v (r) which are coupled via the superconducting pair potential (r) with value 0 in the bulk of the superconductor. Typical Andreev billiards satisfy the separation of energy scales E_{Th} 0 E_F. O ne can then assume that (r) = 0 is constant in the superconducting region and vanishes in the norm alpart of the system [22]. Solutions of Eq. (1) com e in pairs of excitation energies ", where one solution is of the form and the other solution is of the form

In order to convince ourselves of the visibility of scars in the excitation spectrum of an Andreev billiard we

solved the Bogoliubov-de Gennes equation num erically for the chaotic billiard shown in the right panel of Fig. 1 [25, 27]. The norm alpart is a de-sym metrized segment of a Sinai billiard. The superconducting term inal is attached to one of the straight walls. The left panel of Fig. 1 shows the positive excitation energies as a function of the Fermi energy E $_{\rm F}$, scaled in units of the Thouless energy E $_{\rm T\,h}\,$ (the dependence of the T houless energy on the Ferm i energy is taken into account in this rescaling). The second, third etc. excitation energies show the characteristic level dynam ics of chaotic system swhen one param eter is changing, and avoided crossings can also be observed. Random matrix theory predicts that the excitation gap (set by the the lowest positive excitation energy) uctuates around the value $E_{\alpha}^{RMT} = 0.3E_{Th}$ (dashed line) [22, 23]. However, there is an energy interval of width $E = E_{Th}$ 026 in which the excitation gap drops distinctively below this value. The smallest gap $E_{gm in} = 0.0654 E_{Th}$ is attained at Ferm i energy $E_{F,m in} = 707:567 E_{Th}$.

Inspection of the wavefunction of the lowest eigenstate in this energy interval reveals an interesting feature: for E_F smaller than $E_{F,m in}$ [see Fig. 2(a)], the electronic component u is nonuniform and shows clear signatures of scarring along a fam ily of marginally stable periodic orbits which bounce between the straight segments of the billiard. Calculating the probability $P_e = -i j_1 j_1 dr$ $(P_h = jv j' dr)$ of nding the quasiparticle in the electron (hole) state in the norm alpart of the system, one nds $P_e = 0.915$ and $P_h = 0.078$, i.e. the quasiparticle is dom inantly electron-like (the remaining weight is in the superconductor). The next panel [Fig. 2 (b)] corresponds to the eigenstate at the minimum of the excitation gap in Fig. 1(a), showing that in this case both u and v are nonuniform, and the probabilities are $P_e = 0.520$ and $P_h = 0.474$. In Fig. 2(c) we show an eigenstate at a Ferm i energy which is larger than E_{Fm} in . Here the hole component is scarred by the same fam ily of periodic orbits and the quasiparticle becom es dom inantly hole-like with $P_e = 0.064$ and $P_h = 0.929$.




FIG. 3: Scattering wavefunction of the open norm aldot at energies E = $E_{\rm F\,m\,in}$ (a) and E = 707:657 $E_{\rm T\,h}$ (b). The states are excited by an incom ing wave in the third transverse mode of the lead.

These observations suggest that the suppression of the excitation gap and the scarring of the wavefunction stem s from a long-lived scarred quasibound state of the norm al open billiard. W hen the superconducting term inal is replaced by a norm al lead, a scarred state can indeed be detected for energies very close to E_{Fm in} { see the left. panel of Fig. 3, which shows a scattering state computed at the energy $E = E_{F,m in}$. For a slightly dierent energy $E = 707.657E_{Th}$, how ever, this scar is already very much dim inished, as is shown in the right panel of Fig. 3. At this energy, the gap in the excitation spectrum of the Andreev billiard is still strongly suppressed. These num erical results dem onstrate that a long-lived scarred state can be detected over an energy window much larger than its resonance width s in the norm albilliard when the system is coupled to a superconducting term inal.

W e now present a theory which explains the num erical observations. In particular, we relate the Ferm i-energy dependence of the scarred excitation in the Andreev billiard to the properties of the scarred state in the open norm al billiard. Such relations can be derived because the excitation spectrum of Andreev billiards can be calculated from the scattering matrix S (E) of the norm al system using the quantization condition [22]

which is valid in the limit " $E_{\,\rm F}$. The scat-0 tering matrix is a unitary (and in absence of a magnetic eld also sym m etric) m atrix of dim ensions N N, given by the number of open channels N in the opening. In $Eq.(2) S(E_F + ") [S(E_F)]$ ")] describes the propagation of electrons [holes] and denotes com plex conjugation. Equation (2) embodies the condition of total constructive interference after two Andreev re ections, so that an electron is converted is to a hole and then back to an electron. (Each Andreev re ection contributes a phase factor of i.)

Narrow resonances in the normal system are associated to poles of the scattering matrix which are situated close to the real axis in the lower half of the complex energy plane. In what follows we will assume that there is only one such narrow resonance in the energy range of interest, namely that associated to the scarred state, located at a complex energy $E = E_S$ i_s=2. In order to isolate the contribution of this narrow resonance to the scattering matrix we rst diagonalize S(E) = $O(E)(E)O^{T}(E)$ where O(E) is an N N dim ensional orthogonal matrix and (E) is a diagonal matrix containing the eigenvalues $_{i}(E)$, i = 1 ::: N. In the vicinity of the narrow resonance the energy dependence of 0 (E) can be neglected [28]. Inserting the decomposition $S(E) = O(E)O^{T}$ into Eq. (2) one then nds that the quantization condition can be written as

O ne of the eigenvalues, $_{\rm S}$ (E), is associated to the narrow resonance, while the other eigenvalues are associated to

the remaining non-resonant states in the system . The resonant eigenvalue can be approximated as $_{\rm S}$ (E) = $e^{2i_{\rm S}}(E)\frac{E}{E-E}$ [28] where the energy dependence of $_{\rm S}$ (E) can again be neglected over the energy range of interest. Dem anding that the term involving $_{\rm S}$ in Eq. (3) be zero,

one can nd the excitation energies

associated to the scarred eigenstate of the Andreev billiard in terms of the energy and width of the scarred resonance in the open norm alsystem. The excitation energies come in pair as required by the particle-hole sym – metry of the BdG equation (1).

For Ferm i energies far less than the energy E_S of the scar in the norm al system, the positive excitation energy is given by "s E_S E_F , which is then far larger than the RMT gap and hence corresponds to a highly excited state. As E_F is increased, the excitation drifts E_α^{RMT} down through the spectrum , and assuming $_{\rm S}$ the scarred state eventually becom es the lowest excited E_{α}^{RMT} . This de nes the state at an energy E_F E_{S} beginning of the energy interval in which the scar can be detected by m easuring the excitation gap of the Andreev billiard. The m in im alvalue $E_{g,m in} = m in_{E_F} J''_S j = S = 2$ of the excitation gap is obtained for $E_{F,m}$ in = E_S . W hen the Ferm i energy is further increased the excitation energy increases as well, and for values $E_F \& E_S + E_{\alpha}^{RMT}$ the scarred state becom es again a higher excited state, with energy "s E_F E_S . This explains the qualitative features observed in Fig. 1 (a).




FIG. 4: Left panel: The phase (E) = Im $\ln \det[S (E)]$ of the scattering matrix of the open normal billiard [Fig. 1(b) with the superconducting term inal replaced by a normal lead] is plotted as a function of energy (circles). The solid line shows a t of the function $2 \arctan \frac{S}{2(E - E_S)} + C E + _0$ to (E). Right panel: Q uantitative com parison of the excitation energies of the scarred Andreev bound state (squares) with Eq. (5) (solid line), using the parameters E_S and $_S$ of the scar in the normal system.

The microscopic parameters E_s and s=2 entering Eq. (5) can be determined directly from properties of the open norm albilliard. The left panel of Fig. 4 shows the phase (E) = Im ln det S(E) of the scattering matrix over the energy range in which the scardeterm ines the excitation gap. The energy dependence due to the resonant eigenvalue $_{\rm S}$ is given by Im In $_{\rm S}$ 2 $\arctan \frac{s}{2(E - E - s)}$, while the non-resonant states in the system contribute a linear background $C E + _0$ with C 2 = N, where $_{\rm N}$ is the mean level spacing of the normal system . A t of the curve 2 arctan $\frac{s}{2(E - E - s)}$ + CE + 0 to the num erical data delivers the values $E_s = 707:567E_{Th}$ and $_{\rm S}$ =2 = 0:0745E $_{\rm T\,h}$. The width is in good agreement with the sm allest value E_{qm} in of the excitation gap given above, and the energy of the scar coincides exactly with the Ferm i energy E_{Fm in} at which this m in im al value is attained. The right panel of Fig. 4 shows that substituting the obtained parameters E_s and $_s$ into Eq. (5), a quantitative agreem ent can be found between the theoretical prediction and the computed values of the excitation energies of the scarred states.

Finally, we turn to the observation that the scarred character of the state in the Andreev billiard shifts from the electronic component for $E_F = E_{F,m}$ in to the hole component for $E_F = E_{F,m}$ in, while both components show an equal amount of scarring for $E_F = E_{F,m}$ in (see Fig.2). The weight of the scar in each component can be de ned by the squared overlaps $P_{e,S} = j_{S} u drf$ and $P_{h,S} = j_{S} v drf$ with the scarred wavefunction s in the norm al billiard. To a good approximation, these weights should be proportional to the time spent as a particle or hole excitation, which can be quanti ed by the W igner delay time $_W (E) = -\frac{d}{dE}$ [14]. W ithin our previous approximations, we can write

Ignoring the constant C which accounts for the background of non-resonant states we nd

For $E_F = E_S$ this delivers $P_{e;S} = P_{h;S}$, hence scarring in the electronic part of the wavefunction, while the hole part is scarred for $E_F = E_S$. For $E_F = E_S$ the weights in both components are predicted to be equal. This explains the observations in Fig. 2.

In sum m ary, we have demonstrated theoretically and numerically that long-lived scarred wavefunctions of quantum-chaotic system can be observed over large ranges of the Ferm i energy when the system is connected to a superconducting term inal. The resulting suppression of the excitation gap should be accessible in experiments by tunnel spectroscopy [29]. The Ferm i energy can be controlled by side gates [30].
