

Exploring the operation of a tiny heat engine

We model a tiny heat engine as a Brownian particle that moves in a viscous medium in a sawtooth potential (with or without load) assisted by alternately placed hot and cold heat baths along its path. We find closed form expression for the steady state current as a function of the model parameters. This enables us to deal with the energetics of the model and evaluate either its efficiency or its coefficient of performance depending upon whether the model functions either as a heat engine or as a refrigerator, respectively. We also study the way current changes with changes in parameters of interest. When we plot the phase diagrams showing the way the model operates, we not only find regions where it functions as a heat engine and as a refrigerator but we also identify a region where the model functions as neither of the two.

I. INTRODUCTION

Understanding the physical properties of devices of micron- and nano-meters sizes is of interest these days since the trend is in miniaturizing them. Such devices may need to be kept under certain environmental condition such as a particular temperature in order for them to optimally operate. We envision heat pumps (or refrigerators) of similar sizes that provide such favorable condition. On the other hand, heat engines of similar sizes may provide energy to these devices in order for them to perform different tasks. This paper deals with a model of such tiny heat engine or, conversely, heat pump and explores the details.

The idea of microscopic (or Brownian) heat engine working due to non-uniform temperature first came up with the works of Buttiker [1], van Kampen [2], and Landauer [3] while they were involved in exposing the significance of the now influential papers of Landauer on blow torch effect [4, 5]. Later works took models of Brownian heat engine and dealt with the energetics only at the quasi-static limit [6, 7]. Energetics considerations for such engine operating in a finite time were first addressed by Derenyi et al. [8] and recently by us [9, 10]. These two works of us also revealed that the quasi-static limits of either the heat engine or the heat pump behave exactly like that of a Carnot's heat engine or heat pump.

In our first paper [9], we considered a Brownian particle moving through a highly viscous medium in a periodic sawtooth potential (with or without load) assisted by the thermal kick it gets from alternately placed hot and cold heat reservoirs along its path. The heat reservoirs were placed in such a way that the whole left side of each saw-

tooth from its barrier top is coupled to the hot reservoir while the whole right side is coupled to the cold reservoir.

In the present work, instead of coupling the whole left side of each sawtooth to the hot reservoir we let it be hot within a narrower but varying width located at a position that can also vary as a parameter. This will introduce two additional parameters to the model and, thereby, address a more general problem. By evaluating the way energy exchange takes place between the particle and the medium, we explore the conditions under which the model works either as a heat engine or as a heat pump. One new result is the existence of a third region in the parameter space where the model works neither as a heat engine nor as a heat pump with rich phase diagrams.

The paper is organized as follows: In section II we will consider our model in the absence of external load. In this case we will show that the model works only as a heat engine and, at quasistatic limit, the efficiency goes to that of Carnot efficiency. In section III we will consider our model in the presence of external load and explore how current, efficiency and coefficient of performance of the model vary with change in model parameters of interest. We will identify the different operating regions (as a heat engine, as a refrigerator or neither of the two) of the model in phase diagrams. Section IV deals with summary and conclusion.

II. THE MODEL WITH NO EXTERNAL LOAD

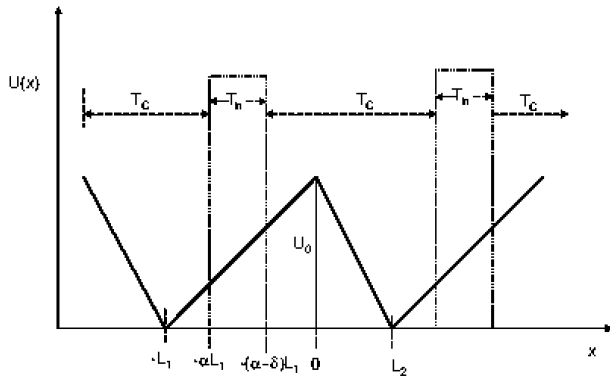


FIG. 1: The plot of periodic sawtooth potential without load. The parameter α describes the left side of hot locality from the nearest barrier top while δ describes the width of hot locality both in the units of L_1 . When $\alpha = 1$ and $\delta = 0$ the sawtooth potential are coupled to the cold reservoir while when $\alpha = 1$ and $\delta = 1$ the left part of the sawtooth potential are coupled with the hot reservoir.

The model consists of a Brownian particle which moves in a viscous medium in a periodic sawtooth potential where the background temperature is also periodic but piecewise constant as shown in Fig. 1. Here $U(x)$ denotes the potential of the sawtooth with a barrier height of U_0 . One of the maxima of the potential is located at $x=0$ and the two minima on the left and right sides of this maximum potential are located at $x = -L_1$ and $x = L_2$, respectively. Two dimensionless parameters, α and β ,

specify the position and width of each hot locality such that α describes the position of the left side of the hot locality from the nearest barrier top while δ describes the width of the hot locality, both in units of L_1 . Here one should note that α and δ are limited to take values between zero and one: $0 < \alpha < 1$ and $0 < \delta < 1$. On the other hand, in our previous work [9] both α and δ are taken to have a fixed value of one. The quantities T_h and T_c in the figure denote the temperature values of the hot and cold localities, respectively. A third parameter, β , relates the temperature of the hot locality with the cold locality such that $T_h = T_c(1 + \beta)$. The potential, $U(x)$, for our model is a series of identical sawtooth potentials. One sawtooth potential around $x=0$ is described by

$$U(x) = \begin{cases} U_0 \left[\frac{x}{L_1} + 1 \right]; & \text{if } -L_1 < x < 0; \\ U_0 \left[\frac{x}{L_2} + 1 \right]; & \text{if } 0 < x < L_2; \end{cases} \quad (1)$$

and this potential profile repeats itself such that $U(x + L) = U(x)$ where $L = L_1 + L_2$. Note that $U(x)$ is determined by three parameters: U_0 , L_1 and L_2 . On the other hand, the temperature profile is given by

$$T(x) = T_c + T_c \left(\theta(x - L_1) - \theta(x - (\alpha + \delta)L_1) \right); \quad (2)$$

for $-L_1 < x < L_2$ and θ is the Heaviside function. This temperature profile repeats itself with the same period as that of the potential: $T(x + L) = T(x)$.

The presence of hot and cold regions coupled to the different parts of the sawtooth potential determines the Brownian particle to be driven unidirectionally and attain a steady state current, J . A general expression for the steady state current of the Brownian particle in any periodic potential (with or without load) is derived in Appendix A. Using the particular potential and temperature profiles of Eqs. (1) and (2), we have evaluated the expressions for F , G_1 , G_2 and H in Appendix A, Eqs.

(A 10, A 11, A 12, and A 13), and found an exact closed form expression for the steady state current J

$$J = \frac{F}{G_1 G_2 + H F}; \quad (3)$$

The expressions for F , G_1 , G_2 ; and H are given in Appendix B. The drift velocity, v , is then given by

$$v = J(L_1 + L_2); \quad (4)$$

As an approximation, we neglect the energy transfer via kinetic energy due to the particle recrossing of the boundary between the regions [7, 8] and find the energetics of the particle as it exchanges energy with the heat reservoirs. In one cycle the Brownian particle is in contact with the hot region of width L_1 while the particle is in contact with the cold region of width $L_2 + L_1(1 - \delta)$. When the particle moves through the hot region, it takes an energy Q_h which enables it not only to climb up the potential of magnitude U_0 but also acquire energy $v L_1$ to overcome the viscous drag force within the hot interval. Hence during one cycle, the amount of heat flow out of the hot reservoir, Q_h , is given by

$$Q_h = U_0 + v L_1; \quad (5)$$

The net heat flow per cycle from the Brownian particle to the cold reservoir, Q_c , is by a similar argument given by

$$Q_c = U_0 - v(L_2 + L_1(1 - \delta)); \quad (6)$$

The difference between Q_h and Q_c is the useful work:

$$W = v(L_1 + L_2); \quad (7)$$

This is exactly the amount of work required to transport the Brownian particle moving with a drift velocity v through one cycle in the viscous medium. It is important to emphasize at this point that in the absence of external load the model works only as heat engine. Following the definition of generalized efficiency introduced in [8], the efficiency of the engine, η , is given by

$$\eta = \frac{Q_h - Q_c}{Q_h} = \frac{v(L_1 + L_2)}{(U_0 + v L_1)}; \quad (8)$$

One can notice that the magnitude of the current approaches to zero when U_0 goes to zero. This corresponds to the quasistatic limit of the engine; i.e. $J \rightarrow 0$. Evaluating the efficiency at quasistatic limit, we found that

$$\lim_{U_0 \rightarrow 0} \eta = \frac{(T_h - T_c)}{T_h}; \quad (9)$$

which is exactly equal to the efficiency of a Carnot engine.

In order for us to explore how current and efficiency vary with change in one of the newly introduced parameters α and δ , we first introduce three scaled parameters: scaled length $\alpha' = L_2/L_1$, scaled barrier height

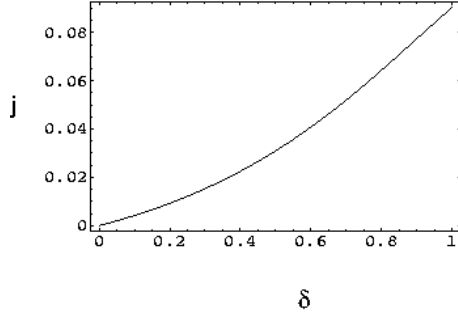


FIG. 2: Plot of j versus δ for $x_{ed} = 1$, $u = 4$ and $\alpha = 1$.

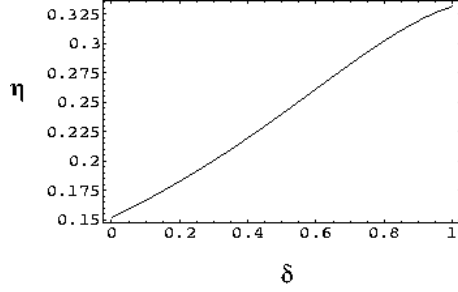


FIG. 3: Plot of η versus δ for $x_{ed} = 1$, $u = 4$ and $\alpha = 1$.

$u = U_0 = k_B T_c$ and scaled current $j = J/J_0$ where $J_0 = k_B T_c = L_1^2$; k_B being Boltzmann's constant.

For x_{ed} values of $\alpha = 1$, $u = 4$ and $\alpha = 1$, the current j is plotted as a function of δ as shown in Fig. 2. When $\alpha = 0$, the whole saw tooth potential is coupled with cold reservoir. Hence there is no net current as can be seen in the figure. Increasing the width of the hot locality leads to an increase in the current. We also plot the engine efficiency, η , as a function of δ as shown in Fig. 3. The figure shows that η increases with increase in δ .

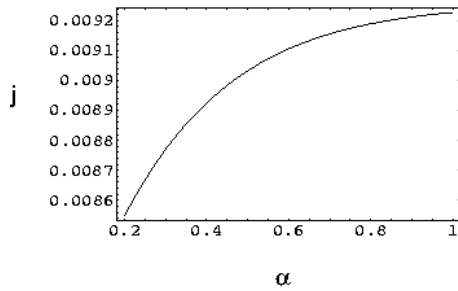


FIG. 4: Plot of j versus α for $x_{ed} = 1$, $u = 4$ and $\delta = 0.2$.

One can fix the width of the hot locality, δ , and investigate the influence of shifting the position of the hot locality along one side of the saw tooth potential. Figure 4 is a plot of j versus α for a given values of $\delta = 0.2$, $u = 4$ and $\alpha = 1$. The figure shows that the current j increases as α increases which implies that positioning

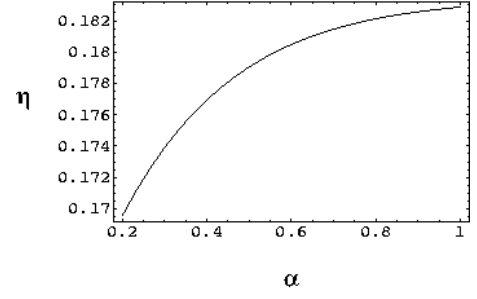


FIG. 5: Plot of η versus α for $x_{ed} = 1$, $u = 4$ and $\delta = 0.2$.

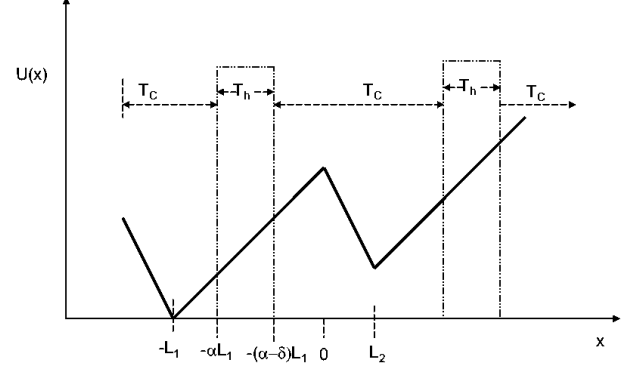


FIG. 6: Plot of periodic sawtooth potential with load where periodic hot and cold locality alternate along the potential.

the hot locality near the potential minimum produces the highest possible value of current than putting it anywhere else. Likewise, plot of η versus α in Fig. 5 shows similar feature as in Fig. 4 in the sense that one gets highest possible efficiency if the hot locality is put near the potential minimum than anywhere else.

In the next section we will consider our model to also have external load.

III. THE MODEL WITH CONSTANT EXTERNAL LOAD

Consider the model in the presence of a constant external load f as shown in Fig. 6. The potential profile will then change from $U(x)$ described by Eq. (1) to $U(x) + fx$. Similar to the previous section, the closed form expression for steady state current J^L in the presence of external load is derived and given by

$$J^L = \frac{F^L}{G_1^L G_2^L + H^L F^L} : \quad (10)$$

The expressions for F^L , G_1^L , G_2^L ; and H^L are given in Appendix C. The drift velocity, v^L , is then given by

$$v^L = J^L (L_1 + L_2) : \quad (11)$$

Before we begin exploring various properties of the model, we introduce a scaled quantity associated with

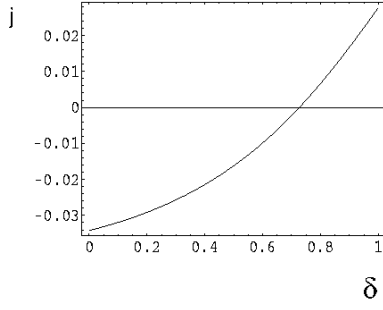


FIG. 7: Plots of j versus δ for $x_{ed} = 1$, $\nu = 3$, $\mu = 4$, $\beta = 0.4$ and $\gamma = 1$.

the load: $f = fL_1/T_c$. We will then have a total of six parameters that can be controlled independently: u , L_1 , L_2 , ν , μ , and β . Fig. 7 is a plot of (scaled) current j versus δ for fixed values of all the other parameters. The figure shows that the current monotonously increases with δ being negative for small values of δ (hot locality width) and then becoming positive beyond a certain value of δ . This implies that in the interval where the current is negative external work is being done on the engine while in the interval where the current is positive the engine does work not only against the viscous medium but also against the load. In order to find whether the engine works either as a heat engine, or as a refrigerator or otherwise, we need to find energy exchange between the particle and the heat reservoirs. When the model behaves as a heat engine, the current takes positive value (see Fig. 7) and in one cycle the particle takes heat energy Q_h^L from the hot reservoir of amount

$$Q_h^L = (U_0 + fL_1 + \nu^L L_1); \quad (12)$$

and gives out an amount of heat

$$Q_c^L = U_0 - [(L_1(1 - \beta) + L_2)](f + \nu^L); \quad (13)$$

to the cold reservoir. The net work, W , done by the heat engine in one cycle is given by the difference between Q_h^L and Q_c^L :

$$W = (\nu^L + f)(L_1 + L_2); \quad (14)$$

The generalized efficiency of the heat engine will then be given by

$$\eta = \frac{W}{Q_h^L} = \frac{(\nu^L + f)(L_1 + L_2)}{(U_0 + fL_1 + \nu^L L_1)}; \quad (15)$$

On the other hand, when the model works as a refrigerator heat flows out of the cold reservoir and enters the hot reservoir driven by the external work of amount $W^L = f(L_1 + L_2)$ done on the refrigerator per cycle. In the region where the model works as a refrigerator, the coefficient of performance (COP) of the refrigerator, P_{ref} , is given by

$$P_{ref} = \frac{Q_c^L}{W^L} = \frac{U_0 - [(L_1(1 - \beta) + L_2)](f + \nu^L)}{f(L_1 + L_2)}; \quad (16)$$

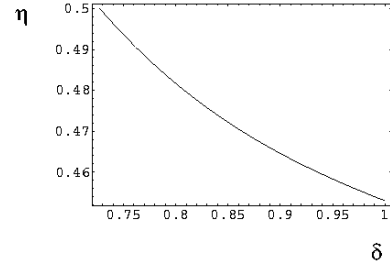


FIG. 8: Plots of η versus δ for $x_{ed} = 1$, $\nu = 3$, $\mu = 4$, $\beta = 0.4$ and $\gamma = 1$.

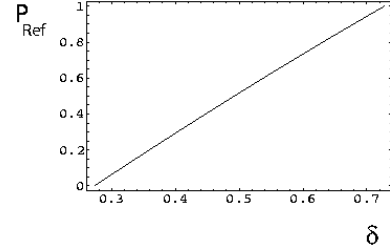


FIG. 9: Plots of P_{ref} versus δ for $x_{ed} = 1$, $\nu = 3$, $\mu = 4$, $\beta = 0.4$ and $\gamma = 1$.

The quasi-static limit of the engine corresponds to the case where the current approaches to zero either from the heat engine side or from the refrigerator side. We have found that this limit is satisfied when

$$f = \frac{U_0}{((1 + \beta)(1 + \gamma))L_1}; \quad (17)$$

This is the boundary demarcating the domain of the operation of the engine as a refrigerator from that as a heat engine. Evaluating the expression for both η and P_{ref} as we approach this boundary, we analytically found that they are exactly equal to that of Carnot efficiency and Carnot COP, respectively:

$$\lim_{J \rightarrow 0} \eta = \frac{(T_h - T_c)}{T_h}; \quad (18)$$

and

$$\lim_{J \rightarrow 0} P_{ref} = \frac{T_c}{(T_h - T_c)}; \quad (19)$$

We now explore how the η and P_{ref} behave as a function of δ fixing all other parameters. Within the region where the model works as a heat engine, we find the efficiency to monotonously decrease from its maximum value (Carnot efficiency) as the width, δ , of the hot locality increases (see Fig. 8). On the other hand, within the region where the model works as a refrigerator the COP linearly increases with increase in δ until it attains its maximum possible value (Carnot refrigerator) as shown in Fig. 9.

Before we plot the phase diagrams showing regions where the model works as a heat engine, as a refrigerator and as neither of the two we think that it is illustrative to know how Q_h and Q_c behave with scaled load, f .

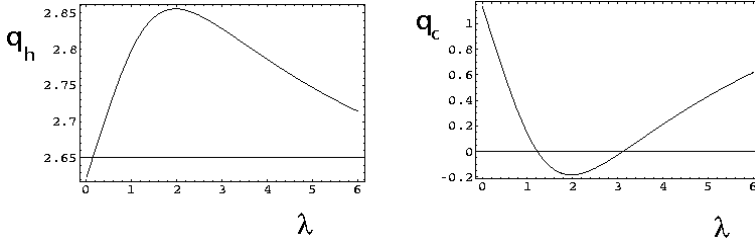


FIG. 10: (a) Plot q_h versus λ for $x_{ed} = 4$, $' = 3$, $u = 4$, $= 1$ and $= 0.6$. (b) Plot q_c versus λ for $x_{ed} = 4$, $' = 3$, $u = 4$, $= 1$ and $= 0.6$.

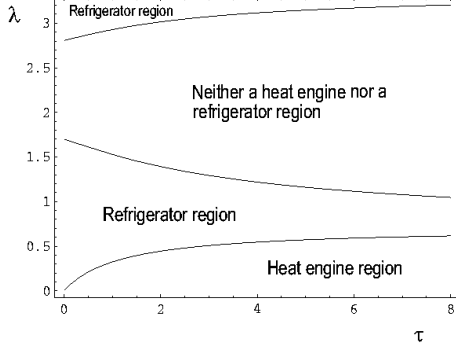


FIG. 11: The phase diagram in the parameter space for $x_{ed} = .6$, $' = 3$, $u = 4$ and $= 1$.

We introduce two scaled quantities $q_h = Q_h/k_B T_c$ and $q_c = Q_c/k_B T_c$ corresponding to Q_h and Q_c , respectively. Figs. 10a and 10b show plots of q_h versus λ and q_c versus λ , respectively, after fixing the other parameters. Note that Fig. 10a shows that q_h is always positive while Figure 10b shows that q_c takes a negative value within some interval values of λ . The quantity $q_h - q_c$ is always positive. In the region that q_c is negative, the model works neither as a heat engine nor as a refrigerator since under this situation external work is supplying energy to both the hot and cold reservoirs. We have found that when

$$0 < \lambda < \frac{u}{(1 + \lambda)(1 + \lambda)} \quad (20)$$

the model works as a heat engine while the model works as a refrigerator when

$$\frac{u}{(1 + \lambda)(1 + \lambda)} < \lambda < \frac{u}{(1 + \lambda) + 1} \quad j(1 + \lambda) : \quad (21)$$

The model works neither as a heat engine nor as a refrigerator if

$$\lambda > \frac{u}{(1 + \lambda) + 1} \quad j(1 + \lambda) : \quad (22)$$

We plot the three operation regions of the model in Fig. 11. The figure demonstrates that in the parameter space of λ and τ , the model works as a heat engine, as a refrigerator or as neither of the two for $x_{ed} = .6$, $' = 3$,

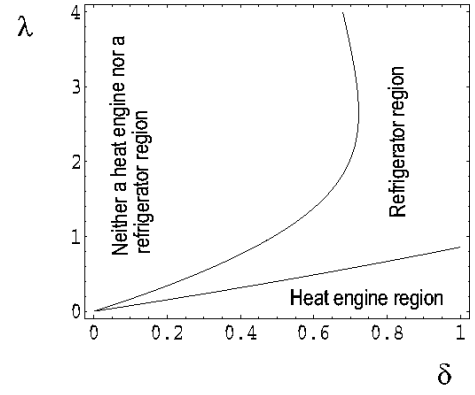


FIG. 12: The phase diagram in the parameter space for $x_{ed} = 1$, $' = 3$, $u = 4$ and $= 1$.

$u = 4$ and $= 1$. One can see in the phase diagram that for $\lambda = 4$, the model works neither as a heat engine nor as a refrigerator when $1.21875 < \delta < 3.156$. In fact in this region, q_c is negative as can be seen in Fig. 10b. Figure 12 shows the three regions in parameter space in which the model operates as a heat engine, as a refrigerator and as neither of the two for $x_{ed} = 1$, $' = 3$, $u = 4$.

IV. SUMMARY AND CONCLUSION

We considered a simple model of a Brownian heat engine and explored how current, efficiency and performance of a refrigerator behave as model parameters of interest vary. In the absence of external load, the model works as a heat engine while in the presence of external load the model works as a heat engine, as a refrigerator or neither of the two depending on the values in the parameter space. At a quasistatic limit the efficiency as well as the COP of the engine goes to that of Carnot efficiency and Carnot COP. In this paper we reported an extended version of the work [9]. The result we obtained shows that unlike the previous work, there are regions that the model may work neither as a heat engine nor as a refrigerator determined by the width of hot locality.

In this work, we found a closed expression for the steady state current. This enabled us to explore the energetics of the Brownian heat engine not only at the quasistatic limits but also while operating at any finite time. This is a clear exposition of the power of having analytic expression for the concerned physical quantities.

APPENDIX A: DERIVATION OF THE STEADY STATE CURRENT

Consider motion of a Brownian particle in any periodic potential, $U(x)$, and temperature, $T(x)$, profiles where both have the same periodic length of $L_1 + L_2 = L$ as

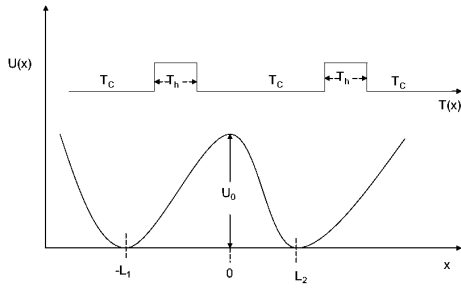


FIG. 13: Periodic potential with non-homogeneous temperature profile.

shown in Fig. 13. In the high friction limit, the dynamics of the Brownian particle is governed by the Smoluchowski equation [11]:

$$\frac{\partial P(x;t)}{\partial t} = \frac{\partial}{\partial x} \left(-U^0(x)P(x;t) + \frac{\partial}{\partial x} (T(x)P(x;t)) \right) \quad (\text{A } 1)$$

where $P(x,t)$ is the probability density of finding the particle at position x at time t , $U^0(x) = \frac{d}{dx}U$ and γ is the coefficient of friction of the particle. Boltzmann's constant, k_B , and the mass of the particle are taken to be unity. The steady state solution, $P^s(x)$, of the Smoluchowski equation implies a constant current, J , given by

$$-\frac{1}{\gamma} [U^0(x)P^s(x) + \frac{d}{dx} (T(x)P^s(x))] = J: \quad (\text{A } 2)$$

Periodic boundary condition implies

$$P^s(x+L) = P^s(x): \quad (\text{A } 3)$$

Equation A 3 is valid for any periodic potential even in the presence of additional constant external load. The stationary probability distribution can be then given by

$$P^s(x) = \frac{B}{T(x)} \exp(-\phi(x)) \quad (\text{A } 4)$$

where B is the normalization constant and $\phi(x) = \int_{L_1}^x \frac{U^0(x')dx'}{T(x')}$ with $L_1 < x < L_2$. After multiplying

both sides of Eq. (A 4) by $\exp(\phi(x))$, we can write it as

$$\frac{d}{dx} [e^{\phi(x)} T(x) P^s(x)] = -J e^{\phi(x)}: \quad (\text{A } 5)$$

Integrating Eq. (A 5) from L_1 to x and, after some algebra, one gets

$$P^s(x) = \frac{e^{-\phi(x)}}{T(x)} \frac{1}{T(L_1)P^s(L_1)} \int_{L_1}^x e^{\phi(x')} dx': \quad (\text{A } 6)$$

Taking $x=L_2$ in Eq. (A 6), we get

$$e^{-\phi(L_2)} \frac{1}{T(L_2)P^s(L_2)} = \int_{L_1}^{L_2} \frac{e^{\phi(x)} dx}{T(x)}: \quad (\text{A } 7)$$

Applying normalizing condition, $\int_{L_1}^{L_2} P^s(x) dx = 1$, on Eq. (A 6) gives us the relation

$$1 = P^s(L_2)T(L_2) \int_{L_1}^{L_2} \frac{e^{-\phi(x)} dx}{T(x)} = \int_{L_1}^{L_2} \frac{e^{-\phi(x)} dx}{T(x)} \int_{L_1}^{L_2} e^{\phi(x')} dx': \quad (\text{A } 8)$$

Using Eqs. (A 7) and (A 8) it is simple to get the steady state current

$$J = \frac{F}{G_1 G_2 + H F}; \quad (\text{A } 9)$$

where

$$F = e^{-\phi(L_2)} - 1; \quad (\text{A } 10)$$

$$G_1 = \int_{L_1}^{L_2} \frac{e^{-\phi(x)}}{T(x)} dx; \quad (\text{A } 11)$$

$$G_2 = \int_{L_1}^{L_2} e^{\phi(x)} \phi'(x) dx; \quad (\text{A } 12)$$

$$H = \int_{L_1}^{L_2} \frac{e^{-\phi(x)}}{T(x)} dx \int_{L_1}^x e^{\phi(x')} \phi'(x') dx': \quad (\text{A } 13)$$

APPENDIX B

In this Appendix, we will give the expressions for F , G_1 , G_2 , and H which define the value of the steady state current, J , for load free case

$$F = e^{U_0 \left(\frac{1}{T_h} - \frac{1}{T_c} \right)} - 1 \quad (\text{B } 1)$$

$$G_1 = \frac{L_1}{U_0} \left[1 - e^{\frac{(-1)U_0}{T_c}} \right] + \frac{L_1}{U_0} e^{\frac{(-1)U_0}{T_c}} \left[1 - e^{\frac{U_0}{T_h}} \right] + \frac{L_1}{U_0} e^{\frac{(-1)U_0}{T_c}} \frac{U_0}{T_h} \left[1 - e^{\frac{(-1)U_0}{T_c}} \right] + \frac{L_2}{U_0} e^{\frac{(-1)U_0}{T_c}} \frac{U_0}{T_h} \left[e^{\frac{U_0}{T_c}} - 1 \right] \quad (\text{B } 2)$$

$$G_2 = \frac{T_c L_1}{U_0} \left[e^{\frac{(-1)U_0}{T_c}} - 1 \right] + \frac{T_c L_1}{U_0} e^{\frac{(-1)U_0}{T_c}} + \frac{U_0}{T_h} \left[e^{\frac{(-1)U_0}{T_c}} - 1 \right] + \frac{T_h L_1}{U_0} e^{\frac{(-1)U_0}{T_c}} \left[e^{\frac{U_0}{T_h}} - 1 \right] + \frac{T_c L_2}{U_0}$$

$$e^{\frac{(1-\gamma)U_0}{T_c} + \frac{U_0}{T_h} + \frac{(\gamma-1)U_0}{T_c}} [1 - e^{\frac{U_0}{T_c}}] \quad (B 3)$$

$$H = t_1 + t_2 + t_3 + t_4 + t_5 + t_6 + t_7 + t_8 + t_9 + t_{10} \quad (B 4)$$

$$t_1 = \frac{L_1}{U_0} [(1-\gamma)L_1 + \frac{T_c L_1}{U_0} [e^{\frac{U_0(\gamma-1)}{T_c}} - 1]]; \quad (B 5)$$

$$t_2 = \frac{L_1^2 T_c}{U_0^2} e^{\frac{U_0(\gamma-1)}{T_c}} [e^{\frac{(1-\gamma)U_0}{T_c}} - 1] [1 - e^{\frac{U_0}{T_h}}]; \quad (B 6)$$

$$t_3 = \frac{L_1}{U_0} [L_1 + \frac{T_h L_1}{U_0} [e^{\frac{U_0}{T_h}} - 1]]; \quad (B 7)$$

$$t_4 = \frac{L_1^2 T_c}{U_0^2} [1 - e^{\frac{U_0(1-\gamma)}{T_c}}] e^{\frac{U_0(\gamma-1)}{T_c}} \frac{U_0}{T_h} [e^{\frac{U_0(\gamma-1)}{T_c}} - 1]; \quad (B 8)$$
