Interplay of order-disorder phenom ena and di usion in rigid binary alloys:

M onte Carlo simulations of the two-dimensional ABV model

Transport phenom ena are studied for a binary (AB) alloy on a rigid square lattice with nearest-neighbor attraction between unlike particles, assuming a small concentration c_v of vacancies V being present, to which A (B) particles can jump with rates $_{\rm A}$ ($_{\rm B}$) in the case where the nearest neighbor attractive energy $_{AB}$ is negligible in comparison with the therm al energy $k_B T$ in the system . This model exhibits a continuous order-disorder transition for concentrations $c_A ; c_B = 1$ c_A c_P in the range $c_{A ; 1}^{crit}$ $c_A = c_{A ; 2}^{rrit}$, with $c_{A ; 1}^{crit} = (1 \text{ m})$ a_v)=2, $c_{A,2}^{crit}$ = (1 + m \odot)=2, m 0:25, the maximum critical temperature occurring for $c = c = c_B = (1 + c_B) = 2$, i.e. m = 0. This phase transition belongs to the d = 2Ising universality class, demonstrated by a nite size scaling analysis. From a study of m ean-square displacem ents of tagged particles, self-di usion coe cients are deduced, while applying chem ical potential gradients allow the estimation of Onsager coe cients. A nalyzing nally the decay with time of sinusoidal concentration variations that were prepared as initial condition, also the interdi usion coe cient is obtained as function of concentration and tem perature. As in the random alloy case (i.e., a noninteracting ABV - m odel) no sim ple relation between self-di usion and interdi usion is found. Unlike this model mean eld theory cannot describe interdi usion, how ever, even if the necessary O nsager coe cients are estimated via simulation.

I. IN TRODUCTION

Understanding of atom ic transport in multicom ponent solids has been a longstanding challenge [1]-[13]. In particular, the problem of interdi usion in binary metallic alloys (as well as other types of mixed crystals) is very intricate: there is a delicate interplay between kinetic aspects that have a complicated energetics (such as jump rates of the various kinds of atom s to available vacant sites) and e ects due to non-random arrangement of these atom s on the lattice sites (a problem which needs to be considered in the fram ework of statistical therm odynam ics [14, 15, 16]). Even the sim plistic limiting case of perfectly random occupation of the sites of a rigid perfect lattice by two atom ic species (A;B) and a sm all fraction of vacancies (V), where one assumes constant jump rates $_{\rm A}$; $_{\rm B}$ of the two types of atom s to the vacant sites), is highly nontrivial [17]. One

nds that neither the self-di usion coe cients D_A ; D_B nor the interdi usion coe cient D_{int} can be analytically reliably predicted, given $_A$; $_B$ and the average concentration c_A ; c_B ; nor does a simple relation between D_A ; D_B and D_{int} exist [17].

Recently, attention has been focused on this problem because of several fascinating developm ents: (i) Progress with the electronic structure calculations of vacancy form ation energies, jum p rates etc. as well as better understanding of short range order parameters in alloys puts the $\$ rst-principles" calculation of interdi usion and self-di usion coe cients in ordered solid alloys such as A l_(1 x) L i_x within reach [13]. (ii) Progress with the atom -tracking scanning tunnelling m icroscopy observation of atom ic m otions in two-dim ensional surface alloys such as In atom s in C u (001) surfaces [10] or P d atom s in C u (001) surfaces [11] has provided com pelling direct evidence for the operation of vacancy m ediated surface di usion. This is a nontrivial result, since com peting m echanism s (surface atom s leave the topm ost atom ic layer to becom e adatom s on top of this layer [18], or direct exchange between neighboring surface atom s, \assisted" by the free space above the topm ost m onolayer of atom s at the crystal surface) can not be ruled out a priori. O f course, this nding enforces the hypothesis that vacancy m echanism dom inates self- and interdi usion processes in crystal lattices in the bulk [1, 2, 3, 4, 5, 6, 7, 8, 9].

In the present work we try to contribute to this problem, emphasizing the statistical mechanics approach by considering again a rigid lattice model but allowing for interactions causing a nontrivial long range order (or, at least, short range order) between the atom s in the system. We are not addressing a specific material, but rather try to elucidate the generic phenomena caused by the interplay of local correlations in the occupancy of lattice sites and the disparities in the jump rates $_{\rm A}$ and $_{\rm B}$ of the two species. Thus, our model is close in spirit to the work in Ref. [17] and employs a related M onte C arb simulation methodology [19]. Unlike [17], the present model does include a nearest-neighbor attraction between unlike neighbors, and thus nontrivial static order-disorder phenomena occur. As expected, we shall demonstrate that the resulting correlations in the occupancy of the lattice sites have a drastic effect on the transport phenomena, and hence cannot be neglected when one tries to interpret real data. We also emphasize that these correlation phenomena need a treatment beyond mean eld level. We point out this fact, because som etimes a

rst principle electronic structure calculation is combined with statistical mechanics of mean eld type or the cluster variation method [16], and such approximations then clearly spoil the desirable rigor. We also note that similar models as studied here have been frequently used to study domain grow the in alloys that are quenched from the high temperature phase to a temperature below the order-disorder transition temperature [20]. In Section II we describe our (two-dimensional) model. We restrict the present work to twodimensional systems, since recently there has been great interest in two-dimensional alloys [21], and we hope that extensions of our modelling can make contact with corresponding experiments. In Section III we summarize our simulation methodology, while Section IV brie y reviews some pertinent theoretical concepts and approximations we wish to test. Section V describes our numerical results, while Section V I summarizes our conclusions, and gives an outlook to future work.

II. THE MODEL AND ITS STATIC PROPERTIES

Having in m ind the application of our work to two-dimensional surface alloys, we assume a perfect square lattice of adsorption sites (Fig. 1). These adsorption sites can either be taken by an A-atom, a B-atom, or a vacancy. Therefore this model traditionally is also referred to as the ABV model [17, 22]. It can also be viewed as an extension of simple lattice gas models, where di usion of a single species (A) occurs by hopping to vacant sites, to two components. Di usion in lattice gases with a single species has been extensively studied [5, 23, 24, 25, 26, 27, 28, 29, 30, 31], but di usion in a two-component lattice gas so far has been thoroughly examined only in the noninteracting case [17]. Here we restrict attention to a model with strictly pairwise interactions between nearest neighbors only, which we denote as AA; AB and BB pairs. However, in general one can consider also energy parameters between pairs of lattice sites involving one (AV, BV) or two (VV) vacancies, but here we do not consider the ABV model in full generality, but only the special case AV = BV = VV = 0, although from rst principles electronic structure calculations there is evidence that nonzero $_{AV}$; $_{BV}$; $_{VV}$ may occur [32]. While all these parameters a ect the di usion behavior of the model, actually only a subset of them controls the static behavior. W ith respect to static properties of thism odel, the well-known transcription to the spin 1 B lum e-Emery-Gri them odel shows (see e.g. [20]), that for constant concentrations only three interaction parameters would be needed. Note that although there are three concentration variables, $c_A ; c_B ;$ and c_v , due to the constraint $c_A + c_B + c_V = 1$ only two of them are independent. A ctually, the physically most interesting case is the lim if $c_V \ ! \ 0$, since in therm all equilibrium the concentration of vacancies is very sm all. In the noninteracting case [17], it was found that m any aspects of this limiting behavior $c_V = 0$ are already reproduced if the vacancy concentration is of the order of a few percent only, e.g. $c_V = 0.04$, and in fact we shall adopt this choice in the case of the present simulations. Also for the interacting case the limit $c_V \, ! \, 0$ greatly simpli es matters, since then, with respect to static properties, we have to consider only a single energy parameter, de ned by

If < 0, the model in therm alequilibrium will exhibit ordering, while for > 0, phase separation occurs [14, 15, 33]. In the case of a square lattice, the model in the limit c_V ! 0 is equivalent to the two-dimensional Ising model, for which some static properties of interest are exactly known [34, 35, 36]. In particular, for $c_A = c_B = 1=2$ the critical temperature T_c is known exactly, namely

This is the maximum value of the critical temperature curve $T_c(q_A)$ at which the order-disorder phase transition occurs. A coording to the well-known B ragg-W illiam s mean-eld approximation, one would rather obtain $k_B T_c^{M-F} = = 2$ than the result in plied by Eq. (2), $k_B T_c = 1.1345$ [37]. Here and in the following, the maximum value $T_c(q_A = 0.5)$ of the pure model without vacancies is simply denoted as T_c . However, an even more important failure of the mean-eld theory is the prediction that an order-disorder transition from the disordered phase to a phase with long-range checkerboard order occurs over the entire concentration range, with $T_c(q_A ! 0) !$ $0; T_c(q_A ! 1) ! 0, see [37]$ for a more detailed discussion of mean-eld theory. As a matter of fact, long range order is only possible for a much more restricted range of concentrations, nam ely $[37] 0.375 = q_A = 0.625$ (note that the pairwise character of the interactions in plies a symmetry of the phase diagram around the line $q_A = 1=2$, in the lim it $q_V ! = 0$ [14, 15, 33]).

If we work with a small but nonzero concentration of vacancies c_V , the maximum critical tem perature no longer occurs at $c_A = c_B = 1=2$, but rather at $c = c_A = c_B = (1 \ c_V)=2$, and the phase diagram is in this case symmetric around this concentration c. A part from this statement, there are no longer any exact results available, but it is fairly straightforward to obtain the phase diagram from standard M onte C arlo methods [19] with an accuracy that is suiteent for our purposes. Fig.2 shows our estimates of the phase boundary for $c_V = 0.04$, in comparison with previous results for $c_V = 0$. A shas been well documented in the literature [19, 33, 37], such phase diagram s are conveniently mapped out by transforming the model to a magnetic Ising spin model (representing the cases that lattice site i is taken by an A atom by spin up, B atom by spin down, respectively) and considering the transition from the param agnetic to the antiferrom agnetic phase for various magnetic elds H (2 H = A B, if AA = BB, and with A and B being the chemical potentials of A and B particles, respectively). Estimating then the magnetization $m_c(H) = m(H; T = T_c(H))$ at the phase boundary, one then obtains the corresponding critical

concentrations from

Fig. 2 shows that for $a_V = 0.04$ the maximum critical tem perature occurs for $T_c (a_V = 0.04) = T_c$ 0:905, and for T ! 0 the phase boundary ends at the concentrations $c_{A;1}^{crit}$ 0:375; $c_{A;2}^{crit}$ 0:585. As it should be, the phase diagram is symmetric around $c_{A max}^{crit} = (1 \ c_{P}) = 2 = 0.48$. The analysis indicates that the order-disorder transition stays second order throughout, also in the presence of this small vacancy concentration. A lthough it is clear that a vacancy concentration of $c_V = 0.04$ does have some clearly visible e ects, in comparison to the model with & ! 0, these changes do not a ect the qualitative character of the phase behavior, but cause only m inor m odi cations of quantitative details. For obtaining accurate results on the dynam ic behavior of the model with a modest amount of computing time, working with su ciently many vacancies on the lattice is m and atory. Note that for the di usion studies we use a lattice of linear dimensions L = 1024, while the static phase diagram was extracted from a standard nite size scaling analysis [19], see Figs. 3, 4 for an example, using sizes 24 \mathbf{L} 192. Periodic boundary conditions are applied throughout. The static quantities that were analyzed in order to obtain the phase boundary are the antiferrom agnetic order param eter (we refer here to the transform ation of the m odel to the Ising spin representation again)

where k; `label the lattice sites in x and y direction, respectively. Similarly, the magnetization m is given by averaging all the spins without a phase factor

and the susceptibility and staggered susceptibility ~ are obtained from the standard uctuation relations

Note that in a nite system in the absence of sym etry-breaking elds one needs to work with the average of the absolute value hj ji rather than h i in order to have a meaningful order parameter [19].

A further quantity useful for nding the location of the transition is the fourth order cum ulant of the order parameter [38]

since the critical temperature can be found from the intersection of the cumulants plotted versus temperature for di erent lattice sizes. For the two-dimensional Ising universality class, this intersection should occur for a value U 0:6107 [39].

Fig. 3 shows that this expectation is only rather roughly full led. To some extent this may be attributed to statistical errors, but in addition probably for $q_V \in 0$ there are somewhat larger corrections to nite size scaling than for the \pure" model (i.e., the model without vacancies). We have hence estimated $T_c (q_V = 0.04)$ alternatively from a plot of the temperatures $T_c (L)$, where the maximum of ~(T;L) for nite L occurs, versus the nite size scaling variable $L^{1=} = L^{-1}$ (remember = 1 in the two-dimensional Ising model [36]), see Fig. 4a. The quality of the nite size scaling \data collapse" of the order parameter (g. 4b) gives us condence in the reliability of our procedures.

We emphasize that the present paper concerns only the choice of the symmetric case, $_{AA} = _{BB}$. While any asymmetry between A and B, leading to $_{AA} \in _{BB}$, has little elect on static properties for small c_v , the distribution of the vacancies and their dynamics may get strongly a lected by such an asymmetry [20, 22].

F inally, we mention a static quantity that plays a role in discussing the self-di usion ∞e cient of particles in lattice gas models, the so-called \vacancy availability factor" [5, 24, 30]

Here $_1$ is the standard C ow key-W arren short range order parameter [14, 15, 16, 33] for the nearest neighbor shell of a particle: $_1 = 0$ if there is a random occupation of the lattice sites by any particles and vacancies (note that here we are not concerned with short range order describing the non-random occupation of A versus B particles on the lattice. Due to the symmetry $_{AA} = _{BB}$, there is also no need to consider separate vacancy availability factors for A and B particles). A ctually, we expect that in the limit $c_V ! 0$ also $_1 ! 0$, and then $V = c_V$. Hence a calculation of $_1$ can serve as a test whether the chosen vacancy concentration is small enough in order to reproduce the desired limit $c_V ! 0$.

III. SIM ULATION METHODOLOGY TO STUDY TRANSPORT PHENOMENA

The M onte C arb simulations consist of an initial part, necessary to equilibrate the system for the desired conditions, and a nalpart, where the transport coe cients of interest are m easured" in the simulation. W hile in the case of the completely random ABV alloy studied in [17] the generation of an initial con guration is straightforward, this is not so here, because depending on where the chosen state point ($T;c_A$) is in the phase diagram, F ig.2, we have long range order or not. If the system in equilibrium is in a state where long range order occurs, it is important to prepare the system in a monodom ain sample: otherwise the presence of antiphase dom ain boundaries [33] m ight spoil the results. In particular, at very low temperature interdi usion could be strongly enhanced near such boundaries, in comparison with the bulk. A lthough such e ects are interesting in their own right, they need separate study from bulk behavior, and are out of consideration here.

A ctually the best way to prepare the equilibrated initial congutations, in cases where long range order is present, is the use of the \m agnetic" representation of the m odel as an Ising antiferrom agnet in a eld H (remember that H physically corresponds to the chemical potential di erence between A and B particles [33]). Recording the m agnetization m (T;H) as function of the eld, one can choose the eld such that states with the desired value of m and hence $g = (1 \quad q \quad m)=2$ result. The initial spin congutation is that of a perfect antiferrom agnetic structure, from which a fraction q of sites chosen at random is removed. The M onte C and algorithm that was used is the standard single spin ip M etropolis algorithm [19], m ixed with random exchanges of the vacancies with random ly chosen neighbors. Note that during this equilibration part the concentration c_A is not strictly constant, but slightly uctuating: this lack of conservation of q is desirable, how ever, since \hydrodynamic slowing down" [19] of long wavelength concentration uctuations would otherwise ham per the equilibration of concentration correlations at long distances.

In the nal stage of the M onte C arb runs, of course, the spin ip M onte C arb m oves are shut o, since for the analysis of the di usion constants the concentrations $_{A}$; $c_{B} = 1$ c_{F} c_{R} need to be strictly conserved. M ost straightforward is the estimation of the self-di usion coe cients (also called \ tracer di usion coe cients") D_{t} of tagged A and B particles, since there one simply can apply the E instein relation

d being the dimensionality of the lattice (d = 2 here), and r_i (t) being the position of the ith particle at time t. Fig. 5 illustrates the application of this method for a typical example, in the case $_{A} = _{B} = 0.01$, temperature T = 1.2 (in units of T_{c} , Eq. 2), and concentrations $c_{A} = 0.40$; $c_{B} = 0.56$, respectively. W hile the plot of $hr^{2}i$ vs. t, for a total time of $t = 10^{4}$ MCS, look at rst sight almost linear (Fig. 5, left part), a closer look reveals a slight but system attic decrease of the slope of the $hr^{2}i$ vs. t curve with increasing time. A similar observation was already reported by Kehr et al. [17], who attributed this decrease of slope to the presence of a logarithm is correction.

Speci cally, it was shown that in d = 2 the estimate $D_{est}(t)$ of the tracer distinct usion constants depend on the time interval to festimation as

where A; B; C are phenom enological constants. Therefore we have analyzed $D_{est}(t)$ as a function of t in the present case (Fig. 5, right part). We found rather generally that there is a signi cant dependence of $D_{est}(t)$ on t for t $2:10^3$, while for t $5:10^3$ the dependence on t can safely be neglected. A remarkable feature of the results also is that the faster B particles exhibit (in the example shown in Fig. 5) a di usion constant that is only about a factor of three larger than the slower A particles, while the jump rate is a factor of 100 larger. This fact already indicates that there is no straightforward relation between the tracer di usion constants and the jump rates.

In the description of collective di usion, the Onsager coe cients $_{AA}$, $_{AB}$, $_{BA}$ and $_{BB}$ play a central role, since they appear as coe cients in the linear relations between particle currents \tilde{J}_{A} ; \tilde{J}_{B} and the corresponding driving forces, the gradients of the potential di erences between A (or B) particles and vacancies V, respectively [17]:

Note that due to the sym metry relation

only three of these four Onsager coe cients are thought to be independent. There is no simple relation between the two jump rates $_{A}$; $_{B}$ (and temperature T and the concentrations c_{A} ; c_{B}) and these three Onsager coe cients $_{AA}$; $_{AB}$; $_{BB}$, of course. Hence it is a task of the simulation to estim ate these Onsager coe cients, and it is well known [17, 23] that this can be done by applying a force to the particles, which acts in the same way as a chem ical potential gradient. Due to the

periodic boundary conditions, particles that have the box at one side will reenter at the opposite one, and hence a chemical potential gradient causes a steady state ux of particles through the simulation box in the direction of this driving force. Care is needed in two respects:

One must average long enough to make sure that slow transients after the imposition of the force have died out and steady-state conditions are actually reached.

One must make sure that the applied force is smallenough so one works in the region where the response of the system to this force is strictly linear, as written in Eqs. (12), (13), and nonlinear corrections can be completely neglected.

This method of estimating Onsager coe cients was pioneered by Murch and Thom [23] for one-component lattice gases and extended to random alloy models in [17, 40]. We refer the reader to these papers for a more detailed justication and discussion of this method. Following [17] we implement this force on species of particles (= A or B) by taking the jump rates in the x direction as

while the jump rate in the y directions remains . If we would have a single particle (sp.) only, the mean velocity in the + x direction would be $v_x^{sp:} = (b \ b^1)$, which should correspond to $v_x^{sp:} = (=k_B T)F_x$, F_x being the force in x direction, in the regime of linear response. Hence one concludes that from the velocity of species one can deduce the Onsager coe cient if a force F_x is exerted on species via

The application of this method is illustrated in Fig. 6. There the mean displacement hxi of A and B particles is followed over 2.5 10° M onte C arb steps (M C S) per site, and a very good linearity of hxi vs. t is observed (left part). In order to check for nonlinear e ects, the bias parameter b is varied in the range 1:05 b 1:5, and the results are extrapolated to b! 1. (right part of Fig. 6). C onsistent with previous work on the random ABV model [17], nonlinear e ects are rather weak, and in this way we are able to estimate O nsager coe cients with a relative error of a few percent.

Stilla di erent approach was followed to estimate the interdi usion constant D_{nt} . We prepare a system in thermal equilibrium in the presence of a wavevector-dependent chemical potential di erence (x) de ned as

^ being an amplitude that needs to be chosen such that the resulting concentration variation is still in the regime where linear response holds, and is the wavelength of the modulation (which is chosen such that the linear dimension L of the lattice is an integer multiple of). Note that in (x) simply translates in a wavelength-dependent magnetic eld, of the Ising spin representation course. The system then is equilibrated in the presence of this perturbation for a large number of M onte C arlo steps (of the order of 10⁶ M C S). This causes a corresponding periodic concentration variation, see Fig. 7, left part. The sinusoidal shape of this initial concentration variation provides a con mation that the linear response description is applicable otherwise the presence of higher harm onics in the concentration variation would indicate the presence of nonlinear e ects. Then a \clock " is set to time t = 0 and the perturbation (x) is put to zero for times t > 0. As a consequence, the concentration variation decays to zero as the time t ! 1. It turns out that this decay with time can be described by a superposition of two simple exponential decays, one governing the decay of the concentration di erence c(x) = c(x) - c(x) of the particles, the other corresponding to the decay of the total density. As discussed in detail for the random ABV model [17], the concentration variation can be described therefore as $(k = 2 = , and D_+ > D)$ are two di usion constants)

where c_A^+ ; c_A^- ; c_B^+ ; c_B^- are an plitude prefactors, which one can estim ate from the treatment that will be outlined in the following section. Here we only mention that $c_A^+ + c_A^- = -q_A(0)$; $c_B^+ + c_B^- = -q_B(0)$, and in the limit c_V^+ 0 we have c_A^+ ; c_B^+ / c_V^+ 0, while c_A^- ; c_B^- stay nite (of the order of $^-$). In this limit the two di usion constants D_+ ; D_- are of very di erent order of magnitude, since D_- / c_V^- , while D_+ stays of order unity [17]. Thus density variations have a very small amplitude (of order c_V^-) and decay fast, while concentration variations decay much slower. This consideration leads us to identify D_- as the interdi usion constant D_{int} in this limit. For nite nonzero q_+ , how ever, in principle both density and concentration variations are coupled, and both di usion constants D_+ ; D_- contribute to the interdi usion of A and B particles [17].

The right part of Fig. 7 illustrates that even for c_V as large as $c_V = 0.04$ there is already a reasonable separation between density and concentration uctuations: both c_V (t) and c_B (t) reach their asymptotic decay (where only the same factor exp (D k²t) m atters, as is evident from the fact that there are two parallel straight lines on the sem ilog plot) already at a time t 2000, long before the concentration variations have decayed to zero.

IV. THEORETICAL PREDICTIONS

A basic ingredient of all analytical theories are the conservation laws for the numbers of A and B particles, which lead to continuity equations for the local concentrations c_A (r;t); c_B (r;t)

Note that these equations hold rigorously, if a local concentration eld c (r;t) f = A;B g can be de ned, unlike the so-called constitutive relations, Eqs. (12),(13), which are only approximately true: these equations only are supposed to hold in the case that the gradients r ($_{A}$ $_{V}$);r ($_{B}$

 $_{\rm V}$) are su ciently small, otherwise the relation between currents and gradients is non linear. In addition, a second requirement is that statistical uctuations can be neglected; otherwise a random force term needs to be added on the right hand side of Eqs. (12),(13) [41]. We also note that in our model (unlike real alloys, where vacancies can be created by hopping of atoms from lattice sites to interstitial sites, and where vacancies can be destroyed by hopping of interstitial atoms to a neighboring vacant site of the lattice [1, 2, 3]) also vacancies are conserved, and hence

However, as discussed in [17] there is no need to include $c_V(r;t)$ and $j_V(r;t)$ as additional dynam ical variables in the problem : the condition that every lattice site is either occupied by an A-atom, B-atom or vacant (V) translates into the constraint $c_A(r;t) + c_B(r;t) + c_V(r;t) = 1$. Sim ilarly, one nds that $j_V = (j_A + j_B)$ [17].

In order to be able to relate the chemical potentials in Eqs. (12),(13) to the concentration variables, we use the therm odynam ic relation

N being the number of particles of species , and F being the total free energy of the system . We decompose F into the internal energy U and the entropic contribution TS, with S being simply the entropy of mixing

where $N = N_A + N_B + N_V$ then is the total number of sites on the lattice, and c = N = N then is the concentration of species . While Eq. (24) is exact in the non-interacting ABV model, it still holds in the disordered phase of the interacting m odel in the fram ework of the B ragg-W illiam s m ean eld approximation. In the disordered phase, no sublattices need to be introduced, and then the concentration variables on average are the same for all lattice sites. Then U can be written as

where z is the coordination number of the lattice, and consistent with the simulated m odel (Sec.II) a nearest neighbor interaction is assumed. Note that the basic approximation of Eq. (25) is the neglect of any correlation in the occupancy of neighboring lattice sites.

W ith some algebra [17] one can reduce Eqs. (12), (13), (20)-(25) to a set of two coupled di usion equations

Note that $D_{AB} \in D_{BA}$. Introducing Fourier transforms and diagonalizing the di usion matrix the solution indeed can be cast into the form of Eqs. (18), (19). As has already been mentioned in this context, for $c_V \ ! \ 0$ the two eigenvalues D_+ ; D_- of the di usion matrix adopt very di erent orders of magnitude [17]:

Since in this limit the $/ c_v$, the coe cient D_+ reaches a nite limit for c_v ! 0, while D_-/c_v . We also recognize that D_- can be decomposed into a product of two factors: a kinetic factor" int, composed by a combination of 0 nsager coe cients, and a \therm odynamic factor",

In the last step, we used the fact that $c_B = 1$ q_A for $c_V ! 0$. We call a \susceptibility" because in the translation to the Ising spin representation simply becomes proportional to the derivative of the \m agnetization" with respect to the eld. Note that for > 0 (i.e., a m ixture with unm ixing tendency) Eq. (33) exhibits a vanishing of ¹ and hence of the interdi usion constant D at the mean eld spinodal curve, de ned by

The mean eld spinodal touches the coexistence curve of such a phase-separating mixture at its maximum in the critical temperature, i.e. $k_B T_c^{M F} = z = 2 = 2$, for a square lattice. A ctually, the symmetry of the Ising H am iltonian in zero eld implies that the maximum critical temperature of the Ising antiferrom agnet, which occurs at zero eld as well, then is also given by

C on paring this estimate to the exact result, Eq.(2), we notice that the mean eld approximation actually overestimates the maximum critical temperature of the ordering alloy by almost a factor of two, as is well known. Note that this error increases for $c_A \in 1=2$ [37]. So Eq. (32) cannot be assumed to be quantitatively reliable. Note that for ordering alloys (where < 0) the interdi usion constants gets enhanced (rather than reduced, as it happens for alloys with unmixing tendency) as an elect of the interactions. Beside that, Eq. (32) does not predict any singularity of D as one approaches the order-disorder phase boundary $T_c (c_A)$ from the disordered side.

D iscussing now the kinetic factor int, we recall the popular approximation to neglect the o -diagonal O nsager coe cient in comparison to the diagonal ones. This leads to

W ith this approximation, Eq. (32) reduces to the well-known \slow mode theory "of interdi usion, which has been much debated in the case of uid polymer mixtures [42]-[47]. A rather di erent result, the so-called \fast mode" theory [46, 47], can be obtained by several distinct argum ents. W emention only one of these argum ents here, which starts from the assumption [46] that everywhere the vacancy concentration c_V (r;t) is in therm all equilibrium, i.e.

Of course, in our model Eq. (39) cannot be justilled, in view of the constraints $\varphi(r;t) = 1$ \mathfrak{g} ($\mathfrak{r};\mathfrak{t}$), $\mathfrak{J}_{V} = \mathfrak{J}_{\mathbb{A}} + \mathfrak{J}_{\mathbb{B}}$) and Eqs. (22)-(24) there is no freedom to make additional C_{A} ($\mathfrak{L};t$) assumptions on $_{\rm V}$ at all, r $_{\rm V}$ (r;t) already is determined from these other equations. However, the motivation for Eq. (39) is that for real system s there is no strict conservation for the num ber of vacancies: in real (three-dimensional) alloys, vacancies can be created and destroyed by form ation or annihilation of interstitial atoms, or by interaction with other lattice imperfections such as dislocations, grain boundaries, etc. For two-dimensional surface alloys [21], vacancies can be created and destroyed if an atom from the considered surface monolayer becomes an adatom on top of this monolayer, or an adatom executing surface di usion [18, 31] becomes incorporated into the m onolayer via a jump to a vacant site inside the m onolayer. In view of these physical mechanisms which are forbidden in our model, Eq. (39) may represent a physically interesting limiting case. A priori, it is not clear for a particular system, whether for the time scales of interest it is closer to a situation where vacancies are in equilibirum (Eq. (39)) or conserved (Eq. (22)). Our num erical studies are concerned with the latter case exclusively. Nevertheless it is of interest to mention that Eq. (39) yields also a structure $D = int^{-1}$ but with $int = c_B D_t^A + c_A D_t^B$ and hence one nds instead of Eq. (38) [17]

W hile for D_t^B D_t^A (a case expected if A_B , as used in our simulation) one expects from Eq. (40) that the faster di using B species dom inates interdi usion, the opposite is true according to Eq. (38): therefore the names \fast mode" and \slow mode" theory have been chosen. In both equations (and in Eq. (32), where the o -diagonal Onsager coe cient is not neglected, unlike in both these theories) the therm odynam ic factor is treated by a simple Bragg-W illiam s mean eld approximation, how ever, which is no problem for the random alloy ABV problem treated in

Ref. [17], but clearly will introduce additional shortcom ings in the present case.

As a naldisclaim of this section we emphasize that Eqs. (20)-(40) were meant to provide a brief review of \chemical di usion" (or \collective di usion") in the context of the present lattice gas model only, and hence many interesting and important facets of this topic have not been mentioned at all and we direct the interested reader to the rich literature on this subject [1, 2, 3, 4, 5, 6, 7, 8, 9, 48, 49].

V. SIM ULATION RESULTS

A. Tracer di usion

We start with a discussion of the tracer di usion coe cients (Figs. 8, 9). The simplest case refers to equal jump rates $_{A} = _{B} = 1$ of both types of particles A and B (Fig. 8). In the in nite temperature limit then there is no longer any physical di erence between A and B particles, they simply di er only by their labels: then $D_{t}^{A} = D_{t}^{B}$, and become independent of concentration c_{A} (thick horizontal straight line in Fig. 8). Note that for $c_{A} = 0.96$ there are no B particles since $c_{V} = 0.04$ and then D_{t}^{A} becomes independent of temperature, similarly as D_{t}^{B} becomes independent of temperature for $c_{A} = 0.0$ focurse, the curves for D_{t}^{B} are simply the mirror in ages of those for D_{t}^{A} around the symmetry line $c_{A,max}^{crit} = (1 - c_{V})=2 = 0.48$ of the static phase diagram, Fig. 2b, since an interchange of A and B means that c_{A} gets replaced by 1 - c_{V}^{A} - c_{V}^{A}.

It is seen that the onset of ordering depresses self-di usion very strongly, while short range order (as it occurs for T = 1.2) has a minor e lect only. For T = 0.6, how ever, the ordering near $c_A = 0.48$ is rather perfect and there deep minim a of D_t^A ; D_t^B occur, the tracer di usion coel cients decrease by about two orders of magnitude. Of course, since D_t^A ; D_t^B are not symmetric around $c_{A,max}^{crit} = c_{B,max}^{crit} = (1 \quad \odot)=2 = 0.48$, due to the choice of a kinetic M onte C arb algorithm which lacks the symmetry between the motion of an A particle, mediated by a vacancy, in a B environment and in an A environment at nite temperatures, the minimum of D_t^A does not occur precisely at $c_{A,max}^{crit}$, as is seen from Fig. 8 (left part). In our algorithm, an A particle jumps to a vacant site with a jump rate $_A \exp((nj_{A,B}) j k_B T)$ when the di erence between the number of AB bonds involving an energy $_{AB}$ each between the initial and nal state is n > 0, and with a jump rate $_A$ else. It is easy to be convinced that this algorithm satis es detailed balance with the canonic equilibrium distribution, as it should be [19]. In the limit $c_A ! 1 = 0$, we always have n = 0, so there is no temperature dependence. In the limit $c_A ! 0$, how ever, every A atom not having a vacancy as nearest neighbors will have four B neighbors on the square lattice,

while an A atom with a vacancy neighbor has only three B neighbors. As a result, the jump of an A atom that has a B neighbor, to a vacant site involves \breaking" an AB bond, and hence this rate is suppressed by a factor exp($j_{AB} \neq k_B T$). This e ect is responsible for the tem perature dependence of D_{+}^{A} for c_{A} ! 0.

Kehr et al. [17] presented arguments to relate the tracer di usion coe cients to Onsager coe cients which take a simple form in the case of identical jump rates $_{A}$; $_{B}$, namely

U sing our estimates for the Onsager coe cients at T = 0.6 (see below) in Eq. (41), one sees that the trend of the concentration dependence of D_t^A is reproduced rather well. However, one should note that the derivation of Eq. (41) is rigorous only for the special case ${}_{AB} = k_B T = 0$, because only then the distinction between A and B particles form ing the environment of a tagged A particle can be neglected.

When $_{A} \in _{B}$ the self-di usion coe cients D_{t}^{A} and D_{t}^{B} lack any symmetric relation of their concentration dependence already in the random alloy limit [17], and for $_{AB} = k_{B}T < 0$ we are not aware of any theoretical treatment to which our simulation results (Fig. 9) could be compared. Interestingly, for not too low temperatures (such as T = 0.912, T = 1.2) the concentration dependence of D_{t}^{A} (the slower di using species, since $_{A} = _{B} = 0.01$ has been chosen in Fig. 9) is rather weak throughout, while for D_{t}^{B} we have a strong decrease when c_{A} increases up to about $c_{A,m}^{crit}$ are seen. Now, for D_{t}^{B} we have a strong decrease when c_{A} increase when c_{A} increases when c_{A

M oreover, when for $c_A = c_{A,m}^{crit}$ the order of the AB deckerboard structure is perfect (apart from a four per cent of vacant sites in the system), a jump of an atom to a vacant site occurs with rates $_A \exp(3_{AB} = k_B T)$ or $_B \exp(3_{AB} = k_B T)$, respectively, while the backward jump occurs at rates $_A$; $_B$. As a result, a high probability for backward jumps is expected, and this is borne out by a study of the correlation factor f for self-di usion (Fig. 10, right part). Following standard treatments [1, 2, 3, 4, 5, 6, 24] we decompose tracer di usion coe cients D_t as

where V is the vacancy availability factor already de ned in Eq. (9), and W is the average jump rate for the considered particle species. W is easily estimated in the simulation from the ratio

of the number of performed jumps to the number of all attempted jumps. The product $V_A W_A$ is plotted in Fig. 10 (left part) versus c_A at various temperatures. For ${}_{AB} = k_B T$! 0 we simply expect a horizontal straight line, $V_A W_A = 0.04$, since then $W_A = 1$, $V_A = c_V$ ($_1 = 0$). There is no independent way to determ ine f, however. Therefore Eq. (42) is taken as a denition of f, to be derived from D_t, while the tracer direct direct direct direct direct from the mean square displacements of the tagged particles, as explained in Sec. III of this paper. For $c_A ! 0.96$, when no B particles are present, the temperature dependence drops out and f reduces to the value f = 0.487 known from studies of a one-component non-interacting lattice gas on a square lattice with concentration $c_A = 0.96$ [29]. Note that our data for D_t, V, W and f at the higher temperatures (where no order-disorder transition occurs) resemble analogous results of M urch [26] for a simple cubic alloy.

As a nalcomment about self-di usion, we consider the temperature dependence of I_t^A and D_t^B for the critical concentration $c_A^{crit} = c_B^{crit} = 0.48$ (Fig. 11). One sees that at high temperatures (T 2T_c) the temperature dependence is very weak, and the tracer di usion coe cients settle down at their in nite temperature asymptotes. Approaching the critical point one sees a more rapid decrease of both D_t^A and D_t^B , with a maximum slope presumably right at T_c , while for T below T_c a crossover to the expected therm ally activated behavior at low temperatures occurs. In fact, one expects that $D_t D_t / (T T_c)^1$ [25], where D_t is the value of the tracer di usion coe cient at the critical point, and is the speci c heat exponent of the model. However, for the two-dimensional Ising model = 0 [34, 35, 36], i.e. the speci c heat has a logarithm ic singularity only. The insert of Fig. 11 shows a log-log plot of $D_t D_t$ versus (T T_c)=T_c, and one sees that the data are compatible with a power law with slope of unity; presumably the accuracy of our simulations does not su ce to identify the presence of a logarithm ic singularity in our data.

B. Onsager coe cients

As a rst issue of this subsection, we turn to the concentration dependence of the Onsager coe cients (Figs. 12, 13). For $_{\rm A} = _{\rm B}$ all Onsager coe cients are symmetric around $c_{\rm A} = c_{\rm B} = (1 \ _{\rm Q})=2$, as it must be, while for $_{\rm A}$ $\stackrel{\bullet}{=} _{\rm B}$ they are not. We have also included an approximate relation suggested by Kehret al. [17] between Onsager coe cients and tracer di usion coe cients,

nam ely

where $c = c_A + c_B$, f (c) being the correlation factor for tagged-particle di usion in a lattice gas with sum m ary concentration c. It is seen that this relation accounts for the general trend of the diagonal Onsager coe cients rather well, although for the o -diagonal Onsager coe cient it seems to work only qualitatively (Fig. 13). In the regime of the ordered phase the diagonal Onsager coe cients (note the logarithm ic ordinate scale) are distinctly smaller than for $c_A ! 0$ or $c_B ! 0$, respectively, when A = B.

An interesting aspect of the o -diagonal Onsager coe cient $_{AB} = _{BA}$ (Fig. 13) is that it is essentially zero for c_A ! 0 if $_A = _B$ while for $_A = _B = 0.01$ it is essentially negative in this lim it. A negative Onsager coe cient means that the currents of A and B particles are oriented in the opposite direction. A further change of sign of this o -diagonal coe cient is found near the phase boundary of the order-disorder transition; but near $c_A = c_B = (1 \quad c_F)=2$ the Onsager coe cient seem s to be positive again, although its absolute value seem s to be very sm all. We do not have any clear physical interpretation for this surprising behavior. Note also, that Eq. (43) can never yield a negative Onsager coe cient, since 0 f(c) 1 by de nition, and hence all term s in Eq. 43 are non-negative.

Finally Fig. 14 shows the tem perature dependence of the Onsager coe cients for the concentration $c_A = c_B = (1 \quad c_P)=2$ where the critical tem perature T_c of the order-disorder transition is maximal. Note that for $_A = _B = 0.01$ the magnitude of the order disorder transition $_{AB}$ is comparable to the smaller ($_{AA}$) of the diagonal ones, both at very high and at very low tem – peratures. This noting con most conclusion of Kehr et al. [17], that in general the order diagonal Onsager coe cient must not be neglected. We also note that the general trend of the tem perature dependence of the Onsager coe cients is very similar to the behavior of the self-di usion coe – cient, see Fig. 11. Both quantities reject the strong decrease of mobility of the particles at low tem peratures.

C. Interdi usion

Fig 15 presents a plot of the interdi usion constant D_{int} vs. concentration for the case of equal jump rates ($_{A} = _{B} = = 1$) at T = 0.6 and compares the results to various analytical

approximations: D (Eq. (32)), the \slow mode" expression $D_{int}^{sm:}$ (Eq. (38)), the \fast mode" expression $D_{int}^{fm:}$ (Eq. (40)), and a very simple result justi ed by Kehr et al. [17] for the non-interacting random alloy model,

W hile this last expression overestim ates the num erical results, all other expressions underestim ate them signi cantly. It is seen that in this case there is not much di erence between the slow mode and fast mode theory, but both are o from the data. In this case using the full expression (Eq. (32)) presents no improvement, unlike the non-interacting case. O fcourse, at nite temperature in d = 2the mean eld theory implicit in Eq. (32) is not expected to be accurate at all.

It now is no surprise any longer that in the asymmetric case $_{A} = _{B} = 0.01$ the various approximate expressions are not reliable either (Fig. 16). In particular, for concentrations near $c_{A} = c_{B} = (1 \quad q_{e})=2 = 0.48$ a pronounced minimum is predicted, while the actual simulation results reveal a rather shallow minimum only. Again the conclusion is that there is no reliable simple relation between self-di usion and interdi usion coe cients, and the temperature dependence of D_{int} at $c_{A} = c_{B} = 0.48$ at higher temperatures (Figs. 17,18) con must this conclusion. Again, for $_{A} = _{B} = = 1$ Eq. (44) is closest to the data, while Eq. (32) is worst. For T ! 1, how ever, in this limit for $c_{A} = c_{B} = (1 \quad q_{e})=2$ and $_{A} = _{B} = 1$ all expressions coincide (at a value highlighted by an arrow in Fig. 17), and the num erical data have been found in good agreement with this prediction [17]. Thus it is clear that including interactions among the particles destroys the applicability of the simple theories.

VI. CONCLUSIONS

In this paper, the study of mobility of particles, interdi usion and tracer di usion coe cients of a lattice model for a binary alloy, that was presented in Ref. [17] for the sim ple non-interacting lim it only, has been extended to the case where an attractive nearest-neighbor interaction between unlike particles leads to an order-disorder transition on the considered square lattice. W hile most theoretical considerations of the previous work [17] can be simply extended to the present case, the m ean- eld character of the approximations that are involved clearly emerges as a severe limitation of the usefulness of all these approaches. On the other hand the M onte C arlo techniques described in Ref. [17], suitable for the direct estimation of all Onsager coe cients and the interdi usion constant D int as function of the ratio of jump rates A = B, tem perature T and concentration c_A , are rather straightforward to apply. Exploring this rather large parameter space numerically is however somewhat tedious, and an understanding of di usion phenomena within the framework of lattice models for interacting particles by simple analytical expressions clearly would be desirable. However, the approximate expressions discussed in the present paper clearly do not give qualitatively accurate results.

Of course, the present study is a st step only: in order to make closer contact with possible experiments in surface layers of metallic alloys, it would be interesting to consider other lattice sym - metries (triangular and centered rectangular lattice rather than square lattices), further neighbors interactions, etc..

A very in portant extension would also be the inclusion of asymmetric e ects ($_{AA} \in _{BB}$) and nonzero energy parameters involving vacancies ($_{AV}$; $_{BV}$; $_{VV}$). Thus e ects could be described that vacancies occupy preferentially sites at interfaces [22] or in one of the sublattices [20]. Such e ects are expected to modify the di usion behavior signi cantly.

We thus hope the present study will stimulate the development of more accurate theoretical descriptions of di usion phenomena in alloys that undergo order-disorder transitions. A loc corresponding experiments studying a wide range of temperature and composition, would be desirable. Then it might be worthwhile to combine the present kinetic M onte C arlo methodology with \ab initio" calculation of jump rates, ordering energies , etc.




FIG.1: Schem atic view of the (100) surface of a substrate (shown as large open circles), whose periodic potential provides a square lattice of prefered adsorption sites (which here are assumed in the center of the square formed by the substrate atoms). A -atom s are shown as black circles, B -atom s are shown as grey circles, and vacancies (V) are shown as empty circles. The energies of the nearest-neighbor interactions between di erent kind of atom s (indicated by thick lines) are labeled by $_{AA}$, $_{BB}$ and $_{AB}$ respectively. The simple choice $_{AB}$, $_{AA} = _{BB}$ 0 is taken througout. This means that A atom s prefer B atom s as nearest neighbors, but it does not matter whether its nearest neighbors are also A atom s or vacancies, respectively. The jump rates for A V and B V exchanges are labeled by $_{A}$ and $_{B}$, respectively. For simplicity, the B atom s are considered as the faster particles ($_{B}$ 1), and $_{A} < _{B}$.




FIG.2: (a) Phase boundary for the order-disorder transition of the ABV model with $c_V = 0.04$. The phase boundary of the pure Ising antiferrom agnet [37] (equivalent to the case $c_V = 0$) is also included for comparison, as a dashed line. (b) Critical curve T vs. c_A , where $c_A = 1$ c_V c_g . The critical curve of the pure Ising antiferrom agnet [37] is also included for comparison, as a dashed line. Tem perature T is alw ays measured in units of the maximal critical tem perature T_c of the pure model (no vacancies, $c_V = 0$ and $c_A = c_B = 0.5$), cf. text.




FIG.3: Dependence of the staggered susceptibility ~ (a) and the fourth order cumulant U_L (b) on the tem perature, along the critical line H = 0 corresponding to the critical concentration $c_A = 0.48$. Several system sizes are considered, as indicated. Here T_c denotes the maximal critical tem perature of the model without vacancies (H = 0 then corresponds to $c_A = 0.5$).




FIG.4: (a) P bt of the size-dependent critical tem perature $T_c(L)$ (de ned as the maximum of ~(T;L)), in term s of the scaled variable $L^{1=}$. The critical Ising exponent = 1 is employed. The linear extrapolation to the therm odynamic limit, shown as a dashed line, provides an estimation of $T_c(a_V = 0.04) = 0.905(5)$ for the ABV model with $a_V = 0.04$. (b) Scaling plot of the order parameter . The estimated critical tem perature and the Ising critical exponents = 1 and = 1=8 are employed.




FIG. 5: Determ ination of the tracer di usion coe cients. (a) M ean square displacements of tagged A particles (open dots) and B particles (full dots) as a function of M onte C arb steps per particle. The tem perature is T = 1.2 (in units of the Ising critical tem perature), and the concentrations are $c_A = 0.4$, $c_B = 0.56$. The ratio of jump rates is $_A = _B = 0.01$. (b) E stim ates of the tracer di usion coe cients as a function of the time interval used. The lines represent the ts of the data after using Eq. (11).




FIG.6: Determ ination of the Onsager coe cients. (a) M ean displacements along the x direction of A and B particles as a function of M onte C arlo steps per particle. The temperature is T = 0.6, and the concentrations are $c_A = 0.71$, $c_B = 0.25$. The ratio of jump rates is A = B = 0.01, and the bias parameter is b = 1.1. (b) E stim ates of the Onsager coe cients $i_j=c_i$ by extrapolation to bias parameter b = 1.




FIG. 7: Determ ination of the interdi usion coe cients. For t < 0 we impose a cosine-like varying bulk eld H (x) which introduces a modulation in the concentration of A and B particles. The characteristic length of this perturbation is = 32 lattice spacings. (a) Temporal evolution of the concentration of A particles along the x direction in the lattice. Times correspond to t = 0 (circles), t = 10000 (squares) and t = 20000 (diam onds), respectively. The thick line marks the wavelenght = 32 of the applied bulk eld. The temperature is T = 1.5, and the concentrations are $c_A = c_B = 0.48$. The ratio of jump rates is $_A = _B = 0.01$. (b) Amplitude of concentration pro les as a function of time, for A particles (circles) and B particles (squares). The dashed lines correspond to ts of the data to single exponential functions, characterized by a decay constant D int.




FIG.8: Tracer di usion coe cients for A particles (left) and B particles (right), as a function of the concentration c_A . The jump rates are $_A = _B = 1$ and several temperatures are considered: T = 0.6 (dotted line), T = 0.912 (dashed line) and T = 1.2 (dot-dashed line). The thick line indicates in both cases the noninteracting, in nite temperature limit (random alloy model). Dots represent results obtained from Eq. (41).




FIG. 9: Tracer di usion coe cients for A particles (left) and B particles (right), as a function of the concentration c_A . The jump rates are $_A = _B = 0.01$ and several temperatures are considered: T = 0.6 (dotted line), T = 0.912 (dashed line) and T = 1.2 (dot-dashed line). The thick line indicates in both cases the noninteracting, in nite temperature limit (random alloy model).




FIG. 10: E ective jump rate (left) and correlation factor (right) for A particles, as a function of the concentration c_A and for di erent temperatures: T = 0.6 (dot line), T = 0.91 (dashed line) and T = 1.2 (dot-dashed line). The jump rates are A = B = 1.

The rst quantity provides an idea of the rate at which jumps actually occur at a certain temperature and composition. It is dened as the product of the vacancy availability factor V_A (related to the short-range order parameter 1) and the average jump rate W_A (dened as the quotient of the number of performed jumps to the number of all attempted jumps). The T ! 1 limit is given by $V = c_v = 0.04$, because in this case 1 = 0.

Once we obtain VW we can estimate the correlation factor f applying the denition $D_t = VW$ f and using D_t from Fig 8. See Refs. [24, 25, 26, 27] for details on the elect of correlations on tracer di usion in lattice gas models.

The limit value f = 0.487 for $c_A ! 0.96$ is known from Ref. [29]. This corresponds to a noninteracting, one-component lattice gas in a square lattice with concentration c = 0.96.




FIG.11: Dependence of the tracer di usion coe cients on the tem perature, for a stoichiom etric com position $c_A = c_B = 0.48$. The ratio of jump rates is $_A = _B = 0.01$. C incluss are A particles and squares are B particles. The dashed arrow marks the critical tem perature $T_c = 0.905$ (in units of the Ising critical tem perature), while the thick arrows indicate the asymptotic, in nite tem perature values for both coe cients. Inset (up): A mhenius plot of D_t for T T_c . Inset (bottom): scaling plot of D_t D_t j T T_c^{i} with

= 0 (specic heat exponent of the Ising model). The dashed line has a slope of unity.




FIG.12: Plot of the Onsager coe cients $_{ii}$ as a function of the concentration c_A , for a xed temperature T = 0.6. The jump rates are $_A = _B = 1$ (left) and $_A = _B = 0.01$ (right). The lines correspond to data obtained directly from the simulations, while the points correspond to the estimates obtained after using the approximation of Eq. (43) for the random alloy model.




FIG.13: The same as gure 12 but here the crossed coe cient $_{\rm ij}$ is shown.




FIG.14: P bt of the O nsager coe cients $_{ij}$ as a function of the tem perature, for a stoichiom etric concentration $c_A = c_B = 0.48$ and jump rates $_A = _B = 0.01$. The lines are drawn to guide the eyes. Inset: plot of the same coe cients in the vicinity of the critical tem perature, showing the linear approach to nite values right at T_c .




FIG.15: Plots of the interdi usion coe cient as a function of the concentration c_A , for a temperature T = 0.6. The jump rates are A = B = 1. The arrows mark the corresponding critical values of c_A for this temperature. Simulation results are compared to di erent theoretical approaches, for a discussion see the text.




FIG.16: P lots of the interdi usion coe cient as a function of the concentration c $_A$, for a temperature T = 0.6. The jump rates are $_A = _B = 0.01$.




FIG.17: Logarithm ic plot of the interdi usion coe cient as a function of the tem perature, for a concentration $c_A = c_B = 0.48$. The jump rates are A = B = 1. The arrow marks the in nite tem perature result, where all the quantities showed in the plot coincide.




FIG.18: Logarithm ic plot of the interdi usion ∞ e cient as a function of the tem perature, for a concentration $c_A = c_B = 0.48$. The jump rates are $_A = _B = 0.01$.
