Rubber friction: role of the ash tem perature

W hen a nubber block is sliding on a hard rough substrate, the substrate asperities will exert time-dependent deform ations of the nubber surface resulting in viscoelastic energy dissipation in the nubber, which gives a contribution to the sliding friction. Most surfaces of solids have roughness on many di erent length scales, and when calculating the friction force it is necessary to include the viscoelastic deform ations on all length scales. The energy dissipation will result in local heating of the nubber. Since the viscoelastic properties of nubber-like materials are extremely strongly temperature dependent, it is necessary to include the local temperature increase in the analysis. At very low sliding velocity the temperature increase is negligible because of heat di usion, but already for velocities of order 10² m = s the local heating may be very important. Here I study the in uence of the local heating on the nubber friction, and I show that in a typical case the temperature increase results in a decrease in nubber friction with increasing sliding velocity for v > 0.01 m = s. This may result in stick-slip instabilities, and is of crucial importance in many practical applications, e.g., for the tire-road friction, and in particular for ABS-breaking system s.

1 Introduction

Rubber friction is of extrem e practical importance, e.g., in the context of tires, wiper blades, conveyor belts and seals[1]. Rubber friction on smooth substrates, e.g., on smooth glass surfaces, has two contributions, namely an adhesive (surface) and a hysteretic (bulk) contribution [1, 2]. The adhesive contribution results from the attractive binding forces between the rubber surface and the substrate. Surface forces are often dom inated by weak attractive van der W aals interactions. For very sm ooth substrates, because of the low elastic m oduli of rubber-like m aterials, even when the applied squeezing force is very gentle this weak attraction may result in a nearly complete contact at the interface [3, 4, 5], leading to the large sliding friction force usually observed [6]. For rough surfaces, on the other hand, the adhesive contribution to rubber friction will be much smaller because of the sm all contact area. The actual contact area between a tire and the road surface, for example, is typically only

1% of the nom inal footprint contact area [7, 8, 9]. Under these conditions the bulk (hysteretic) friction mechanism is believed to prevail [8, 9]. For example, the exquisite sensitivity of tire-road friction to temperature just re ects the strong temperature dependence of the viscoelastic bulk properties of rubber.

W hen a nubber block is slid on a hard rough substrate the surface asperities of the substrate will exert uctuating forces on the nubber surface which, because of the internal friction of the nubber, will result in energy transfer from the translationalm otion of the block into the irregular them alm otion. This will result in a contribution to the friction force acting on the nubber block. The energy dissipation will result in local heating of the nubber. Since the viscoelastic properties of nubber-like m aterials are extrem ely strongly tem perature dependent, it is necessary to include the local tem perature increase when calculating the friction force. At very low sliding velocity the tem perature increase is negligible because of heat di usion, but already for velocities of order 10 2 m =s the local heating m ay becom e very in portant. Here I study the in uence of the local heating on the rubber friction. I show that in a typical case the tem perature increase w ill result in a friction which decreases with increasing sliding velocity for v > 0.01 m =s. This m ay result in stick-slip instabilities, and is of crucial in portance in m any practical applications, e.g., for the tire-road friction, and in particular for ABS-breaking system s.

2 Surface roughness and m acro-asperity contact

The in uence of surface roughness on rubber friction is mainly determ ined by the surface roughness power spectrum C (q) de ned by

Here h(x) is the substrate height measured from the average plane de ned so that hhi = 0. The h:: i stand for ensem ble averaging, or averaging over the surface area. We have assumed that the statistical properties of the substrate are translational invariant and isotropic so that C (q) only depend on the magnitude q = jqjof the wave vector q. Note that from (1) follows

so that the root-m ean-square (m s) roughness am plitude $h_0 = hh^2 i^{1=2}$ is determined by

In reality, there will always be an upper, q_L , and a lower, q_L , lim it to the q-integral in (2). Thus, the largest possible wave vector will be of order 2 = a, where a is some lattice constant, and the sm allest possible wave vector is of order 2 = L where L is the linear size of the surface.




FIG.1: Surface roughness power spectrum of a surface which is self a ne fractal for $q_1 > q > q_0$. The long-distance rollo wave vector q_0 and the short distance cut-o wave vector q_1 depend on the system under consideration. The slope of the logC logg relation for $q > q_0$ determ ines the fractal exponent of the surface. The lateral size L of the surface (or of the studied surface region) determ ines the sm allest possible wave vector $q_L = 2 = L$.

M any surfaces tend to be nearly self-a ne fractal. A self-a ne fractal surface has the property that if part of the surface is magni ed, with a magni cation which in general is appropriately di erent in the perpendicular direction to the surface as compared to the lateral directions, then the surface \looks the sam e", i.e., the statistical properties of the surface are invariant under the scale transform ation. For a self-a ne surface the power spectrum has the power-law behavior

where the Hurst exponent H is related to the fractal dimension D_f of the surface via H = 3 D_f. Of course, for real surfaces this relation only holds in some nite wave vector region $q_0 < q < q_1$, and in a typical case C (q) has the form shown in Fig. 1. Note that in many cases there is a roll-o wavevector q_0 below which C (q) is approximately constant.




FIG.2: The surface roughness power spectra C (q) for two asphalt road surfaces.

A sphalt and concrete road pavem ents have nearly perfect self-a ne fractal power spectra, with very well-de ned roll-o wave vector $q_0 = 2 = _0$ of order 1000 m⁻¹, corresponding to $_0$ 1 cm, which re ect the largest stone particles used in the asphalt. This is illustrated in Fig. 2 for two di erent asphalt pavem ents. From the slope of the curves for $q > q_0$ one can deduce the fractal dimension D_f 22, which is typical for asphalt and concrete road surfaces.




FIG.3: A nubber block (dotted area) in adhesive contact with a hard rough substrate (dashed area). The substrate has roughness on m any di erent length scales and the nubber m akes partial contact with the substrate on all length scales. W hen a contact area is studied at low m agni cation (=1) it appears as if com plete contact occurs in the m acro asperity contact regions, but when the m agni cation is increased it is observed that in reality only partial contact occurs.

A ssume that an elastic solid with a at surface is squeezed against a hard, random ly rough substrate. Fig. 3 show sthe contact betw een two solids at increasing m agni cation . At low m agni cation (1) it looks as if com plete contact occurs between the solids at m any m acro-asperity contact regions, but when the m agni cation is increased sm aller length scale roughness is de-

tected, and it is observed that only partial contact occurs at the asperities. In fact, if there would be no short distance cut-o the true contact area would vanish. In reality, how ever, a short distance cut-o will always exist since the shortest possible length is an atom ic distance.

The magnication refers to some (arbitrarily) chosen reference length scale. This could be, e.g., the lateral size L of the nom inal contact area in which case = L = , where is the shortest roughness wavelength components which can be resolved at magnication . In this paper we will consider surfaces with power spectra's of the form shown in Fig. 1, and we will use the roll-o wavelength $_0 = 2$ =q as the reference length so that = $_0 = =$ q=q.




FIG.4: The contact area between an elastic solid with a at surface and a hard random ly rough substrate shown at low m agni cations (= 4), left, and high m agni cation (= 216), right. The surface has the fractal dimension $D_f = 2.2$ and $q_D = q_L = 3$. A dapted from [10].

I now explain the concept of macro-asperity contact area, which is important for my treatment of the in uence of the ash-tem perature on rubber friction. A ssum e that the surface roughness has the qualitative form show n in Fig. 1 with a roll-o wave vector q_0 corresponding to the magni cation = 1. In this case the macro-asperity contact is the contact region between the solids when the system is studied at low magnication = m 2 (see Appendix A). At this magni cation, at low squeezing pressures one observe a dilute distribution of random ly distributed m acro-asperity contact regions with lateral $_{0}$ = $_{m}$. As the magni cation is size typically of order increased each m acro-asperity contact region breaks up into a relative dense distribution of much smaller microasperity contact regions. This is illustrated in Fig. 4 which shows the result of a Molecular Dynamics (MD) calculation [10] where the surface roughness power spectrum was assumed to be of the form shown in Fig. 1 (with the fractal dimension 22).

Consider the contact between two solids at low nom – inal contact pressure $_0 = F_N = A_0$, where the contact area is proportional to the load. Consider rst the system on the length scale $_0=_m$. On this length scale the

solids will make (apparent) contact at a low concentration of (widely separated) contact areas. Since the separation between these macro-asperity contact regions is very large we can neglect the interaction between the macro contact regions: in this case the pressure in the m acro-asperity contact regions will be of order $q_0 h_0 E$, where h_0 is the rm s roughness am plitude, and E the elastic modulus. Thus, the (average) pressure in the m acroasperity contact regions is independent of the nom inal contact pressure $_{0} = F_{N} = A_{0}$. Now, each macroasperity is covered by smaller micro asperities, and the smaller asperities by even smaller asperities, and so on. It is easy to see that at short enough length scale the m icro-asperity contact regions will be very closely separated and it is therefore in possible to neglect the (elastic or therm al) interaction between the asperities at short enough length scale.

In Sec. 4 we will calculate the ash tem perature in the asperity contact regions as a rubber block is sliding on a rough substrate. W e will neglect the therm al coupling (or overlap) between the macro-asperity contact regions, which should be a good approximation as long as the m is much smaller contact area at the m agni cation than the nom inal contact area (which im plies that the distance between the macro-asperity contact regions is $_0 = _m$ of these remuch larger than the linear size gions). However, owing to the high density of microasperity contact regions within a macro-asperity contact region, it is not possible to neglect the therm all coupling (or overlap) between the micro-asperity contact regions within each macro-asperity asperity contact region.




FIG.5: Infrared photo of time as it rotates out of contact with the road. The red-yellow color indicates the hot" spots arising from m acro-asperity contacts in the time-road footprint. A dapted from Ref. [11, 12].

The temperature increase in the macro-asperity contact regions between a tire and a road surface has recently been studied using infrared camera. Fig. 5 shows a photo of a tire as it rotates out of contact with the road. The red-yellow color indicate the \hot" spots arising from m acro-asperity contacts in the tire-road footprint.

3 Rubber friction without ash tem perature




FIG.6: The road asperities exert pulsating forces on the sliding rubber block, leading to energy dissipation in the rubber via the internal friction of the rubber. M ost of the energy dissipation occurs in the volum e elements bound by the dashed lines. The rubber viscoelastic deform ations in the large volum e elements are induced by the large road asperities, while the sm aller dissipative regions result from the sm aller asperities distributed on top of the large asperities. In general, in calculating the rubber friction, the viscoelastic energy dissipation induced by all the asperity sizes m ust be included, and the local tem perature increase (ash tem perature) in the rubber resulting from the energy dissipation m ust also be taken into account in the analysis.

The main contribution to rubber friction when a rubber block is sliding on a rough substrate, i.e., a tire on a road surface, is due to the viscoelastic energy dissipation in the surface region of the rubber as a result of the pulsating forces acting on the rubber surface from the substrate asperities, see Fig. 6. Recently I have developed a theory which accurately describes this energy dissipation process, and which predicts the velocity dependence of the rubber friction coe cient [7, 9]. The results depend only on the (com plex) viscoelastic modulus E (!) of the rubber, and on the substrate surface roughness power spectrum C (q). Neglecting the ash tem perature e ect, the kinetic friction coe cient at velocity v is determined

where $_0$ is the mean perpendicular pressure (bad divided by the nom inal contact area), and the Poisson ratio, which equals 0.5 for nubber-like materials. The factor P (q) = P (q) = A ()=A_0 is the (normalized) area of contact when the system is studied at the magnication = q=q_0.

The theory takes into account the substrate surface roughness components with wave vectors in the range $q_L < q < q_1$, where q_L is the smallest relevant wave vector of order 2 =L, where (in the case of a tire) L is the lateral size of a tread block, and where q_L m ay have di erent origins (see below). Since q_L for a tire tread block is smaller than the roll-o wave vector q_0 of the power spectra of most road surfaces (see Fig.2), nubber friction is very insensitive to the exact value of q_L .

The large wave vector cut o $q_1 m ay be related to$ road contam ination, or may be an intrinsic property of the tire rubber. For example, if the road surface is covered by sm all contam ination particles (diam eter D) then 2 = D. In this case, the physical picture is that đ when the tire rubber surface is covered by hard particles of linear size D, the rubber will not be able to penetrate into surface roughness \cavities" with diam eter (or wavelength) sm aller than D, and such short-range roughness will therefore not contribute to the rubber friction. For perfectly clean road surfaces we believe instead that the cut-o q1 is related to the tire rubber properties. Thus, the high local (ash) tem peratures and high local stresses which occur in the tire rubber-road asperity contact regions (see below), may result in a thin (typically of order a few m icrom eter) surface layer of rubber with m odi ed properties (a \dead" layer), which may contribute very little to the observed rubber friction (see Sec. 10). Since the stresses and tem peratures which develop in the asperity contact regions depend som ew hat on the type of road [via the surface roughness power spectrum C (q)], the thickness of this \dead" layer may vary from one road surface to another, and some run-in time period

will be necessary for a new \dead" layer to form when a car switches from one road surface to another (such \run-in" e ects are well known experimentally).

4 Rubber friction with ash tem perature

The temperature eld T (x;t) in the rubber block is determined by




FIG. 7: A nubber block sliding on a rough hard substrate with surface roughness on a single length scale. The region in the vicinity of a substrate asperity is shown. The heat energy production $Q_{-}(x;t)$ per unit volum e and unit time occurs mainly within the volum e element surrounded by a dashed line.

where Q is the energy production per unit volum e and unit time as a result of the internal friction in the rubber. The heat dissivity $D = C_V$, where is the m ass density and the heat conductivity. For rubber 10^{3} kg=m³, C_v 10^{3} J=kgK and we typically have 10 ⁷ m²=s. Consider 0:1 W = m K. This gives D now a rubber block with a at surface sliding on a rough hard substrate. A ssum e that there is an asperity contact area with diam eterd, see Fig. 7. During sliding at the velocity v the asperity will generate pulsating forces on the rubber surface characterized by the frequency $!_0$ v=d, which will result in energy dissipation in a volume elem ent of order d^3 . If the velocity v is high enough, negligible heat di usion will take place during the tim e period d=v and the tem perature increase in the rubber in the vicinity of the asperity will be T $Q = C_V$, where Q the the amount of frictional heat energy (per unit volum e) in the volum e element d^3 . The assumption of neqligible heat di usion requires that the e ective contact

time d=v is smaller than the di usion time d²=D, i.e., vd > D. Thus, for example, if v = 0.1 m =s, heat di usion will be unimportant if d > D =v 10⁶ m. How ever, after the substrate asperity { nubber contact is \broken", the peak tem perature will decrease, and the tem perature distribution will broaden with increasing time, in a way determ ined by the heat di usion equation.

In this section we will develop a theory for the in uence of the ash temperature on rubber friction when the substrate has roughness on very m any di erent length scales. We consider rst an idealized case where surface roughness occurs on a single length scale, and then the m ore com plex case of roughness on m any di erent length scales.

We consider a surface with random ness on a single length scale $_0 = 2 = q_0$ and with the root-mean-square roughness amplitude h_0 . The surface roughness power spectrum C (q) = $(h_0^2=2 q_0)$ (q q₀). The (average) radius of curvature of the asperities is R $1=(q_0^2h_0)$. Figure 7 shows the contact between one substrate asperity and the nubber. The diameter of the contact area is of order d. We assume that no roughness occurs on sm aller length scale than the size of the asperity in Fig. 7. The time it takes to slide the distance d is d=v. D uring this time the heat energy produced in the volume element

 d^3 at the asperity is given by $\ensuremath{\,F_N}\xspace d,$ where $\ensuremath{\,F_N}\xspace = d^2$ is the norm alasperity bad (is the average perpendicular stress in the contact area). Thus the energy production per unit volume Q $\ensuremath{\,F_N}\xspace d=d^3$ = . Neglecting heat di usion this will result in the temperature increase T $\ensuremath{\,Q}\xspace = C_V$. But we have shown earlier

where T_0 is the background tem perature. Note that the complex elastic modulus E (!;T) depends on the (local) tem perature T. For \sim ple" (un lled) rubber the W illiam s-Landel-Ferry equation (W LF)[13] equation can be used to (approxim ately) describe the tem perature dependence of E (!;T):

For any given viscoelastic modulus $E(!;T_0)$, equations (7)-(9) form a complete set of equations from which the temperature T and the friction coe cient can be obtained by, e.g., iteration. Here I will only discuss qualitatively how the temperature increase T in uence the nubber friction.




FIG.8: (a) The viscoelastic modulus E (!) = $E_1 + iE_2$ of a typical nubber-like material, and (b) the loss tangent $E_2=E_1$. (Schematic.)

In order to understand the qualitative in uence of the ash tem perature on rubber friction it necessary to know the general structure of the viscoelastic m odulus E (!) of nubber-like m aterials. In Fig. 8 we show the real $E_1 = ReE$ and the imaginary part $E_2 = ImE$ of E (!) and also the loss tangent $E_2=E_1$. At \low " frequencies the m aterial is in the \rubbery" region where ReE (!) is relative sm all and approxim ately constant. At very high frequencies the m aterial is elastically very sti (brittle-like). In this \glassy" region ReE is again nearly constant but m uch larger (typically by 3 to 4 orders ofm agnitude) than in the rubbery region. In the interm ediate frequency range (the \transition" region) the loss tangent is very large and it is mainly this region which determ ines, e.g., the friction when a time is sliding on a road surface.

The in uence of the ash tem perature on rubber friction di ers depending on if the perturbing frequency $!_0 = vq_0$ is smaller or larger than the frequency $!_1$ where Im E $(!;T_0)=E$ $(!;T_0)$ is maximal. Since an increase in

the temperature $(T_0 \ T > T_0)$ shifts the viscoelastic spectrum to higher frequencies (see the W LF function), if $!_0 < !_1$, the ash-temperature will decrease the friction. On the other hand, if $!_0 > !_1$ the opposite e ect occur. However, in most applications, e.g., in tire applications, the perturbing frequencies are (almost) always below $!_1$ and the friction will decrease when the ash temperature is taken into account. This has extrem ely im portant practical consequences, as we will be discussed later.

W e consider now the role of the ash tem perature for the general (and m ore com plex) case where roughness occurs on m any di erent length scales. W e consider rst stationary sliding and then non-stationary sliding.

4.1 Stationary sliding

In this section we will develop a general expression for the friction acting on a rubber block sliding at a constant velocity on a random ly rough substrate. W e will take into account the e ect of the ash tem perature. W e will including the therm all overlap between the heat produced in the m icro-asperity contact area inside every m acroasperity contact area. That is, the tem perature rise at one m icro-asperity contact area will produce a subsequent tem perature rise at a neighboring m icro contact. W e willmake use of a mean eld" type of approxim ation where we laterally sm ear out the heat sources associated with the m icro-asperity contacts within a m acro-asperity contact, which should be an excellent approxim ation in




FIG.9: A nubber block sliding on an asperity with shorter wavelength asperities on top of it. The tem perature increases $T_0 < \ T_1 < \ T_2$.

m ost cases.

Let us now discuss the ash-tem perature when a rubber block is sliding on a hard substrate with surface roughness on many di erent length scales. The basic problem is illustrated schematically in Fig. 9 in the case of only two length scales, where a \large" asperity is covered by \sm all" asperities. In response to the large asperity there will be a heating of the rubber in the big volum e elem ent of linear size d_1 . If T_0 denote the background tem perature, then the ash tem perature in the large volum e elem ent will be higher, say $T_1 = T_0 + T_1$. The ash temperature in a small-asperity volume elem ent (linear size d_2 , see F ig. 9) will be even higher, say $T_2 = T_1 + T_2$. For surfaces with surface roughness on many length scales the tem perature will increase as we go to sm aller and sm aller asperity contact regions. W e now study the tem perature distribution quantitatively.

The average shear stress which acts in the macro asperity-contact area is

where f is the nom inal frictional shear stress, and A (m) the m acro asperity contact area observed at the m agnication $= m = 0 = m = q_m = q_0$ which usually is of order unity (see Appendix A). Using (3) and (10) and that P (q) = A ()=A_0 gives

where T_q is an elective temperature in the volume of the rubber involved in the calculation of the contribution to rubber friction from surface roughness on the length scale = 2 =q (see below). Thus the energy \dissipation" per unit tim e and unit area in a m acro contact area

The energy production per unit volume, from asperities on the length scale = 2 =q, decay into the solid as e^{2qz} so that the energy production per unit volume

To solve the heat di usion equation (6) we need a boundary condition on the surface z = 0. We will assume that @T = @z = 0 for z = 0, i.e., we neglect heat transfer from the substrate. This is an excellent approximation at high enough sliding velocity. At low sliding velocity it will give rise to an overestimation of the ash temperature, but in this case the ash temperature e ect is anyhow not very important. The boundary condition @T = @z = 0 is equivalent to solving the heat di usion equation for an extended solid (1 < z < 1) with




FIG.10: The common region (dotted area) between the two circles has the area h(w).




FIG.11: The friction coe cient (a), the ash temperature (b), and the logarithm of the (norm alized) area of contact (c), as a function of the logarithm of the sliding velocity. For a nubber block (time tread nubber) sliding on an asphalt road surface. The background temperature $T_0 = 60$ C and $_{max} = 400$. In (a) we show the kinetic friction coe cient both with and without the ash temperature. In (b) and (c) we show results both for = 1 and at the highest magni cation = 400.

5 Sliding dynam ics: num erical results


In this section we will present num erical results for the friction force acting on a nubber (time tread) block, sliding on an asphalt road surface. W e will study the friction as a function of the velocity of the bottom surface of the block. In real experim ents it is, of course, not possible to speci es them otion of the bottom surface directly (unless steady sliding occur), but usually one specify the motion of the top surface of the nubber block (or some other dis

5.1 Stationary m otion

Fig. 11 shows the friction coe cient (a), the ash tem perature (b), and the logarithm of the (norm alized) area of contact (c), as a function of the logarithm of the sliding velocity. In (a) we show the kinetic friction coe -

cient both with and without the ash temperature. In (b) and (c) we show results both for = 1 and at the highest magni cation = 400. Note that without the ash tem perature the rubber friction coe cient increases m onotonically up to the highest studied sliding velocity 77 100 m =s. W hen the ash tem perature is included in the study the friction is maximal for v 1 cm =s. The decrease of the friction observed when the ash tem perature is included in the analysis is easy to understand (see also Sec. 4): when the rubber heats up the viscoelastic modulus E (!) shift towards higher frequencies and the rubber becom es more elastic (less viscous) resulting in less energy dissipation.

Fig. 11(b) shows that the ash temperature at the magnication = 400 (ie., the tem perature about 10 m below the rubber surface) is 140 C, i.e., about 80 C above the rubber background tem perature. On the other hand the tem perature increase a few mm below the surface (corresponding to the magni cation = 1) is just a few degree. We note that during steady sliding the tem perature in the whole rubber block will increase continuously with increase time, but this e ect is not included in the discussion above, unless one allowed for the background tem perature To to increase with increasing time. The calculation of the time dependence of T₀ require the know ledge of the tem perature of the surrounding m edium, and the heat transfer coe cient to the surrounding. This topic is important in many practical applications, but does not interest us here.

Fig. 11(c) shows that the area of (apparent) contact at low magnication (=1) decreases continuously with increasing sliding velocity. This result is expected because the frequencies ! of the pulsating deform ations of the rubber increases with increasing sliding velocity v v), and rubber becom es elastically sti er at higher (! frequencies, resulting in an (apparent) sm aller contact area at high sliding velocity. However, at the highest = 400, g. 11 (c) shows that the area m agni cation of contact increases with increasing sliding velocity for v > 0:1 m = s. This is caused by the increase in the tem perature in the surface region of the rubber, which shift the viscoelastic m odulus tow ards higher frequencies faster than the linear increase ! v in the perturbing frequencies arising from the increase in the sliding velocżγ.

Fig. 12 shows (a) the friction coe cient, (b) the ash tem perature, and (c) the logarithm of the (norm alized) area of contact, as a function of the logarithm of the m agni cation, for the sliding velocity v = 1 m = s. In (a) and (c) we show results both with and without the ash tem perature. Fig. 12 (a) shows that when the ash tem perature is included, the surface roughness on every decade in length scale contributes roughly with an equal am ount to the rubber sliding friction. Fig. 12 (c) shows that at low m agni cation the contact area is the sam e with and without the ash tem perature included in the analysis, while for large m agni cation the area of contact increases when the ash tem perature is included, as expected from the elastic softening of the rubber at higher tem peratures (see above).




FIG.13: Non-uniform sliding motion. (a) The velocity of the bottom surface of the block increases linearly with time from zero to 1 m = s and then decreases back to zero. In case 1 the time for the whole velocity cycle is 0:002 s and for case 2, 0:004 s. (b) The friction coe cient exhibit hysteresis as a function of the sliding velocity, and is sm aller during the retardation time period than during the acceleration time period. This behavior refect the build up of the line temperature during the sliding cycle.

5.2 N on-stationary m otion

It is usually assumed in simple treatments of friction, that the friction coe cient is a function only of the instantaneous slip velocity v_b (t), i.e., (t) = $(v_{b}(t)),$ where v_b (t) is the velocity of the bottom surface (in contact with the substrate) of the sliding block. However, this approximation fails badly for rubber friction. The reason is the strong dependence of rubber friction on the tem perature distribution in the rubber block. Since the tem perature distribution T (x;t) at time t depends on the sliding motion for all earlier times t⁰ t, it follows imm ediately that for rubber-likem aterials the ction coe cient will depend on the sliding history, i.e., it will be a functional of v_b (t): = $(v_b (t^0); t^0 t)$. In this section I present num erical results which illustrate this fact.




FIG.14: The ash temperature (a) and the frictional shear stress (b) as a function of time as the bottom surface of the rubberblock perform the motion indicated in Fig.13(a), and with $v_{\rm b}$ = 0 for t > 0.002 s and 0.004 s for case 1 and 2, respectively.

Let us assume the velocity of the bottom surface of the block rst increases linearly with time from zero to 1 m = s and then decreases back to zero, as indicated in Fig. 13(a). In case 1 the time for the whole cycle is 0.002 s and for case 2, 0.004 s. In Fig. 13(b) we show the resulting friction coe cient. Note that exhibits hysteresis as a function of the sliding velocity, and that

is smaller during the retardation than during the acceleration time period. This behavior just relects the nite slip-distance necessary for building up the ash tem perature, and the nite time involved in heat di usion, and shows that does not just depend on the instantaneous sliding velocity but on the whole sliding history (m em ory-e ects). Note that the slip-distance is given by $v_{max}^2 = a$, where $v_{max} = 1$ m = s is the maximum of the velocity and the acceleration a = 1000 and $500 \text{ m} = \text{s}^2$ for case 1 and 2 respectively, giving the slip distances 1 and 2 mm, respectively. These values are both smaller than the diam eter of the m acro-asperity contact regions which is 2R 3:3 mm. The larger slip distance for case 2 im plies that more energy is deposited (in the rubber) at the rubber-substrate contact regions than for case 1, which will result in a higher ash temperature in case 2 than in case 1. This explains why the friction coe cient is smaller for case 2 (see Fig. 13(b)).




FIG.15: (a) the friction coe cient, (b) the ash-tem perature at the highest m agni cation and (c) the (relative) contact area at the highest m agni cation, as a function of time. The bottom surface of the block m oves with the constant velocity $v_b = 2 \text{ m} = \text{s}$ for 0 < t < 0.002 s, and at t = 0.002 s it is abruptly reduced to $10^{5} \text{ m} = \text{s}$ and is kept at this velocity for 0.0005 s (case 1), 0.001 s (case 2), 0.002 s (case 3), 0.003 s (case 4), and then returned to $v_b = 2 \text{ m} = \text{s}$.

The tem perature buildup during the sliding motion is illustrated in Fig. 14. This gure also shows that after the sliding motion has stopped, i.e., for t > 0.002 s and t > 0.004 s for case 1 and 2, respectively, the tem perature at the surface decreases monotonically because of heat di usion. Note that as a function of the slip velocity v_b (not shown), the ash tem perature in Fig. 14(a) is always higher for case 2 as compared to case 1. Fig. 14(b) shows the frictional shear stress $_f(t) = _0$ (t) as a function of tim e.

Assume now that the bottom surface of the block moves with the constant velocity $v_b = 2 \text{ m} = \text{s}$ for 0 < t < 0.002 s, and at t = 0.002 s it is abruptly reduced to

10 5 m =s, and is then kept at this value for 0.0005 s (case 1), 0:001 s (case 2), 0:002 s (case 3), 0:003 s (case 4), and then returned to $v_b = 2 \text{ m} = \text{s.}$ For this sliding history we show in Fig. 15 (a) the friction coe cient, (b) the ash-tem perature at the highest m agni cation and (c) the (relative) contact area at the highest m agni cation, as a function of time. Note that the longer the system is kept in the low-velocity state (where $v = 10^{5} m = s$), the higher the \start-up" peak in the friction will be when the velocity is switched back to 2 m = s. The reason for this is that, because of heat di usion, in the low -velocity state the tem perature in the rubber will decrease continuously with increasing time, see Fig. 15(b), and the nubber friction increases when the nubber tem perature decreases. Fig. 15(c) illustrate that, as expected, the contact area between the rubber and the substrate increases when the rubber heats up and when the rubber sliding velocity decreases.




FIG.16: A rubber block (thickness d) pulled on a rough hard substrate. The upper surface is clamped and moved with a prescribed velocity v(t) = x_t . In the mathematical description of the sliding motion, the block is discretized into N layers of thickness d = d=N. The coordinates x_1 (t) = x_b (t), x_2 (t); $x_{N+1} = x_t$ (t) depend on time. The continuum limit is obtained as N ! 1.

6 Rubber block dynam ics

W e consider the sim plest but m ost fundam ental case of a nubber block (m ass M) squeezed against a substrate, and with the upper surface clam ped and in prescribed lateralm otion as indicated in Fig. 16.

The shear stress that acts on the lower surface of the rubber block is treated as a spatially uniform stress $_{\rm f}$ (t). In the most general case, where inertia e ects are in portant, we discretize the block (thickness d) into N layers of thickness d = d=N and mass m = M = N. The coordinates x_1 (t) = x_b (t), x_2 (t); $\dots x_N$ (t); x_{N+1} (t) = x_t (t) depend on time. The continuum limit is obtained as N ! 1. The non-stationary sliding of the nubber block [see Fig. 16] is determined by the equations of motion

where F_0 is the friction force acting on the bottom surface of the block, and F_i the shear force acting on layer i from the layer i+ 1 above. $F_{\rm N}\,$ is the force acting on layer N from the drive (the black slab on top of rubber block in Fig. 16).

Note that the friction force $F_0[x_b(t)]$ is a functional of $x_b(t)$ since it depends on the whole history $fx_b(t^0)$; t^0 tg. The shear force F_i acting on layer i from the layer above, can be derived from the equation relating the shear stress (!) to the shear strain (!) via

The equations above can also be applied when the properties of the rubber block depends on the vertical coordinate z if one replace the mass m ! m_i and m em ory spring K ! K_i. If = (z) is the rubber mass density, then m_i = A₀ d (z_i) and similarly K_i = A₀G (z_i;t) = d. Since the rubber friction F₀ depends extrem ely strongly on the sliding velocity for very small sliding velocities, the system of di erential equations given above is of the sti nature, which requires special care in the tim e-integration in order to avoid num erical instabilities.

7 V iscoelastic m odulus

M any experim ental techniques can be used to obtain the complex, frequency dependent, shear modulus G (!) [or Young modulus E (!)]. This quantity enters directly in the calculation of the rubber frictional shear stress $_{\rm f}$. But in the rubber block dynam ics theory described in Sec. 6 we also need the time-dependent real shear modulus

Since G (!) usually is known only in a nite frequency interval, $!_0 < ! < !_1$, it is not easy to calculate G (t) directly from (65) using, e.g., the Fast Fourier Transform m ethod. Another, even m ore serious problem is that in some cases G (t) is not a `perfect" linear response function (see below), which gives rise to serious problem s if one tries to calculate G (t) directly from (65), e.g., one nds that G (t) is com plex rather than real.

Let us rst assume that G (!) is the viscoelastic modulus of a linear viscoelastic solid. Now, the shear stress

(t) in a solid at time t can only depend on the deform ations (or strain) the solid has undergone at earlier times, i.e., it cannot depend on the future strain (causality). Thus we can write




FIG.17: The real and the imaginary part of the viscoelastic modulus G (!) for Styrene Butadiene copolymer (a) without ller, and (b) with 30% carbon black ller. The red and green lines are the original data and the t-data obtained by tting the experimental G (!) to a sum over relaxation times as described by (68). For the temperature T = 60 C.

The idea is now to determ ine G_1 and H (!) so that the di erence $G(!) = G_{m eas}(!) - G(!)$ between the measured $G_{m eas}$ shear modulus and the analytical expression G(!) given by (66) becomes as small as possible. If the relaxation times are distributed exponentially (i.e., $_{k} = _{0} \exp({_{k}})$, where $_{k}$ are uniform ly distributed), it is usually enough to include 10 15 relaxation times, or one relaxation time for each decade in frequency. If the measured $G_{meas}(!)$, $!_{0} < ! < !_{1}$, correspond to a true linear response function then one can nd G_{1} and H (!) so that V vanish. Since in many cases G (!) is not a true linear response function (see below) it is impossible to choose the real function H (!) so that V vanish. However, if we can nd H (!) and G_{1} so that V << 1 we have a very good representation of G (!) of the form (66). U sing (66) it is easy to integrate (65) to obtain

The minimization of V with respect to G_1 and H_k can be performed by using a random number generator: First some (arbitrary) set of parameters G_1 and H_k are chosen and V calculated. Next, one replace G_1 and H_k with G_1 (1+) and H_k (1+ $_k$), where and $_k$ are small random numbers. If the new V, calculated using these parameter values, is smaller than the original one, then the new parameters are accepted as in proved parameters; otherwise they are rejected and the old parameters kept. If this procedure is repeated (iterated) m any times the elective \potential" V will converge towards a m inim a, and the parameters G_1 and H_k at the minim a of




FIG.18: The spectral density H $_{\rm k}$ as a function of the relaxation time $_{\rm k}$ as obtained by tting the measured G (!) to the spectral representation (68). The squares and circles correspond to the un lled and lled SB copolymer. For the temperature T = 60 C.

V are the best possible ones, which we use in calculating G (t) as described above.

As an example, in Fig. 17(a) we show the real and the imaginary part of the viscoelastic modulus G (!) for Styrene Butadiene copolymer (a) without ller, and (b) with 30% carbon black ller. The red and green lines are the experim ental data and the t-data, respectively, where the t-data was obtained by approximating the experimental G(!) by the sum (68) as described above. Note that for the un lled rubber both the real and in aginary part of G(!) are very well tted by suitable choice of a single real (positive) function H (). This is possible only because ReG (!) and Im G (!) are not independent but related via a K ram ers-K ronig relation (see below). For the led rubber the t of ReG is equally good, but there is a small deviation for ImG. We have observed the same for other rubber compounds, and sometimes the deviation G between measured and tted Im G is larger than in Fig. 17(b), but the calculated G (t) is still accurate enough for our applications. The deviation G re ects the fact that for lled rubber G (!) is not a \perfect" linear response functions, but exhibit non-linearly. One source of non-linearity is the so called Payne e ect, due to the strain-induced break-up of the ller network [14, 15].

Fig. 18 shows the spectral density H_k as a function of the relaxation time $_k$ as obtained by tting the measured G (!) to the spectral representation (68). The squares and circles correspond to the un lled and lled SB copolymer. Note that the main di erence be-

tween the two cases occur for the longest relaxation times $> 10^8$ s, where the lled nubber has a much higher spectral density H (). This implies that for the lled nubber, in contrast to un lled nubber, there is a high spatial density of (relatively) high-energy-barrier rearrangement processes. This results from polymer molecules

bound to the surfaces of the carbon ller particles; the bound layers, which may be 1 nm thick, are in a glassylike state and exhibit larger energy barriers for (therm ally activated) rearrangements, as compared to the polymer segments further away from the ller particles.

We emphasize that only when G (!) corresponds to a linear response function causality will result in a well-de ned analytical structure for G (!). In this case the real part $G_1 = ReG$ and imaginary part $G_2 = Im G$ of G (!) are related via K ram ers-K ronig relations:


where $G_1 = G(1)$ is the (real) high frequency shear modulus. For lled rubbers, (69) and (70) only hold approximately. In particular, due to the Payne e ect (see above) the rubber behaves in a non-linear way i.e., G(!)is not a \perfect" linear response function, and eqs. (69) and (70) will only hold approximately.

8 N um erical results: rubber block dynam ics

In this section we present results for the sliding dynam ics of a rubber block with thickness 0.5 cm, squeezed against an asphalt road with the nom inal pressure $_0 =$ 0.4 M Pa.




FIG.19: A nubber block with thickness 0.5 cm sliding on an asphalt road. The nom inalpressure $_0 = 0.4$ M Pa. The upper surface of the nubber block is clam ped and undergoes uniform acceleration $a = 500 \text{ m} = \text{s}^2$ for 0.004 s. (a) The velocities v_t and v_b of the top and bottom surface of the nubber block, respectively, as a function of the distance x_t the top surface has m oved. (b) The shear stress acting on the bottom surface of the nubber block, as a function of x_t . In the calculation the block is \divided" into N = 12 layers.

Assume is that the upper surface of the rubber block is clamped and undergoes uniform acceleration $a = 500 \text{ m} = \text{s}^2$ for 0:004 s. Fig. 19 shows (a) the velocities v_t and v_b of the top and bottom surface of the rubber block, respectively, and (b) the shear stress acting on the bottom surface of the rubber block, as a function of the distance x_t the top surface has moved. Note that the bottom surface of the block is e ectively pinned until the shear stress reaches s 0:44 M Pa, corresponding to the friction coe cient = s=0 1:1. A fler the depinning, the velocity of the bottom surface of the block increases towards the velocity of the top surface, while the shear stress approaches a constant value determ ined by the kinetic friction coe cient. The physical reason for the peak in the shear stress at x_t 0:07 cm is due to the ash tem perature; the full ash tem perature is not built up until the slip distance is of order the diam eter of the macro asperity contact regions, i.e., of order 0.4 cm in the present case.

Next, let us consider a case when the upper surface of the nubber block rst accelerates with a = $500 \text{ m} = \text{s}^2$ for 0 < t < 0.004 s, and then retards with a = $500 \text{ m} = \text{s}^2$ for 0.004 < t < 0.008 s. In Fig. 20(a) we show the shear stress, divided by the nom inal pressure $_0$, acting on the bottom surface of the nubber block, as a function of velocity v_t of the top surface of the block. In Fig.

20 (b) we show the velocity v_b of the bottom surface of the nubber block, as a function of time.

9 C om parison with experim ent

A lot of experim ental data has been presented in the literature related to nubber friction. However, in order to quantitatively compare the nubber friction theory with experimental data, both the viscoelastic modulus E (!;T) and the substrate surface roughness power spectrum C (q) must be known, but this information was never reported in any experimental investigations of rubber friction which I am aware of. Thus, in the present section we will only consider general (universal) aspects of nubber friction, and show that the theory is in good qualitative agreement with the presented experimental data.




FIG.21: The friction ∞ cient as a function of the logarithm of the sliding velocity. For a rubber tread block sliding on an asphalt road surface at T = 18 C. (Courtesy of 0 laf Lahayne).

Let us rst consider stationary sliding. Fig. 21 shows the measured kinetic rubber friction coe cient as a function of the logarithm of the sliding velocity, for a tread rubber block sliding on an asphalt surface [18]. The velocity dependence of $_{\rm k}$ (v) is in good qualitative agreement with the theory (com pare Fig. 21 with Fig. 11 (a)). More

generally, I have found that the theory, and all the experim ents known to me, gives a maxim al friction coe cient of order unity, and the position of the maximum in the range 10³ 10¹ m=s, depending on the rubber com – pound and the substrate surface. In the absence of the ash tem perature, according to the theory the maximum would instead occur at much higher sliding velocities, typically in the range 10^2 10^4 m=s. This illustrates the crucial role of the ash tem perature.




FIG.22: The friction ∞ cient as a function of the background temperature, during sliding of a nubber block on a rough substrate. The experim ental data was obtained using a portable skid tester [16, 17] for tread nubber on road surface. The theory data was calculated using the viscoelastic modulus of a standard tread nubber, sliding on an asphalt road surface (with the power spectrum given in Fig. 2, surface 1) at v = 1 m =s.

Next, let us consider the dependence of the friction coe cient on the background temperature. Fig. 22 shows experim entaldata (obtained using a portable skid tester[16, 17]) for a tread nubber block sliding on a road surface. The theory data in the same gure is calculated for a nubber block sliding on an asphalt road surface (with the power spectrum given in Fig. 2, surface 1) at v = 1 m = s. The viscoelastic m odulus of the nubber used in the calculation is for a tread nubber. A sexpected, the nubber friction decreases with increasing background temperature.




FIG.23: A soft nubber block (thickness 1:1 cm) sliding on a wet concrete surface at the nom inal pressure 0.2 M Pa. The variation of the e ective friction coe cient with the velocity v of the drive is shown for non-uniform sliding (see inset) involving acceleration (a $5 \text{ m} = \text{s}^2$) followed by retardation (a $5 \text{ m} = \text{s}^2$). From Ref. [19] (with perm ission).




FIG.24: A rubber block (thickness 0.5cm) sliding on an asphalt road surface at the pressure 0.2 M Pa. The (calculated) variation of the e ective friction coe cient with the velocity v_t is shown for two di erent cases where the drive rst accelerate (a $5 \text{ m} = \text{s}^2$ and $50 \text{ m} = \text{s}^2$) followed by retardation (a $5 \text{ m} = \text{s}^2$ and $50 \text{ m} = \text{s}^2$).

Let us now consider non-stationary sliding. Fig. 23 shows results for a (soft) rubber block (thickness 1:1 cm) sliding on a wet concrete surface at the nom inal pressure 0:2 M Pa. The variation of the e ective friction coe cient with the velocity v of the drive is shown for non-uniform sliding (see inset) involving acceleration (a $5 \text{ m} = s^2$) followed by retardation (a $5 \text{ m} = s^2$) [19]. Note that the experim ental data is of the general form predicted by the theory (see Fig. 24) with a \start-up" peak due to the ash-tem perature; the rubber block m ust slide a distance of order the linear size of the m acro asperity contact regions before the full ash tem perature has been developed, and this is the origin of the \start-up" peak.

Note that the \start-up" peak in Fig. 23 and in the

calculations 24 has nothing to do with the static friction coe cient, but rather is a kinetic e ect related to the nite sliding distance necessary in order to fully build up the ash temperature. In fact, rubber on rough substrates does not exhibit any static friction coe cient, but only a kinetic friction which (for sm all sliding velocities) decreases continuously with decreasing sliding velocity.




FIG.25: The kinetic (steady state) nubber friction coe cient for typical tire tread compounds for racer car (top) and personal car (bottom), sliding on an asphalt road surface. The background temperature T = 60 C.

Finally, let us check if the theory agrees with the observation that tires for racer cars (or racer motorcycles) exhibit much larger friction (but also much larger wear) than tires for passenger cars. In Fig. 25 I show the calculated kinetic friction coe cient, using the measured viscoelastic modulus of a rubber compound from racer tires, and for a passenger car tire, assuming all other conditions identical. The maximum kinetic friction is about 50% higher for the racer compound which is also what is typically found experimentally [20]. This calculation indicates that even for racer tires the main origin of the friction is due to the internal damping of the rubber rather than an adhesive tire-road interaction.

10 On the origin of the short-distance cut-o

The nubber friction theory presented above assumes that the friction is due to the internal friction of the nubber. That is, the substrate surface asperities exert forces on the nubber surface and result in pulsating deform ations of the nubber. The deform ations cannot occur completely adiabatically, but result in transfer of energy into random heat motion in the nubber. In calculating this asperity-induced contribution to the friction I include only the road surface roughness with wavevectors $q < q_1$. Here I will discuss the origin of the short distance cut o q_1 . In principle, there may be several di erent origins of q_1 . For example, if the road is covered by sm all particles, e.g., dust or sand particles, with typical diam –

eter D, then one may expect q 1=D. Similarly, on a wet road, the water trapped in the surface cavities may act as an elective short-distance cut o [21]. However, for clean dry road surfaces, I believe that the cut o may be determined by the nubber compound properties.

If no short-distance cut o q_1 would exist the ash tem perature and the surface stresses in the contact areas would increase as we study the contact regions at higher and higher m agni cation. However, when the ash tem – perature and surface stresses becomes high enough, the rubber will degrade [22]. In fact, measurements on bulk samples have shown that natural rubber rapidly thermally degrades already at T 200 C. The surface layer of the tire rubber is exposed to oxygen and ozone and will degrade even faster than in the bulk, even if the tem perature would be the same. The therm aldegradation results in a thin layer of modi ed nubber at the surface, and we will make the basic assumption that the deform ation of the nubber on length scales shorter than the thickness of the modi ed layer, gives a negligible contribution to the tire-road friction. Thus, with respect to friction, we assume that the modi ed surface layer acts as a \dead" layer.

The form ation of a modi ed surface layer is a thermally activated mechanic-chemical process involving the breaking of chemical bonds (and the form ation of new bonds). The rate of bond-breaking (at the temperature T and the tensile stress) is assumed to be given by the standard expression of activated processes:

where the attempt frequency w_0 is usually of order 10^{12} s¹, and where E is the activation energy for bond breaking, and $_c$ the stress necessary for bond-breaking at zero temperature. The weakest (chemical) bonds in nubber cross-linked with sulfur, are multi-sulfur crosslinks for which E is of order 2 3 eV. A ssum ing a typical cross-link density, and that the applied stress distributes itself entirely on the cross-links (which requires so high temperature that the rubber is liquid-like between the cross-links), and assum ing that the same force acts on all the crosslinks, one can estim ate the stress $_c$ to be of order 1 GPa. How ever, in inhom ogeneous materials such as nubber, there will be a large distribution of local forces acting on the cross-links, and the cross-links where the local stress is highest will in general break rst.

The contact time of a time tread block in the footprint area is typically of order 0.01 s, and since the dead layer has been worn out in about 100 contacts, the rate w must be of order 1 s^{1} . Taking w 1 s^{1} gives

Note that the RHS of this expression is not very sensitive to the value of w. We can use (72) as a criteria to determining the optimum cut-o $q_1: W$ e determine q_1 so that Eq. (72) is satisfied, where T is now the ash temperature in the contact area and the stress in the contact area.

We have found that using E 1:25 eV and $_{\rm c}$ 100 M Pa result in a friction coe cient in good agreement with experiment. Note that E is smaller than the typical energy to break sulfur cross link (which is of order 2 3 eV) or the energy to break a C-C bond along a carbon chain (which is of order 3 4 eV). However, in the present case the bond breaking is likely to involve reaction with foreign m olecules, e.g., ozone or oxygen, and the e ective activation energy for such processes may be much smaller than when the bond break in vacuum . The value for $_{\rm c}$ is higher than the nupture stress of m acroscopic nubber blocks, but $_{\rm c}$ refer to the nupture stress of very small rubber volume elements, which is higher than for macroscopic rubber blocks due to the absence of (large) crack-like defects [23]. It is clear that the processes which determ ines the cut-o q_1 are closely related to tire tread wear.

11 Sum m ary and conclusion

W hen a rubber block slips on a hard rough substrate, the substrate asperities will exert tim e-dependent deformations of the rubber surface resulting in viscoelastic energy dissipation in the rubber, which gives a contribution to the sliding friction. Most surfaces of solids have roughness on m any di erent length scales, and when calculating the friction force it is necessary to include the viscoelastic deformations on all length scales. The energy dissipation will result in local heating of the rubber. Since the viscoelastic properties of rubber-like m aterials are extrem ely strongly tem perature dependent, it is necessary to include the local temperature increase in the analysis. In this paper I have developed a theory which describe the in uence of the ash tem perature on rubber friction. At very low sliding velocity the tem perature increase is negligible because of heat di usion, but already for velocities of order 10 $^2\,$ m =s the local heating m ay be very important, and I have shown that in a typical case the temperature increase result in a decrease in rubber friction with increasing sliding velocity for v > 0:01 m =s. This may result in stick-slip instabilities, and is of crucial importance in many practical applications, e.g., for the tire-road friction, and in particular for ABS-breaking system s.

A ppendix A : A verage size of a m acro-asperity contact region




FIG.26: The contact area at increasing magnication (a)-(d). The macro-asperity contact area (c) breaks up into smaller contact areas (d) as the magnication is increased.

Consider the contact between two solids with nom inally at surfaces. Fig. 26 shows the contact area at increasing magnication (a)-(d). At low magnication < 1 it appears as if complete contact occur between the solids. The macro-asperity contact regions typically appear for a magnication somewhere in the range $_{\rm m} = q_{\rm m} = q_0$ 2 5 depending on the substrate surface and the nubber compound, where A=A₀ 0.25 0.3 is slightly below the site percolation threshold (for a hexagonal lattice). The macro-asperity contact regions (c) breaks up into smaller contact regions (d) as the magnication is increased.

Let us now estimate the (average) size of the macroasperity contact regions. Assume that the contact patches have the surface areas A_i (i = 1;:::;N). Let




FIG.27: The (average) radius R of a m acro-asperity contact area as a function of the (norm alized) projected contact area $A = A_0$.

Using Fig. 27 this gives the diam eter of the m acro-asperity contact regions 2R 3=q $_0$. If q $_0$ = 600 m⁻¹ this gives 2R 0.5 cm.
