Possible ferro-spin nem atic order in N iG a_2S_4

W e explore the possibility that the spin-1 triangular lattice m agnet N iG $a_2 S_4$ m ay have a ferronem atic ground state with no frozen m agnetic m om ent but a uniform quadrupole m om ent. Such a state m ay be stabilized by biquadratic spin interactions. We describe the physical properties of this state and suggest experiments to help verify this proposal. We also contrast this state with a hon-collinear' nem atic state proposed earlier by T sunetsugu and A rikawa for N iG $a_2 S_4$.

I. IN TRODUCTION

Spins on a lattice often develop som e periodic order at low tem peratures. It has been appreciated for som e tim e that such ordering m ay be killed even at zero tem perature by quantum uctuations. This is particularly true of spin systems in low dimension and/or the presence of geom etric frustration of the m agnetic interactions. Indeed one of the earliest suggestion of a \resonating valance bond" spin liquid state was for the nearest neighbor antiferrom agnetic H eisenberg on the triangular lattice.[2] A lthough, the ground state of this system is now believed to be the \120 ordered" state (see C apriottiet al.[3] and references therein), the experimental search for low spin quantum m agnets on a frustrated perfect triangular lattice has continued.

Recently, Nakatsuji et al.[4] reported an experim ental realization of an insulating spin-1 quantum magnet on a perfect triangular lattice in the chalcogenide N iG a_2S_4 . This is a layered material with alternating Ni-S and Ga-S planes. Each N i^{2+} ion is in a (distorted) octahedral environm ent of six S^2 ions, and the N i layer has N f^{2+} ions arranged in a perfect triangular lattice. The system is an insulator; the only important electronic degree of freedom being the spin on the $N \dot{I}^{+}$ ion which has an electronic con guration of $t_{2\alpha}^6 e_{\alpha}^2$ (due to the crystal eld splitting brought about by the octahedral environm ent of the S^2 ions), and due to the H und coupling in the e_a sector, has S = 1. The compound shows unusual magnetic properties. The high tem perature susceptibility is Curie-Weiss like (with a Wiess temperature of 80 K), consistent with an S = 1 m om ent on the N t^{2+} ions. H ow ever at around the W eiss tem perature, the susceptibility begins to drop smoothly, and reaches a nite value at T = 0 indicating the absence of a spin gap. The magnetic speci c heat shows two humps, one at around 10 K elvin, and another broad hum p at about 80 K elvin (the W eiss

tem perature). However there is no sign of any singular or discontinuous behavior suggesting a phase transition. The magnetic entropy per spin shows a plateau between 15 to 50 K elvin at about a third of the high tem perature entropy suggesting large degeneracy of low lying excitations above the ground state. The speci c heat, up to 10 K, shows a T² power law suggesting the presence of linear dispersing gapless modes in the Niplanes. Moreover, this behavior of the speci c heat was found to be robust to non-magnetic Zn substation in the compound [5]. Intriguingly despite this no periodic spin order is detected in powder neutron scattering, and a broad (possibly incommensurate) peak is seen with a wavelength that is roughly twice that of the well known 120 spin order on the antiferrom agnetic triangular lattice. Furtherm ore there is no indication of any lattice distortion associated with possible developm ent of spin-Peierls order on cooling to low tem perature.

M otivated by these experiments, T sunetsugu and A rikawa[1] have recently proposed a spin nem atic ground state for N iG a_2S_4 . In such a state there is no average m agnetic m om ent (hS i = 0) but there is a non-zero quadrupole m om ent characterized by a non-zero average of

where S_i is the -spin component operator at site i, is the K roneker delta symbol. In the state proposed in [1], the quadrupole orderparam eter has a three sublattice structure. P recisely if one w rites

then the \director" n points along three orthogonal directions in the three sublattices of the triangular lattice.

In this paper we propose an alternate spin nem atic state as a possible ground state of N iG a_2S_4 . The particular state we propose m ay be dubbed a 'ferro-nem atic' in the sense that the average quadrupole m om ent is spatially uniform in the ground state. The director vector n is independent of site i. This is thus distinct from the

T sunctsugu-A rikawa (TA) state [1] which m ay be dubbed a non-collinear nem atic. We discuss a num ber of dierent properties of the ferro-nem atic state that m akes it attractive as an explanation of the properties of N iG a_2S_4 . We also point out dierences with the TA state that m ay be used to distinguish them in experiments.

M icroscopically the sim plest nearest neighbor antiferrom agnetic H am iltonian for a spin-1 triangular m agnet is expected to have a 120 spin order which is not seen in N iG a_2S_4 . Thus the H am iltonian m ust apparently involve other terms that destabilize the m agnetic order. This is further supported by the observation that bulk N iS₂ is close to a M ott transition and hence m ay have signi cant charge uctuations even when insulating. In N iG a_2S_4 the m agnetic layers consist of N iS₂ sheets – an e ective spin-only description of these m ay then plausibly have sizable interactions beyond the sim plest near neighbor antiferrom agnetic exchange.

M otivated by these considerations we will discuss the possibility of spin nem atic order in the fram ework of the m odel H am iltonian $\$

Here H₀ is the part of the Ham iltonian that is isotropic in spin space. H_a refers to small an isotropy term swhich may be important in pinning any possible long range order. S $_{\rm i}$ is the spin-1 operator at the site i of a two dimensional triangular lattice, and J;K 0. Biquadratic interactions of som e strength K will in general be present in spin-1 m agnets and are known to favor nem atic ordering.[6, 7] In the present case where the bilinear exchange J is frustrated the e ects of the biquadratic exchange are som ew hat enhanced. W e study the ground state of such a H am iltonian in the mean eld approxim ation and construct a zero temperature phase diagram. We nd that at values larger that a critical value of the bi-quadratic exchange K =J 1:15, there is a rst order transition from a magnetic (120 order) state to a ferro-nem atic ordered state. It is the latter that we propose to be ground state of the N iG a_2S_4 . We then study the expected properties of the ferro-nem atic by including uctuations beyond the mean eld.

TA also invoked biquadratic interactions to stabilize their non-collinear nem atic state. However, they chose K < 0. M icroscopically a biquadratic term may arise from a few di erent sources. First in an underlying twoband Hubbard type description of the e_{α} orbitals, the spin Ham iltonian arises describes the gain of kinetic energy due to virtual uctuations in a M ott insulating state. In this large-U perturbation theory the leading term is just the usual antiferrom agnetic exchange. At higher orders a variety of term swill be induced which include the biquadratic exchange. The sign is readily guessed by just considering two sites. In a total spin-2 con guration of the two sites, there can be no net gain of kinetic energy { so K must be such as to make total spin-2 a high energy state. This requires positive K . In some systems biquadratic interactions m ay also be induced due to spinphonon coupling. Indeed if an optical phonon couples to the spin bilinear in a bond, its e ects can be approxin ately accounted for by integrating it out in favor of a biquadratic term . Again this leads to a positive K . W e note that positive K tends to favor the ferro-nem atic state.

II. MEAN FIELD AND FLUCTUATIONS

We now proceed to obtain an approximate ground state of the isotropic part of the H am iltonian H $_0$ adopting a mean eld approach. Using the de nition (1), the H am iltonian H $_0$ can be rewritten as

ignoring constant term s. The K term is thereby seen to favor ferro-nem atic order. For small K we expect that the stable ground state will have spiral magnetic order which may give way to the ferro-nem atic state as K is increased. We therefore calculate the mean eld energies of spiral magnetic and ferro-nem atic states to obtain the mean eld phase diagram.

W e introduce the expectation values of the spin and nem atic operators respectively as hS $_{\rm i}{\rm i}$ and hQ $_{\rm i}$ i at each site and obtain the local H am iltonian at site i as

where runs over all the neighbors of the site i.

For the ferro-nem atic state the mean spin at any site

is zero, and the hQ i_i has the form

with n independent of the site index i. The mean eld value of q is readily calculated to be 1 corresponding to an energy per spin 2K. This energy must be compared with that of the spiral state.

For the spiral state the m can spin at the site i is taken to be of the form

with s_i a unit vector de ned at the site i with position vector \textbf{r}_i as

where m and q are, as yet undeterm ined, m agnitude and wave vector respectively, and es are two orthogonal basis vectors in the plane of spiral ordering. The spin ordering will induce a non-zero hQ_i i of the form

with Q satisfying $\frac{3}{2}m$ 1 Q 1. The four variational \mathfrak{S} parametersm; $q_x; q_y; Q$ are determined by minimizing the ground state energy of the mean eld H am iltonian (6).

Fig.1(a) shows the variation of the ground state energy as a function of K =J. The standard spiral state with 120 three sublattice order is obtained as the ground state for $(K = J)_c = \frac{24}{21}$ 1:143. Beyond this value the ferronem atic state is found to have lower energy. A study of the spin order parameter m (g.1(b)) shows that it jumps at the transition point indicating a rst order transition.

The structure of the uctuations beyond the mean eld in the spiral state are well-known and consist of three gapless spin wave modes. The ferro-nem atic state also breaks global spin SU (2) symmetry despite the absence of a frozen magnetic moment. Indeed the director n picks out a single direction in spin space. Thus this state will have gapless G oldstone modes corresponding to slow transverse uctuations of the director. A straighforward calculation shows the existence of two such gapless modes (corresponding to the two independent transverse directions in which the director can tilt) centered at wavevector k = 0. At low energies the dispersion is linear $! = c_i k$ jw ith velocity

III. PHYSICAL PROPERTIES OF THE FERRO-NEMATIC STATE

We now consider various physical properties of the ferro-nem atic state with an eye toward interpreting experiments in N iG a_2S_4 . In thinking about experiments it is important to allow for the possibility of small spin anisotropies that pin the nem atic order parameter. The




FIG.1: (color online) (a) Variation of the mean eld ground state energy E_g per site with K =J. N ote the \level crossing" at (K =J)_c = 1:143. (b) The variation of m with K =J. A rst order phase transition occurs at (K =J)_c = 1:143 at which m vanishes. (c) The variation of q with K =J. There is a jump in q at (K =J) = 0⁺, and another at the critical value of (K =J)_c = 1:143.

m ost important of these is single ion an isotropy that selects out a particular direction in spin space. Speci cally consider

with D > 0. The natural choice is to have the hard axis point perpendicular to the Ni-S layers. Note that this anisotropy couples directly to the ferro-nem atic order parameter. Thus a non-zero D even if small will generally pin the director to point perpendicular to the layers. Then in the ferro-nem atic state even though there is no magnetic order the spins will predom inantly uctuate parallel to the layers at low tem perature.

In the presence of a non-zero D the linear dispersion of the small k jdirector uctuation m odes will be cut-o -instead a gap of order D will develop as k ! 0. For the speci c heat this in plies that

so long as $T > T_D \qquad D$. In NiG $_2\mathrm{S}_4$, precisely this behavior is seen in the range $0.35~\mathrm{K} < T < 10~\mathrm{K}$. Thus the ferro-nem atic state can explain the low temperature speci c heat provided D is sm aller than about $0.35~\mathrm{K}$.

Let us now consider the magnetic susceptibility. In a single domain sample assuming that the director is xed the pure ferro-nematic state has strongly anisotropic magnetic susceptibility. The system is spin-gapped for magnetic elds aligned precisely along the nematic director, but has nite susceptibility for elds applied perpendicular to the director. A straightforward calculation shows that the susceptibility tensor (per site) is

where n is the direction of the nem atic director (now ferro-aligned at all sites), g is the gyrom agnetic ratio, and $_{\rm B}$ is the Bohrm agneton. If the director is not xed how ever and is free to rotate it would prefer to orient itself in a direction perpendicular to the external eld, and the susceptibility would be a constant. In the real system the detailed behavior therefore depends sensitively on the competition between the pinning due to the spin anisotropy D and the reorientation energy in a eld. At very low elds the pinning will win and the susceptibility will be anisotropic. At higher elds the pinning will be overcom e and the susceptibility will be a constant independent of the eld orientation. As the pinning energy D while the reorientation energy per site B² the

crossover occurs at a $\,$ eld strength B $_{\rm D}$

Therefore the energy scale associated with the depinning eld B_D is much larger than D since K $\,$ D (K is expected to be of the order of 100 K and D < 0.35 K), and thus B_D expected to be a measurably large $\,$ eld.

In a single crystal sample, the susceptibility at a measuring eld B B_D will therefore be strongly

anisotropic while at higher elds a constant susceptibility independent of eld orientation will be obtained. In polycrystalline sam ples (where the existing experiments have been done), due to the existence of domains with di ering orientations of the pining axis, the susceptibility will be independent of eld orientation even at low elds (< B_D). However as the eld increases beyond B_D domains with pinning direction parallel to the eld will reorient their directors thereby increasing the net m agnetization. We therefore expect signi cant increase in the m agnetization on eld strengths on the scale of B_D .

The constant low-T susceptibility and the T² speci c heat of the ferro-nem atic are consistent with the experim ents. However these properties are also shared by the TA state. W hat experiments may distinguish the two states? A useful and direct signature is the polarization of the spin uctuation spectrum . In the ferro-nem atic state (with director perpendicular to the N i-S planes) the spins should primarily uctuate in the directions along the planes at low tem perature. In the TA state on the other hand there should be no such strong preference for the spins to lie along the planes. Thus spin polarized neutron scattering experim ents on single crystals m ay be able to determ ine which (if either) of these two spin nem atic states is realized in N iG a_2S_4 . A nother useful experim ent that could distinguish the ferro-nem atic state from the TA state is the direction dependent susceptibility m easurem ent in single crystals. A snoted above a vanishing susceptibility is expected for a eld smaller than $B_{\rm D}$ along the pinning direction in the ferro-nem atic state, with a signi cant increase in the susceptibility when the eld exceeds $B_{\,\rm D}$. Field in a direction perpendicular to the pinning direction would obtain a constant susceptibility independent of the eld strength over eld scales of order B_D and above. On the other hand, in the TA state the anisotropy in the susceptibility is expected to be much smaller for small elds, and the susceptibility is expected to remain constant with increasing eld.

IV. CONCLUSION

In this paper we have proposed that N iG a₂S₄ m ay have a ferro-nem atic ground state characterized by a uniform quadrupole m om ent. W e discussed som e of the experim ental properties of this state and suggested experim ents to distinguish it from the alternate proposal of T sunetsugu and Arikawa[1]. In a simple model for a spin-1 triangular m agnet with bilinear and biquadratic term s, the latter promotes nem atic order. We suggest that the naturally expected sign for the biquadratic term prefers ferro-nem atic order and not the non-collinear nem atic. W e note that while many properties of either spin nematic state (speci c heat, susceptibility) resemble that seen in experiments neither proposal directly addresses the short ranged incommensurate spin uctuations inferred from powder neutron data. This feature of the spin uctuation spectrum presum ably depends on the details

of the m icroscopic spin H am iltonian which are not known at present.

Just prior to submission of this paper condm at/0605234 [8] appeared which also studies the ferronem atic state in the J-K spin-1 triangular magnet, and suggests this as a possible ground state in N iG a_2S_4 .
