Exchange Interaction, Entanglem ent and Quantum Noise Due to a Therm al Bosonic Field

We analyze the indirect exchange interaction between two two-state systems, e.g., spins 1=2, subject to a common nite-temperature environment modeled by bosonic modes. The environmental modes, e.g., phonons or cavity photons, are also a source of quantum noise. We analyze the coherent vs noise-induced features of the two-spin dynamics and predict that for low enough temperatures the induced interaction is coherent over time scales su cient to create entanglement. A nonperturbative approach is utilized to obtain an exact solution for the onset of the induced interaction, whereas for large times, a Markovian scheme is used. We identify the time scales for which the spins develop entanglement for various spatial separations. For large enough times, the initially created entanglement is erased by quantum noise. Estimates for the interaction and the level of quantum noise for localized in purity electron spins in SiGe type sem iconductors are given.

I. IN TRODUCTION

The idea that exchange of ferm ionic or bosonic excitations can lead to physical interactions in solid state is not new.¹ Recently, such induced interactions have received attention due to the possibility to experim entally observe quantum dynamics in nanoscale devices.^{2,3,4,5,6,7,8,9} In this work we explore the dynamics of two qubits (two two-state quantum systems), e.g., electron spins 1=2, placed a distance d apart, as they are entangled by com m on therm alized bosonic environm entwithout direct spatial electron wave function overlap. At the sam e tim e quantum noise originating from the same bosonic eld (e.g., phonons) ultimately erases the generated entanglem ent for large enought times. We dem onstrate that the indirect exchange interaction induced by the bosonic thermal eld¹⁰ can, in some cases, be comparable with other qubit-qubit couplings.

Extensive studies have been reported^{11,12,13,14} of the decay of quantum correlations between qubits subject to individual (local) or common environmental noise. In the presence of quantum noise, entanglement was shown to decay very fast and, in some cases, vanish at nite times.^{12,13} On the other hand, the idea that common bosonic as well as fermionic environment is able to entangle the qubits has also been advanced.^{10,11,15,16,17,18,19,20,21,22,23} For fermionic environment, this e ect has been attributed to Ruderm ann-K ittel-K asuya-Yosida (RKKY) type interactions^{15,17,18,19,20,22,23} and it has recently been experimentally demonstrated for two-qubit semiconductor nanostructures.^{4,5}

In this work, we investigate the two competing physical e ects of a therm alized bosonic environm ent (bath) in which two qubits are immersed. Speci cally, the induced interaction, which is electively a zero-temperature elect, and the quantum noise, originating from the same bath modes, are derived within a uniform treatment. We study the dependence of the induced coherent vs noise (decoherence) elects on the parameters of the bath modes, the qubit system, and their coupling, as well as on the geometry. Speci c applications are given for spins interacting with phonons in sem iconductors.

W e assume that the spins are identically coupled with the modes of a therm alized bosonic bath, described by H_B = $^{P}_{k;}$!_k; $a_{k;}^{y}$, $a_{k;}$, where we introduced the polarization index and set ~ = 1. W ith qubits represented as spins 1=2, the external magnetic eld is introduced in the qubit H am iltonian

as the energy gap between the up and down states for spins 1 and 2, with the spins labeled by the superscripts. A natural example of such a system are spins of two localized electrons interacting via lattice vibrations (phonons) by m eans of the spin-orbit interaction.^{1,24,25,26} A nother example is provided by atom s or ions in a cavity, used as two-state system s interacting with photons. For each type of phonon/photon, the interaction will be assum ed^{1,26,27,28} linear in the bosonic variables. The spin-boson coupling for two spins j = 1;2 has the form

Here, as before, the index accounts for the polarization and r_j is the position of jth spin. The overall system is described by the Ham iltonian $H = H_S + H_B + H_{SB}$.

O ur em phasis will be on com paring the relative im portance of the coherent vs. noise e ects of a given bosonic bath in the two-qubit dynam ics. W e do not include other possible two-qubit interactions in such com parative calculation of dynam ical quantities.

For the analysis of the induced exchange interaction and quantum noise for most time scales of relevance, it is appropriate to use the M arkovian approach^{28,29,30} that assumes instantaneous retherm alization of the bath modes. In Section II, we derive in a uni ed formulation the bath-induced spin-spin interaction and noise terms in the dynamical equation for the spin density matrix. The onset of the interaction for very short times is also investigated within an exactly solvable model presented in Sections III and IV. Speci cally, in Section IV, we discuss the onset and developm ent of the interaction H am iltonian, as well as the density matrix. It is shown that the initially unentangled spins can develop entanglem ent. We nd that the degree of the entanglem ent and the time scale of its ultim ate erasure due to noise can be controlled by varying several parameters, as further discussed for various bath types in Section V. Estimates for the induced coherent interaction in Si-G e type sem iconductors are presented in Section VI. The coherent interaction induced by phonons is, expectedly, quite weak. However, we nd that in strong magnetic elds it can become com parable with the dipole-dipole coupling.

II. COHERENT INTERACTION AND QUANTUM NOISE INDUCED BY THERMALIZED BOSONIC FIELD

In this section we present the expressions for the induced interaction and also for the noise e ects due to the bosonic environm ent, calculated perturbatively to the second order in the spin-boson interaction, and with the assumption that the environm ent is constantly reset to therm al. Speci c applications and examples are considered towards the end of this section, as well as in Sections V and VI.

The dynamics of the system can be described by the equation for the density matrix

In order to trace over the bath variables, we carry out the second-order perturbative expansion. This dynam ical description is supplemented by the Markovain assumption^{27,28,29,30} of resetting the bath to thermal equilibrium, at temperature T, after each in nitesinal time step, as well as at time t = 0, thereby decoupling the qubit system from the environment.^{27,28} This is a physical assumption appropriate for all but the shortest time scales of the system dynamics.^{31,32,33} It can also be viewed as a means to phenomenologically account in part for the random ization of the bath modes due to their interactions with each other (anharm onicity) in real system s. This leads to the master equation for the reduced density matrix of the qubits $_{\rm S}$ (t) = T $r_{\rm B}$ (t),

Analyzing the structure of the integrand in Eq.(2.2), one can obtain the equation with explicitly separated coherent and noise contributions, see Appendix A,

The expressions for the amplitudes ${}^{m}_{c}(d)$, ${}^{m}_{s}(d)$, ${}^{m}_{s}(d)$, and ${}^{m}_{s}(d)$ will be given shortly. The rst three terms following H_S constitute the interaction between the two spins. We will argue below that the leading induced exchange interaction is given by the rst added term, proportional to ${}^{m}_{c}(d)$. The last term corrects the energy gap for each qubit, representing their Lam b shifts.

The explicit expression for the noise term is very cumbersome. It can be represented concisely by introducing the noise superoperator M, which involves single-qubit contributions, which are usually dominant, as well as two-qubits term s

Here the principal values of integrals are assumed.

Note that ${}^{m}_{s}$ (d) appears only in the induced interaction H am iltonian in Eq.(2.4), whereas ${}^{m}_{c}$ (d), ${}^{m}_{s}$ (d), and ${}^{m}_{s}$ (d) enter both the interaction and noise terms. Therefore, in order to establish that the induced interaction can be signi cant for some time scales, we have to demonstrate that ${}^{m}_{c}$ (d) can have a much largerm agnitude than the maximum of the magnitudes of ${}^{m}_{c}$ (d), ${}^{m}_{s}$ (d), and ${}^{m}_{s}$ (d). The third and fourth terms in expression for the interaction (2.4) are comparable to the noise and therefore have no signi cant contribution to the coherent dynam ics.

Because of the complexity of the expressions for the noise term s within the present M arkovian treatment, in this section we will only compare the magnitudes of the coherent vs noise e ects. In the next section, we will discuss a di erent m odel for the noise which will allow a m ore explicit investigation of the time dependence.

For the rest of this section, we will consider an illustrative one-dimensional (1D) example favored by recent experiments,^{4,5} leaving the derivations for higher dimensions to Sections V and VI. We comment that the 1D geometry is also natural for certain ion-trap quantum - computing schemes, in which ions in a chain are subject to C culom b interaction, developing a variety of phonon-mode lattice vibrations.^{21,34,35}

In 1D geometry we allow the phonons to propagate in a single direction, along d, so that k d = k j d j. Here, for de niteness, we also assume the linear dispersion, $!_k = c_s k$, since the details of the dispersion relation for larger frequencies usually have little e ect on

the decoherence properties. Furtherm ore, we ignore the polarization, g_{k}^{m} ! g^{m} (!). Another reason to focus on the low-frequency modes is that an additional cuto $!_{\rm c}$ resulting from the localization of the electron wave functions, typically much smaller than the Debye frequency, will be present due to the factors g^m (!). The induced interaction and noise terms depend on the am plitudes $_{c}^{m}$ (d), $_{c}^{m}$ (d), $_{s}^{m}$ (d), and $_{s}^{m}$ (d), two of which can be evaluated explicitly for the 1D case, because of the -functions in Eqs. (2.9, 2.10). However, to derive an explicit expression for $\begin{smallmatrix} m \\ c \end{smallmatrix}$ (d) and $\begin{smallmatrix} m \\ s \end{smallmatrix}$ (d), one needs to specify the !-dependence in j_{2}^{m} $(!)_{1}^{2}$. For the sake of simplicity, in this section we approximate j^m (!) j^2 by a linear function with superim posed exponential cuto . For a constant 1D density of states $(!) = V=2 c_s$, this is the 0 hm ic-dissipation condition,²⁷ i.e.,

The expression for $_{s}(d)$ could not be obtained in closed form . However, numerical estimates suggest that $_{s}(d)$ is comparable to $_{c}^{m}(d)$. At short spin separations d, $_{s}(d)$ is approximately bounded by $_{1}^{m}$ ln $\frac{1}{1_{c}} \exp(-\frac{jHj}{C_{a}})$, while at lager distances it may be approximated by $_{1}^{m}$ $\frac{1}{2} \sin \frac{jHj}{C_{a}}$ och $\frac{1}{2k_{B}T}$. The level of noise may be estimated by considering the quantity

The interaction Ham iltonian takes the form

This induced interaction is temperature independent. It is long-range and decays as a powerlaw for large d. For the super-O hm ic case, n > 1, one obtains sim ilar behavior, except that the interaction decays as a higher negative power of d, as will be shown in Section V.

If the noise term were not present, the spin system would be governed by the Ham iltonian $H_{\rm S}$ + $H_{\rm int}$. To be speci c, let us analyze the spectrum, for instance,




FIG.1: Short-time correction to the induced exchange interaction for the 0 hm ic case. The arrow shows the order of the curves for increasing $!_{c}ji_{fcs} = 0;1;...;10$.

for $\frac{x}{1} = \frac{y}{1}$, $\frac{z}{1} = 0$. The two-qubit states consist of #"i)= 2 and the split triplet J"i, the singlet (j"#i 4 ×, , $E_1 = 4 c^{x}$, $E_3 = c^{x}$, respectively. The en- $E_0 =$ ergy gap \mathbf{E}_1 \mathbf{E}_2 j between the two entangled states is de ned by 4 $_{c}^{x}$ (= 4 $_{c}^{y}$). In the presence of noise, the oscillatory, approximately coherent evolution of the spins can be observed over several oscillation cycles provided that $2 \stackrel{\text{m}}{_{1}} !_{c} = [1 + (!_{c}jd_{j} = c_{s})^{2}] > M$. The energy levels will acquire e ective width due to quantum noise, of order $\frac{m}{c}$ (d). This interplay between the interaction and noise e ects is further explored within an exactly solvable model in the next section.

III. EXACTLY SOLVABLE MODEL

In this section, we consider a model appropriate for short times,^{31,32,33} which does not invoke the M arkovian assumption of the rethermalization of the bath modes. This model is particularly suitable for investigating the onset of the system's dynamics. W hile the noise e ects are quantitatively di erent in this model, the qualitative interplay of the coherent and noise e ects in the dynamics is the same as in the M arkovian approach. Furtherm ore, we will show that the induced interaction is consistent with the one obtained within M arkovian approach in the previous section.

W epoint out that, due to the instantaneous retherm alization assumption (resetting the density matrix of the bath to thermal), in the Markovain formulation it was quite natural to assume that the bath density matrix is also thermal at time t = 0; the total density matrix retained an uncorrelated-product form at all times. In the context of studying the short-time dynamics, in this section the choice of the initial condition must be addressed more carefully. In quantum computing applications, the initially factorized initial condition has been widely used for the qubit-bath system ^{31,32,33}




FIG.2: D evelopm ent of the concurrence as a function of time, calculated with $\frac{1}{1} = 1=20$ and $k_B T = !_c = 1=20$. The curves correspond to various spin-spin separations, as can be read o the left inset, which shows the distribution of the concurrence in the jdjt plane. The right inset presents the dynamics of the diagonal density matrix elements P_{**} h"" j_s j""i, etc., on the same time scale.

This choice allows comparison with the Markovian results, and is usually needed in order to make the shorttime approximation schemes tractable,³³ speci cally, it is necessary for exact solvability of the model considered in this and the next sections.

A som ew hat m ore \physical" excuse for factorized initial conditions has been the following. Quantum com putation is carried out over a sequence of tim e intervals during which various operations are perform ed on individual qubits and on pairs of qubits. These operations include control gates, m easurem ent, and error correction. It is usually assumed that these \control" functions, involving rather strong interactions with external objects, as com pared to interactions with sources of quantum noise, erase the fragile entanglem ent with the bath m odes that qubits can develop before those tim e intervals when they are \left alone" to evolve under their internal (and bath induced) interactions. Thus, for evaluating relative im portance of the quantum noise e ects on the internal (and bath induced) qubit dynam ics, which is our goal here, we can assume that the state of qubit-bath system is \reset" to uncorrelated at t = 0.

It turns out that the resulting m odel is exactly solvable for the Zeem an splitting = 0, and provided that only a single system operator enters the expression (1.2) for the interaction. Here we take $\frac{y}{n} = \frac{z}{n} = 0$, while $\frac{x}{n} \in$ 0. We derive the exact solution and demonstrate the emergence of the interaction (2.17).

W ith the above assumptions, one can utilize the bosonic operator techniques²⁹ to obtain the reduced density matrix for the system (12, 1.3),

Calculating the sums by converting them to integrals over the bath-mode frequencies ! in Eqs.(3.3) and (3.4), assuming the Ohmic bath n = 1 for T > 0 one obtains a linear in time t large-time behavior for both the temperature-dependent real part and for the imaginary part. The coe cient for the former is kT, whereas for the latter it is !_c. For super-Ohmic models, n > 1, the real part grows slower, as was also noted in the literature.^{28,31,36}

Let us rst analyze the e ect that the imaginary part of L $_{\rm o}$ (t) has on the evolution of the reduced density matrix, since this contribution leads to the induced interaction. If the realpart were not present, i.e., om itting Eq.(3.3) from Eqs.(3.2), (3.4), and (3.6), we would obtain the evolution operator in the form exp[iH_{int}t iF (t)t]. The interaction H_{int} comes from the rst term

It commutes with H int and therefore could be viewed as the initial time-dependent correction to the interaction. In fact, it describes the onset of the induced coherent interaction; note that F (0) = $H_{\rm int}$, but for large times

F (t) $\sum_{n=1}^{n} \sum_{c=1}^{n} (1, c)^{n}$. In Figure 1, we plot F (t), de ned via F (t) = F (t) $\sum_{x=1}^{n} \sum_{x=1}^{n} c$, for the 0 hm ic case as a function of time for various spin-spin separations.

Let us now explore the role of the decoherence term (3.3). In the exact solution of the short-time model, the bath is therm alized only initially, while in the perturbative M arkovian approximation, one assumes that the bath is reset to therm alafter each in nitesim altime step. Nevertheless, the e ect of the noise is expected to be qualitatively similar. Since the short-time model o ers an exact solution, we will use it to compare the coherent vs noise e ects in the two-spin dynam ics. W e evaluate the concurrence $r^{37,38}$ which measures the entanglem ent of the spin system and is monotonically related to the entanglem ent of form ation.^{39,40} For a m ixed state of two qubits, s, we rst de ne the spin-ipped state, $\sim_{\rm S} = p \frac{1}{p} \frac{2}{y} \frac{1}{y} \frac{2}{y} \frac{1}{y}$, and then the Herm it in operator $R = \frac{p_{p} \frac{y' y - p_{p} y}{s - s}}{s - s}, w \text{ ith eigenvalues} \quad i= 1, 2, 3, 4. In Figure 2, we plot the concurrence as a function of time and the spin-spin separation, for the (initially unentangled) state j'''i, and n = 1. One observes decaying periodic oscillations of entanglement. We should point out that the measure of entanglement we use here | the concurrence | provides the estimate of how much entanglement can be constructed provided the worst possible scenario for decomposing the density matrix is realized; see Refs. 37, 38 for details and de nitions. Therefore, one expects the entanglement that one can make use of in quantum computing to be no smaller than the one presented in Figure 2. In the next section, additional quantities are considered, namely, the density matrix elements, which characterize the degree of coherence in the system's dynamics.

IV. ONSET OF THE INTERACTION AND DYNAM ICS OF THE DENSITY MATRIX

Let us now investigate in greater detail the onset of the induced interaction, the time-dependence of which is given by F (t). In Figure 1 we have shown the magnitude of F (t), as a function of time for various qubit-qubit separations and n = 1. The correction is initially nonmonotonic, but decreases for larger times as mentioned above. The behavior for other non-0 hm ic regimes is initially more complicated, how ever the large time behavior is similar.

It may be instructive to consider the time dependent correction H_F (t) to the interaction Ham iltonian during the initial evolution, corresponding to F (t). Since F (t) commutes with itself at di erent times, as well as with H_{int} , it generates unitary evolution according to




FIG. 3: The magnitude of the time-dependent H am iltonian corresponding to the initial correction as a function of time and distance. The O hm ic (n = 1) case is shown. The inset demonstrates the onset of the cross-qubit interaction on the same time scale.

where u() = cos[n arctan()]=[1 + 2]¹⁼². The above expression is a superposition of two waves propagating in opposite directions. In the O hm ic case, n = 1, the shape of the wave is simply u() = 1=(1 + 2). In Figure 3, we present the am plitude of H_F (t), de ned via H_F (t) = H_F ${}^{1}_{x}$, as well as the sum of H_{int} and H_F (t), for n = 1. O ne can observe that the \onset wave" of considerable am plitude and of shape u() propagates once between the qubits, \switching on" the interaction. It does not a ect the qubits once the interaction has set in.

To understand the dynam ics of the qubit system and its entanglem ent, let us again begin with the analysis of the coherent part in Eq.(3.2). A fler the interaction, H int, has set in, it will split the system energies into two degenerate pairs $E_0 = E_1 = H_{int}$ and $E_2 = E_3 = H_{int}$. The wave function is then j (t)i = exp(iH_{int}t)j (0)i. For the initial \up-up" state, j (0)i = j"'i, it develops as j (t)i = j"'icosH intt + j##iisinH intt, where H int = H int $\frac{1}{m} \frac{2}{m}$. One can easily notice that at times $t_E =$ =4H int; 3 =4H int;::; maxim ally entangled (B ell) states are obtained, while at times $t_0 = 0$; =2H int; =H int;::; the entanglem ent vanishes; these special times can also be seen in Figure 2. The coherent dynam ics obtained with the M arkovian assumption is the same.

However, the coherent dynam ics just described is only approximate, because the bath also induces decoherence that enters via Eq.(3.3). The result for the entanglement is that the decaying envelope function is superimposed on the coherent oscillations described above. The magnitudes of the rst and subsequent peaks of the concurrence are determined only by this function. As tem per-

ature increases, the envelope decays faster resulting in low er values of the concurrence; see the inset in Figure 2. A lthough in the M arkovian approach, presented in Section II, the noise is quantitatively di erent, one expects qualitatively sim ilar results for the dynam ics of entanglem ent.

Note also that nonmonotonic behavior of the entanglement is possible only provided that the initial state is a superposition of the eigenvectors of the induced interaction with more than one eigenvalue (for pure initial states); see Eqs.(3.2)-(3.4). For example, taking the initial state (#"i+ J"#i)= 2, in our case would only lead to the destruction of entanglement, i.e., to a monotonically decreasing concurrence, sim ilar to the results of R efs. 12, 13.

For the model that allows the exact solution, i.e., for $H_s = 0$, one can notice that there is no relaxation by energy transfer between the system and bath. The exponentials in Eqs.(3.2), with (3.3), suppress only the o-diagonalmatrix elements, i.e., those with \notin ⁰. It happens, however, that at large times the d-dependence is not in portant in Eq.(3.3), and ReL \circ (t! 1) vanishes for certain values of \notin ⁰. In the basis of the qubit-bath interaction, $\frac{1}{x} \frac{2}{x}$, the limiting t! 1 density matrix for our initial state (j""i) is $\frac{1}{4} + \frac{1}{4}$ j+ ih + j+ $\frac{1}{4}$ j + ih+ j, which takes the form

in the basis of states J^{μ} , J^{μ} , J^{μ} , J^{μ} , and J^{μ} . The significance of such results, see also Ref. 11, is that in the model with H_S = 0 and nonretherm alizing bath not all the o -diagonalm atrix elements are suppressed by decoherence, even though the concurrence of this mixed state is zero.

V. OHM IC AND SUPER-OHM IC BATH MODELS IN GENERAL DIMENSION

Let us generalize the results of the previous sections obtained prim arily for the 0 hm ic bath m odel and 1D geom – etry. In Section II, we considered the 1D case with 0 hm ic dissipation with the M arkovian approach. In the general




FIG. 4: Dynam ics of the occupation probabilities for the states j"i, j"#i, j"#i, and j##i. The param eters are the same as in Figure 2. The inset shows the structure of the reduced density matrix (the nonshaded entries are all zero).




FIG.5: Dynamics of the inverse-diagonal matrix elements for the same system as in Figure 4. Note that $\lim_{\#', \eta' \neq 0} = 0$.

case, let us consider the M arkovain m odel and, again, assume that =! c is small. We will also assume that the absolute square of the m th component of the spin-boson coupling, when multiplied by the density of states, can be modelled by m_{n_m} ! n_m exp(!=!_c); see Eq.(2.12). The integration in Eq.(2.8) can then be carried out in closed form for any n_m = 1;2;:::. The induced interaction (2.17) is thus generalized to

W ith the appropriate choice of parameters, the result for the induced interaction, but not for the noise, coincides with the expression for H $_{\rm int}$ obtained within the short-time model. From Eq.(5.1) one can infer that the elective interaction has the large-distance asymptotic behavior jdj $^{n_{\rm m}}$, for even $n_{\rm m}$, and jdj $^{n_{\rm m}}$ 1 , for odd $n_{\rm m}$.

Let us now consider the noise term s. The amplitudes (2.9, 2.10), entering the decoherence superoperator, de-




FIG.6: The magnitude of the induced exchange interaction H am iltonian for the O hm ic $n_m = 1$ and super-O hm ic $n_m = 2;3;4;5$ baths.




FIG.7: The magnitude of the noise for the Ohm ic $n_m = 1$ and super-Ohm ic $n_m = 2$;3;4;5 baths, for $2k_BT = !_c = 0.01$.

pend on $n_{\rm m}$ only via the prefactor (=! $_{\rm c})^{n_{\rm m}}$. The remaining amplitude (2.11) has to be calculated num erically. The spin-spin separation up to which the \coherent" e ects of the induced interaction can be observed in the tim e-dependent dynam ics, is de ned by com paring the magnitudes of the interaction and noise amplitudes. It transpires that the comparison of the amplitude in Eq.(2.17) vs Eq.(2.16) for $n_m = 1$, also su ces for an approxim ate estim ate for the super-0 hm ic case, as long as $\frac{m}{s}$ (d) does not dom in the in M. In Figure 6, we plot the am plitudes of Eq.(5.1), i.e., $H_{int} = Tr(H_{int} = \frac{1}{m} = \frac{2}{m})=4$, for di erent values of $n_{\rm m}$. Figure 7 shows the magnitude of the noise super-operator. Figures 6 and 7 suggest that the noise am plitudes can be made su ciently small with respect to the induced interaction, at small values of $=!_{c}$, for any n_m . We note that for quantum com puting applications one usually assum as the regim a k_B T ! c. The tem perature dependence in Fig. 7 becomes insignicant for $k_B T =$ 1, which is approximately to the right of $=!_{c}$ 0:01. To the left of 0:01, by reducing the tem perature one can fur-=! . ther reduce the values of the noise am plitudes even for small .

In higher dimensions the structure of g_{k}^{m}

in the k-space becomes important. P rovided !k; is nearly isotropic, the integrals entering Eqs.(2.8)-(2.11) will include (in 3D) a factor $\begin{array}{ccc} R_{2} & R\\ 0 & d' & 0 & \sin & g_{k}^{m} \end{array}$ cos(kjdjcos), which can be written as [f₁^m (!;kjd)) f² (!;kjd)@=@jdjcos(kjd), e.g., Eqs. (B 2, B 3) in Appendix B. W hen the dependence of f_1^m ; f_2^m on kjdj is negligible, the interaction is simply H_{int} ! H_{int} j_{nm g! a} (@=@jdj)H_{int}j_{nm g! b}, where a and b are sets of three integers representing the !-dependence of f_1^m (!;kjdj) and f_2^m (!;kjdj). O therwise, a more complicated dependence on jdj is expected. The noise superoperator can be treated similarly. As a result one can see that the form of the interaction depends more on the structure of g_{k}^{m} . than on the dimensionality via the phonon density of states. However, reduced dimensionality in the k-space might allow for better control over the magnitude of the interaction by external potentials that modify the spin-orbit coupling.

VI. PHONON INDUCED COHERENT SPIN-SPIN INTERACTION VS NOISE FOR P-DONOR ELECTRONS IN SIAND Ge

As a speci c example, let us consider a model of two localized in purity-electron spins of phosphorus donors in a SiG e type sem iconductor, coupled to acoustic phonon modes by spin-orbit interaction. In what follows, we rst obtain the coupling constants $g_{k_1}^m$, entering Eq.(1.3), which de ne the interaction and noise amplitudes. A brief discussion is then o ered on the possibility of having an 0 hm ic bath model realized in 1D channels. The rest of the present section is devoted to calculations of the induced interaction and noise in 3D bulk material. A comparison with the dipole-dipole spin interaction is given.

A veraging the spin orbit Ham iltonian over the localized electron's wave function, one obtains the spinorbit coupling in the presence of magnetic eld H = $(H_x; H_y; H_z)$ in the form

where $_{\rm B}$ is the Bohr m agneton. Here the tensor $g_{m\,1}$ is sensitive to lattice deformations. It was show n^{25} that for the donor state which has tetrahedral sym m etry, the H am iltonian (6.1) yields the spin-deformation interaction of the form

Here cp. denotes cyclic permutations and is the elective dilatation. The tensor " $_{ij}$ already includes averaging of the strain with the gradient of the potential over the donor ground state wave function.




FIG. 8: The magnitude of the induced spin-spin interaction for a 3D SiG e type structure: The dom inant interaction am – plitude, which is the same for the x and y spin components, is shown. The arrow indicates increasing b values for the curves shown, with b = 0.03, 0.09, 0.15, 0.21, 0.27, 0.33. The inset estimates the level of the noise (for $2k_B T a_B = c_s = 0.01$): The bottom curve is $\frac{m}{c}$ (0), with m = x;y. For b. 0.4, the am – plitude $\frac{m}{s}$ (d) can be comparable, and its values, calculated numerically for 0 r 50, are shown as long as they exceed $\frac{m}{c}$ (0), with the top curve corresponding to the maximum value, at r = 0.

A s before, let us assume that the separation d, as well as the magnetic eld, are directed along the z-axis, for an illustrative calculation. Then the spin-deformation interaction H am iltonian simpli es to

Here a_B is half the elective Bohr radius of the donor ground state wave function. In an actual Si or G e crystal, donor states are more complicated and include corrections due to the symmetry of the crystal matrix including the fast B loch-function oscillations. However, the wave function of the donor electrons in our case is spread over several atom ic dimensions (see below). Therefore, it su ces to consider \envelope" quantities. Thus, the spin-phonon Ham iltonian (12, 13) coupling constants will be taken in the form

Let us rst consider a 1D channel geom etry along the z direction. This will give an example of an Ohm ic bath m odel discussed towards the end of Section II. In 1D channel the boundaries⁴² can approxim ately quantize the spectrum of phonons along x and y, depleting the density of states except at certain resonant values. Therefore, the low-frequency e ects, including the induced coupling and quantum noise, will become e ectively oned in ensional, especially if the e ective gap due to the con nem ent is of the order of ! c. A sm entioned earlier, this frequency cuto comes from Eq.(6.5), namely, it is due to the bound electron wave function localization. A channel of width com parable to a will be required. This, how ever, may be di cult to achieve in bulk SiorGewith the presentday technology. O ther system s m ay o er m ore im m ediately available 1D geom etries for testing sim ilar theories, for instance, carbon nanotubes, chains of ionized atom s suspended in ion traps,^{21,34,35} etc. In our case, the longitudinal acoustic (LA, j) phonons of the one-dim ensional spectrum will account for the $g_{k,k}^z$ component of the coupling, whereas the transverse acoustic (TA, ?) phonons will a ect only the x and y spin projections.

O ne can show that the contributions of the crossproducts of coupling constants, $g_{k,j}^m$, $(g_{k,j}^m)$ with $m \notin m^0$, to quantities of interest vanish. The diagonal combinations are

W ith our usual assumption for the low-frequency dispersion relations $!_{k_z,k}$ qk_z and $!_{k_z,i}$ qk_z , the expressions (6.7) lead to the Ohm ic bath model discussed at the end of Section II. The shape of the frequency cuto resulting from Eq.(6.7) is not exponential. How-ever, to estimate the magnitude of the interaction and noise one can utilize the results obtained earlier for the 1D Ohm ic bath model with exponential cuto . The coupling constants in Eqs.(2.17) and (2.16) should, then, be taken as

where S is a cross section of the channel, and the cuto is $!_c ! c_k = a_B$ for the z component, and $!_c ! c_r = a_B$ for the x and y components. Considering Sias an exam – ple, we arrive at an approxim ately adiabatic H am iltonian $\begin{pmatrix} z \\ 1 \end{pmatrix}$ with 0 hm ic-type coupling. The dynam ics of the concurrence, then, is qualitatively similar to the one shown on Fig. 2, with the peak entanglement 0:4 as well. The coupling constant $\frac{z}{1}$, how ever, is signi cantly sm aller due to the weakness of the spin-orbit coupling of P impurity electrons in Si, which results in low magnitude of the induced interaction (and the noise due to the same environment), and slightly modi es the shape of the concurrence.

In the 3D geometry, let us consider for simplicity only the LA phonon branch, ! k=jkj and assume an isotropic dispersion $!_{k}$; $= c_s jkj$. The expression for the coupling constants is then

The cross term s, with m f n, of the correlation functions T $r_B ~X_m^{~j} X_n^{~i}$ (t) $_B$, see Eq.(A 3) in Appendix A, depend on the combination $g_{k_1}^m \left(g_{k_1}^n\right)$, which is always an odd function of one of the projections of the wave vector. The nondiagonal term s thus vanish, as mentioned in Appendix A.

Integrating Eqs.(2.8) and (2.9) with Eq.(6.9), see Appendix B, one can demonstrate that decoherence is dom - inated by the individual noise terms for each spin, with the typical amplitude

The interaction amplitude m_c (d) and, therefore, the induced spin-spin interaction, has inverse-square power-law asymptotic form for the x and y spin components, with a superim posed oscillation, and inverse-fth-power-law decay for the z spin components

Here $r = jd j=a_B$ and $C_A = A^2 C_B = B^2$. At sm all distances the interaction is regular and the amplitudes converge to constant values, see F igure 8. The complete expressions for $\frac{m}{c}$ (d) and $\frac{m}{c}$ (d) are given in Appendix B.

In Figure 8, we plot the amplitudes of the induced spin-spin interaction (6.11, B.4, B.7) and noise for different values of the spin-spin separation and b, for electron impurity spins in 3D Si-Ge type structures. The value of b can be controlled via the applied magnetic eld, $b = {}_{B}H_{z}g a_{B}=c_{s}$. The temperature dependence of the noise is insigni cant provided $2k_{B}T = 1$.

A typical value^{24,25,41} of the e ective Bohr radius in Si for the P-donor-electron ground state wave function is $2a_B = 2.0 \text{ nm}$. The crystal lattice density is $= 2.3 \quad 10^{4} \text{ kg/m}^{3}$, and the g-factor g = 1.98. For an order-of-m agnitude estimate, we take a typical value of the phonon group velocity, $c_s = 0.93 \quad 10^{4} \text{ m/s}$. The spin-orbit coupling constants in Si are^{24,25,41} A² 10^{6}




FIG. 9: The magnitudes, measured in units of s¹, of the induced spin-spin interaction, the EM coupling strength, and the level of noise for P-in purity electron spins in Ge. Here H_z = 3 10^4 G, and low temperature, $2k_BT = 1$, was assumed.

and B^2 10¹. The resulting interaction constants in Eqs.(6.10, 6.11) are $C_{\rm B}$ = 7:8 s 1 and $C_{\rm A}$ = $10^3 C_{\rm B}$. In the Ge lattice, the spin-orbit coupling is dom inated by the non-diagonal term $s_{\prime}^{24,25,41}$ A² 0 and B^2 10°. The other parameters are $2a_B = 4.0 \text{ nm}$, = 5:3 10^3 kg/m^3 , $c_s = 5.37$ 10^3 m/s , and g = 1.56. This results in a much stronger transverse com ponent interaction, $C_B = 1:3 \quad 10^7 \text{ s}^{-1} \text{ and } C_A$ 0. In both cases the magnetic eld was taken H $_z$ = 3 10⁴ G . In the above estimations, one could use various experimentally suggested values for the parameters, such as, for instance, a_B . This will not a ect the results signi cantly.

As mentioned is Section II, the obtained interaction (6.11) is always accompanied by noise coming from the same source, as well as possibly by other, direct interactions of the spins. When the electron wave functions overlap is negligible, the dominant direct interaction will be the dipole-dipole one

The comparison of the two interactions and noise is shown in Figure 9. We plot the magnitude of the electrom agnetic induced interaction (6.11, B.4, B.7), the electrom agnetic interaction (6.12), measured by $H_{EM} = \begin{pmatrix} 0 & 2 \\ B & 2 \end{pmatrix}^3$, and a measure of the level of noise, for P-donor electron spins in Ge. It transpires that the induced interaction can be considerable as compared to the electrom agnetic spin-spin coupling. How ever the overall coherence-to-noise ratio is quite poor for Ge. In Si, the level of noise is lower as compared to the induced interaction. How ever, the overall amplitude of the induced term s compares less favorably with the electrom agnetic coupling.

In conclusion, we have studied the induced indirect exchange interaction due to a bosonic bath which also introduces quantum noise. We demonstrated that it can create substantial two-spin entanglement. For an appropriate choice of the system parameters, speci cally, the spin-spin separation, for low enough temperatures this entanglem ent can be maintained and the system can evolve approximately coherently form any cycles of its internal dynamics. For larger times, the quantum noise effects will eventually dominate and the entanglem ent will be erased.

Estimates for P-impurity electron spins in Si and Ge structures have demonstrated that the induced interaction can be comparable to the dipole-dipole spin interaction. One can also infer that this phonon-mediated interaction in the bulk (3D) Ge is not very elective to be used for quantum computing purposes, i.e., to entangle qubits. This is due to poor coherence to noise ratio. Therefore, the use of Sim ay be favored, despite the fact that it has weaker spin-phonon coupling. Indeed, the noise am plitudes for Si are signi cantly smaller then the induced exchange interaction, where the latter is dom inated by the adiabatic term. The situation is expected to be further improved for systems with reduced dimensionality for phonon propagation.

APPENDIX A:DERIVATION STEPS FOR THE INDUCED INTERACTION AND NOISE

An important assumption required for the validity of the M arkovian approach concerns the time scale of the decay of the bath correlations introduced in Eqs.(A 2) and (A 3) below. By constantly resetting the bath to therm al, one implies that this time scale is signi cantly shorter than the dynam ical system time scales of interest. The M arkovian treatment, considered here, is, therefore, valid at all but very short times. The short-time dynamics, for the time scales down to order 1=! c, requires a di erent approach.^{31,32,33} N ote that one usually assumes that ! c

Here we review some of the steps that lead from the M arkovian equation for the density m atrix (2.2), to the expressions for the induced interaction and quantum noise.
