H ard x-ray spectroscopy in N a_x C oO $_2$ and superconducting N a_x C oO $_2$ yH $_2$ O: A view on the bulk C o electronic properties

The electronic properties of C o in bulk N $a_{0:7}C \circ O_2$ and the superconducting hydrated com pound N $a_{0:35}C \circ O_2$ yHO have been investigated by x-ray absorption spectroscopy (XAS) and resonant inelastic x-ray scattering (RIXS) using hard x-rays. The XAS spectra at the C o K -edge were m easured in both com pounds with two di erent polarization directions. The changes in the XAS spectra upon hydration and their polarization dependence are well accounted for by linear m u n-tin orbital calculations in the local density approximation. The underlying electronic structure indicates the strong hybridization between the C o 3d and O 2p states in both com pounds, while the electron localization is enhanced in the hydrated com pound due to the increase of the C o-C o interplanar distance. The C o K pre-edge further highlights the splitting of the d band as a result of the crystal eld e ect and dem onstrates the C o valency increase when N $a_{0:7}C \circ O_2$ is hydrated. The R IX S spectra m easured at the C o K -edge show an energy loss feature around 10 eV in both com pounds in fair agreem ent with the calculated dynam ical structure factor. The R IX S feature is associated to a dam ped plasm on excitation.

I. IN TRODUCTION

The recent discovery of superconductivity in Na_xCoO_2 yHO (Ref. 1) has renewed interest in layered cobaltates. These com pounds have been extensively studied in the past for their large therm celectric power. But the novel hydrated material, the rst to show superconductivity, calls for a new look at their electronic properties. The parent compound N a_x C oO 2 has a hexagonal structure (space group 194; P 6₃/mm c) consisting of alternating Na- and CoO₂-layers stacked along the c-axis. The superconducting compound is obtained by the hydration of the parent compound whose main structural e ect is the dramatic increase (about a factor of two) of the Co-Co inter-planar distance upon intercalation of ice-like sheets. The critical tem perature T_c is observed to be weakly dependent on Na doping, with a maximum at 5 K for $x = 0.35^{2,3}$.

The strong anisotropy of the resistivity between the inplane and the out-of-plane directions reported in these com pounds indicates quasi two-dimensional electronic properties4,5 and underlines the important role played by the Co-O planes, in particular for superconductivity. The Co-O planes form a spin frustrated triangular lattice of edge sharing CoO₆ octahedra. This strongly di ers from the high-T_c cuprates, where the Cu-O planes are arranged in a square lattice of corner sharing oxygen octahedra. Furtherm ore in cobaltates, the C o valency is supposedly m ixed between $4+(3d^5)$ and $3+(3d^6)$ depending on the N a content x, but the exact valent state of C o is ill-de ned: Early works have indicated that the average Co valency n in the hydrated compound, as estimated from chemical titration, departs from the (n = 4 x)value expected from charge neutrality.^{6,7} The di erence has been attributed to the presence of H_30^+ ions in the Na layers in the hydrated compound. In contrast, recent nuclear magnetic resonance data have showed that the Covalence state is insensitive to hydration and only depends on the N a content.⁸ A statem ent con m ed lately by powder neutron di raction.9

The indeterm inate Co valency in these materials reveals the diculty to properly characterize the Co d states and their hybridization with the neighboring

atom s. In the presence of the crystal electric-eld in the octahedral environment, the Co 3d level is split into a triply degenerated t_{2q} level and a doubly degenerated e_q level. The trigonal distortion of the CoO₆ octahedra lifts the degeneracy of the t_{2g} states to give one a_g and two e_{α}^{0} levels. A critical issue related to the Co properties is the supposed existence of \hole-pockets" form ed by these e_{α}^{0} electrons at the Ferm i surface. The nesting conditions of these hole-pockets m ight be responsible for the onset of superconductivity in the hydrated m aterial.^{10,11} This Ferm i surface topology was rst proposed by density functional theory calculations in the local density approach $(LDA)^{12,13}$ and later con m edin presence of dynam ical C oulom b correlations.¹⁴ B ut no such Ferm isurface topology has been observed in photoem ission m easurem ents.^{15,16} M ore recently, a calculation using a multi-orbitalH ubbard m odel in the H artree{Fock and strong-coupling Gutzwiller approximations showed the absence of hole-pockets in the Ferm i surface,¹⁷ in better agreem ent with experim ents.

O ne reason for the lack of consistency in the characterization of the C o electronic properties lies in the sensitivity of the materials to hum idity. Surface-clean sam – ples are di cult to prepare and speci c studies of the bulk materials become necessary. In this paper we report on the electronic structure of both the hydrated and non-hydrated com pounds, using com plem entary hard xray spectroscopies at the C o K -edge, nam ely x-ray absorption spectroscopy (X A S) and resonant inelastic x-ray scattering (R IX S). These high-energy probes are selective of the cobalt properties and provide bulk sensitive data. The experim ental X A S and R IX S spectra will be com pared to spectra obtained from rst-principles calculations.

The polarization-dependent XAS spectra at the CoK – edge (1s ! 4p transition) are discussed in Sec. II. The XAS data are analyzed in the light of simulations based on the electronic density of states (DOS) given by linear mu n-tin orbital (LMTO) calculations. In Sec. III, we address the low-energy excitations observed by RIXS at the CoK -edge. The results are tested against calculations of the optical absorption spectrum derived from the com puted DOS.Conclusions are drawn in Sec. IV.

II. COK-EDGE X-RAY ABSORPTION

A. Experim ents

The experiments were performed on single-crystals of $Na_{0:35}CoO_2$ 1:3HO (NCOH) and $Na_{0:7}CoO_2$ (NCO). The samples were prepared in the form of thin plates (0.5mm thick, 1:5 0:6mm² for NCOH and 1 2mm² for NCO) with the c-axis normal to the sample surface. The CoK -edge XAS spectra were acquired at the BM 30 beam line at the European Synchrotron Radiation Facility (Grenoble), in total uorescence yield mode. Details of the experimental setup have been de-

scribed elsewhere.¹⁸ The incident energy is selected by a double crystal Si(220) m onochrom ator providing a total energy bandwidth of 450 m eV. The beam was focused in the horizontal plane by the second m onochrom ator crystal and in the vertical plane thanks to a Rhcoated m irror, located downstream. The spot size was 280 150 m² at the sample position. The samples were maintained between two kapton sheets. The measurements were carried out on both samples at 20 K using a liquid helium cryostat. The low-temperature mount was found to be e cient to retain NCOH (NCO) hydrated (non-hydrated).^{11,19} The spectra were measured in re ection geometry along two polarization directions by turning the sample holder by 80 in the horizontal plane, starting from the polarization quasi perpendicular to c (in-plane polarization) to parallel to the c (out-of-plane polarization). In our experim ental geom etry, the detector was alw aysperpendicular to the incident beam .




FIG.1: (Cobronline) CoK XAS spectra in $Na_{0.7}CoO_2$ (upper panel) and $Na_{0.35}CoO_2$ 13H0 (lower panel) with ? c (solid lines) and k c (circles). The insets show the corresponding enlarged pre-edge region for both compounds. Vertical lines indicate the peak energy positions.

Figure 1 shows the polarization dependence of the C o K -edge XAS spectra in NCOH (bwer panel) and NCO (upper panel). The spectra are normalized to an edge jump of unity. The spectra exhibit a low-intensity feature (labeled A in Fig. 1) in the pre-edge region at 7710.9 eV (7710.5 eV) in NCOH (NCO) followed by two pronounced peaks (respectively labeled B and C) at 7723.5 eV (7723.5 eV) and 7731.0 eV (7730.4 eV) in the vicinity of the absorption edge. W hen the polarization is turned from in-plane to out-of-plane, we notice a strong decrease in the intensity of the white line C in both sam ples, whereas peak B increases. The polarization dependence indicates that peak C is mainly associated to 1s ! $4p_{x,y}$ (in-plane) transitions, while peak B is related to 1s ! $4p_z$ (out-of-plane) transitions.

No sign of Co^{3+} { Co^{4+} charge disproportionation is observed in the near-edge region. This contrasts with recent Co 2p photoem ission m easurements in NCO and NCOH where well-separated features seem ingly related to Co^{3+} and Co^{4+} have been observed.¹⁹ Sim ilarly to core-level photoem ission, XAS is a fast probe and should be able to distinguish between m ixed valent states, whether static or dynam ic order exists. How ever, the description of the ground state in terms of ionic con gurations is not valid here because of covalency e ects and multiple charge-transfer states have to be taken into account. In the XAS nal state, the di erent con gurations are split in energy

because of the core-hole potential, but with additional interm ixing. The XAS spectral features are therefore not directly assignable to pure valent states. A similar observation was made at the Co K -edge in the mixed-valent Co^{3+}/Co^{4+} compounds La_{1 x} Sr_xCoO₃ (Ref. 20).

The pre-edge region, on the contrary, is in principle more sensitive to the Co valent states: in transition metal compounds, this spectral region mainly results from quadrupolar1s ! 3d transitions, though with an adm ixture of dipolar character because of the trigonal distortion of the Cooctahedralsite.²¹ A closer look shows that the pre-edge consists of two peaks in NCO (see vertical lines in the inset to Fig. 1) which we relate to the crystal-eld splitting (mainly of octahedral symmetry) of the Co 3d states. The low-energy peak corresponds to transitions to the empty t_{2g} states, whereas the peak at higher energy is associated to transitions to the eq states. This energy splitting (2 eV in NCO) is consistent with the values of the crystal-eld param eter 10D q used in cluster model simulations of the Co 2p photoem ission spectra of NCO and NCOH (estim ated at 2.5 eV and 4.0 eV respectively for Co^{3+} and Co^{4+} ions).¹⁹ In NCOH, only the lowest 3d split state is visible (see vertical line in the inset to Fig. 1). We sst note that the dipolar-like tail of the white line extends further tow ards lower energy in NCOH compared to NCO, thus notably masking the high-energy crystal-eld related structures. M ore importantly, the change in the pre-edge region in NCOH primarily rects the variation of the Covalency, induced by the di erent Na doping level. In NCOH, the number of holes in the t_{2q} states (0.65) is about a factor

2 larger than in NCO (0.3). A ssum ing that the strength of quadrupolar matrix elements does not depend on the sample, this will lead to enhanced intensity of the low-est energy absorption peak corresponding to transitions to empty t_{2g} states in NCOH compared to NCO, with respect to the e_g peak, as observed in the spectra. The spectral changes in the pre-edge region therefore con m the e ects of N a doping on the Co valency.

In order to analyze further the changes in the XAS spectra as a function of both polarization and Na doping, the CoK -edges were simulated from LMTO band structure calculations. This one-electron approach is well suited here because the XAS nal states are mainly com - posed of Co 4p band-states. The monoelectronic approach is not expected to reproduce every feature of the absorption spectra but, as explained hereafter, provides valuable inform ation on the Co electronic properties in these materials.

B. Calculations

1. Density of states




FIG.2: (Color online) Atom ic and empty (E) spheres positions in the NCO unit cell with Na occupying site 2b (upper graph) and 2c (lower graph). All spheres are projected onto the (a, b) plane.

The calculations were performed using an LMTO code²² within the local density approximation starting from the known crystal structures for both com pounds.²³ We used the von Barth {Hedin parametrization for the exchange-correlation potential.24 Spin-polarization was neglected. One empty sphere per unit cell was used in order to m in in ize the overlap of the atom ic spheres. The positions of the empty and atom ic spheres in the unit cell are shown in Fig. 2 with Na alternatively occupying the 2b and 2c sites (upper and lower graphs). Separate band structure calculations were perform ed for each compound with Na either in 2b or 2c sites. Since the exact partitioning of N a between the two sites is unknown, the calculated DOS and absorption spectra were averaged assuming that the 2b and 2c sites are equally populated. To obtain the right Na stoichiom etry (i.e., 0.35 in NCOH and 0.7 in NCO), the Na concentration was adjusted articially using the virtual crystal approxin ation (VCA). In this approximation, the Na atom s are replaced by \virtual atom s" de ned by a pseudopotential taken as the average potential of the real atom s at the same site. In the calculations, this was achieved by allowing for a non-integer N a nuclear charge and, hence, a non-integer num ber of valence electrons. The VCA approximation was used by Singh et al¹² for band structure calculations in NCO and was shown to yield a satisfactory description of the electronic properties. Finally, the hydrated compound was modeled by constructing a unit cell with an elongated c-axis (considered to be the main consequence of the hydration) and displaced 0 atoms, but without water molecules.




FIG.3: (Color online) Calculated total and partial Cod, O p, and NapDOS in NCO (upper graph) and NCOH (lower graph).

The total and the partial DOS are given in Fig. 3. We show only the Cod, O p, and NapDOS, as they are the main contributions to the total DOS. They are in good




FIG. 4: (Color online) Partial DOS projected onto Co $p_{x,y}$ (e_u) (thin lines) and p_z (a_{2u}) states (thick lines) in NCO (upper graph) and NCOH (lower graph).

agreem ent with previous calculations, 12, 25, 26, 27 although we concentrate here on a more expanded energy scale com pared to the cited works and not to the details of the valence electrons in the region of the Fermi energy (E_F). Farbelow E_F (from 6:0 eV to 1:5 eV), the DOS has mainly 0 p character in addition to a weaker contribution of the Cod states. The close connection between the O - and C o-projected D O S indicates a strong p-d hybridization of the occupied states. In both compounds the DOS show a non-vanishing intensity at $E_{\rm F}$, consistent with their m etallic character. The split Co-d band, striding the Ferm i level, is rem iniscent of the crystaleld e ect. The splitting amounts to 2.4 eV and 2.9 eV in NCO and NCOH (measured from the position of the center of mass of each d subband). The form er value is slightly higher than the 2 eV splitting found experim entally in NCO. Such a discrepancy is common within the LDA, which is known to overestim ate hybridization of d orbitals. At higher energy, the DOS mainly consists of Nap states hybridized with Cop (see Fig. 4) and O p states. W e note that the total DOS in the hydrated com pound shows sharper features com pared to the nonhydrated one. This could indicate a stronger localization of the electrons in the hydrated com pound resulting from a nearly doubling of the clattice constant.

The partial DOS projected onto the Co $p_{x,y}$ (e_u) and p_z (a_{2u}) states are shown in Fig. 4. The empty p states are spread over a large energy range (10{30 eV in NCO; 10{25 eV in NCOH}). The elongation of the c-axis in the

hydrated compound likely is at the origin of the bandwidth decrease. This a ect mostly the p_z component, as presumed from steric arguments. More unexpectedly, the calculations indicate that the $p_{x\,;y}$ states are far from being insensitive to the structural change.

2. CoK-edge XAS spectra




FIG.5: (Color online) Calculated Co K -edge XAS spectra in NCO (upper graph) and NCOH (lower graph) for the two polarization directions, in-plane (thin lines) and out-ofplane (thick lines). The pre-edge region is enlarged in the insets.

The CoK -edge XAS spectra were calculated by multiplying the DOS by the energy dependent dipolar matrix elements. The matrix elements are calculated at each k-point, before integration over the Brillouin zone. Figure 5 shows the XAS spectra calculated for the two polarization directions, in-plane (thin lines) and out-of-plane (thick lines) in the hydrated (lower graph) and the nonhydrated (upper graph) compounds. The contribution from the continuum is not included. The spectra are shown as calculated without normalization, the cuto at E_F being aligned to the experimental value (taken at the expoint of peak A).

The calculated spectra reproduce qualitatively the experim ental results, though with di erences in the peak intensities and positions. In the in-plane calculated spec-

tra, the main line appears at 7732.5 eV in the hydrated com pound and 7732.0 eV in the non-hydrated one. These features, which correspond to peak C in the experim ental spectra, are shifted to higher energies by 1:5 eV. M oreover, a broadening of the white line is observed in the non-hydrated com pound com pared to the hydrated one, sim ilarly to the experiment. This is likely a consequence of the more localized character of the electrons in the hydrated com pound com pared to non-hydrated one, as mentioned above. The observed changes in the (x;y)and z DOS are also re ected in the XAS spectra. In the out-of-plane con guration, the spectra are no longer characterized by a white line but present a series of broad features of comparable intensity, specially in NCO. Feature B, which is located at 7724.0 eV in NCO, is in good agreem ent with the experim ental value with, how ever, a shift of 0.5 eV to higher energy. In the hydrated com pound, the B feature appears broader because of the superim position, in this energy region, of at least two com ponents as suggested by its asym m etric spectral shape.

W e notice in the calculated spectra, a peak located at around 7710.5 eV of sizable intensity (see inset to Fig.5) which reminds the pre-edge features A observed in the experimental XAS spectra. It cannot be attributed to quadrupolar transitions since only the dipolar contributions are considered in the calculations. It should rather be understood as resulting from the hybridization between the Co 4p states with the Co 3d states through the interaction with the O 2p ligand states. In both NCO and NCOH simulated spectra, we note a 2:4 eV

splitting of the pre-edge in the z direction, rem iniscent of the crystal-eld e ect on the Co^{3+} ion. The splitting is absent in the (x;y) component, which could point to a more delocalized character of the in-plane electrons. In the experim ental spectra, crystal- eld related features were only observed in NCO and in both geometries. Direct com parison with the calculations is di cult how ever, because quadrupolar and dipolar-assisted transitions are m ixed in the experim ental spectra. By inspecting the Co d DOS in more detail (not shown here), the calculated pre-edge is seen mainly composed of in plane Cop (e_u) states hybridized with Cod (t_{2g}) states. Thus, even a relatively small number of holes in the t_{2g} states leads to strong increase in the intensity of the corresponding peak for the in-plane polarization. As a result, the preedge intensity in the in-plane XAS spectrum of NCOH will increase compared to NCO.

In the calculated XAS spectra it is important to disentangle the in uence of the Na sites from the impact of the Na concentration and the hydration (c-axis elonga-




FIG.6: (Color online) Calculated CoK -edge XAS spectra in Na_xCoO₂ compound, for two di erent c=a ratios (3.99 and 6.92, lower and upper graphs, respectively) and for the two di erent Na sites [2b (thick lines) and 2c (thin lines)]. Panels (a) and (c) [(b) and (d)] represent the calculations with a Na concentration of 0.35 (0.7). In each panel, the lower spectra correspond to the in-plane polarization (x;y) direction and the upper spectra to the out-of-plane polarization (z).

tion) e ects. W ith this aim in mind, we show in Fig. 6 the calculated spectra separately for the two N a sites (2b and 2c) and as a function of the N a concentration (0.35 or 0.7) and the c=a ratio (3.99 and 6.92, for NCO and NCOH respectively). Each spectrum is further projected onto the two polarization directions, i.e., (x;y) (lower spectra) and z (upper spectra). For a given c=a ratio, the calculations for two di erent N a sites (2b, 2c) and two different N a concentrations (0.35, 0.7) are alm ost identical in the in-plane con guration (especially at c=a = 6:92). O n the contrary, the spectra in the out-of-plane con guration do show di erences when substituting a N a on site 2b by one on site 2c. The largest changes are observed for c=a = 3:99, when interplane interactions are largest. Sim ilarly, the variation of the N a concentration mostly

a ects the out-ofplane spectra obtained with Na occupying the 2b site. The highest sensitivity when Na occupies site 2bm ay be related to its location in the unit cell above the Co atom s, while the o -centered Na 2c atom s are a much weaker perturbation to the Cop states.

To sum m arize, the elongation of the c-axis is the m ain m odifying factor of the XAS spectra, thus of the Co electronic properties, while the Na concentration and sitesubstitution has a less in uence. This a posteriori justi es our starting hypothesis for the LM TO calculations with Na equally distributed in the 2b and 2c sites. The out-of plane spectra are observed to be highly sensitive to the structural change as expected from the quasitwodim ensional character of the Co-O network.

III. COK-EDGE RESONANT INELASTIC X-RAY SCATTER ING

Signatures of C o valence states m ay be revealed also in the low -energy excitation spectra through intra-band or inter-band excitations around E_F . Electron energy-loss spectroscopy or optical absorption provide m eans of m easuring low -lying excited states. However, unlike R IX S, they do not bene t from the resonant enhancem ent and only transition with a very low m on entum transfer q can be observed. W e analyze here results obtained by R IX S at nite q in NCO and NCOH, in the light of the calculated electronic structure derived in section IIB.




FIG.7: (Coloronline) RIXS spectra at the CoK -edge (lower panel) and calculated dynam ical structure factor S (q = 0; !) (upper panel) in NCO and NCOH. For comparison with experiment, the calculated S is convoluted with a 1 eV fullwidth at halfm aximum Lorentzian prole. Dotted lines (lower panel) are polynom ial sm oothed data in NCO and NCOH.

The experiment was carried out at beam line ID 16 (ESRF) in a previous experim ental run using single crystals of NCO and NCOH at the CoK-edge. Details about the measurements and complete data set have been reported in Ref. 28. Both samples are intrinsically of poor crystalline quality as a result of their synthesis process. To m in im ize the contribution from the quasi-elastic line, the spectra were measured at a high scattering angle corresponding to a momentum transfer of q $2 A ^{1}$. The main result is sum marized in Fig. 7 (bottom panel). The RIXS spectra exhibit a single excitation peaking at 10.0 eV in NCO and at 10.4 eV in NCOH. Note that the spectra of NCOH and NCO were measured with different energy resolutions, respectively 0.4 eV and 1 eV. The inelastic feature resonates in the vicinity of the white line energy (7729 eV). The high energy of this excitation precludes it originating from crystal-eld-like excitations. To help the identi cation of this excitation, we plot in Fig. 7 (upper panel) the calculated dynam ical structure factor S (q = 0; !) in NCO and NCOH. This quantity was derived from the computation of the dielectric response function "obtained from the DOS, and according to the relationship S / Im (1="). Spectral broadening due to the nite resolution and lifetim e e ect were taken into account by a convolution of the calculated spectrum with a 1 eV fullwidth at half-maximum Lorentzian pro le. The calculation shows an intense peak at 92 eV in NCO (8.9 eV in NCOH), in good agreement with the RIXS feature, although the latter is shifted to higher energy. The shoulder on the low energy side (clearly seen in the better resolved spectrum in NCOH) is well reproduced as well. The shift between the experiment (q \in 0) and the calculation (q = 0) may be related to the dispersion of the inelastic features at nite q. In the experimental spectra, we observe an apparent displacem ent of the main peak by 0.5 eV towards high energy (between NCO and NCOH) which contrasts with the calculations. A though the variation of the C o valence with doping could reasonably explain the energy shift³³, we cannot totally exclude resolution e ects.

The overall agreement of the computed dynamical structure factor with the experiment is at rst unexpected, considering that the calculated spectrum is derived from a purely non-resonant scattering process, opposite to the resonant cross-section in RIXS. Recently,

G renier et al.²⁹ reported sim ilar results in a R IX S experim ent perform ed on m anganites at the M n K -edge. They observed an energy-loss feature at 12 eV in the R IX S spectra that they attribute to a plasm on excitation rem iniscent of the non-resonant dynam ical structure factor. N on-resonant contributions to R IX S can be understood as arising from a third-order process^{30,31} which involves shake-up phenom ena in the R IX S interm ediate states. In this picture, the R IX S cross-section would be proportional to the dynam ical structure factor multiplied by a resonant denom inator.

In our case, the m om entum transfer is about one order of m agnitude higher than that of R ef. 29. At high q, plasm on excitations are severely dam ped by creation of electron-hole pairs, but the critical wave vector above which the plasm on looses its de nition is unknow in the present case w ithout a detailed know ledge of the dispersive behavior. In a system atic IX S study, G urtubay et al.³² lately reported plasm on-like excitations at sim ilar m om entum transfer in elemental transition m etals, although signi cantly broader in energy com pared to low q m easurem ents. Thus, the m ain feature in our R IX S spectra is understood as a dam ped plasm on involving C o p-electrons while the ne structure (e.g. low energy shoulder) is attributed to a background of excitations due to inter-band transitions.

IV. CONCLUSIONS

We have investigated the Co electronic properties in $Na_{0:7}CoO_2$ and $Na_{0:35}CoO_2$ 1:3 HO using hard x-ray spectroscopic probes. The experimental results are compared to rst-principles calculations of the Co K-edge XAS spectra within the LM TO approach. The underlying DOS show the strong hybridization of the Co 4p band with O 2p and Co 3d states. This particularly concerns the spectral region close to the Ferm i energy. A stronger electron localization is revealed in the hydrated

com pound with respect to the non-hydrated one, consecutively to the elongation of Co-Co inter-planar distance. The pre-edge region is found mostly sensitive to the Co-valence change, while no clear dependence on the N a content is observed in the near-edge part of the spectra. D etailed calculations indicate that the X A S spectra are more a ected by the expansion of the c-axis when NCO is hydrated than by the change of the N a doping level. Low-energy excitations observed by R IX S at the CoK -edge could be assigned to a dam ped plasm on m ode, presum ably involving the Co valence electrons.
