# Bose-Einstein condensates in RF-dressed adiabatic potentials

Bose-E instein condensates of <sup>87</sup>Rb atoms are transferred into radio-frequency (RF) induced adiabatic potentials and the properties of the corresponding dressed states are explored. We report on measurements of the spin composition of dressed condensates. We also show that adiabatic potentials can be used to trap atom gases in novel geometries, including suspending a cigar-shaped cloud above a curved sheet of atoms.

#### I. INTRODUCTION

A diabatic potentials, created using a combination of radio-frequency (RF) and static magnetic elds, are promising tools for conining ultra-cold atoms in novel geometries and for use as beam splitters in atom interferometry. Examples of proposed trapping geometries include potentials with two dimensional character [1, 2, 3], ring shaped potentials [4], and tunnel arrays [5]. The use of adiabatic potentials as a beam splitter in an atom ic interferometry application was recently demonstrated in [6]. A potential advantage of this technique for exploring atom ic super uids in new geometries over other methods (e.g., optical traps) is that the potential can be very smooth [7].

In this work, we investigate the properties of ultracold atoms con ned in adiabatic potentials generated through a combination of RF magnetic elds, applied using a small antenna, and static magnetic elds from a Io e{Pritchard (IP) magnetic trap. Bose condensed  $^{87}\mathrm{Rb}$  atoms are created in the F = 1, m  $_\mathrm{F}$  = 1 state in a cigar-shaped axisymmetric IP trap and then transferred into three types of adiabatic potentials: a nite-depth cigar-shaped harm onic trap, a cigar-shaped trap which is strongly anharm onic, and a curved-sheet potential. The primary results presented in this paper are measurements of the population in each m  $_\mathrm{F}$  state for the nite depth and anharm onic potentials and measurements of the displacement of the curved-sheet potential for different frequencies of the RF magnetic eld.

## II. THEORY

An atom moving in the presence of static and RF magnetic elds experiences adiabatic potentials as long as there are no Landau-Zener transitions. These adiabatic potentials are provided by a spatially inhom ogeneous static magnetic eld which gives rise to a spatially varying detuning for the RF magnetic eld. In the adiabatic potential, the atom exists in a superposition of hyper ne or Zeem an states, which is a stationary state in the rotating frame. These superposition states are typically referred to as dressed states [8].

In our experiment, the dressed states are composed

of the m  $_{\rm F}$  = 1 and m  $_{\rm F}$  = 0 Zeem an states in the  $5S_{1=2}$ , F = 1 hyper ne ground state of  $^{87}{\rm Rb}$ . The Zeem an states are coupled by an RF magnetic eld B  $_{\rm rf}$  =  $\cos(!\,t) \hat{y}$ , where  $\hat{z}$  is the weak direction of the IP trap and the gravitational force acts in the  $~\hat{y}$  direction. The frequency ! of the RF ~ eld is tuned near the m  $_{\rm F}$  = 0 \$ m  $_{\rm F}$  = +1 and m  $_{\rm F}$  = 0 \$ m  $_{\rm F}$  = 1 transitions, which are nearly degenerate at the static ~ eld magnitudes used here (< 11 G).

To determ ine the dressed state wavefunctions, one must solve three coupled G ross-P itaevskii equations. A simpli cation of these equations is possible in our system because the interaction strengths between dierent m<sub>F</sub> states are nearly equal, and spin exchange rates are small compared to the RF Rabi rate (we estimate spin-exchange rates less than 10 Hz). The many-body wavefunction may therefore be written as ji= c<sub>+</sub> j+ i + + c<sub>0</sub> jDi <sub>0</sub> + c j i , where j+ i; jDi; j i are the single atom dressed states and +; 0; are the Thomas{ Ferm i wavefunctions determined by the corresponding adiabatic potentials. In the dressed-state basis, j i is a stationary state the numbers of atoms in each dressed state are independent and are determined by the process used to transfer atoms into the adiabatic potentials.

In our experiment, the rates are nearly equal: 0:483  $_{B}$   $B_{rf}=\sim$ . The dressed state wavefunctions are written in Eq. (1) in a rotating frame ede ned by  $\varsigma=\varepsilon_{t}\,e^{i!\,t}$ ,  $c=\varepsilon_{t}\,e^{i!\,t}$ , and  $c_{0}=c_{0}$ , where the single-atom spin wavefunction is written in the Schrodinger picture as  $j\sim i=\varepsilon_{t}\,j m_{F}=+1 i+\varepsilon_{t}\,j m_{F}=0 i+\varepsilon_{t}\,j m_{F}=1 i$ . The dressed states have eigenenergies  $E_{+}=\sim \frac{1}{2}+2^{-2}$ ,  $E_{-}=\sim \frac{1}{2}+2^{-2}$ , and  $E_{0}=0$ .

The shape of the adiabatic potentials is determ ined by the e  $\,$  ect of the inhom ogeneous magnetic  $\,$  eld created by the IP trap, where

near the center of the trap [9]. Here, B $_0$  is the bias eld, i.e., the magnitude of the eld at the center of trap,  $C_1$  is the radial gradient, and B $_2$  is the axial curvature. For the work presented in this paper, B $_0$  = 1:33(1) MHz h= , and  $C_1$  = 355(2) G/cm and B $_2$  = 129(2) G/cm  $^2$  (determined from measurements of the harmonic trapping frequencies). The shape of the adiabatic potentials depends on the detuning, = ! !0, relative to the resonance at the trap center, !0 = B0=~. We sum marize here the shape of the adiabatic potentials, starting with the U potential. The U , > 0 potential is the familiar potential utilized for forced RF-induced evaporative cooling [10]. This potential is harm onic near the centralm inim um and the curvature there is independent of detuning, except for small (compared with the Rabi rate) detunings. The U ,

< 0 potential is not con ning.

In contrast to the U potential, the  $U_+$  potential is always con ning with a trapping geometry that depends strongly on detuning: for large and negative , it is harmonic near the potential minimum. For small and negative , the  $U_+$  potential is quartic in the absence of gravity; gravitational sag results in an overall trapping potential for this case which is strongly anharmonic and cannot be characterized as purely quartic. For > 0, the  $U_+$  potential is an ellipsoidal shell in the absence of gravity. A tom s in the j+i state are forced by gravity to occupy a curved sheet in the bottom of this shell.

#### III. EXPERIMENTS

The dressed states are primarily characterized by the population in each m $_{\rm F}$  state. We investigate the m $_{\rm F}$  state composition of the dressed states in the U and U $_{+}$  potentials for > 0 and < 0, respectively, by measuring the population in the m $_{\rm F}$  = 0 and m $_{\rm F}$  =




FIG. 1: A diabatic potentials for the F = 1 state in the presence of gravity. The potential U is shown along the  $\dot{\gamma}$  direction for the  $\dot{j}$ + i,  $\dot{j}$ 0i, and  $\dot{j}$  i states on the right and with no RF magnetic eld present on the left. The arrows indicate how the m<sub>F</sub> states transform when the RF eld is turned on adiabatically for positive ( > 0) and negative ( < 0) detuning.

1 states after the RF is turned o suddenly. We also show that measuring the populations in the m $_{\rm F}$  basis for dierent detunings is a sensitive method for determining the Rabi rate.

We begin by creating a condensate of approximately  $10^5$  87Rb atoms in the F = 1, m<sub>F</sub> = 1 state with no observable therm aloom ponent via RF evaporative cooling (we use an apparatus sim ilar to that described in [11]). The atoms are trapped in a Io e{ Pritchard type magnetic trap as described above with radial and axial trapping frequencies  $!_r = 231(8) \text{ Hz}$ and  $!_z = 14:5(3)$  Hz, respectively. A tom s are in aged via a standard absorption im aging technique, using light resonant with the  $5S_{1=2}$ ; F = 2 to  $5P_{3=2}$ ; F = 3 cycling transition. Im m ediately before the probe beam is switched on, atoms are optically pumped from the F = 1 manifold to the F = 2 manifold using light tuned to the  $5S_{1=2}$ ; F = 1 to  $5P_{3=2}$ ; F = 2 transition. RF signals are coupled to the atom sby an antenna which is a three turn, 10 mm radius coil located 1.5 cm from the atoms in the \$\psi\$ direction.

To measure the m $_{\rm F}$  state composition, the RF turned on slow ly to transfer all the atom s in the condensate from the  $m_F = 1$  state to a single dressed state, and then turned o suddenly to project the dressed state on to the m  $_{\rm F}$  basis. Once a condensate is created, the RF power is increased linearly from 0 to 35 dBm (of which a fraction is coupled into the RF antenna) over 5 ms at  $1.10 \,\mathrm{M}\,\mathrm{Hz}$  (1.75 M Hz) for data taken with  $< 0 \ (> 0)$ . The RF frequency is swept linearly at 10 kH z/m s to the value at which we wish to measure the spin composition; the RF is then shut o suddenly (the RF source is turned o within 3 ns). Turning o the RF much faster than the e ective Rabirate projects the dressed states into the m<sub>F</sub> basis, making it possible to investigate the spin composition by measuring the relative number of atoms in each  $m_F$  state. A fter waiting 3 m s for the  $m_F$  = 0 atom s to

fall and spatially separate from the m  $_{\rm F}=1$  atom s, the m agnetic trap is shut o . This 3 m s delay also forces any m  $_{\rm F}=+1$  atom s to be ejected from the trapping region by the inhom ogeneous magnetic eld from the IP trap. The m  $_{\rm F}=0$  and m  $_{\rm F}=1$  clouds are im aged 7 m s after the magnetic trap is turned o . We verify that the frequency sweep is adiabatic by sweeping the RF source back to the initial frequency (1.10 M Hz or 1.75 M Hz) before turning o the RF eld and observing no loss of atom s.




FIG. 2: Ratio of m  $_{\rm F}$  = 0 atom s to total number of m  $_{\rm F}$  = 0 and m  $_{\rm F}$  = 1 atom s versus RF frequency. Data for RF frequencies greater (less) than 1.328 MHz represent atom s con ned in the U (U+) potential. Each data point represents a single im age, except the points with error bars, which are each an average of 7 m easurem ents; the error bars indicate the standard deviation of these m easurem ents. The solid red line is a tto Eq. (3). Open circles represent data points for which gravitational sag is calculated to shift the measured ratio by more than 1% and are not included in the t. The inset shows a typical in age used to obtain the data; the eld of view is approximately 260 m by 370 m. The lower (upper) cloud consists of m  $_{\rm F}$  = 0 (m  $_{\rm F}$  = 1) atom s.

The number of atoms in each m $_{\rm F}$  state is obtained by thing the absorption in ages to the Thom as{Ferm i pro le expected for a BEC. The data in Fig.2 show the experimentally determined ratio of m $_{\rm F}=0$  atoms to the total number of m $_{\rm F}=0$  and m $_{\rm F}=1$  atoms for dierent nal RF frequencies; as many as 20% of the atoms are observed in the m $_{\rm F}=0$  state. The data in Fig. 2 are the to

which is the relative Zeem an state distribution expected from Eq. (1) [12]. Only points at detunings beyond 50 kHz, where gravitational sag is calculated to shift the measured ratio by less than 1%, are included in the t. The Rabi rate and  $!_0$  are left as free param eters in = 2 the t; the values obtained are 24:6(5) kHz 1:328(2) MHz, corresponding to an RF and  $!_0 = 2$ eld strength  $B_{rf} = 36:3(7) \text{ mG.D}$  eterm in ing the Rabi rate is normally very dicult in cold-atom experiments involving transitions between magnetically trapped and untrapped states, because Rabioscillations cannot be directly observed and uncertainty in the geometry of the RF antenna. We are able to determ ine to within 2% via spin com position m easurem ents. The response of the RF source and antenna do not vary signi cantly over the frequency range covered by the data in Fig. 2.

The simplest example of using adiabatic potentials to conneultra-cold atoms in a novelgeometry can be realized using the j+ i state for positive detuning. A toms in the U+ potential for > 0 occupy a curved sheet, which is the bottom part of an ellipsoidal shell potential [1]. We characterized the shape of the U+ potential by measuring the displacement of atoms in the j+ i state from the minimum of the m $_{\rm F}$  = 1 potential (in the absence of the RF eld).




FIG. 3: D isplacement from the IP trap center for atoms trapped in  $U_+$  potential for dierent RF frequencies. The solid red line shows the calculated displacement. The inset shows atoms simultaneously loaded into the U (upper cloud) and  $U_+$  potentials at = 2 1 MHz. The eld of view for the inset (taken while the atoms were trapped) is approximately 640 m by 390 m.

A tom s are transferred into the  $U_+$  potential by tuming on the RF eld at < 0 and sweeping the frequency through  $!_0$  to the value where the displacement will be measured. [1, 3]. In general, caremust be taken to sweep slowly enough to adiabatically transfer a BEC into the  $U_+$  potential. We made no attempt to sweep adiabatically because the measured displacement was found to be independent of the details of the frequency sweep. For the data shown in Fig. 3, the RF is turned on at 1.10 MHz and swept at 31 kHz/ms using 2 40 kHz. A fler transferring atoms into the  $U_+$  potential, the atoms are held for 4 ms and then in aged in the trap. The center

of the atom cloud is determ ined by a G aussian  $\,$  to the absorption in age. Fig. 3 shows the measured displacement from the the minimum of the m $_{\rm F}=1$  potential for dierent RF frequencies. The error bars account for uncertainty in the magnication of our imaging system.

The measured data agree well with the displacement expected for an IP magnetic trap. The solid red line in Fig. 3 is the displacement calculated using the magnetic eld m in im um in Eq. (2)) at z = 0. We have ignored gravitational sag, calculated to be less than 1 m for detunings beyond 02 MHz. At large detunings, the displacem ent is dominated by the radial gradient of the IP trap. For small detunings, the cloud samples only the eld near the center of the IP potential, and the displacement is quadratic in detuning. Plotting Fig. 3 as RF frequency vs.displacem ent produces a m ap of the radial eld of the IP trap. This provides a method to measure the radial eld to high accuracy tting the data in Fig3 to the equation used to calculate the solid red line, but leaving  $!_{0}$  and  $C_{1}$  as free param eters, yields  $C_{1}$  = 357(2) G/cm . The radial gradient obtained using this technique is in excellent agreem ent with the value derived from measuring the IP trap frequencies through \sloshing" motion of the condensate.

We have also realized an unusual trapping geometry in which a cigar-shaped cloud of atoms is trapped above a curved sheet of atoms. By increasing the frequency sweep rate and/or decreasing the RF power, it is possible to

transfer only a fraction of the atom s to the  $U_+$  potential. Under these conditions, Landau-Zener transitions result in atom s trapped in both the  $U_+$  and  $U_-$  potentials, as seen in the inset to Fig. 3. Here, the detuning was = 2 - 1 MHz, and the loading ramp was altered so that the frequency sweep rate was 300 kH z/m s and = 2 - 3.3 kHz within  $40 \text{ kHz} - 2 \text{ of!}_0$ .

We brie y discuss the prospects for obtaining a 2D BEC in the  $U_+$ , > 0 potential. Motion around the bottom of this potential is characterized by three dierent harm onic oscillator frequencies: a large radial frequency and two small frequencies along directions which experience pendulum—like motion [2, 3]. For the  $U_+$  potential at = 2 1 MHz and = 2 40 kHz, the radial and two pendular frequencies are calculated to be 900 Hz and 60 Hz and 4 Hz, respectively. These frequencies are calculated using a classical norm almodes calculation and the magnetic eld from Eq. (2). We observed a lifetime of

4(2) s and a heating rate of 4.5(3) K/s under these conditions. Sources of atom loss may be Landau {Zener transitions to untrapped states [2]; three body recombination may also play a role because the non-adiabatic loading into this potential can transiently increase the density [13]. Because adiabatic transfer into the the 2D regime is quite slow, due to the low pendular trap frequencies of the U<sub>+</sub> potential, we expect obtaining a condensate in the 2D regime to be di cult without signi cant im provem ent to the heating rate. A large heating rate was also observed in [3], where it was attributed to noise in the RF frequency. Finally, we remark that we have observed partially condensed clouds upon release from the U+ poup to 1.5 M H z after rapid (non-adiabatic) loading (31 kHz/ms frequency sweep rate), indicating that the condensate is not destroyed im m ediately by the loading process.

### IV. CONCLUSION

In conclusion, we have investigated the nature of RF dressed potentials for magnetically trapped  $^{87}{\rm Rb}$  in the F = 1 state and measured the m  $_{\rm F}$  state composition of the dressed states. We have also studied the shape of the ellipsoidal U  $_{+}$  potential. Potentially useful techniques for measuring the RF Rabi rate and for directly characterizing the radial eld of a magnetic trap were also demonstrated.

Future directions for this research include creating ring traps [4, 14], which are promising for use as atomic Sagnac interferom eters. Courteille et.al. [5] also recently proposed a scheme to create versatile potentials using multiple RF frequencies. An important future step is to characterize and address heating and loss mechanisms in dressed state potentials. Because the dressed states are superpositions of the atom ic spin states, a related question of particular interest concerns the nature of spin exchange collisions for dressed states.
