# B ogoliub ov m odes of a dipolar condensate in a cylindrical trap

#### Abstract

The calculation of properties of B ose $\pm$ instein condensates with dipolar interactions has proven a com putationally intensive problem due to the long range nature of the interactions, lim iting the scope of applications. In particular, the low est lying B ogoliubov excitations in three dim ensional harm on ic trap $w$ th cylindricalsym $m$ etry were so far com puted in an indirect way, by Fourier analysis oftim e dependent perturbations, or by approxim ate variationalm ethods. W e have developed a very fast and accurate num erical algorithm based on the $H$ ankel transform for calculating properties of dipolar B ose - instein condensates in cylindrically sym $m$ etric traps. A $s$ an application, we are able to com pute $m$ any excitation $m$ odes by directly solving the Bogoliubov-D e G ennes equations. W e explore the behavior of the excited $m$ odes in di erent trap geom etries. W e use these results to calculate the quantum depletion of the condensate by a combination of a com putation of the exact m odes and the use of a local density approxim ation.


## I. INTRODUCTION

The ${ }^{-i}$ zation of a B ose E instein condensate ( BEC ) of ${ }^{52} \mathrm{Cr} \quad \mathrm{m}$ arks a m ajor developm ent in degenerate quantum gases in that the inter-particle interaction via $m$ agnetic dipoles in this B EC is m uch larger than those in alkali atom $s$, and leads to an observable change in the shape of the condensate. The long range nature and anisotropy of the dipolar interaction pose challenging questions about the stability of the BEC and brings about un ique phenom ena, such as roton -m axon spectrum and di erent phases of vortex lattices. For $N$ bosons in an extemal trap potental $V_{\text {ext }}(r)$ at very low tem peratures, the ate can be described using m ean-eld theory A $l l$ the particles in the condensate then have the sam e w ave function

$w$ here $r$ is the displacem ent from the trap center, $m$ is the atom ic m ass, and the function is norm alized to unit norm . W e shall consider the case of a cylindrical

where $a$ is the scattering length, $d$ the dipole $m$ om ent, $r$ the distance betw een the dipoles, and the angle betw een the vector $r$ and the dipole axis, which we shall take to be aligned along the trap axis. a depends on the dipole $m$ om ent $\quad$ This observation is im portant in an experm entalsecup where the dipole m om ent is tuned by an extemal eld. In the present work we shall rather assum e that a and $d$ are either xed orm ay be tuned independently.

For the follow ing w $\& \frac{1}{}$ de ne the transverse harm onic oscillator length $\mathrm{a}_{\mathrm{ho}}=\frac{\mathrm{h}}{\mathrm{m}!}$, and the tw o dim ension less interaction param eters $s=(\mathbb{N} \quad 1) \frac{a}{a_{\mathrm{h}}}$ and $D=\mathbb{N}$ 1) $\frac{m}{h^{2}} \frac{d^{2}}{a_{\mathrm{h}} \mathrm{o}}$. We work in scaled units where $h=m=1$.

Eq. with the potential Eq. $\quad$ is an integro-dl erential equation. The integral term $\left.d^{2} d r \frac{013 \cos ^{2}}{j r r^{0} j^{3}} j\left(r^{0}\right)\right\}^{2}$ needs special attention due to the apparent divergence of the dipolar potential at sm all distances. M oreover, it is non-local and requires a com putationally expens -im ensional convolution. Two di erent procedures, ve been proposed to dealw ith this problem. In KeI Fourier transform ation to $m$ om entum space was employed to perform the convolution and avoid the divergence, but the calculation still had to be pe-m ed in 3D even for cylindrical sym $m$ etry. In Ref. the cylindrical sym $m$ etry of the system was utilized to com pute a 2D analytic expression for the convolution kemel in real space, which, how ever, required further computationally intensive num erical
sm oothing in order to avoid the $r=0$ singularity. In either case, it seem sthat the com putations rem ain quite intensive, and this $m$ ay be th son wh calculations of low lying excitation modes were perform ed only via spectral analysis of tim e aependent perturbations. T hese calculations w ere tim e consum ing and num erically challenging.

In this paper, we present a new algorithm based on H ankel transform for calculating properties of dipolar condensates in cylindrical traps which combines the advantages of the tw om ethods above: nam ely, both a transform to $m$ om entum space and utilization of the cylindricalsym $m$ etry to work in two dim ensions. In addition, we exam ine the accuracy of the previous 3D Fourier transform algorithm and show that it does not achieve high spectralaccuracy asm ight have been expected. W e analyze the reason for this and suggests a sim ple correction that provides high accuracy. T he sam e correction also applies to our new 2D algorithm.
$T$ he ground state is found by $m$ in im izing the totalenergy, which is often done by propagating the wavefunction in im aginary tim $e . W$ e nd that thism ethod is slow. Instead, we use a highly e cient m in im ization technique, con jugate-gradients, to further speed up the calculation of the ground state, resulting in a typical com putation tim e of fraction of a second on a present day PC.F inally, we apply our new algorithm to a fast and e cient calculation of $m$ any excited $m$ odes via direct solution of the B ogoliubov-D e G ennes ( BdG ) equations. C alculation of tens of $m$ odes is achieved in a span of a few seconds to a few $m$ inutes. $W$ e also com pute the quantum depletion at $\mathrm{T}=0$ due to the dipolar interaction.

## II. THEALGORITHM

Follow ind the calculation of the dipolar interaction integral can oe sim pli ed by $m$ eans of the convolution theorem. Let $n(r)=j(r) j^{2}$ be the density per particle at $r$ and let $V_{D}(r)=\left(3 z^{2}=r^{2} \quad 1\right)=r^{3}$. Let $\mathrm{n}(\mathrm{k})$ and $\nabla_{D}(k)$ be their Fourier transform $s$, i.e

where $F^{1}$ is inverse Fourier transform. The Fourier transform of $V_{D} m$ ay be found by expanding $\exp (i k r)$ in a series of spherical harm onics and sphericalB essel functions (the usual expansion of a free planar wave in free sphericalw aves), where on ${ }^{\text {n the }} Y_{20}$ term gives non-zero contribution. where is the angle betw een k ane the z axis.
It has also been show $n$ in Ref that a cuto of the dipolar interaction at sm all $r$ in real space is not im portant when the calculation is perform ed in m om entum space, since $\mathbb{1}$ a ects only very high m om enta which are not sampled. $n(k)$ can be num erically evaluated from $n(r)$ by $m$ eans of a standard fast Fourier transform ( FFT ) algorithm . This m ethod is quite general, and has the speed advantage of using FFT. It is sim ilar to the calculation of the kinetic energy to high accuracy by Fourier transform of the wavefunction to m om entum space and multiplication by $k^{2}=2$.

W e w ish to consider traps w ith cylindrical sym $m$ etry, for which the the projection of the angular $m$ om entum on the z -axis is a conserved quantity. T he eigenstates $m$ ay then be w ritten

$w$ ith ( ; z; ) the usualcylindricalcoordinates, and $m$ an integer. For the ground state $m$ is zero, but we would also like to consider m > excitations.

The 3D FFT cannot take direct advantage of the cylindrical sym m etry. T he key idea of the new algarithm is the observation that for a function of the form the 2D Fourier transform in the (x;y) plane is reduced, after integration , to a 1D H ankel (or B essel) transform of order m

where $J_{m}(x)$ is the Bessel function of order $m$. Thus, a combination of $H$ ankel transform in the transverse ( ) direction and Fourier transform in the axial ( $z$ ) direction, which we shall call here the discrete $H$ ankelFourier transform (D H FT), can be used to m ove betw een spatial and $m$ om entum spaces. The wavefunction need only be speci ed on a two dim ensionalgrid in ( ; z ) coordinates. The transform can be used to com pute both the dipolar interaction energy and the kinetic energy. lan, there exist fast $H$ ankel transform $s$

These algorithms perform a discrete transiorm of N radial points in time complexity of O $(\mathbb{N} \log (\mathbb{N}))$, just as for 1D fast Fourier transform (we use $N$ also to indicate num ber of particles. The meaning should be clear from the context). H ow ever, they require sam pling the transform ed function on a logarithm ically spaced grid. Thus the function is oversam pin sm all radii. O ur experience $w$ ith the fast algorithm is that it works well for one transform, but requires careful attention and tuning to avoid increasing num erical errors $w$ hen applied $m$ any $t i m$ es over in the energy $m$ inim iza process (for an early attem pt of applying the $m$ ethoc
for a scattering problem, see . For this reason, we have selected as our $m$ ethod oI cnoice a discrete $H$ ankel transform (DHT) , on zeros of the Bessel function W e found it to be accurate and robust. I nis algorinn is of com plex-斗y $O\left(\mathbb{N}^{2}\right)$. The non-uniform sam pling $m$ ight seem unusual at rst, but is actually of great advantage in that, as we shall show, it allow s a highly accurate integration form ula, rem in iscent of $G$ aussian-quadrature. A though for large grids the DHT is slower than the fast H ankel transform smentioned above, we nd that in practice it is faster for radial grid sam pling of up to 32 points.

## A. The discrete H ankel transform

W e shallnow describe the D H T.TheH ankeltransform oforderm of a function $f(r)$ is de ned by:

$T$ is a real, $N$ xN sym $m$ etric $m$ atrix. $N$ ote also that it depends on $S$. Im posing the boundary conditions $f(\mathbb{R})=$ $\tilde{f}^{\sim}(\mathrm{K})=0$ requires $S=m ; \mathrm{N}+1$ (then $\mathrm{T}_{(\mathrm{N}+1) ; j)}=0$ ). Since the $H$ ankel transform is the inverse of itself, we should require $T$ to be unitary for self-consistency. In fact, w ith $S=\quad ; N+1, T$ is found to be very close to being unitary E.g., for $N=50$ and $m=0$ 3, jdet[T]j $1<10^{8}$, and the unitarity is better with larger $N$. If an tly unitary $m$ atrix $T$ is desired, it has been suggested using $B=\left(T^{Y_{T}} T\right)^{1=2} T$ instead of T. But in num ercal tests it was found that in practice essentially the sam e high accuracy was obtained w ith $T$ as w ith B .

In practioe, we rst determ ine an appropriate $R$ for the function, and som e convenient N . Then de ne $\mathrm{S}=$ $m ; N+1$, and $K=S=R$. N should be chosen such that $f(k)$ is as sm all as desired for $k \quad K$.
B. Q uadrature-like integration form ula

W hen the integrals in Eq are evaluated in cylindrical coordinates, we are required to calculate an integral of the form :

An important hene $t$ of sampling the function $f()$ according to Eq is that we are able to derive a highly accurate approxim ation to this integral. Lot $\tilde{f}(\mathrm{k})$ be the $m$ 'th order H ankel transform of ( ), Eq W e shall st assum $e$ that $f()$ is band lim ited. That $1 S$, we assum $e$ that there exist $K$ such that

Substitution of $k=0$ gives im m ediately Eq. This form ula has appeared relativel tationalm athem atics literature It has been show $n$ to be intim ately related to $G$ aussian quadrature. In $G$ aussian quadrature, the sam pling points are roots of orthogonalpolynom ials, while here they are roots of the Bessel function $J_{m}(\mathbb{K})$.

The wavefunctions of interest in our problem are not strictly zero for $k>K$, but they typically decrease exponentially for large k . M oreover, as the wavefunction decreases exponentially in space, the in nite series can be truncated to provide the follow ing approxim ate formula:

In our application, N and K are the sam e as those given above for the DHT. The approxim ation converges exponentially to the exact value w ith increasing $N$ and $R$.

## C. A ccuracy of calculating the dipolar interaction energy

Before continuing to applicatir we re-exam ine the accuracy of the 3D FFT m ethod The behavior discussed below appears also in the 2 D m ethod, but the analysis in the 3D case is easier. From the sim ilarity to the calculation of kinetic energy w ith spectral accuracy, which typically achieves m achine precision with a sm all num ber of grid points, we expected that the dipolar interaction energy w ill also be calculated to this high accuracy. We nd that the relative accuracy, typically varying betw een $1 \mathrm{E}-5$ to $1 \mathrm{E}-2$, is enough for practical purposes, but not as accurate as $m$ ight be expected. A detailed analysis is given in the appendix. T he reason for the num erical erronc is traced down to the discontinuity of $V_{D}(k)$, Eq. at the origin. An im proved accuracy, by at least tw o orders of $m$ agnitude and up to machine precision, is obtained by using, instead of Eq. the Fourier transform of a a dipolar interaction truncated to zero outside a sphere of radius $R$, where the spatialgrid dim nsions are [ $R \cdot R] \quad[R ; R][R ; R]$. Thus, Eq. replaces Eq. N ote that this truncation of the dipolar potential has no physicale ect on the system, as long as $R$ is greater than the condensate size. For a pancake trap it is advantageous to use a grid of dim ensions [ P; P ] [ P;P] [ Z;Z]with Z < P. For $Z<P=2$ we nd that it is preferable to use the Fourier transform finolar interaction truncated to zero for $\dot{\mathrm{z}} \boldsymbol{j}\rangle>\mathrm{Z}, \mathrm{Eq}$. These m odi cations apply also to the 2D case.
III. GROUND STATEOFA D IPOLAR CONDENSATE

For nding the ground state ofdipolar BEC, the wavefunction is samplod on a 2D grid ( $i ; z_{j}$ ), w th $i$ deter$m$ ined from Eq. and $z_{j}$ evenly sam pled. Since the ground state is symm etric in $z$, it is enough to sam ple z 0. TheFFT in th lirection is then perform ed as a fast cosine trar forw hich we used the FFTW softw are package I ne fast cosine transform uses the
property of the wavefunction being real and sym $m$ etric to enhance speed by a factor of 4 com pared to standard com plex FFT.
$T$ he $m$ ost com $m$ only practiced $m$ ethod to obtain the ground state is propagation of an initial moss of the wavefunction in im aginary tim e, using Eq. w ith $t$ !
it. $T$ his $m$ ethod is robust but slow, though the reduction of the problem to 2 D speeds it up considerably. W e obtained a further substantialgain in speed by adopting, instead, direct $m$ inim ization ofth totalenergy using the con jugate-gradients technique . This technique has becom epopular in density function- ${ }^{-1+1}$ pory calculations, and a review of it appears in Ref plication to BEC vortioes is found in Kef which we closely follow. T he G P energy functional is given by Z

The essence of the conjucato-rradients $m$ ethod is $m$ inim izing the energy, Eq. by successive linem inim izations along optim ally cnosen directions. The initialdirection is along the gradient, but in the $(n+1)$ 'th step the new direction is a judicious linear com bination of the new gradient and the previous ( $n$ 'th) direction. This 'mem ory' property provides the algorithm with a better feeling (so to speak) for the shape of the energy surface, and faster convergence is achieved com pared to sim ply follow ing the present gradient at each step. A n im portant feature for our speci c problem is that that each line-m inim ization step can be done analytically. A nother im portant point is the need to ensure that, just like in im aginary tim e propagation, we reach the localm inim um nearest to the initial guess, rather than a global $m$ in im um, which $m$ ay be a collapsed state. D etails of the im plem entation are given in the appendix.

The algorithm using the DHFT and the conjugategradients $m$ in im ization was im plem ented in $M$ atlab, and its correctness veri ed by com paring to the published results in the literature and to independent code im plem enting the 3D method of $w$ ith im aginary time propagation. In a typical applrcation, the grid consists of $32 \times 32$ points, covering the dom ain $[0 ; 8] \quad[0 ; 8]$ in the ( $; \mathrm{z}$ ) coordinates. The starting guess is a su ciently wide G aussian. W e have checked the num erical convergence of the ground state energy w ith respect to increasing the grid resolution and its size. Generally, convergence w ill depend on the param eters of the problem, but
in $m$ ost cases this grid already achieves convergence to very high accuracy. A s a benchm ark, the harm onic oscillator energy in a sphericaltrap ( $!=!_{z}=1$ ) is obtained to accuracy of $10^{14}$ w ith the above grid. For a dipolar $B E C$ w th the interaction param eters $s=1$ and $D=3$, we nd that the energy is converged to the sam e accuracy, $10^{14}$, w ith respect to increasing the resolution and size of the grid. The runtim e for this com putation on our $P C$ is 0.5 seconds.
IV. BOGOLIUBOV-DEGENNESEXCITATIONS

## A. Form ulation

W e now tum our attention to com puting excitations of the cond e by direct solution of the BdG equations (see, e.g, for the case of a short range potential). W e rst derive the BdG equations for the dipolar case by analyzing the linear stability of the tim e-dependent GPE about a stationary state $0(r)$. W ew rite

For a stable ground state, alleigenvahes! are real and the excitation energy of one particle into a given $m$ ode is given by (the positive signed) !. In this case the functions $u$ and are real vahod. The appearance of negative ! ${ }^{2}$ solutions of Eqs. , i.e. complex !, indicates instability of the condensare.

In our application we nd the eigenvalues of Eq. by rst discretizing $f$ on a rrid, as described for the ground state 0 in section $T$ he eigenstates $m$ ay be classi ed as odd or even w in respect to re ection through the $x-y$ plane. T hus, as in the case of the ground state, only the positive $z$ sem i-axis need to be sam pled The calculation of the integrals with $V_{D}(r)$ in Eqs. perform ed in $m$ om entum space via the use of eq.
(w th the appropriate re-interpretation of $n\left(r^{0}\right)$ there) and the DHFT. The excitation $m$ odes $w$ ith $m>0$ require special attention, and we refer the reader to the appendix for their treatm ent. A s part of the DHFT we need the Fourier transform in the $z$ direction. This is perform ed by a fast cosine transfi.. or even parity, and fast sine transform for odd parity for which we used the FFTW software package.

Since (as we nd) m any excited modes $m$ ay be obtained to very high accuracy w th relatively sm all grids ( $32 \times 32$ to $64 \times 64$ ), it is feasible to construct the $m$ atrix elem ents of $A \quad\left(H_{0}+C\right)\left(H_{0}+C+2 X\right)$ and diagonalize it. Since we are only interest the low est energy eigenstates, the A moldim ethod is a much $m$ ore e cient $m \overbrace{}^{+1-1}$, which is also appircable to $m$ uch larger, 3D grids . It is an iterative $m$ ethod that requires at each iteration only the action ofA on the vector $f$, and the fullm atrix A itselfneed not be constructed. It is particularly e ective for sparse $m$ atrices. In our case, A is not sparse, but it has a special structure: parts of it are diagonal in space and other parts (the kinetic energy as well as the dipolar parts of C and X ) are diagonal in m om entum space. The use of HFT enables the e cient calculation of its action on $f w$ thout ever form ing the fullm atrix ofA in one particularbasis. Interestingly, this is the sam e prope. ${ }^{\text {th }} \mathrm{m}$ akes the tim e-dependent propagation technique appealing for calculating the spectrum ofexcitations: in that case, only successive operations w th the $H$ am iltonian on the wavefunction are necessary. H ow ever, com bined use of linearization (i.e

BdG equations) and the A moldim ethod should be m uch $m$ ore e cient, even in the 3D case. O fcourse, non-linear e ects, which in principle can be probed by the tim edependent $m$ ethod, cannot be studied by use of the B dG equations alone. M ore im plem entation details are given in the appendix.

For com pleteness of the discussion, we com pare in the next subsection the exact num erical solution of the B dG equations as obtained w ith our new m ethod, w th som e low lying $m$ ode ationalm ethod In the variationalm ethod, one assum es a tm e-aepenaent G aussian ansatz:

w th the param eters A (com plex am plitude), w (w idth), o (œenter of cloud), and are variational param eters. T he resulting equations of $m$ otion give the equilibrium widths (variational Gaussian solution of the tim eindependent GP equation) and frequencies of som e low lying modes. Them odes that are described by the ansatz ofEq corresponaing to the $m$ ovem ent of the center of the cloud 0 . These are found to have the frequencies! and $!_{z}$ of the ham onic oscillator and are n- ected by the interaction. In fact, K ohn's theorem proves that the exact solution for these $m$ odes gives the sam e harm onic oscillator frequencies, and are not a ected by the interaction. To understand this, consider a sm all displacem ent of the center of them ass of the cloud w ithout changing its shape. The inter-cloud foroes are then unchanged, while the restoring force due to the ham on ic trap is proportional to the displacem ent and is the sam e throughout the cloud. This results in a classical harm onic m otion of the cloud as a whole. The constant frequency of these m odes will provide a good check on the num erical accuracy of our algorithm. Secondly, one obtains three collective $m$ odes describing the oscillation of the widths, two m odes w th $\mathrm{m}=0$ and one w th $\mathrm{m}=2$. In the ideal gas lim it they correspond to $\mathrm{m}=0 \mathrm{~m}$ odes w th frequencies 2 ! and $2!_{z}$, and $m=2 \mathrm{~m}$ odew th frequen . hese $m$ odes have been ilhustrated graphically in $\quad$ w ith the twom $=0 \mathrm{~m}$ odes described as the breatning $m$ ode and the quadrupole $m$ ode.

## B. B ehavior and shape of B dG excitations

The param eter space of the dipolar BEC problem in a cylindrical trap is 3 dim ensional: we have the aspect ratio of the trap, $\frac{!}{!}$, the dipolar param eter D , and the contact interaction param eter s. In this work we shall concentrate on dom inant dipole-dipole interactions, and set the contact interaction to zero. W e explore the behavior of the BdG m odes $w$ ith varying dipole-dipole interaction strength in di erent trap geom etries, from pancake shaped to cigar shaped. For orientation, consider a

Let us rst consider a BEC in a JILA pancake tran $w$ ith $\frac{!_{z}}{!}={ }^{P} \overline{8}$. The results are presented in $F$ io $\quad$ For D $=0$ we retrieve the ideal-gas results $\frac{!}{!}=n_{z} \overline{8}+n$ w th $\mathrm{n}_{\mathrm{z}} ; \mathrm{n}=0 ; 1 ; 2 ;:::$. The lowest m ode has $\mathrm{m}=1$ and corresponds to a transverse $K$ ohn $m$ ode $w$ ith frequency! (in fact these are tw o degenerate $m$ odes: $m=1$ and $m=-1$, or altematively, sloshing $m$ otion in the $x$ and $y$ directions). The frequency is evidently constant as a function ofD, in agreem ent w ith K ohn's theorem. Sim ilarly, the second lowest $\mathrm{m}=0 \mathrm{~m}$ ode is a K ohn m ode in the $z$ direction $w$ ith frequency $!z . N$ ext, consider the tw o m odes that converge to ! = 2! in the ideal-gas lim it. One of them has $m=0$ (solid line) and the second $m=2$ (dashed line). $T$ he $m=0 \mathrm{~m}$ ode is shifted dow $n$ in frequency $w$ ith increasing $D$ while the $m=2$ m ode is shifted up. The $\mathrm{m}=0 \mathrm{~m}$ ode goes to zero at $D=3: 87 . T$ his point $m$ arks the collapse of the condensate: for higher value of $D$, there is no stable solution of the GPE. These two m odes are also described by the variationalm ethod outlined above, w ith good agreem ent w th the exact num erical results up to about $\mathrm{D}=2: 2$. H ow ever, the variational m ethod signi cantly overesti$m$ ates the $D$ for collapse (giving $D=4: 87$ at collapse). O urexact num ericalresults are in agreem entw ith the m erical results for these tw o m odes obtained in $R$ ef using the tim e-dependent response of the system to extemalperturbation, and $m$ oreover, we are able to resolve them right dow $n$ to the collapse point.

The behavior of the next few low m odes is also inter-

esting: som $e$ m odes of di erent sym $m$ etries cross each other, while twom odes (one of the them the third $m=0$ m ode) converge together near to collapse. $N$ ote also the 5 'th $m=0 \mathrm{~m}$ ode, w th the ideal-gas frequency of $2!_{\mathrm{z}}$. T his m ode is also described by the variational m ethod. W e see that the lowest $\mathrm{m}=0$ variational m ode is also the low est $m=0$ exact $m$ ode, but the second variational $m=0 \mathrm{~m}$ ode is $\mathrm{m} u \mathrm{ch}$ higher, and betw een them there are two $\mathrm{m}=0 \mathrm{~m}$ odes (excluding the K ohn m ode), as well as other $m>0 \mathrm{~m}$ odes, which are not described at all.by the variationalm ethod. A s m entioned above, the variationalm ethod obtains only twom $=0 \mathrm{~m}$ odes (excluding a K ohn m ode) that approach 2 ! and $2!\mathrm{z}$ in the ideal gas lim it. But for $!_{z}>2!$ there are at least tw o other (non-K ohn) $m=0 \mathrm{~m}$ odes that are between them, and approach $2!+!_{z}$ and $4!$ in the ideal gas $\lim$ it.

It is worth noting the com putational e ciency of our algorithm in obtaining these BdG results. W e obtained 100 converged $m$ odes for a given dipole $m$ om ent and $m$ in about half a m inute on our PC, with a grid size of $\mathrm{N} \quad \mathrm{xN} \mathrm{z}_{\mathrm{z}}=34 \mathrm{x} 64$.

Let us now mnsider the case of a spherical trap ! = $!_{z} \quad!_{0}, F$ ig $T$ he low est excitation (in the ideal gas lim it) consists of three degenerate K ohn m odes corresponding to $l=1 \mathrm{w}$ ith $\mathrm{m}=0$; $1 ;+1$. N ote that the $K$ ohn frequencies are constant and $m$ aintain their degeneracy for $D>0$, even though the dipolar interaction does not conserve the total angular $m$ om entum, and the ground state shape is elongated in the $z$ direction. $N$ ext, consider the 4 m odes that converge to $2!_{0}$ : two w th $\mathrm{m}=0$, and another two w th $\mathrm{m}=1$ and $\mathrm{m}=2$. $\mathrm{Ac}^{-}$ tually, there are six, accounting for the degeneracy w th negativem. In the idealgas lim it these correspond to ve degenerate $l=2 \mathrm{~m}$ odes and one $\mathrm{l}=0 \mathrm{~m}$ ode. T he low est $m=0$ of these causes the collapse of the condensate at

D $=4: 19 . N$ ote that this $m$ ode crosses the three $K$ ohn m odes. T his is possible whenever there are tw o di erent $m$ modes or two modes $w$ th the sam $e m$ but di erent parity $w$ th respect to the sym $m$ etry $z!\quad z$. The two $\mathrm{m}=0 \mathrm{~m}$ odes and the $\mathrm{m}=2 \mathrm{~m}$ ode are also described by the variational m ethod. T he variational frequencies agree quite well w ith the exact ones up to D 3, although, again, the variationalm ethod overestim ates the criticald for collapse.
$N$ ote that an isotropic short range interaction that conserves 1 would only split the degenerate ideal gas levels into di erent 1 m odes. T hus, if there is a dom inant short range interaction and a sm aller dipolar interaction in a sphericaltrap, the dipolar interaction w ould not just shiff the levels, but also split them into non-degenerate states of di erent in $j$. This could provide an interesting and unam biguous experim ental signature of dipolar interaction e ects. In such an experim ent, it would be im portant to verify the spherical ham onicity of the trap, to exclude splitting due to anisotropy of the trap or nonharm onicity. This could be accom plished by m easuring the K ohn (i.e, sloshing, or dipole) m odes.

W e m ove now to a slightly cigar shaped trap, with $!_{\mathrm{z}}=!=5=6$ ( F iq Here, the collapse occurs at $\mathrm{D}=$ $4: 32$. T he interesting feature here is the avoided crossing betw een the second and third $m=0 \mathrm{~m}$ odes. We nd that in the avoided crossing the nature of the lowest $m$ ode changes from quadrupole-like mode for sm all D to a breathing $m$ ode close to collapse. H ow ever, we found the sam e change in the nature of the low est $m$ ode also in a spherical trap, whe 'here is no such avoided crossings (see below. See alsc for discussion ${ }^{\text {file }}$ nature of the m odes with the vamationalm ethoo

tw o m $=0 \mathrm{~m}$ odes which are described by the variational $m$ ethod have now a wide gap in energy and there is no longer a clear avoided crossing betw een them. T here is an interesting pattem of crossing betw een som $e$ of the higher $m$ odes. N ote again, that the low est variational $m$ ode is the one that leads to collapse, but the tw o other tw o variationalm odes lie above others which are not accounted for by the variational ansatz.

We can also exam ine the shape and nature of the BdG eigenm odes. The two eigenm ode functions $u$ and are real, and determ ins the tim e dependent oscillation through Eqs and The oscillation of the density $(r ; t)=j(r ; t) J$ is then given, to linear order in $u ;$,by
$(r ; t)=2(u(r)+\quad(r)) \cos (!t)$. The function $f=u+$ therefore gives the shape of the density oscillations.

A s an exam ple, consider the low est (non K ohn) m odo in the sphericaltrap, the $m$ ode that goes to zom in $F$ is and leads to the collapse of the BEC. In Fio ve draw the contour plot of $f$ for this $m$ ode, for two values of D , one $s m$ all, and one close to the collapse point. If we exam ine the nodal line ( $f(r)=0$, heavy line), we see that for sm alld it form $s$ an open, hyperbolic-like contour. This signi es a quadrupole-like $m$ ode. In contrast, close to collapse, the nodal line form s a closed, elliptic contour, typical of a breathing $m$ ode. $W$ e conclude that the nature of the $m$ ode changes from quadrupole-like for sm all $D$ to a breathing $m$ ode for $D$ close to collapse. $T$ his conclusion is in a m ent $w$ th analysis based on the variational m ethod . In betw een, the nodal line is parallel to the z axis, and the eigenm ode character is essentially that of a pure transverse ( ) excitation.
C. C ollective versus single-particle excitations

Let us now exam ine in $m$ ore detail the structure of tho BdG excitations spectrum for a speci c case. In $F$ ig we show the spectrum evaluated for a sphericaltrap with $D=4$. Each state is characterized by angular $m$ om entum projection $m$, and by even (positive) parity or odd (negative) parity w ith respect to re ection $z$ ! z. The BdG states are represented by thick solid hars.
$T$ he BdG m odes in each colum $n$ of $F$ id re grouped in $m$ ultiplets $w$ ith increasing near degeneracy of $1 ; 2 ; 3 ;::$ : near the harm onic oscillator frequencies. In the ideal-gas lim it these groups becom e exactly degenerate. $N$ ote that the for the $0^{+}$colum $n$ the two lowest $m$ odes ( $w$ hich are far apart) become degenerate (w th frequency $2!0$ ) at the ideal gas lim it. T he splitting betw een the groups in each given colum $n$ is approxim ately $2!0$. T he splitting betw een the tow ers ofeven and odd $m$ odes of the sam em is approxim ately $!_{0}$. In the ideal gas lim it, the tow er of states w ith $\mathrm{m}^{+}$is degenerate w ith that of $(\mathrm{m} 1$ ) . We can classify the states in the idealgas lim it by $\left(1 ; n_{r}\right)$, w ith $l$ the total angular $m$ om entum, $n_{r}$ the num ber of radial nodes (not counting a node at $r=0$ ), and $w$ th energy $\left(2 n_{r}+1\right) h!_{0}$. The towers of $m^{+}$and ( $m$ 1) states becom e, in the ideal gas lim it, a tower of $\left(l_{;} n_{r}\right)$ states as follow s: the low est state is $\left(1 ; n_{r}\right)=(m ; 0)$. A bove it there is a pair $(m+2 ; 0) ;(m ; 2)$ degenerate in the ideal gas lim 辻, follow ed by a triplet $(m+4 ; 0) ;(m+2 ; 2) ;(m ; 4)$ and so on. Here, the ordering of the states inside each multiplet is conventionalonly and does not indicate their order of increasing energy when split by the interaction.

The BdG eigenm odes are given by the pair u; corresponding to positive and negative frequencies. A collective $m$ ode is characterized by non negligible com ponent. It describes excitation of a quasi-particle, as opposed to an excitation of a single particle. H ow ever, the high-energy part of the spectrum is expected to be well reproduced by a single-particle description in the

$m$ ean- eld approxim ation since the condensate as a whole has little tim e to respond to the fast oscillations of a single particle in a high-frequency mode. T he single-particle, or $H$ artree Fock (HF) picture is obtained by neglecting the coupling between $u$ and in Eq Thiccomesponds to setting $=0$ in the rst equation of Eq. which then reduces to the eigenvalue problem ( $\mathrm{H}_{\mathrm{HF}}$ ) $=$ !u, with the HF H am iltonian

The spectnum of $H_{H F}$ is shown as dotted horizontal bars in $F$ if The general structure of the H $F$ spectrum is vory sim lar to that obtained with the BdG equations apart from states w th low energy and $m$, which are collective m odes. N ote that the HF spectrum fails to satisfy the $K$ ohn theorem for the dipole $m$ odes. It is worth noting the good agreem ent betw een the HF and the BdG spectra form $>2$ as well as for the odd $m=1$ m odes. A close look at the near-degenerate groups of the even $\mathrm{m}=0 ; 1 \mathrm{~m}$ odes show sthat for the $0^{+}$sym m etry, there is good agreem ent betw een the tw o spectra except for two modes in each group. For the 0 and $1^{+}$sym $m$ etries, there is good agreem ent except for one $m$ ode in each group. These observations can be understood as follow s. In the ideal gas lim it, m odes with $l>0$, have zero am plitude at the center of the condensate, where the density is at its $m$ axim um. $W$ ith increasing $l$ the $m$ odes becom em ore concentrated near the cirface. The dipolar non-diagonalcoupling term in Eq is proportional to the local ground state am plitude, ana so becom es sm all for surface $m$ odes. This, assum ing that $m$ odes having l> 1 in the idealgas $\lim$ it are well approxim ated by the

HF description, explains the pattem ofF the even $m=0$ tower.

To explain the fact that for the $0^{+} \mathrm{m}$ odes we see two non single-particle $m$ odes in each near-degenerate group, we observe that, to rst order of perturbation theory, the dipolar interaction m ixes the $\mathrm{l}=0$ and $\mathrm{l}=2 \mathrm{~m}$ odes into two orthogonal linear com binations, each having some $l=0$ com ponent. Thus, for exam ple, the group of three $0^{+}$near degenerate $m$ odes around $!=!0 \quad 4$ corresponds to the ideal gas modes $\left(1 ; \mathrm{n}_{r}\right)=(0 ; 2) ;(2 ; 1) ;(4 ; 0)$. The rst two are $m$ ixed already in rst order of perturbation theory, so that both have som e l= 0 character, and as a consequence are not w ell described by the single-particle picture. This intenpretation is supported by visualexam ination of the exact num ericaleigenfunctions of the three states. N ote that the state that goes to the $(4 ; 0)$ state in the ideal gas lim it is the second of the three in order of energy.

> D. Quantum depletion

T he quantum depletion, ie, the num ber of particles $N$ out of the condensate, due to the interaction, is given by the B ogoliubov theory as:

Typically, $m$ any thousands of $m$ odes nead ta obtained in order to converge the sum in Eq. A usefiul approxim ation ntext in the local density approxim ation (LDA) which is the leading order of a sem i-classical approxm ation. It w as em ployed for the description of BEC $w$ th a repulsive short range interaction. For an attractive short range interaction $m$ ore generally, for a dipolar BEC with $d^{2}>a=3$ an hom ogeneous BEC is unstable to sm all m om entum perturbations. Thus, the LDA, which assum es local ho$m$ ogeneity, leads to unphysical com plex frequencies for sm allm om enta. H ow ever, it is still usefiulto describe the high m om entum m odes.

$N$ ote that the factor in the D irac delta fiunction depends on the direction in m om entum space. That is, the isoenergy surfaces are not surfaces of equal $m$ om entum $p$. A lso, we use the $H$ eaviside function (! н $\quad$ ( $p ; r$ )) to exclude unphysicalIDA m odeswith! ${ }_{\text {н }}<0$, even though the de nition can assign them a real positive frequency, due to taking the positive root. H ow ever, this $m$ atters only for $s m$ all $m$ om enta below $!c$.

As an exam ple, we consider the case of a BEC (34) spherical trap $w$ th $D=4.0$ and $s=0$. U sing Eqs. and we nd that the totaldepletion is 1.4 particles. The rractional depletion depends on the num ber of condensate particles. Since D is proportionalto $(\mathbb{N} \quad 1) d^{2}$, we can achieve the sam e value of $D \quad w$ ith $m$ any particles

with a small dipole $m$ om ent, or a few particles $w$ ith a large dipole m om ent. For tho ${ }^{52} \mathrm{C}$ r exam ple m entioned in the beginning of sectio we obtain D $=4: 0 \mathrm{w}$ ith $\mathrm{N}=1670$, and the quantum aepletion is entirely negligible. H ow ever, we m ay im agine a dozen or so m olecules w ith high dipolem om ent in a m icro-trap. In which, case, the depletion $m$ ay be $m$ easurable.

To dem onstrate the agreem ent betw een the LDA and the exact BdG spectrum for high frequencies, we de ne the spectraldistribution $g_{1 d}(!)$ as the num ber of depleted bosons per unit frequency. T hus $g_{l d}(!) d!$ is the num ber of depleted bosons w ith frequency ! in the intervald!. W e have

obtained from the low-lying discrete $m$ odes by folding $R_{j}(r)$ with a Gaussian of standard deviation (som e sm oothing of the discrete data is is necessary for m eaningfiulcom parison $w$ ith the continuous LD A spectraldistribution).

In $F$ io ve com pare $g$ and $g_{1 d}$ for a BEC in a spherical trap, with dipolar intemation $D=4: 0$ and $s=0$. W e computed $g$ from Eq. $w$ ith $=!0$. For frequencies above $!=!0 \quad 5$ the uw o curves are essentially indistinguishable. This show s the e ciency of the LDA in describing the high energy part of the spectrum .

W e have calculated, for the rst tim $e, m$ any $B d G e x-$ cited m odes of a dipolar BEC in a cylindricaltrap, by direct solution of of the $B d G$ equations. $T$ his achievem ent was m ade possible by a novel, highly e cient algorithm which takes advantage of the cylindrical sym $m$ etry. W e show ed how properties of the BdG spectrum depend on the shape of the trap; exam ined in detail the spectrum in a spherical trap and the nature of the modes (collective vs single-particle); and calculated the quantum depletion due to dom inant dipolar interactions, which is typically very sm all, but $m$ ay becom em ore signi cant in $m$ icro-traps containing a dozen or so $m$ olecules $w$ ith high dipole $m$ om ent.

W e note that the form alism developed in this work $m$ ay be easily extended to com pute properties of dipolar BEC and its depletion at non-zero tem pe re using the H artree Fock B ogoliubov $P$ opov $m$ ethoc We intend to study the non-zero tem perature behavior in a fiuture work.

## 1. $M$ odi cation of the dipolar potential

In this part of the appendix we analyze the num erical accuracy of the 3D FFT m ethod for calculating the dipolar interaction. A correction is suggested to increase the accuracy, and this correction also applies to our 2D algorithm .

The 3D FFT m ethod was used to calculate the mean eld potentialdue to dipolar interactions via Eq. To check its accuracy it is $m$ ore convenient to consider the dipolar interaction energy for a dipole strength $D=1$, given by:

In fact, by noticing that $V_{D}(k)=\frac{4}{3} \frac{2 k_{z}^{2} k_{x}^{2} k_{y}^{2}}{k^{2}}$, it is seen that $\mathrm{E}_{\mathrm{D}}$ evaluated on a cubic grid is guaranteed to be zero for any density $n(x ; y ; z)$ which is sym $m$ etric under all perm utations of ( $x ; y ; z$ ).

For a pancake shaped density $=2$; $z=1$, the exact result is $E_{D}=0: 038670861:::$. W e have evaluated it on cubic grids of extent [ $R$; $R$ ] [ $R$; $R$ ] [ $R$; $R$ ] $w$ ith varying size $R$ and number of points $N x N x N$. The relative error is tabulated in the rst row of table

It is seen that the errors are sm all but far from m acnine accuracy. N ote that convergence with respect to N is already achieved w th a m odest spatial resolution of $2 \mathrm{R}=\mathrm{N}=2 \quad 8=32=0: 5$, but there is a rather slow convergence $w$ ith increasing $R$. $T$ his $m$ ake it clear that the error is not due to failure to resolve the density function $n(r)$. For cigar shaped densities sim ilar behavior w as observed. The reason for the behavior of the nu$m$ erical error is understood if we realize that $\nabla_{D}(k)$ is discontinuous at the origin, where $n(k)$ obtains its $m a x-$ im um. This discontinuly originates in the long range and non-isotropic nature of the interaction. Thus, the num erical accuracy converges slow ly w ith increasing grid resolution, proportional to $1=\mathrm{R}$, in m om entum space.

An altemative and equivalent way to understand the source of the error is that the use of FFT im plicitly assum es that we are dealing w th a 3D periodic lattice of condensates, $w$ th unit cell of size $2 R$. Thus the error $m$ ay be traced dow $n$ to the long range interactions betw een copies of condensates in di erent unit cells.

A $n$ obvious correction suggests itself: since our actual condensate is isolated and of a nite size, we can lim it the range of the dipolar interaction $V_{D}(r)$ such that it is the sam $e$ as before for $r<R$ and and zero for $r \quad R$. This should have no physical consequences as long as R is greater than the extent of our condensate. Then the Fourier transform of this interaction is continuous at the origin and resolved by the grid in $m$ om entum space. We obtain the follow ing expression for the corrected dipolar interaction $\nabla_{D}^{\text {cutR }}(\mathrm{k})$ :

U sing this corrected interaction, we obtain the much betor accuracy dem onstrated in the second line of tab] $T$ he rem aining error depends on $R$ only due to the spatual extent of the condensate, and fast convergence is achieved by increasing $R$ while keeping appropriate grid resolution through increasing $N$. O ne $m$ ay com prom ise on $R$ and $N$, and still obtain at least a 100 fold increase in accuracy as com pared to using the in nite range interaction.

For highly pancake/cigar traps the condensate has also a highly pancake/cigar shape. In this case it is natural to work w ith a grid whose extent [ Z;Z] in the $z$ direction is, respectively, sm aller/larger than its extent [ P;P] [ P;P] in the ( $x ; y$ ) plane. Thus, few er grid points are needed along the shorter axis. In this case, we nd that w ithout correction, num ericalerrors can be typically as large as one percent. H ow evor trincating the interaction outside a sphere as in Eq. is not very helpful in this case, since the condition $R \quad m$ in (Z ; P ) $m$ ust be $m$ et, which restricts the condensate extent to less than the shorter direction. The ideal x would be to cut the interaction exactly by the shape of the box, or a cylinder inscribed w ithin it. $W$ e were unable to nd an analytic expression for the Fourier transform of a dipolar interaction bounded by a cylinder. A partialbut still helpful solution for pancake traps is to truncate the interaction only for $\dot{j} j>Z . W$ e then $n d:$

W ith this corrected interaction, a sm all Z m ay be used as long as it fully contains the condensate. N um erical convergence with the size P will still be slow, but typically the accuracy is im proved by an order ofm agnitude at the least.

Finally, with our 2D algorithm combining $H$ ankel transform in the transverse direction and Fourier transform in the $z$ direction, we nd num ericalerrors ofsim ilar behavior and $m$ agnitude. In the case of 2D, sm allnum erical errors exists even for a spherical sym $m$ etric density, since there is no sym $m$ etry of the grid that ensures getting the correct zero energy, as in the 3D case. All of these errors are signi cantly reduced by em ploying the sam e cuto interactions as in the 3D case.

## 2. C on jugate-gradients im plem entation

We describe here in some detail aspects of the con jugate-gradients im plem entation speci c to the problem of ndinc the ground state of a dipolar condensate, see section he standard conjugate-gradients algorithm perform sunconstrained $m$ inim ization. In principle a constraint could be im plem ented through a Lagrange m ultiplier. In our im plem entation we rather follow the

A $n$ additionaltechnicalingredient in our im plem entation of the con egradients algorithm is the use of pre-conditioning a technique used to accelerate the convergence. O ur pre-conditioner is given in m om entum space as $\frac{1}{k^{2}=2}, w$ ith $M=m a x\left(E ; E_{k}\right), E$ is the energy given by Eq. and $\mathrm{E}_{\mathrm{k}}$ is the kinetic energy.

## 3. Excitations spectrum

An important issue in calculating the $m>0$ excitations is that the grid points given by Eq. are di erent for di prent m . T he point is that the iunction f of Eq. is represented on the $m>0$ grid whereas the ground state wavefunction entering Eqs. is dened on the $m=0$ grid. Our solution is to anterpolate the ground state wavefunction to the grid $m>0$. The interpolation is facilitated by the fact that the roots of the B essel function $J_{m}(r) m$ arch to the right as $m$ is increased, and those of $m$ are interlaced betw een those of order m 1. Fortunately, a high curate interpolation schem e is available in this case Sim ilarly to the exact integration form ula one can derive an exact interpolation form ula for band lim ited functions satisfying Eq

It can be truncated to the rst $N$ term sprovided $f(r)$ is sm all for $r \quad R=0 ; i+1=K$. W e used this formula to interpolate the ground state w avefunction to the required grid points of $m>0$. N ote that this interpolation need only be done once prior to solving the BdG eigensystem. A $n$ altemative $m$ ethod for calculating $m>0 \mathrm{~m}$ odes using a xed grid corresponding to $m$ no need for interpolation was suggested in Refs

In our application we have taken adrontage of the structure of the BdG equations (sectio: to e ciently com pute the low lying spectrum . W e have used a variant of the A moldim ethod (the im plicitly restarted A moldi $m$ ethod"ich is im plem ented in the ARPACK software package and enables nding the $M$ largest or sm allest eigenvames of an operator A, where $M$ is selected by the user. A need not be herm itian. For our punposes, the $m$ ain advantage ofthis $m$ ethod is that it requires as input
only the evaluation of x for som e vector x . T he m atrix elem ents of $A$ need not be known. The user need only provide a function that accepts $x$ and retums $y=A x$. $T$ he eigenvalues in the requested part of the spectnum are then found iteratively by repeated applications of A, starting from som e random try chosen $x$. In our case, Ax represents the lh.s of Eq. and the com putation is facilitated, as usual, by using DHFT to m ove between space and m om entum space representations.
